(57) **CLAIM**

The ornamental design for a wood vertical file, as shown and described.

**DESCRIPTION**

My new design for a wood vertical file can be in an oak and/or a cherry wood finish for use with a four-drawer

vertical file, a two-drawer vertical file, and a two-drawer lateral file.

FIG. 1 is a perspective view of a first embodiment of the design for a wood vertical file showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 14 is a top plan view of the third embodiment of the design;

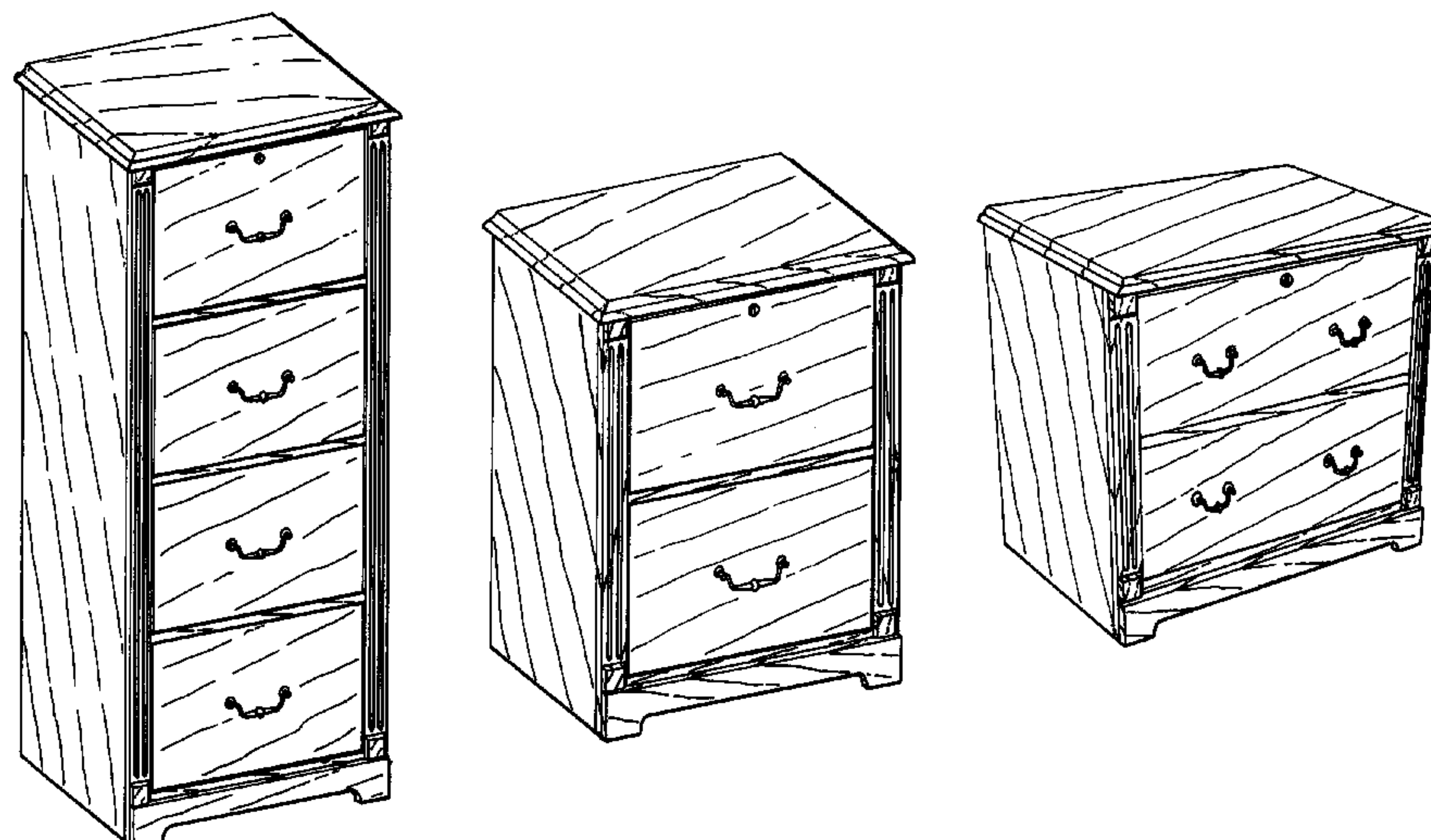
FIG. 15 is a front elevational view of the third embodiment of the design;

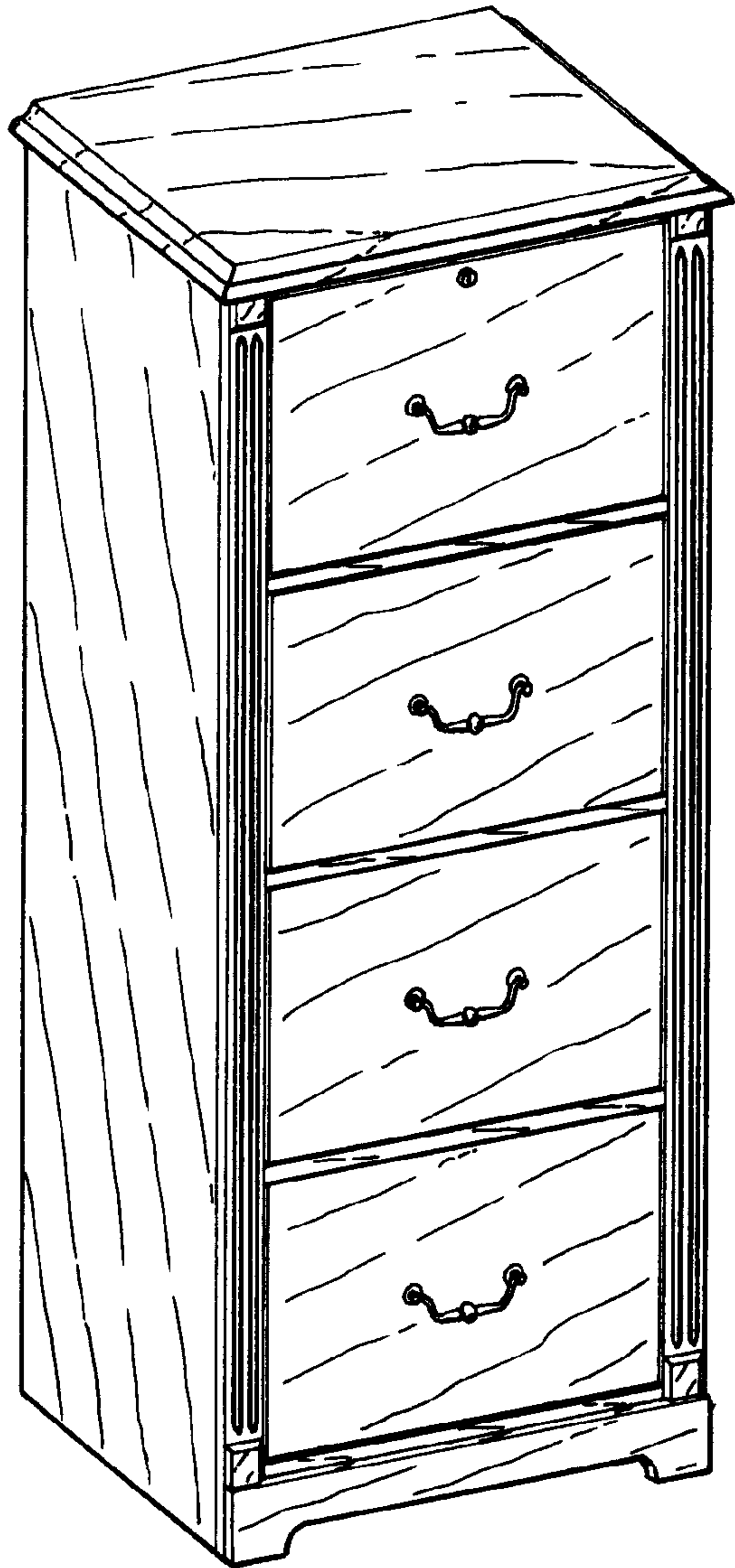

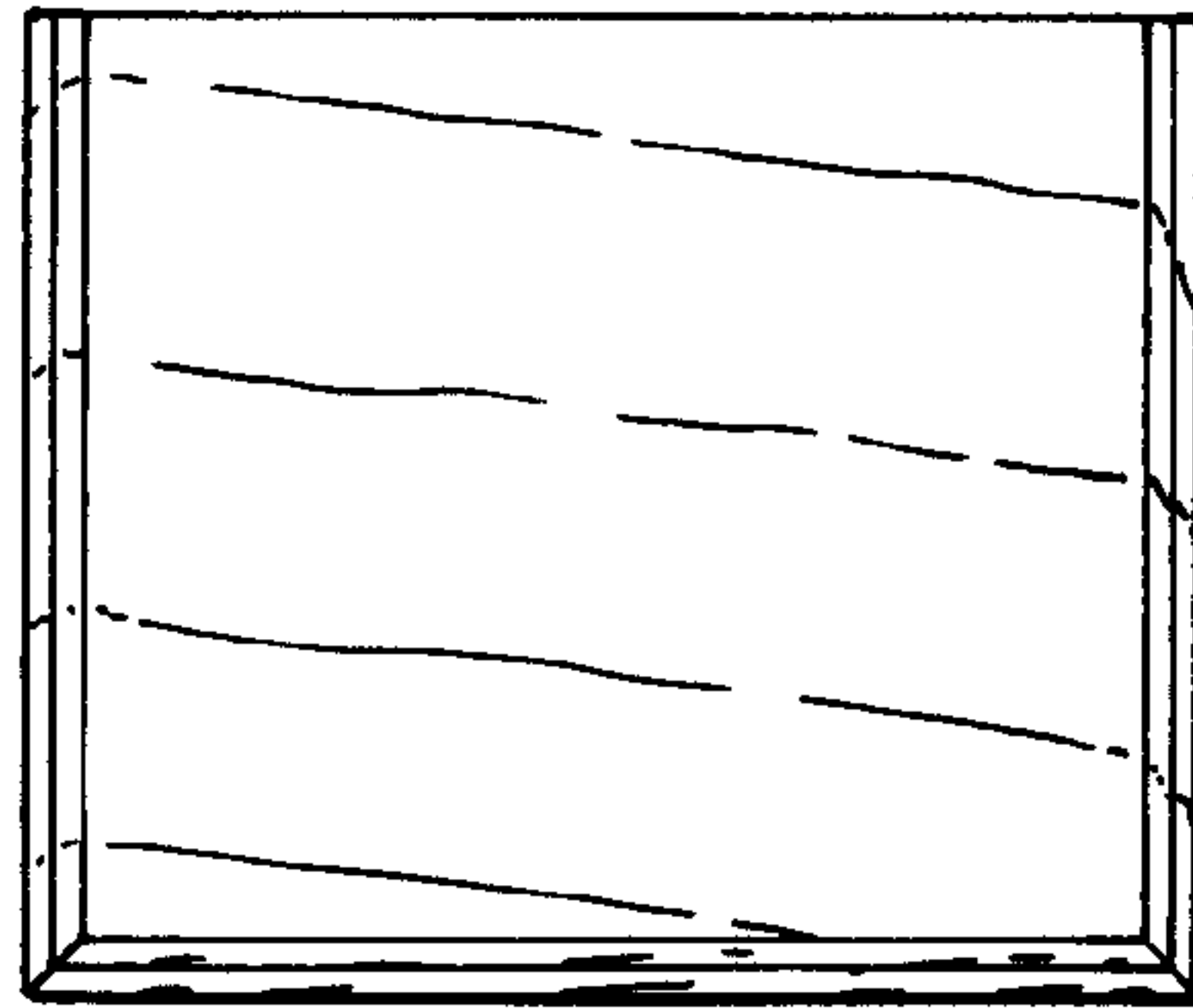

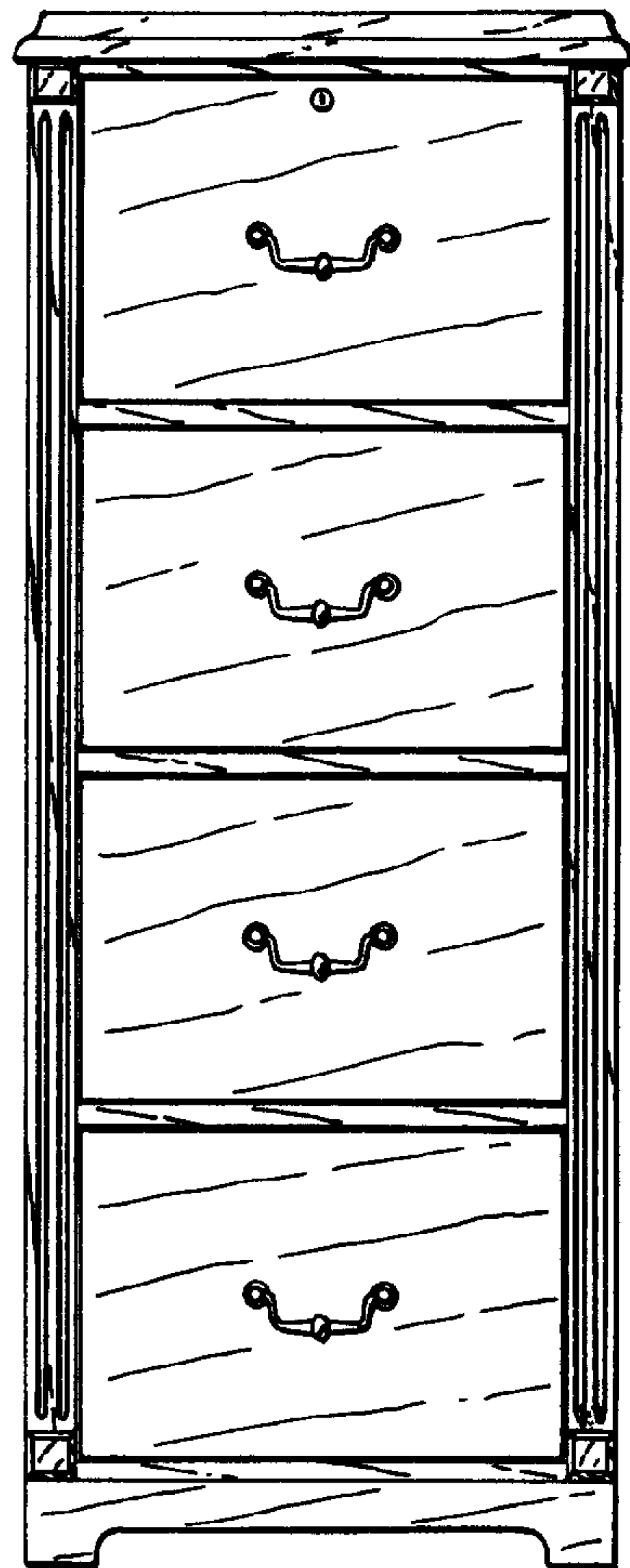

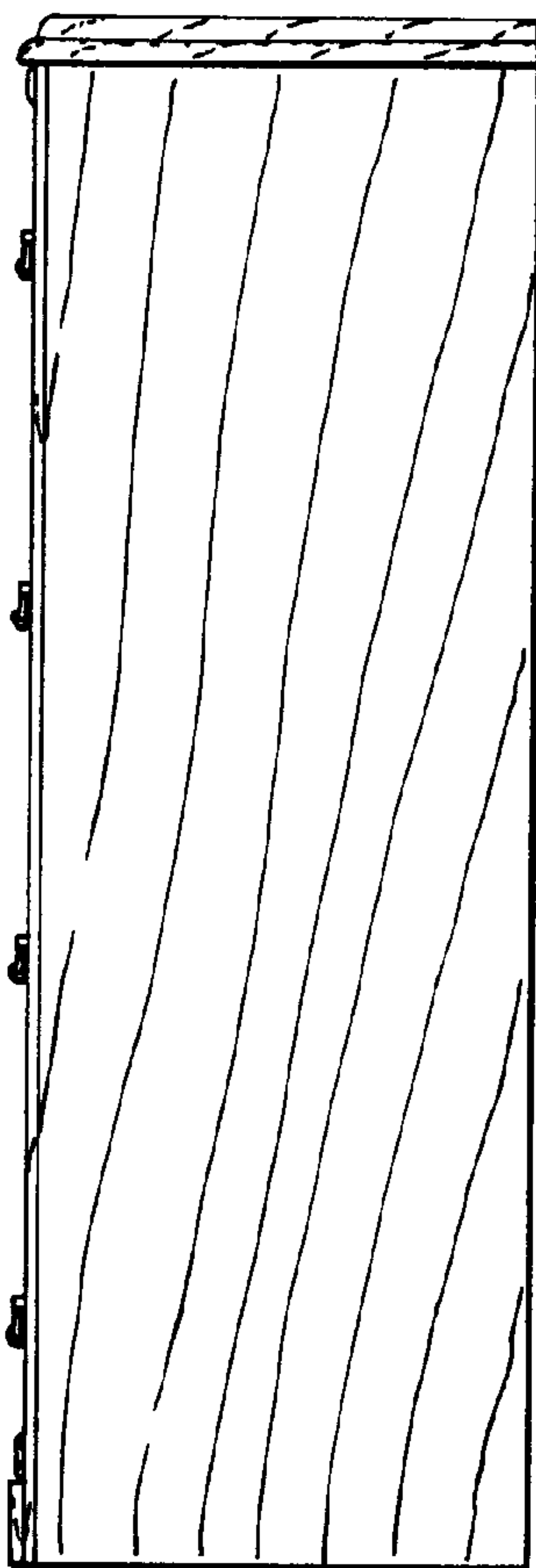

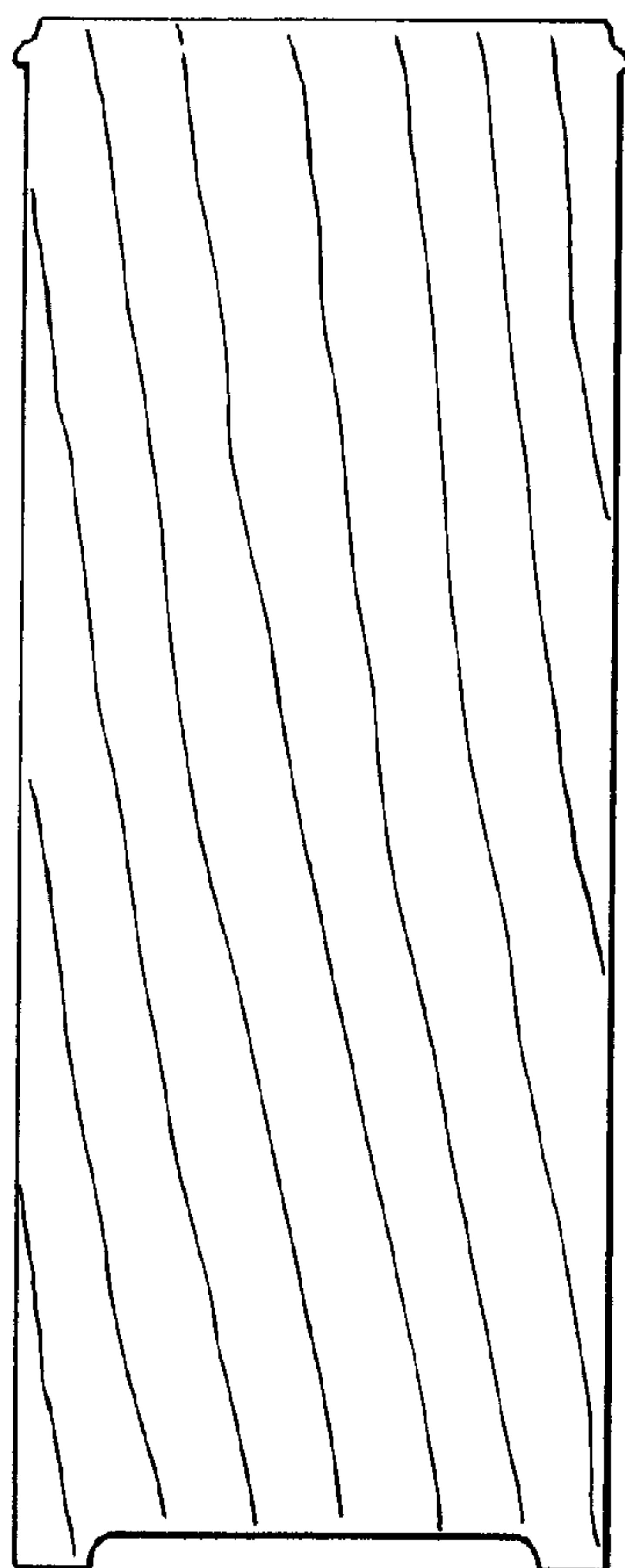

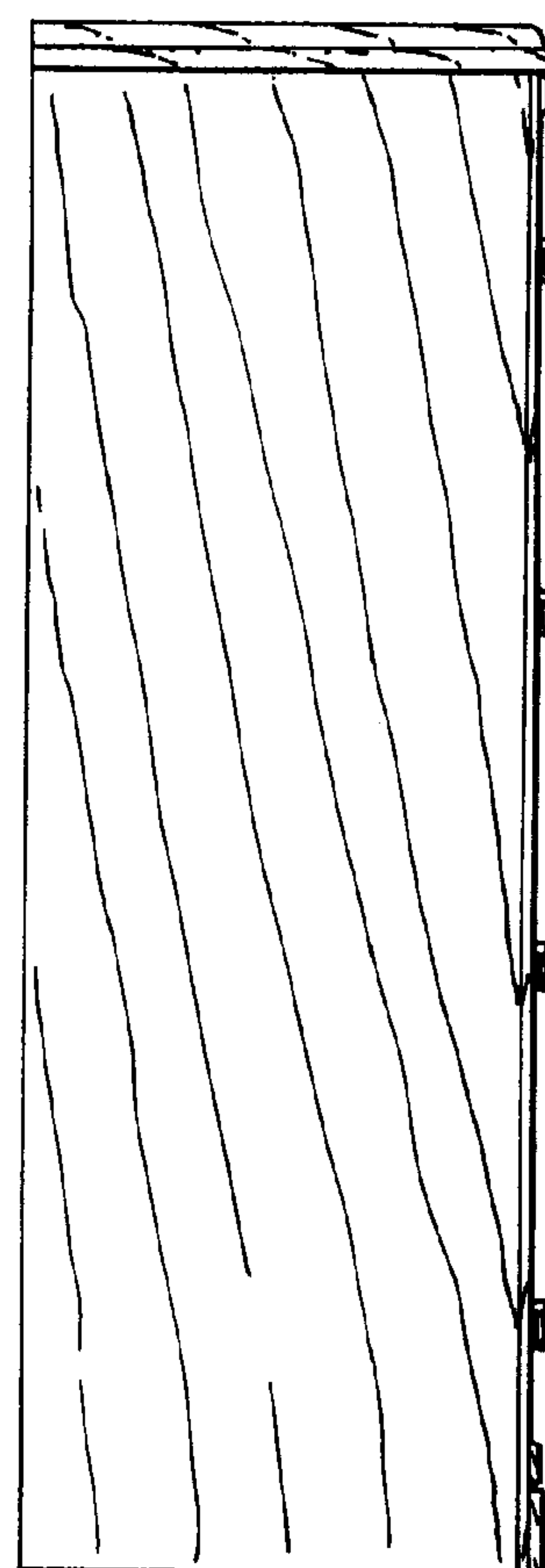

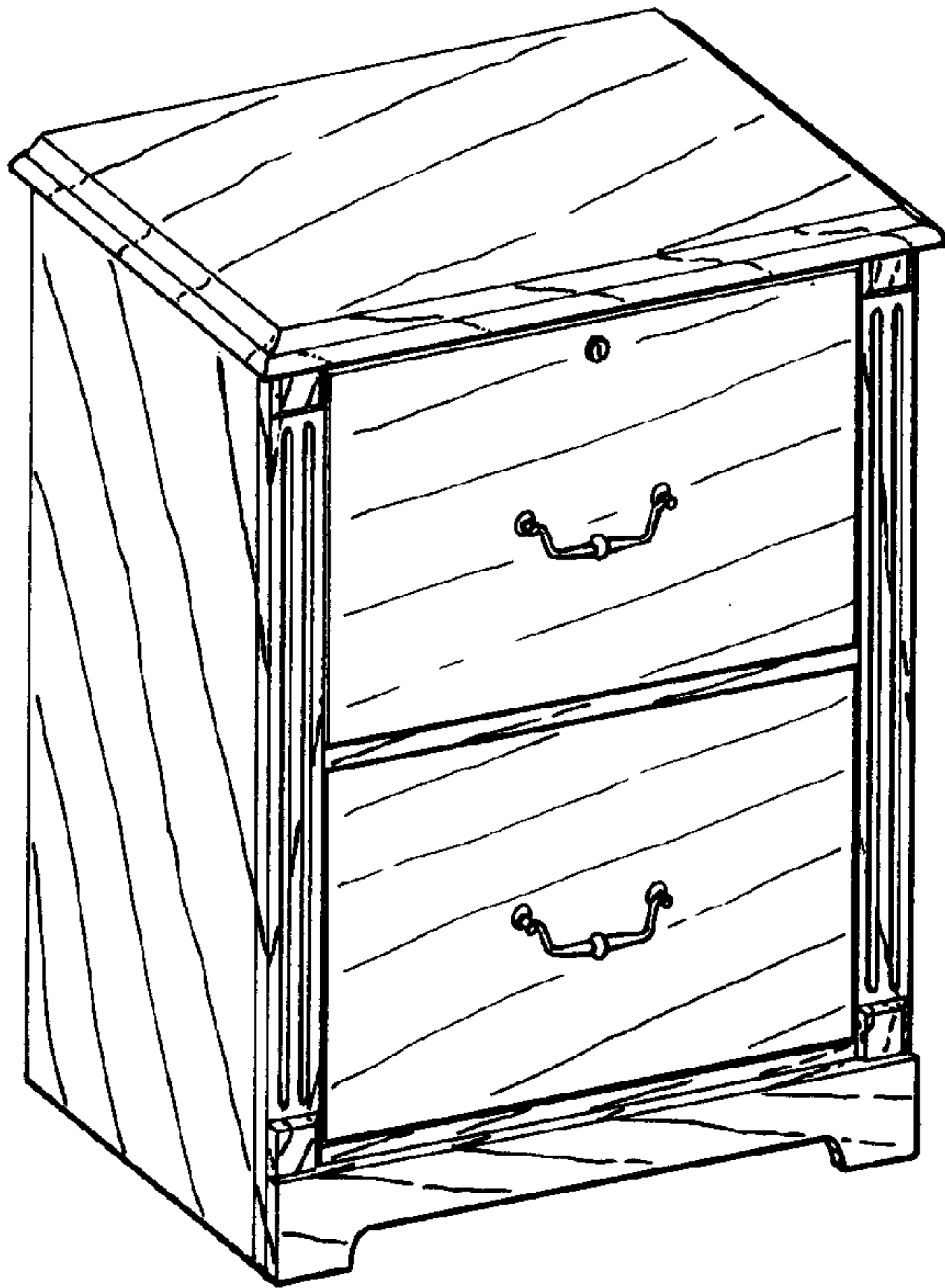

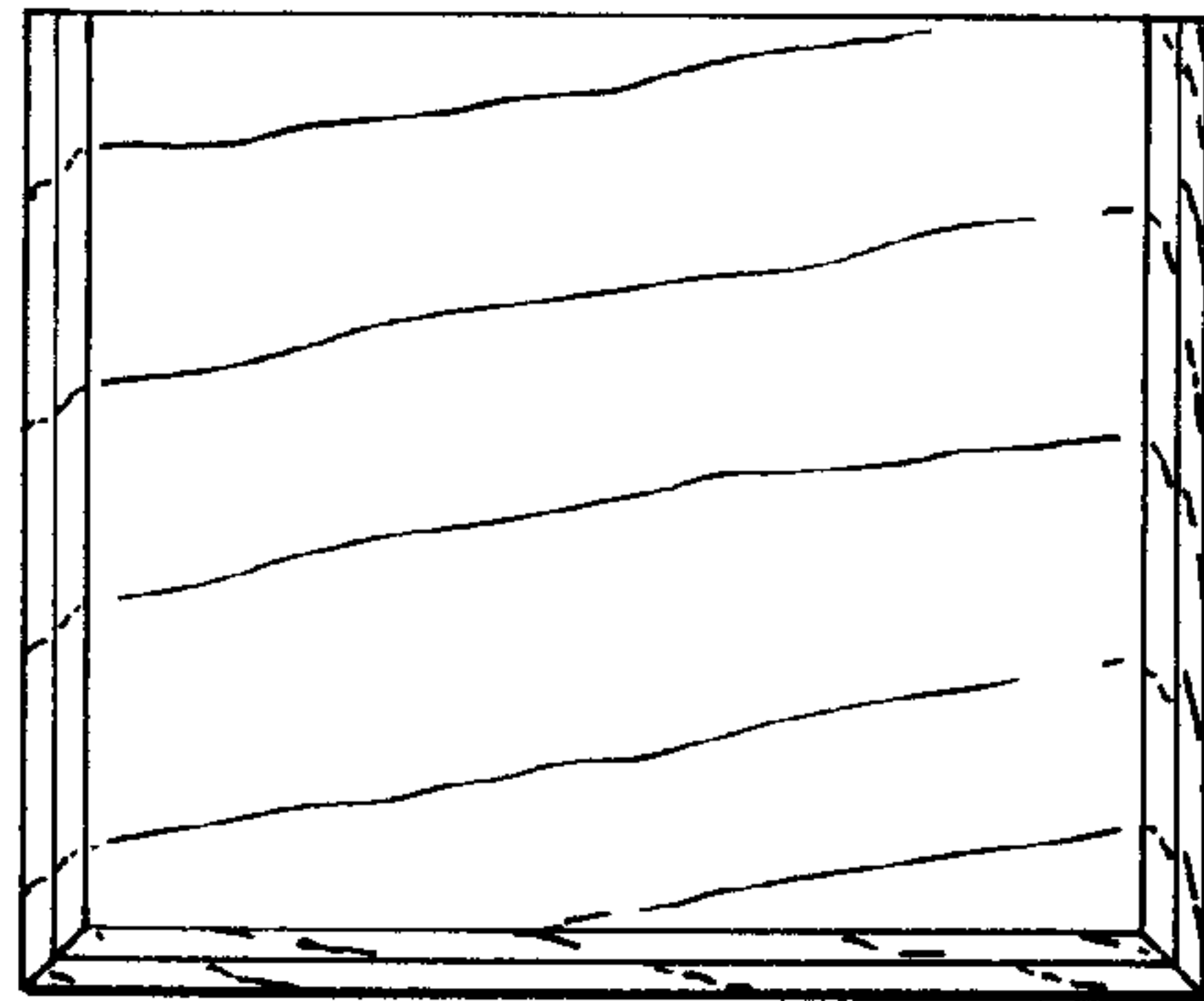

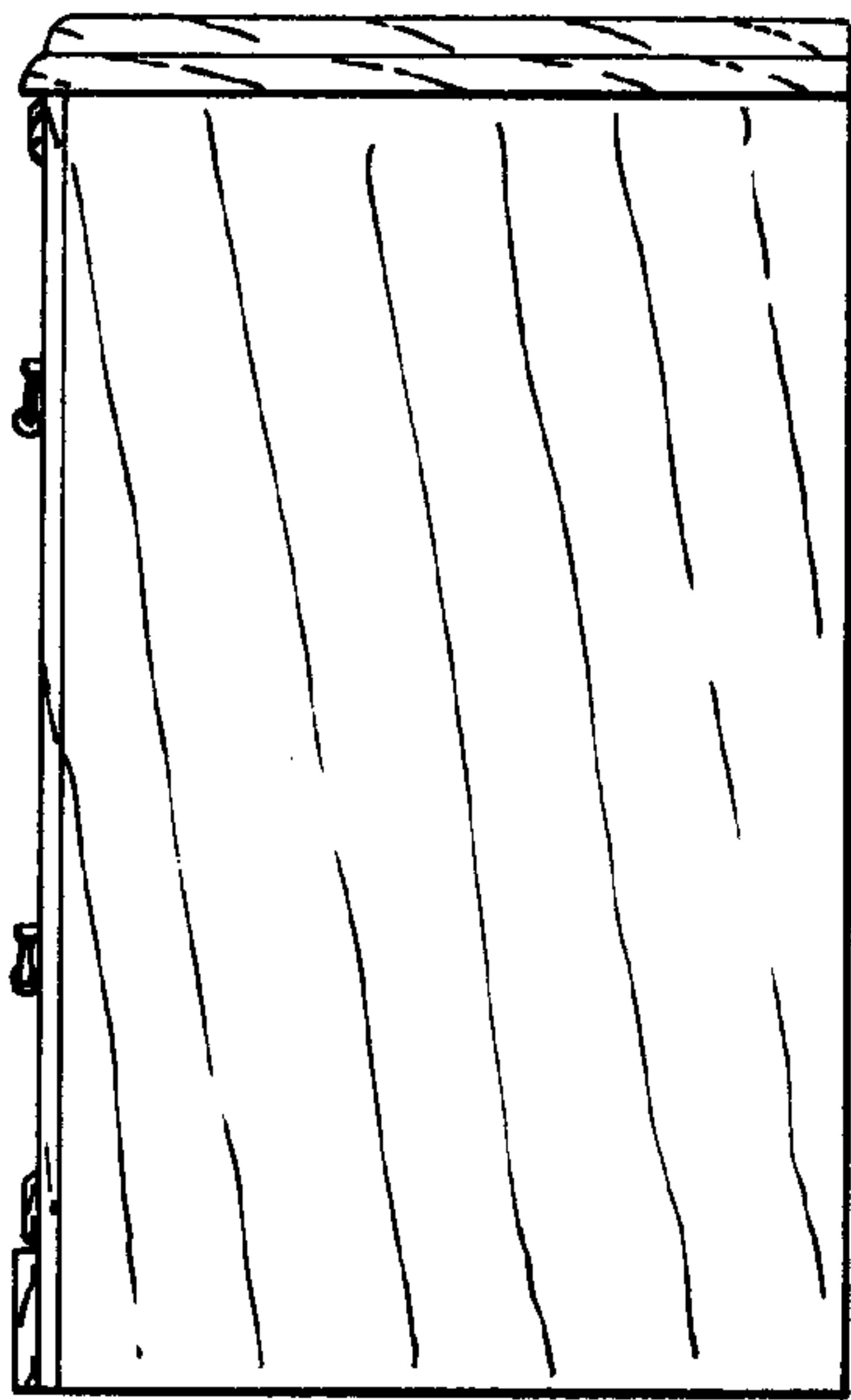




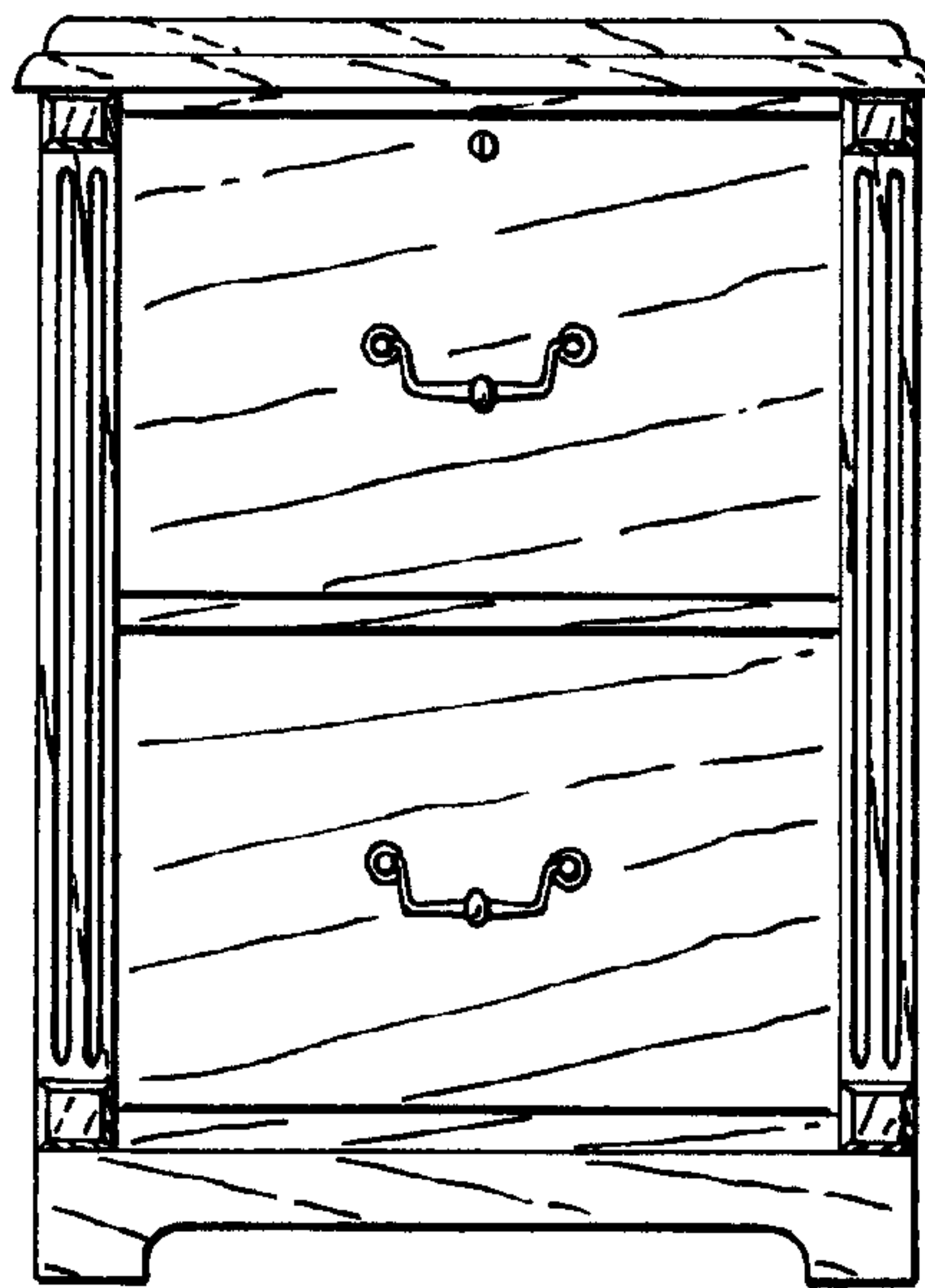

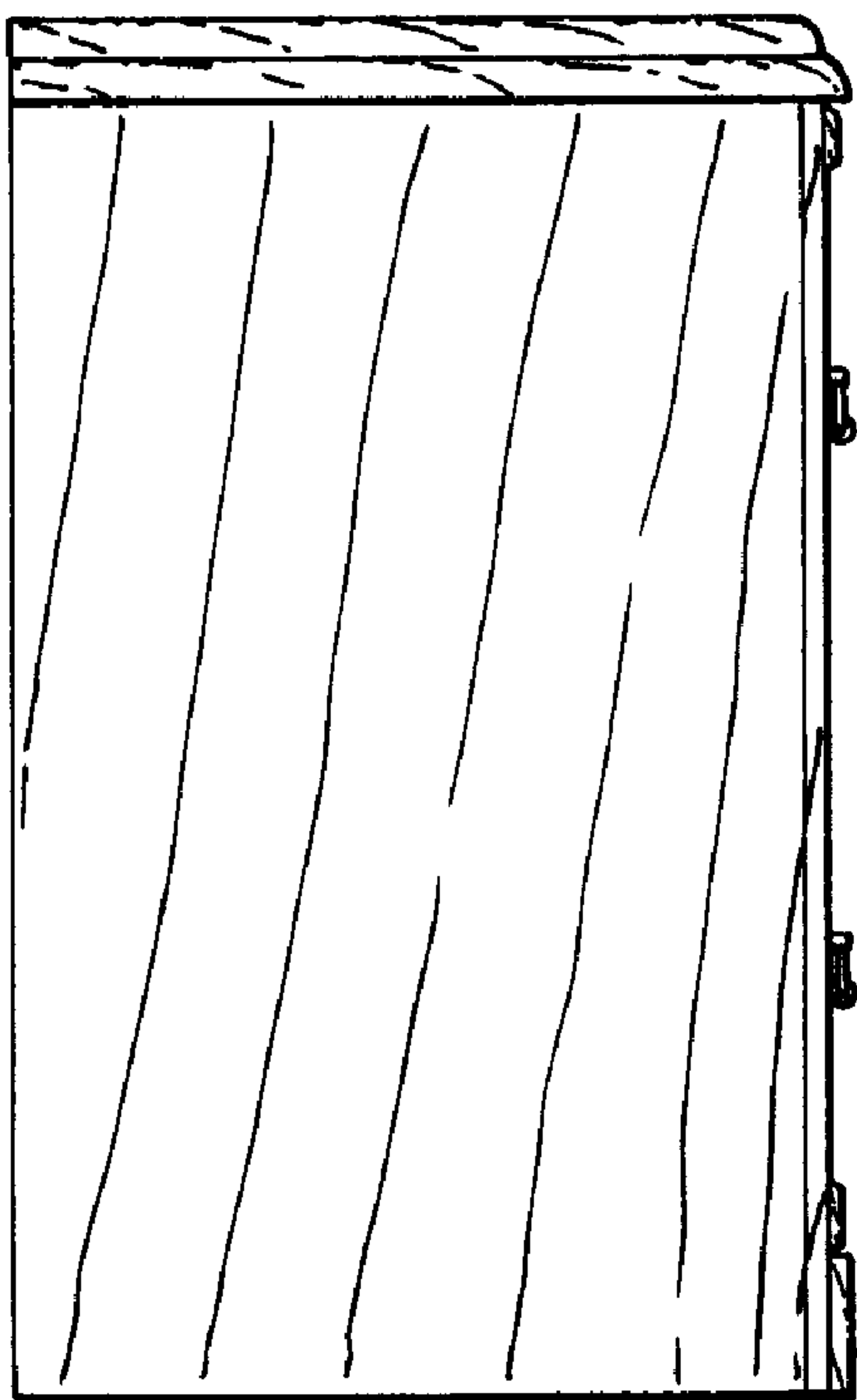

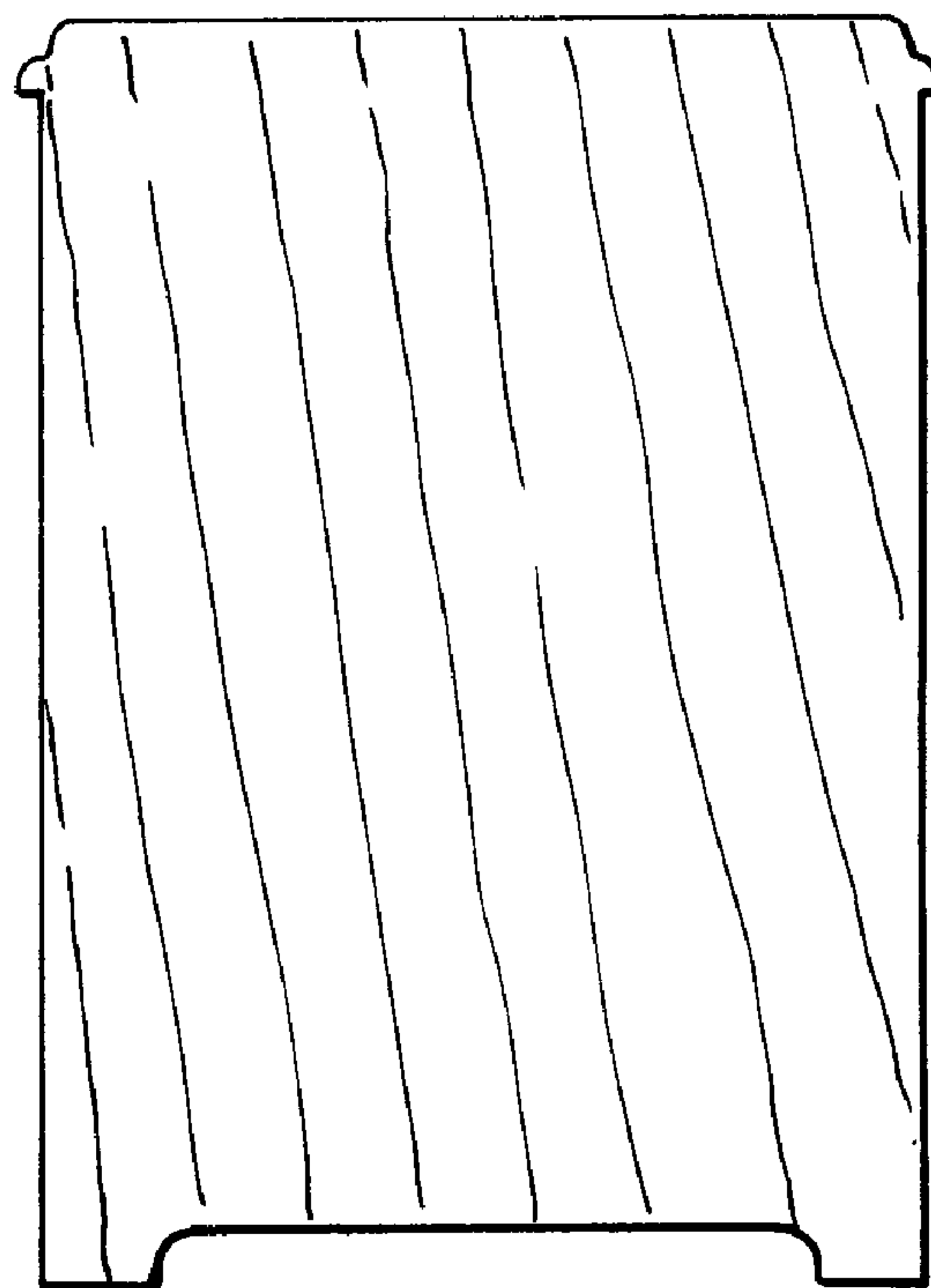

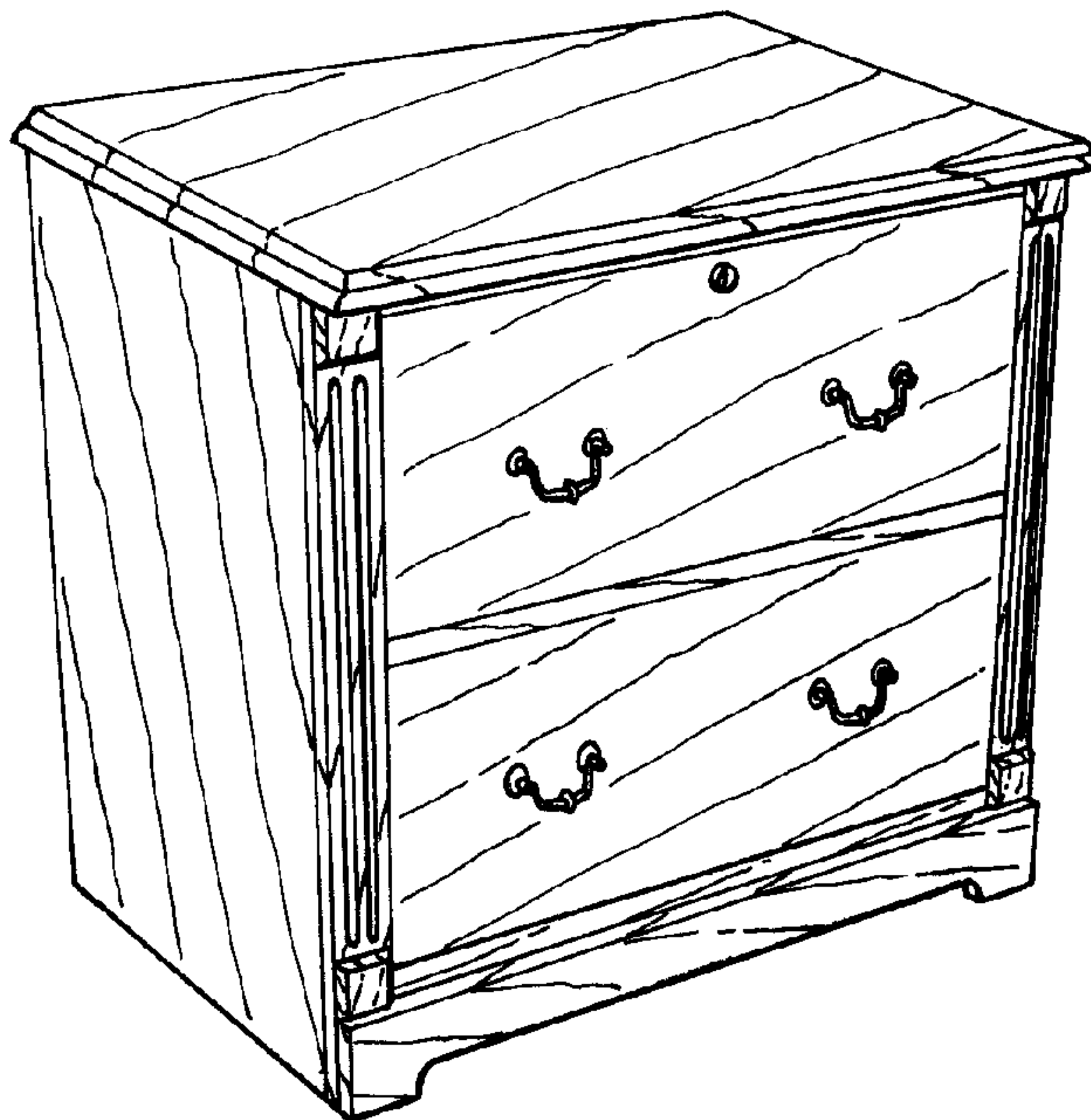

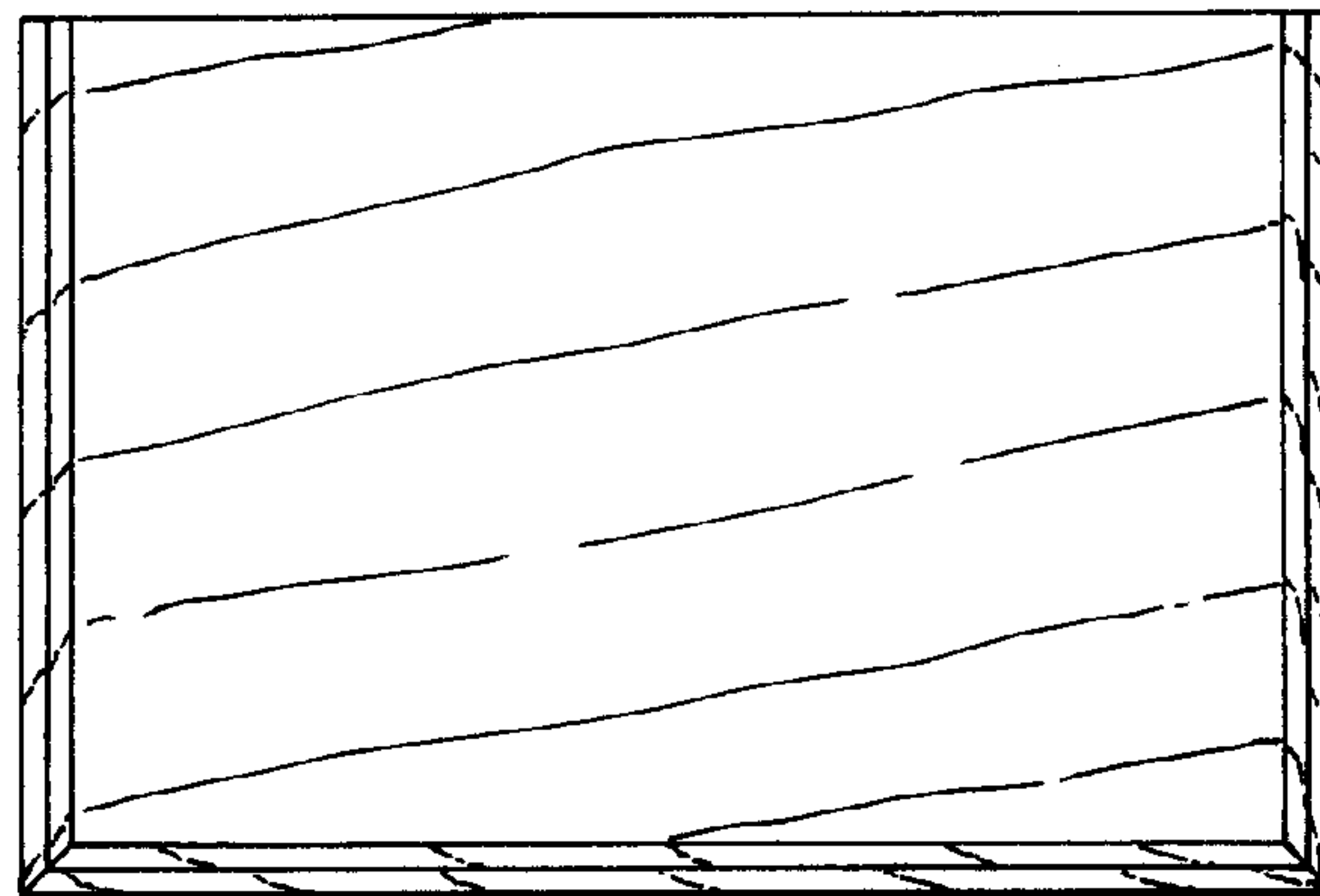

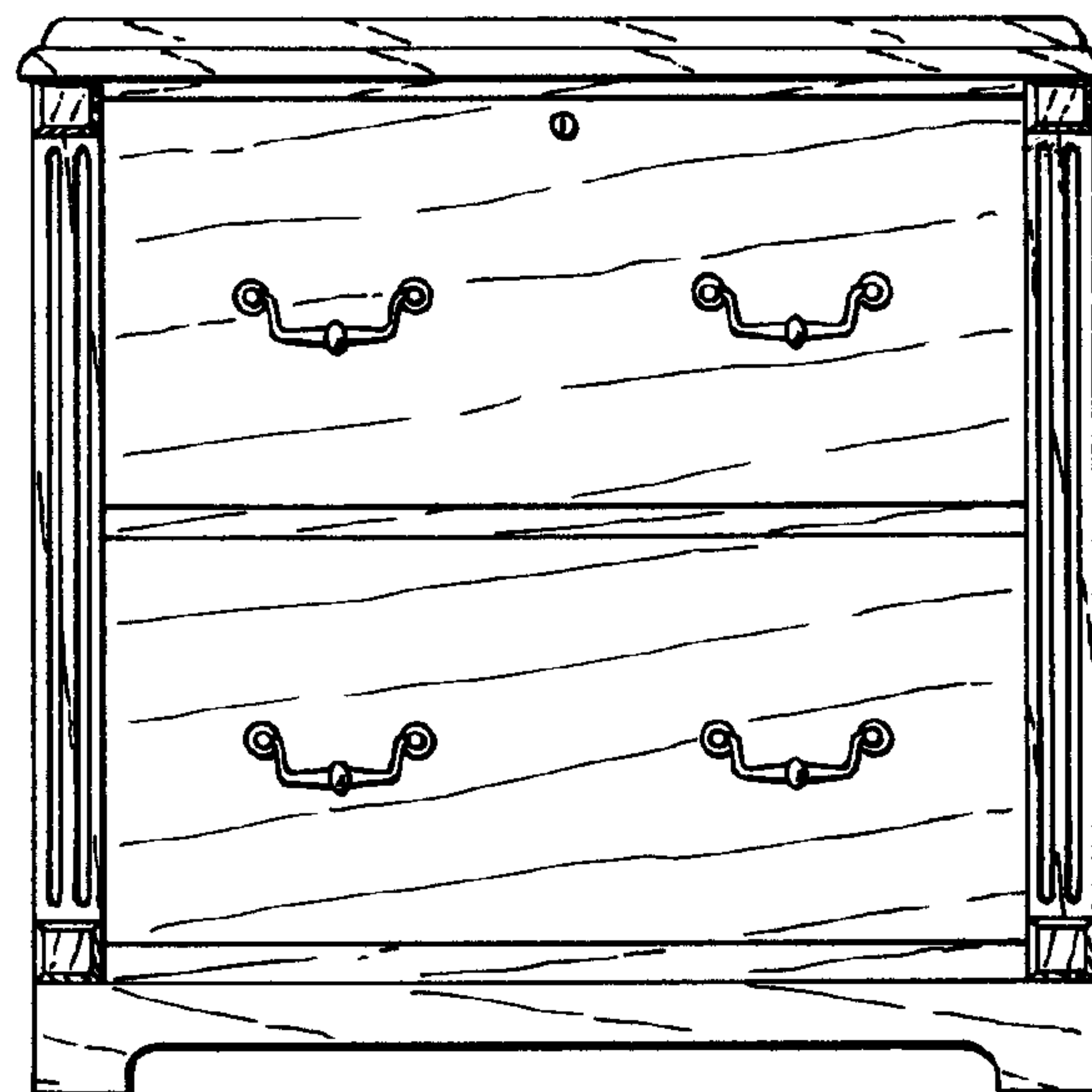

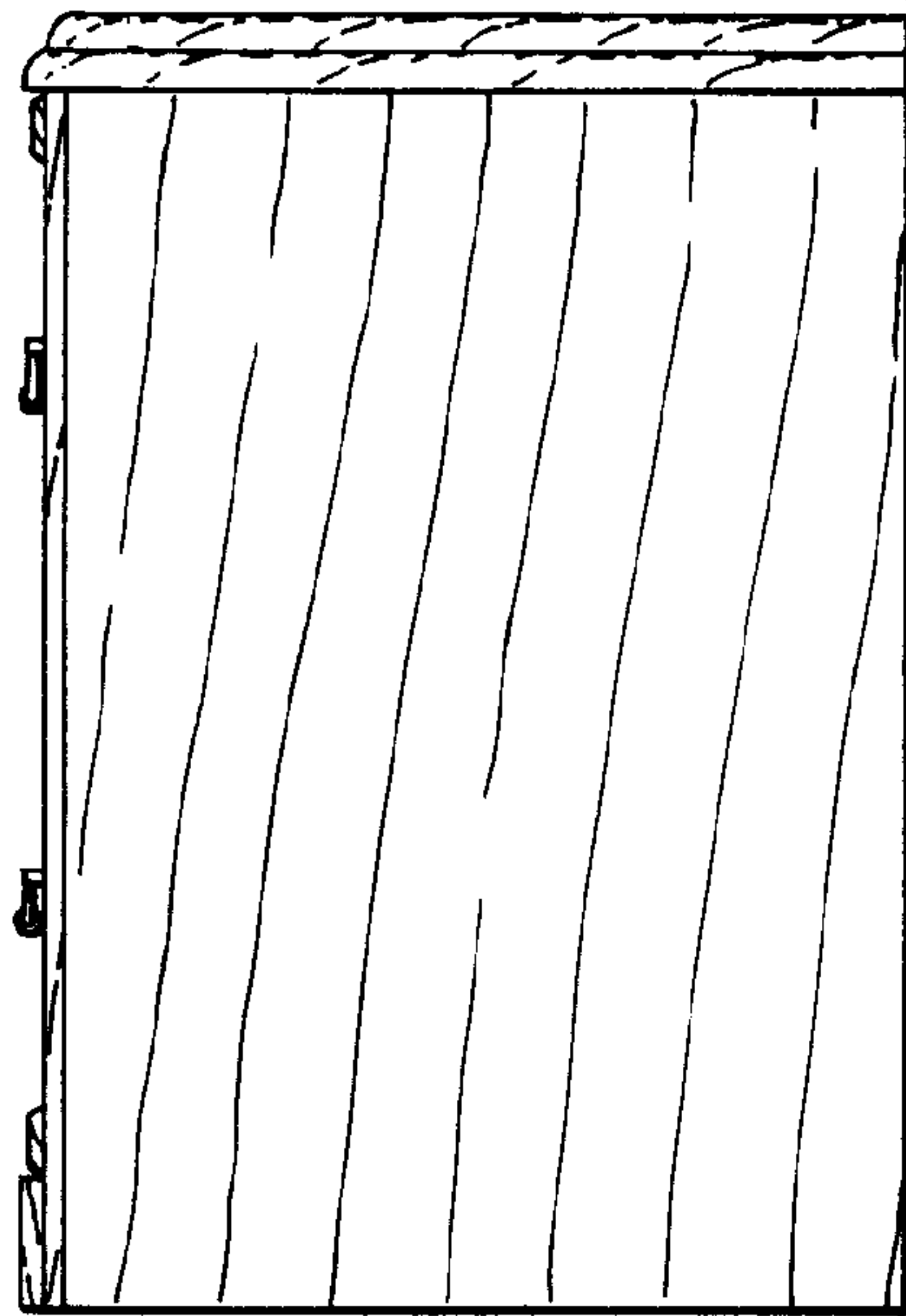

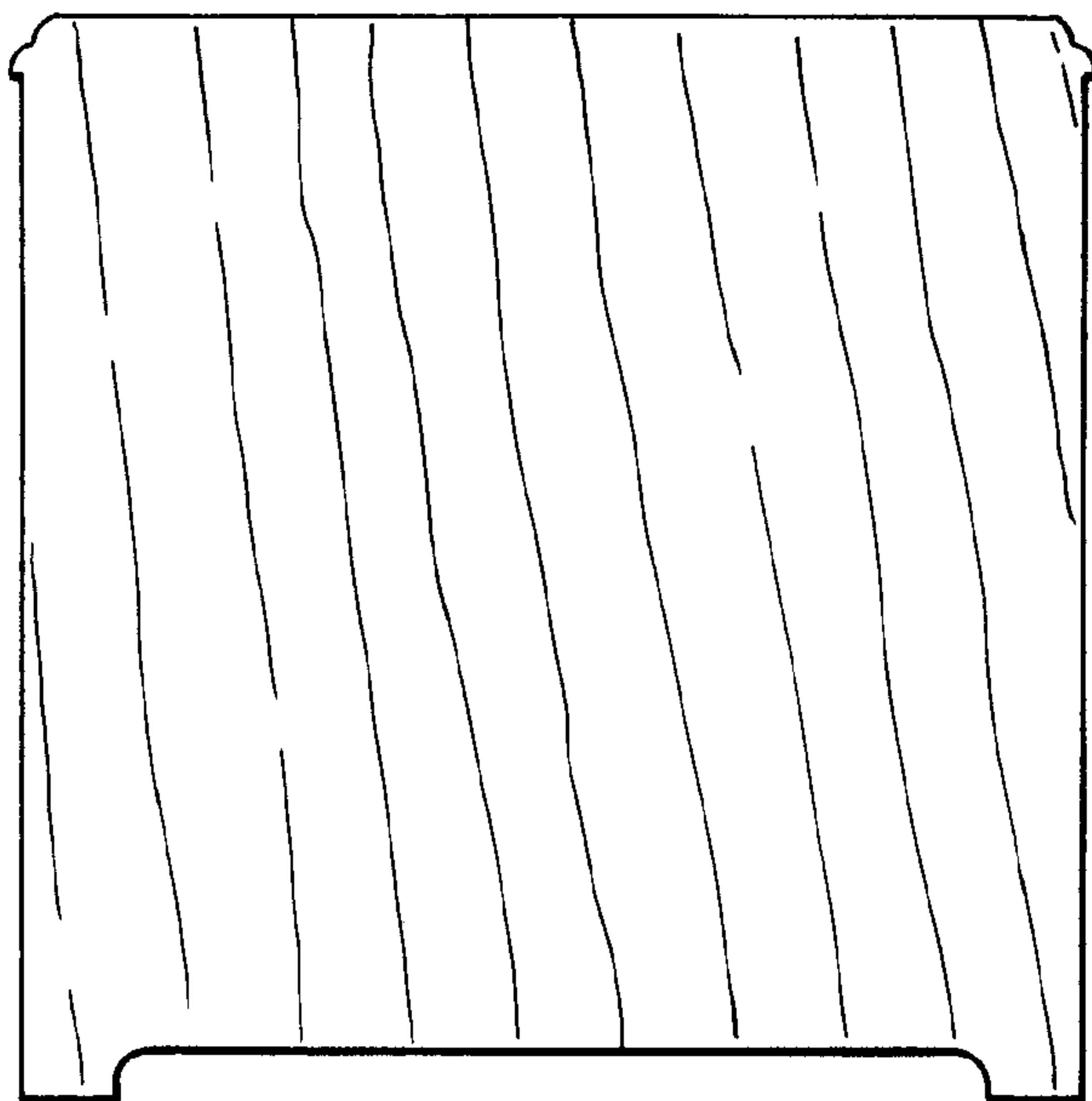

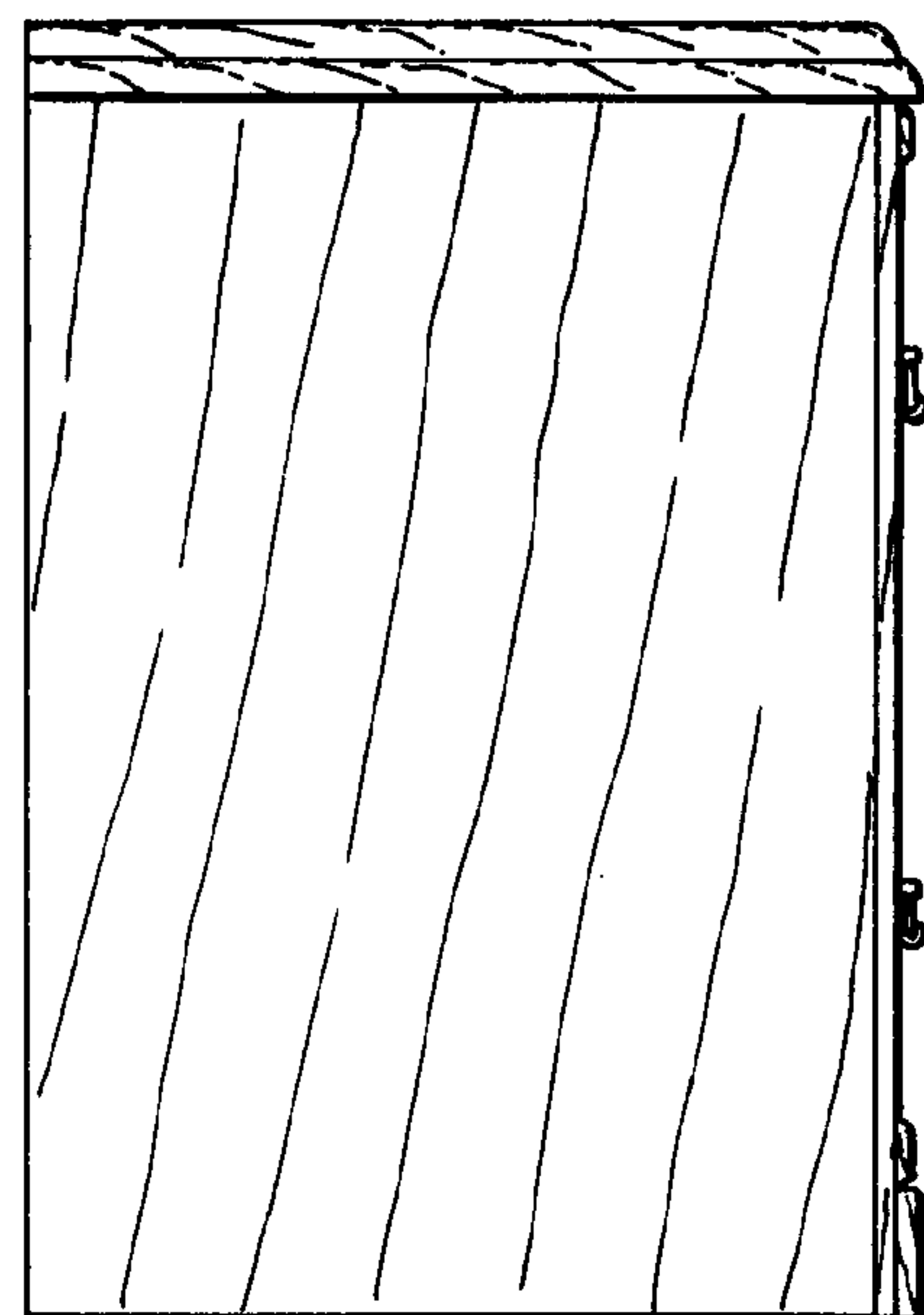
