(57) **CLAIM**

The ornamental design for a double-sided fuel pump beverage dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dispenser;

FIG. 2 is a front view of the dispenser, a back view being a mirror image thereof;

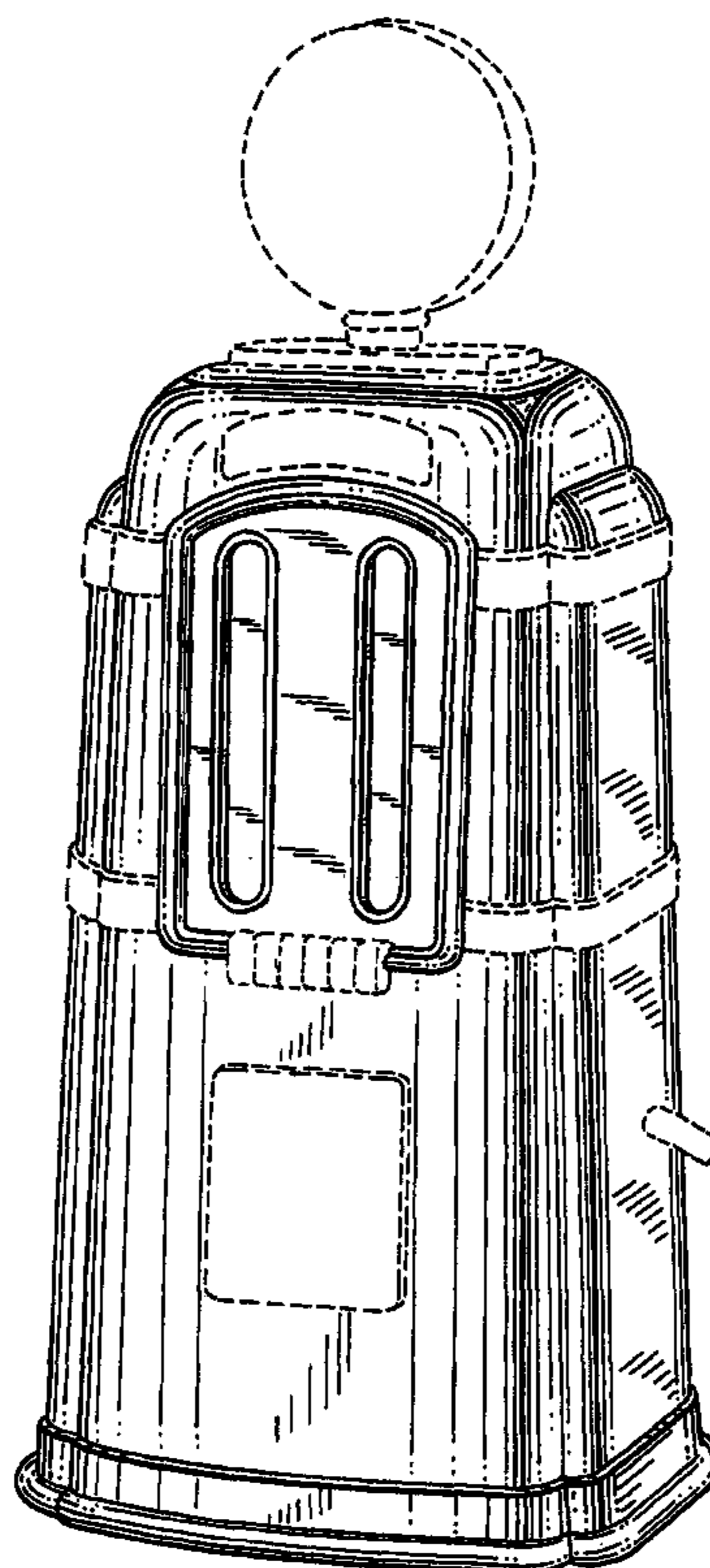
FIG. 3 is a top view thereof;

FIG. 4 is a right-sided view of the dispenser, a left side view being mirror image thereof, and,

FIG. 5 is bottom view thereof.

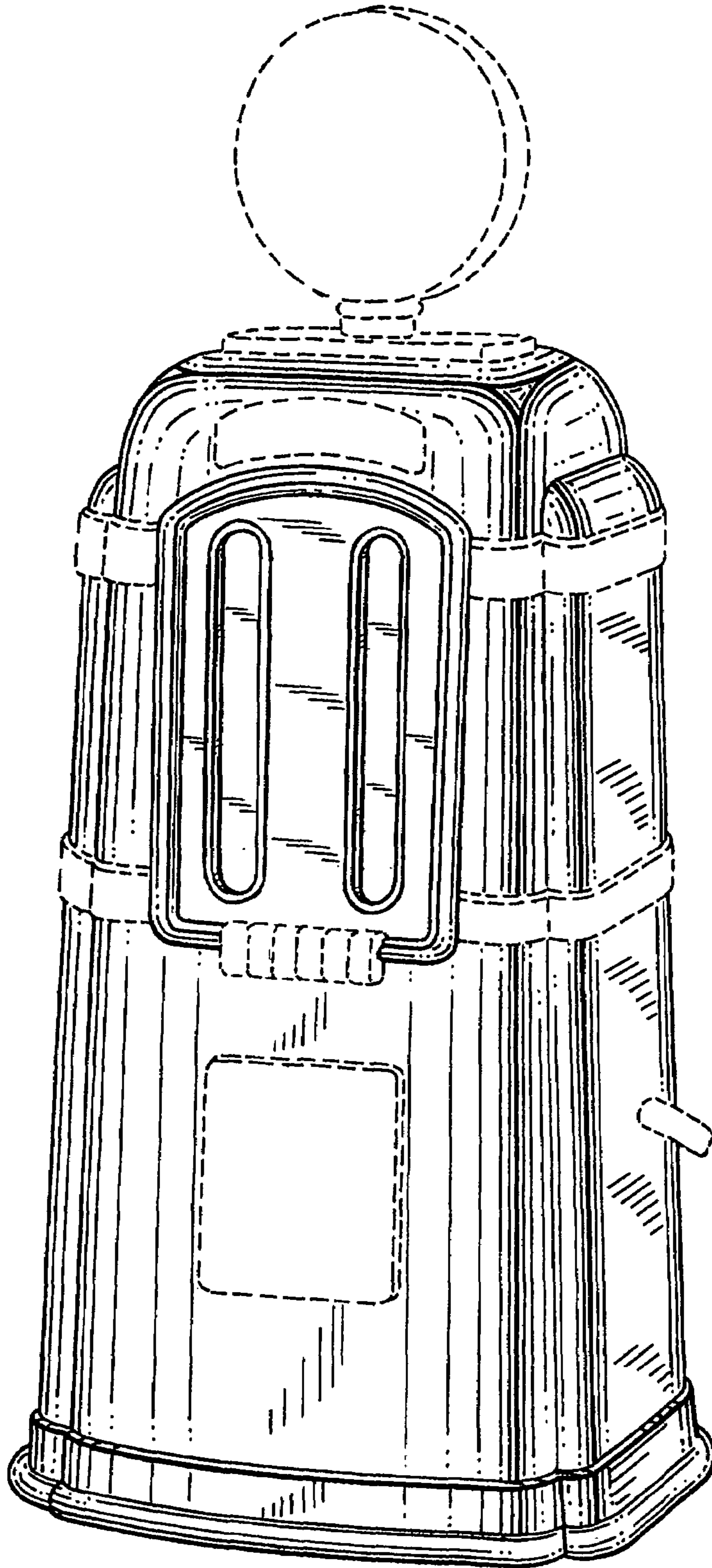

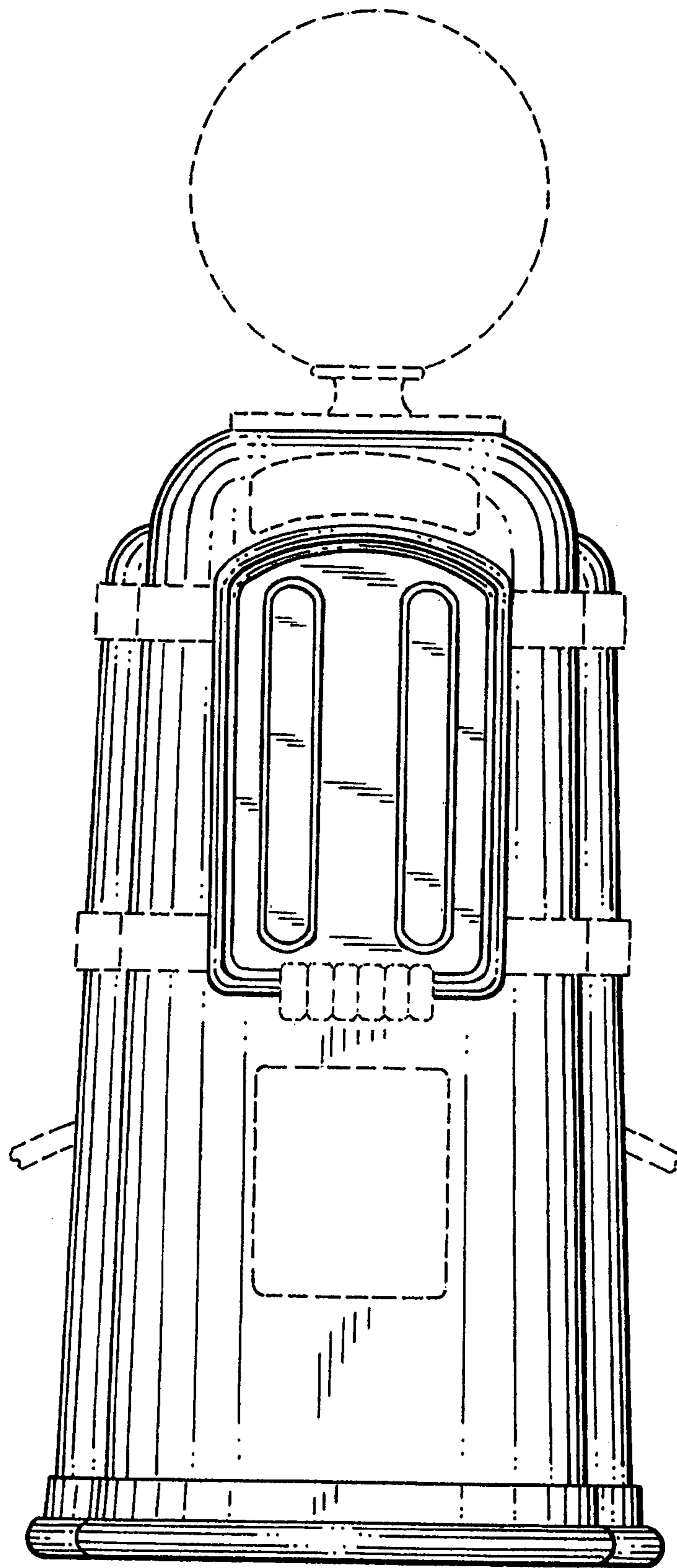

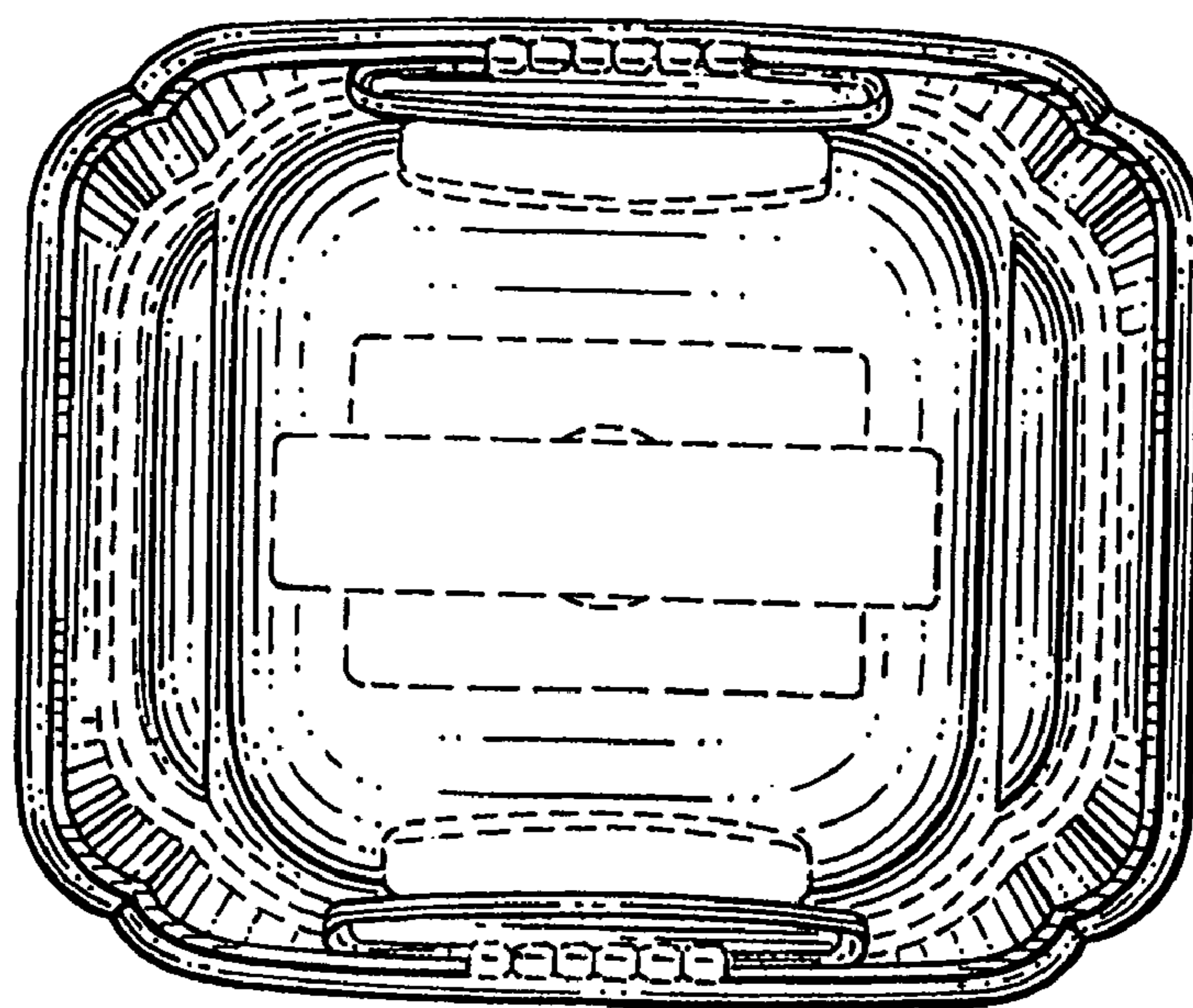

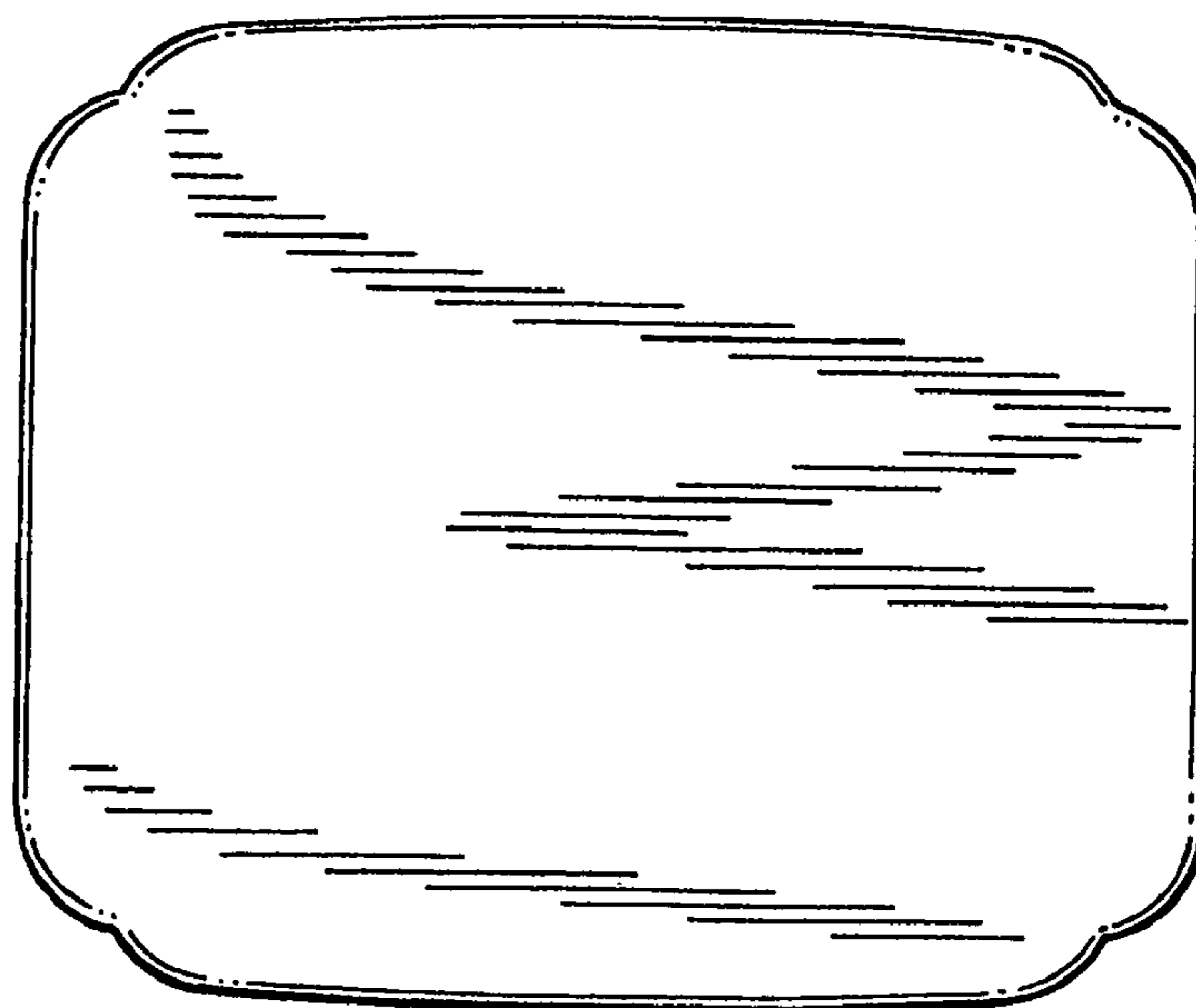

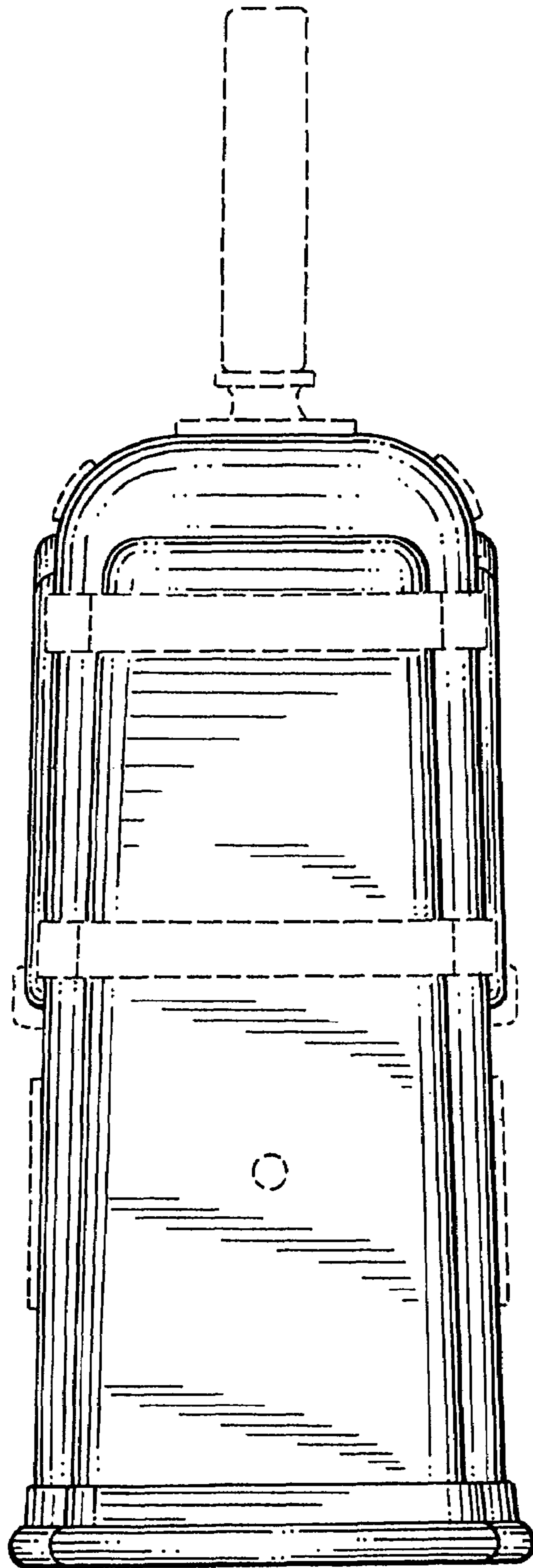
