The ornamental design for a cookware side handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a reduced perspective view of the cookware side handle, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevation thereof;

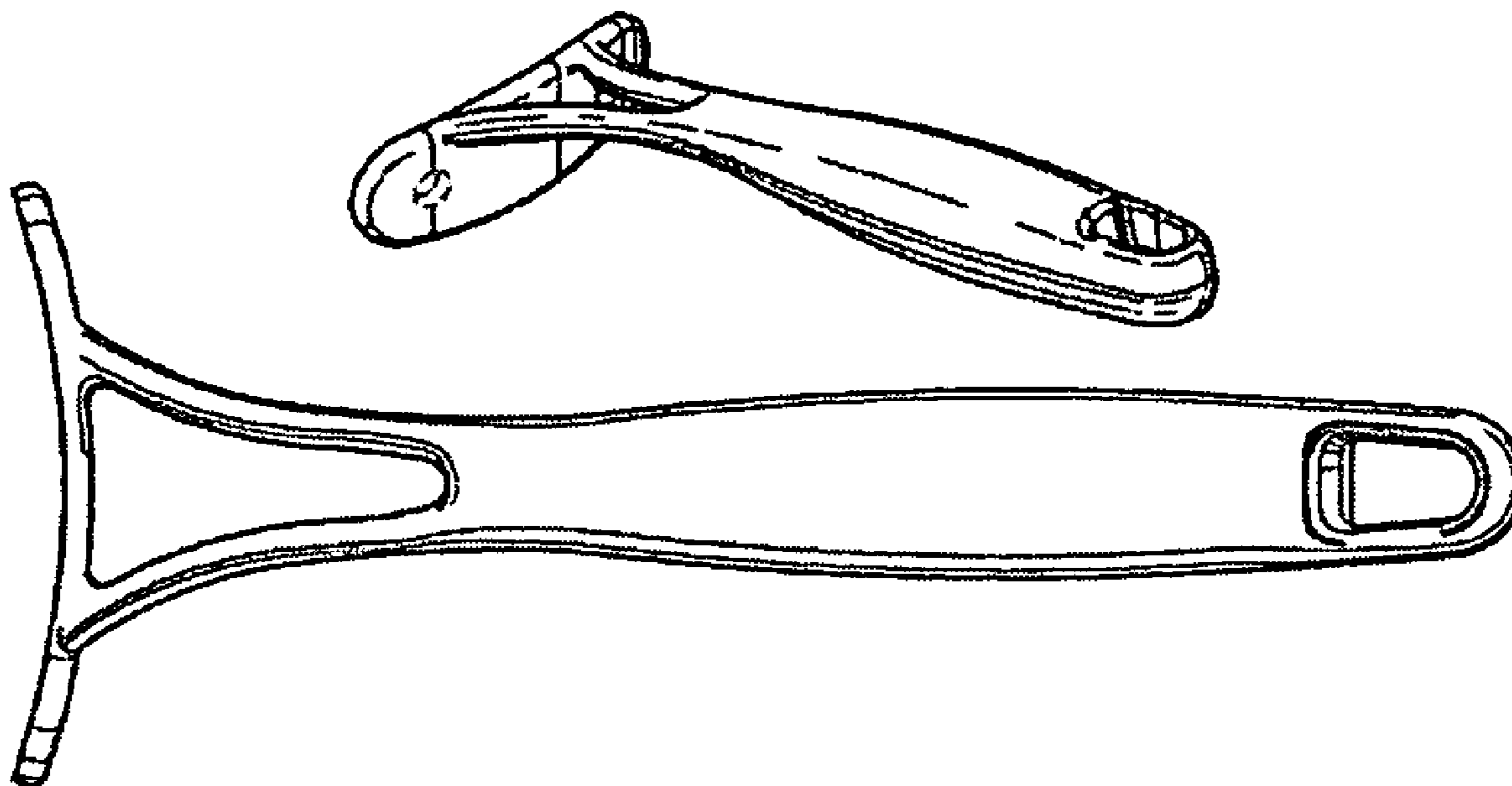
FIG. 4 is a right side elevational view thereof;

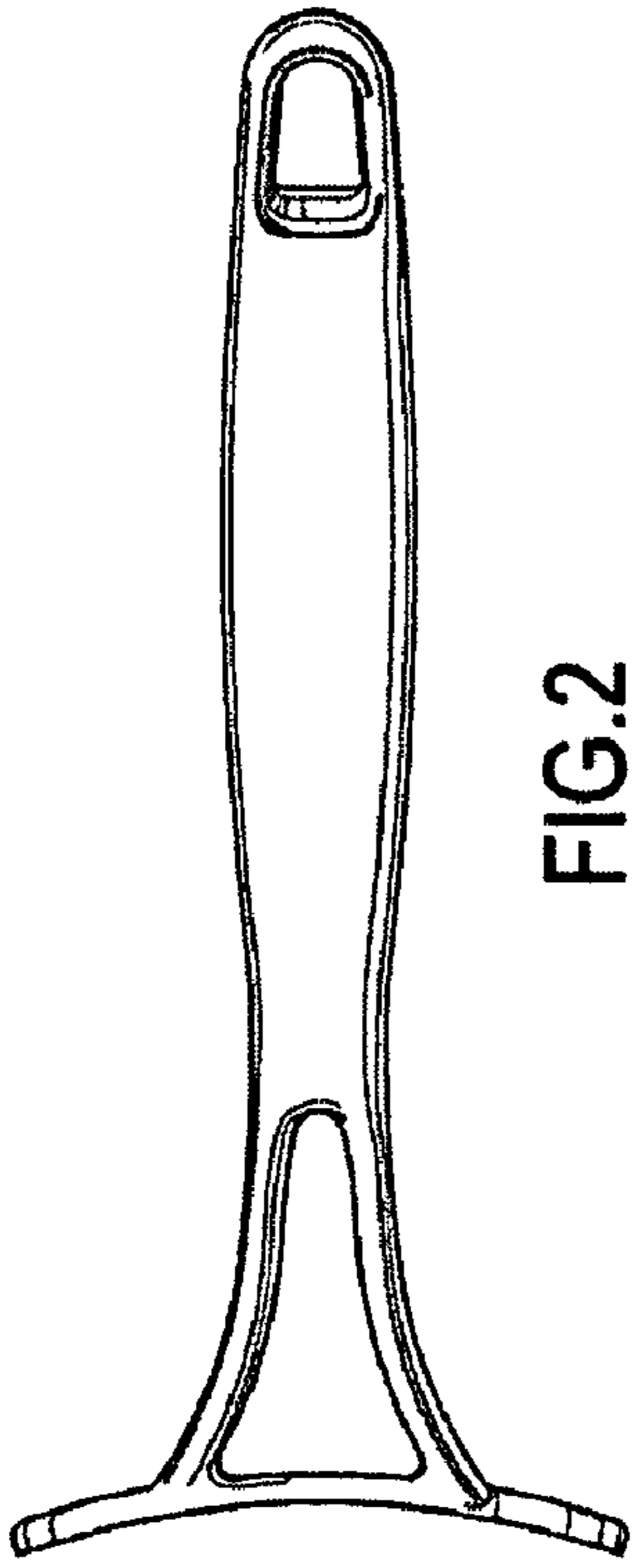

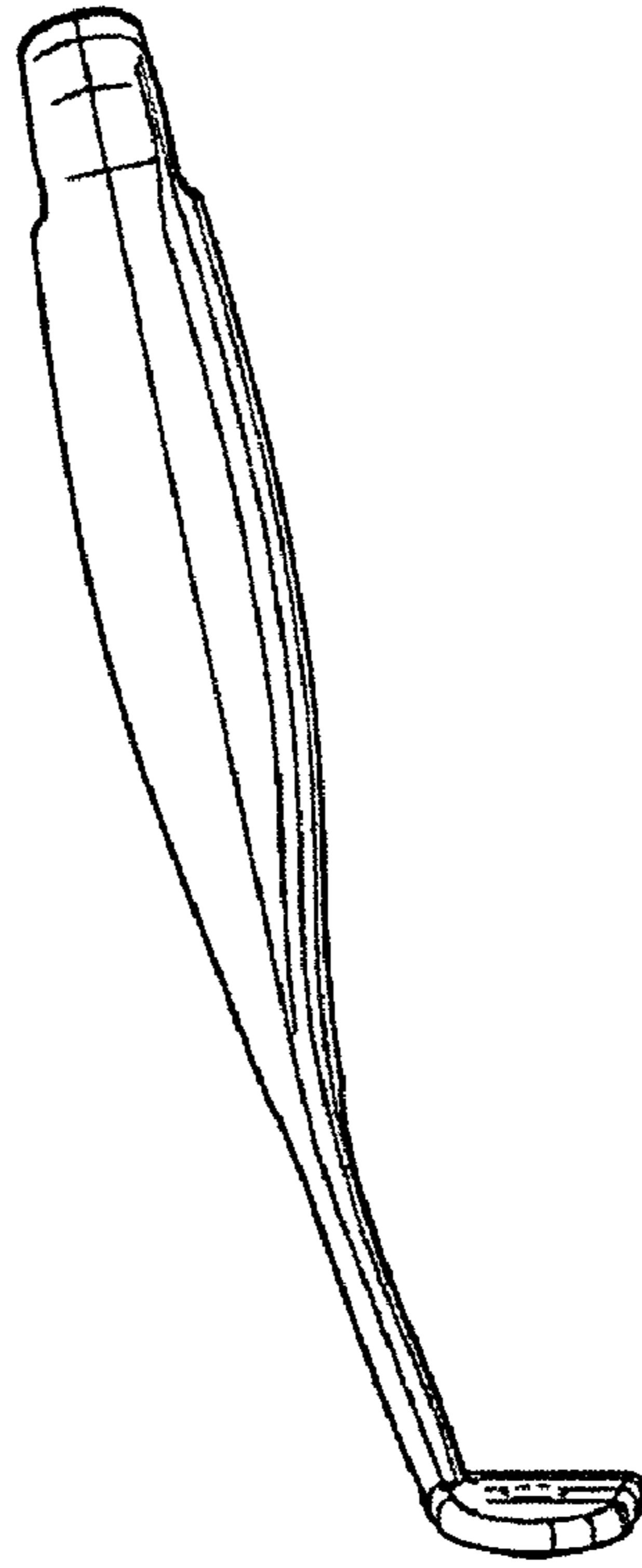

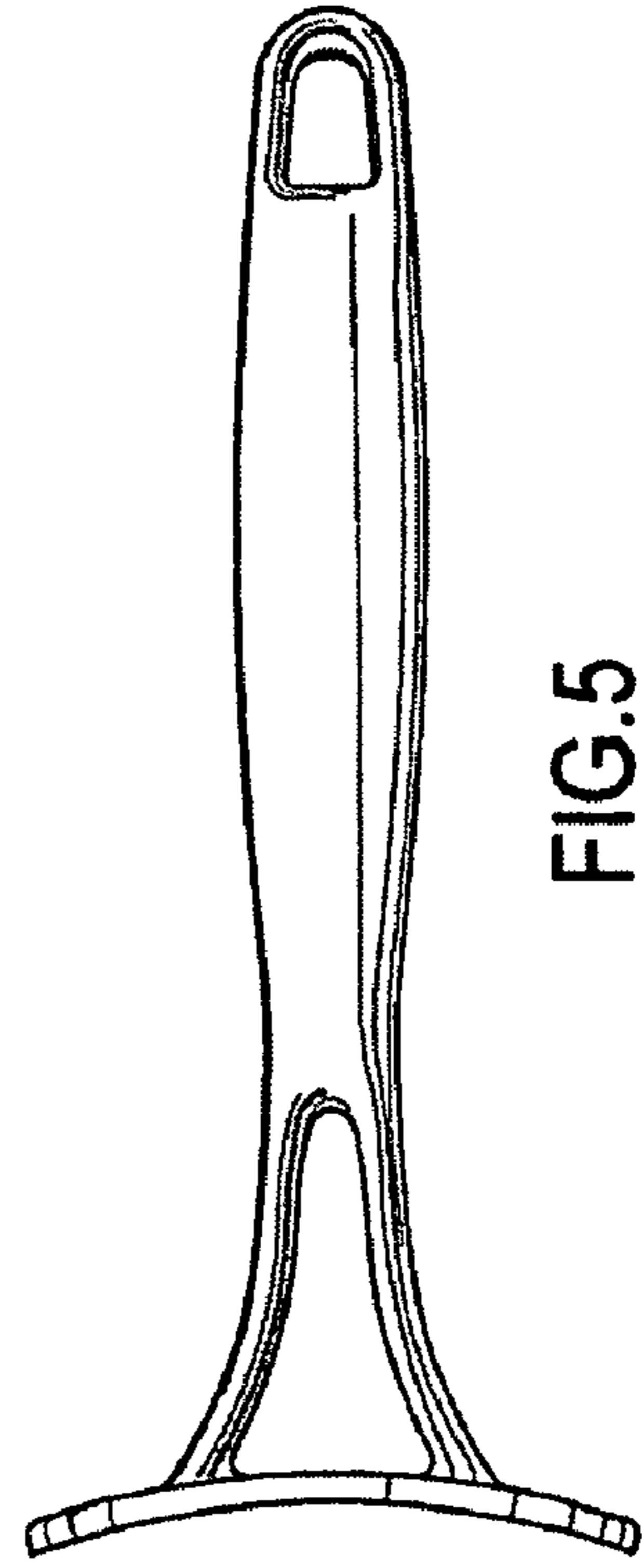

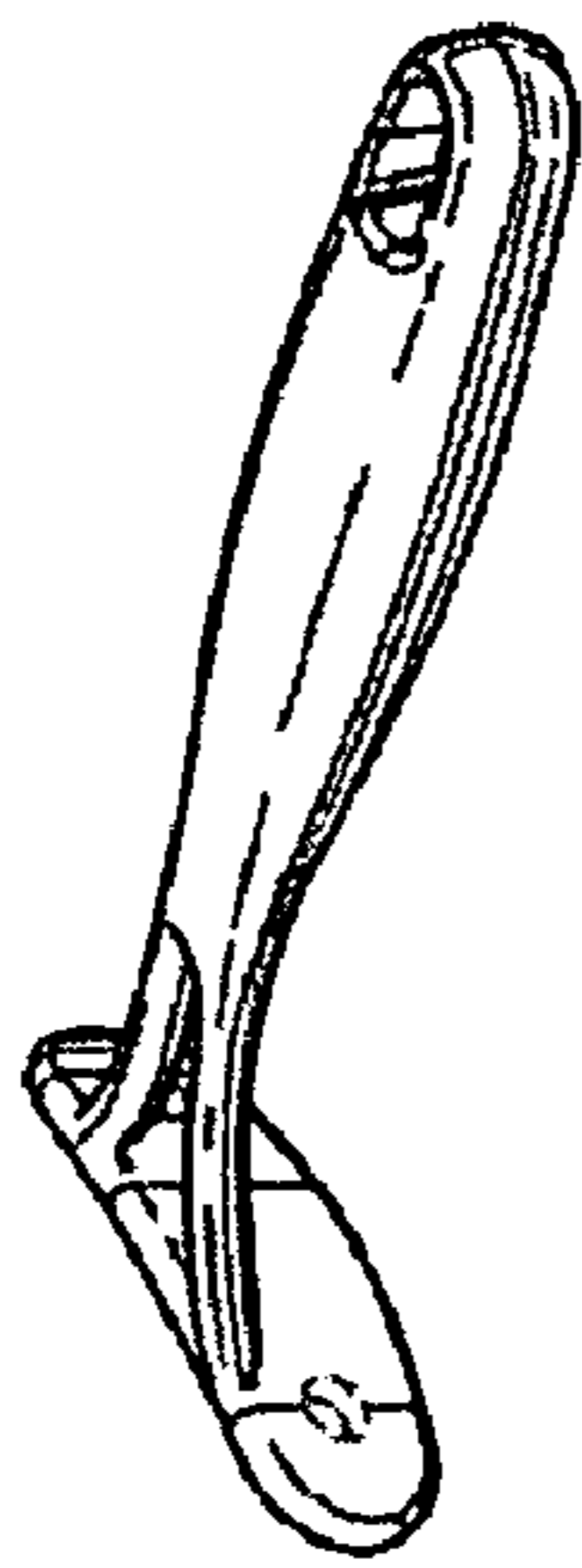

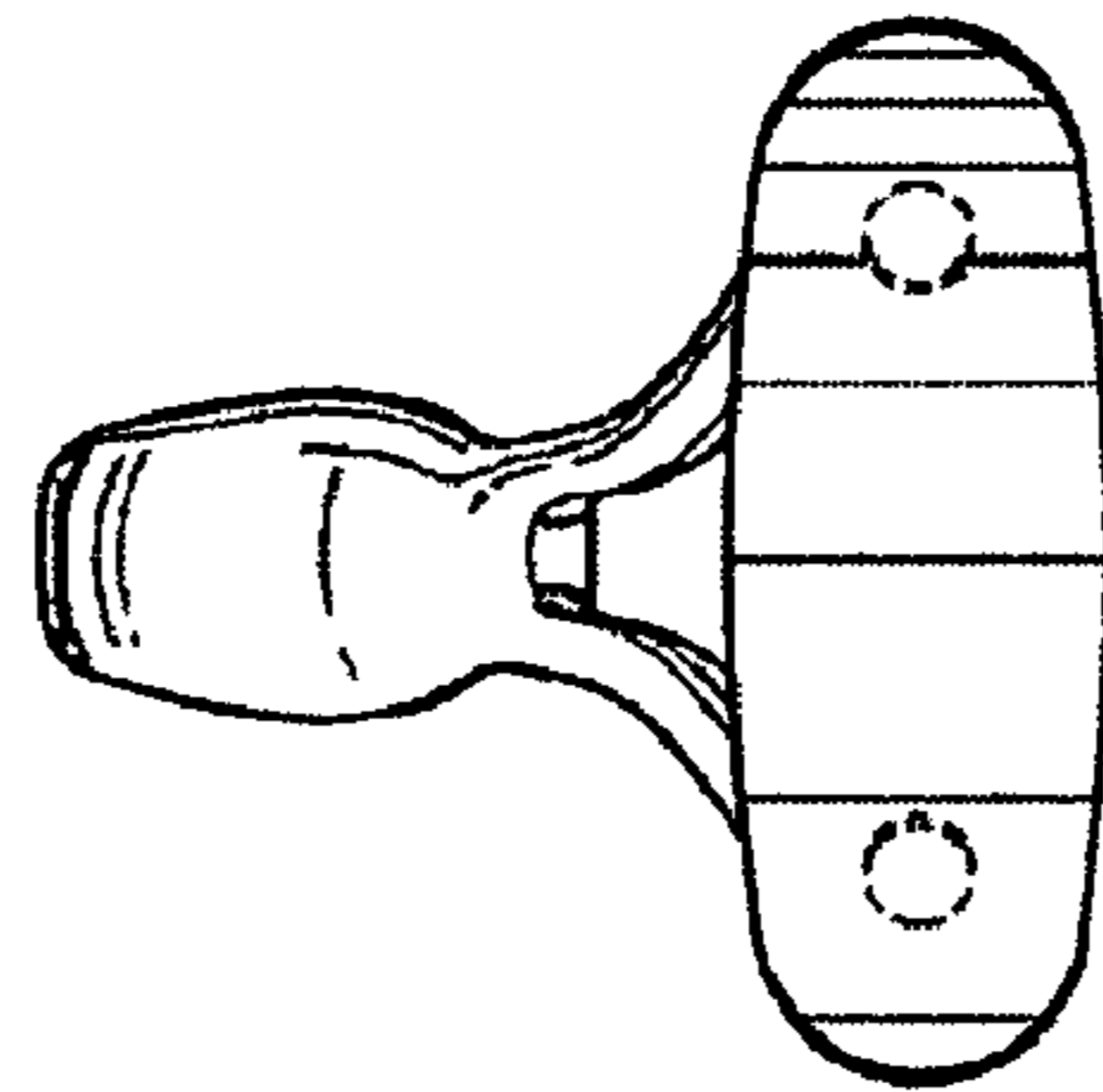

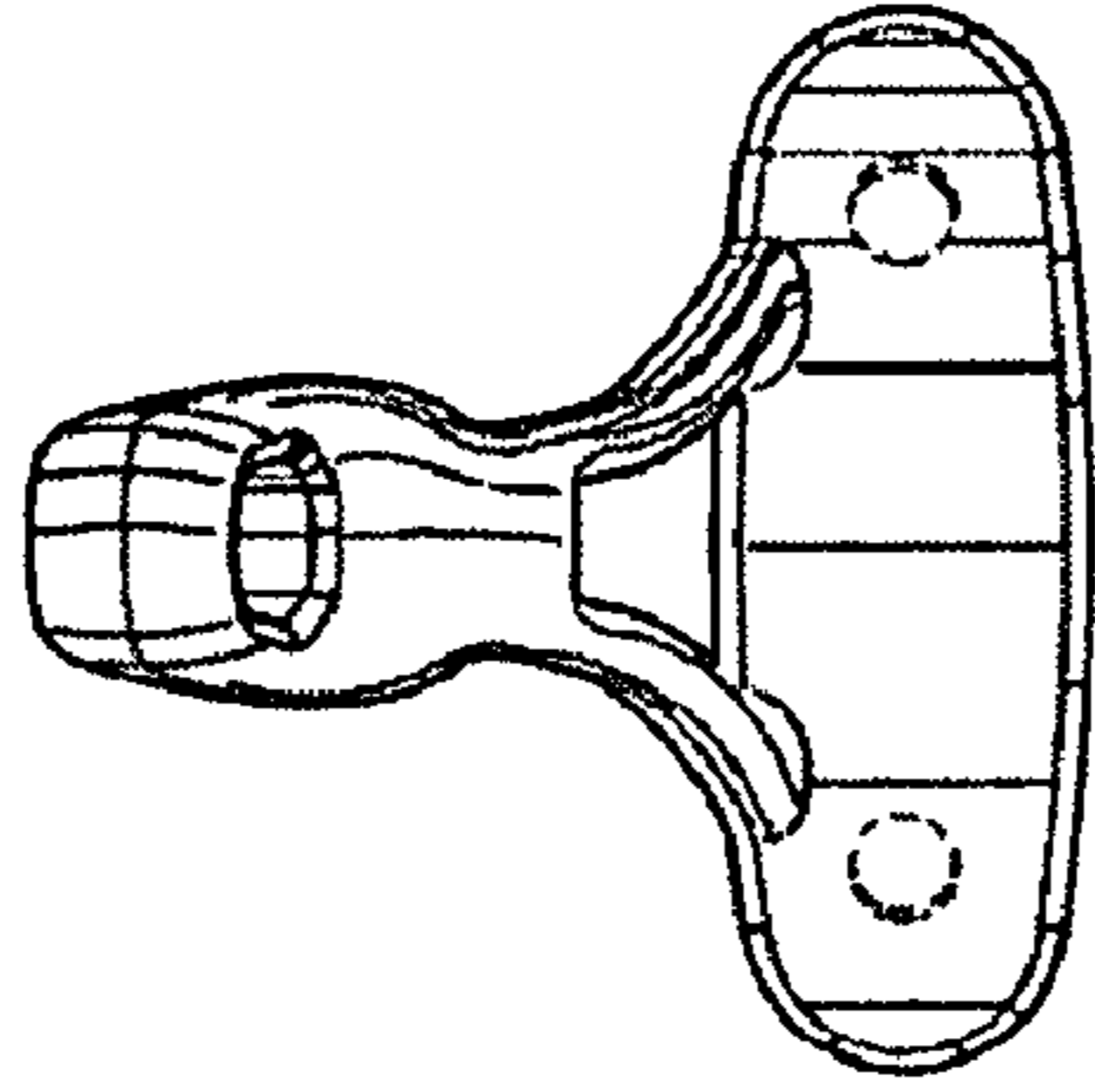
