FIG. 3 is a rear side perspective view.

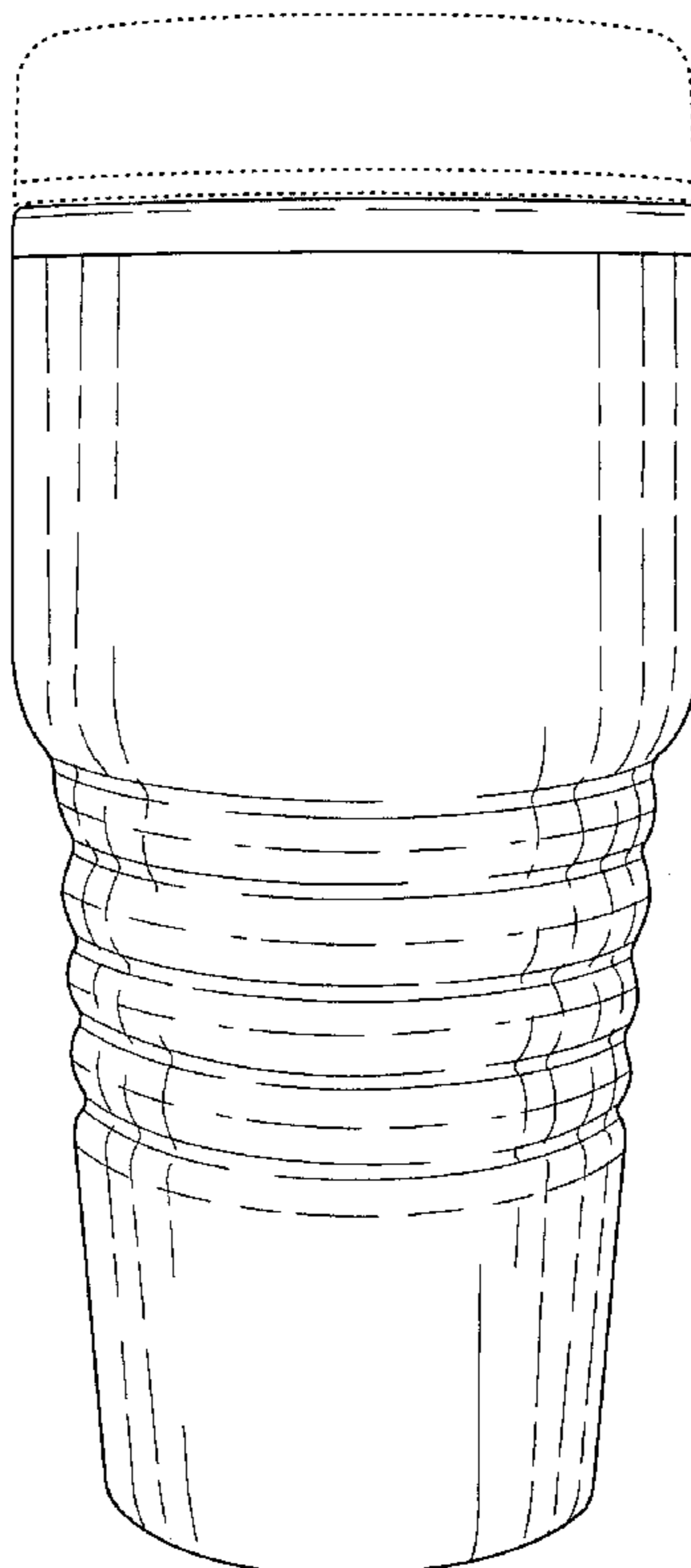
FIG. 4 is a left side perspective view.

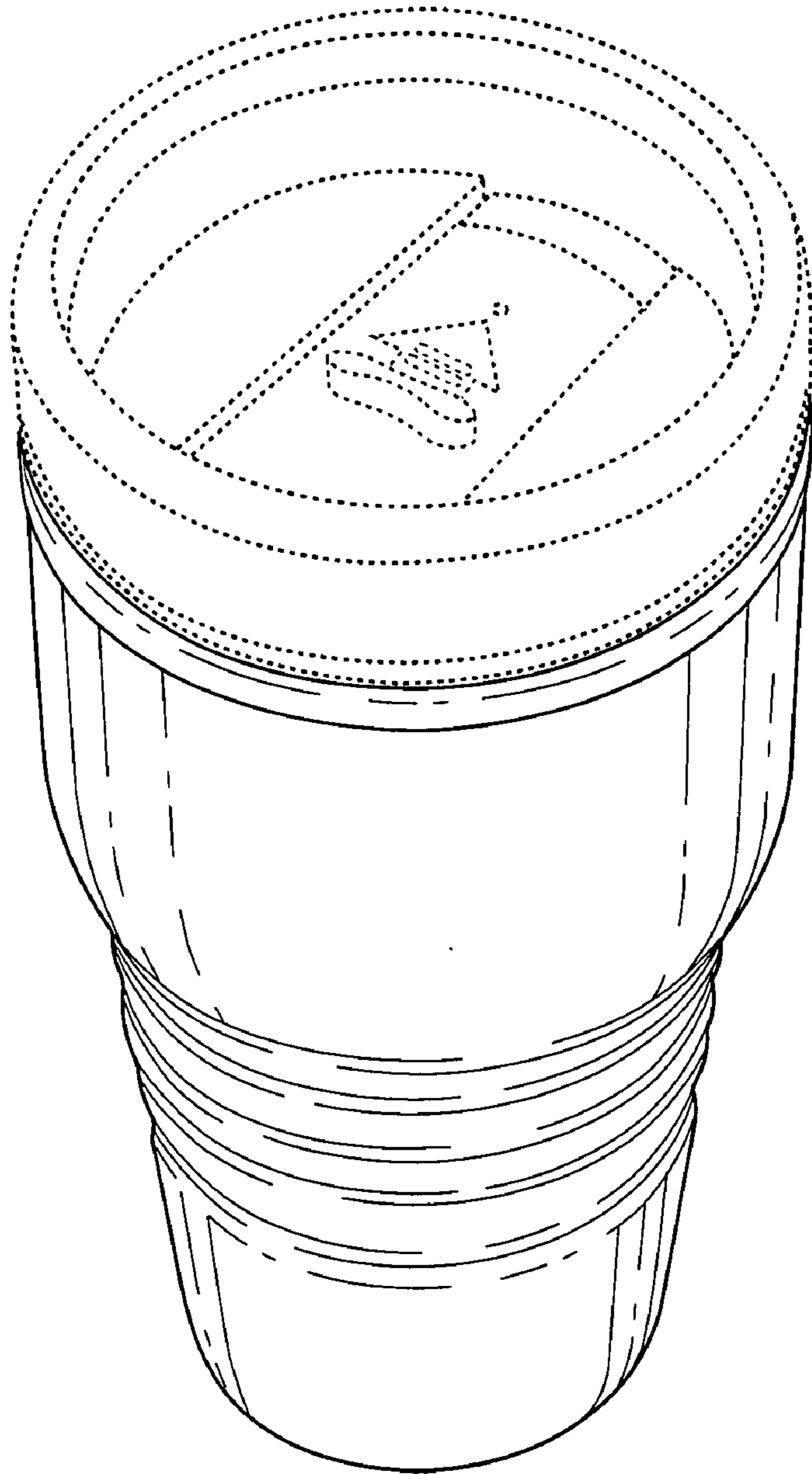
FIG. 5 is a right side perspective view.

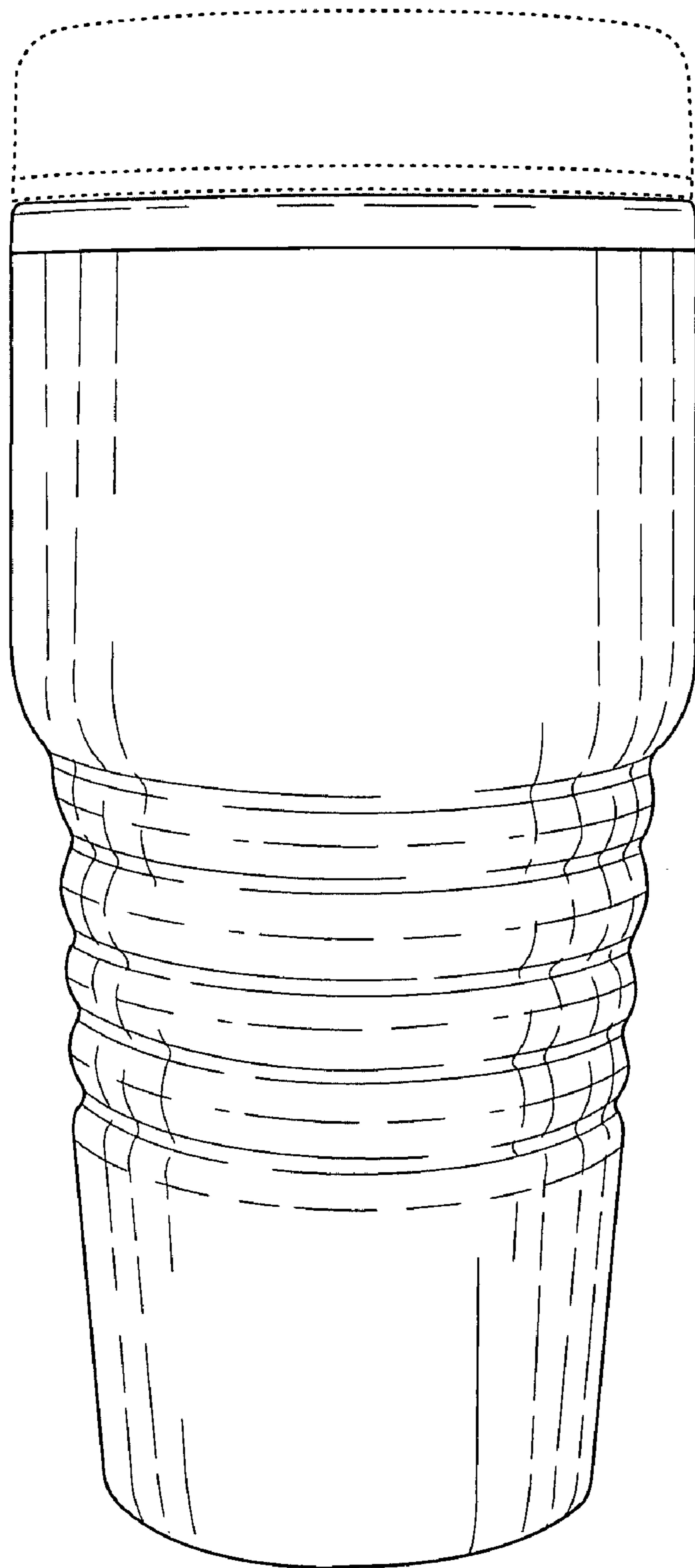

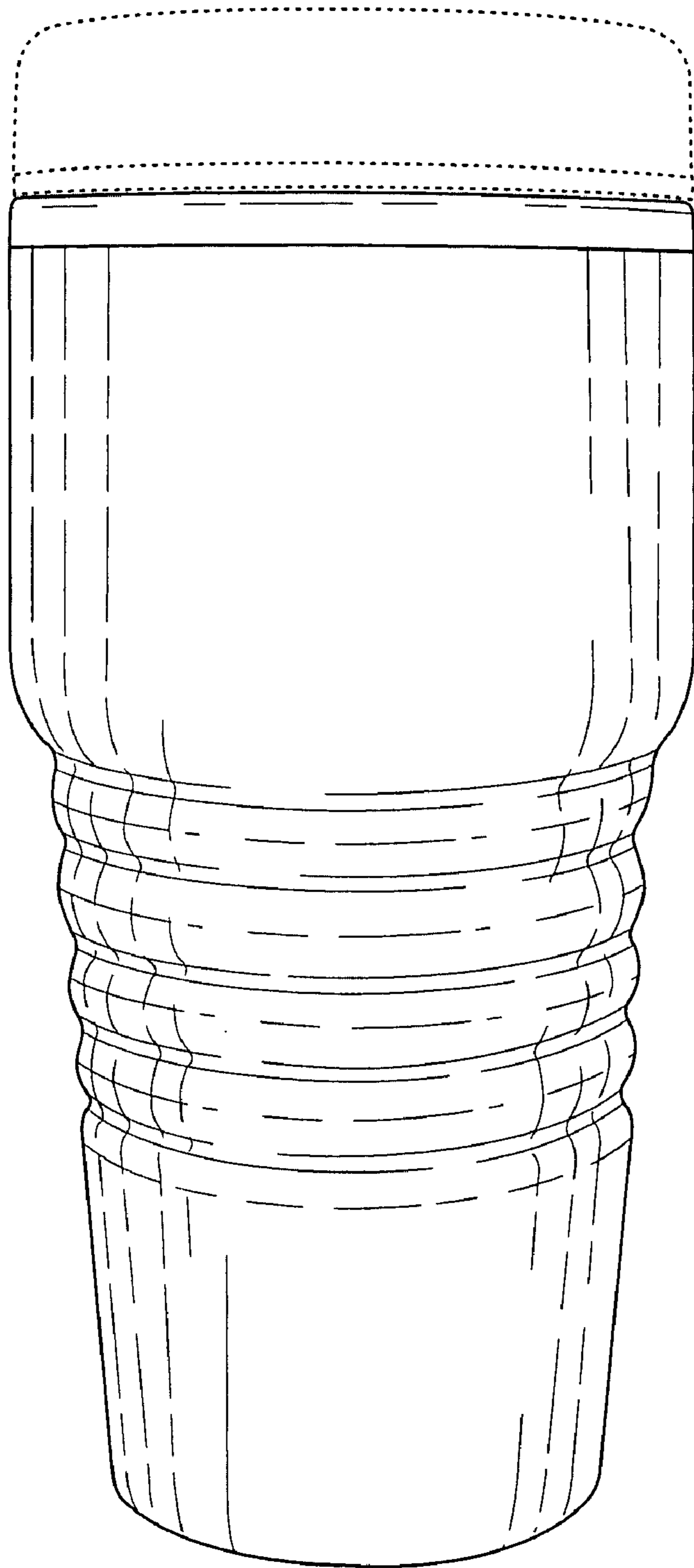




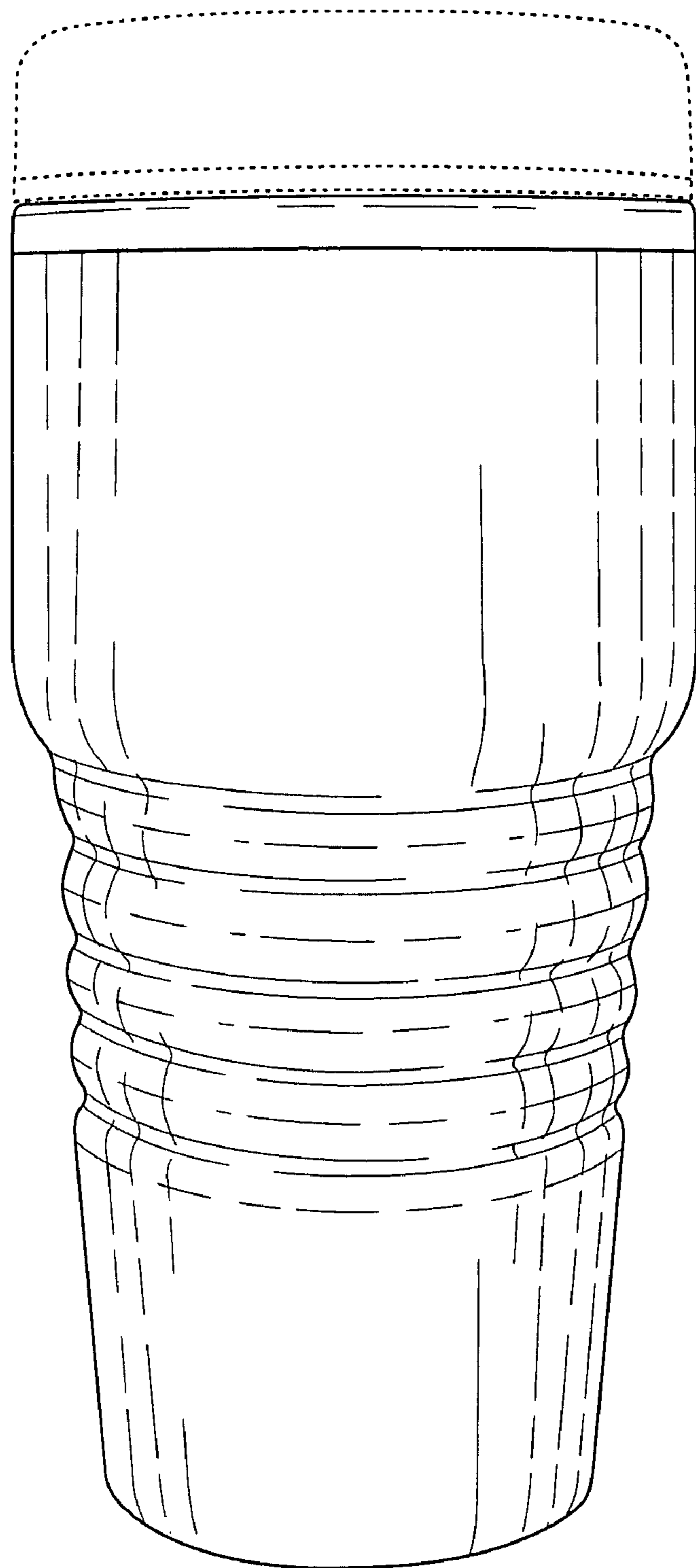

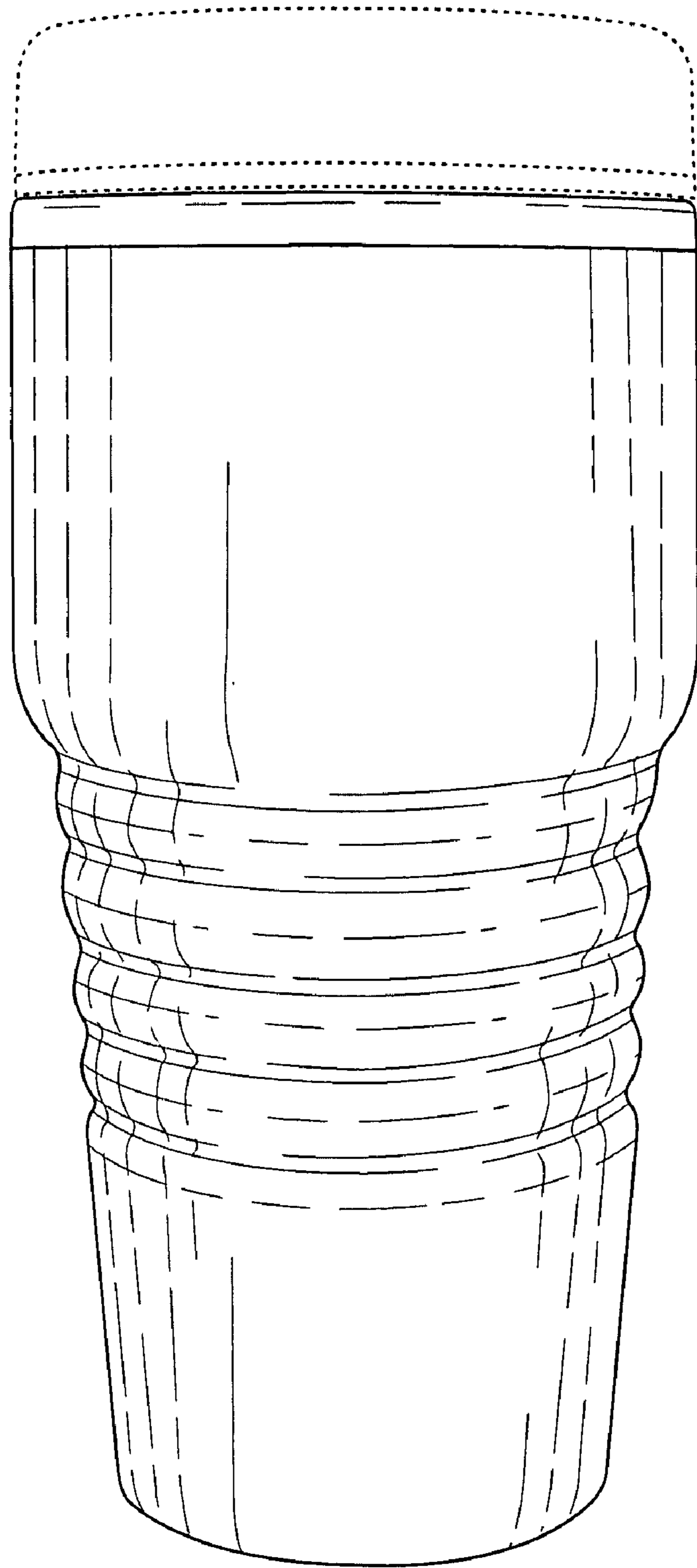

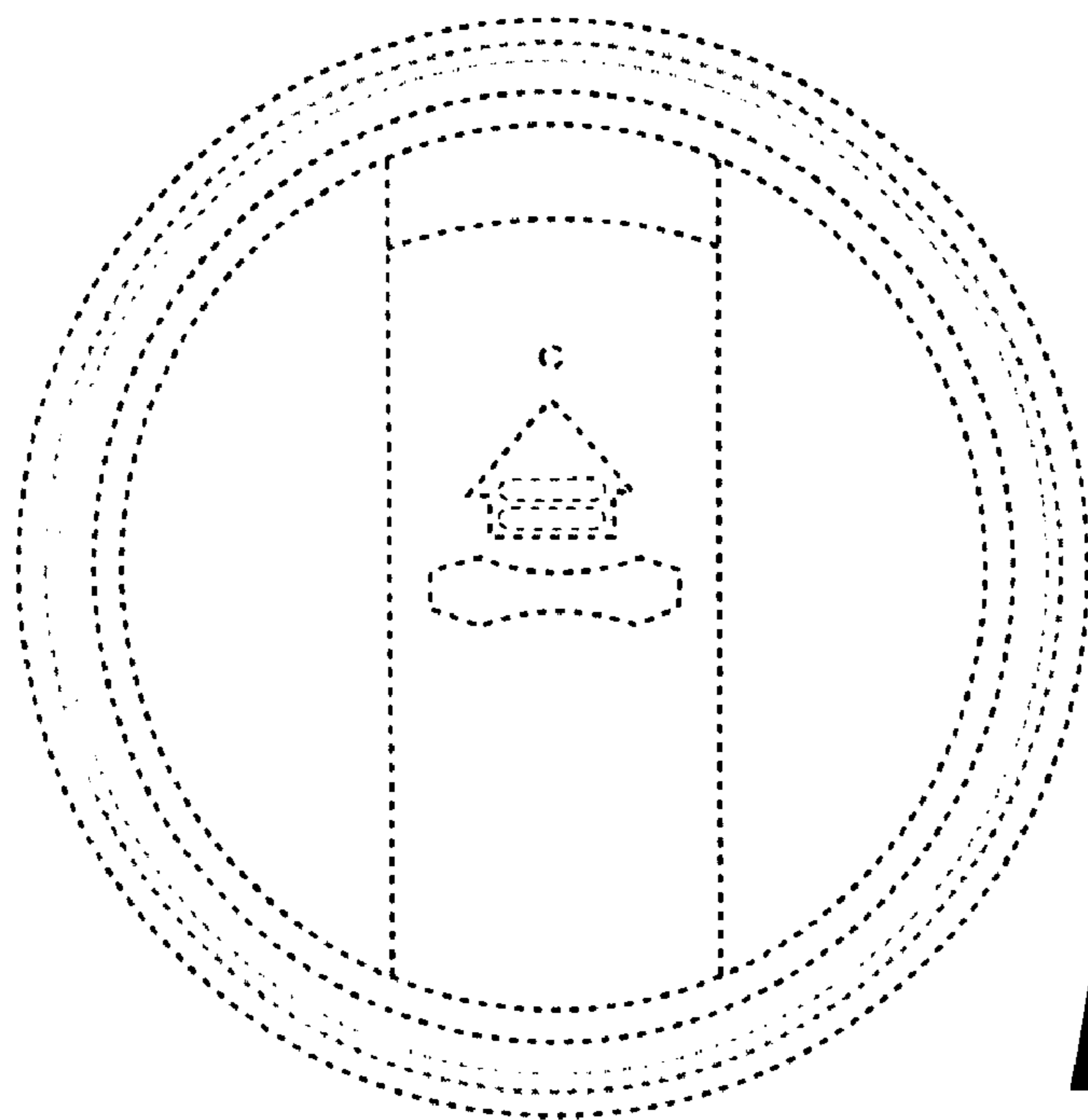

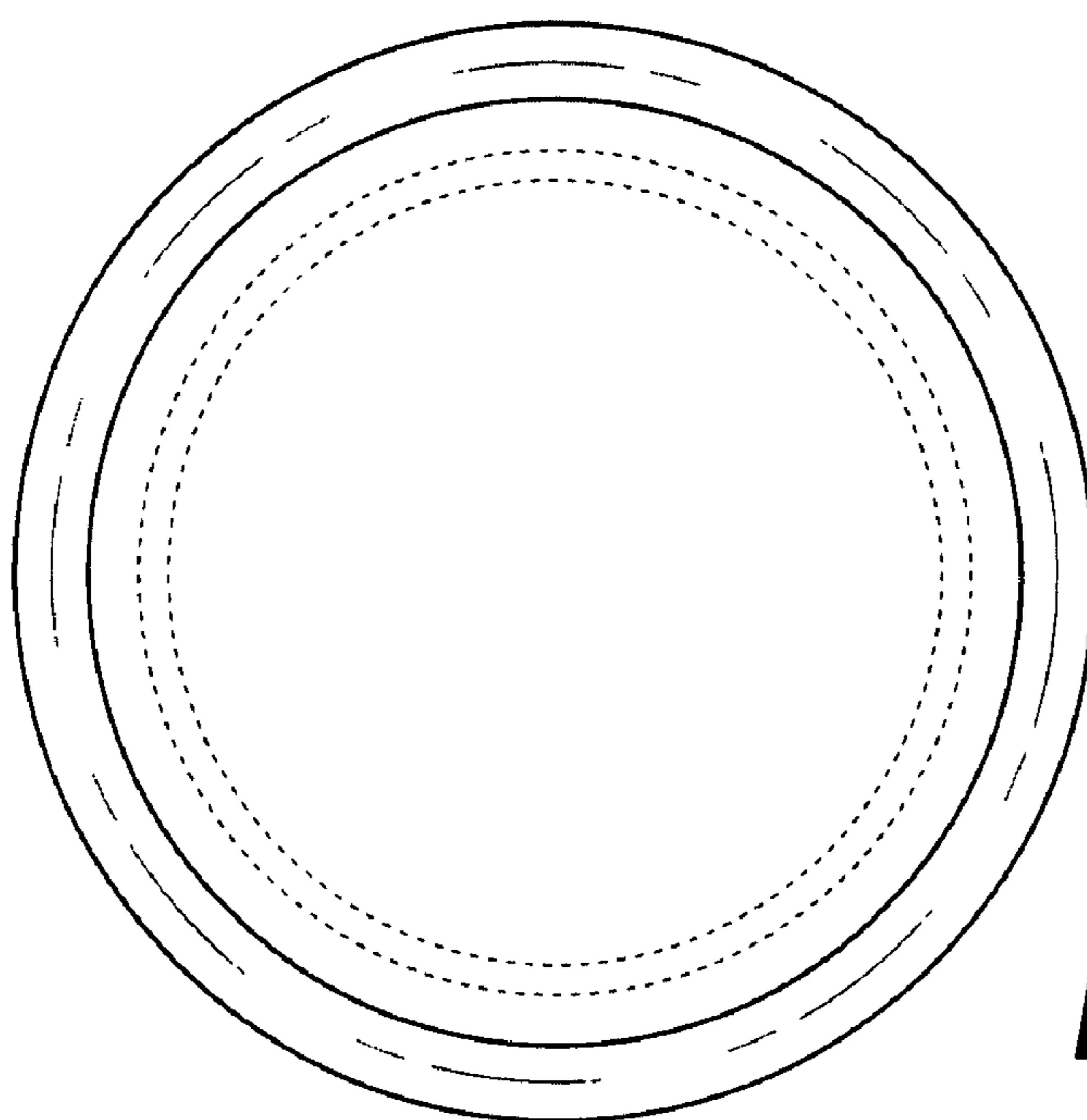
