The ornamental design for a tube, as shown and described.

DESCRIPTION

FIG. 1 is left side, perspective view of one embodiment of a tube in accordance with the present invention;

FIG. 2 is a right side, perspective view of the tube shown in FIG. 1;

FIG. 3 is a front, elevational view of the tube shown in FIG. 1;

FIG. 4 is a rear, elevational view of the tube shown in FIG. 1;

FIG. 5 is a left side, elevational view of the tube shown in FIG. 1;

FIG. 6 is a bottom, elevational view of the tube shown in FIG. 1;

FIG. 7 is a top, elevational view of the tube shown in FIG. 1;

FIG. 8 is a right side, perspective view of another embodiment of the tube of the present invention;

FIG. 9 is a left side, perspective view of the tube shown in FIG. 8;

FIG. 10 is a front, elevational view of the tube shown in FIG. 8;

FIG. 11 is a rear, elevational view of the tube shown in FIG. 8;

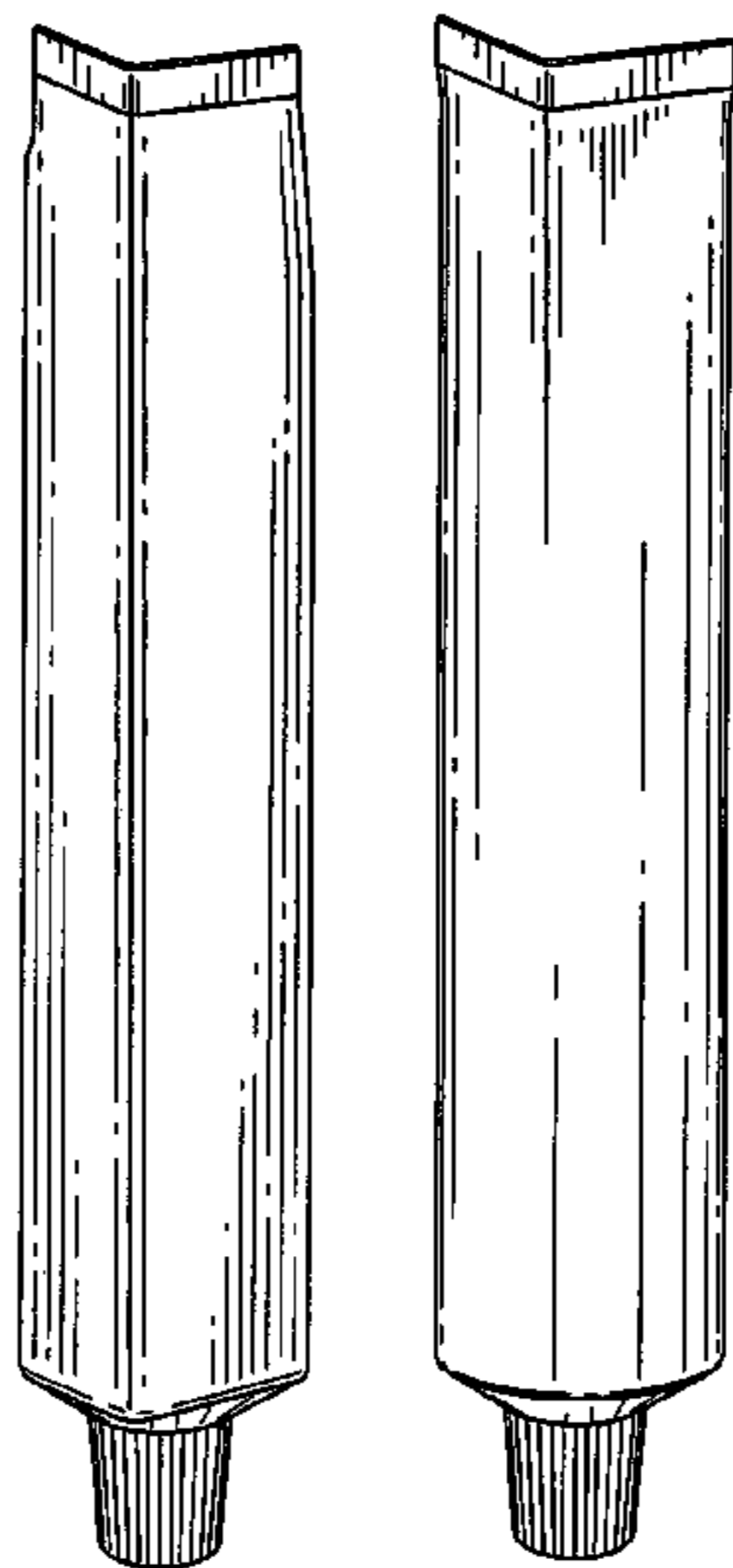

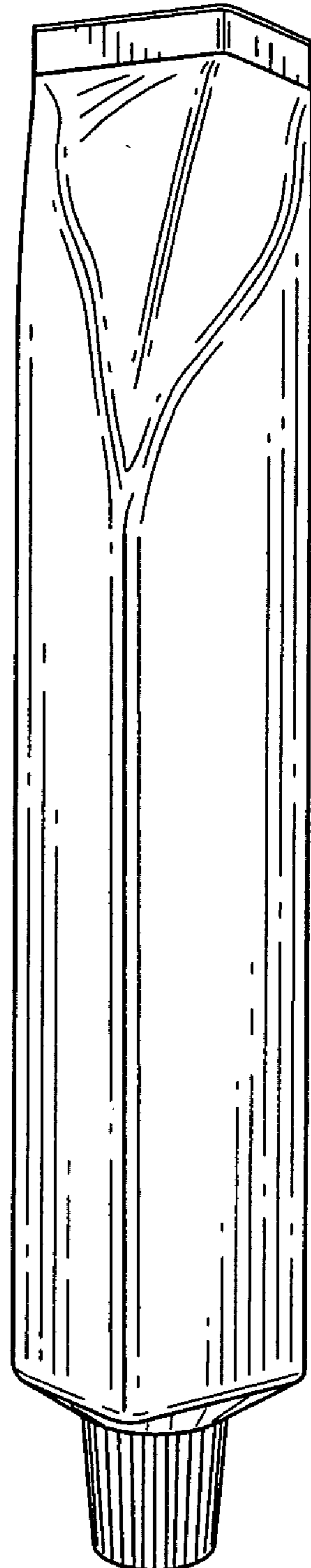

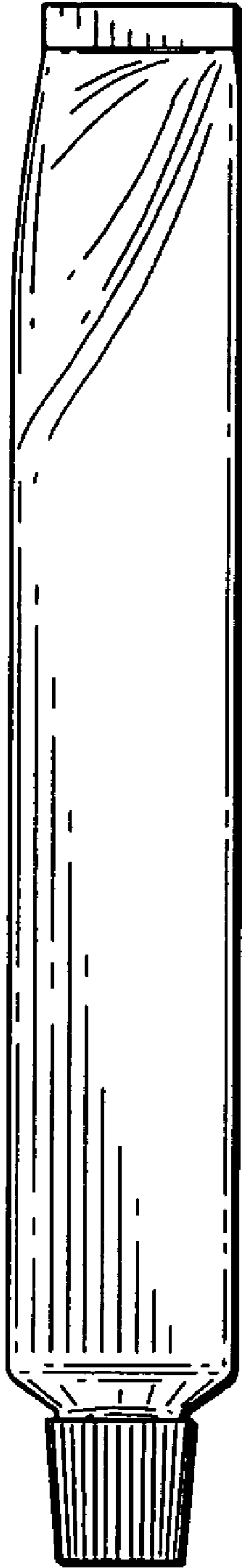

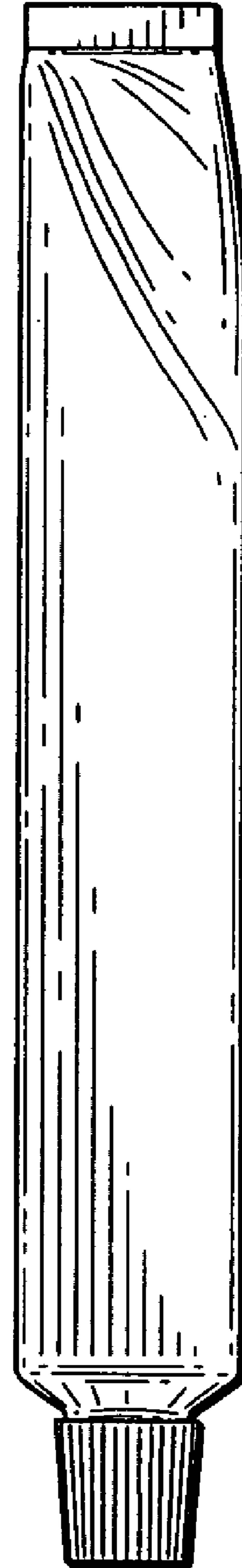

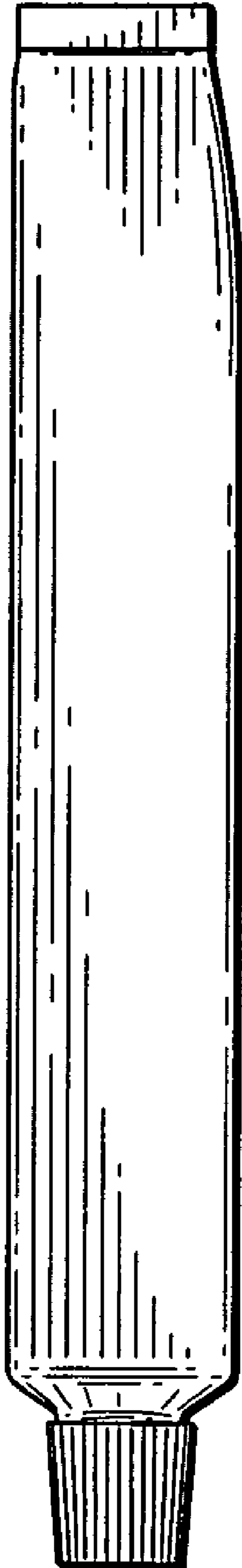

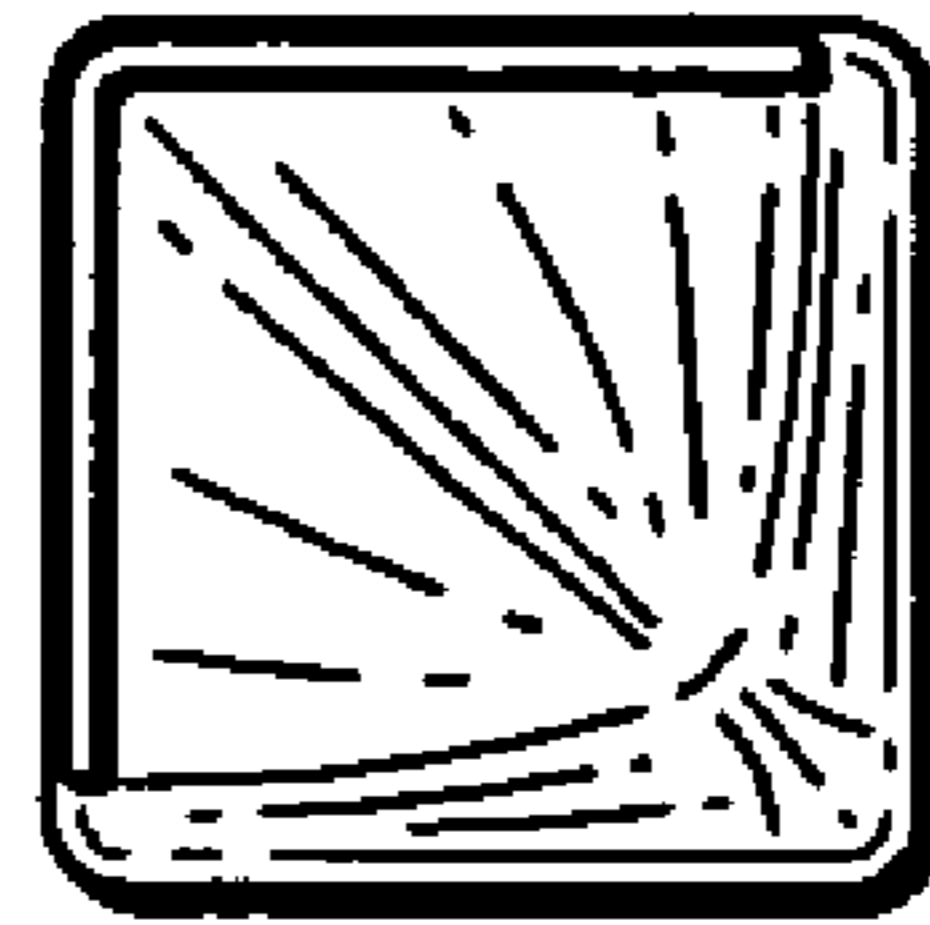

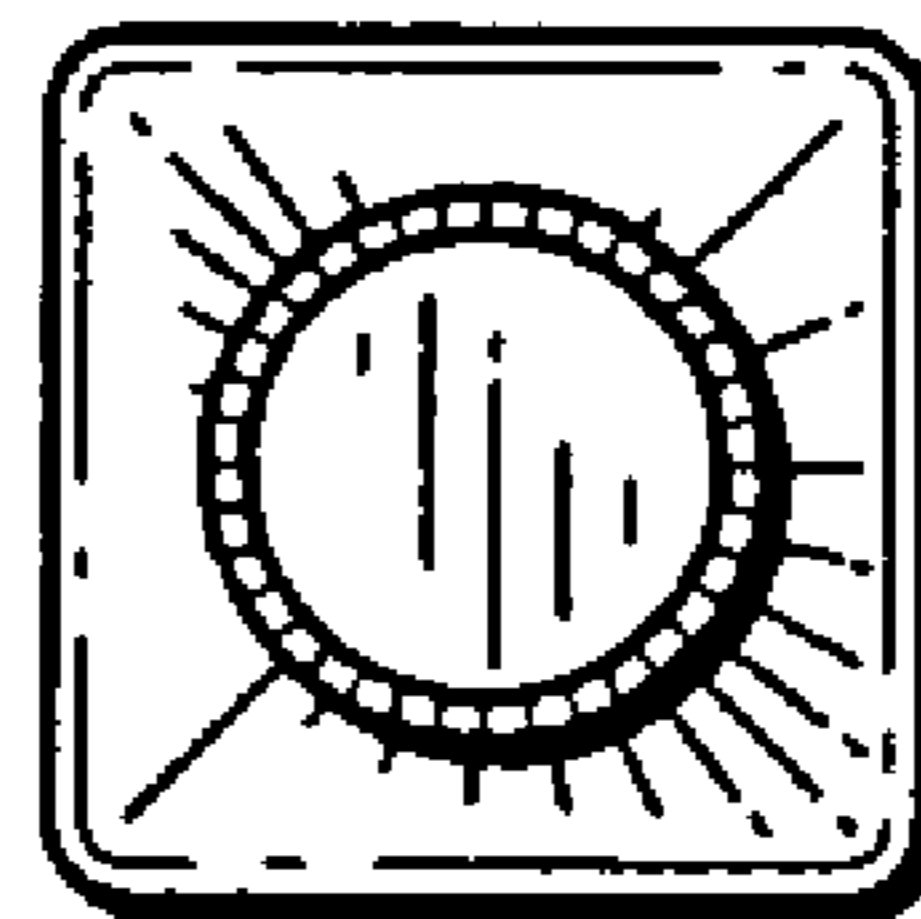

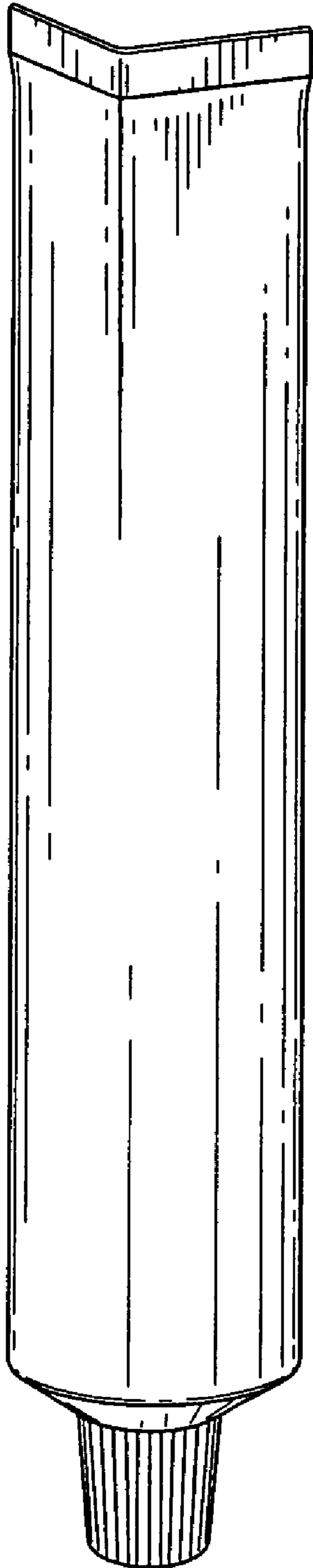

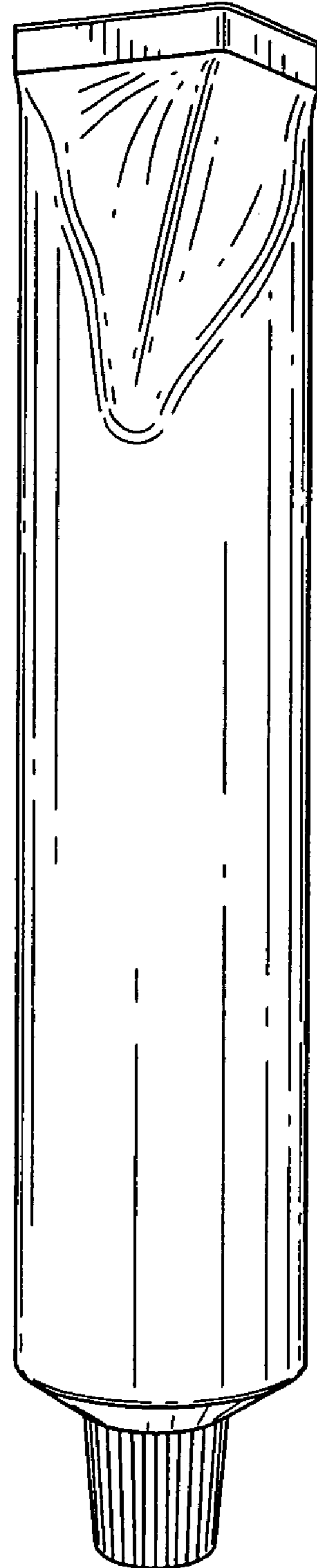

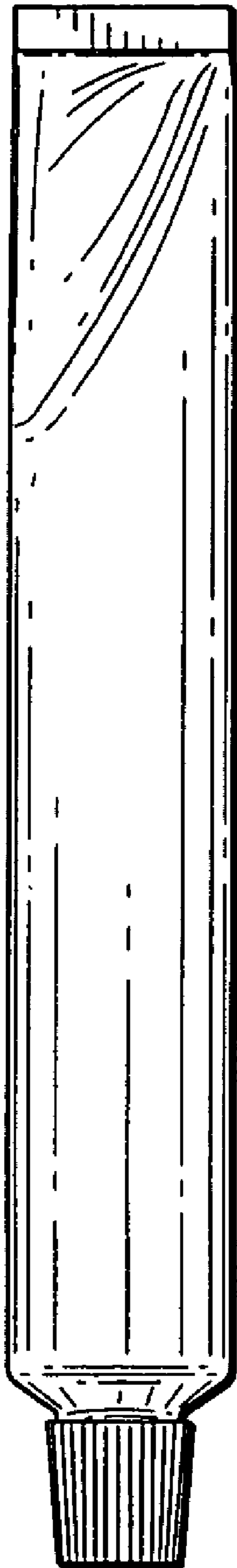

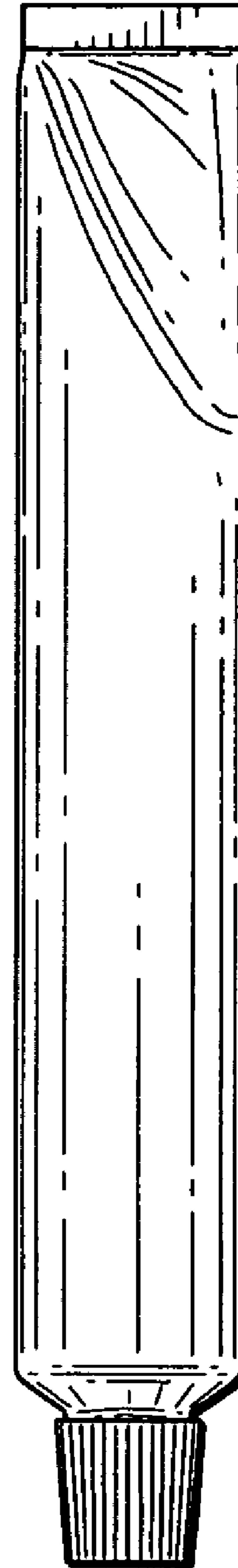

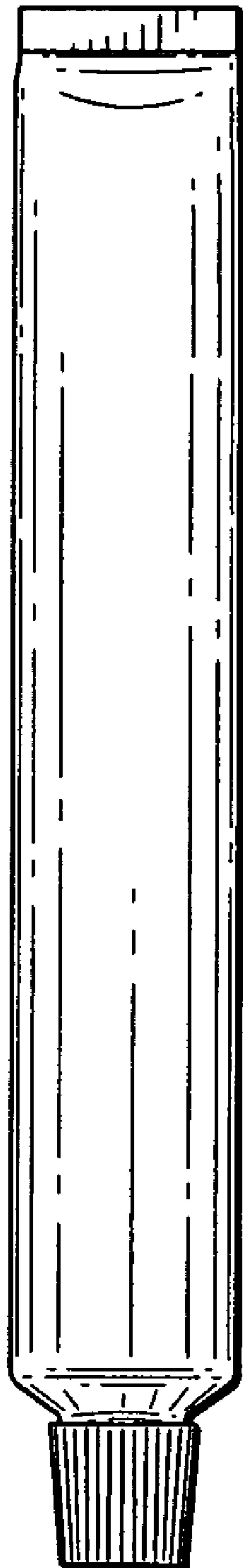

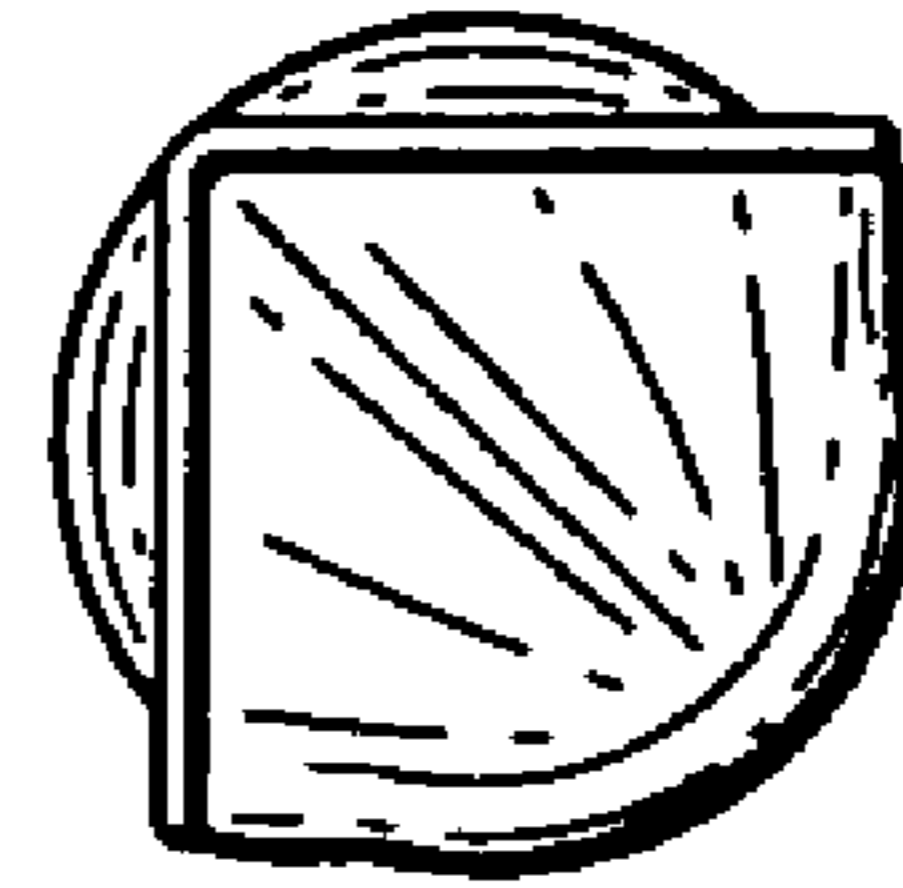
