DESCRIPTION

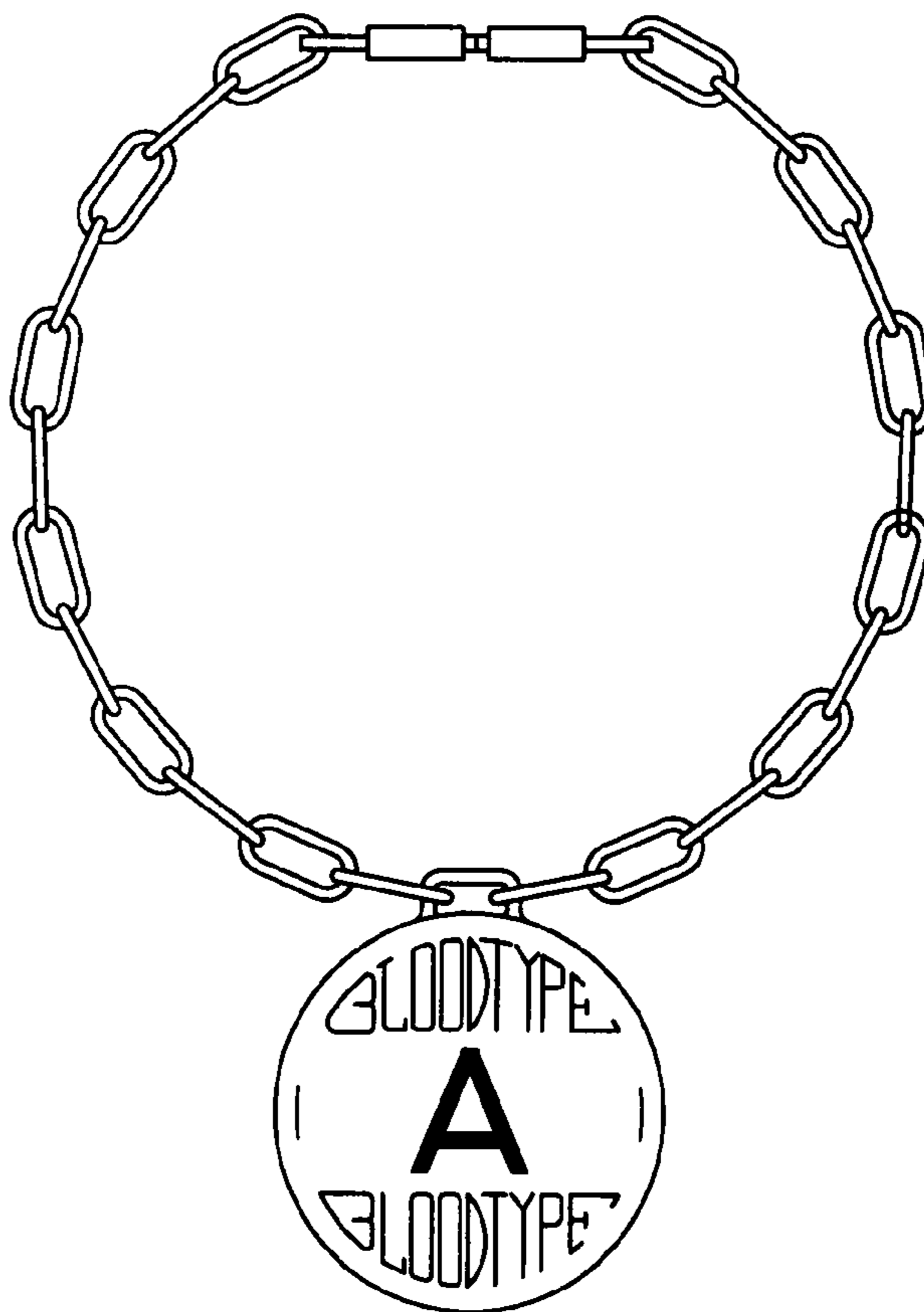
FIG. 1 is a front elevation view of an identification necklace showing the new design;

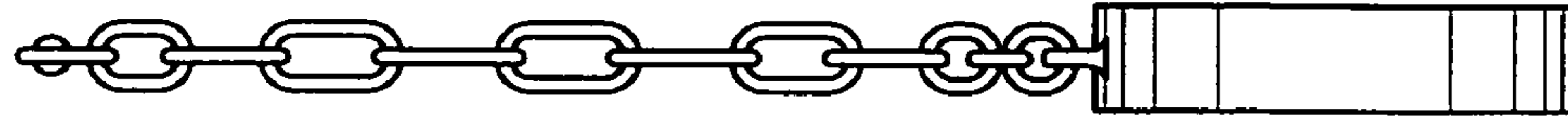

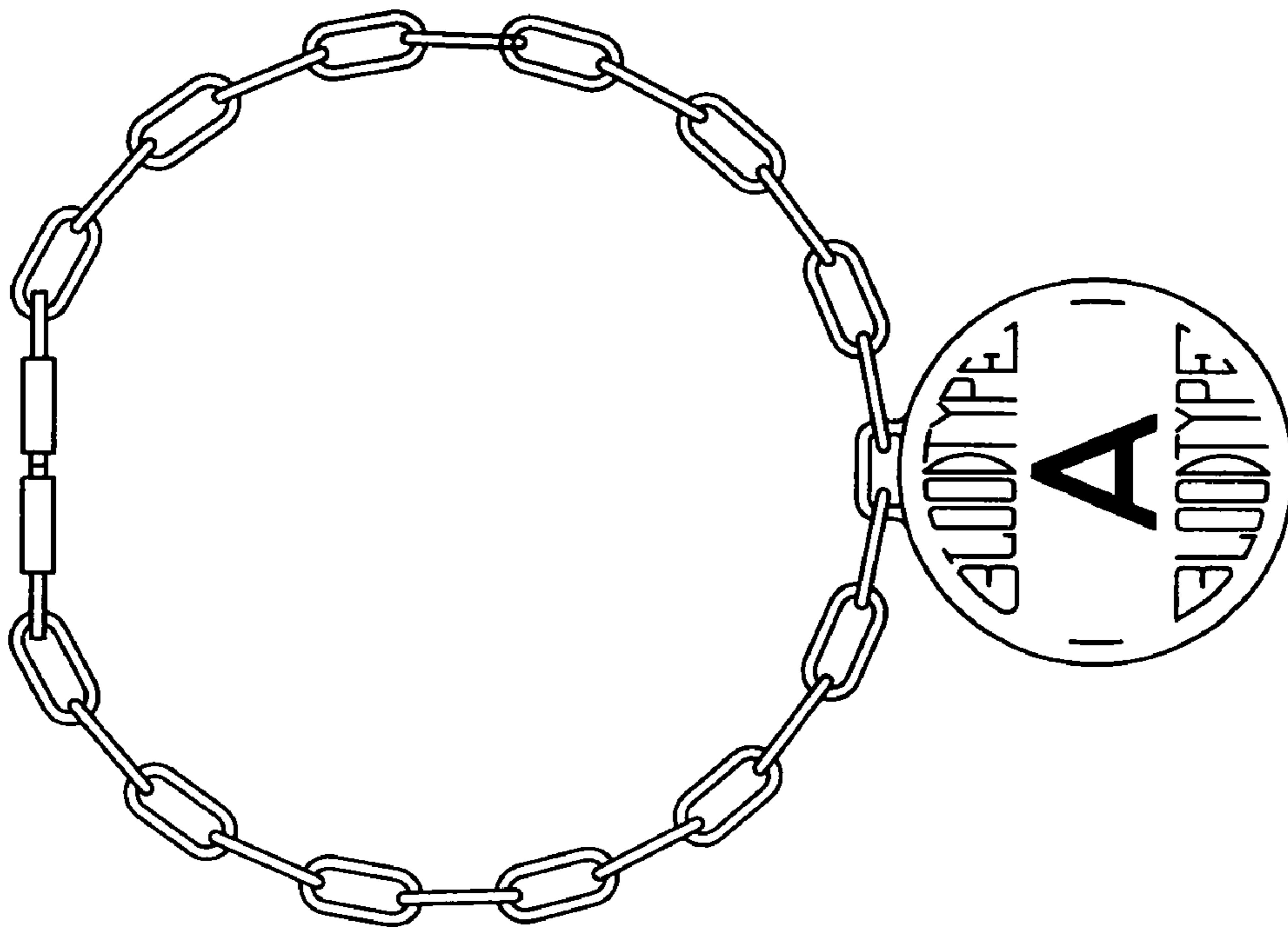

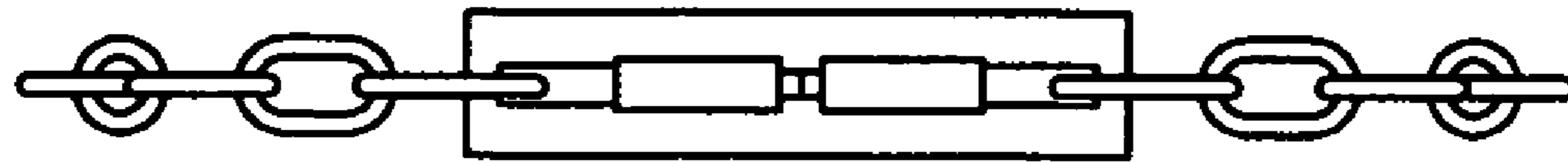
