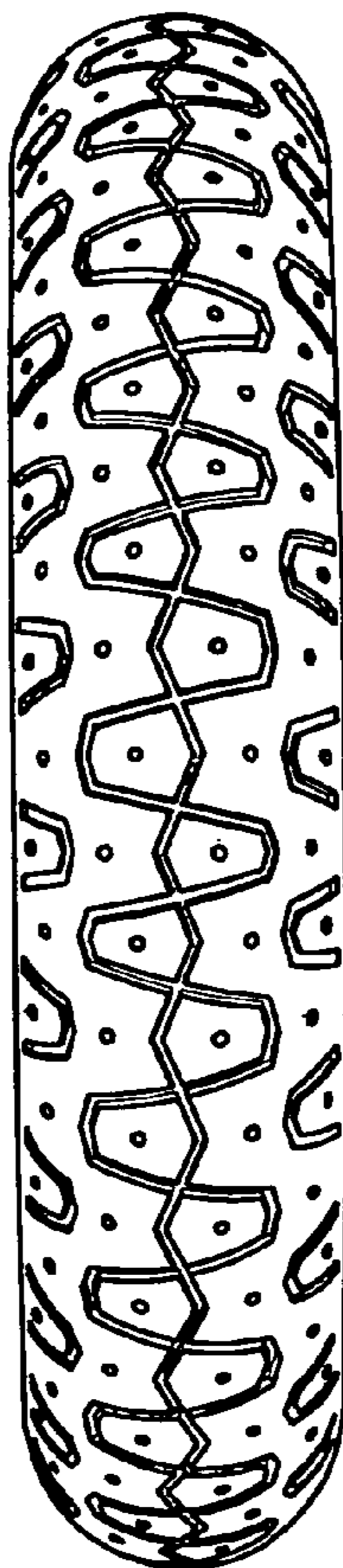
The ornamental design for the motorcycle tire, as shown and described.

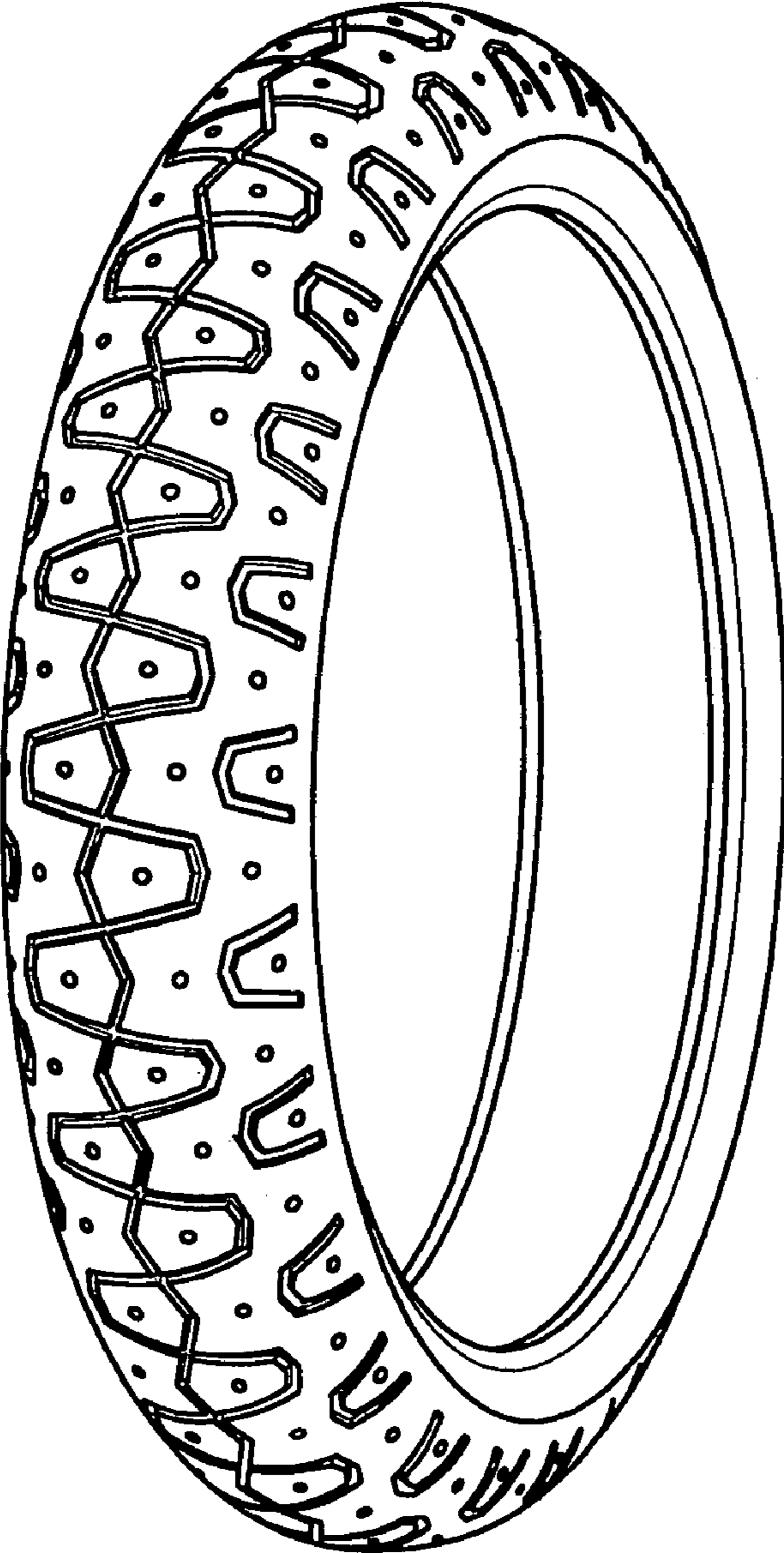
**DESCRIPTION**

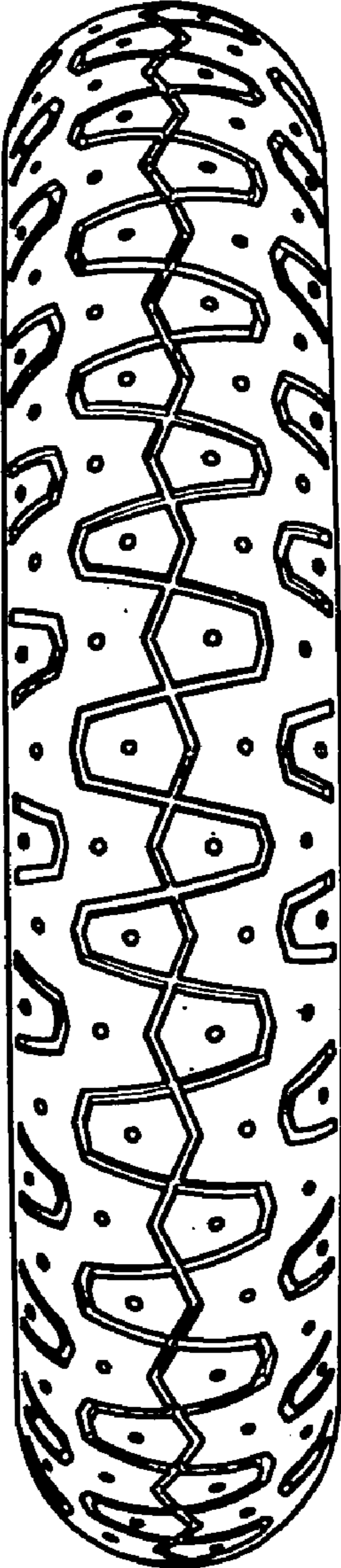
FIG. 3 is a right-side view of our new design, the left-side view being identical thereto.

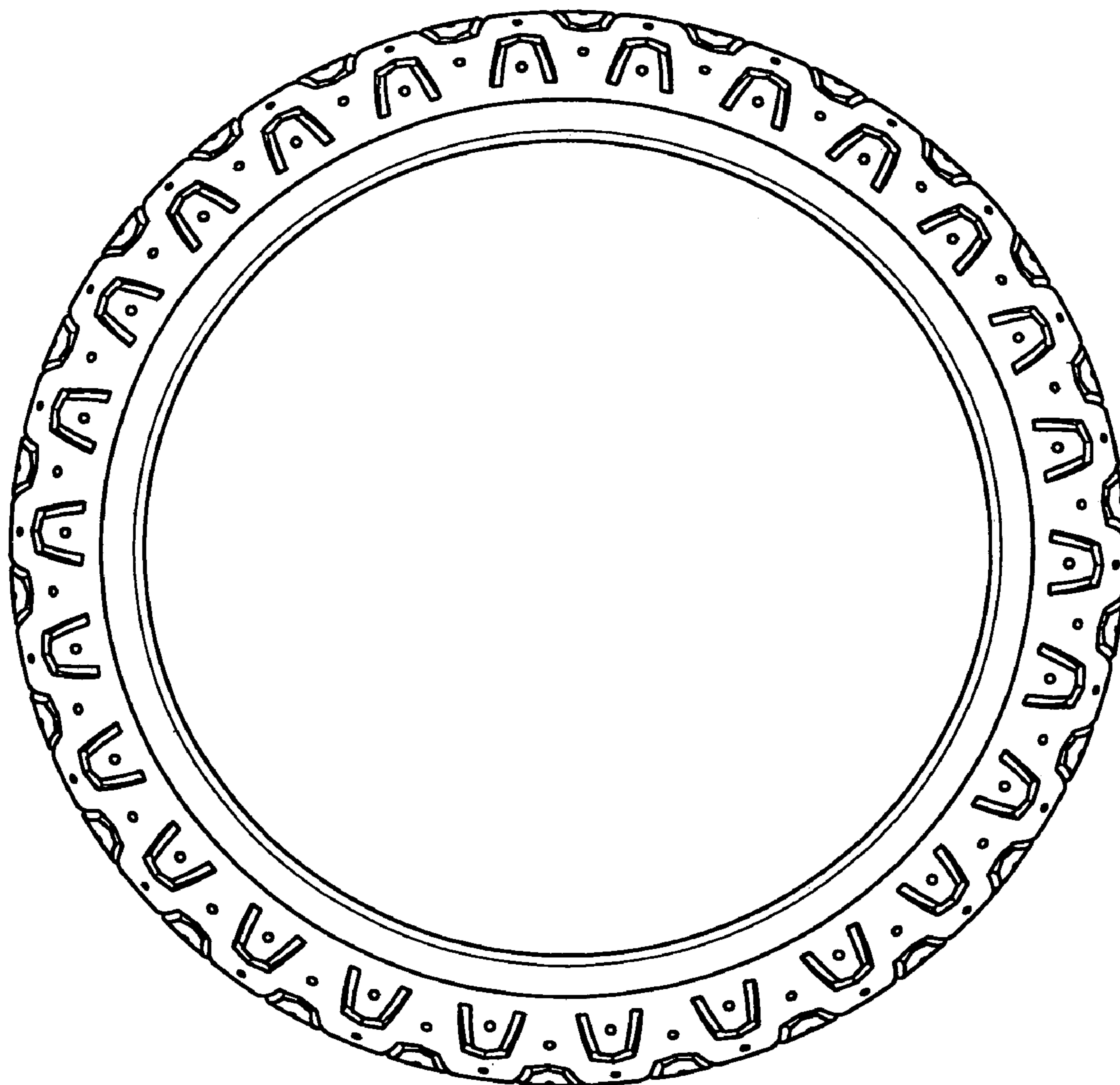
