DESCRIPTION

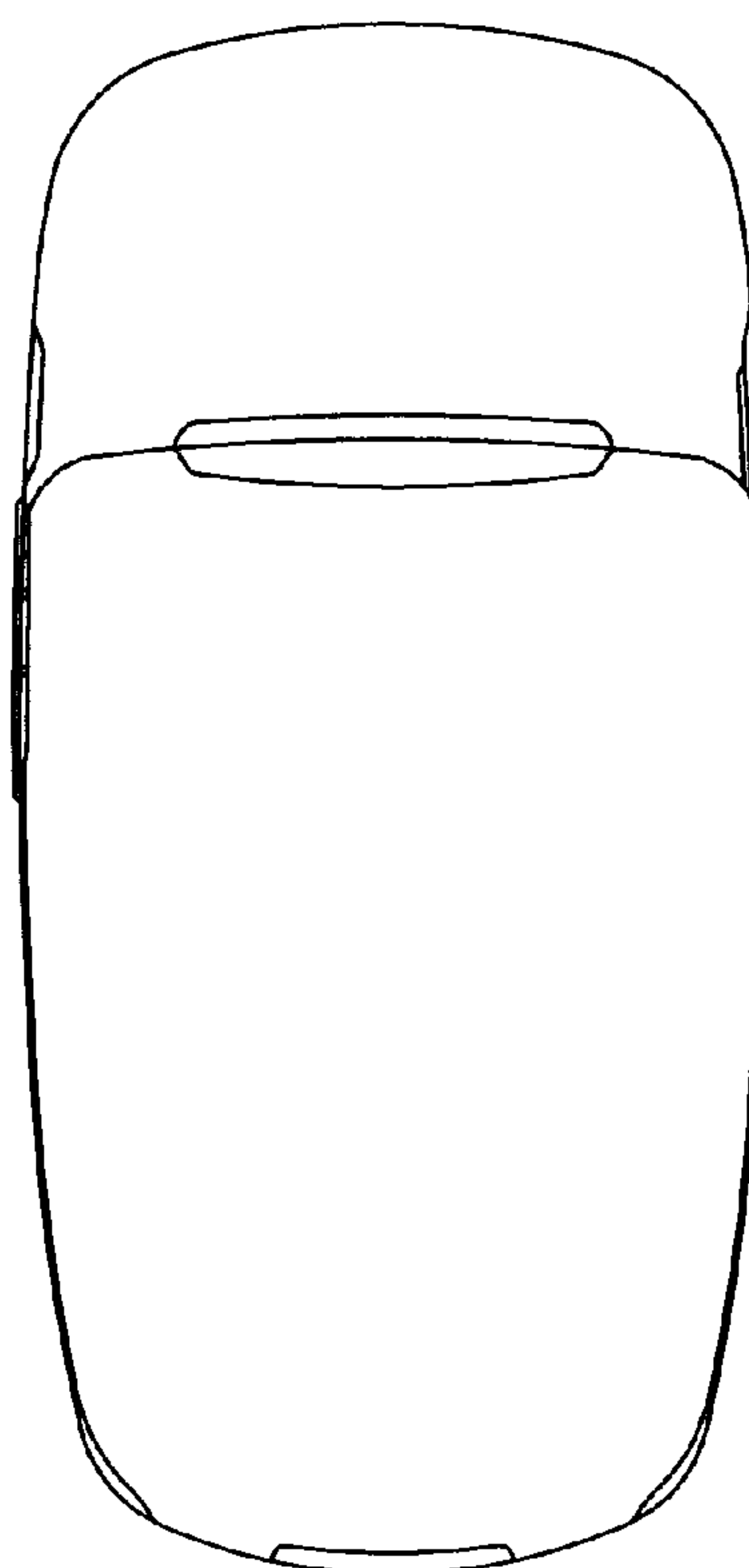
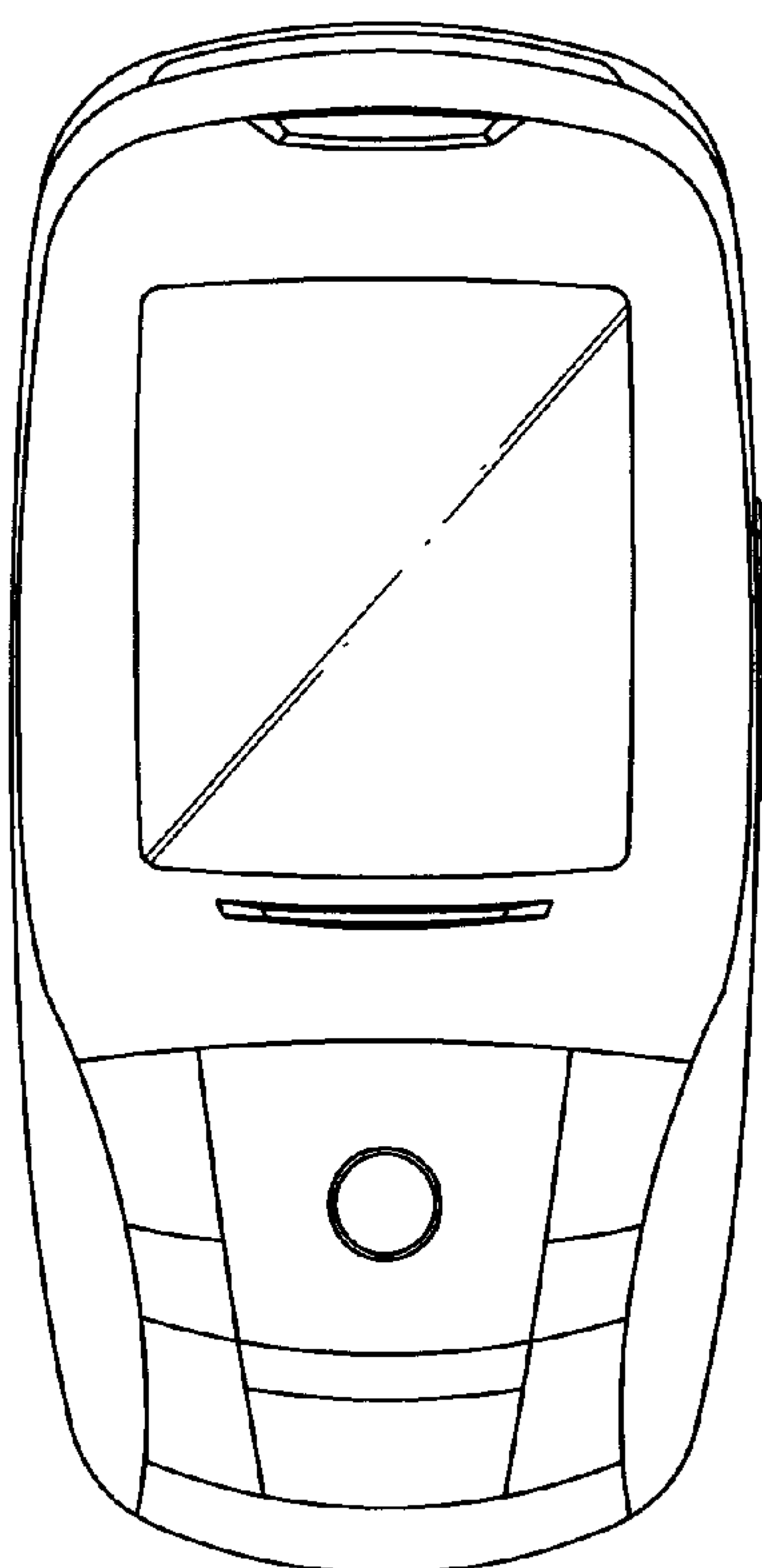

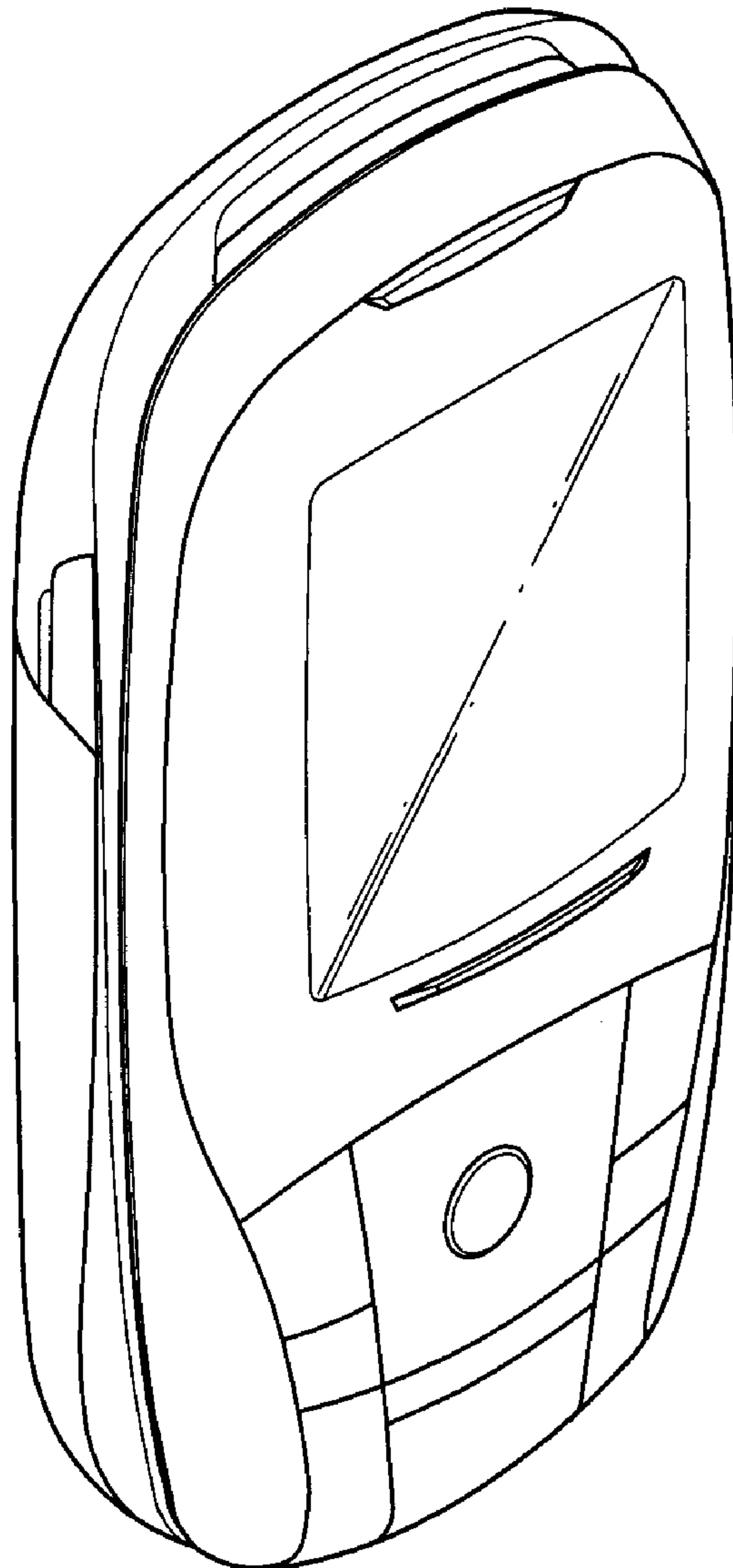

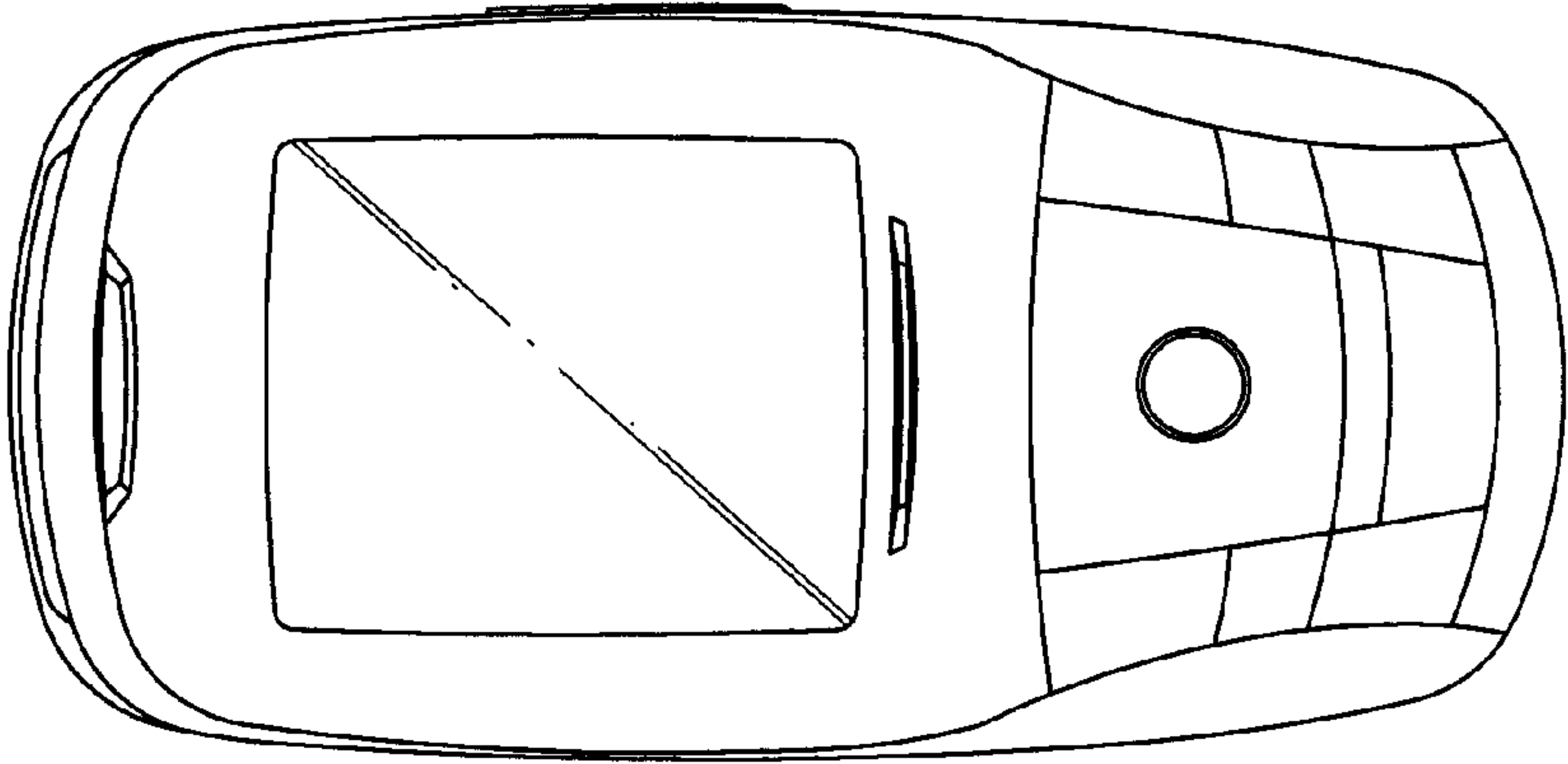

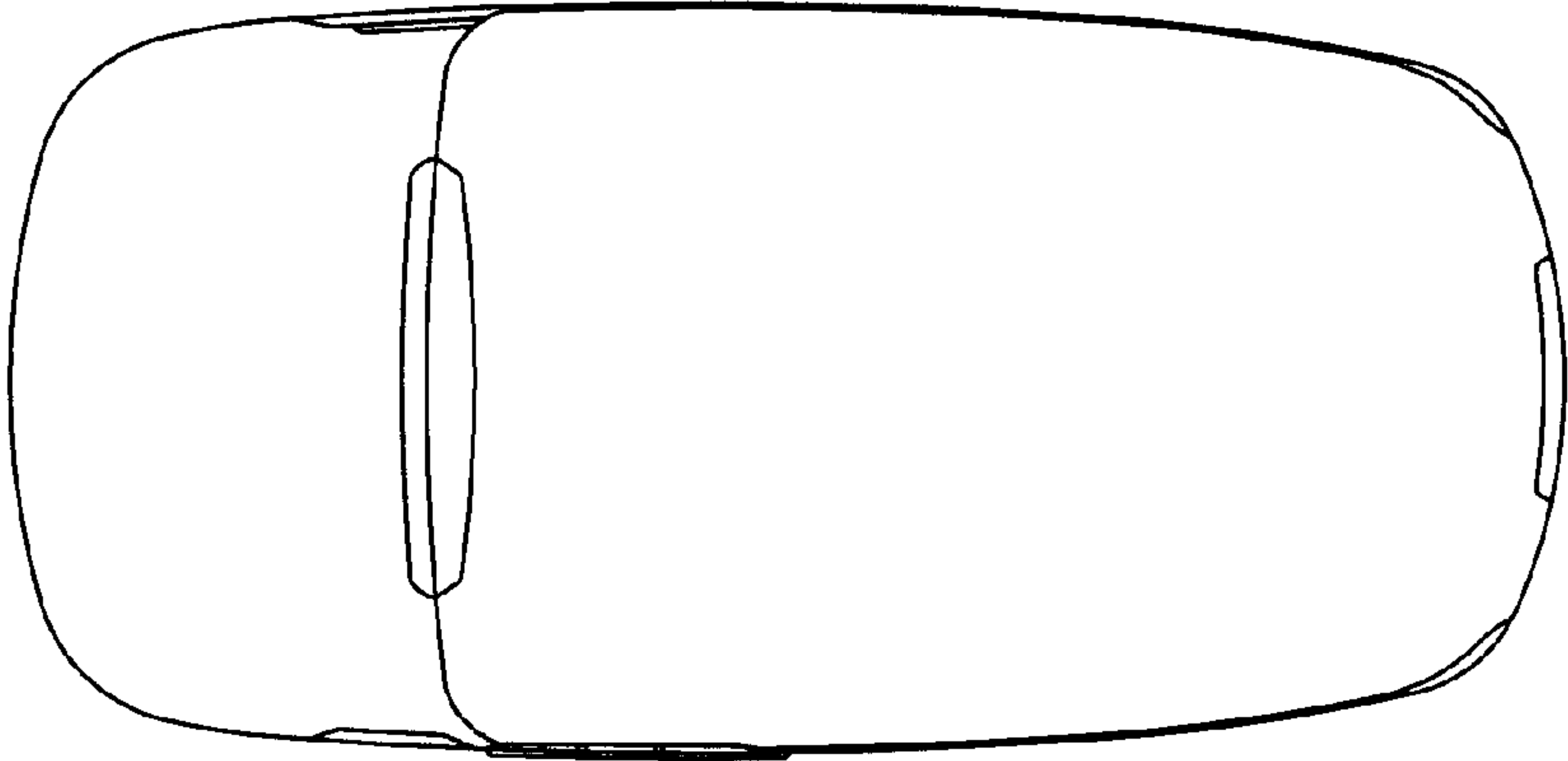

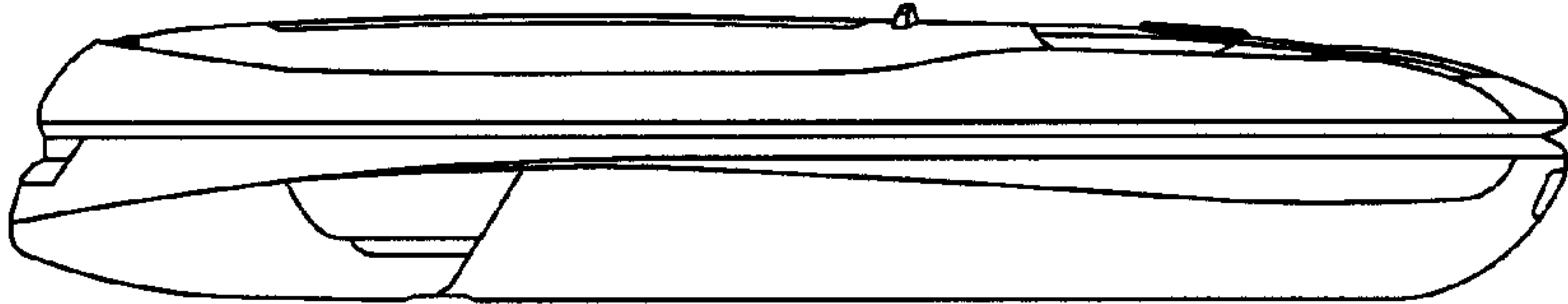

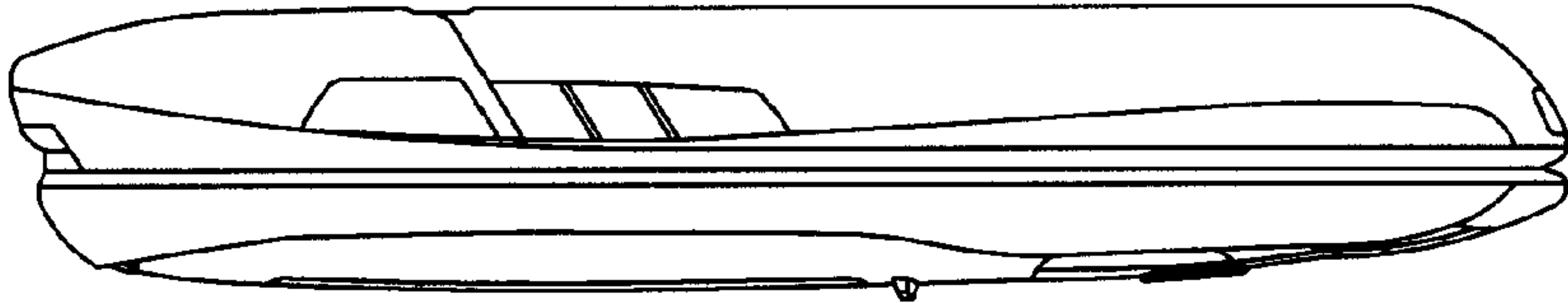

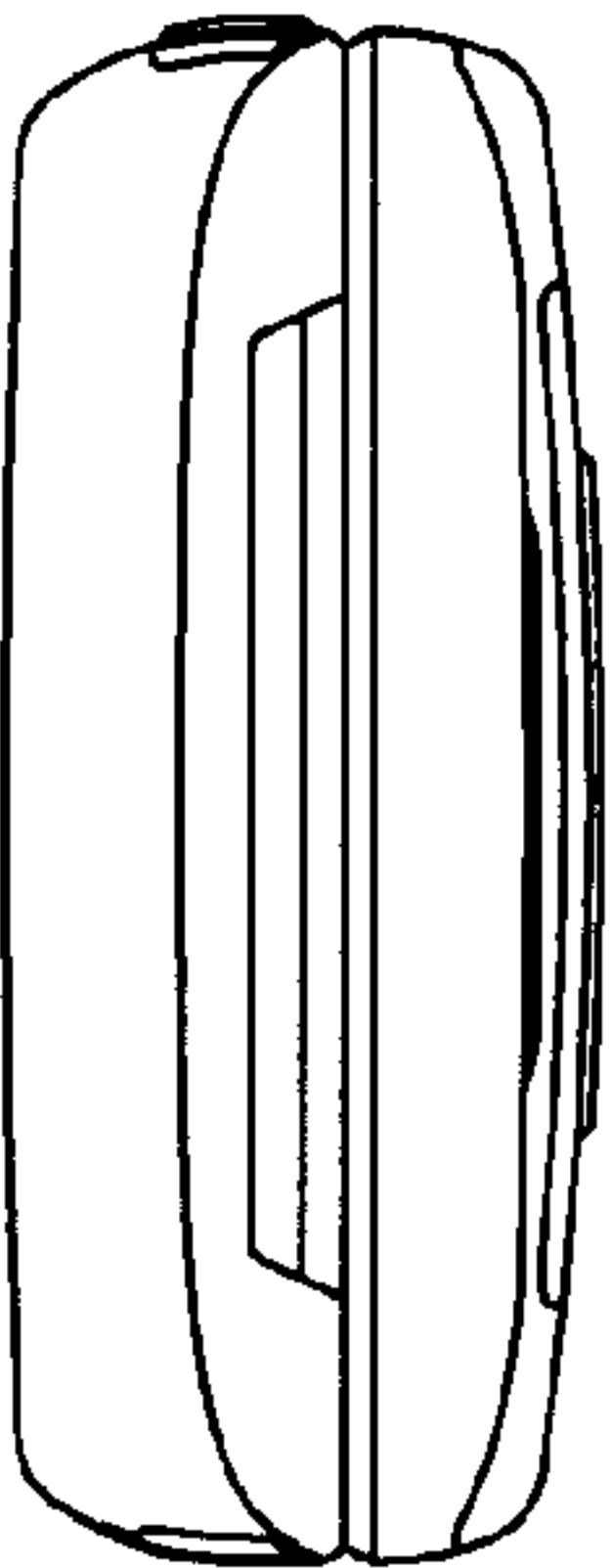

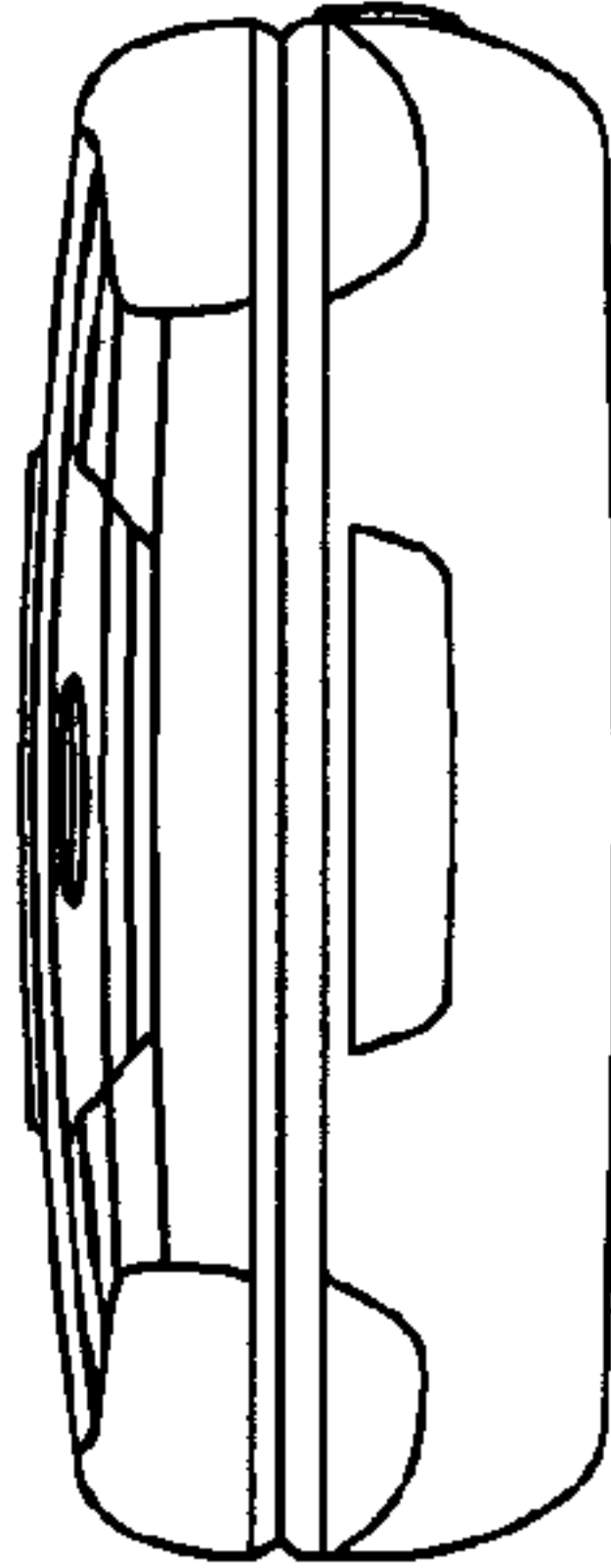

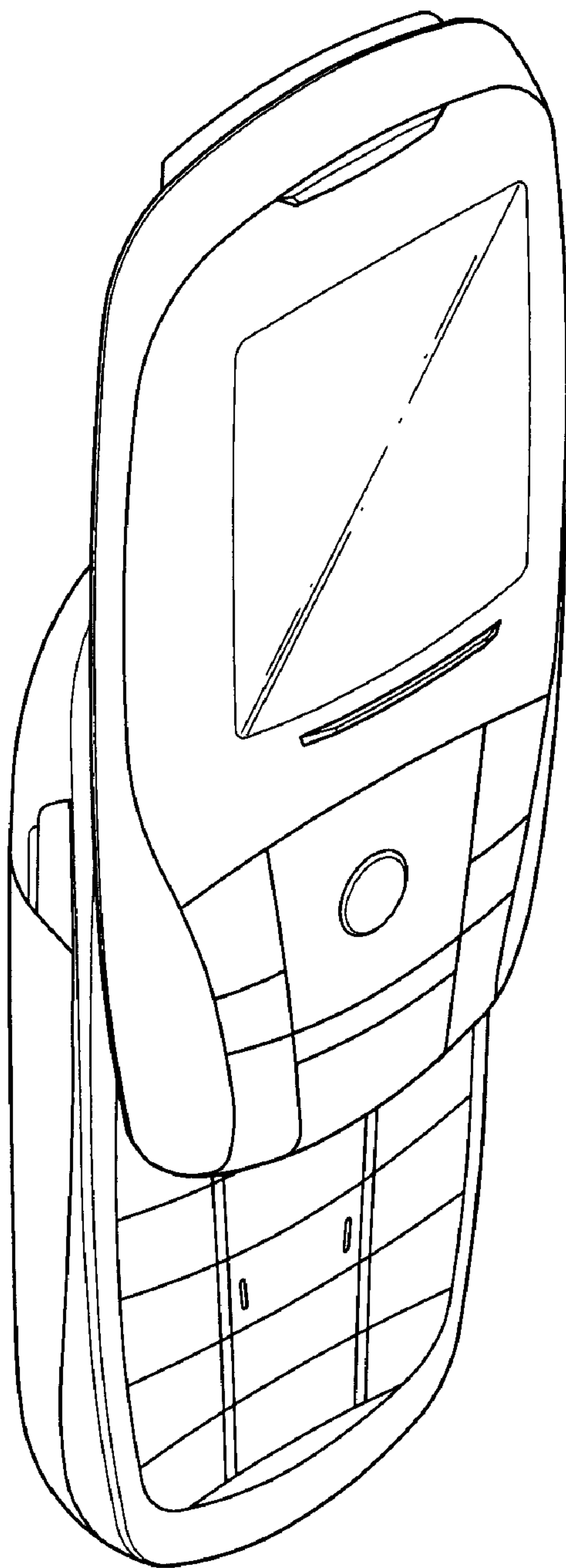
