(57) **CLAIM**

The ornamental design of a golf tee locator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the golf tee locator of my design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevational view thereof, the opposite side elevational view being a mirror image thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view of a first modification of the golf tee locator of FIG. 1;

FIG. 8 is a front elevational view of FIG. 7;

FIG. 9 is a side elevational view of FIG. 7, the opposite side elevational view being a mirror image thereof;

FIG. 10 is a rear elevational view of FIG. 7;

FIG. 11 is a top plan view of FIG. 7;

FIG. 12 is a bottom plan view of FIG. 7;

FIG. 13 is a perspective view of a second modification of the golf tee locator of FIG. 1;

FIG. 14 is a front elevational view of FIG. 13;

FIG. 15 is a side elevational view of FIG. 13, the opposite side elevational view being a mirror image thereof;

FIG. 16 is a rear elevational view of FIG. 13;

FIG. 17 is a top plan view of FIG. 13;

FIG. 18 is a bottom plan view of FIG. 13;

FIG. 19 is a perspective view of a third modification of the golf tee locator of FIG. 1;

FIG. 20 is a front elevational view of FIG. 19;

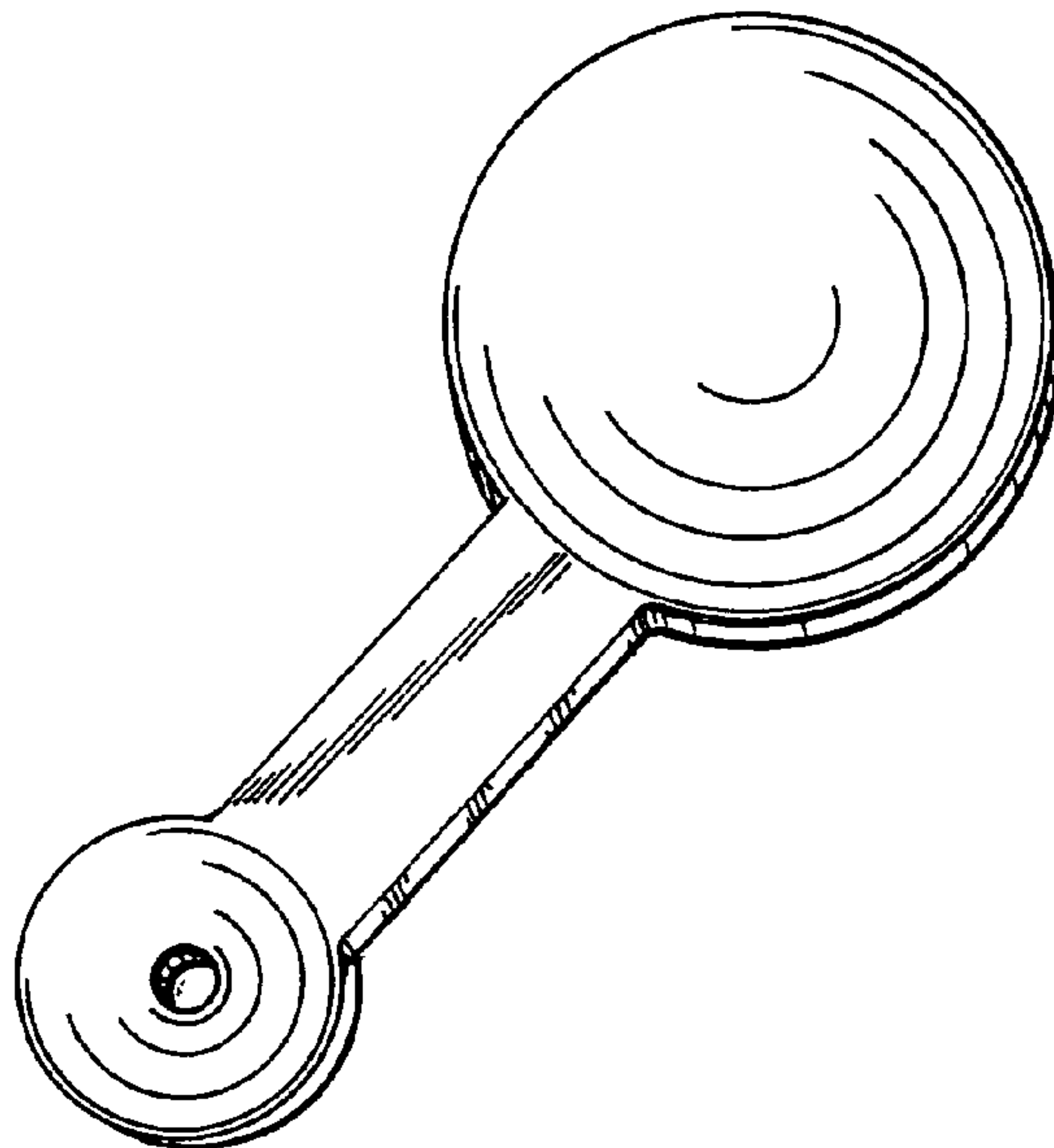
FIG. 21 is a side elevational view of FIG. 19, the opposite side being a mirror image thereof;

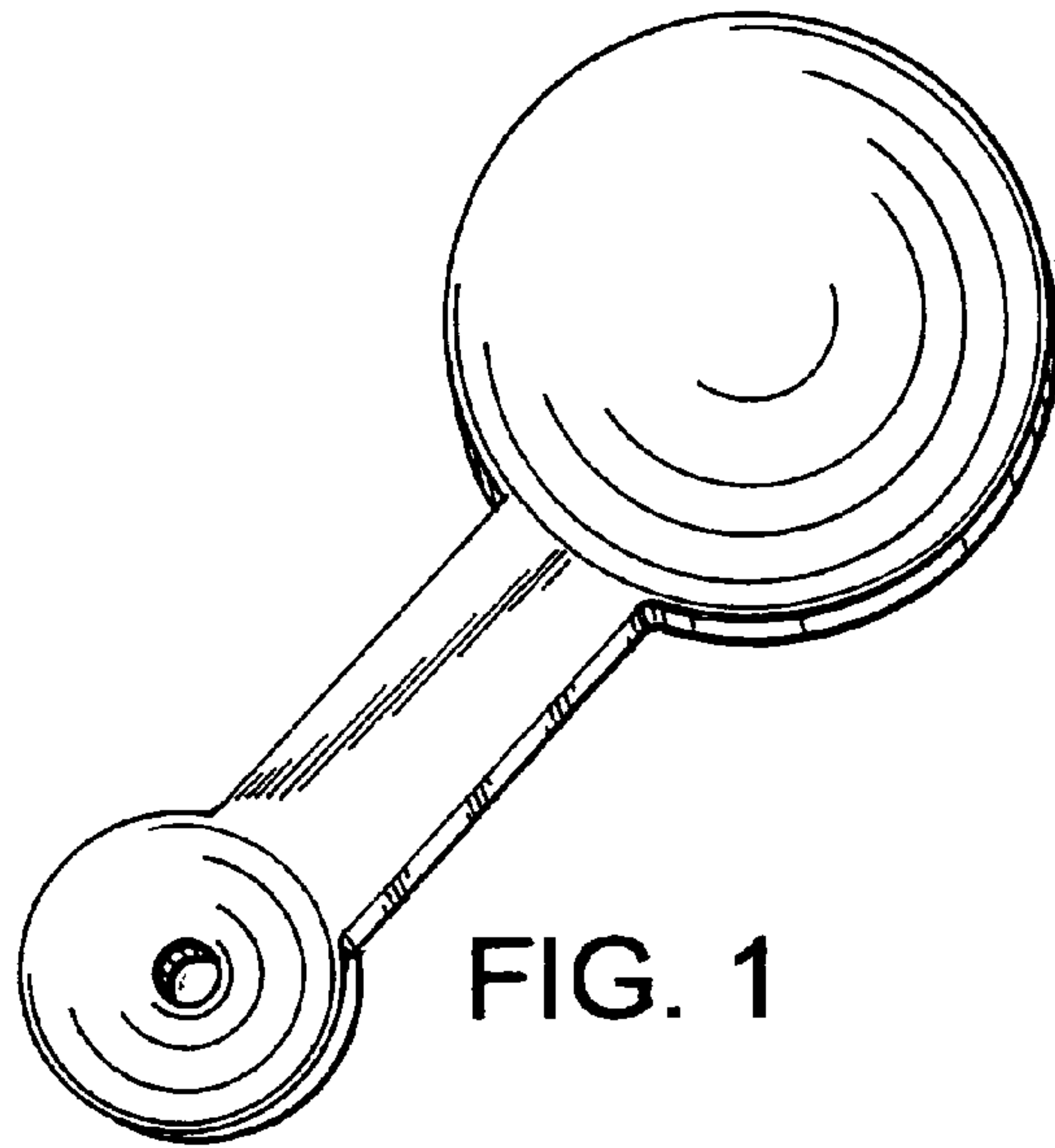

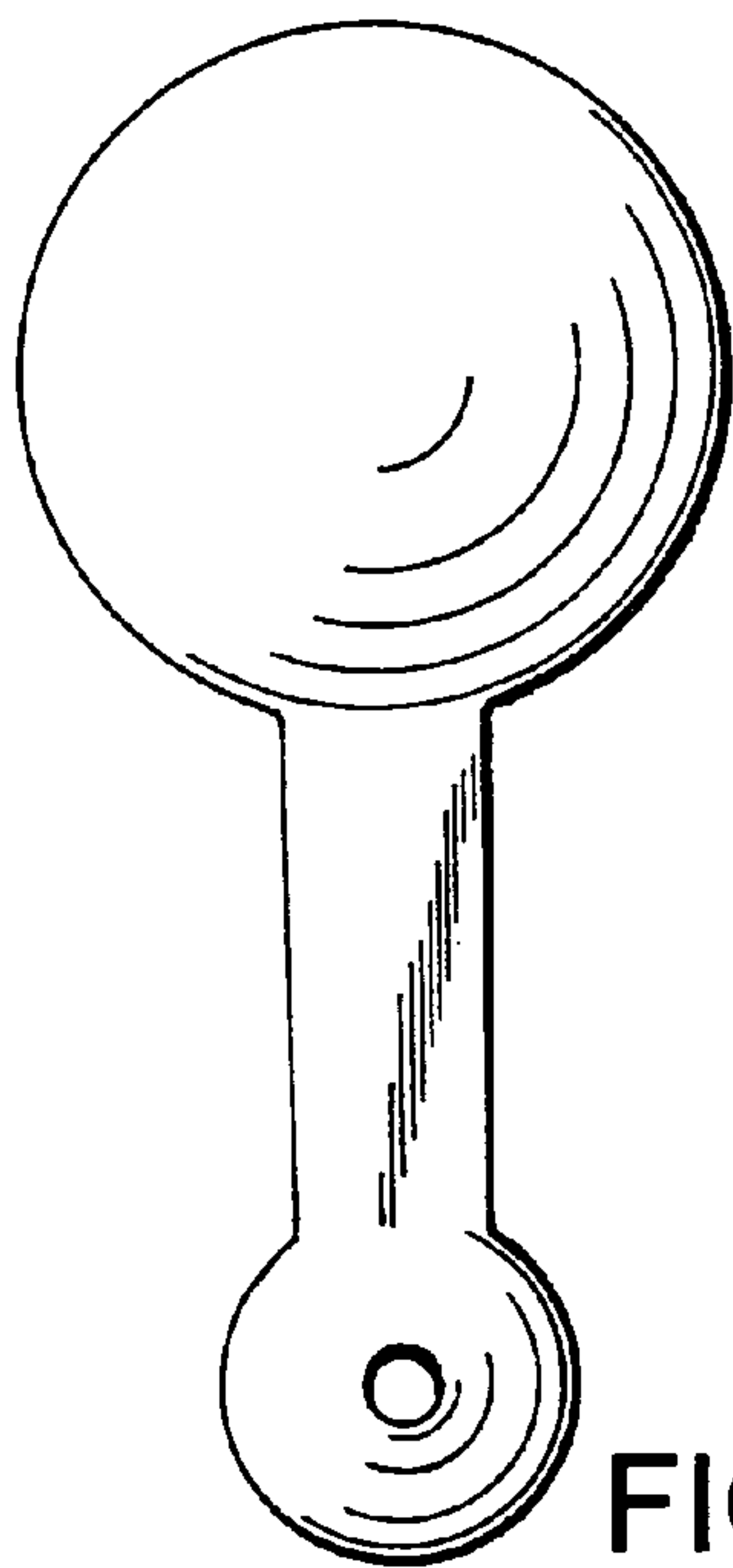

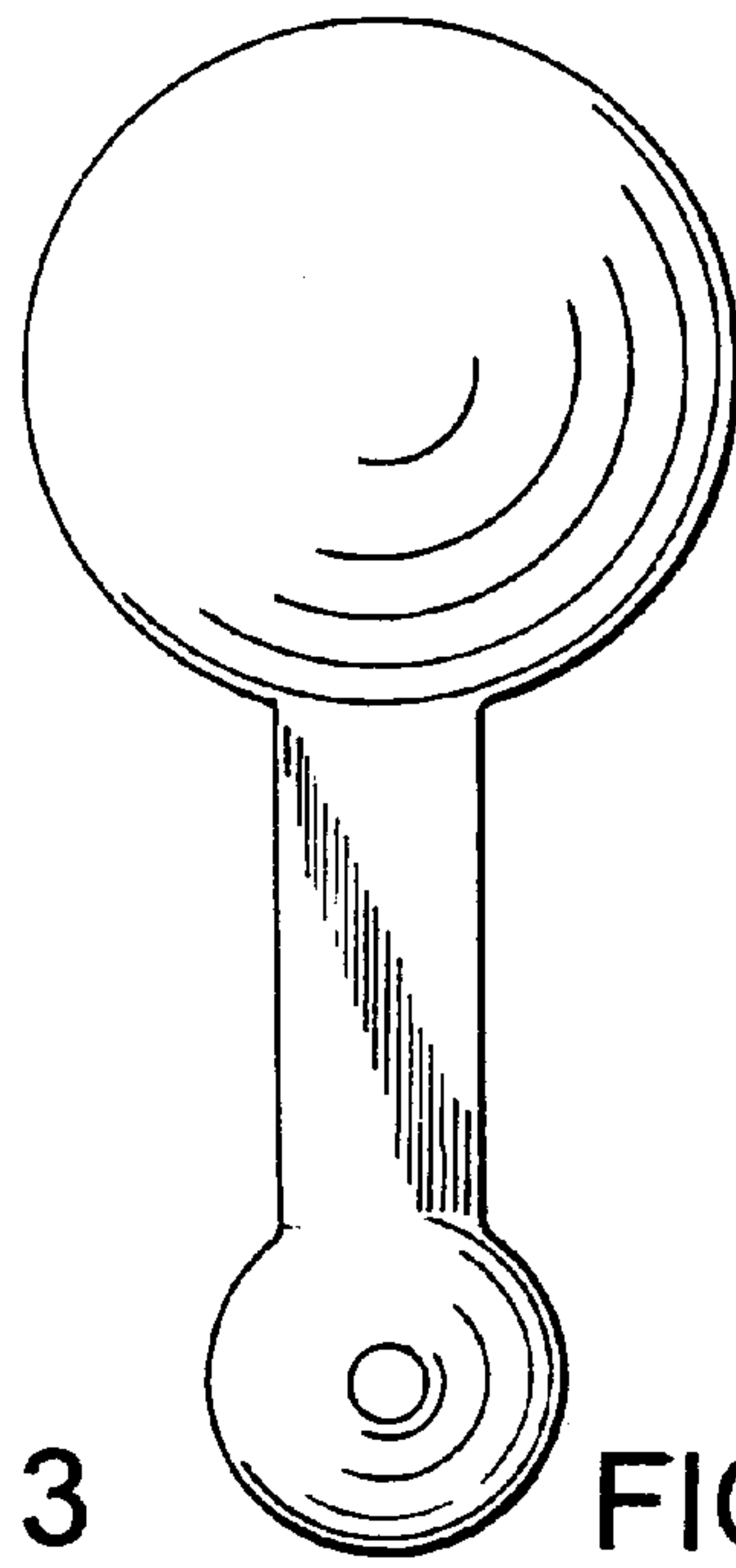

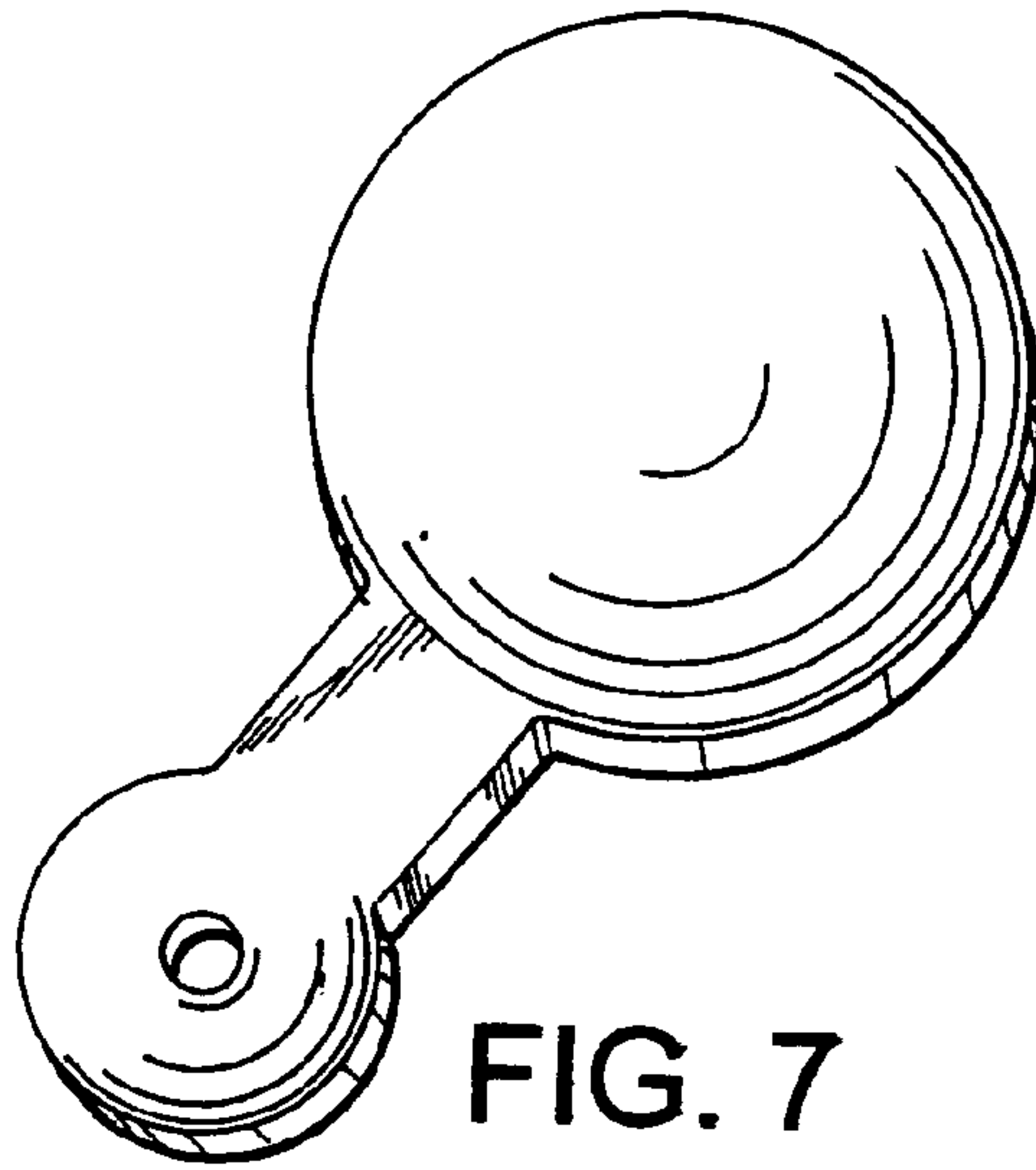

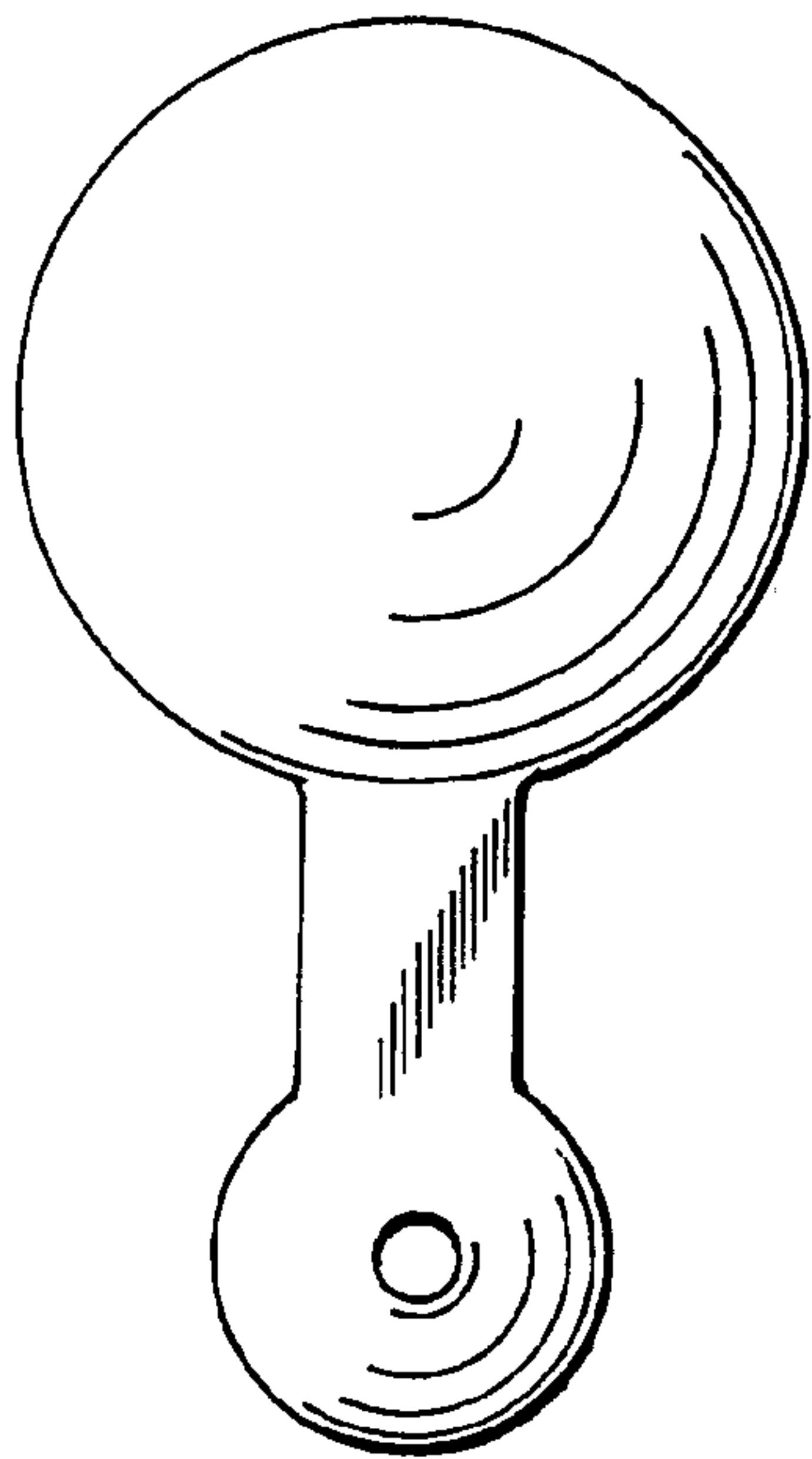

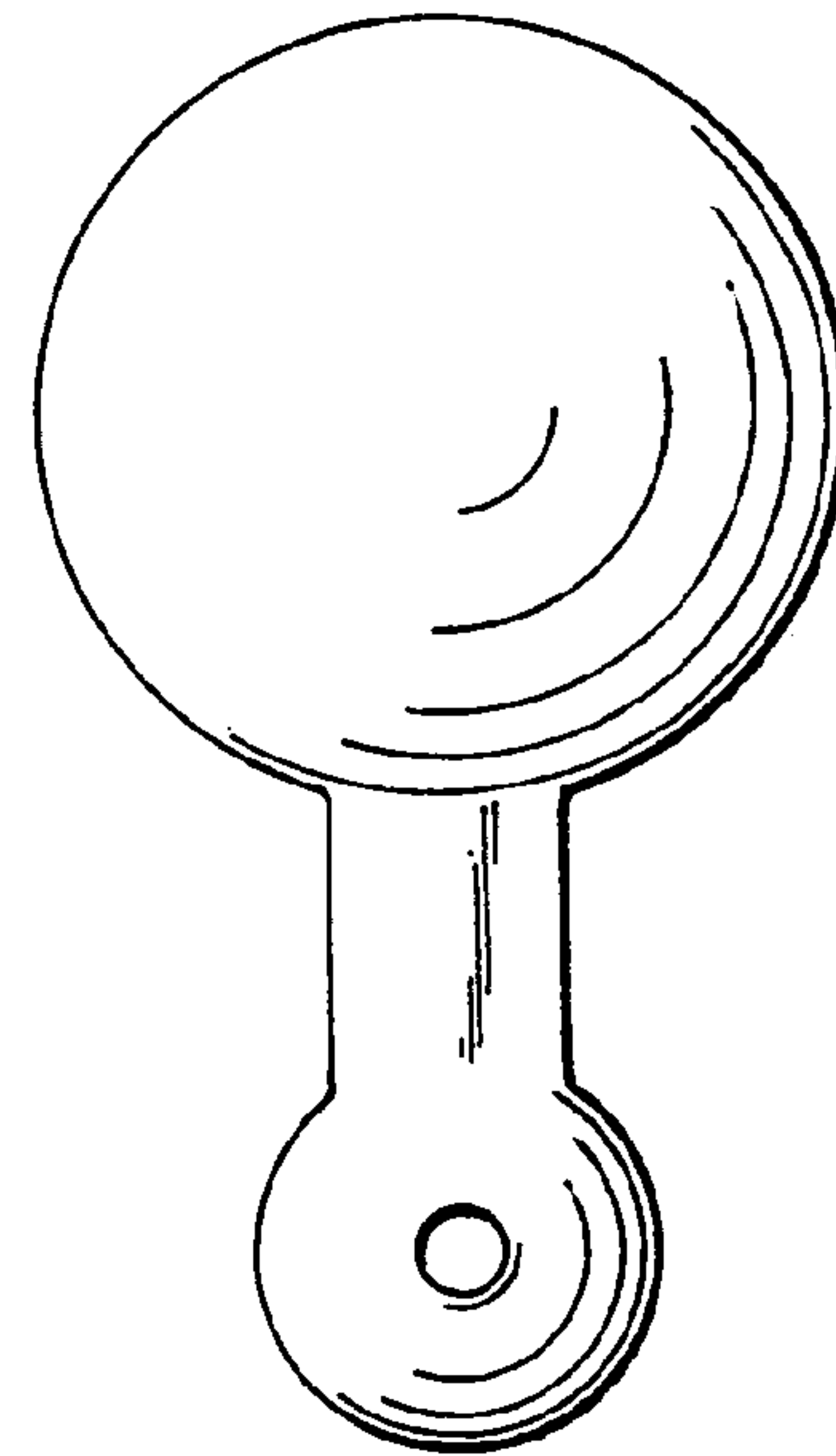

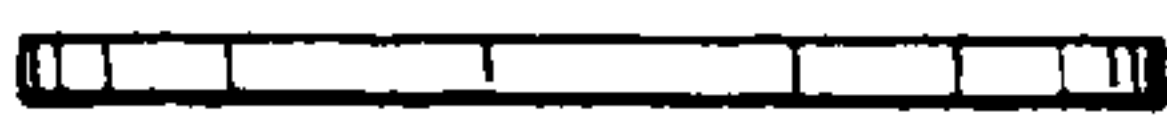

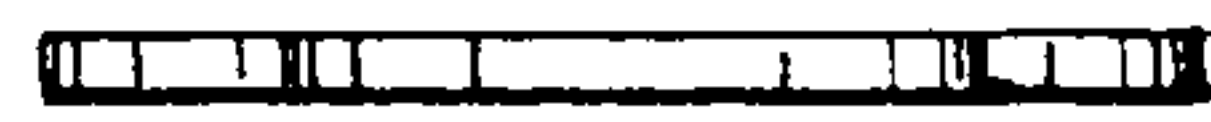

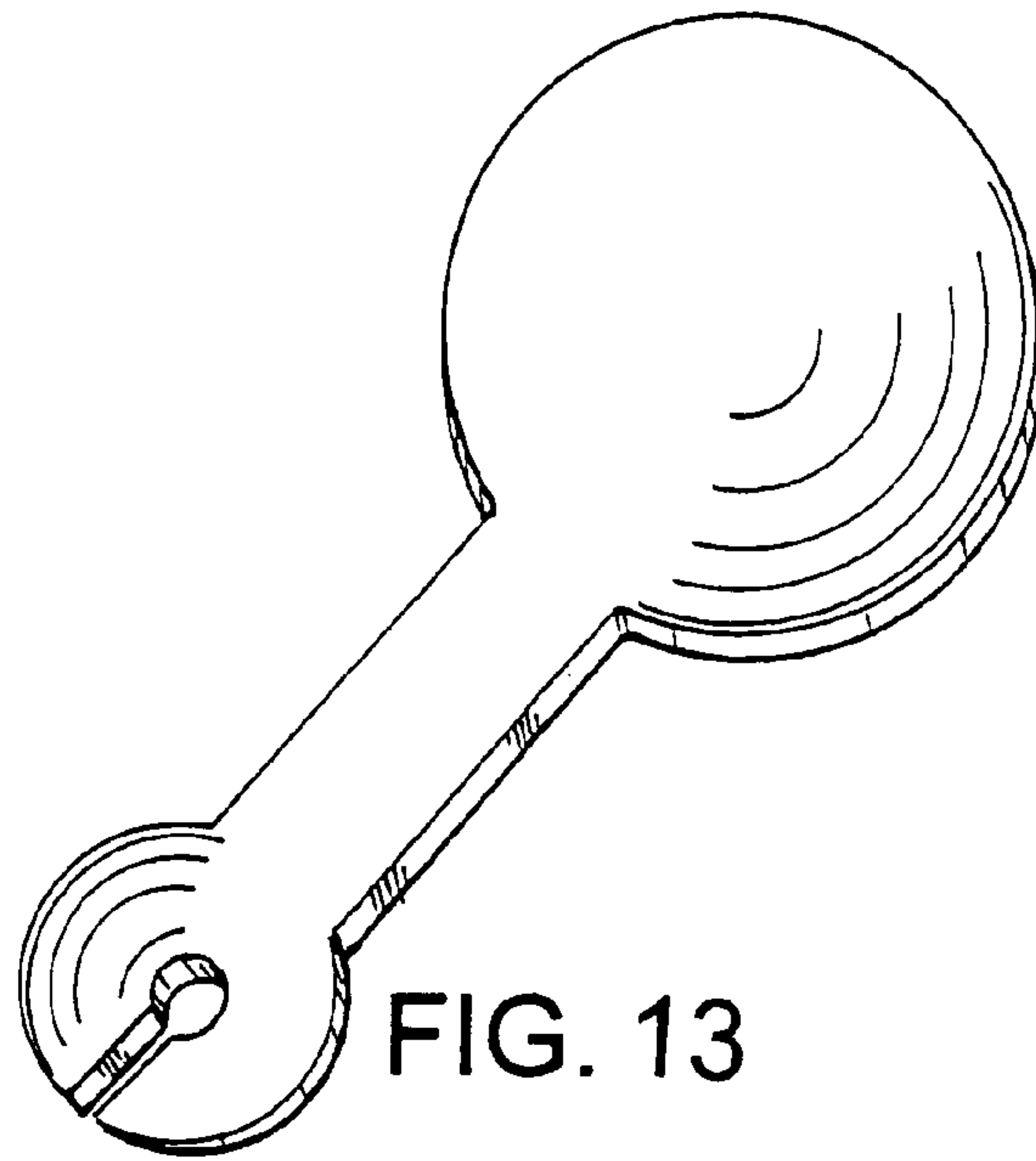

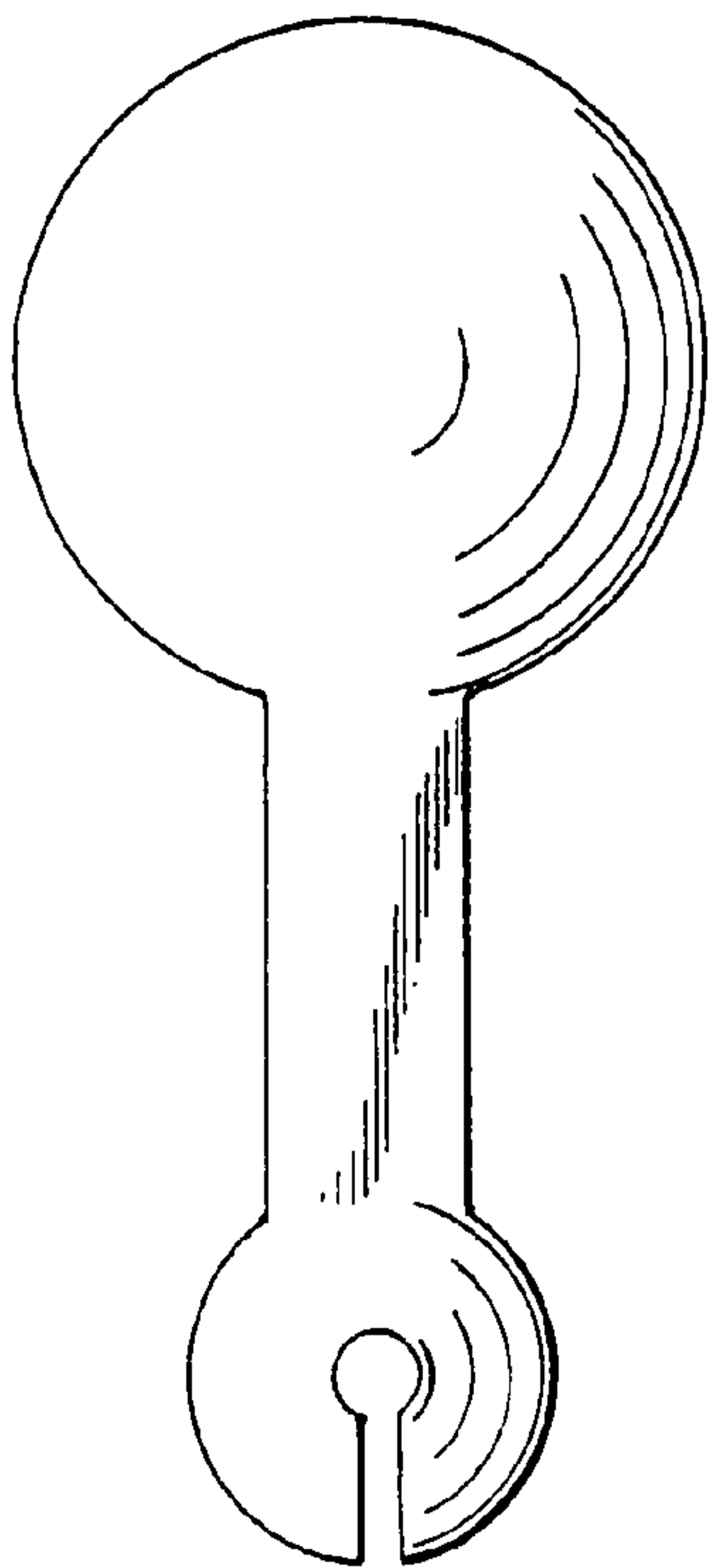

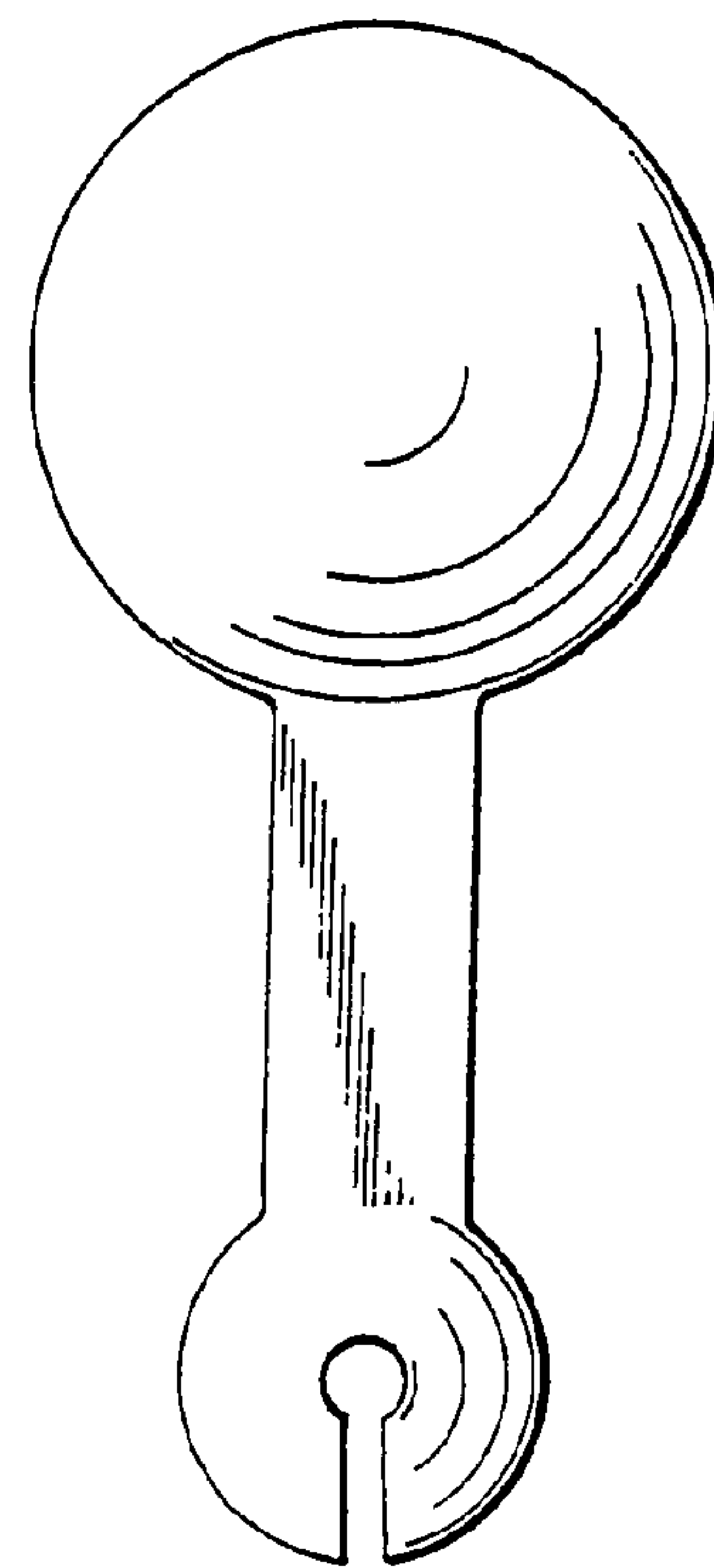

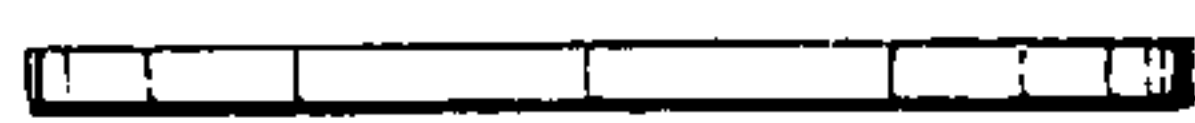

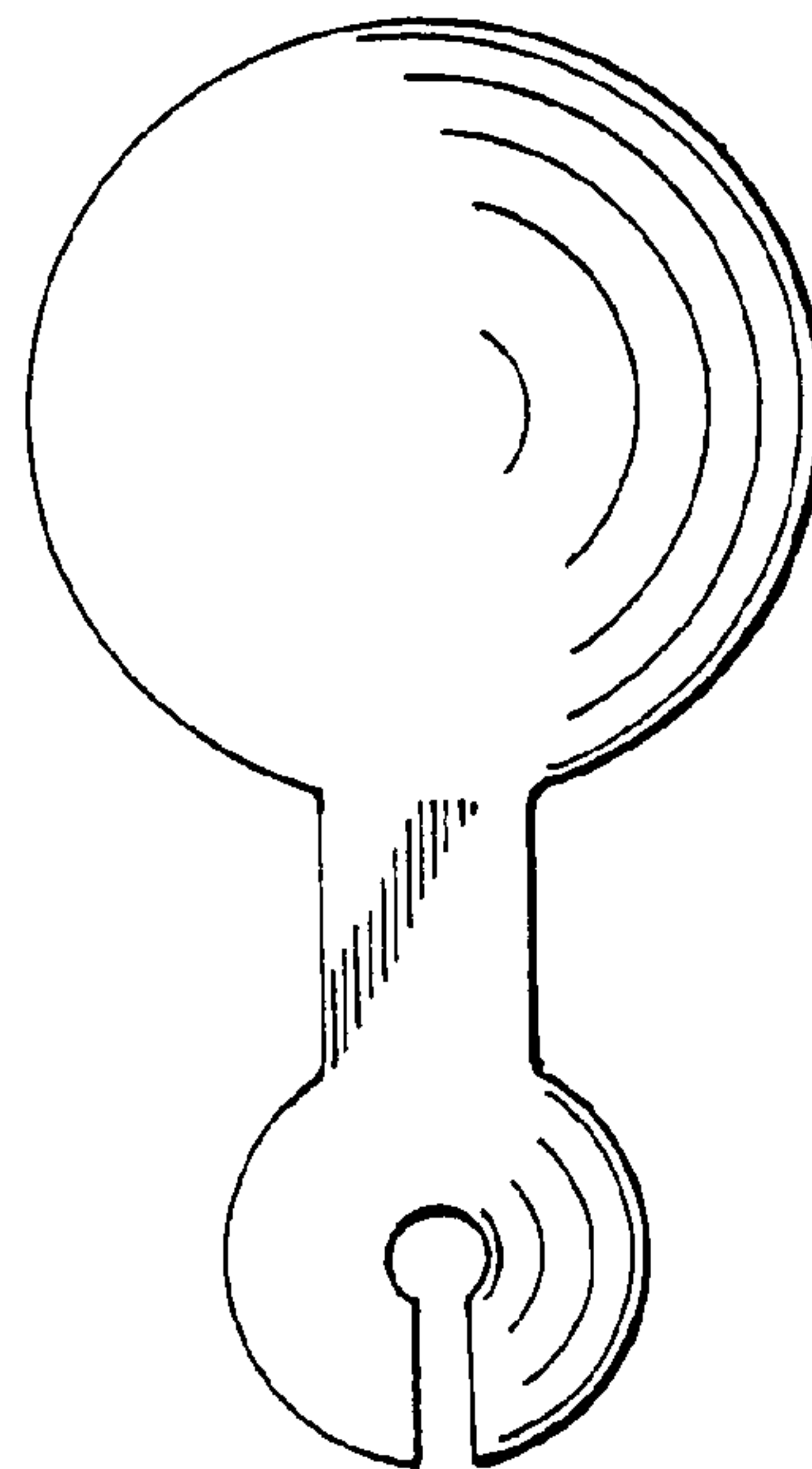
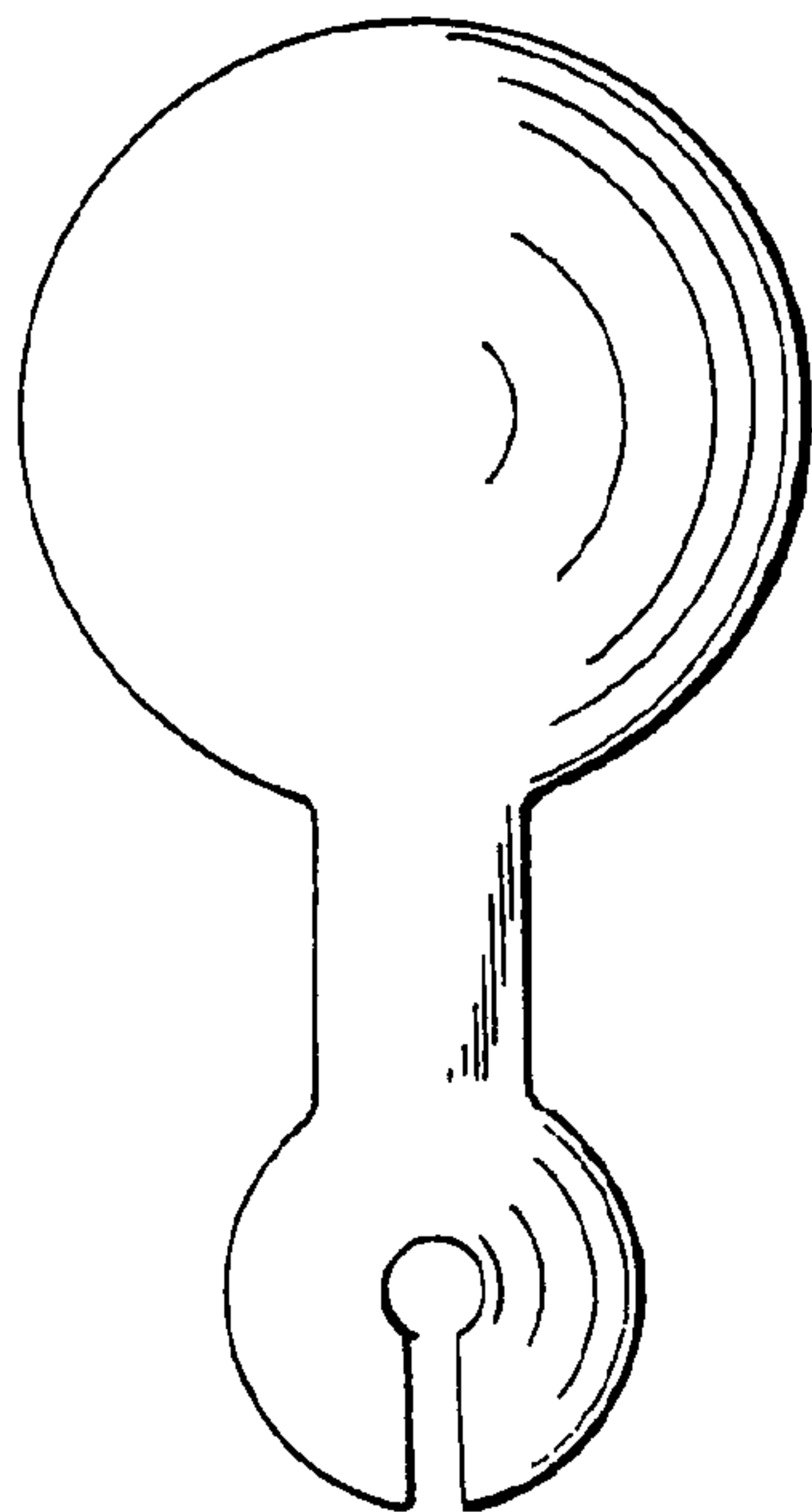
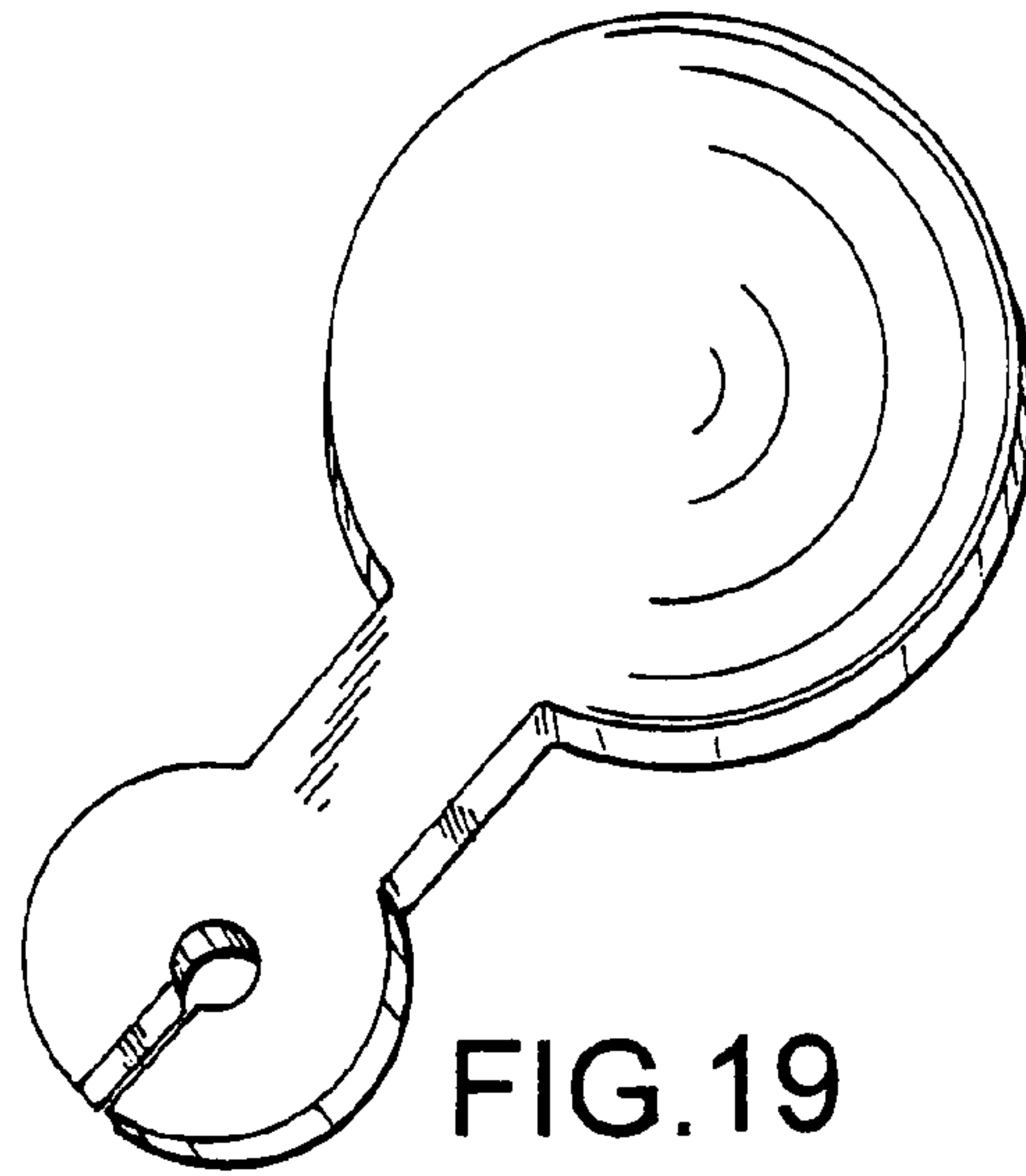

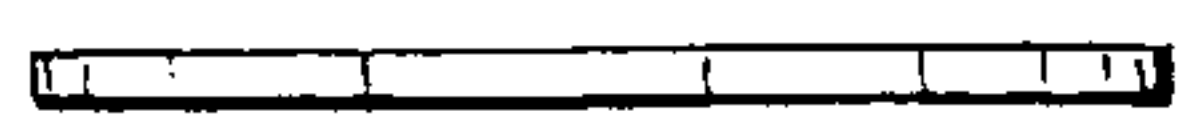
