**DESCRIPTION**

FIG. 1 is a top perspective view of a vitamin tablet showing our new design;

FIG. 2 is a right side elevational view thereof;

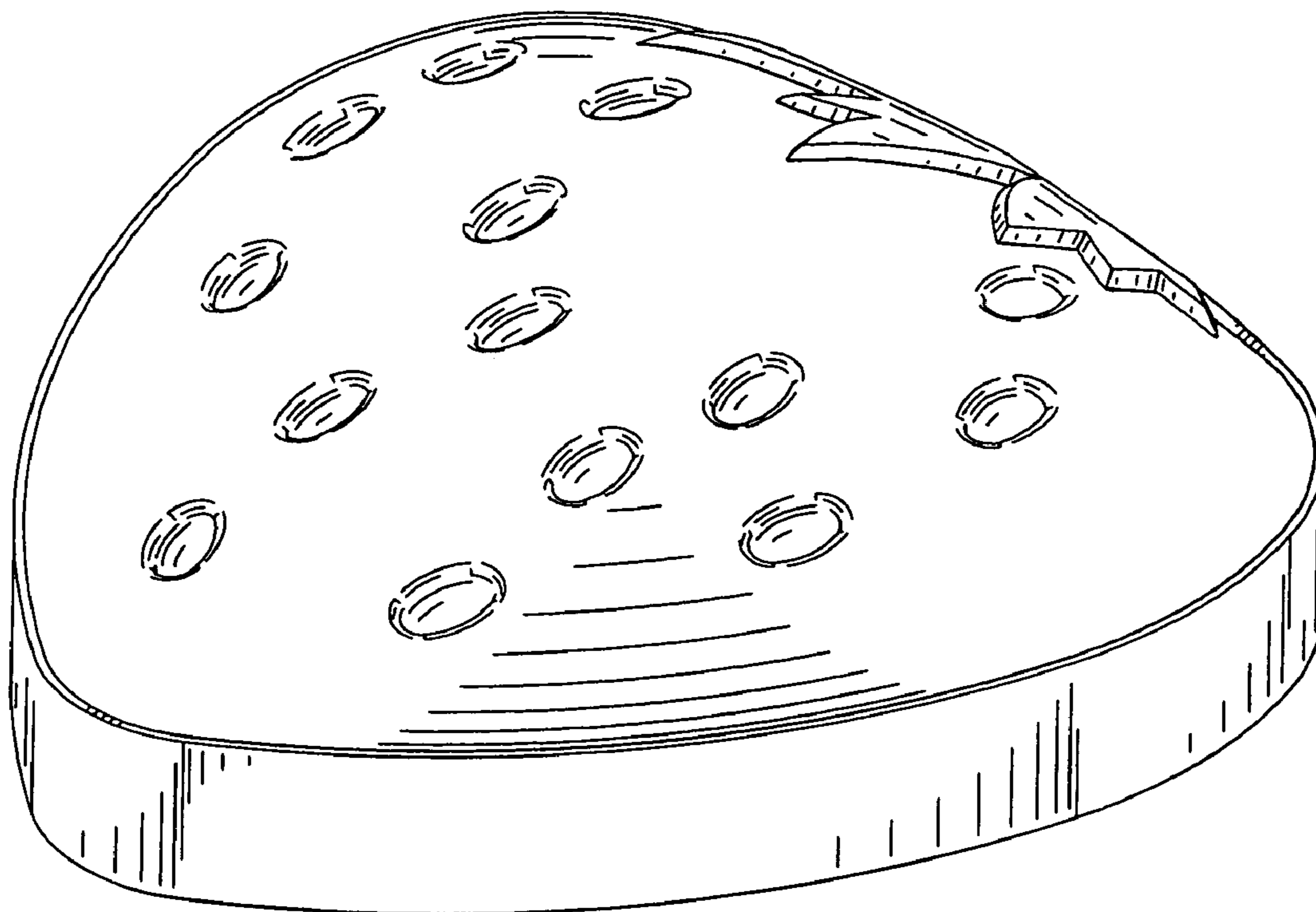
FIG. 3 is a top plan view thereof, the bottom plan view being a mirror image of the top plan view;

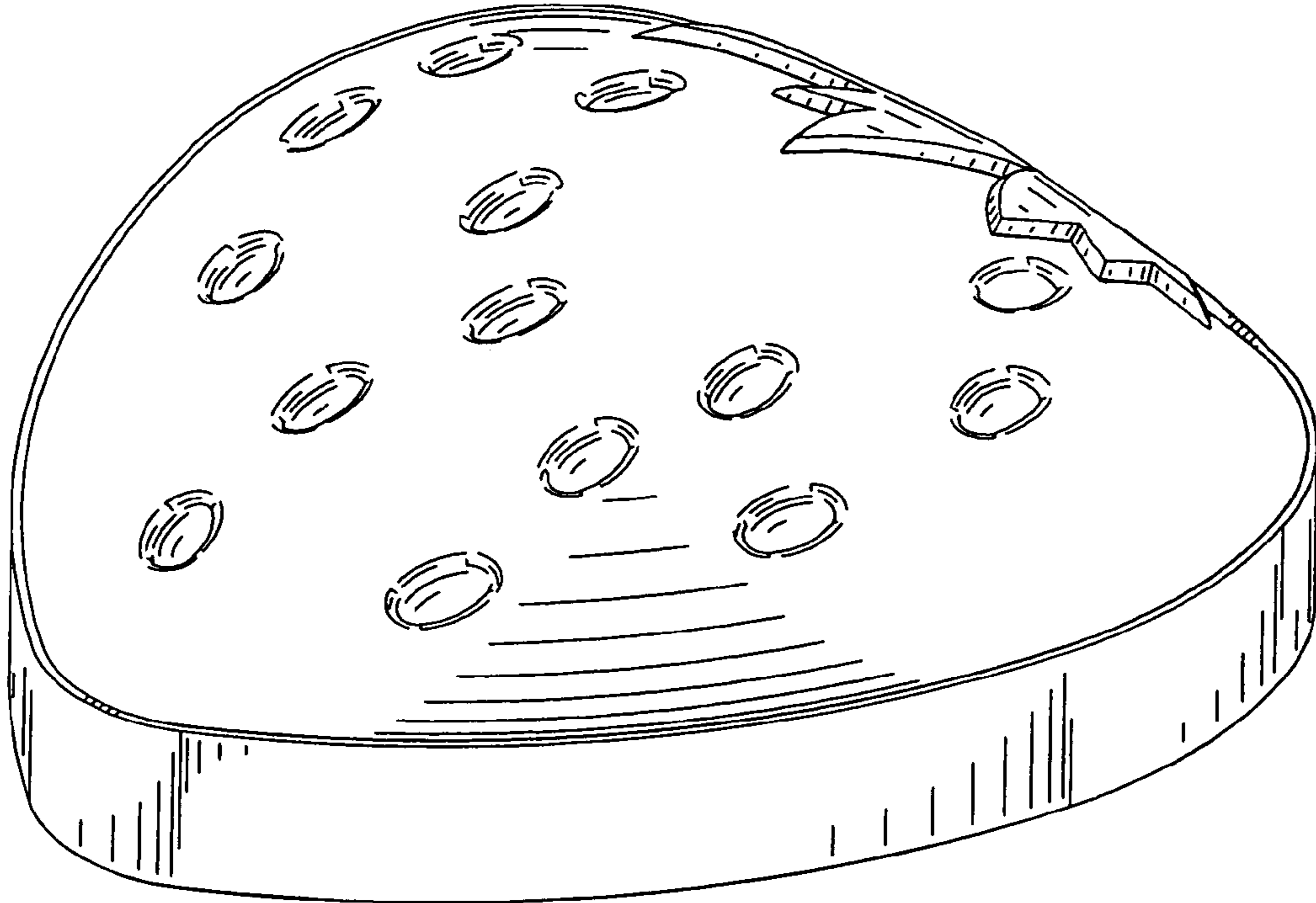

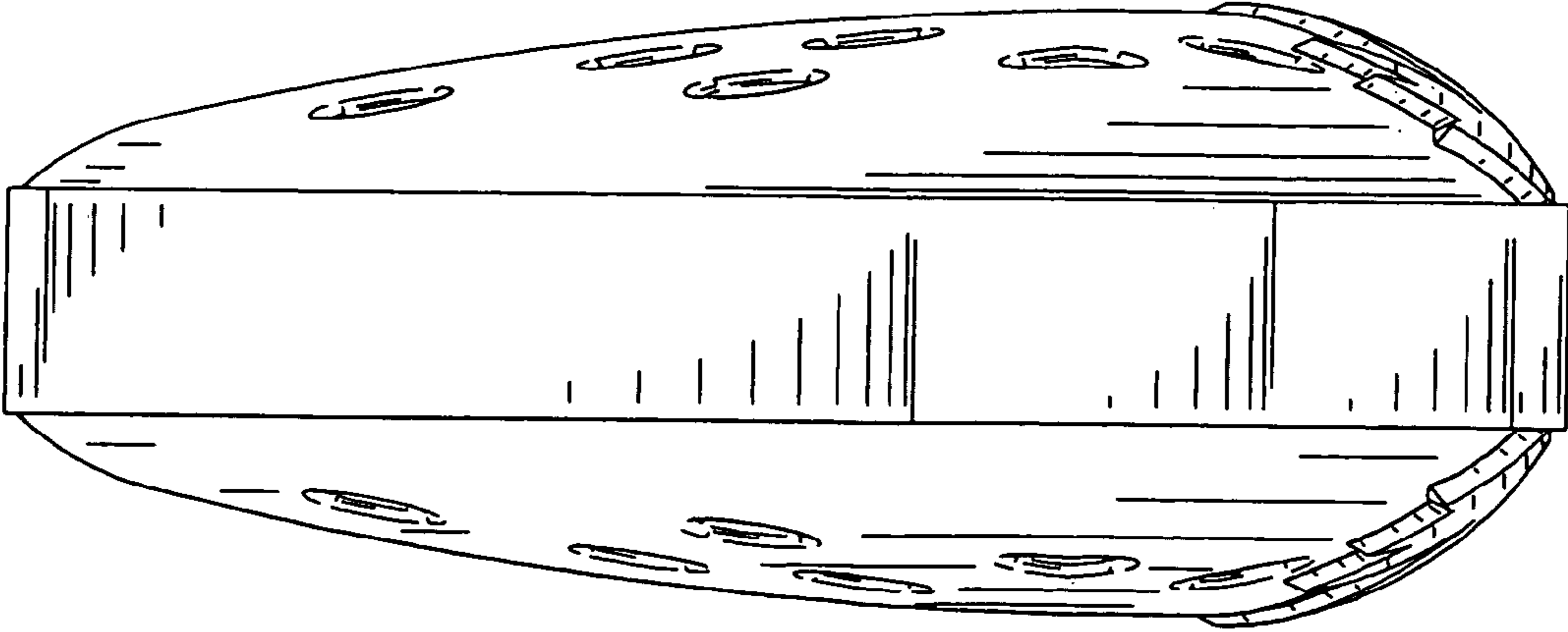

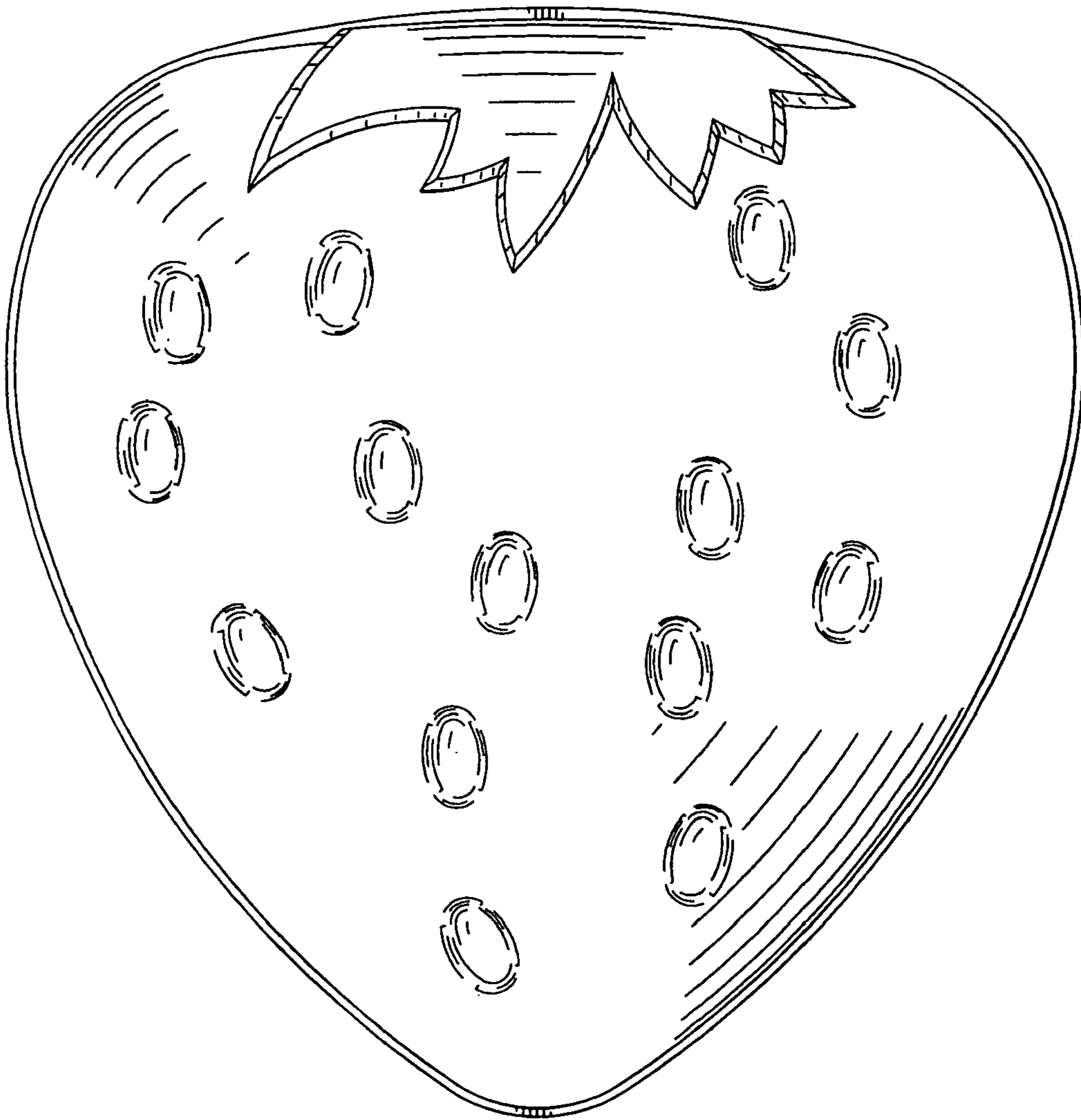

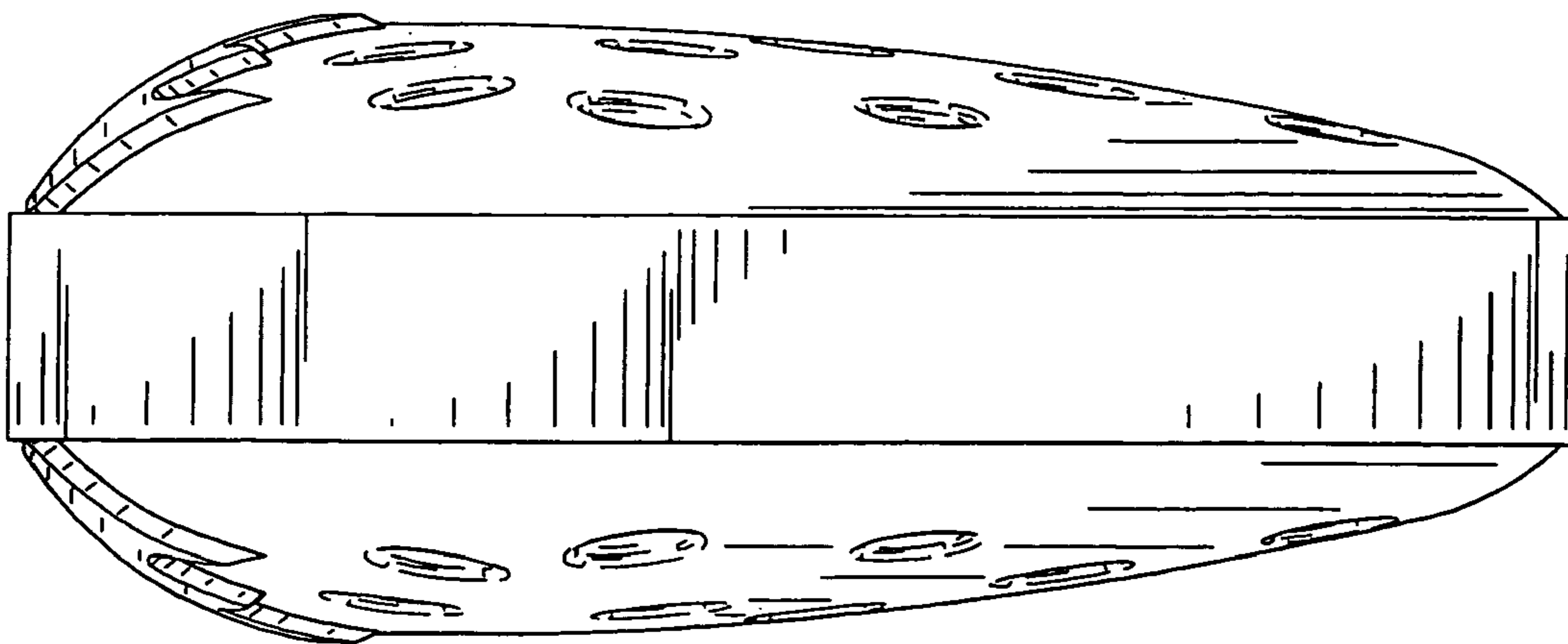

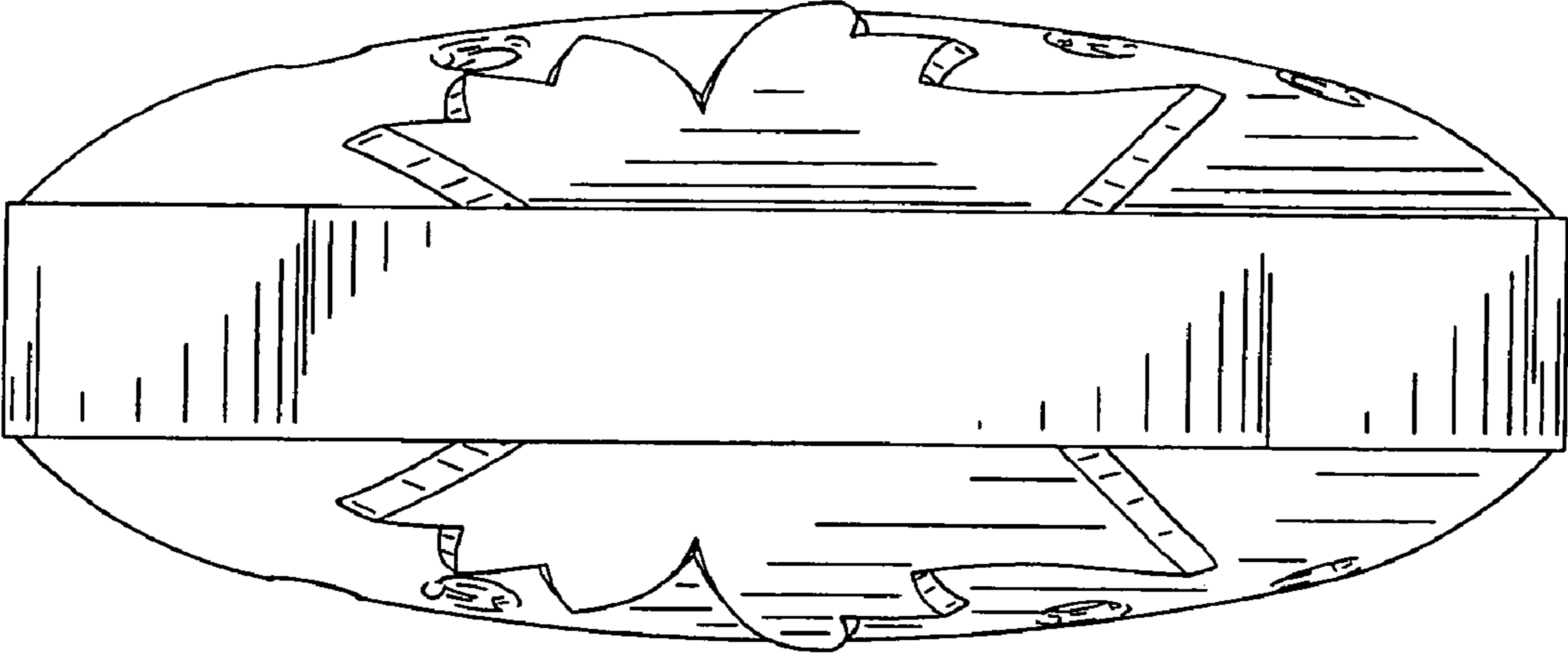

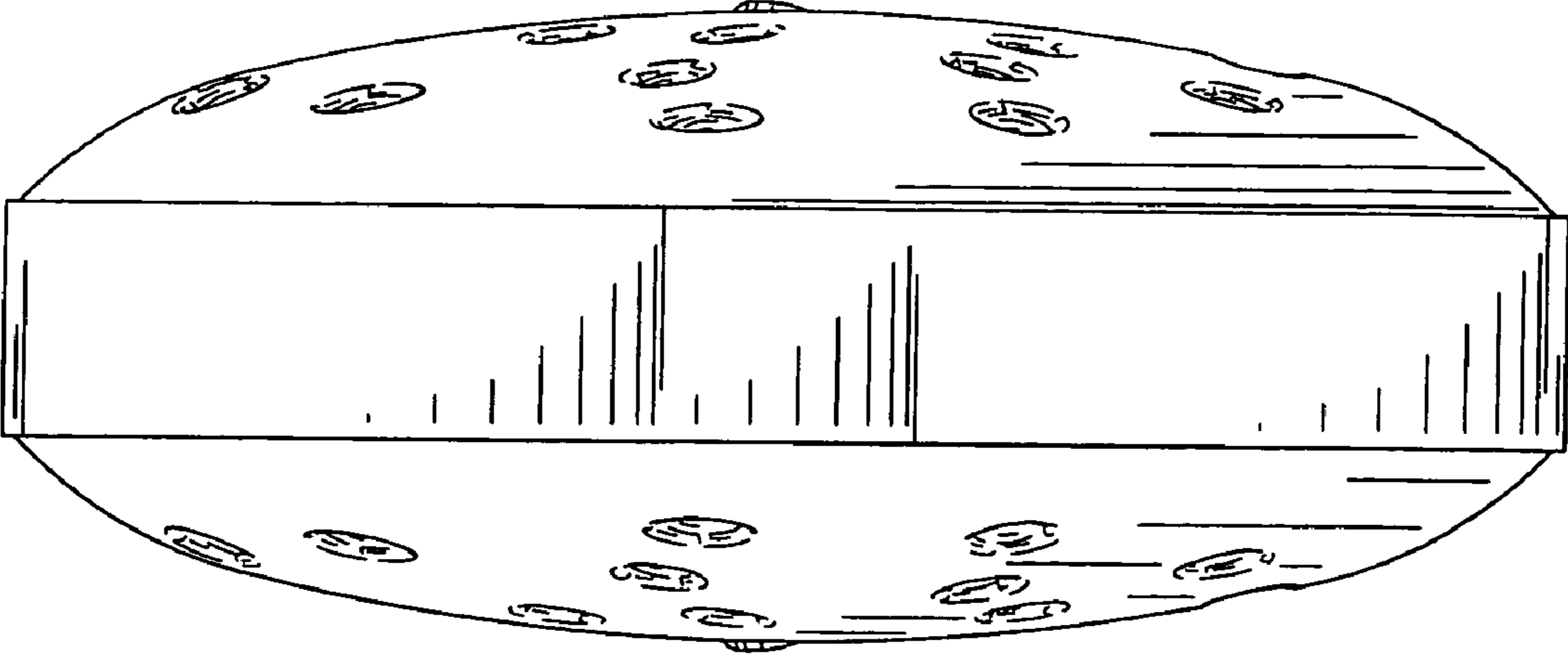
