(57) **CLAIM**

The ornamental design for a trim for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the trim for light fixture showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is another side view thereof at 90° to that of FIG. 3;

FIG. 5 is an opposite side view thereof at 180° to that of FIG. 3;

FIG. 6 is a top plan view thereof;

FIG. 7 is a perspective view of a second embodiment of the trim for light fixture;

FIG. 8 is a bottom view thereof;

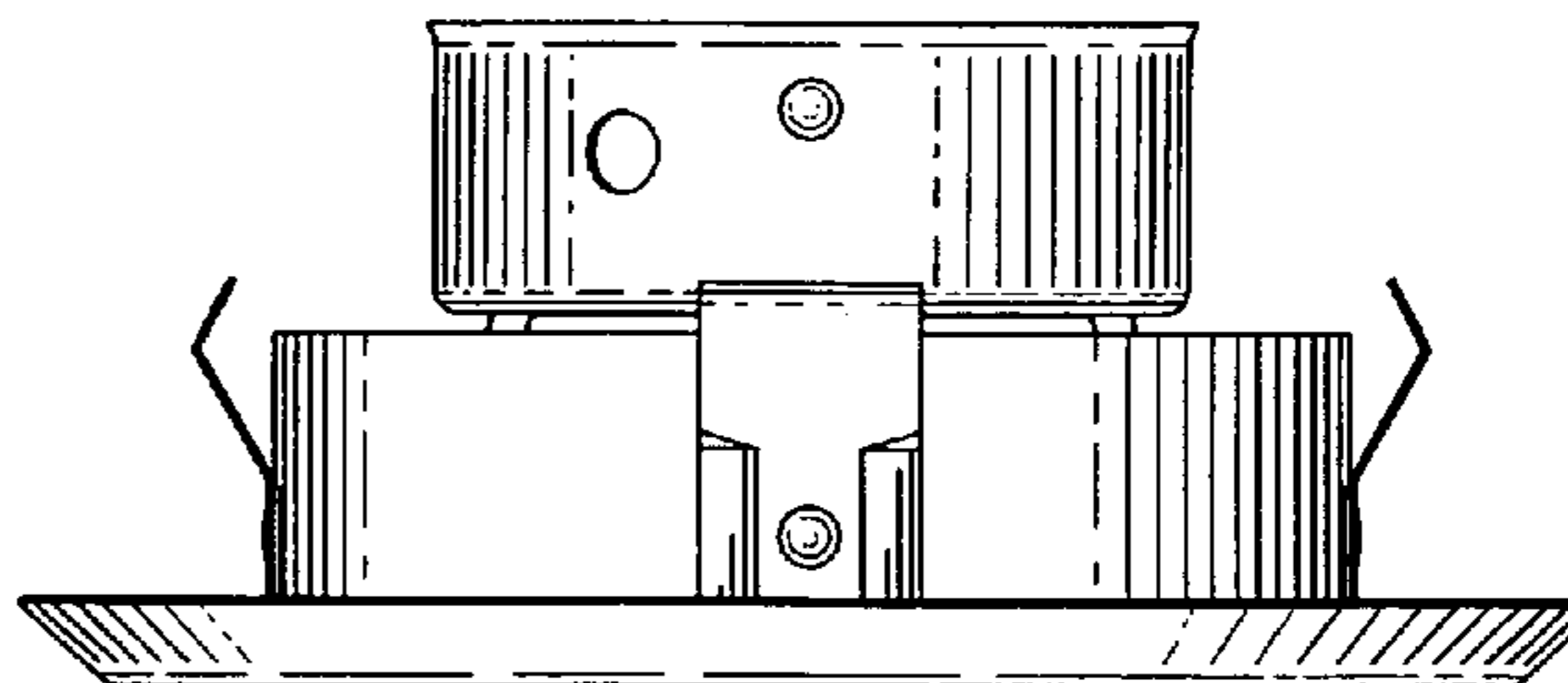
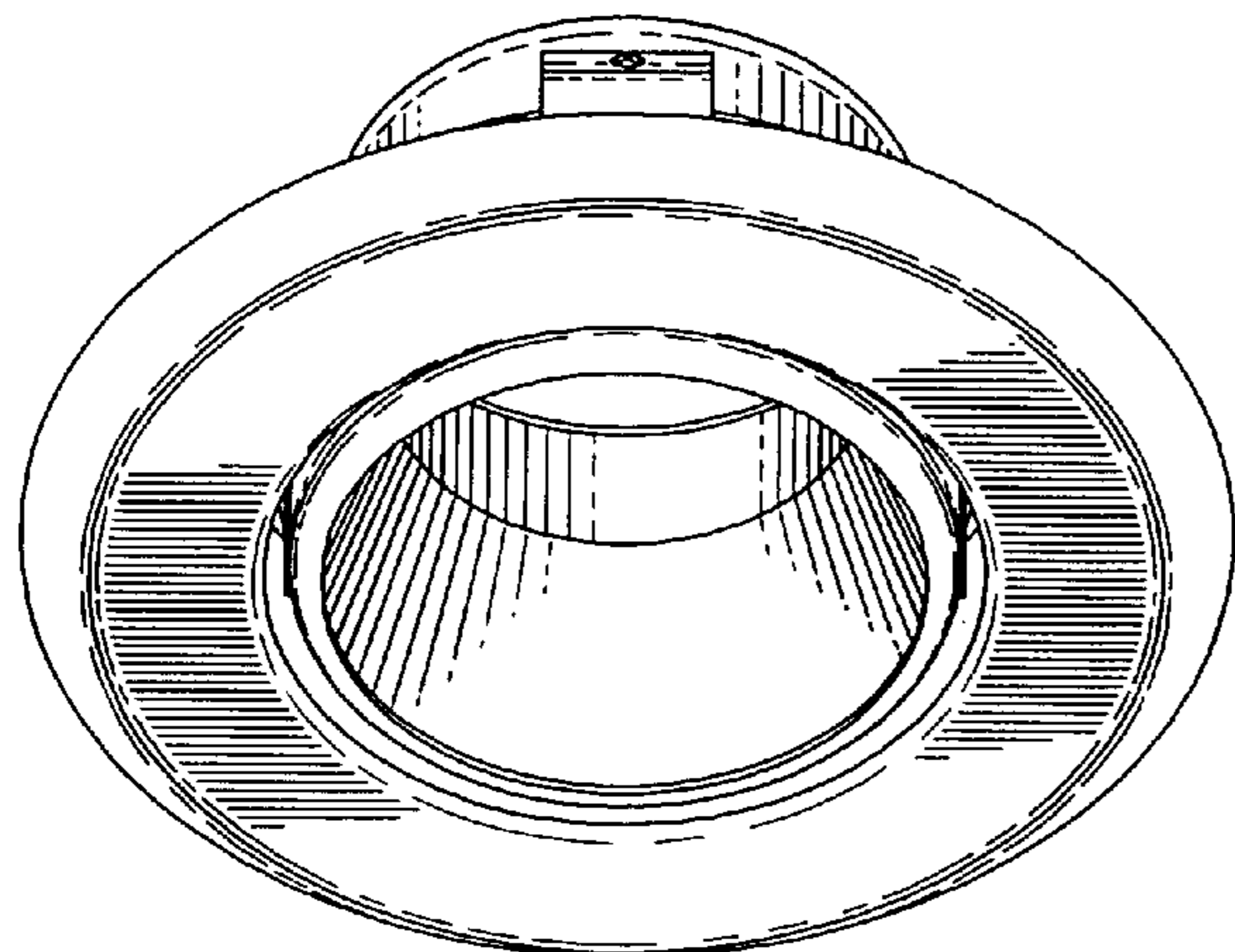
FIG. 9 is a side view thereof;

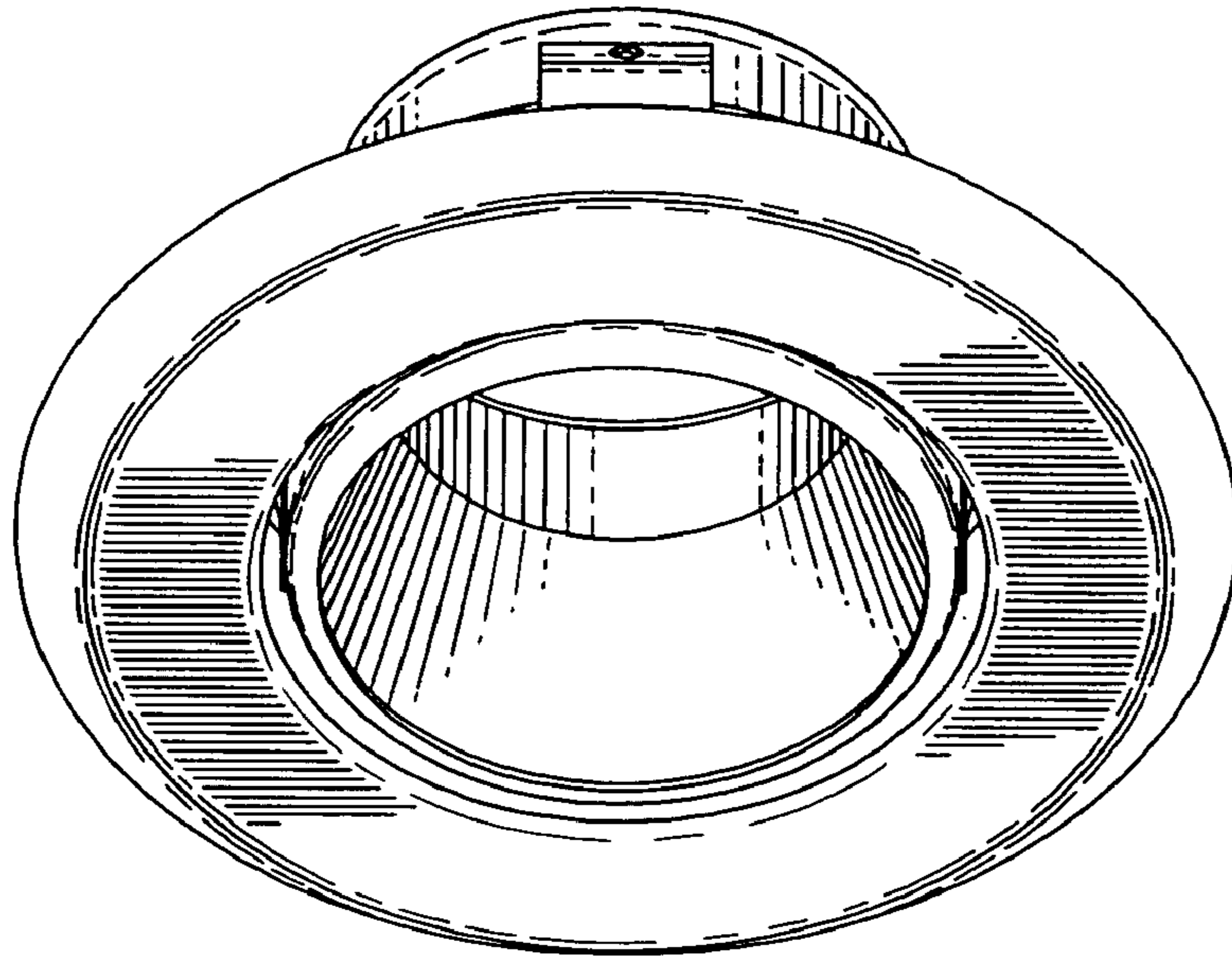

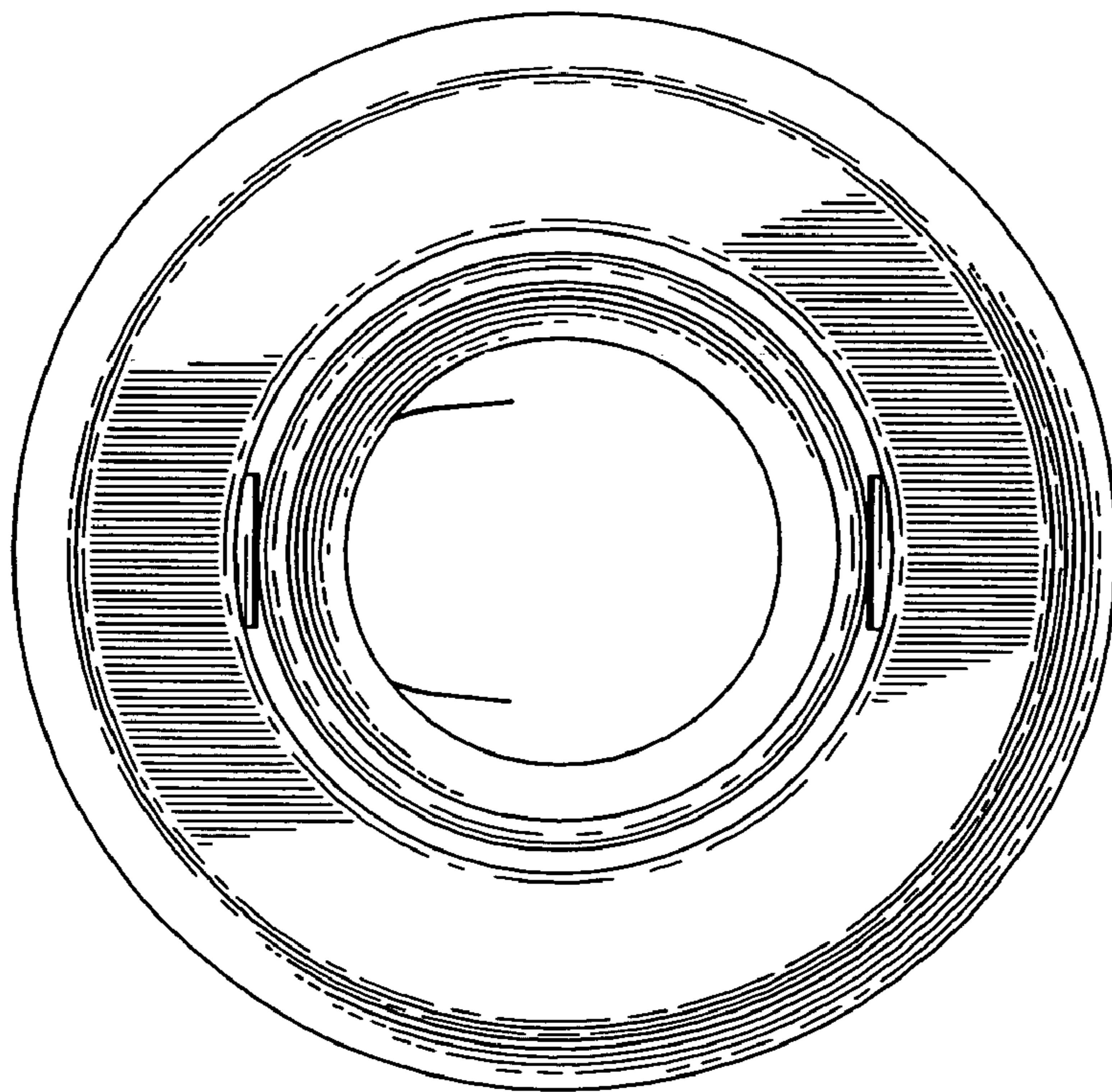

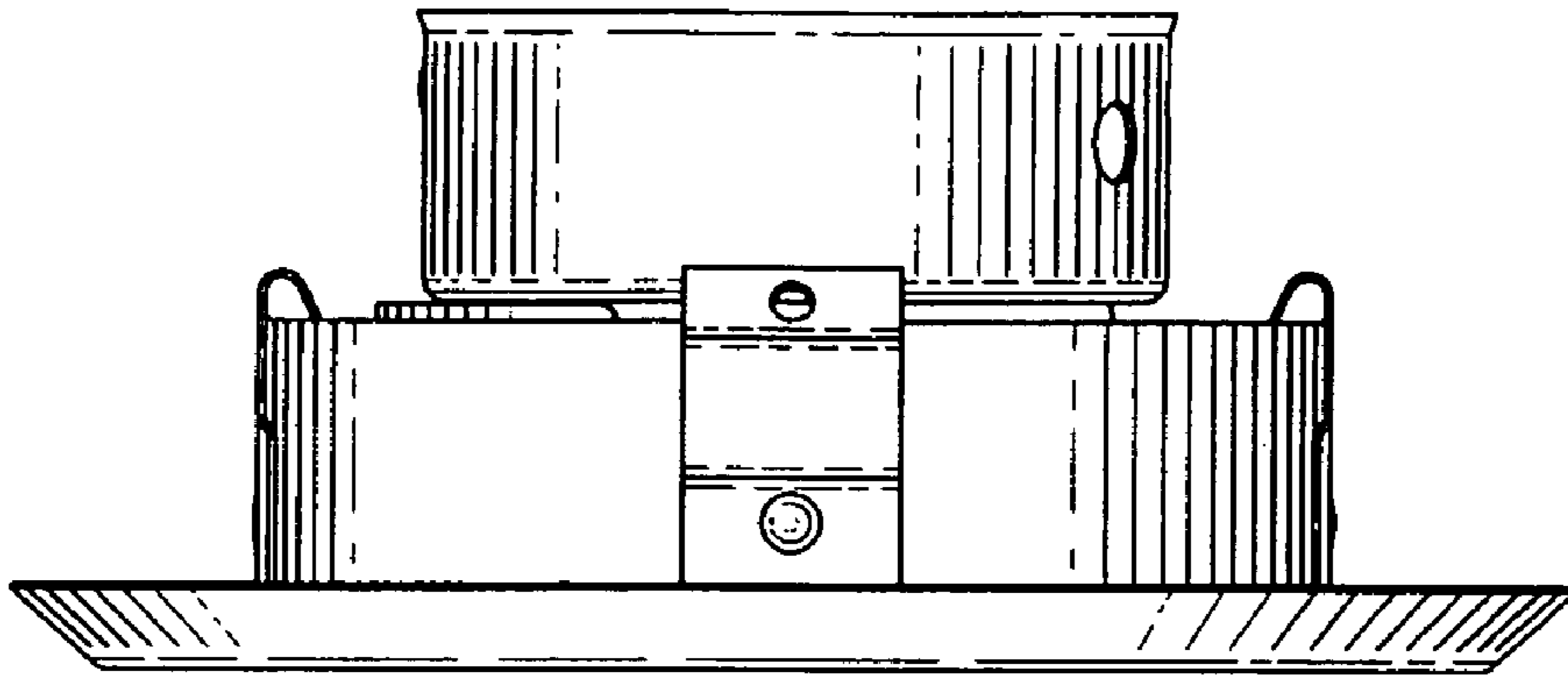

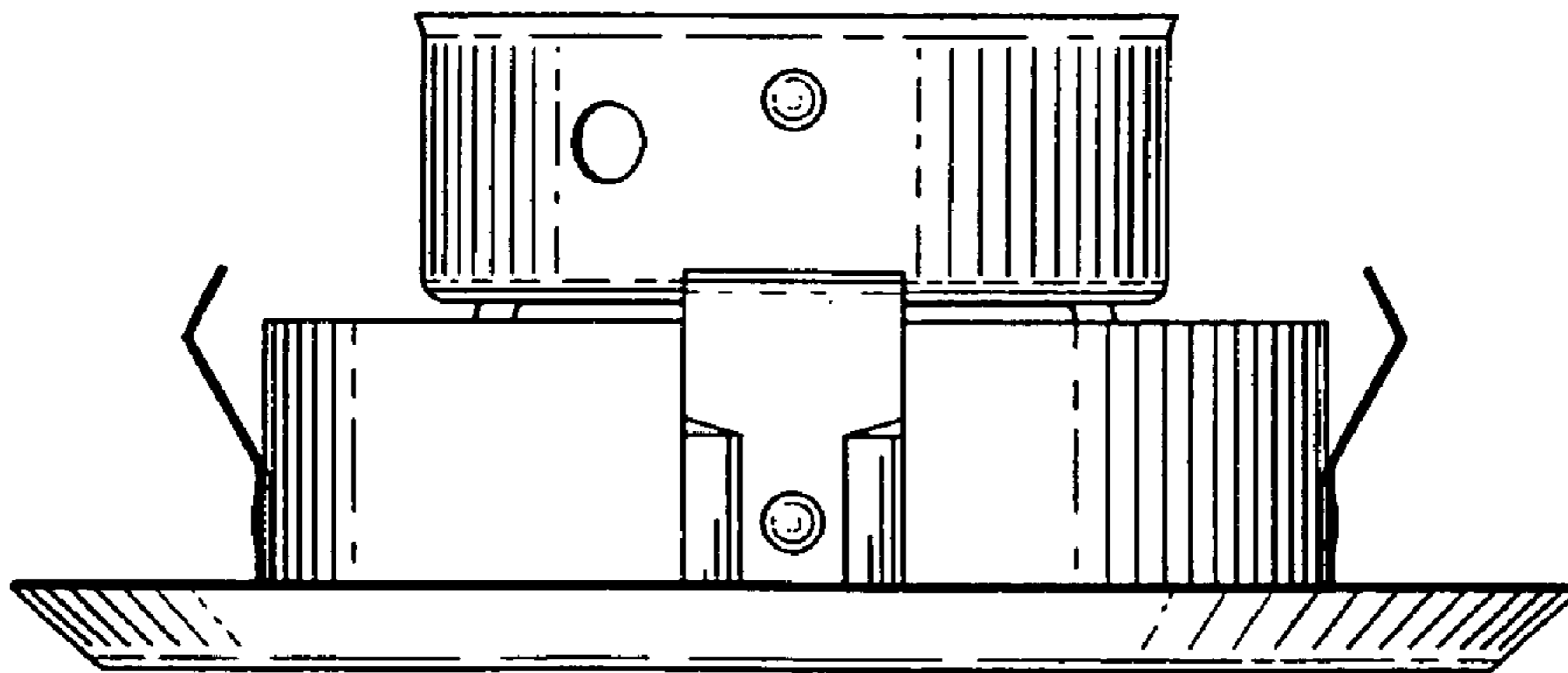

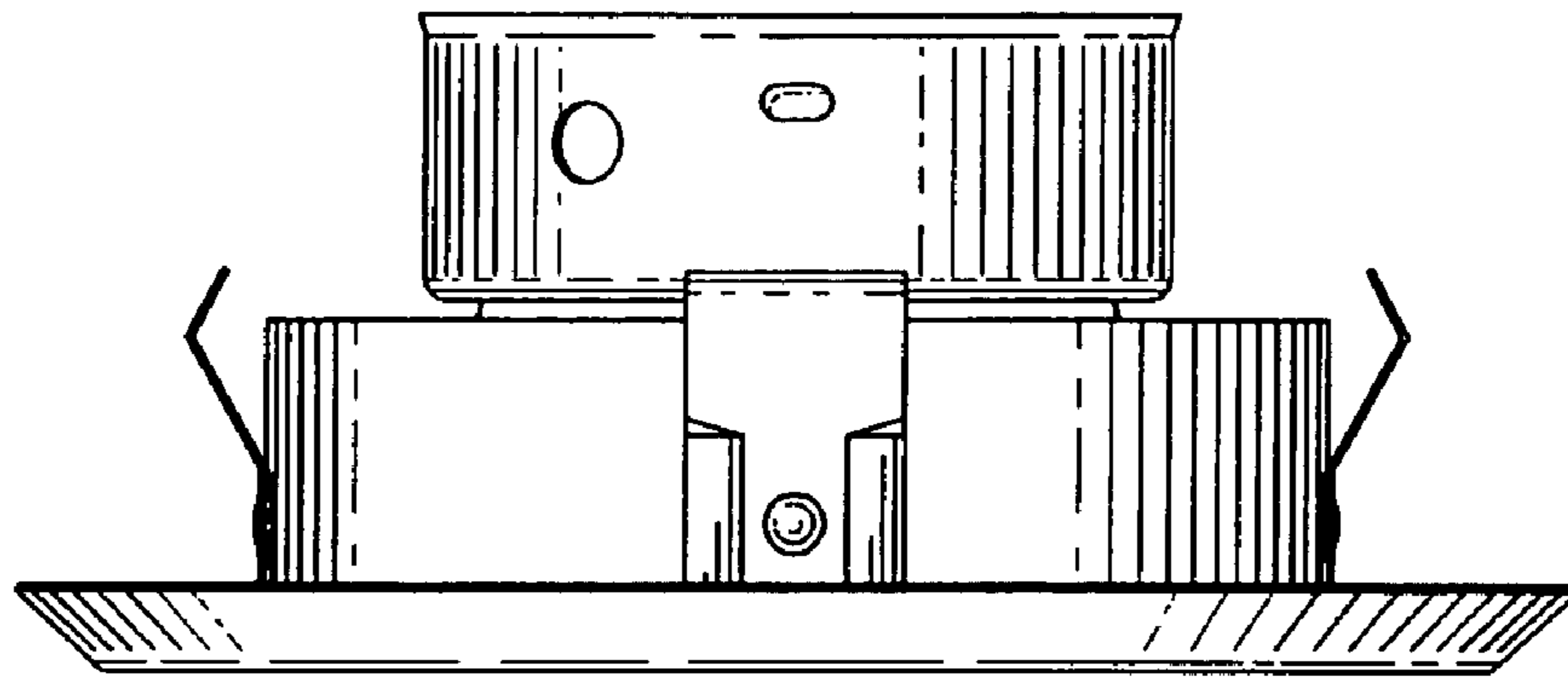

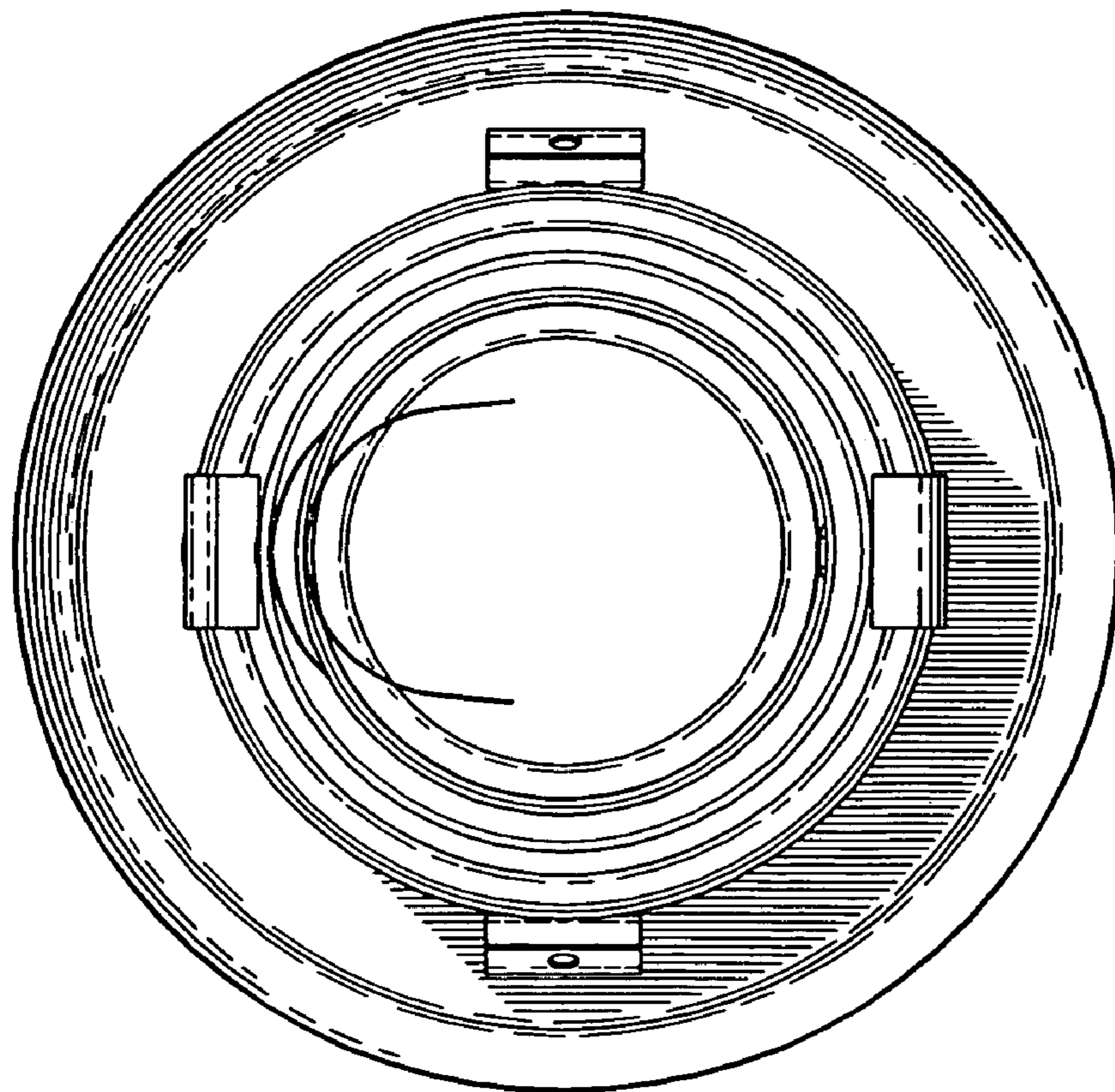

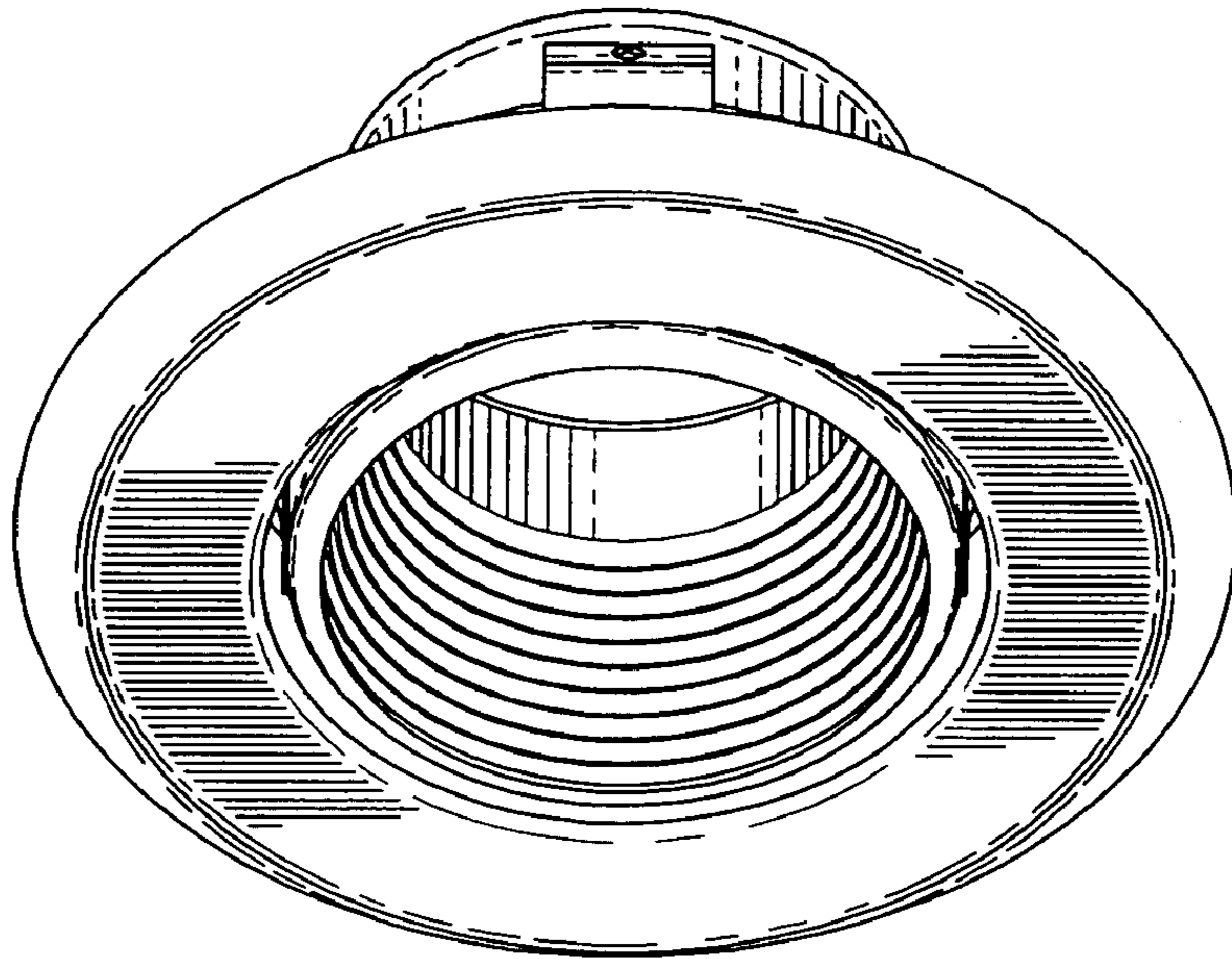

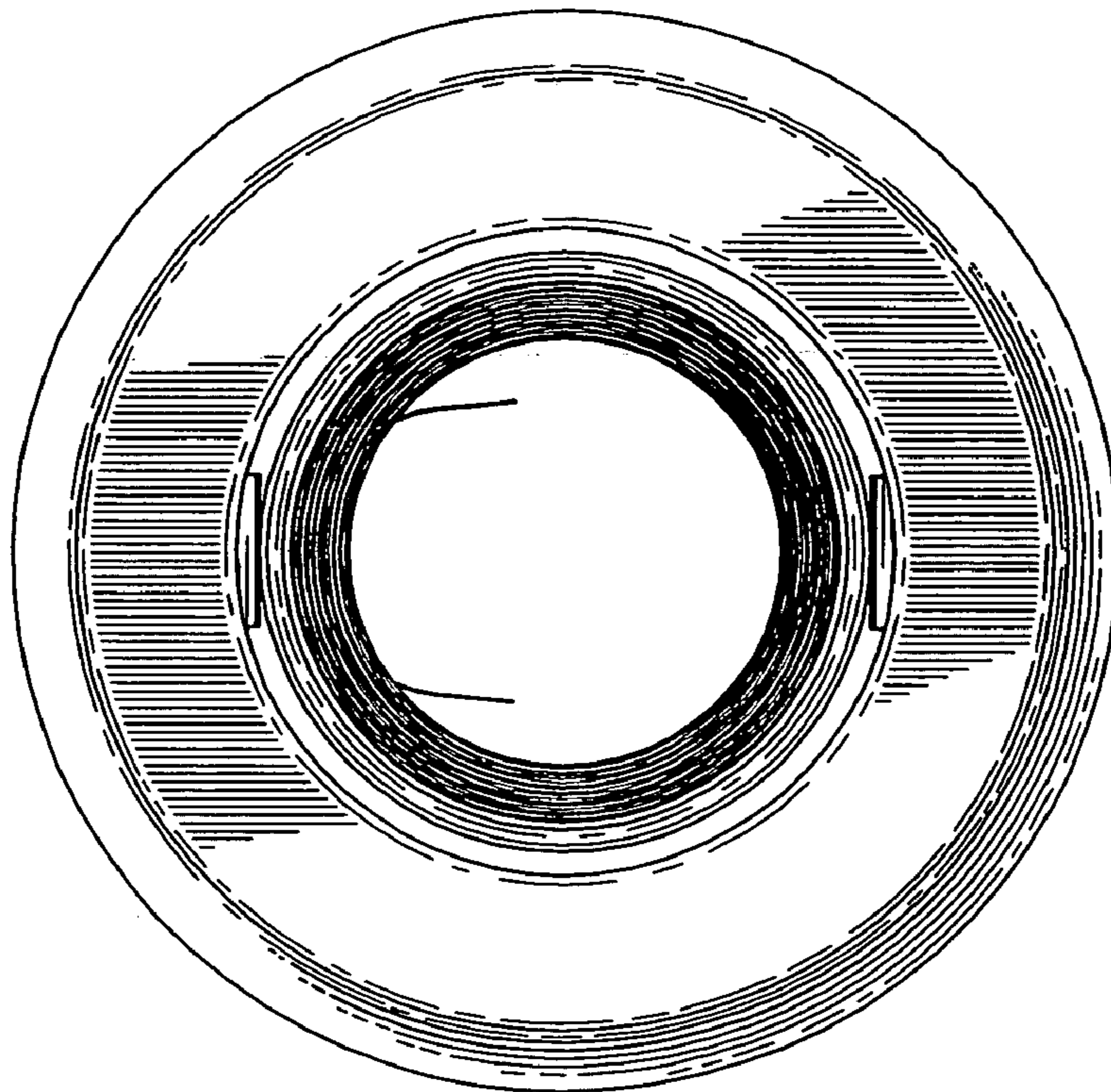

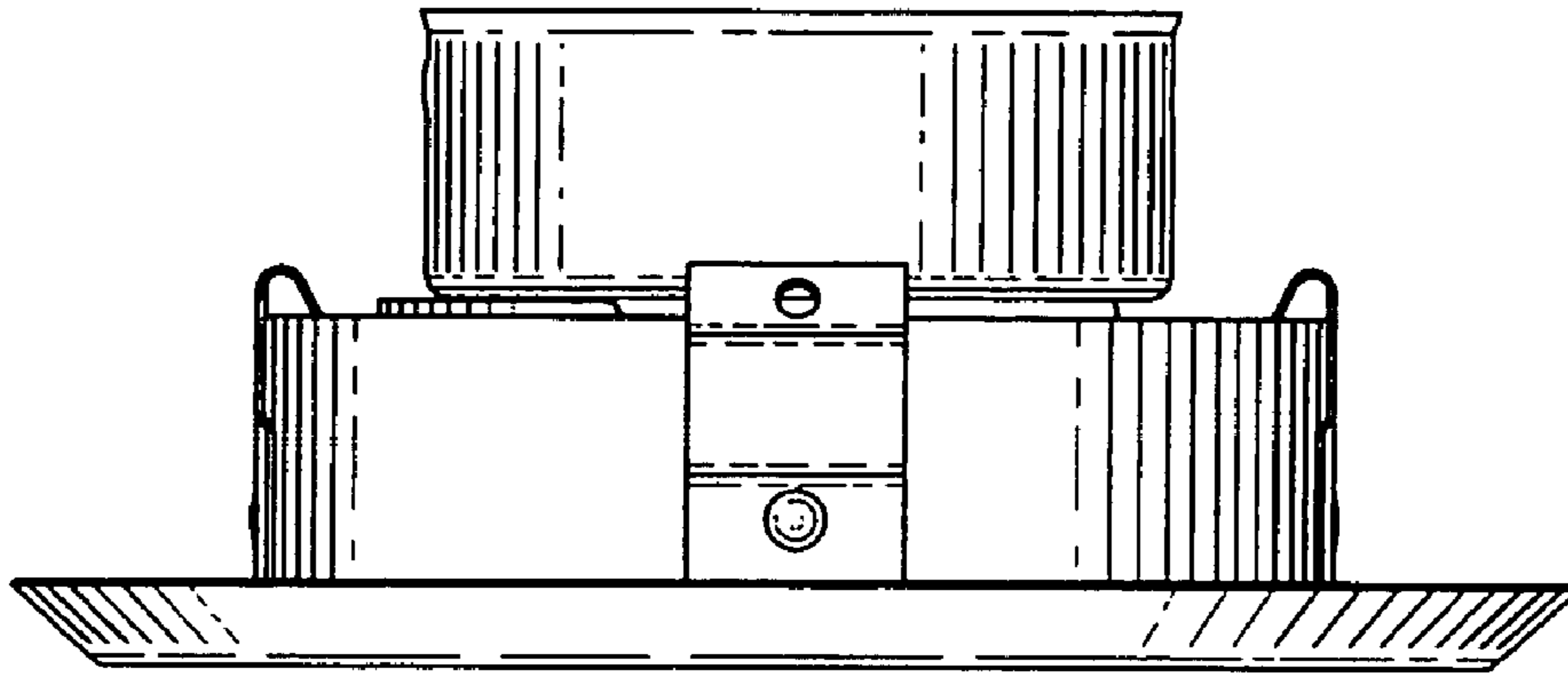

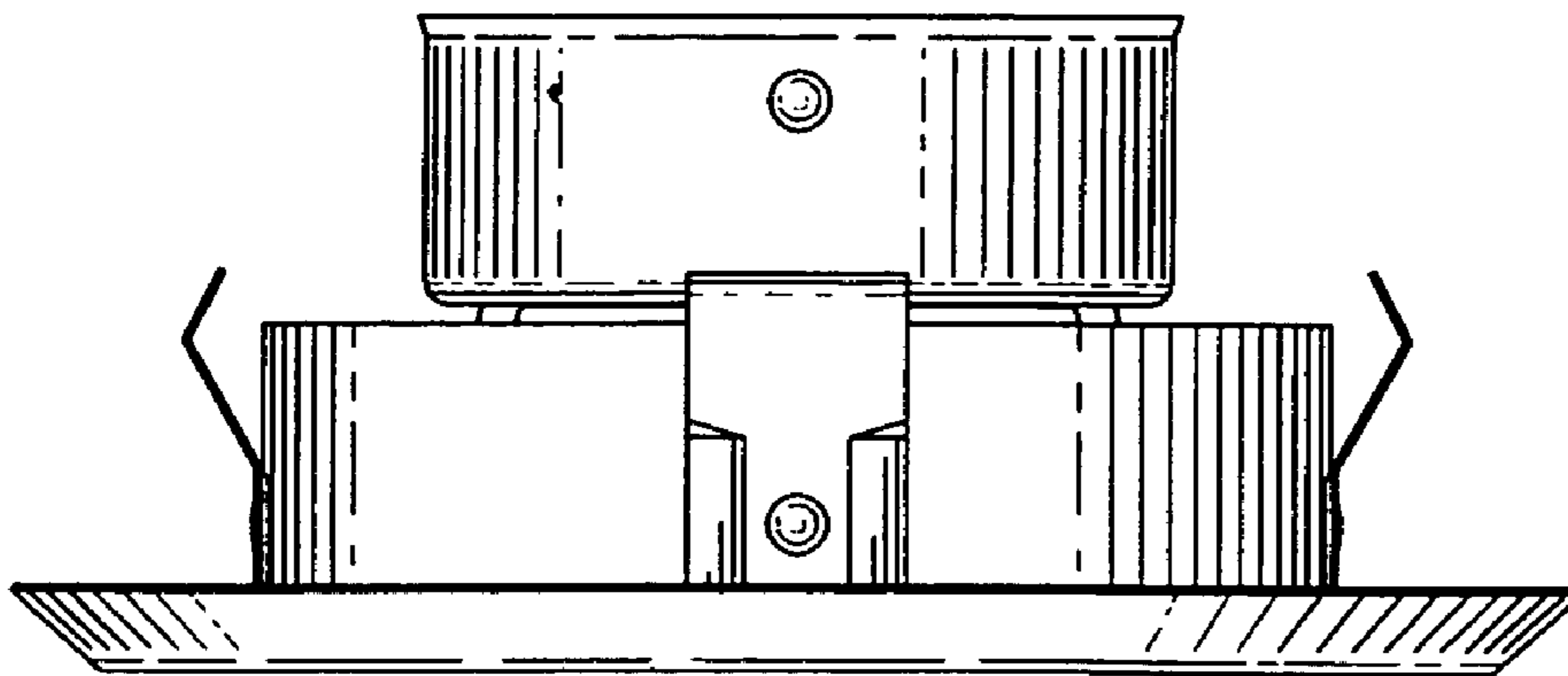

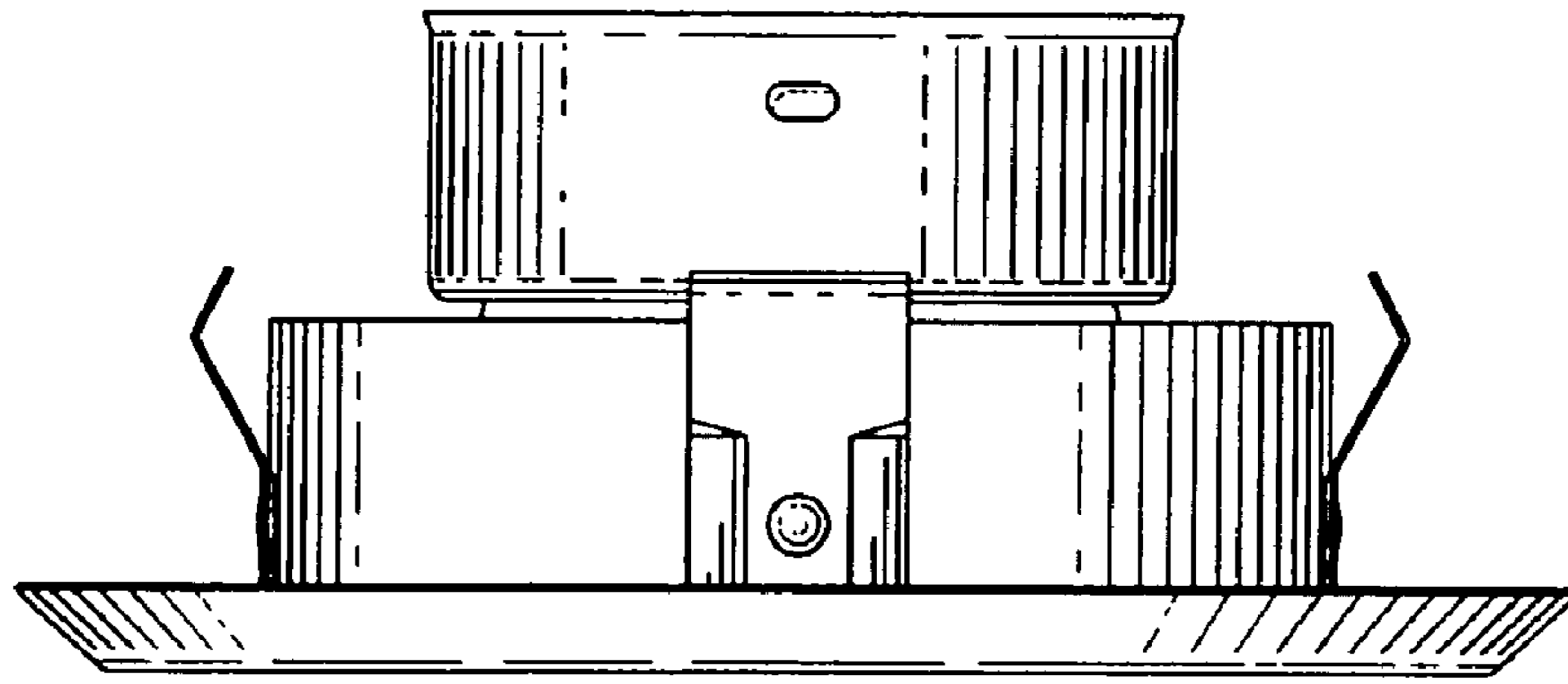

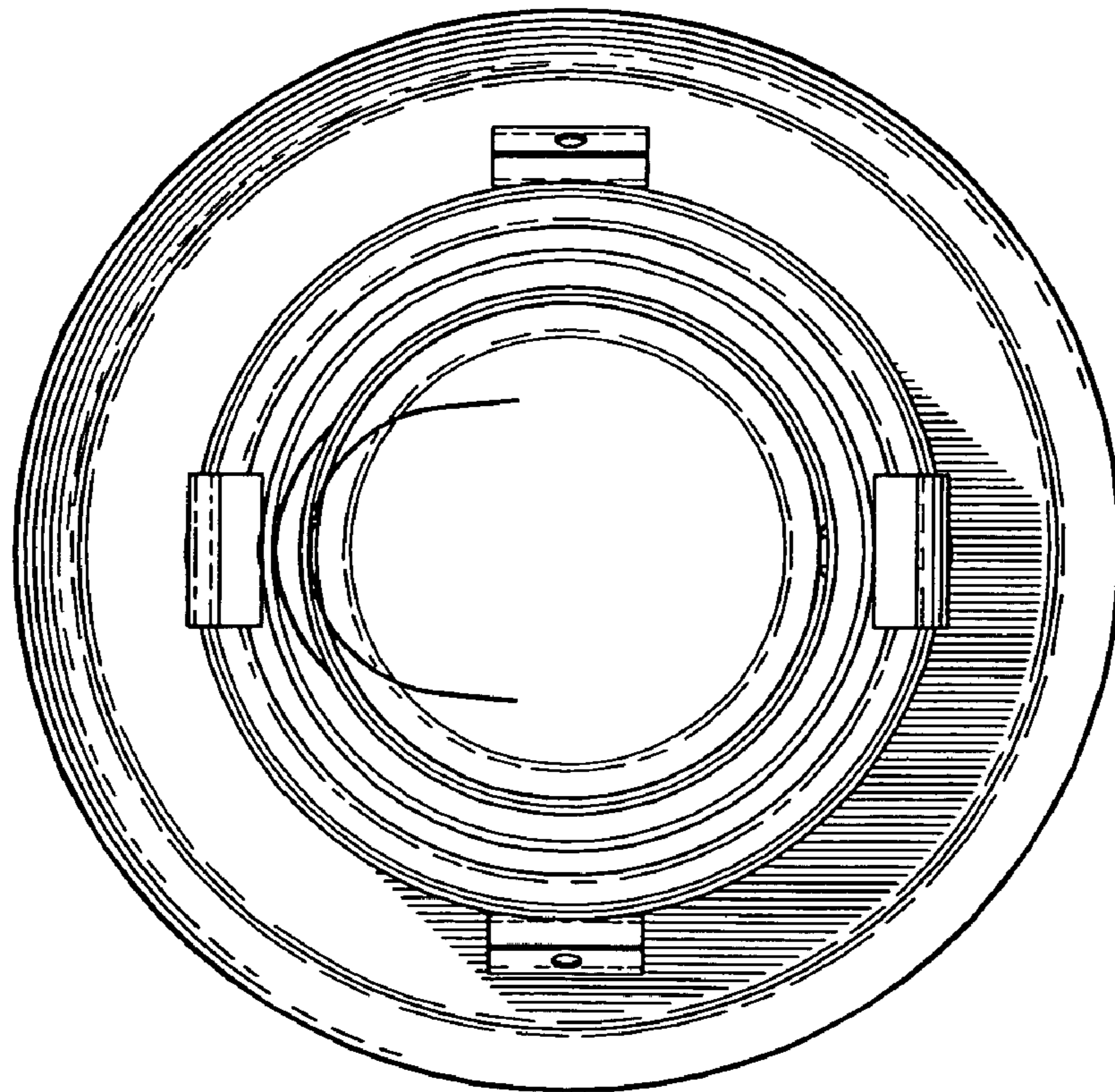
