(57) **CLAIM**

The ornamental design for a padded neck collar, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a padded neck collar.

FIG. 2 is a bottom plan view of the padded neck collar in FIG. 1.

FIG. 3 is a right-side elevational view of the padded neck collar in FIG. 1.

FIG. 4 is a left-side elevational view of the padded neck collar in FIG. 1.

FIG. 5 is a back elevational view of the padded neck collar in FIG. 1.

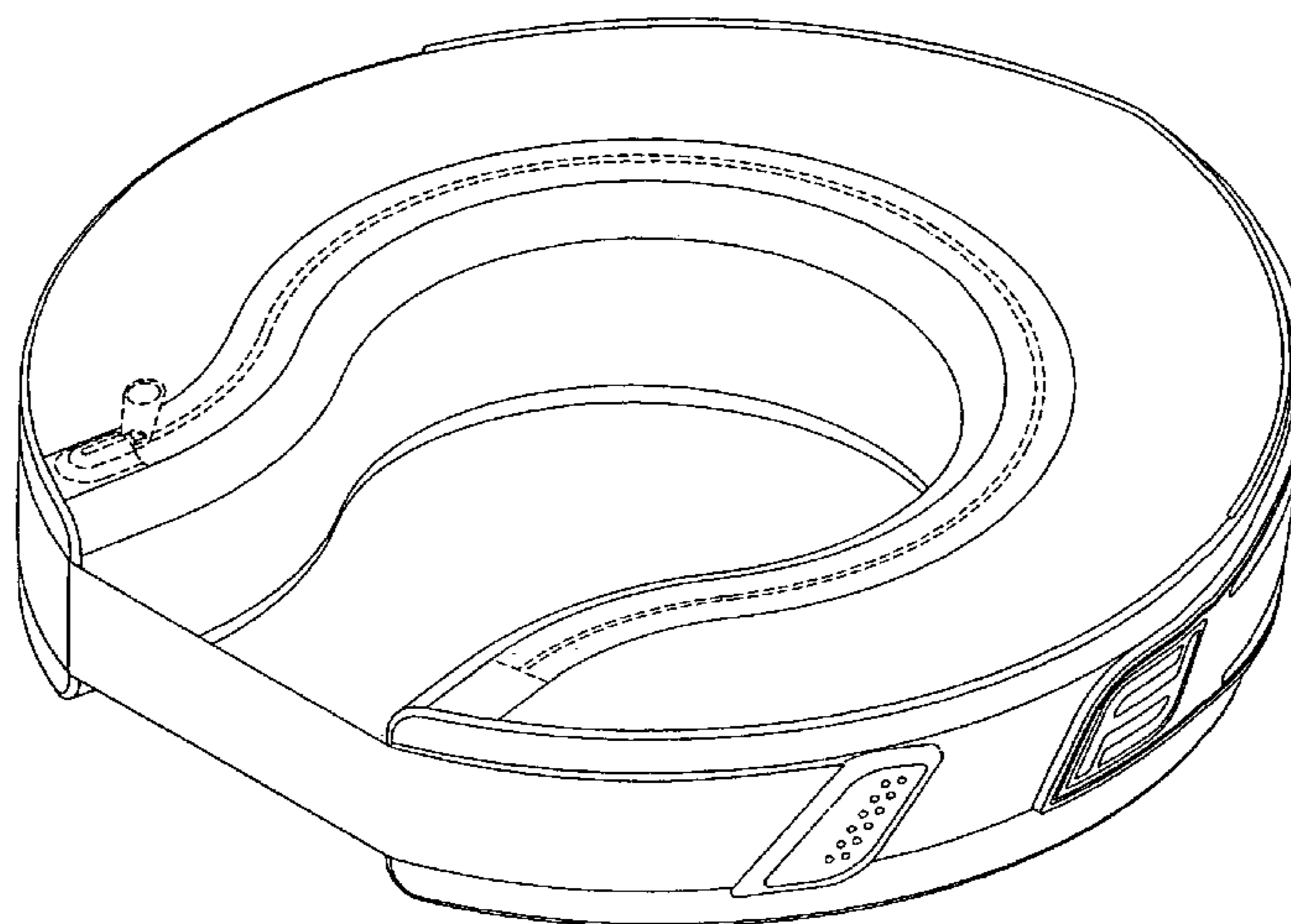
FIG. 6 is a front elevational view of the padded neck collar in FIG. 1.

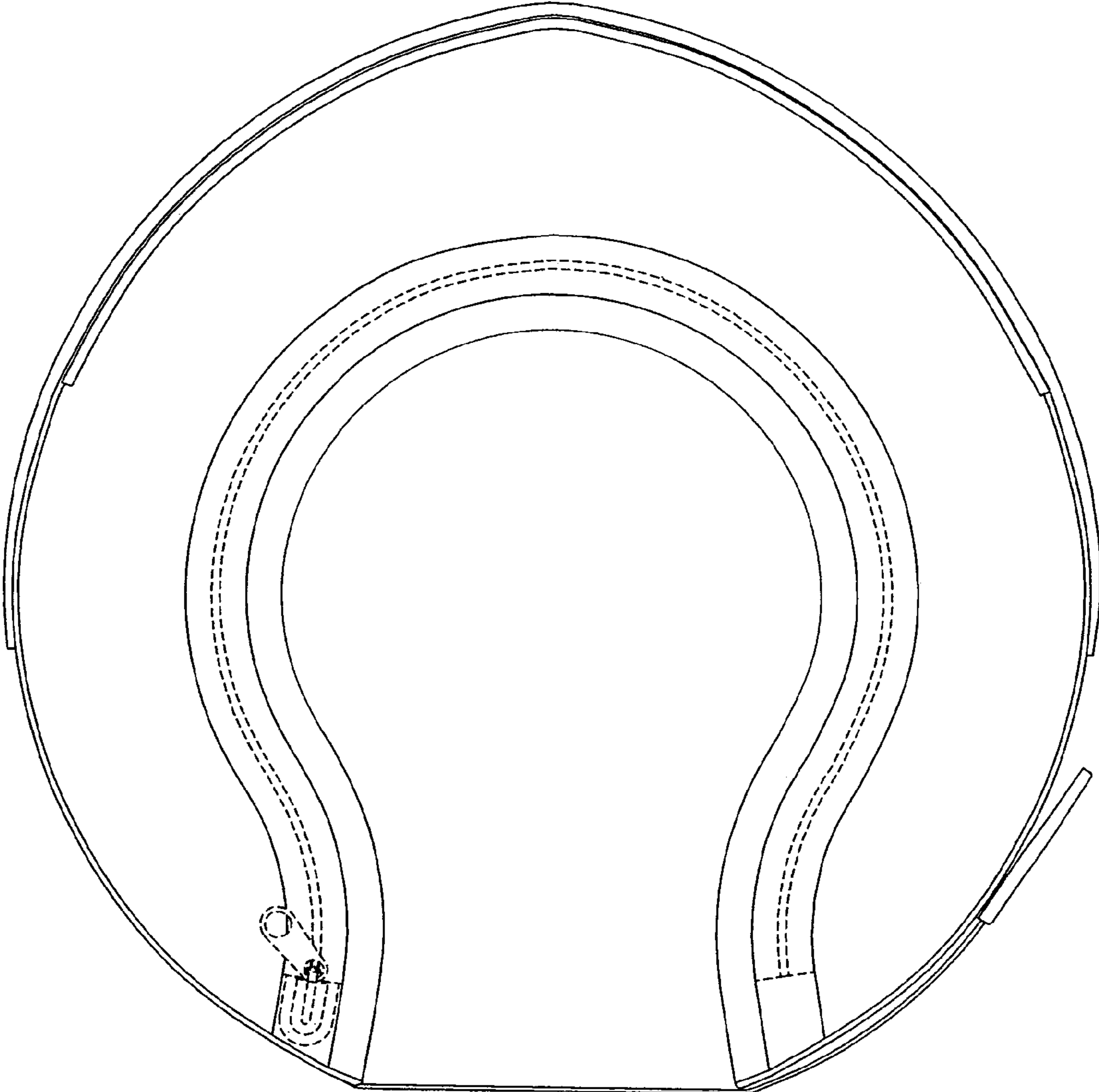

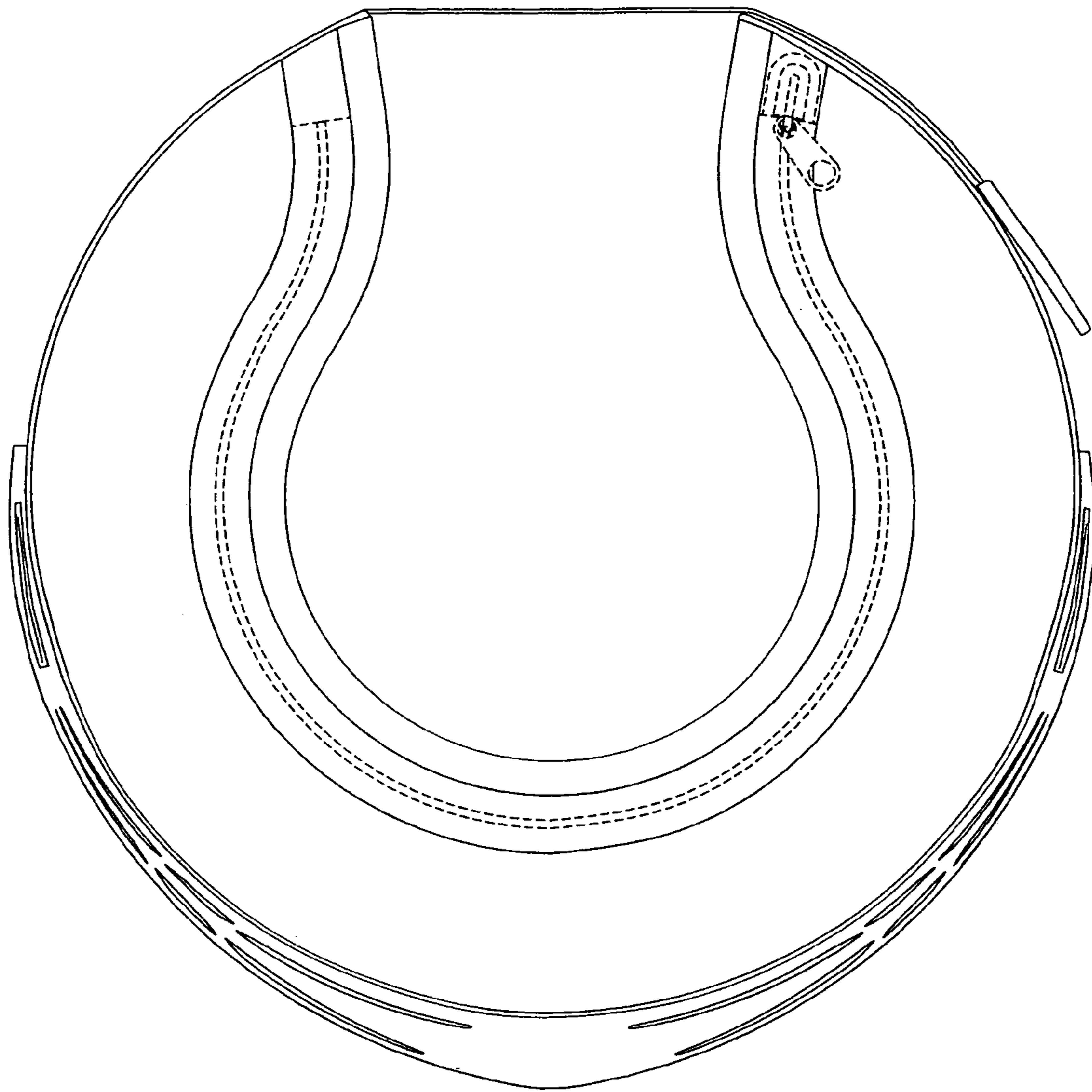

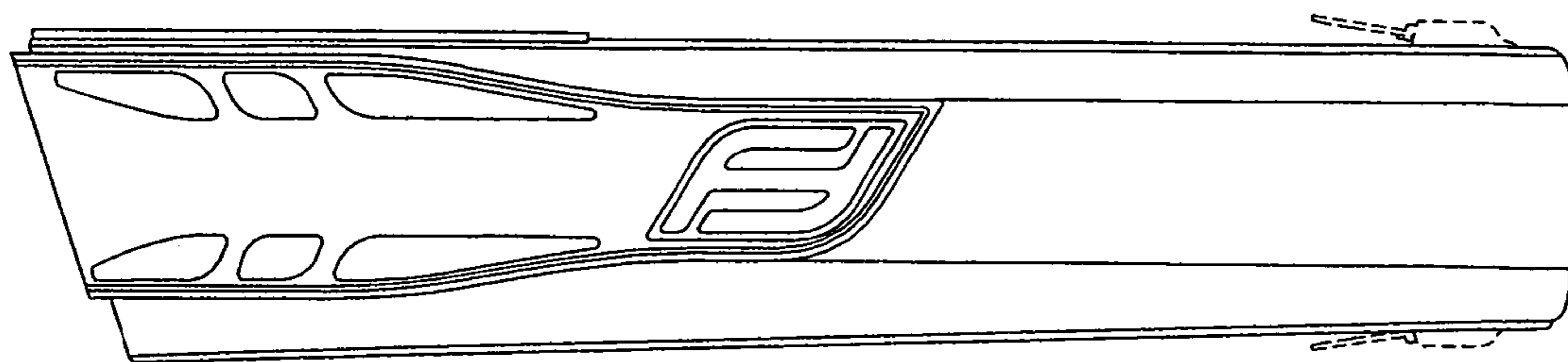

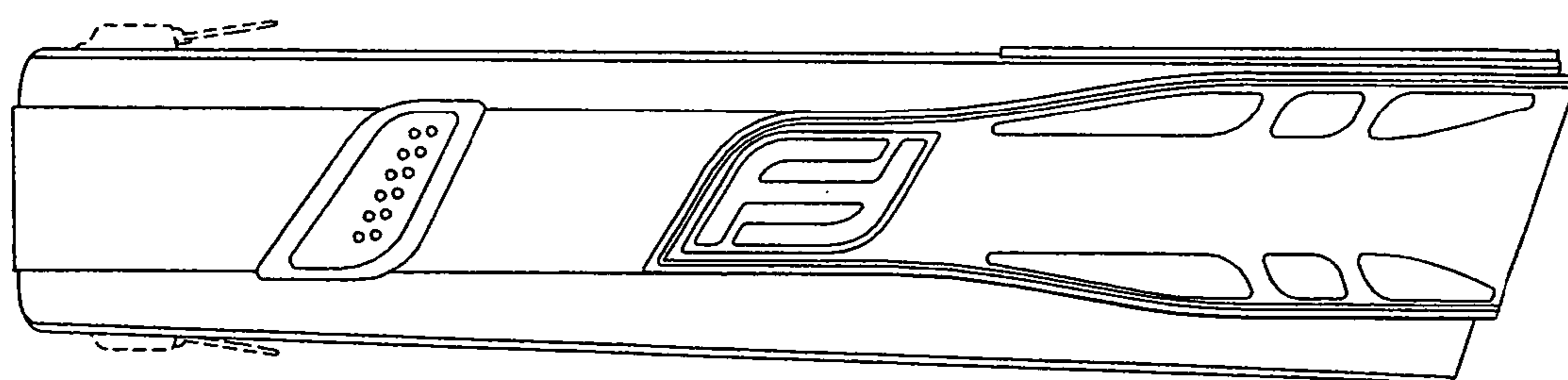

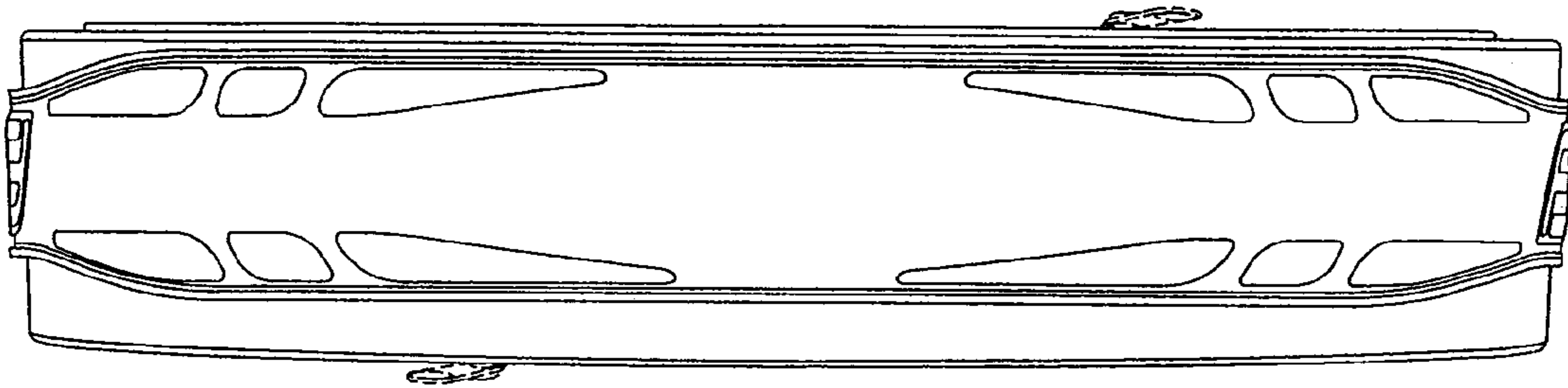

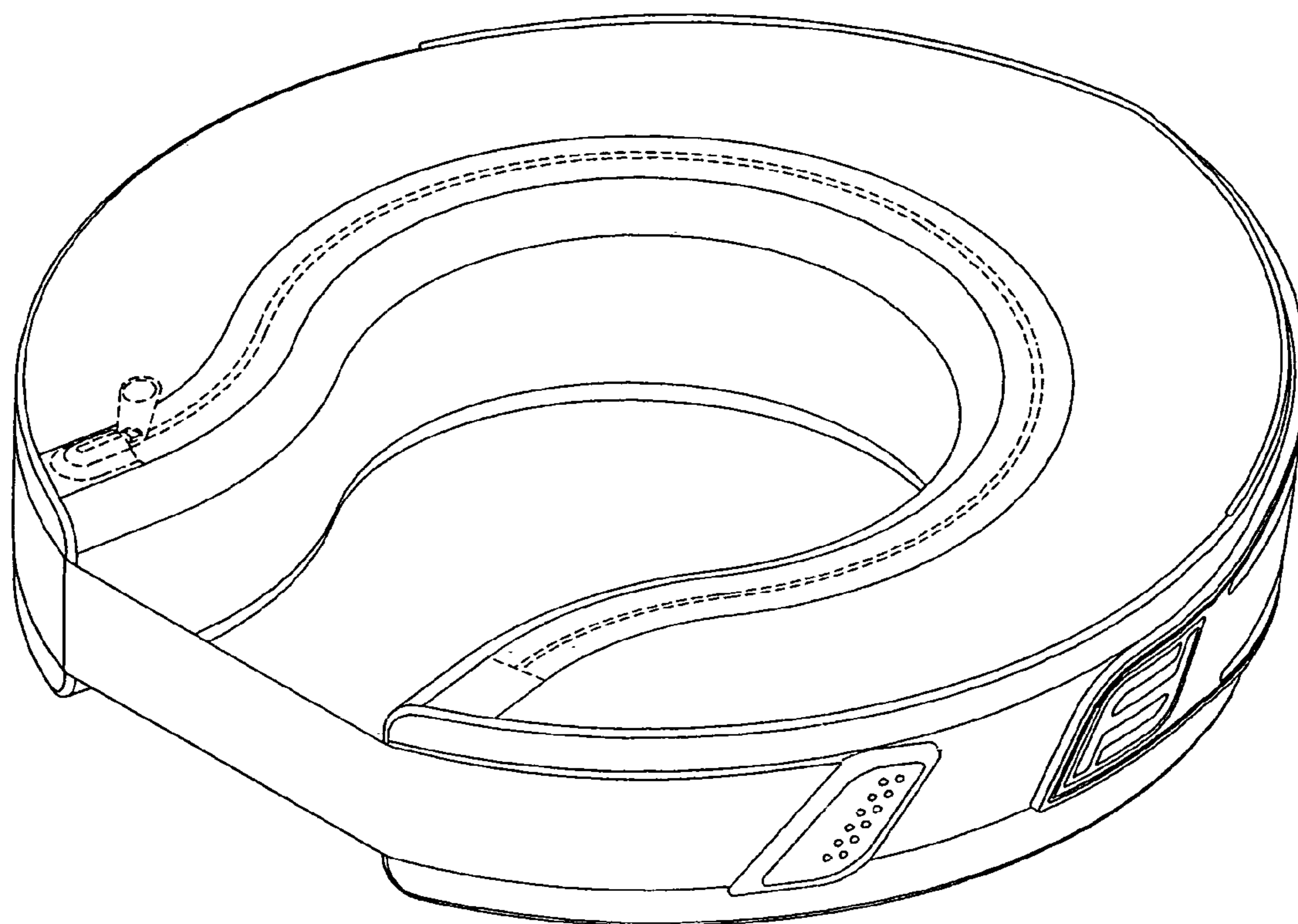

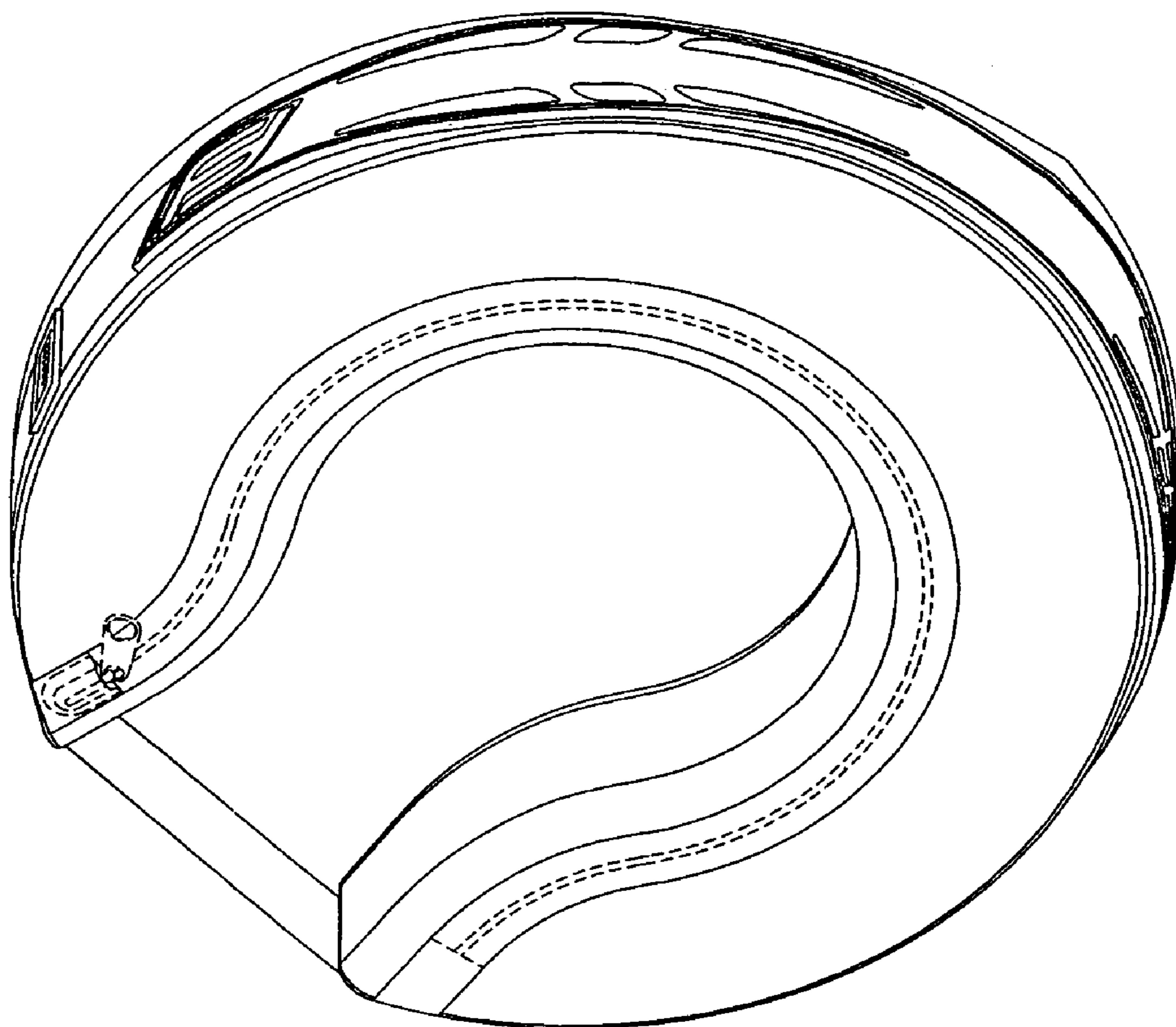
