FIG. 2 is a top view of the cat scratch box;

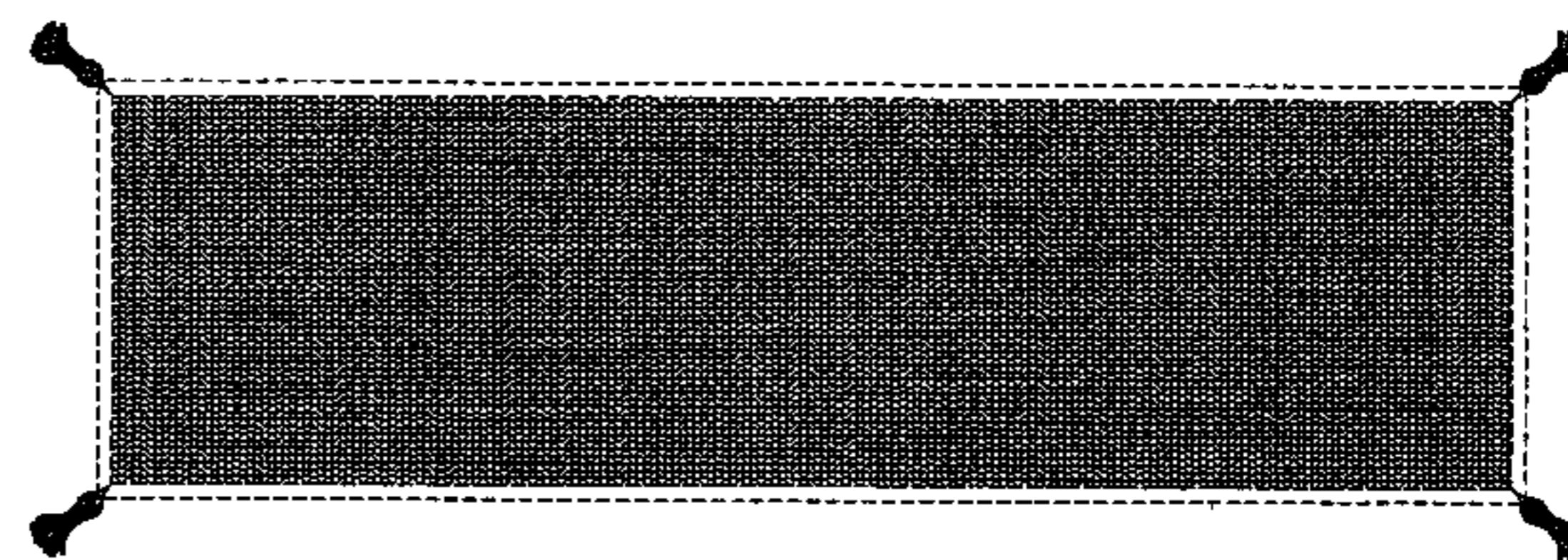
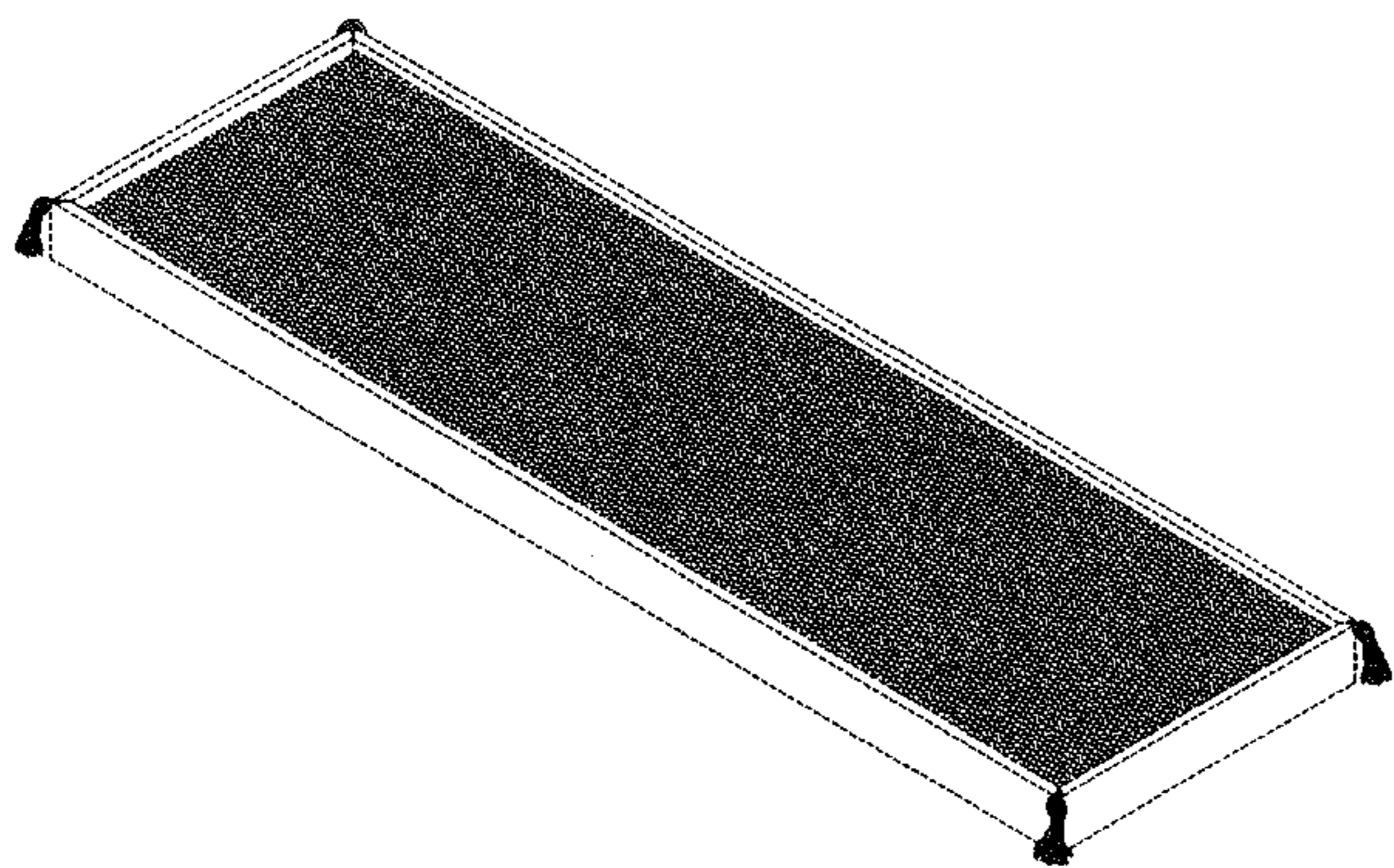
FIG. 3 is a right side view of the cat scratch box, the left side view being a mirror image;

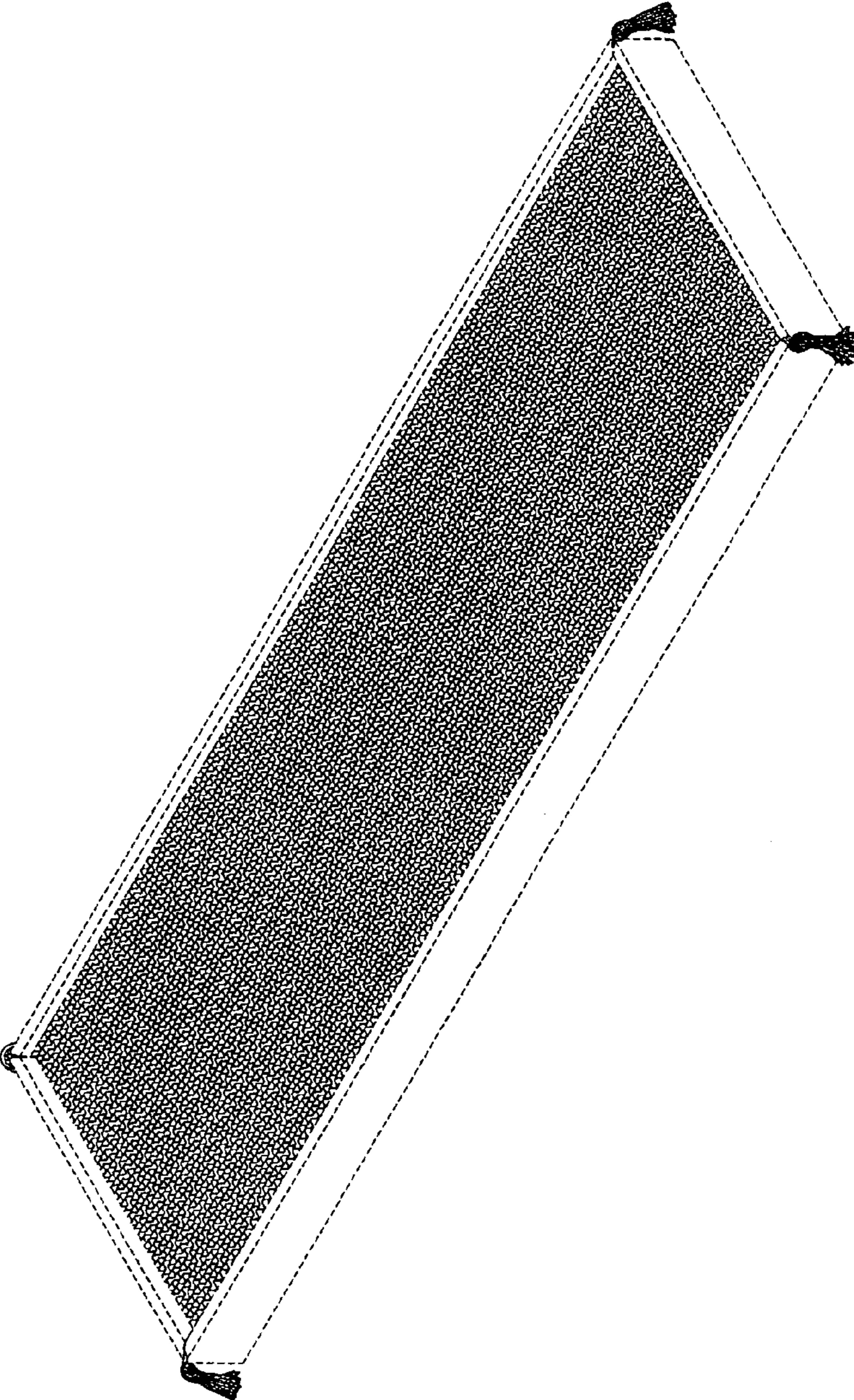
FIG. 4 is a front view of the cat scratch box, the rear view being a mirror image; and,

In the drawings, the broken line showing of a box depicts environmental subject matter and forms no part of the claim.

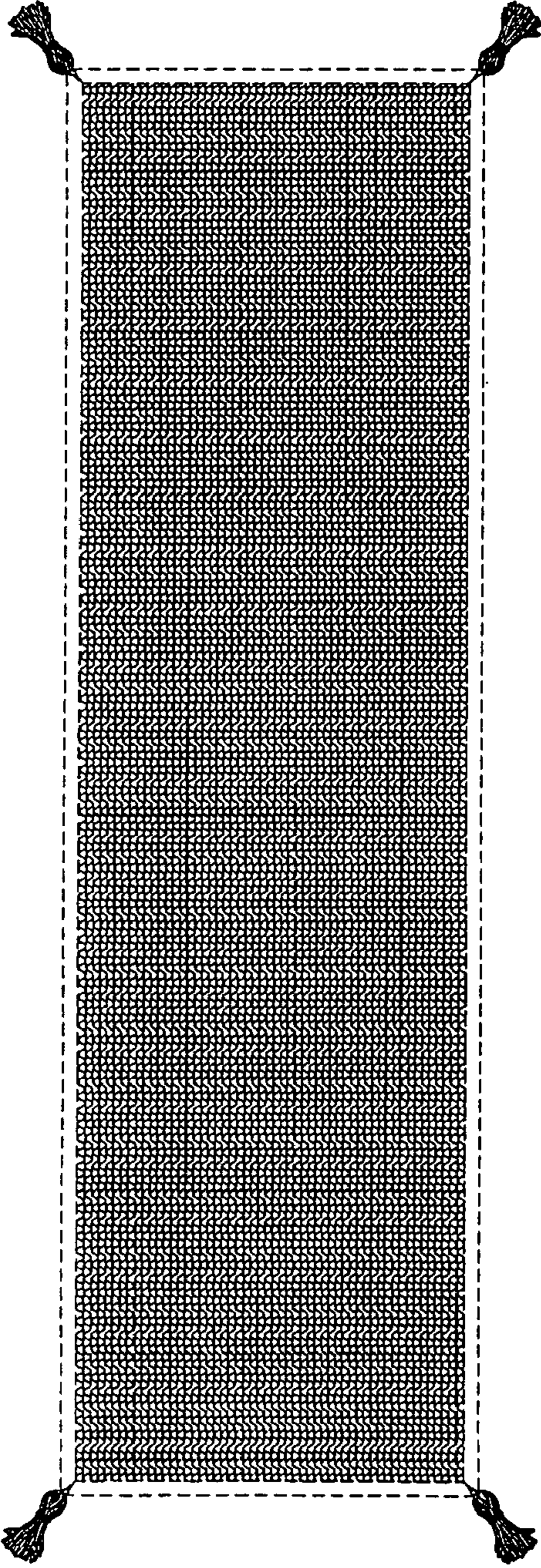

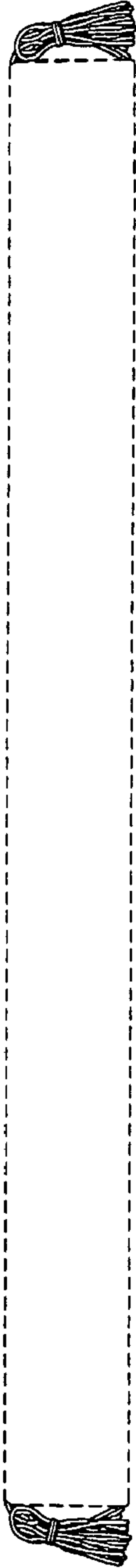

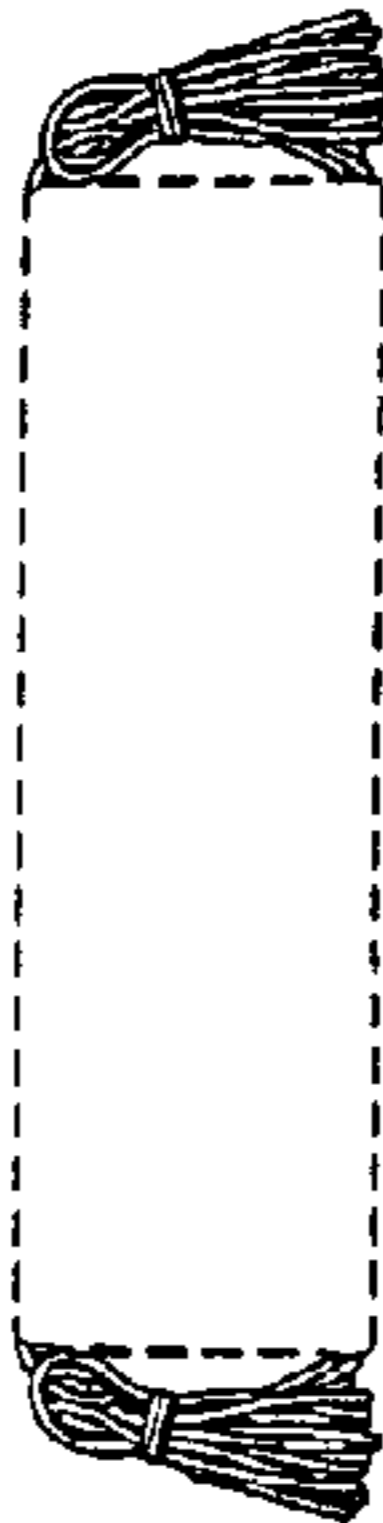
