FIG. 3 is an elevation view from the rear.

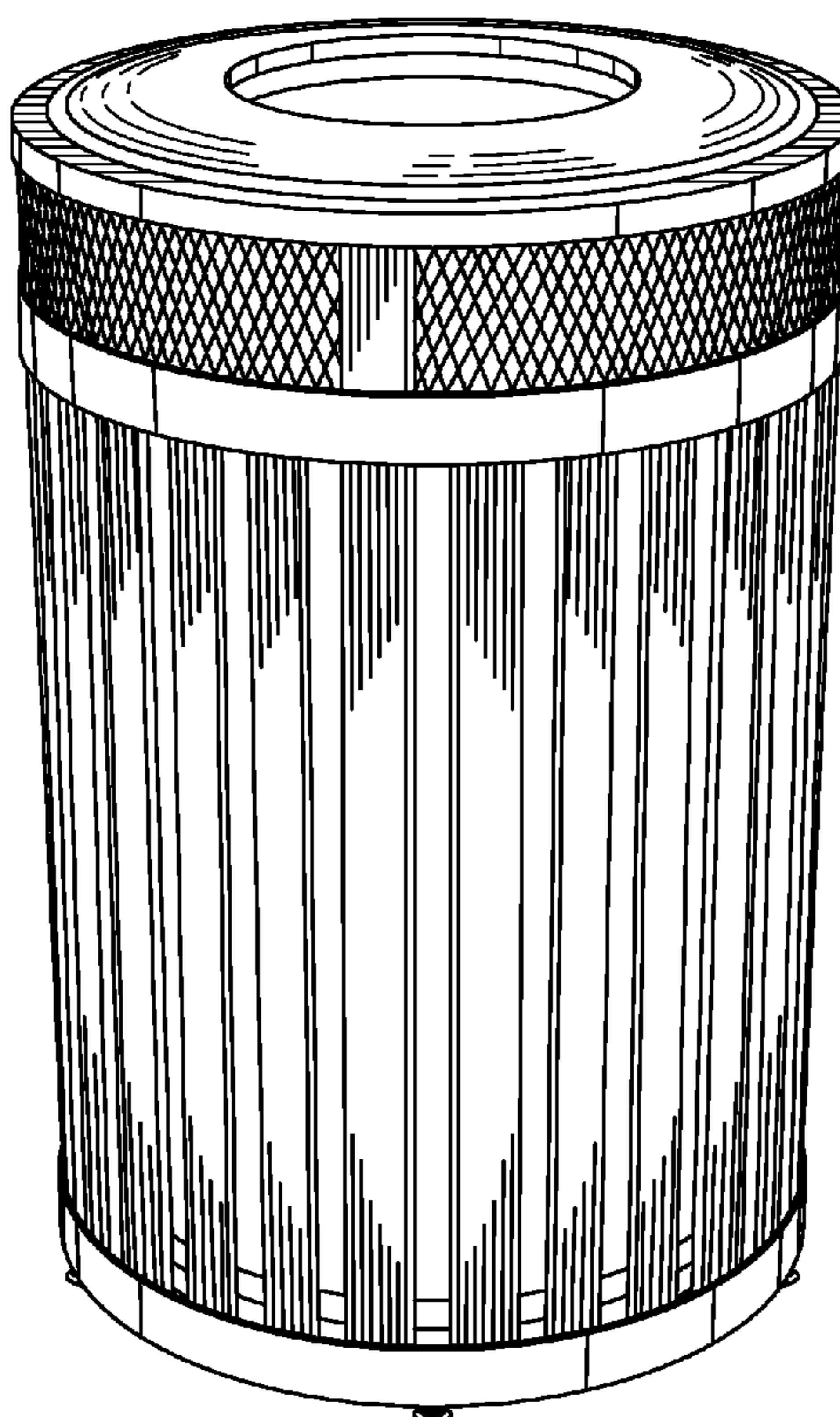
FIG. 4 is an elevation view from the left side in FIG. 2.

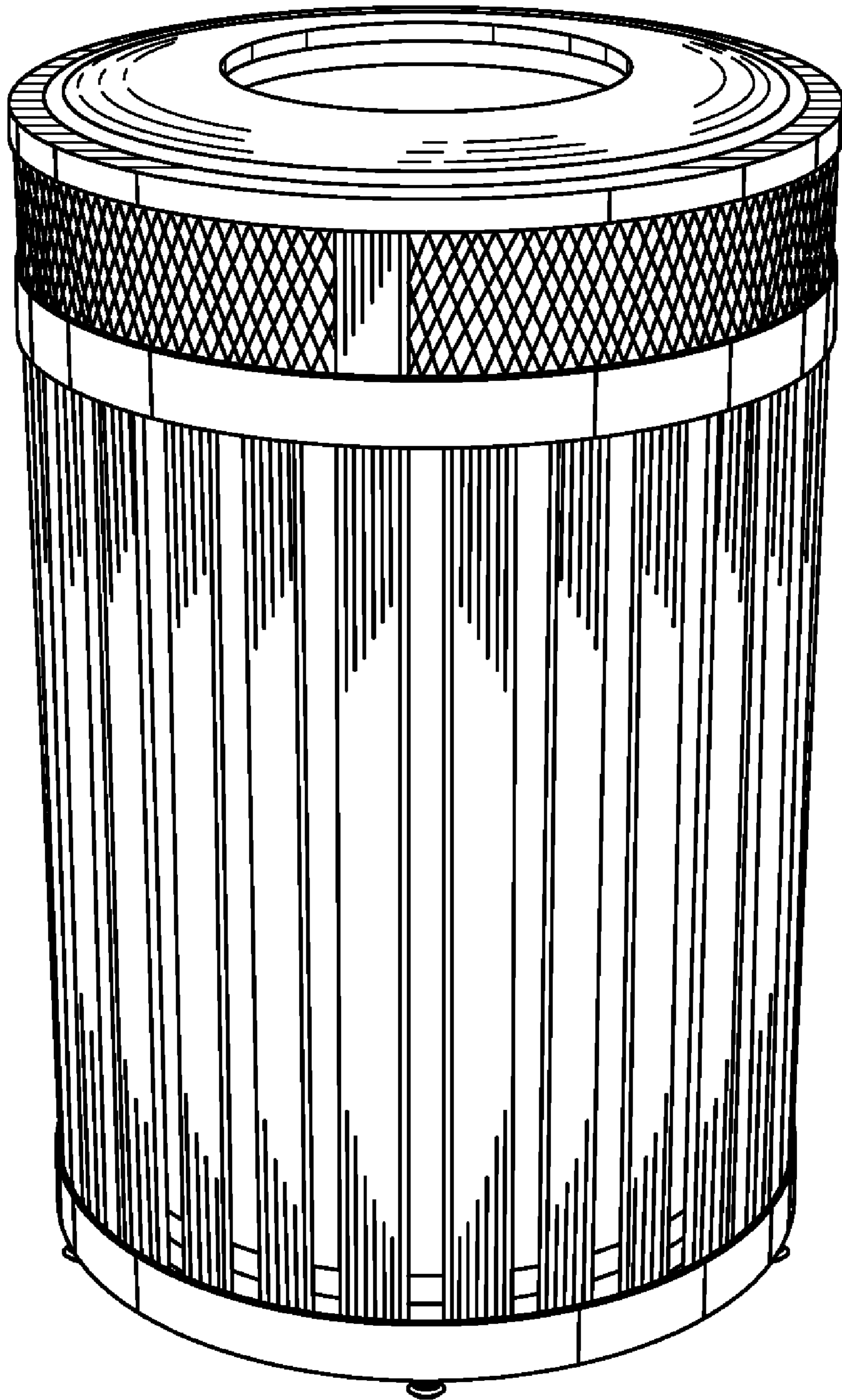

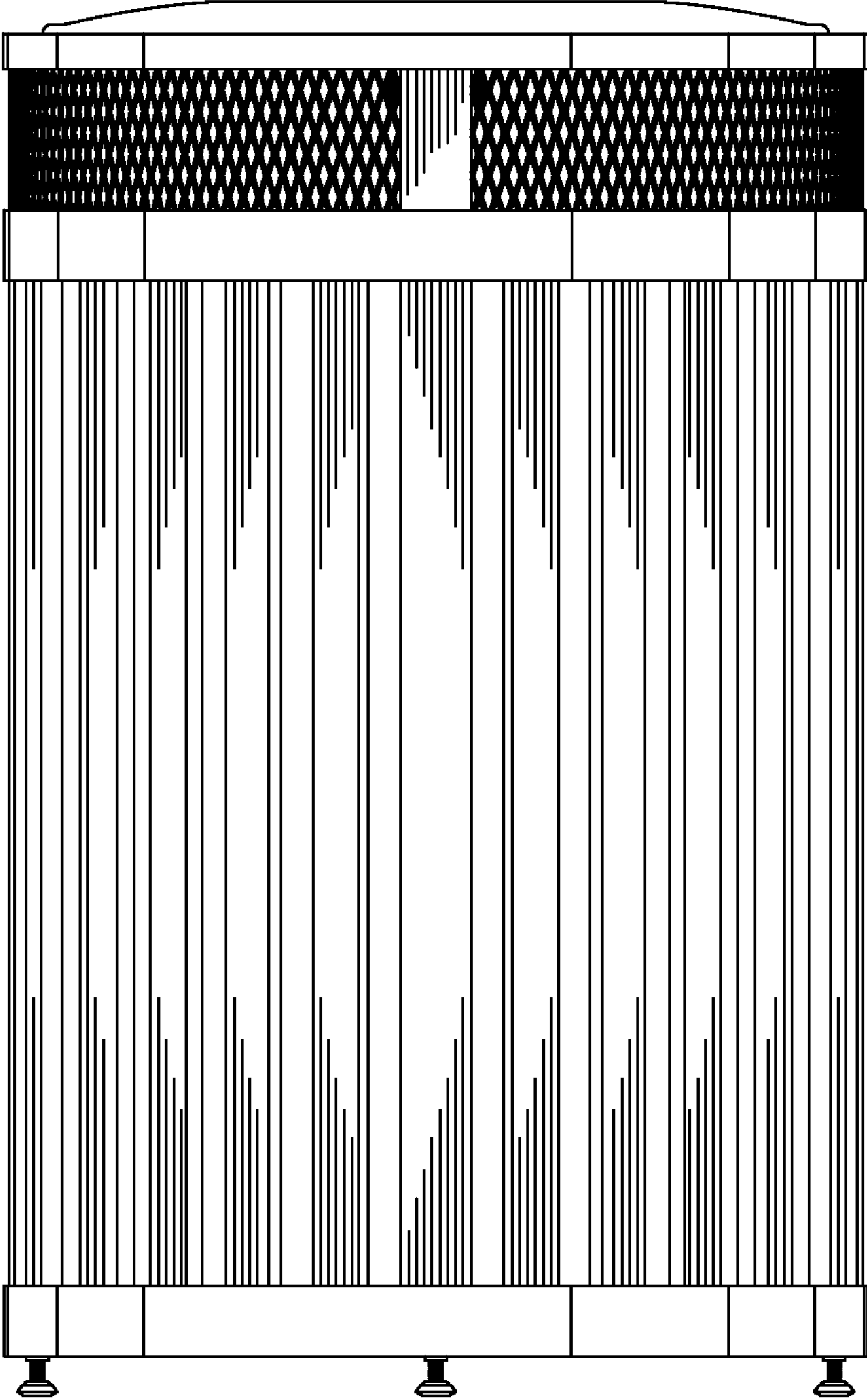

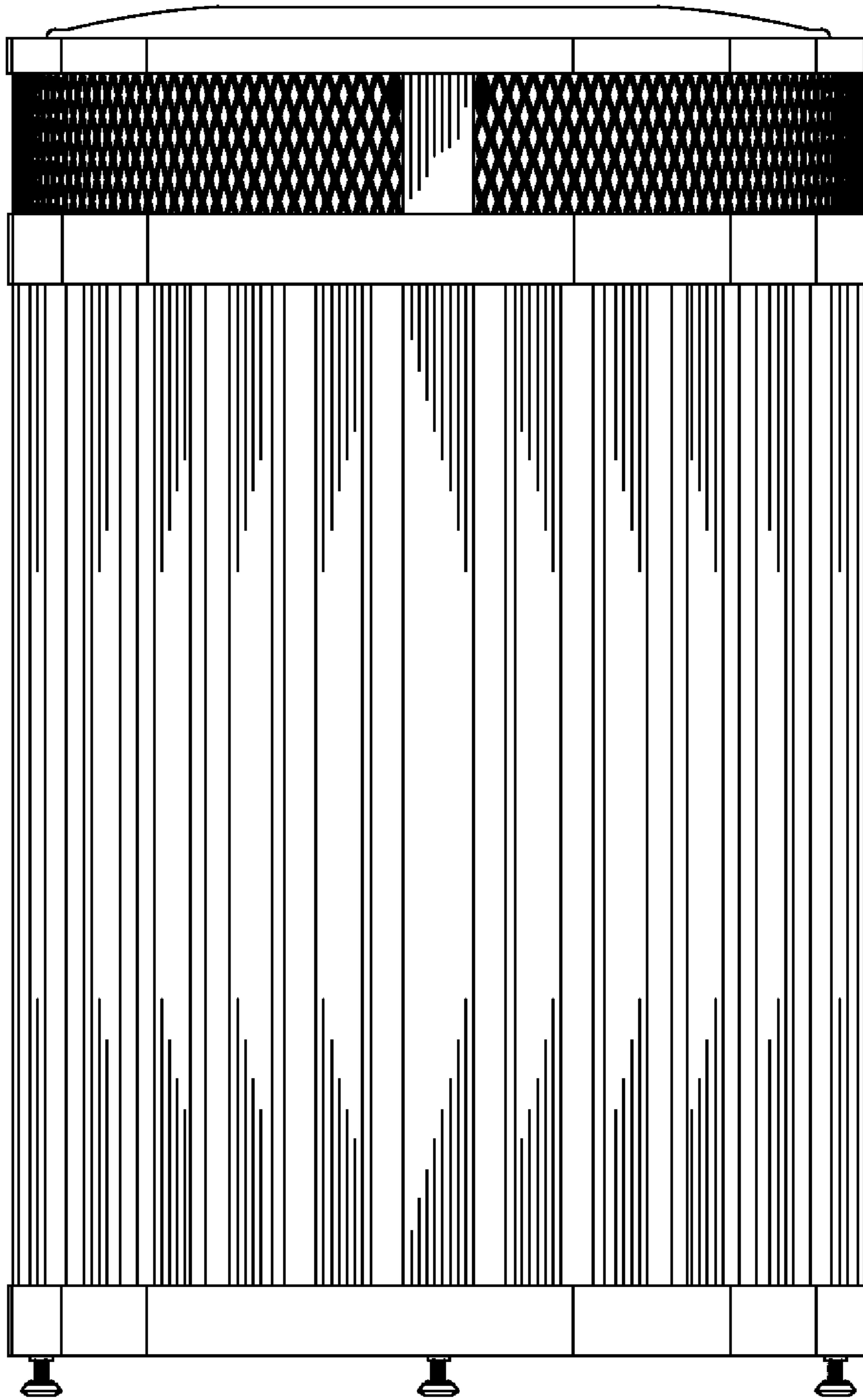

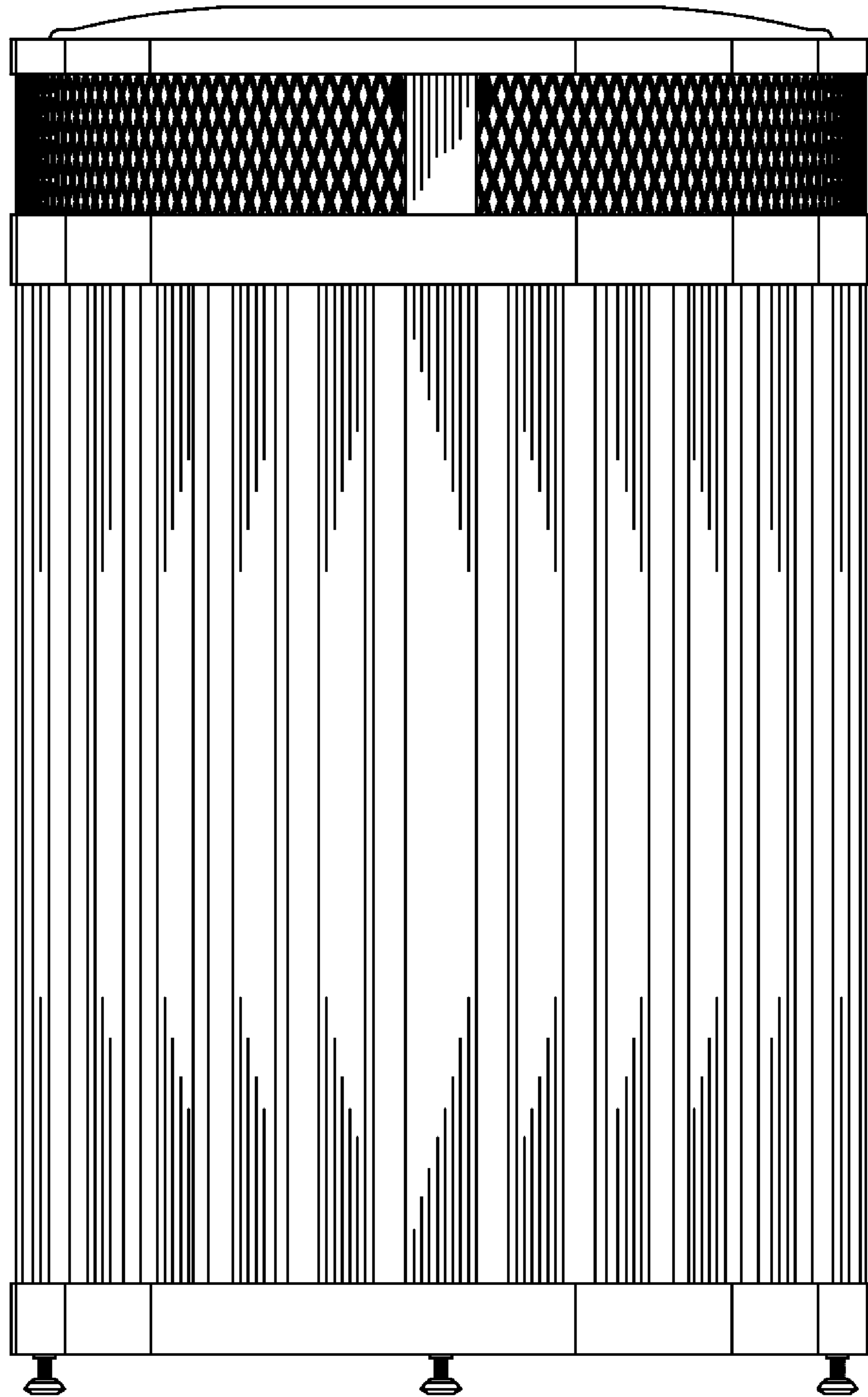

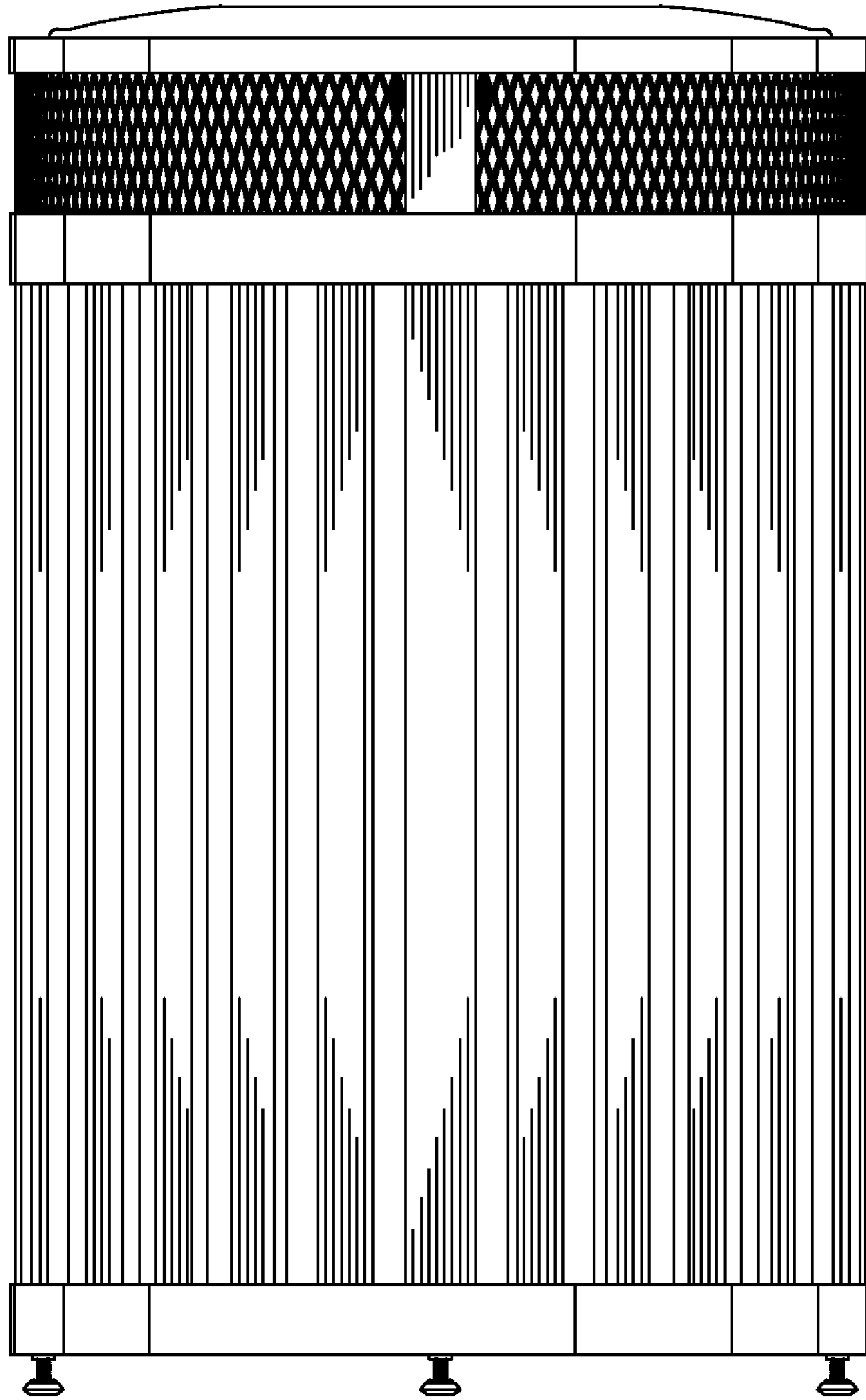

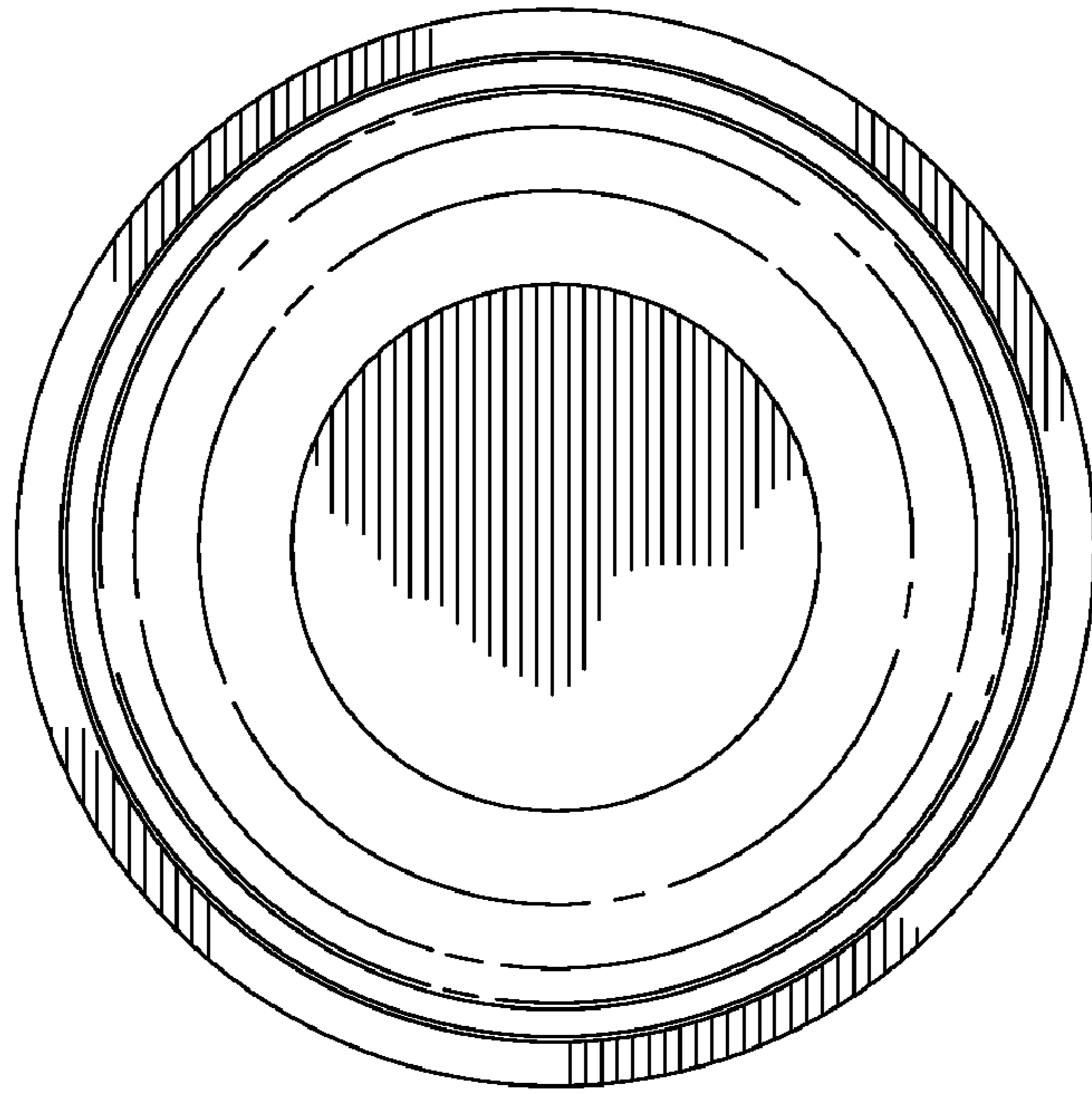

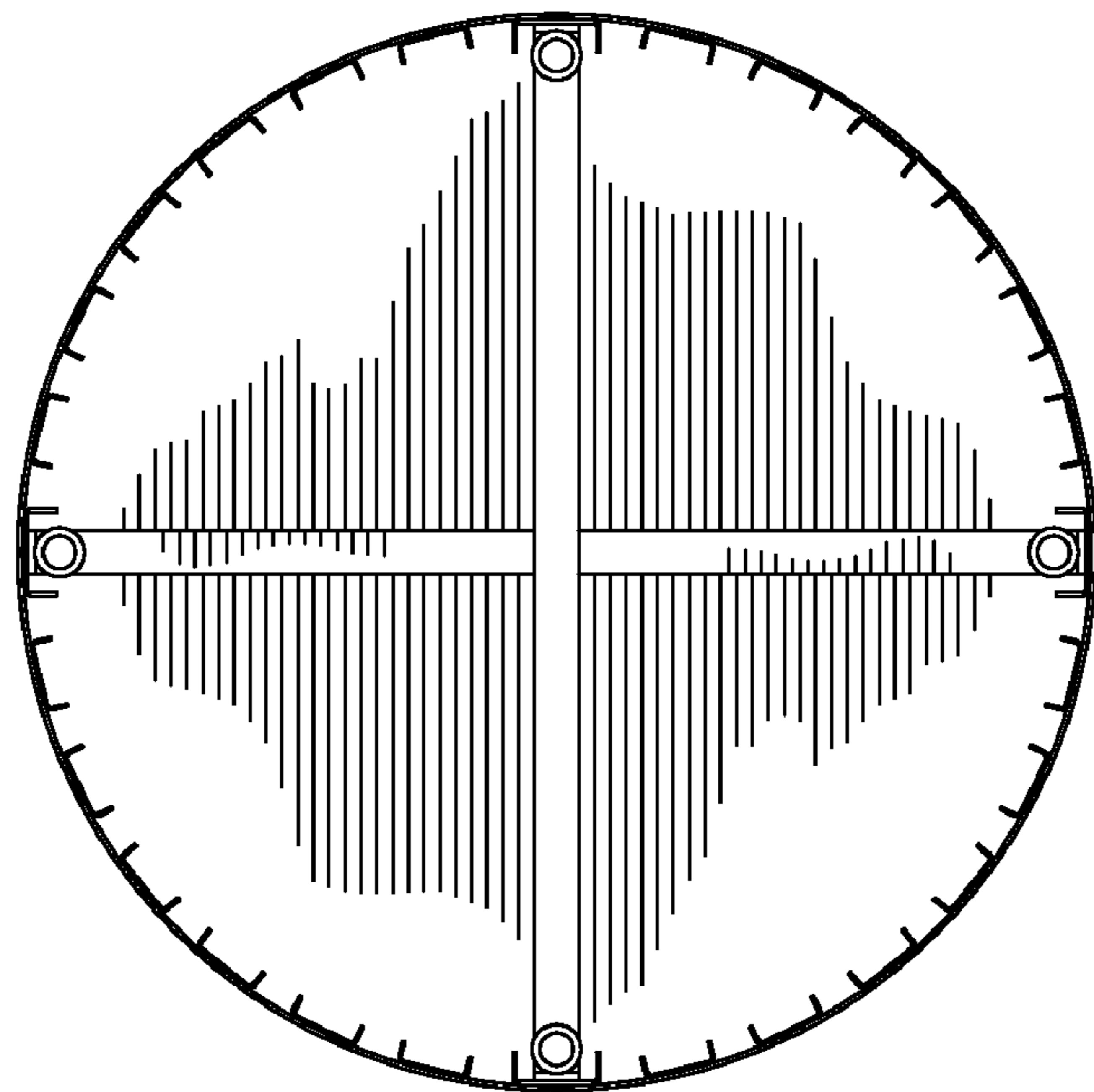
