(57) **CLAIM**

I claim the ornamental design for a plant watering and supporting device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the plant watering and supporting device according to the new design with the lid unattached.

FIG. 2 is a top view of the combined plant support and waterer according to the new design.

FIG. 3 is a side view of the combined plant support and waterer according to the new design.

FIG. 4 is a top perspective view of the combined plant support and waterer with the lid and the container assembled according to the new design.

FIG. 5 is a top perspective view of the container of the combined plant support and waterer according to the new design.

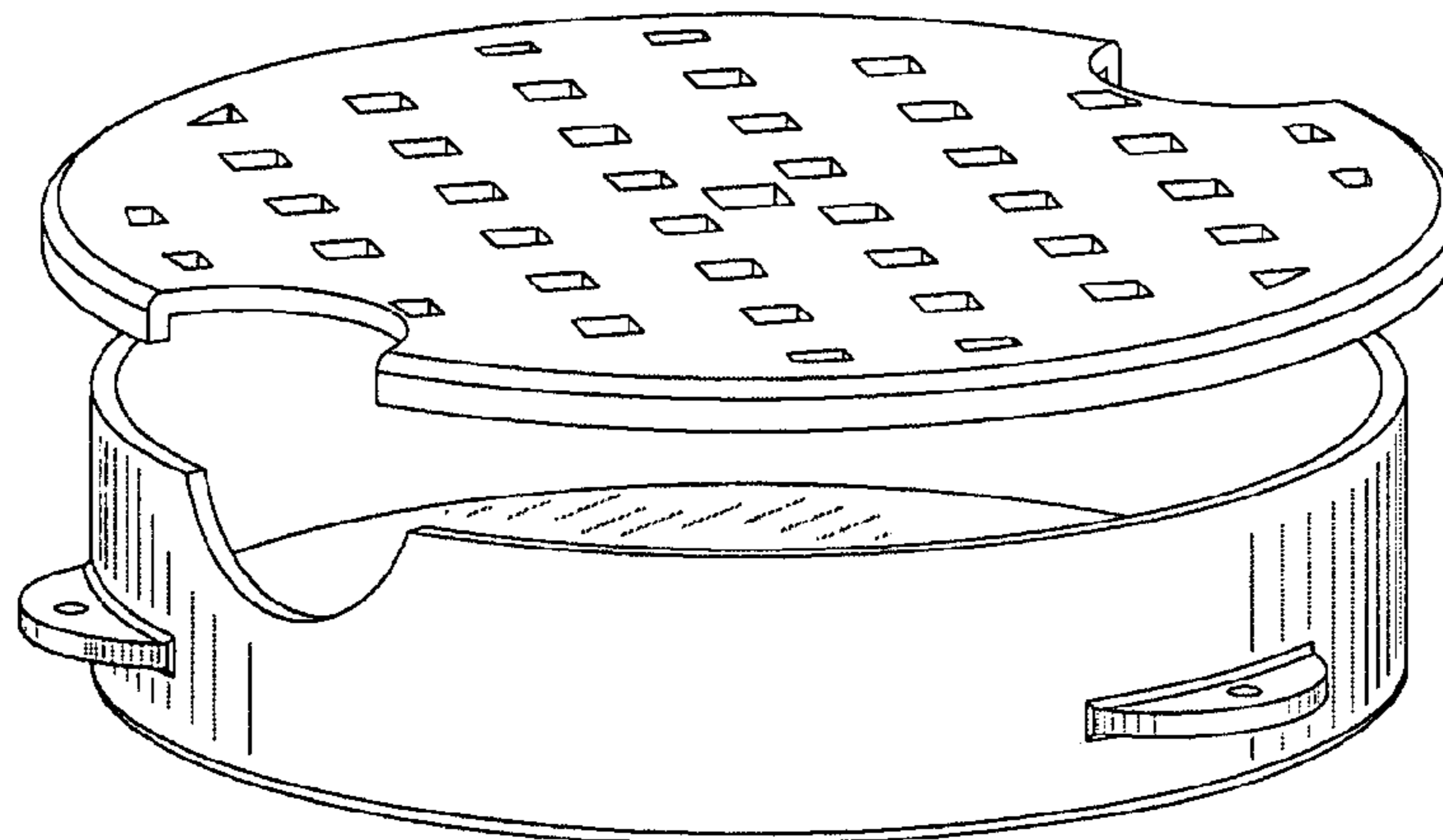
FIG. 6 is a top view of the container of the combined plant support and waterer according to the new design.

FIG. 7 is a top perspective view of the lid of the combined plant support and waterer according to the new design.

FIG. 8 is a bottom perspective view of the lid of the combined plant support and waterer according to the new design; and,

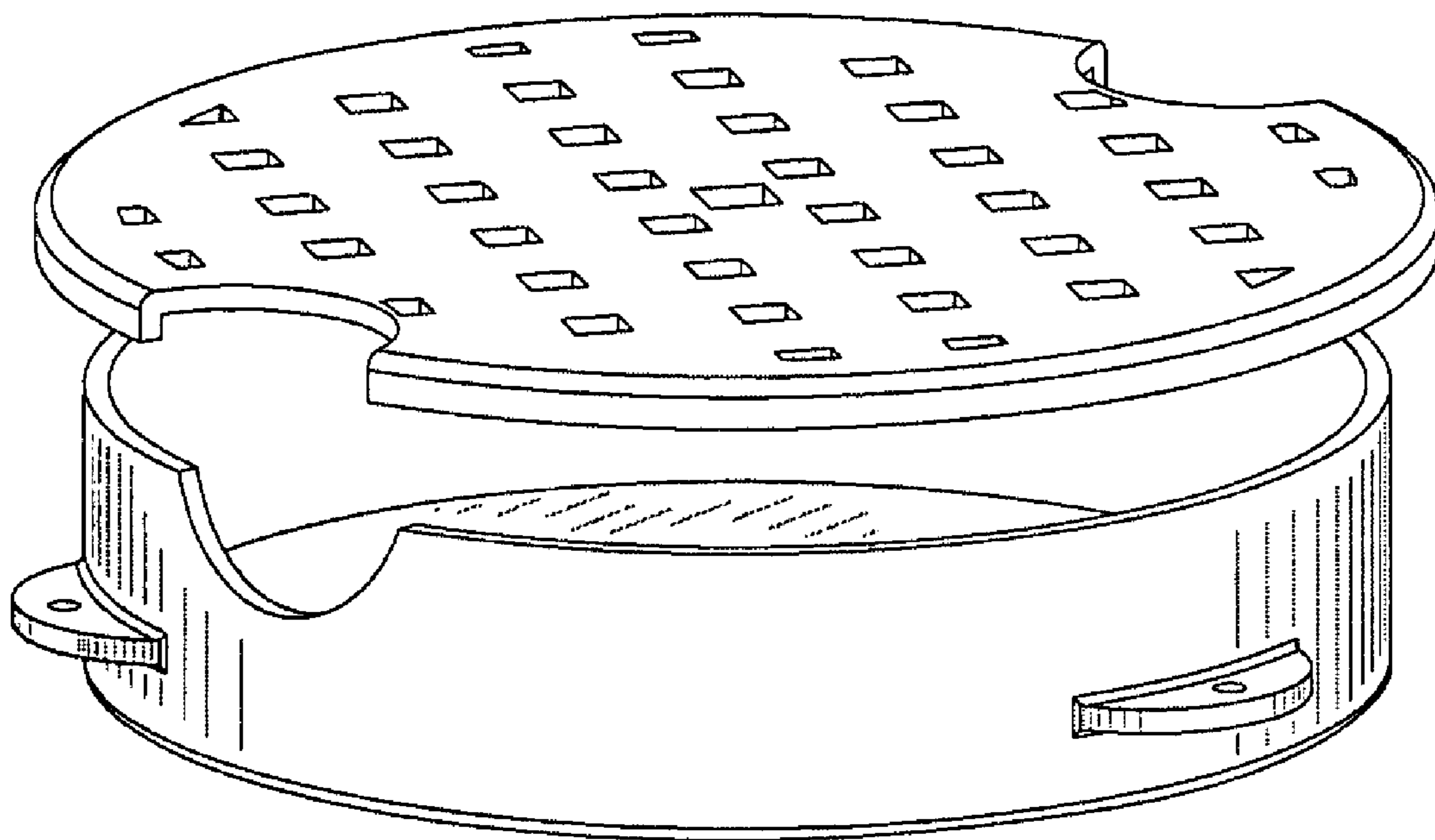

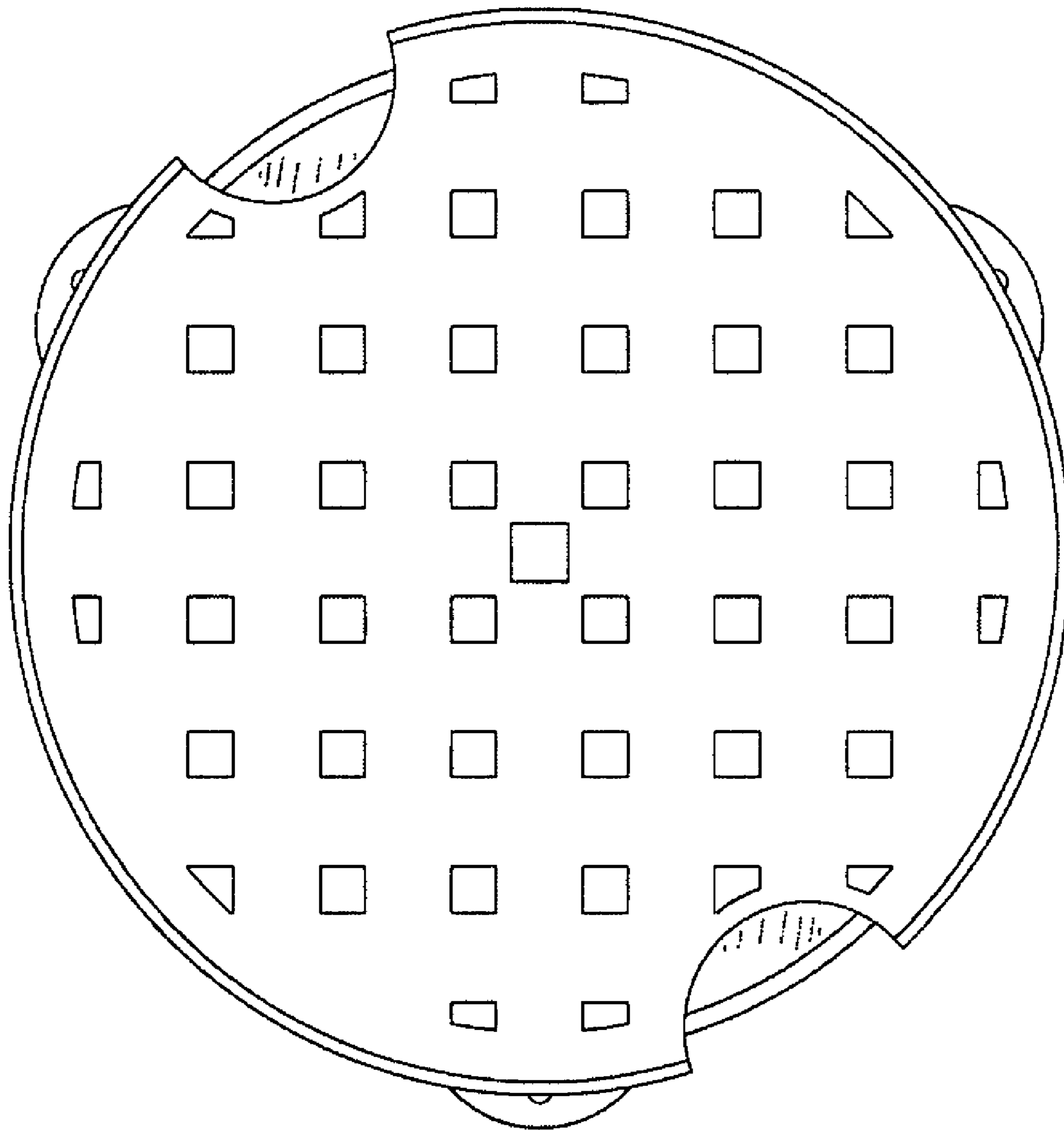

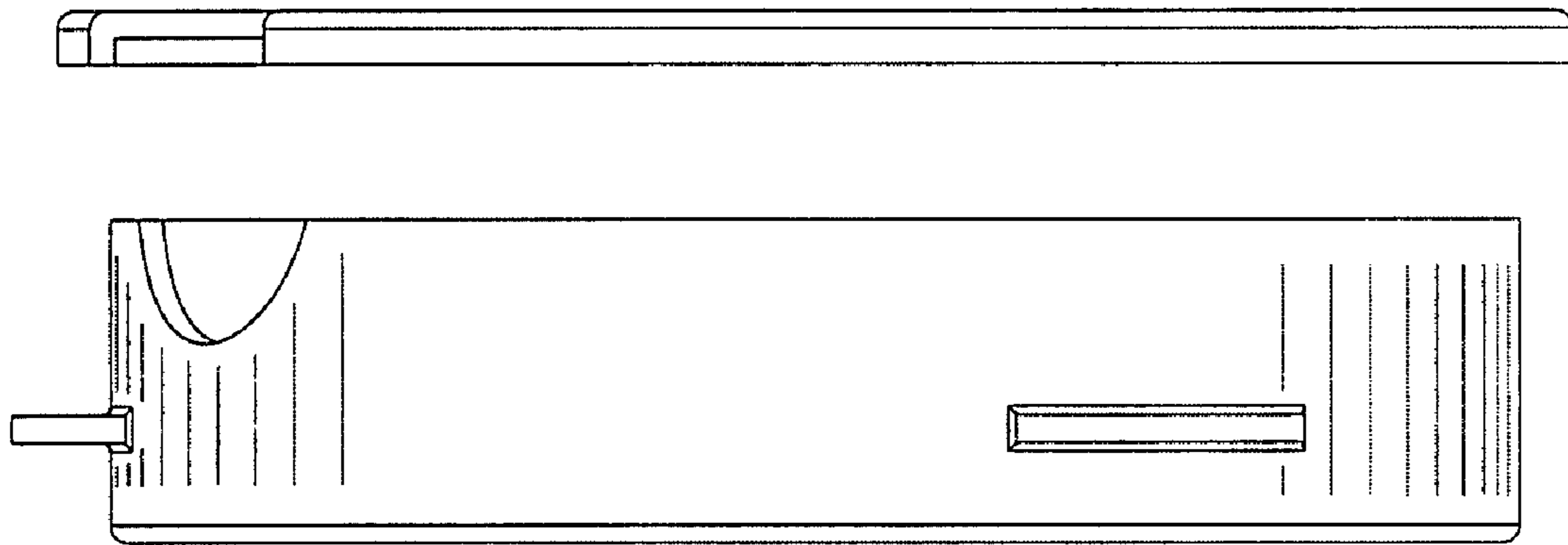

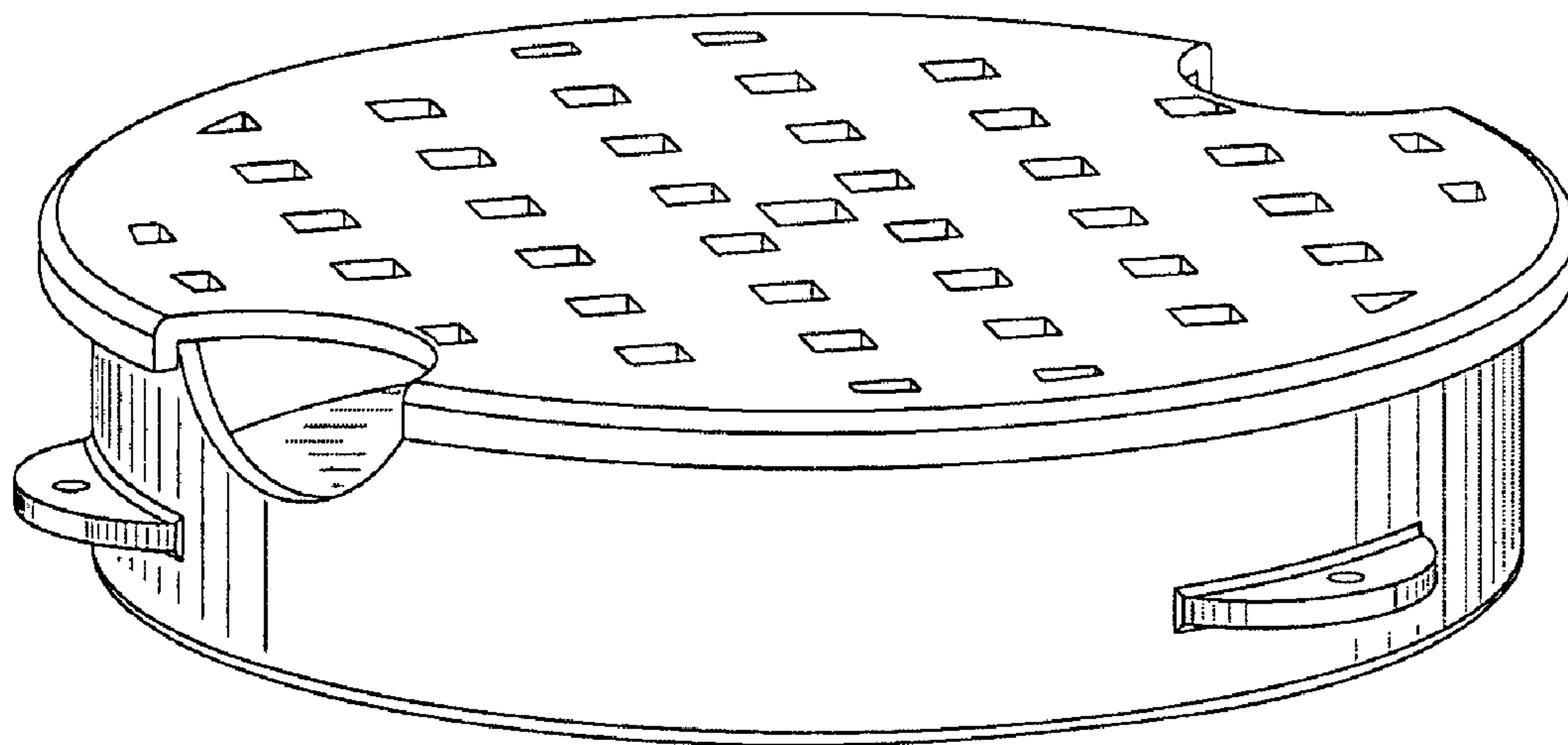

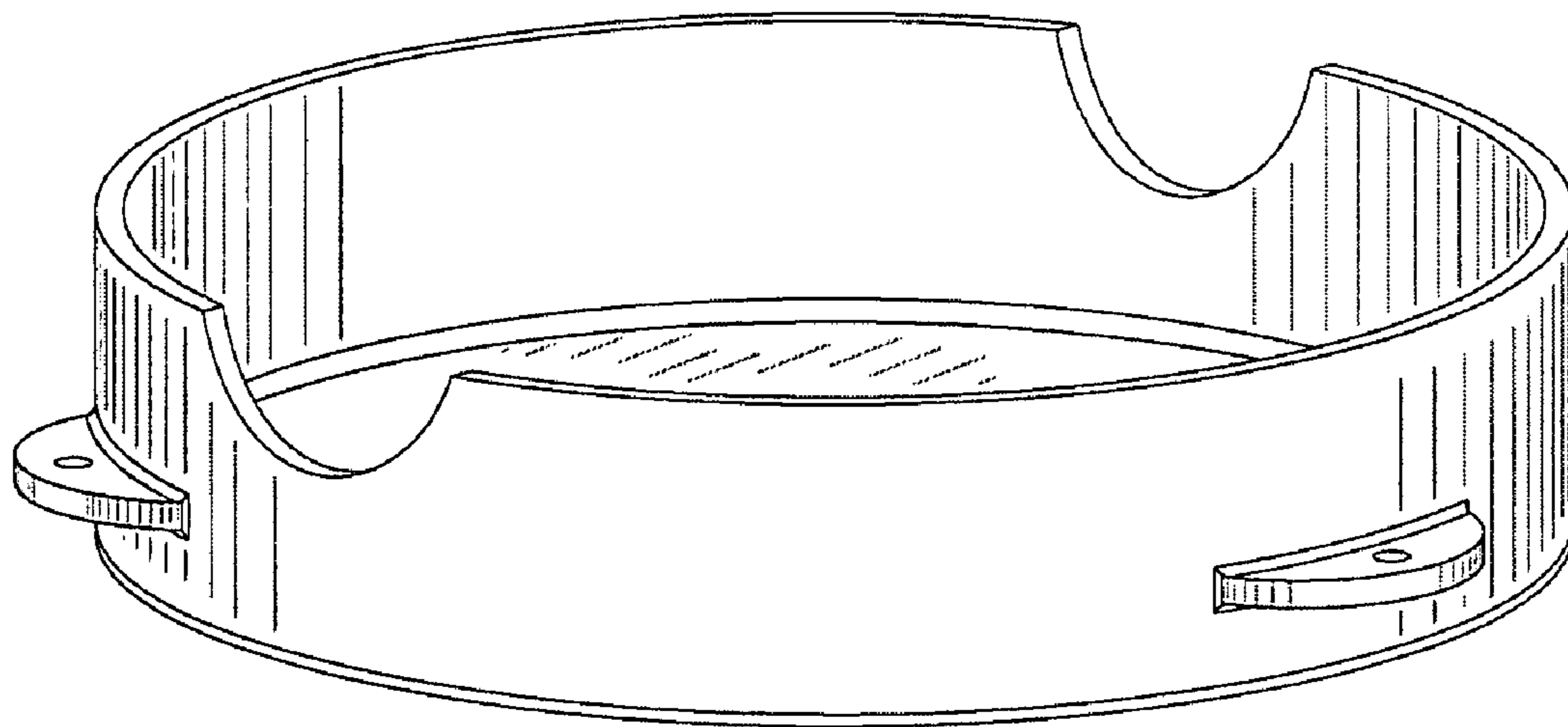

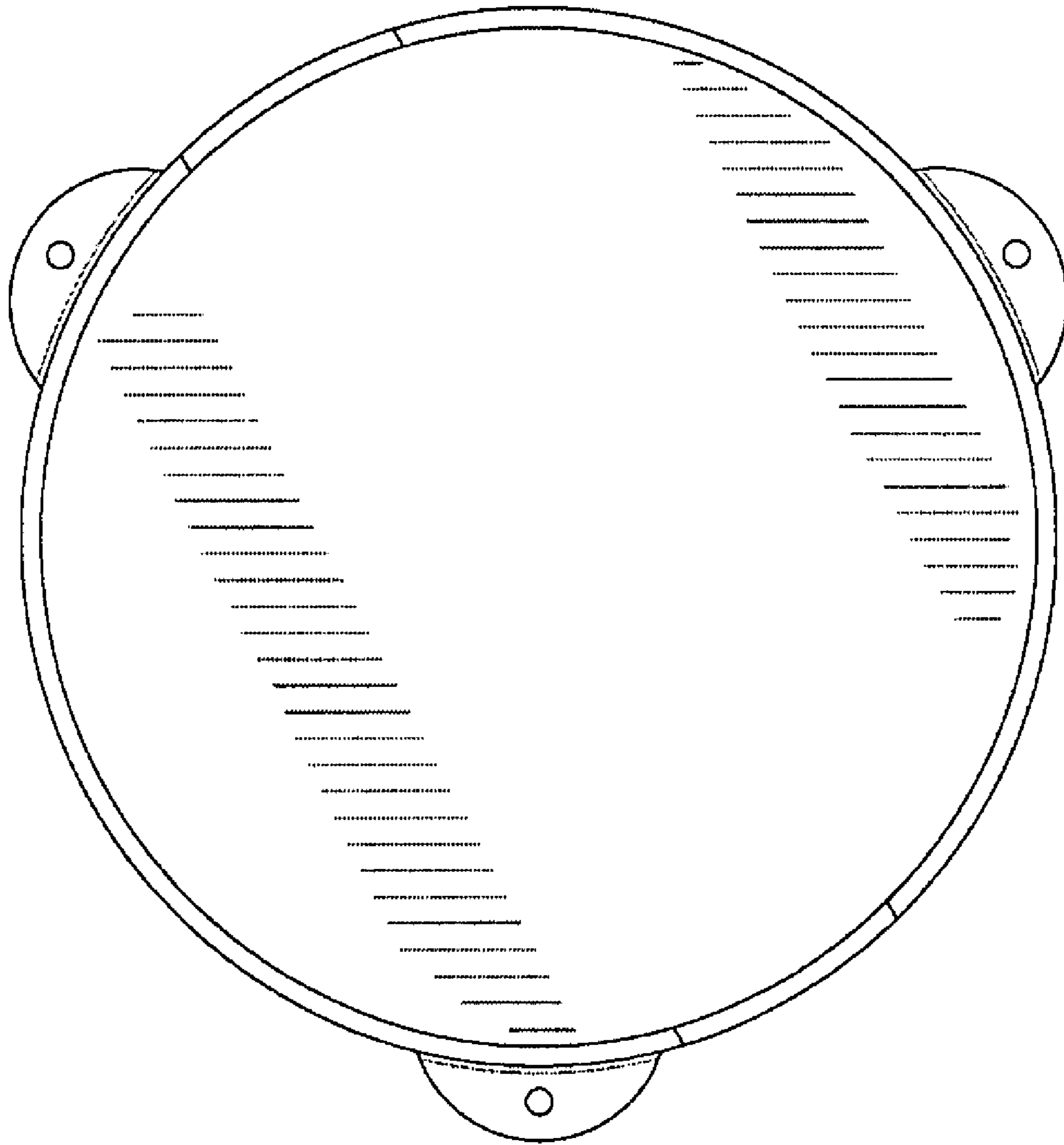

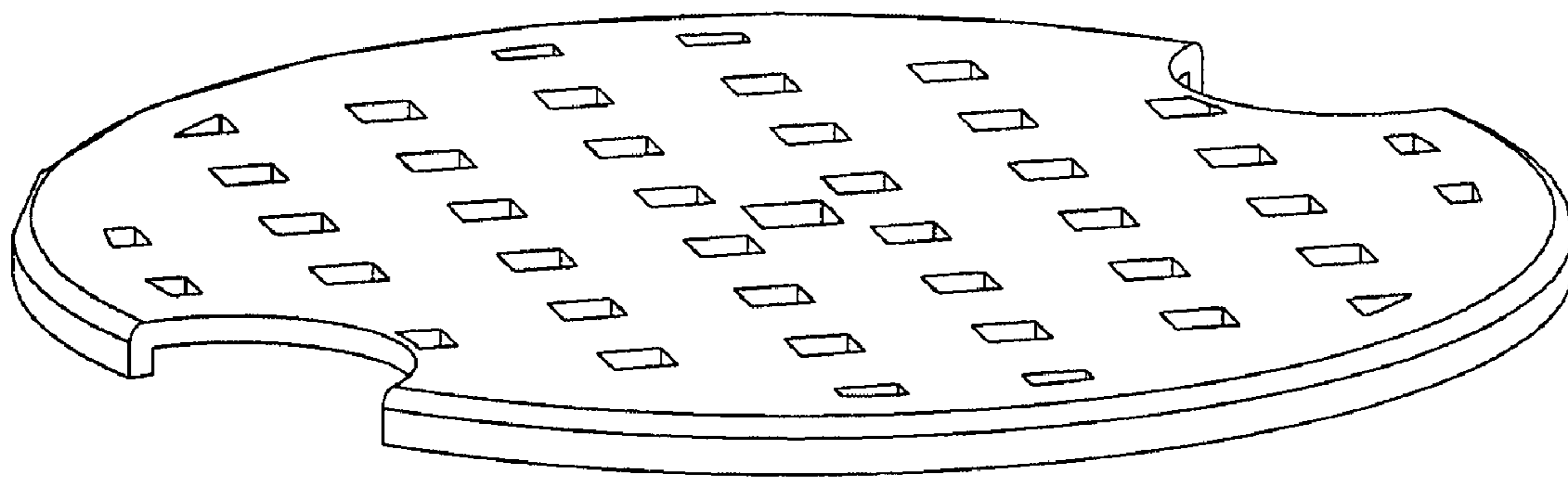

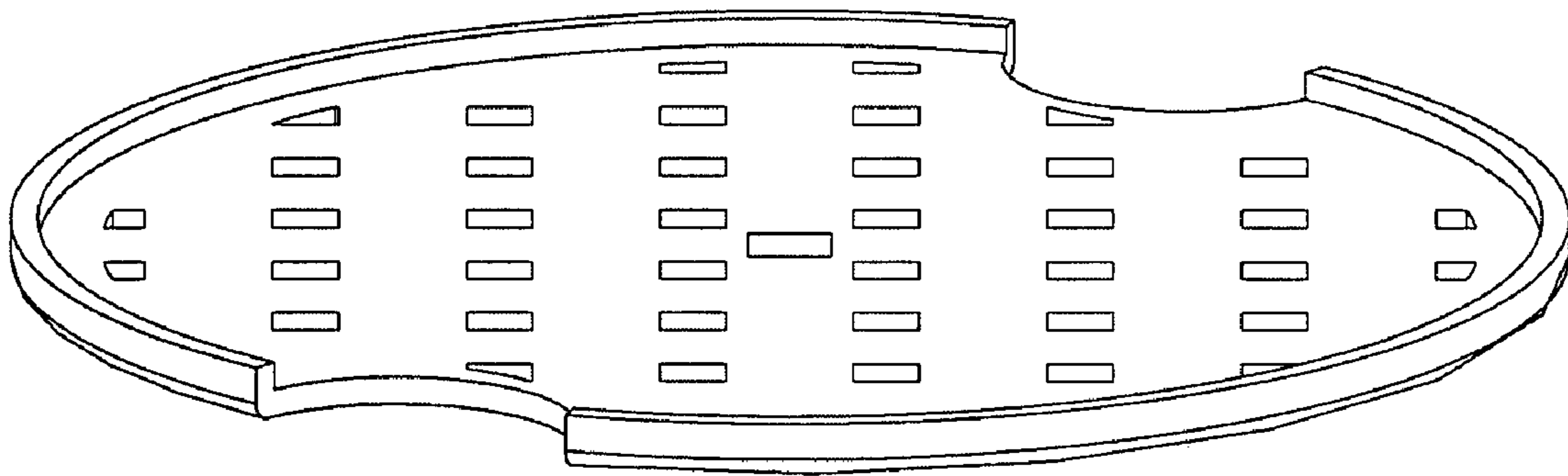

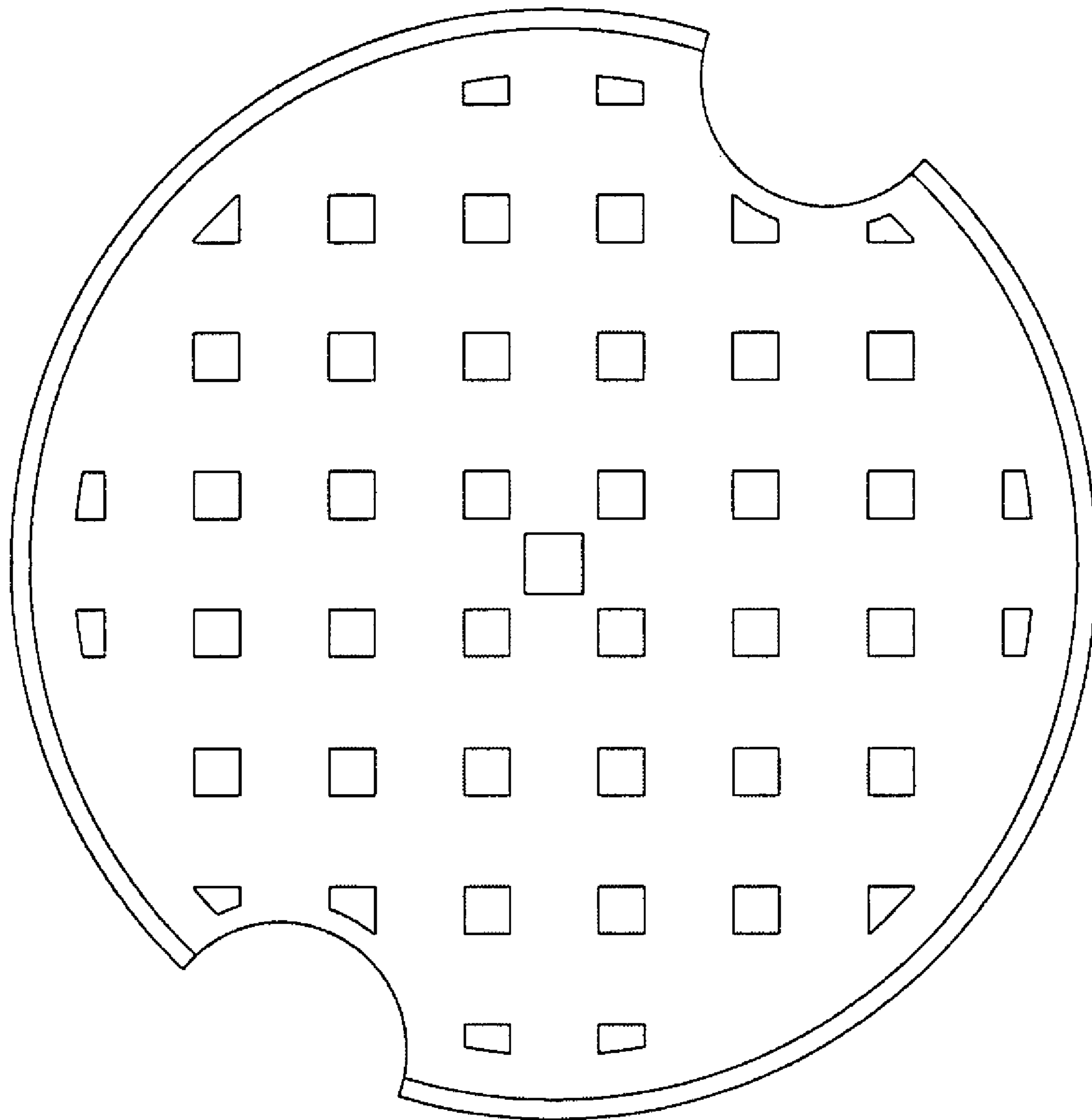
