FIG. 7 is a bottom view thereof;

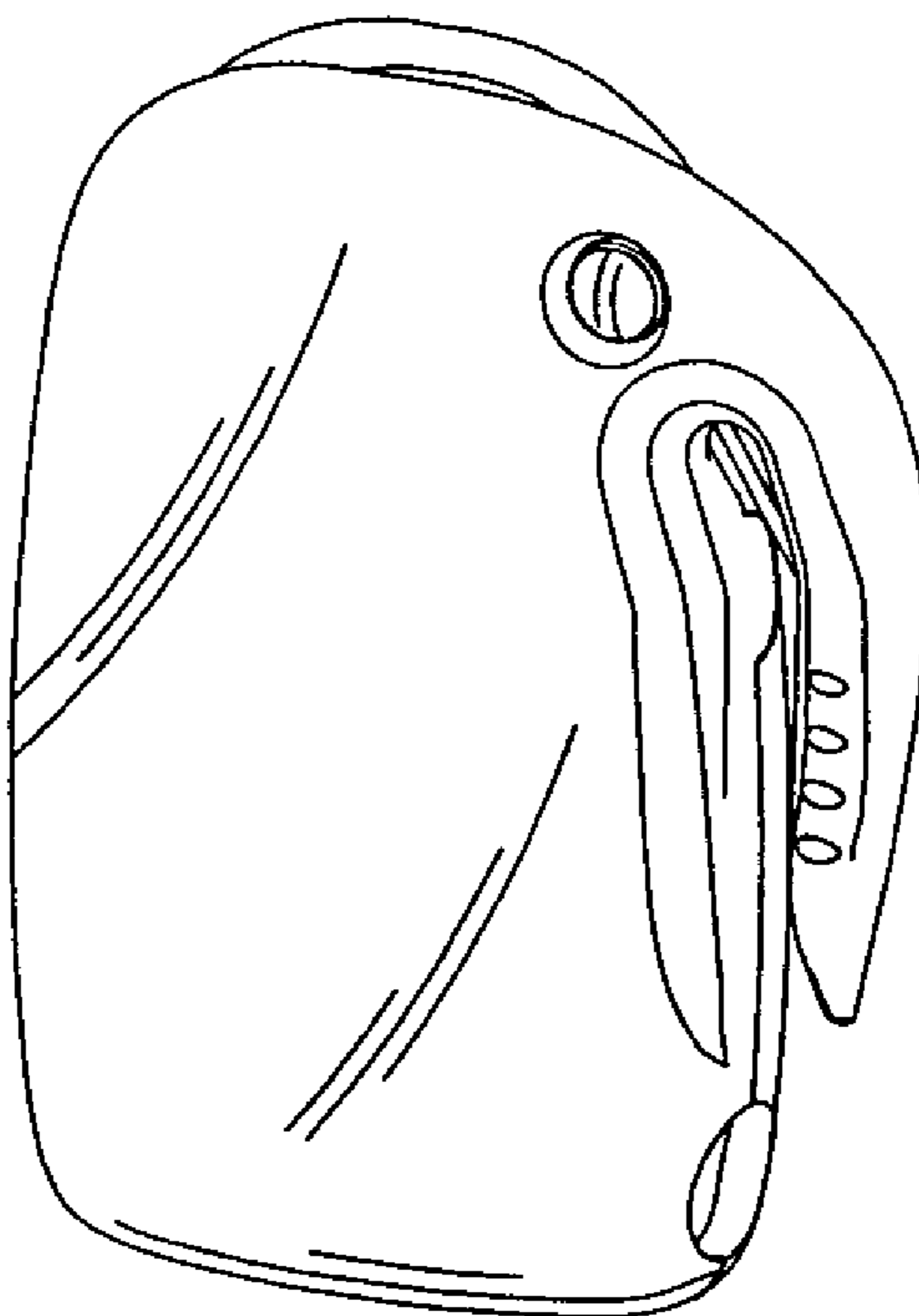
FIG. 8 is a perspective view thereof, with an envelope shown in broken lines.

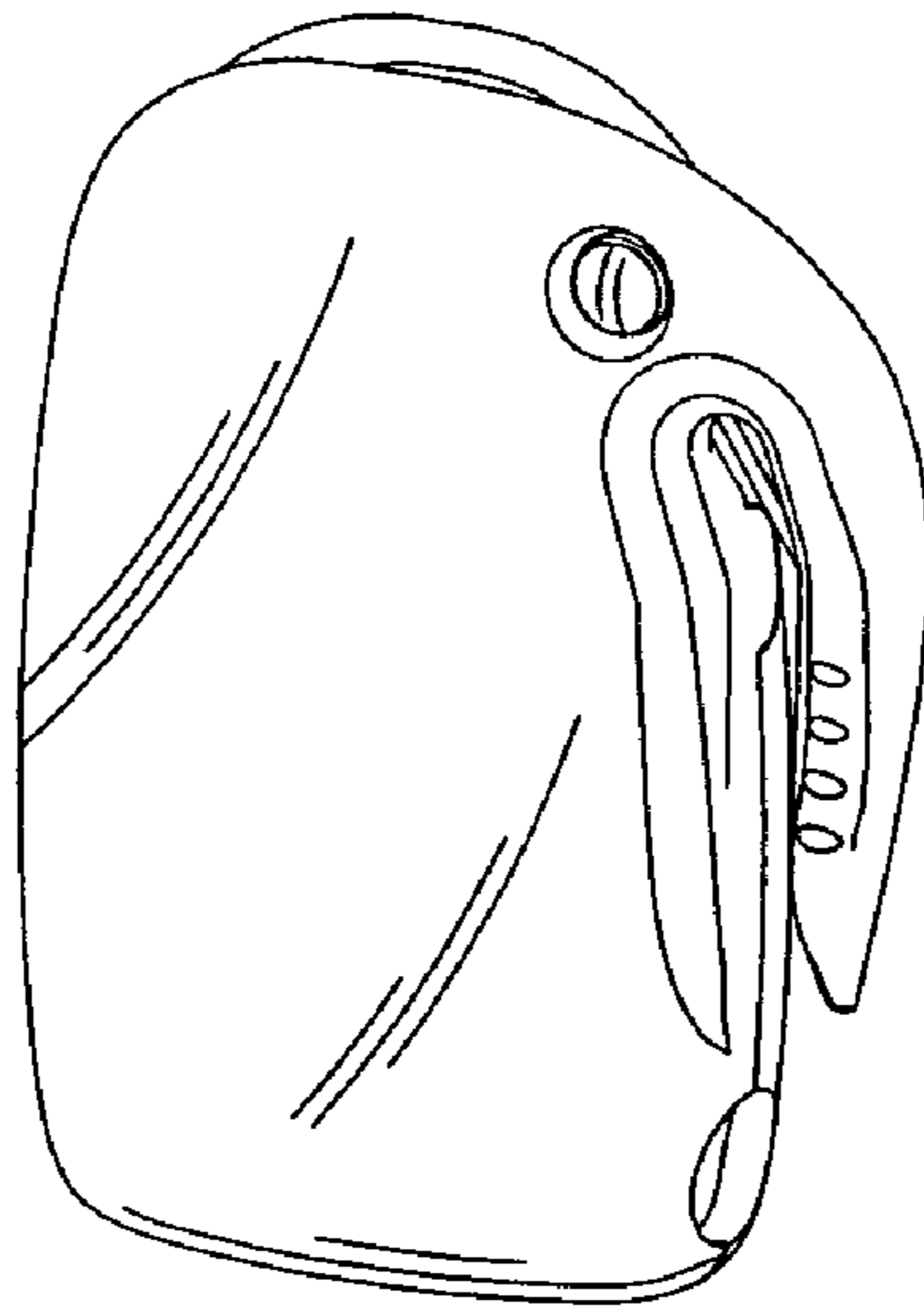

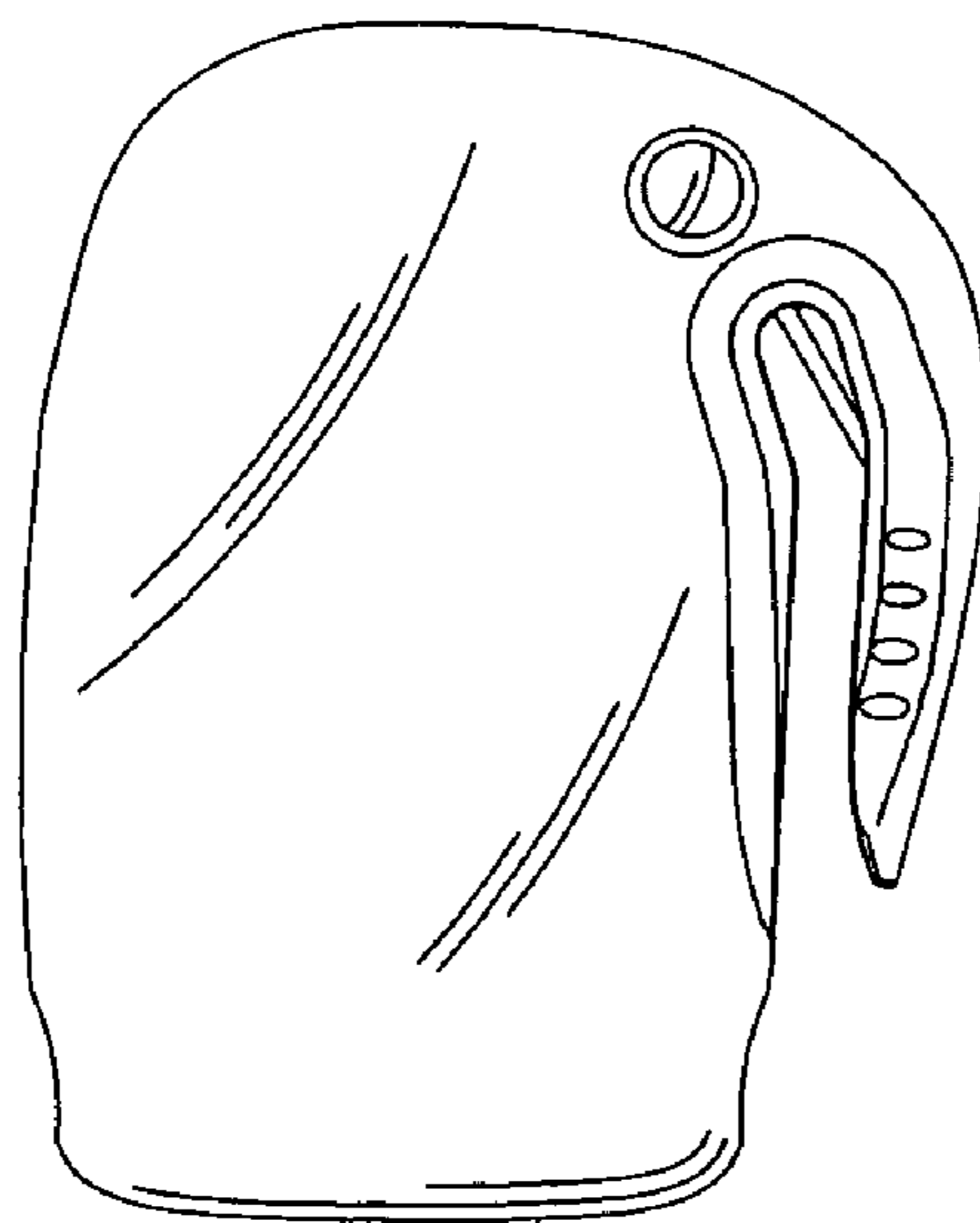

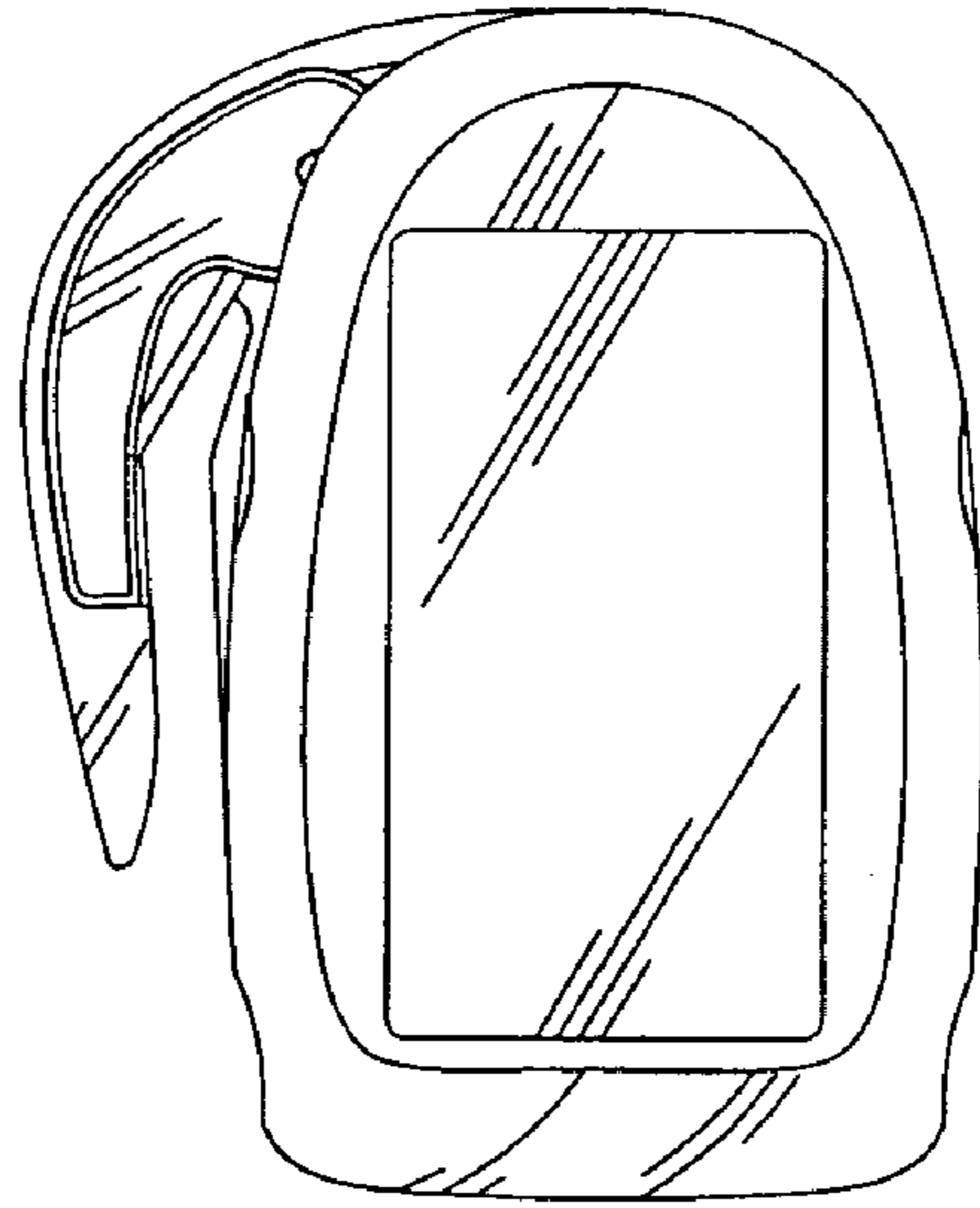

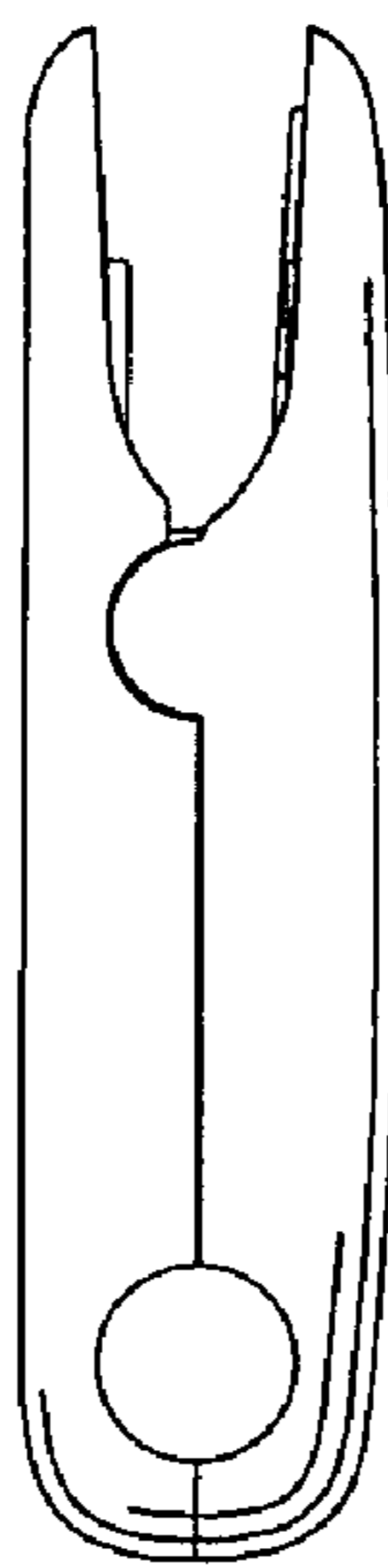

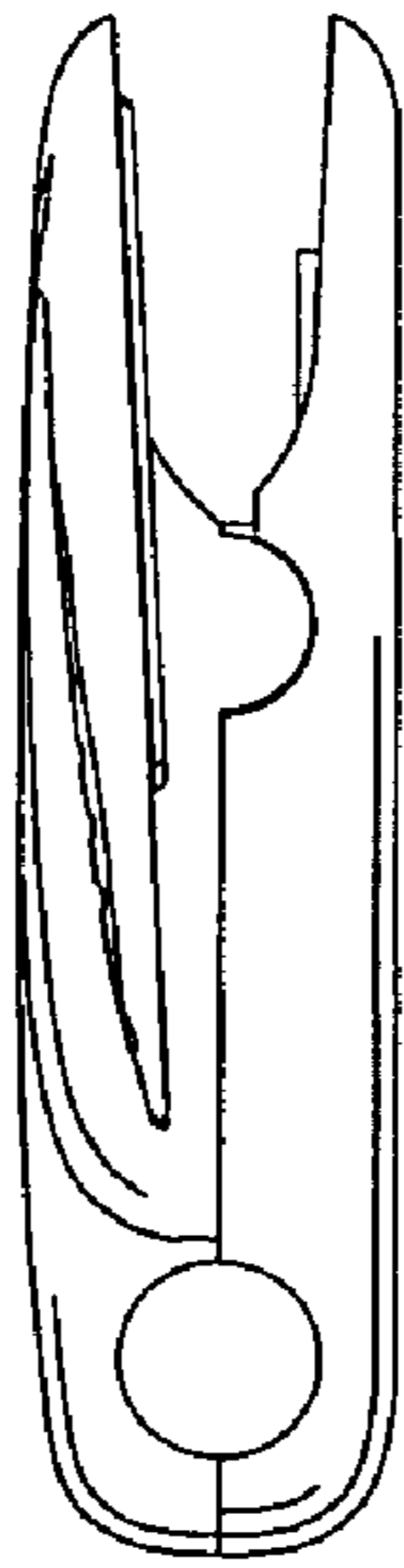

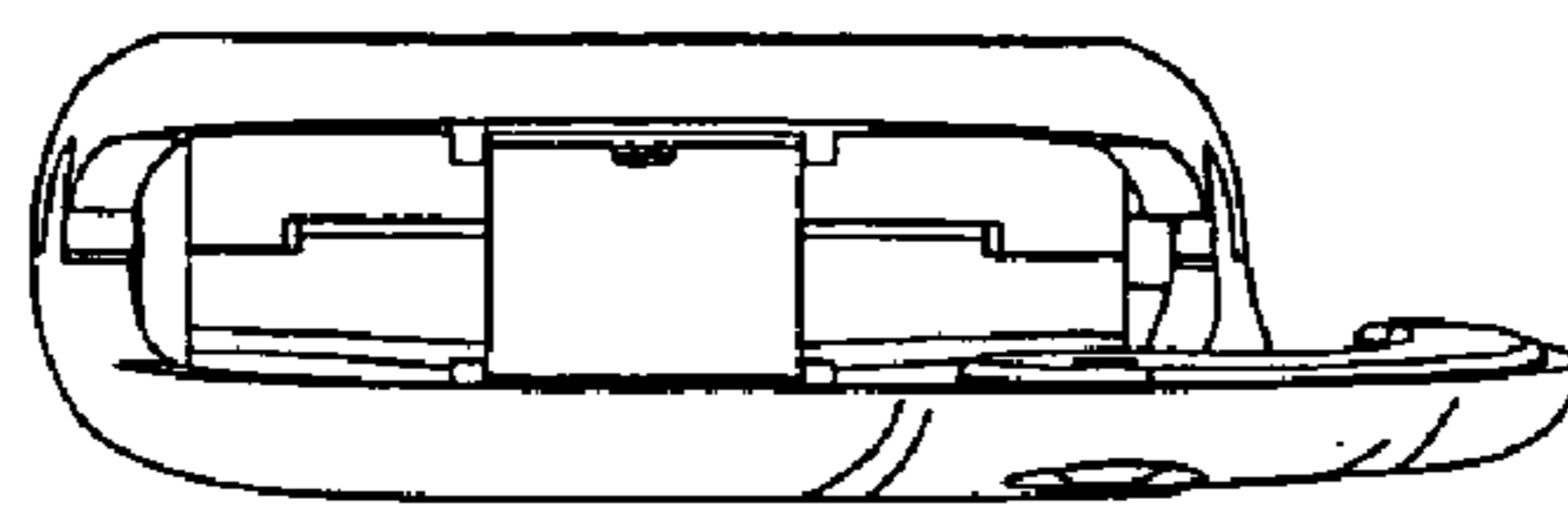

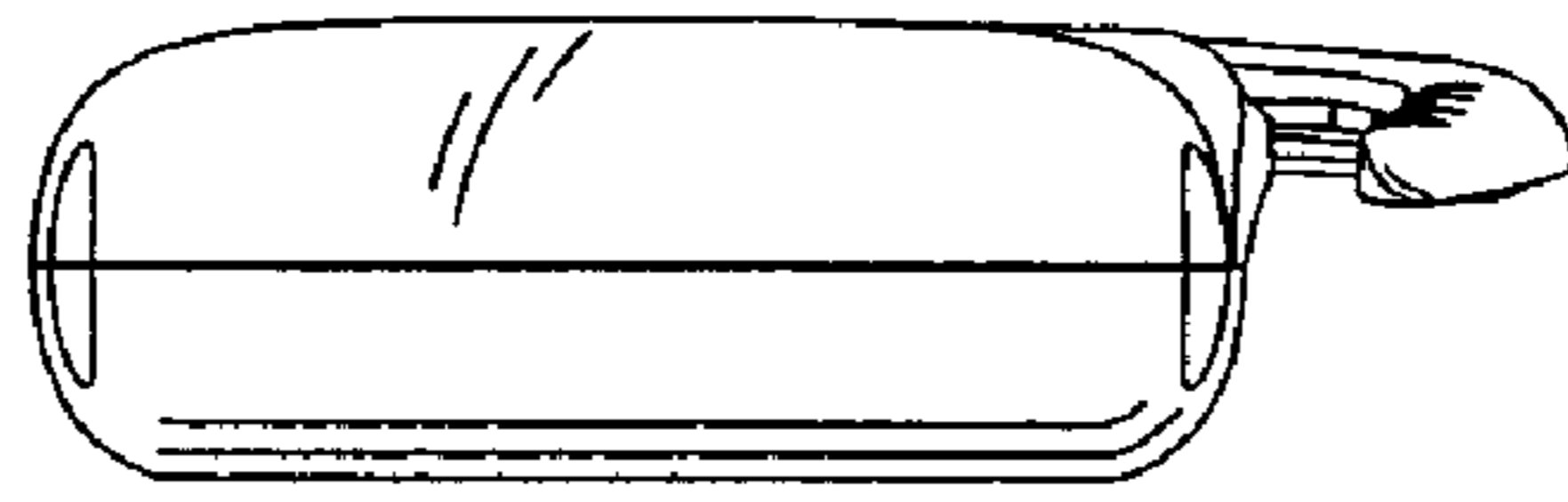

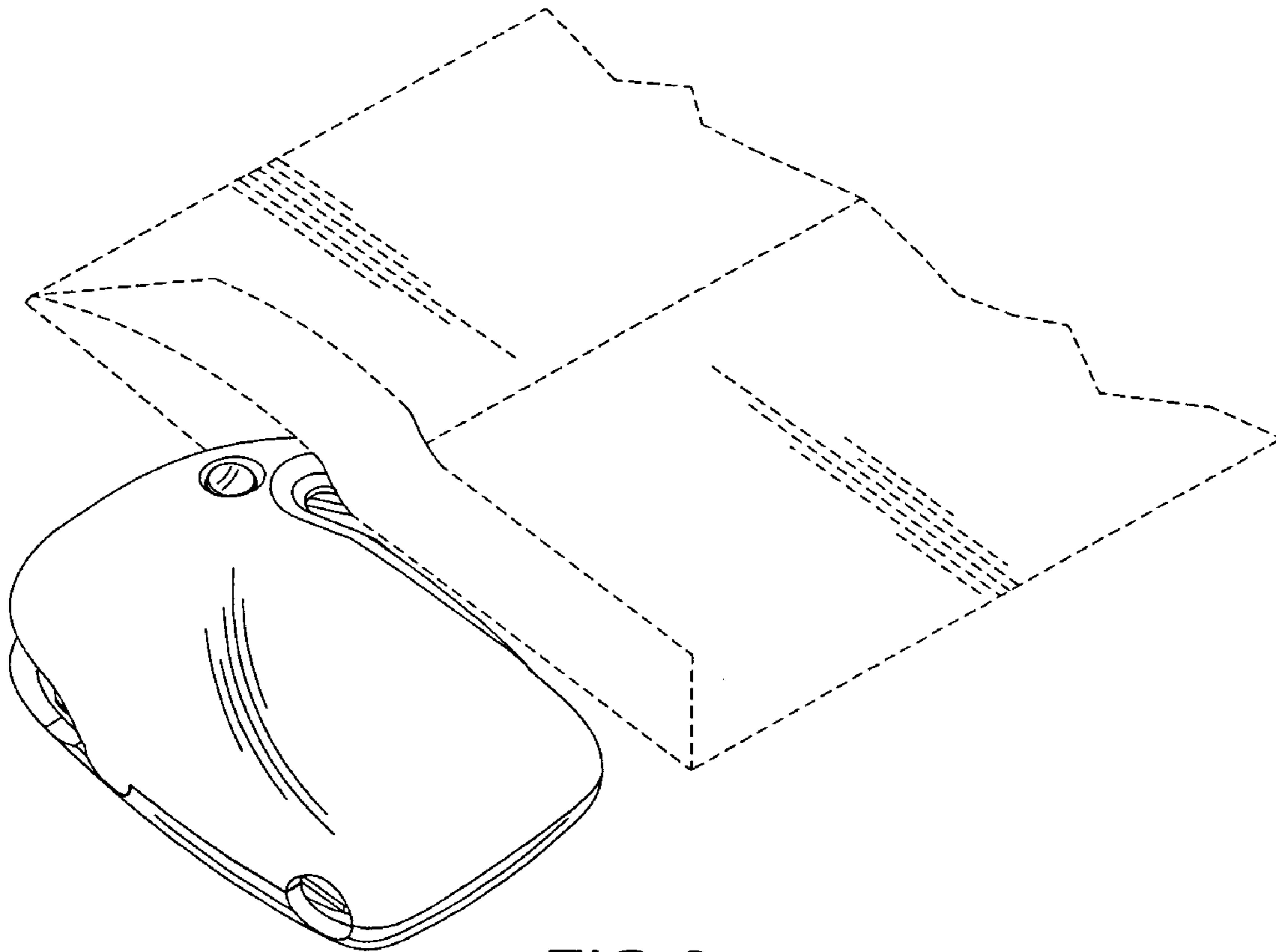

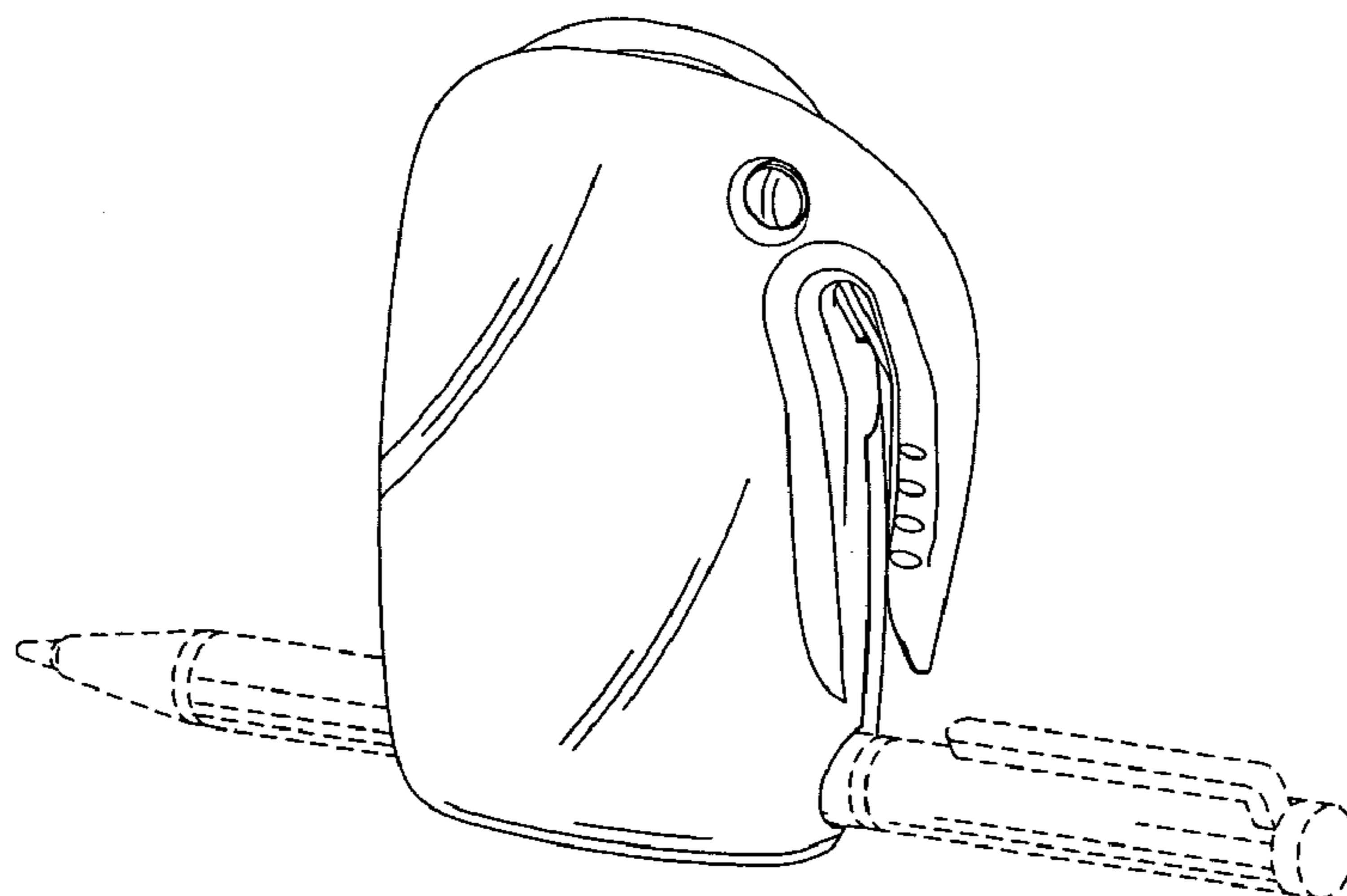

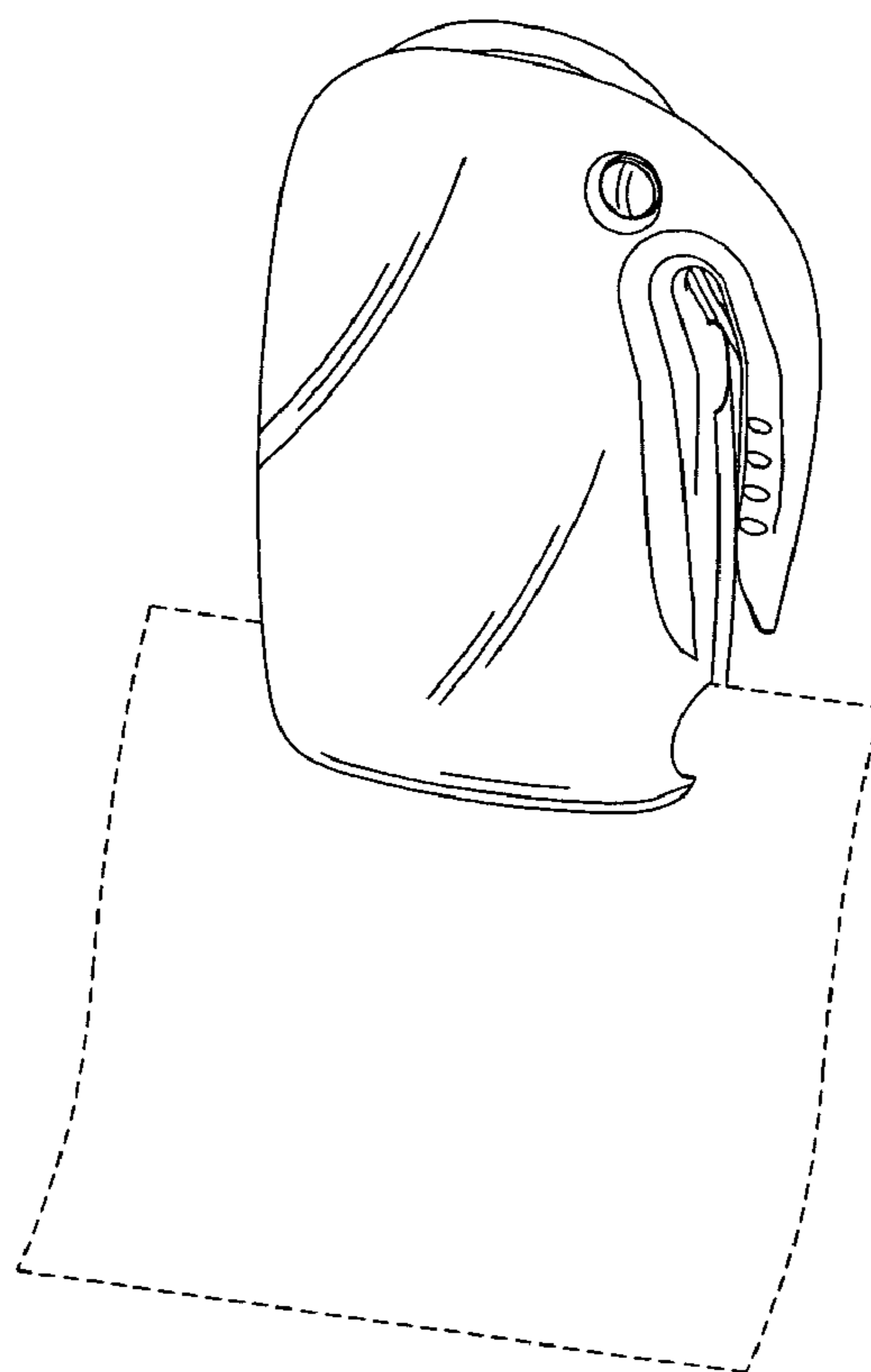
