DESCRIPTION

FIG. 1 is a right perspective view of a container showing our new design;

FIG. 7 is a right perspective view thereof, in an open position;

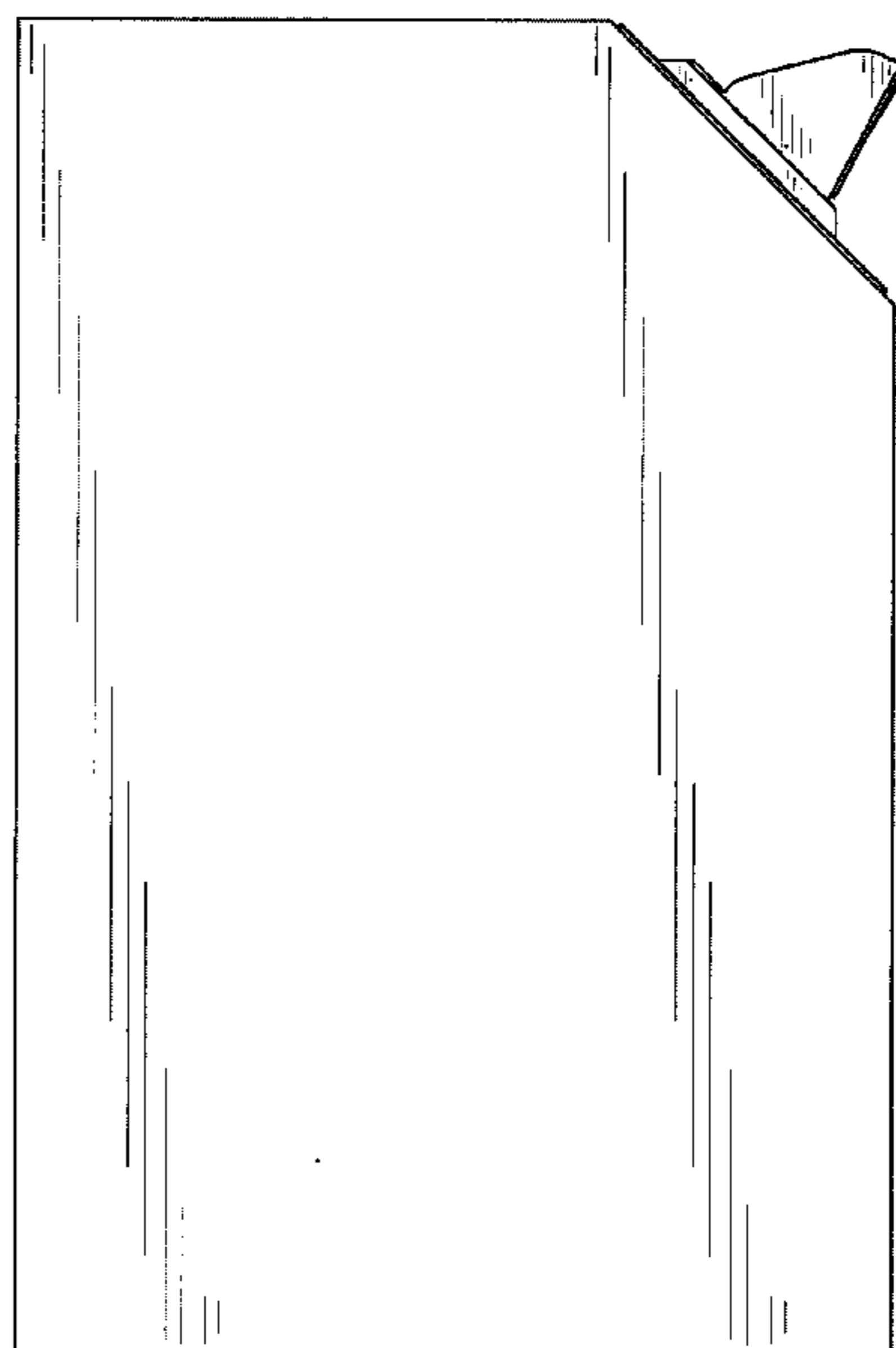
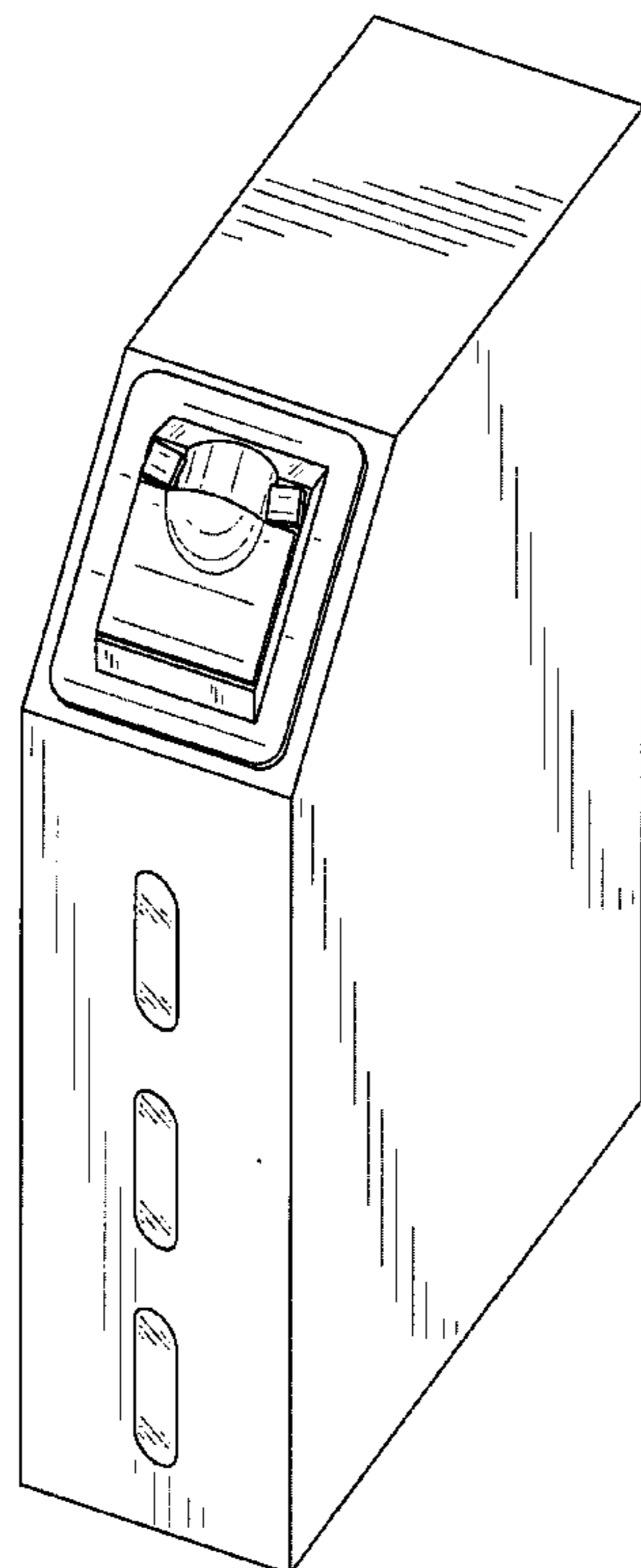
FIG. 8 is a left side elevational view thereof, in an open position;

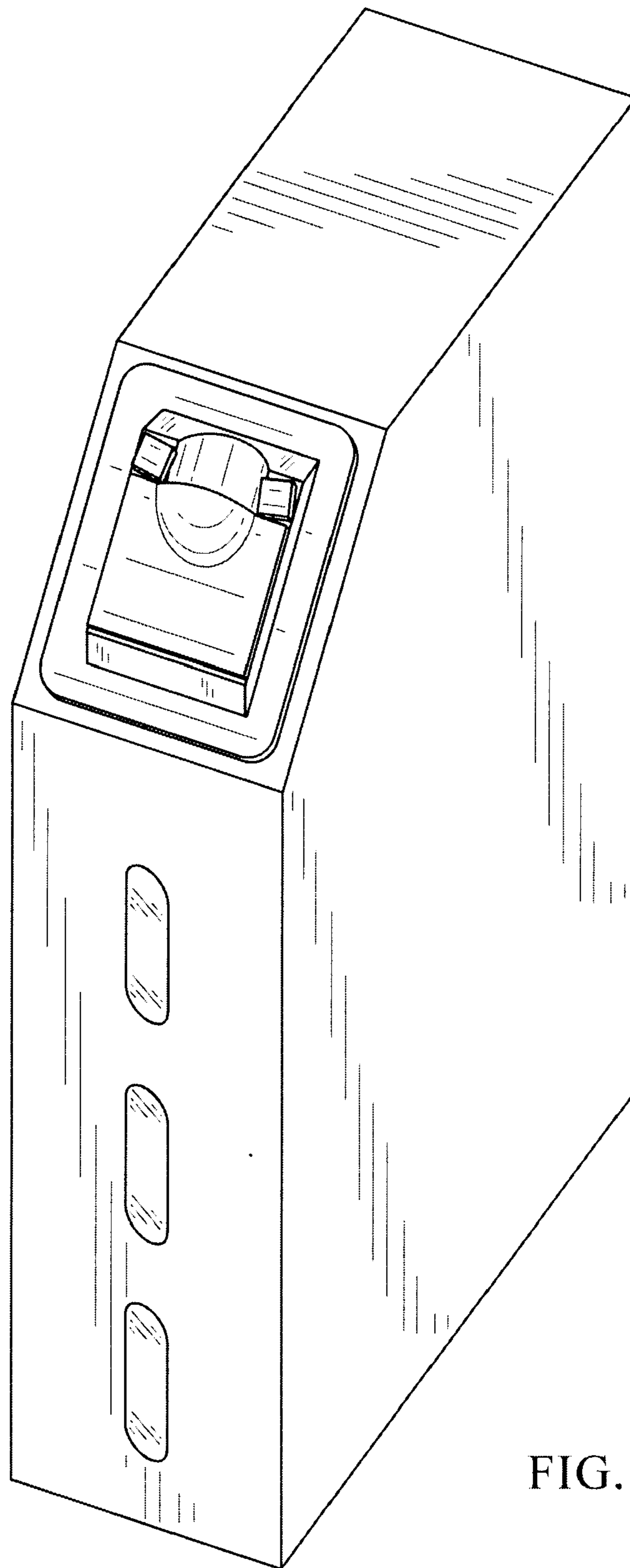

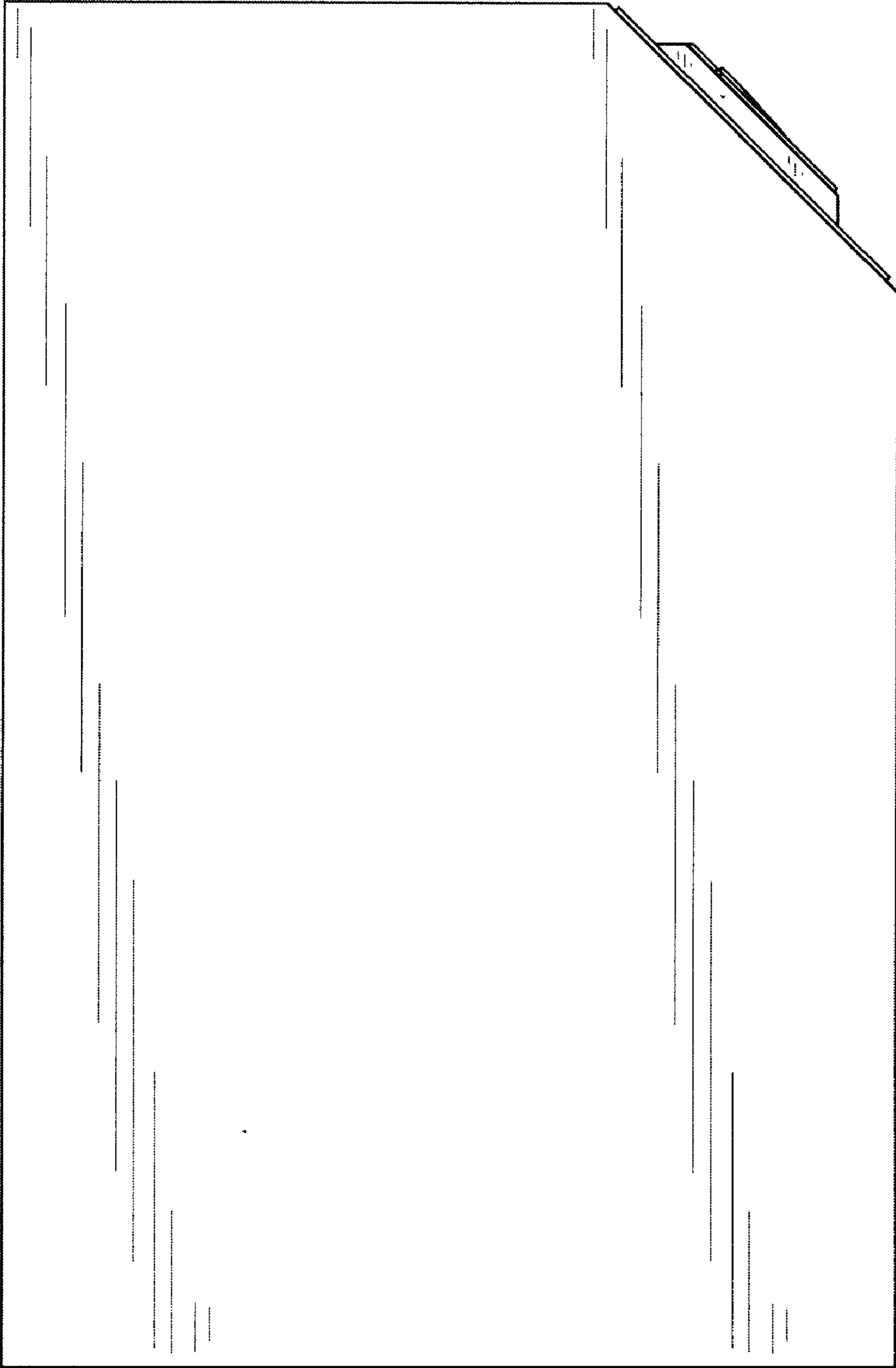

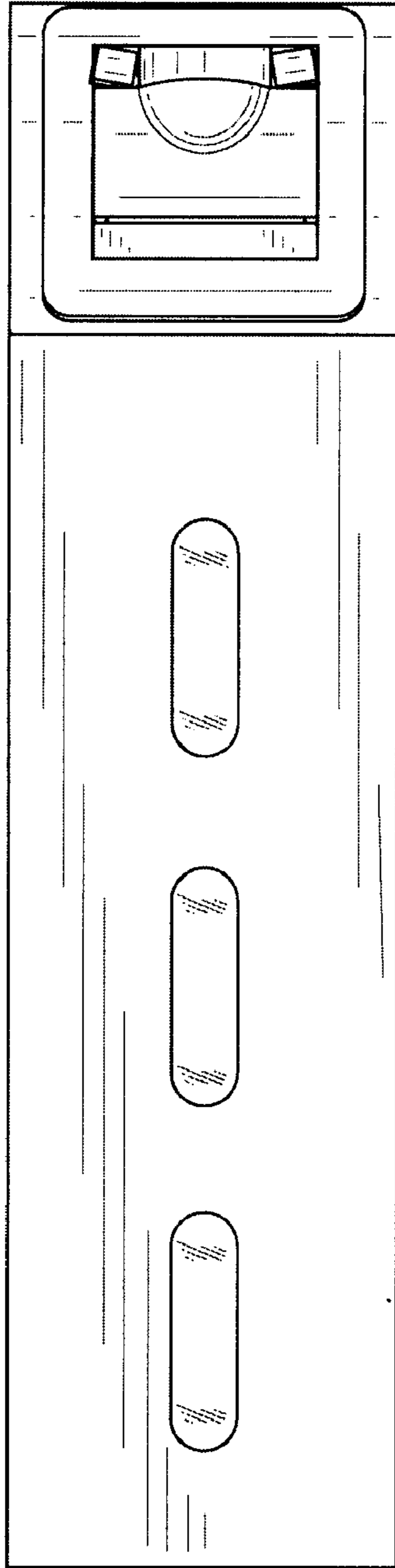

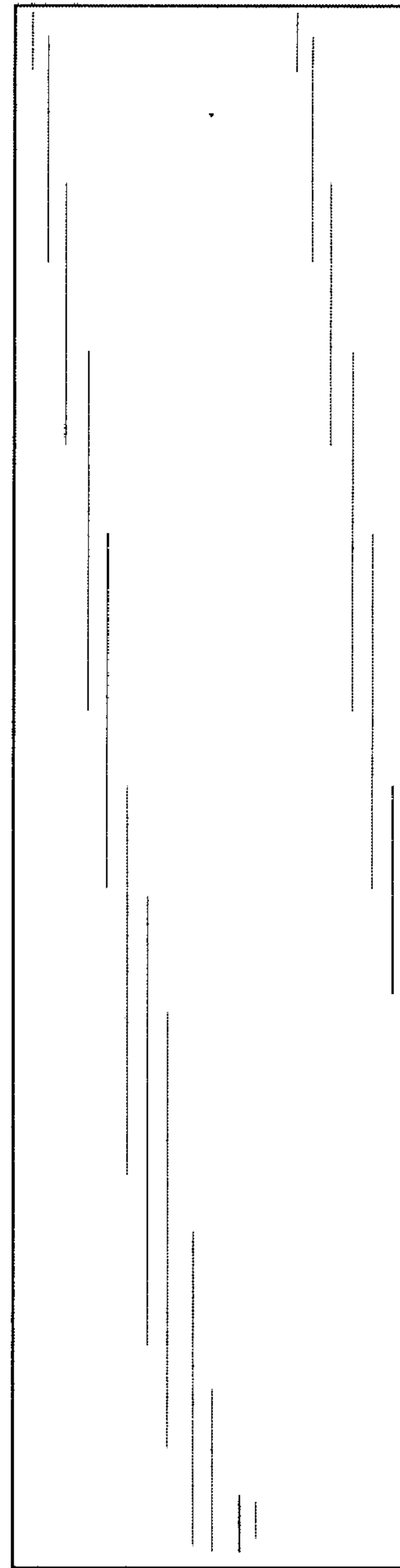

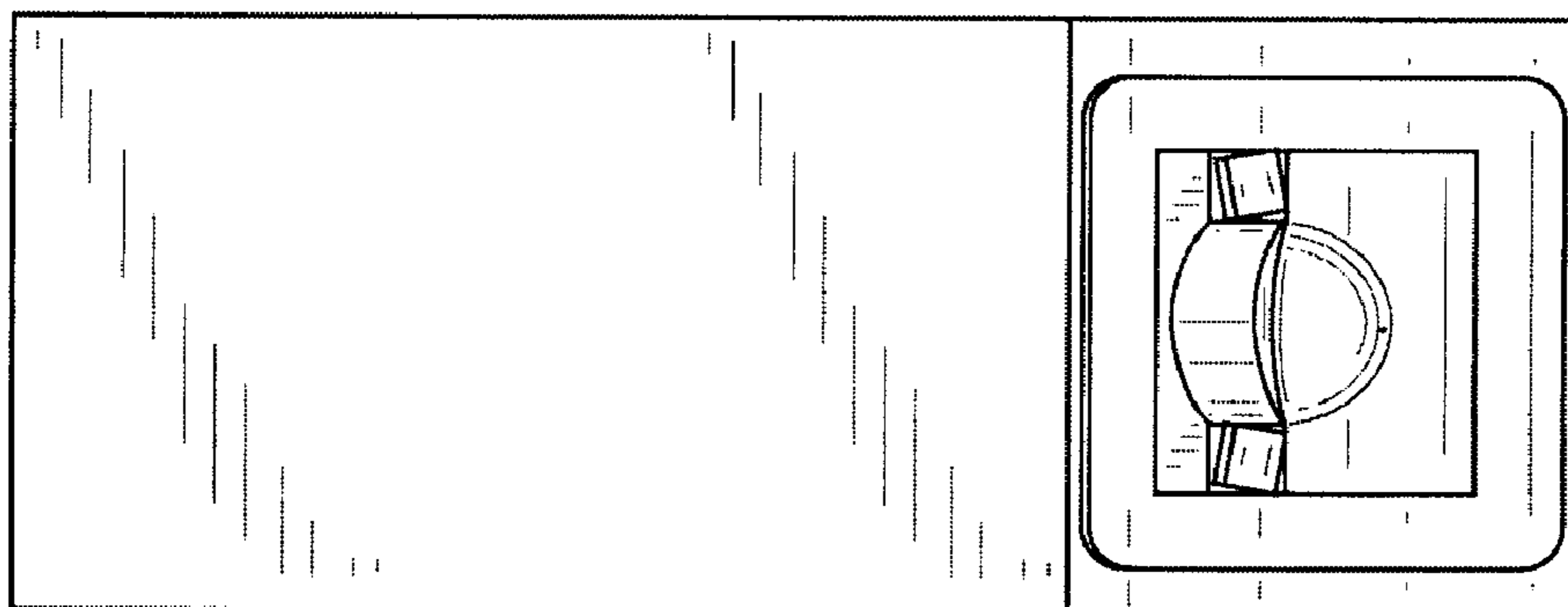

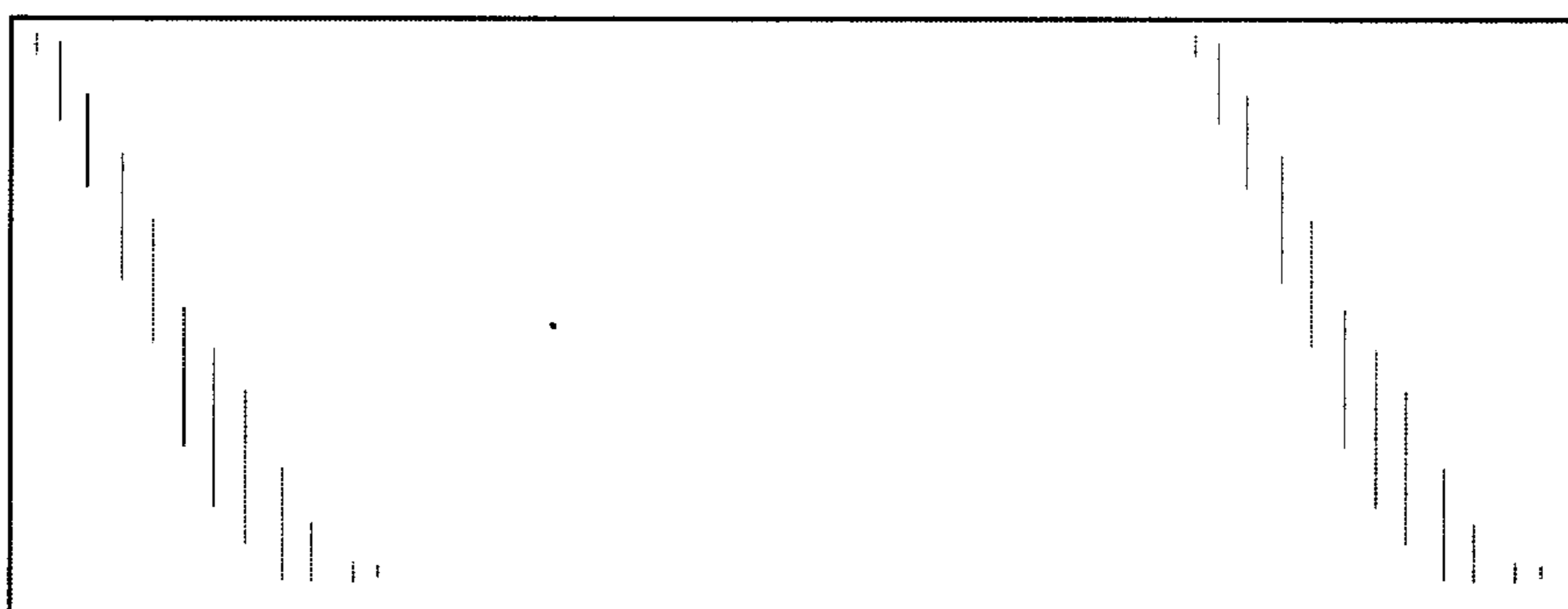

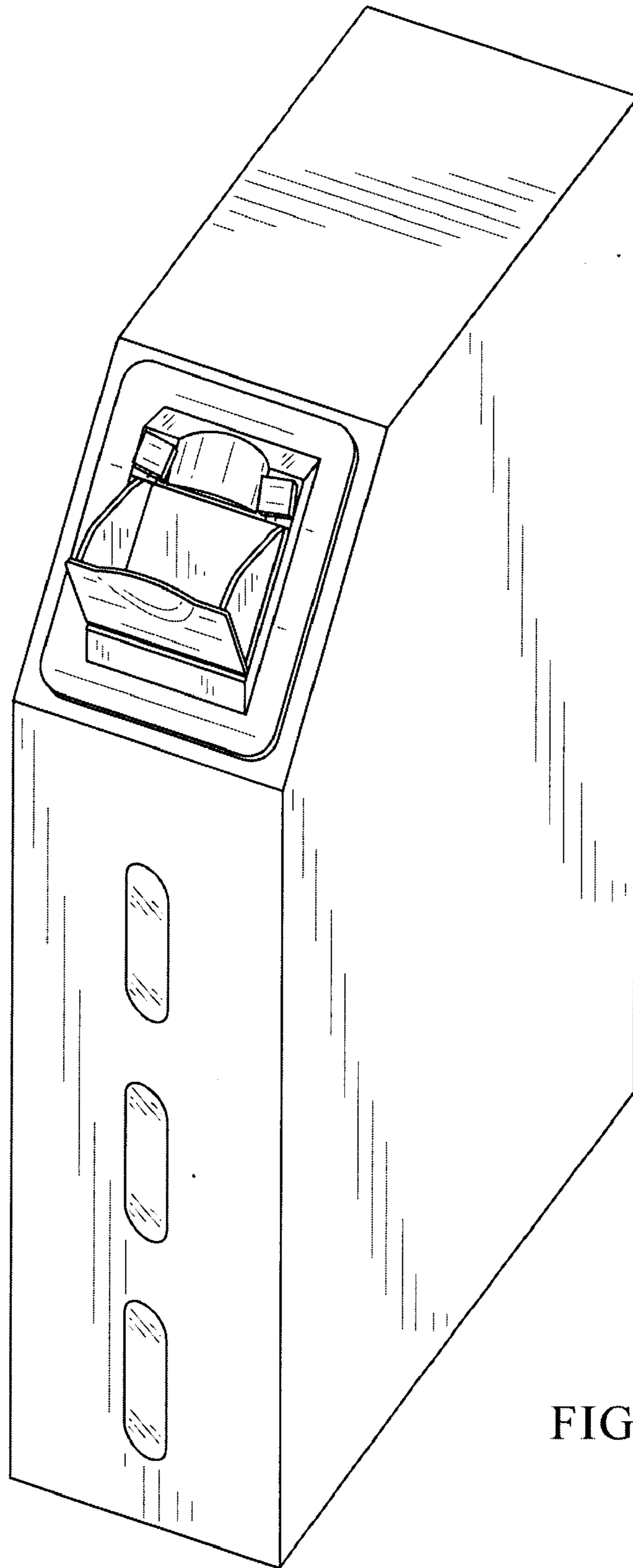

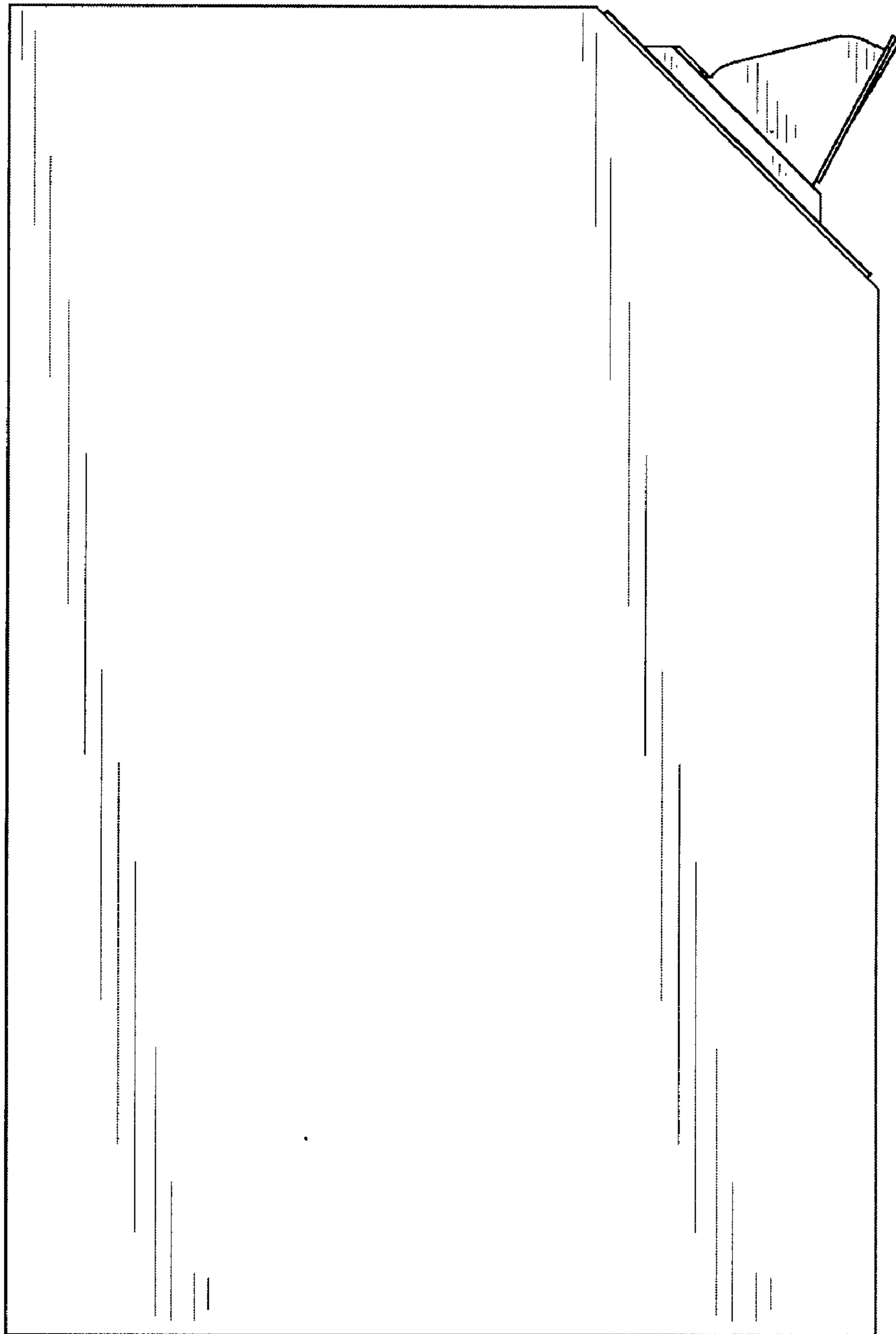

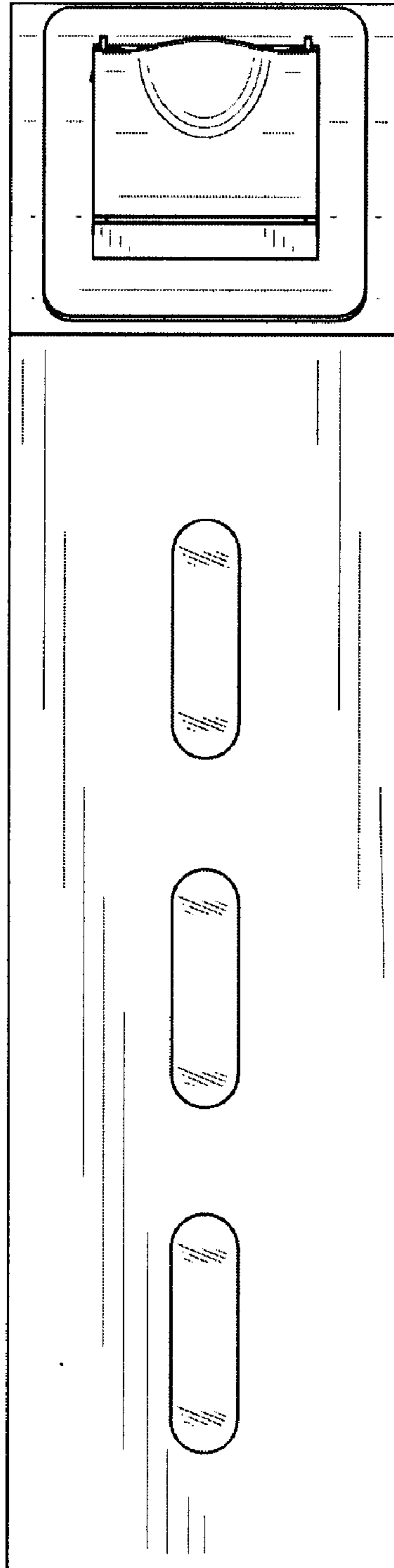

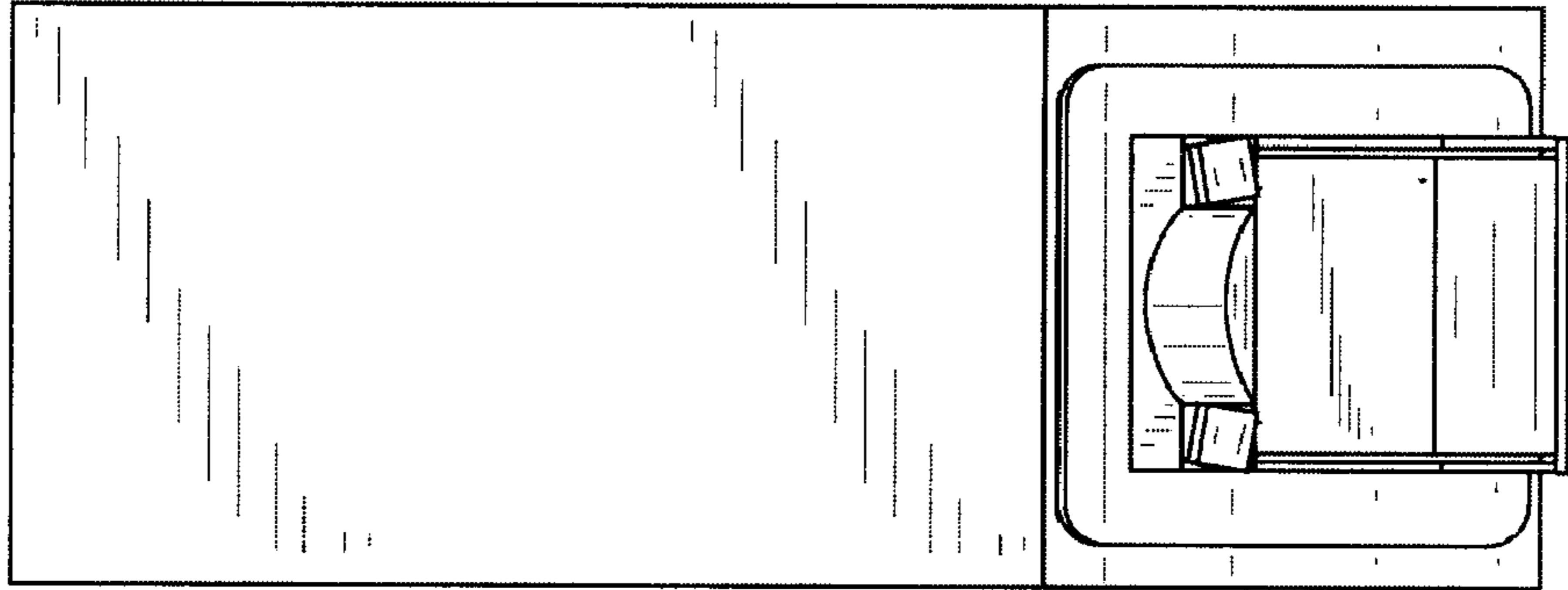

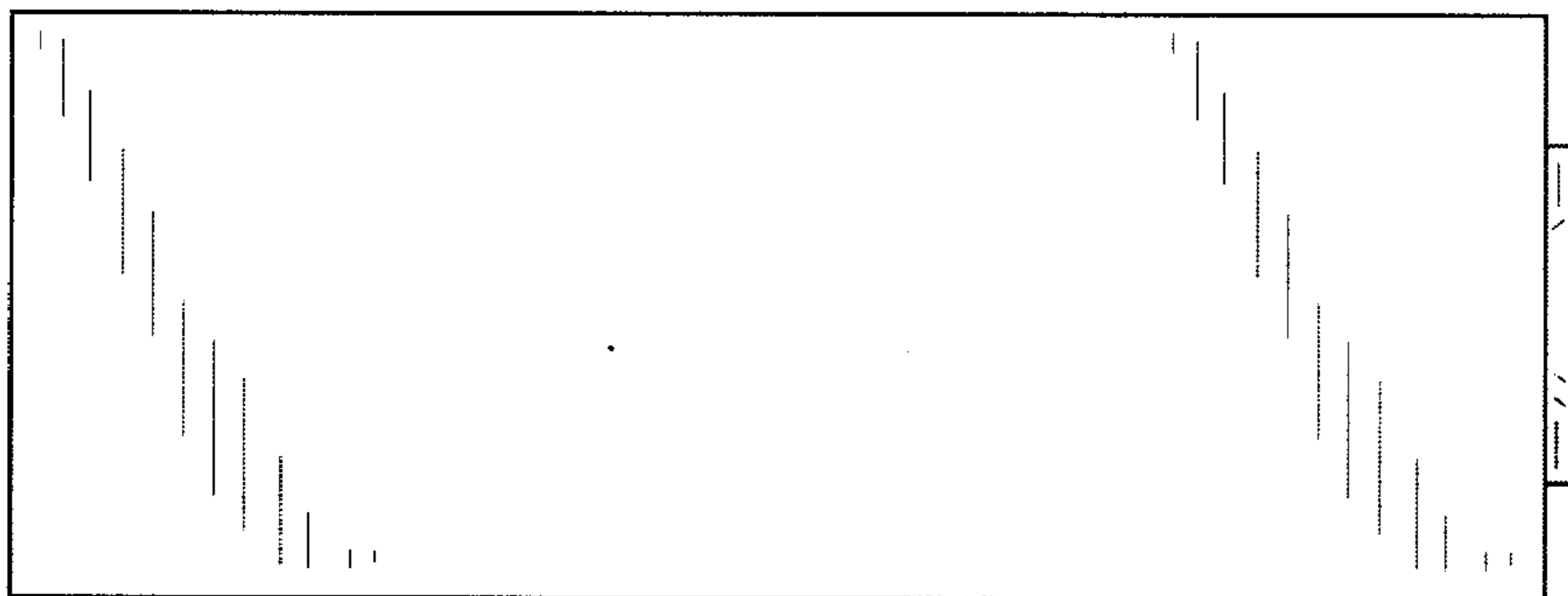
