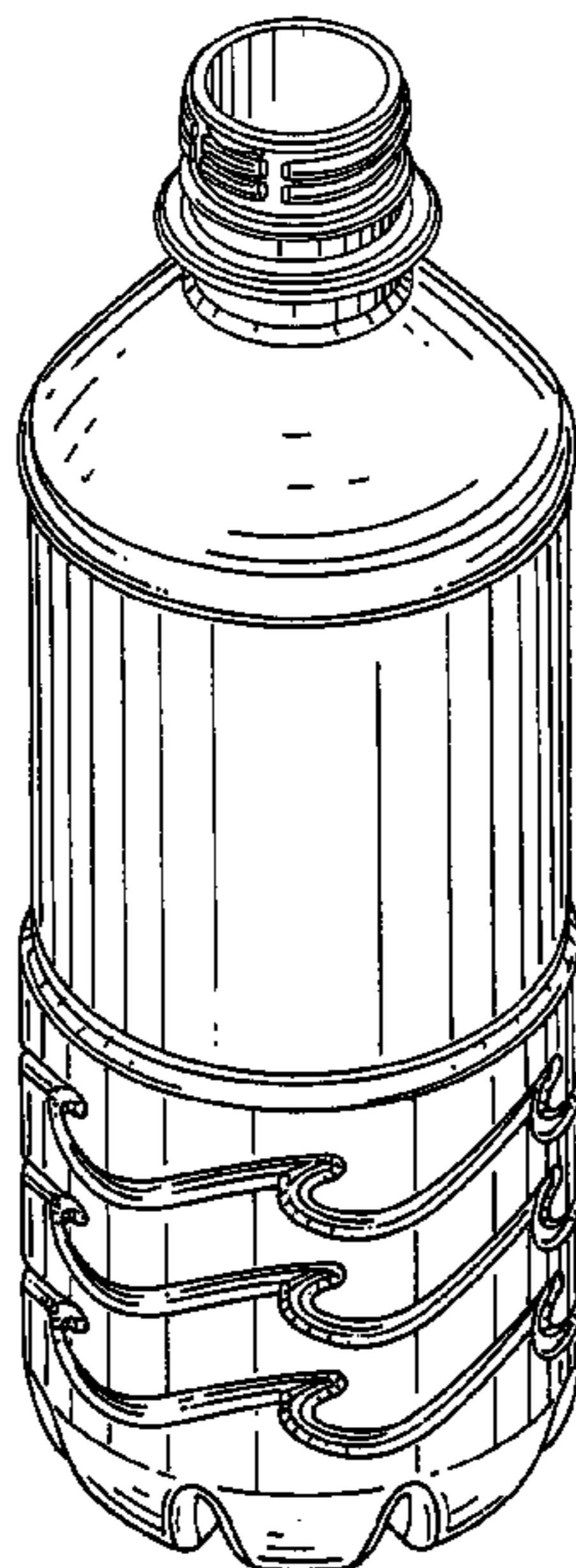
(57) **CLAIM**

FIG. 1 is a top front perspective view of a bottle according to our new design;

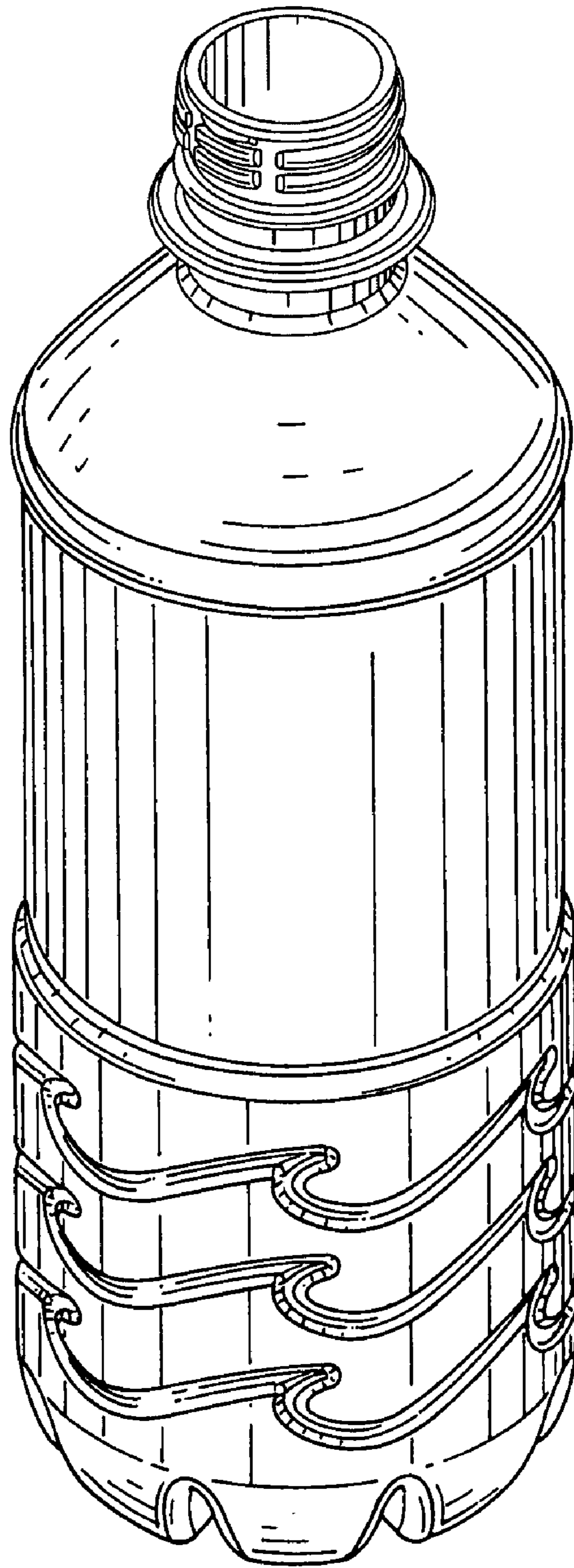

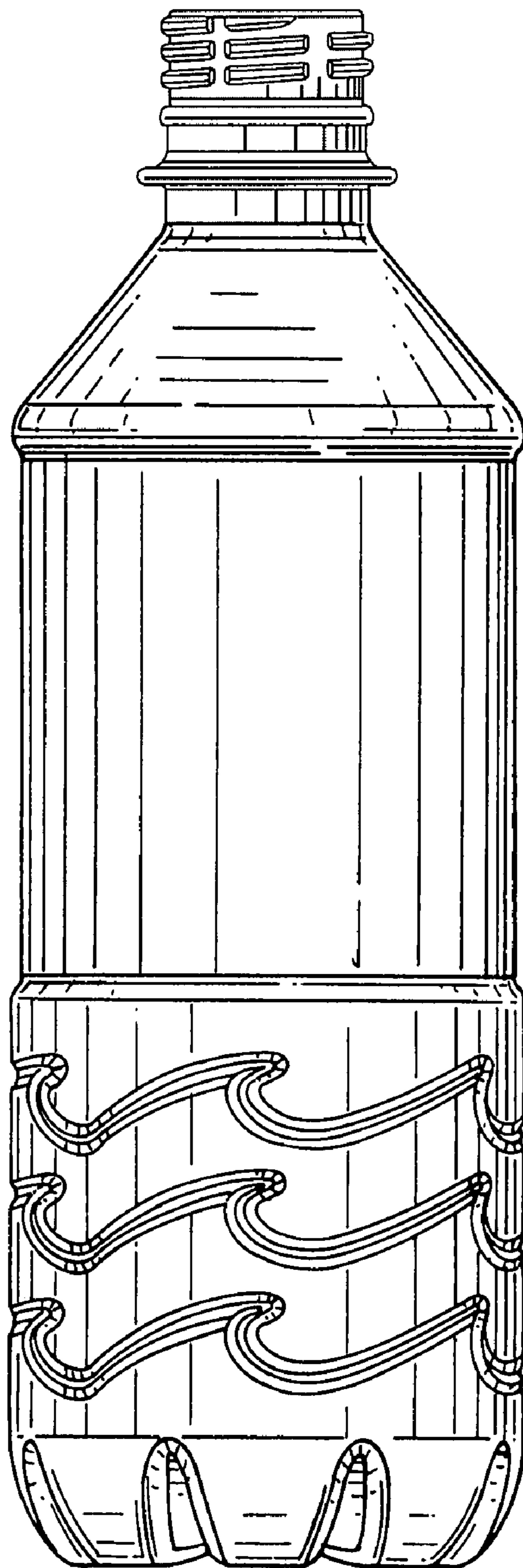

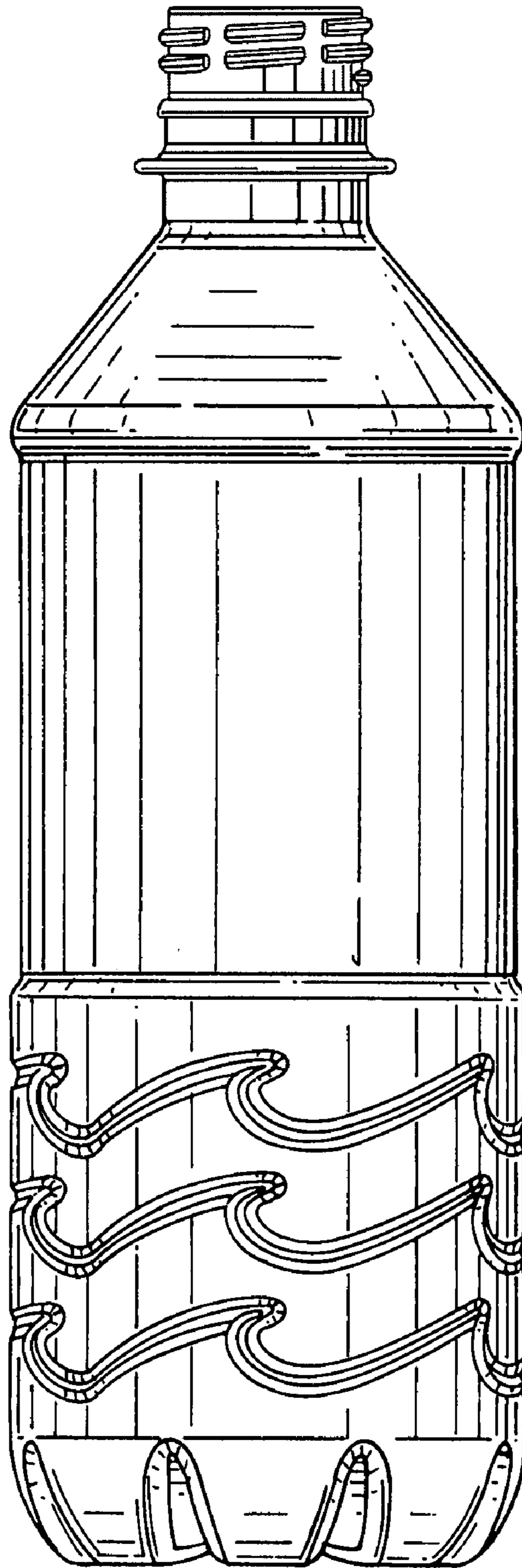

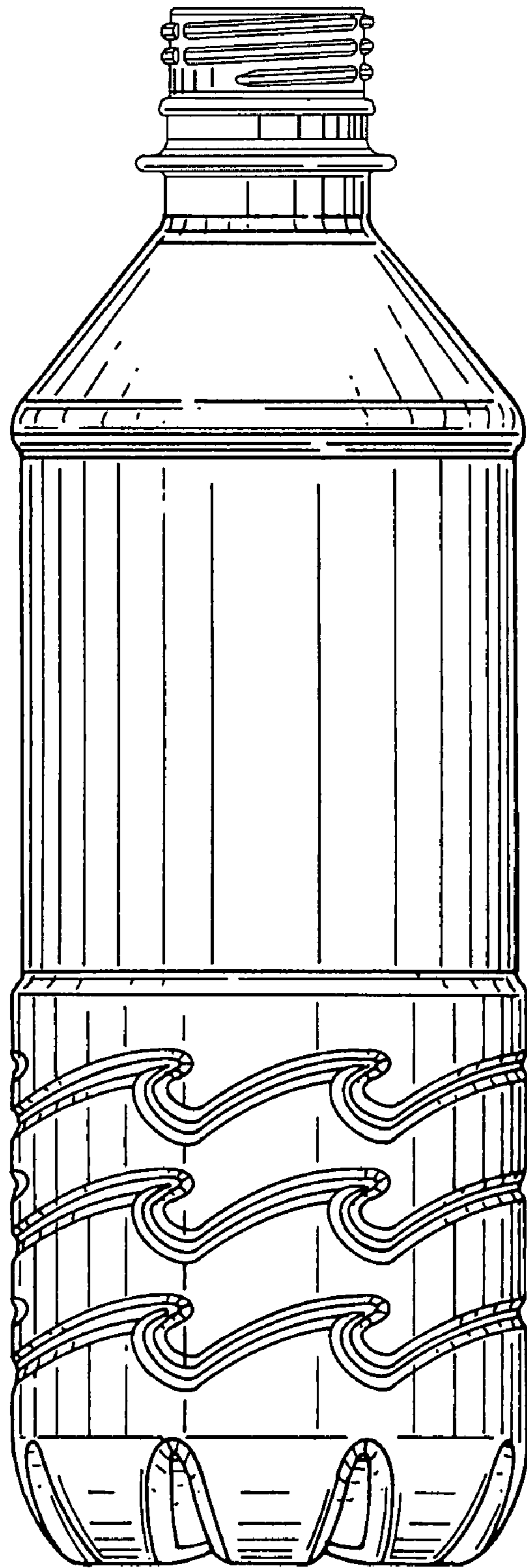

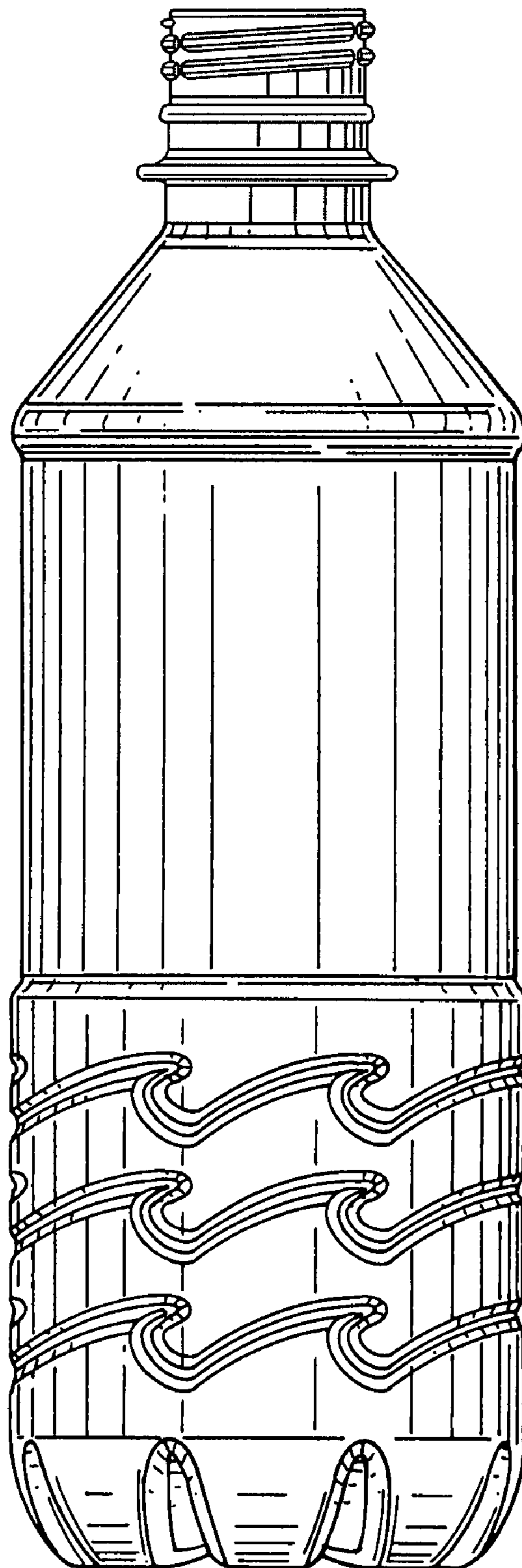

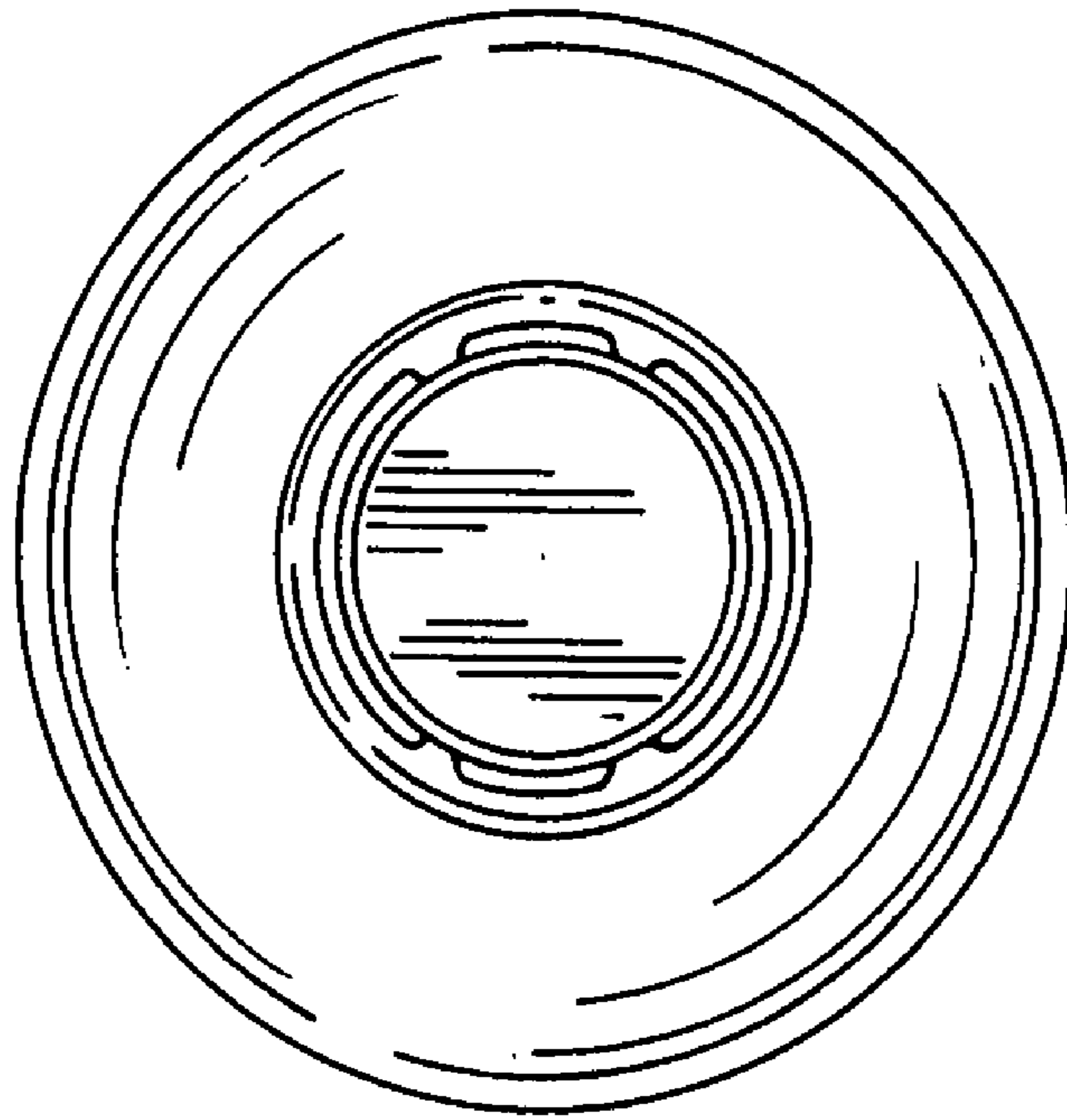
