DESCRIPTION

FIG. 1 is a front elevation view of a contact for connector, showing my new design;

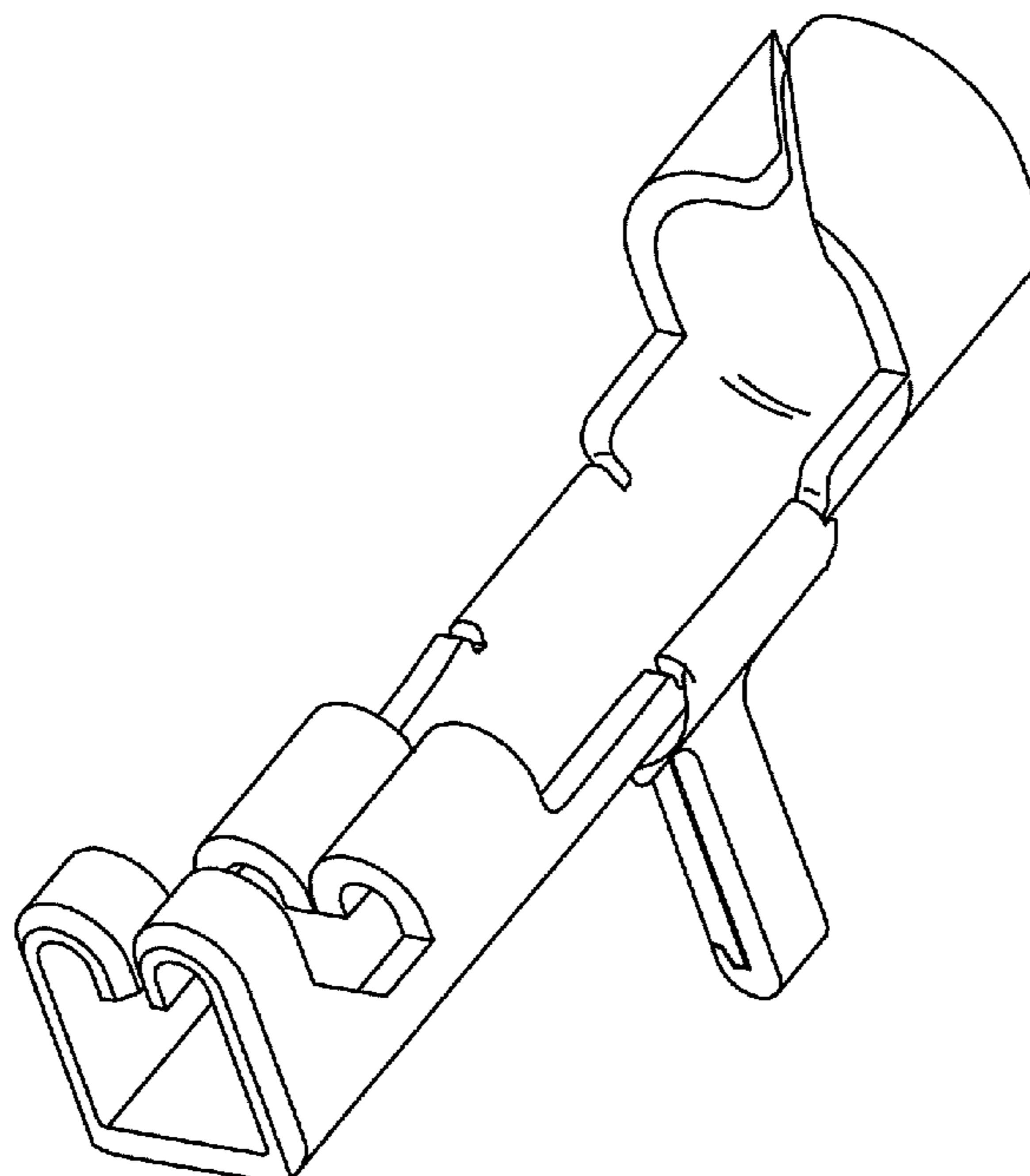

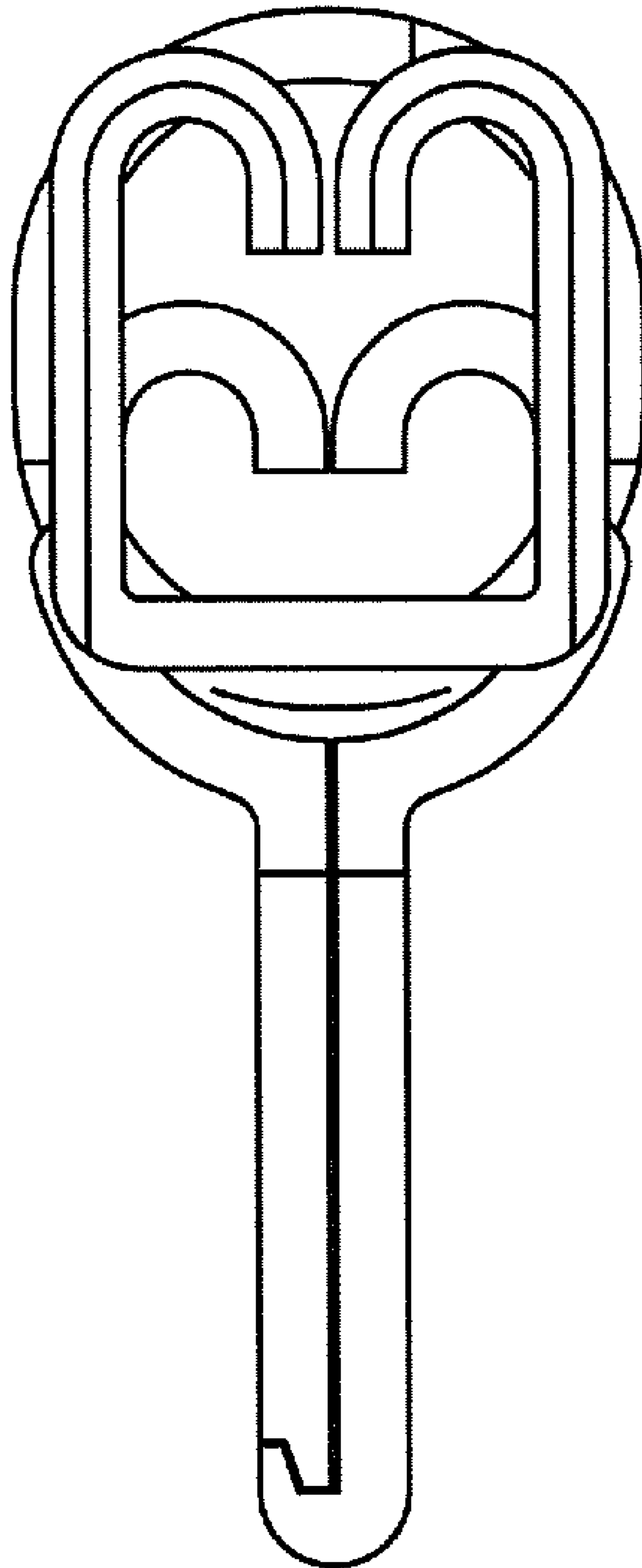

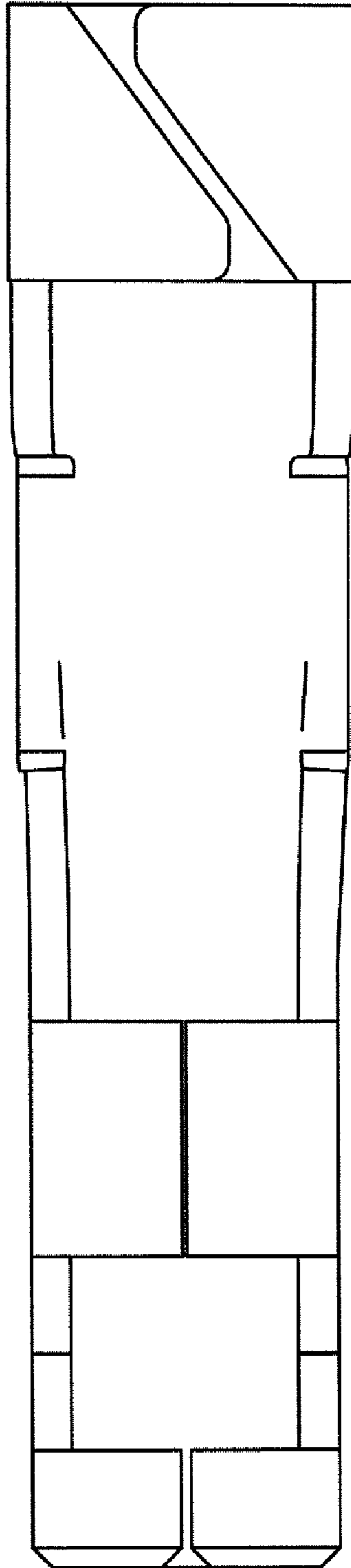

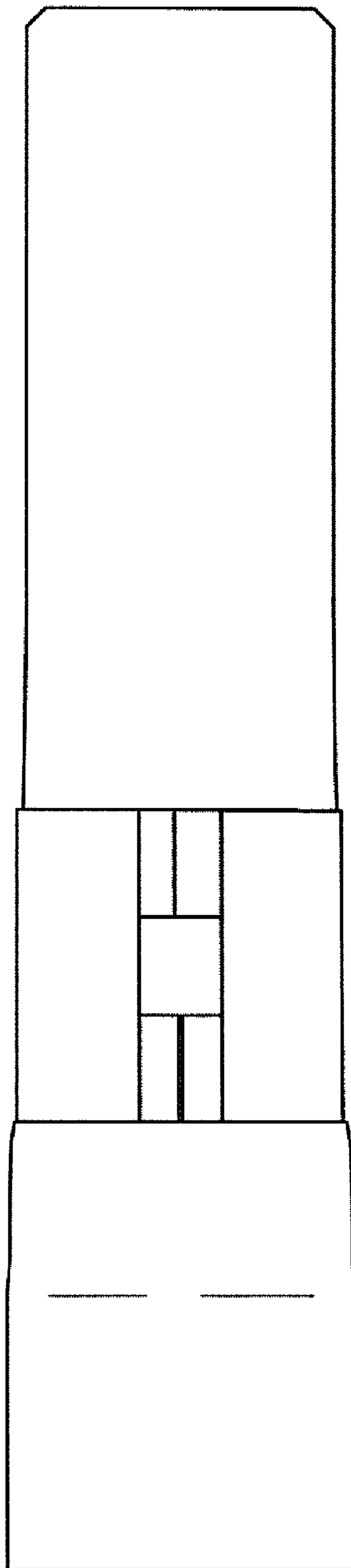

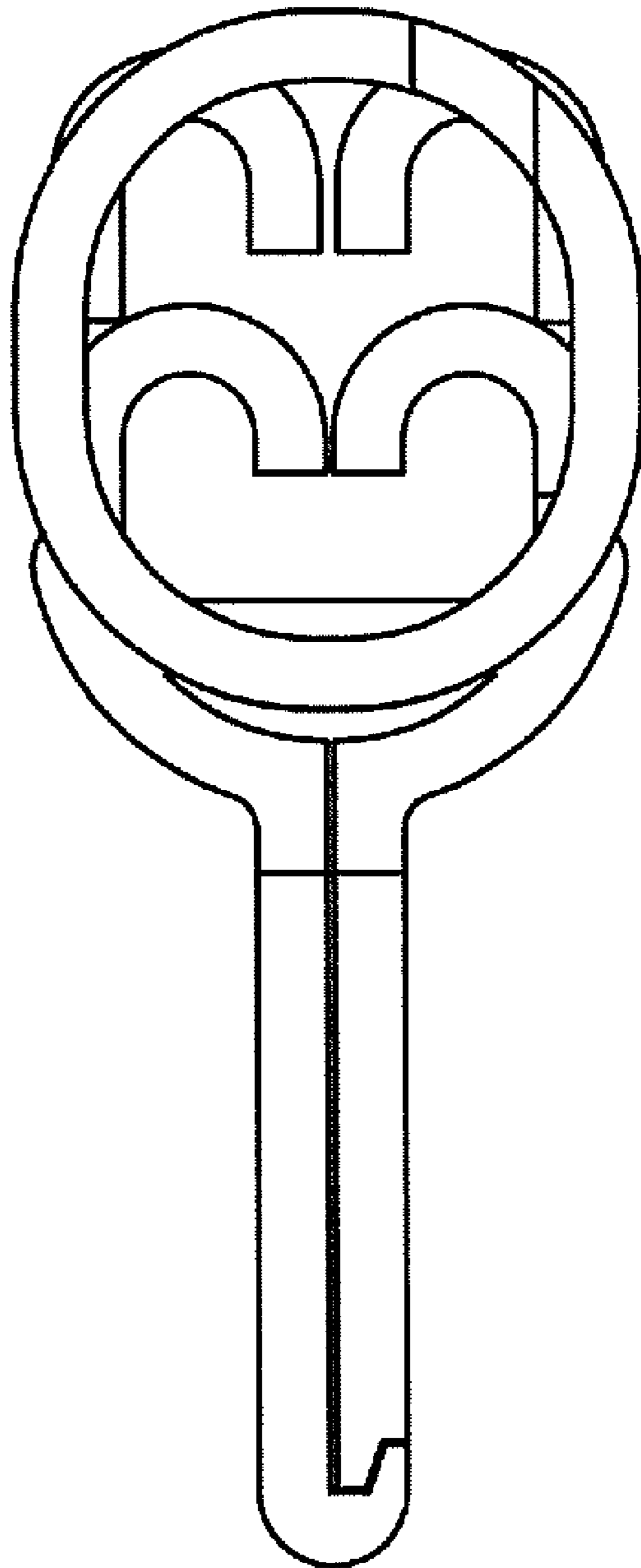

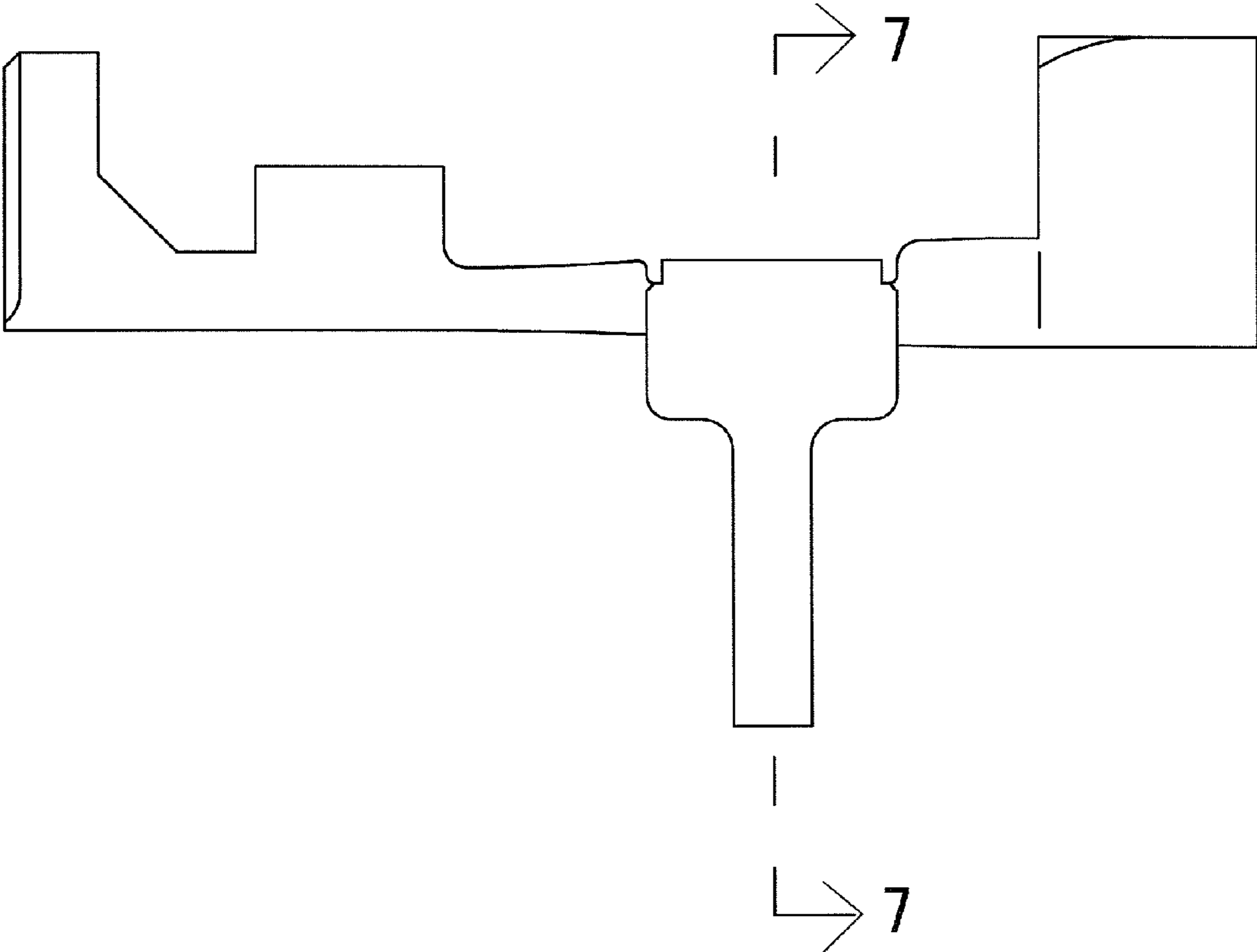

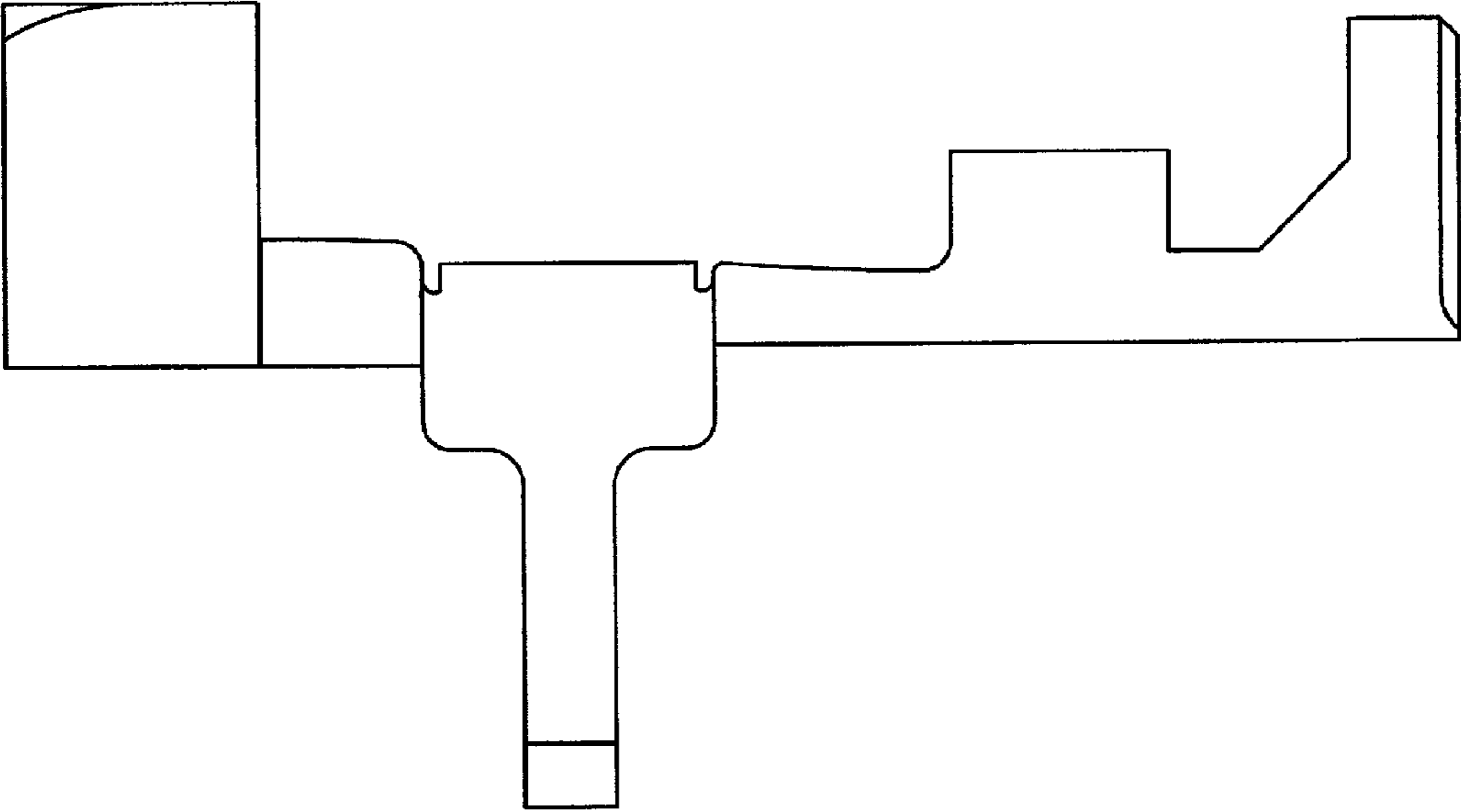

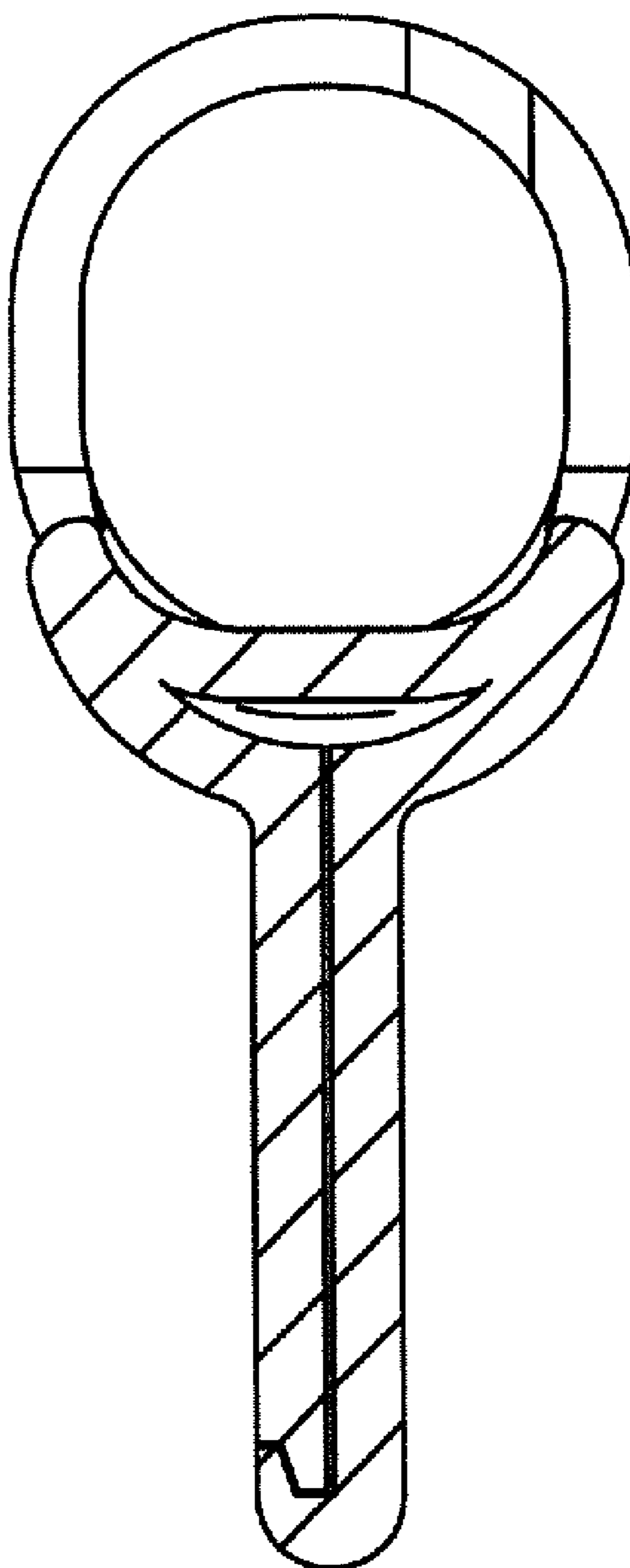
