(57) **CLAIM**

The ornamental design for a DVD player, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a DVD player in a closed configuration;

FIG. 2 is a left side view thereof, in which the DVD player is in an open configuration;

FIG. 3 is a right side view thereof, in which the DVD player is in an open configuration;

FIG. 4 is rear view thereof, in which the DVD player is in a closed configuration;

FIG. 5 is a top plan view thereof, in which the DVD player is in a closed configuration;

FIG. 6 is a top view thereof, in which the DVD player is in an open configuration;

FIG. 7 is a front perspective view thereof, in which the DVD player is in a closed configuration;

FIG. 8 is a front view of a second embodiment of FIG. 1, in which the DVD player is in closed configuration;

FIG. 9 is a left side view of FIG. 8, in which the DVD player is in an open configuration;

FIG. 10 is a right side view of FIG. 8, in which the DVD player is in an open configuration;

FIG. 11 is a rear view of FIG. 8, in which the DVD player is in a closed configuration;

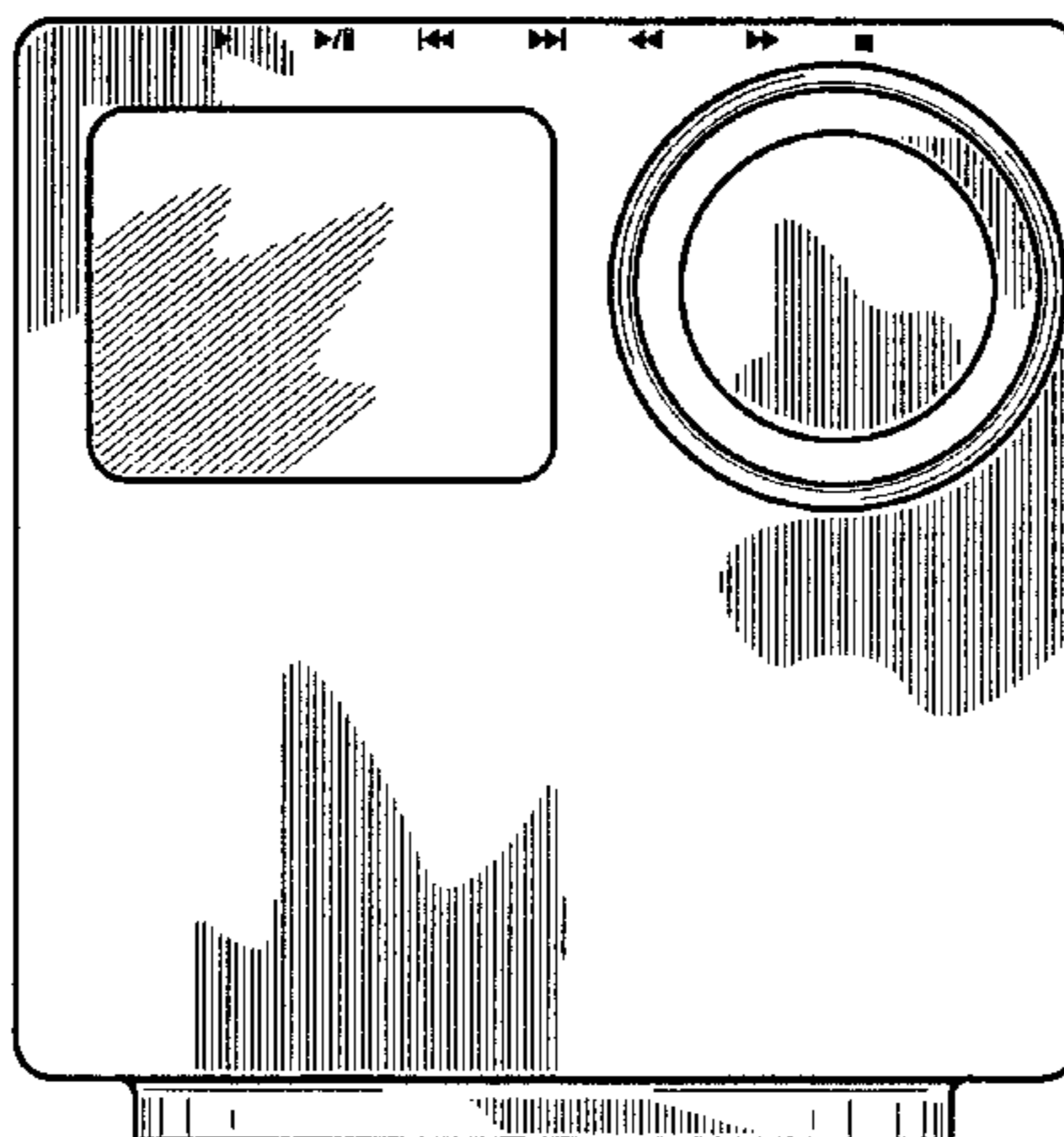
FIG. 12 is a top view of FIG. 8, in which the DVD player is in a closed configuration;

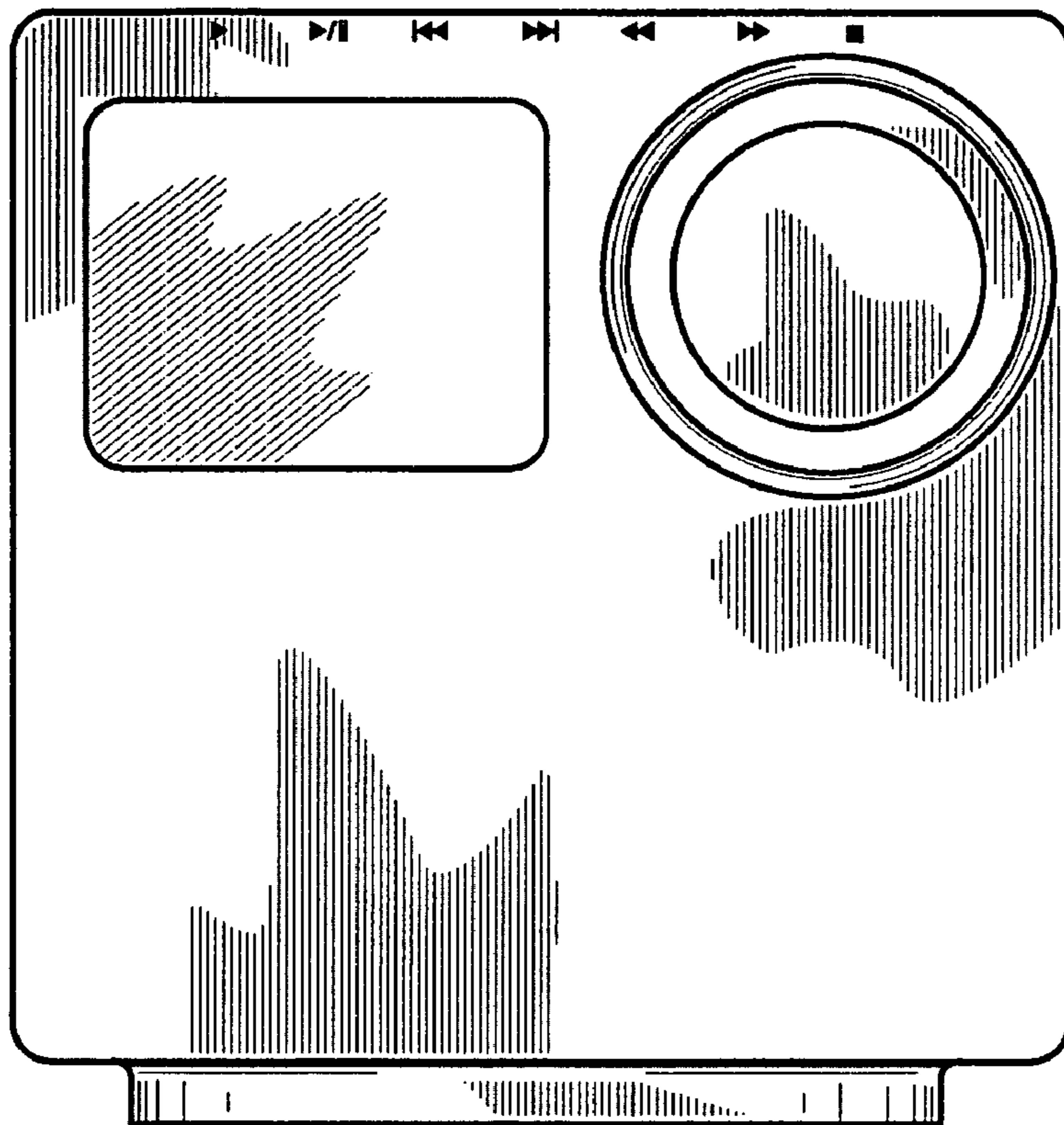

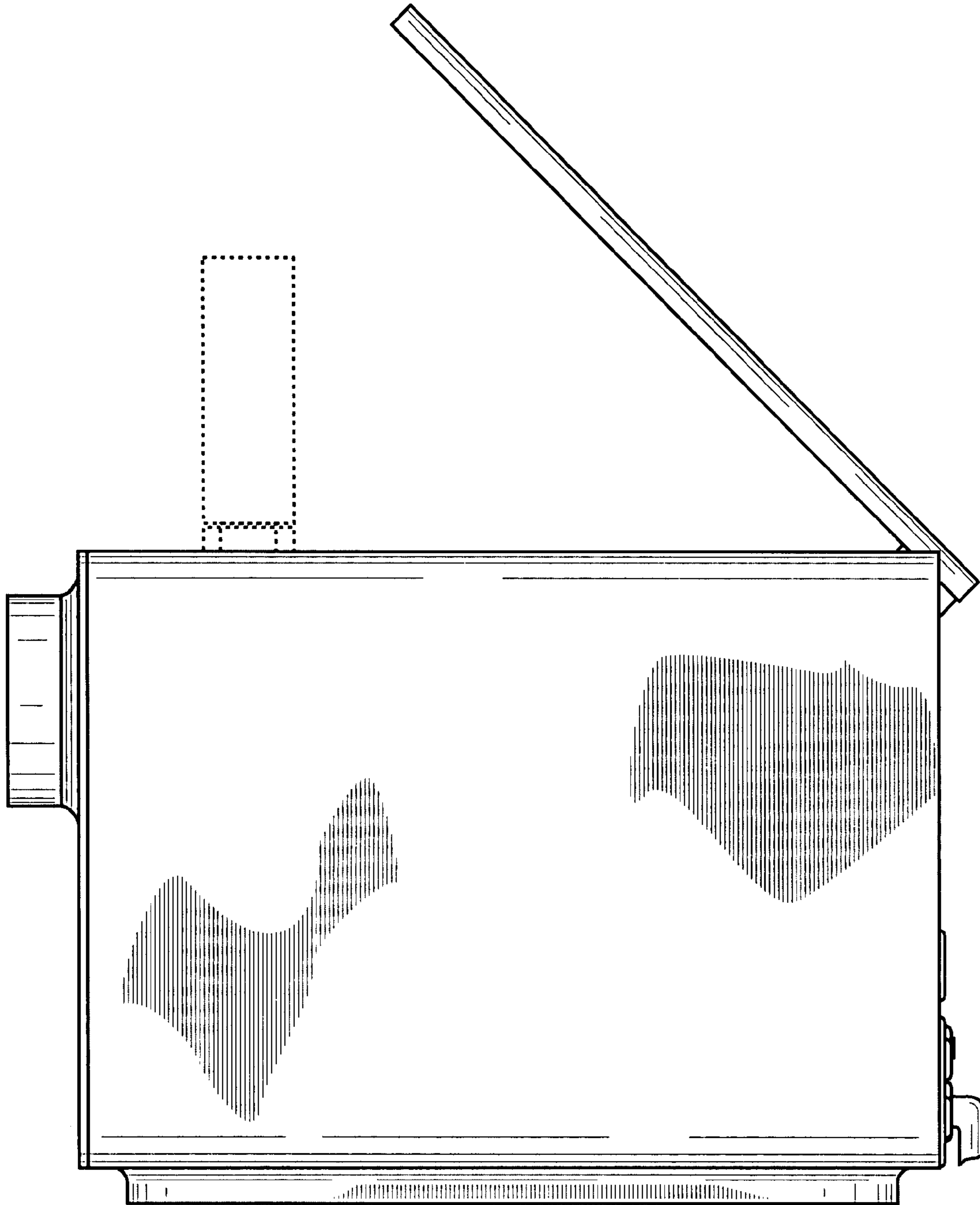

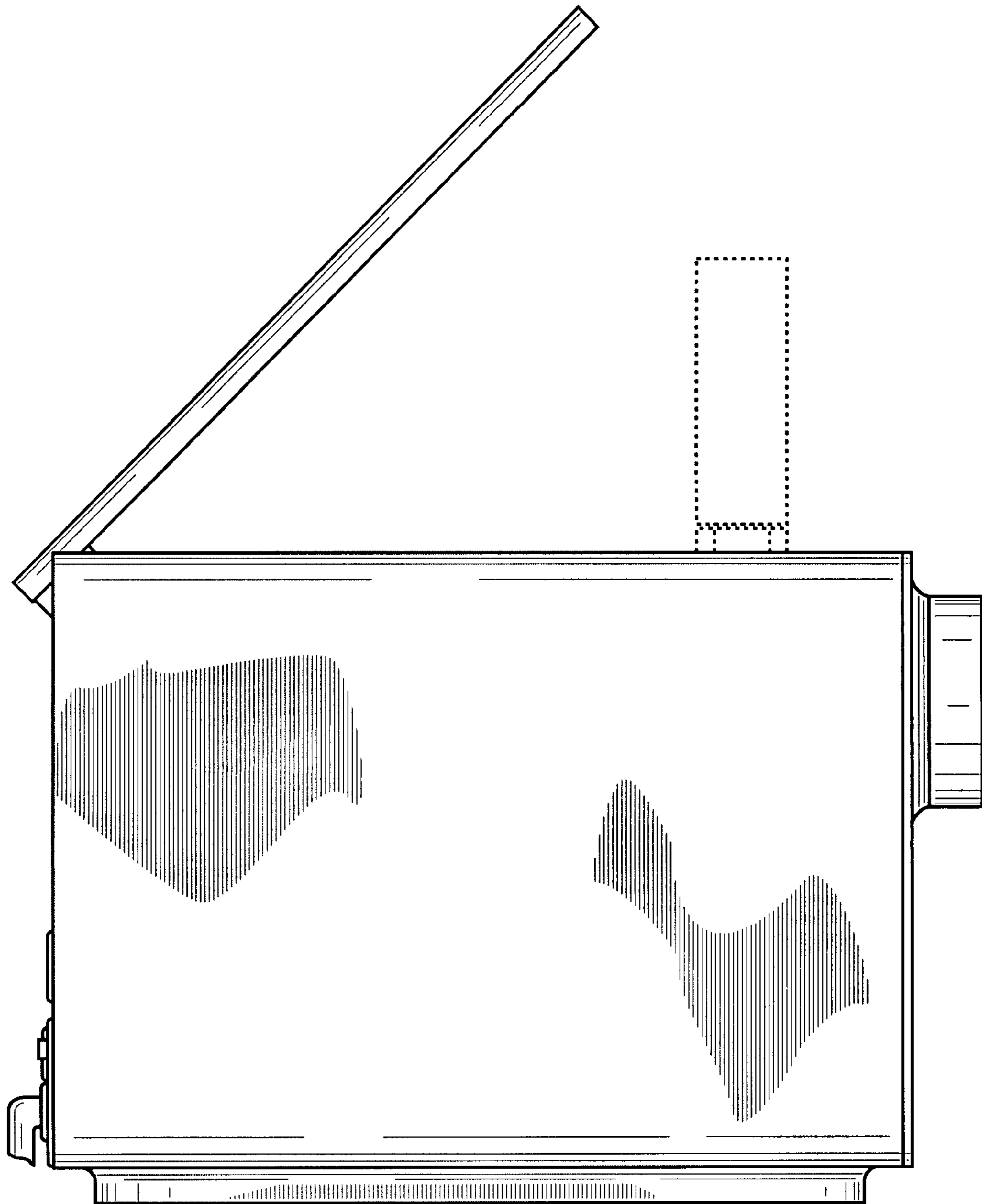

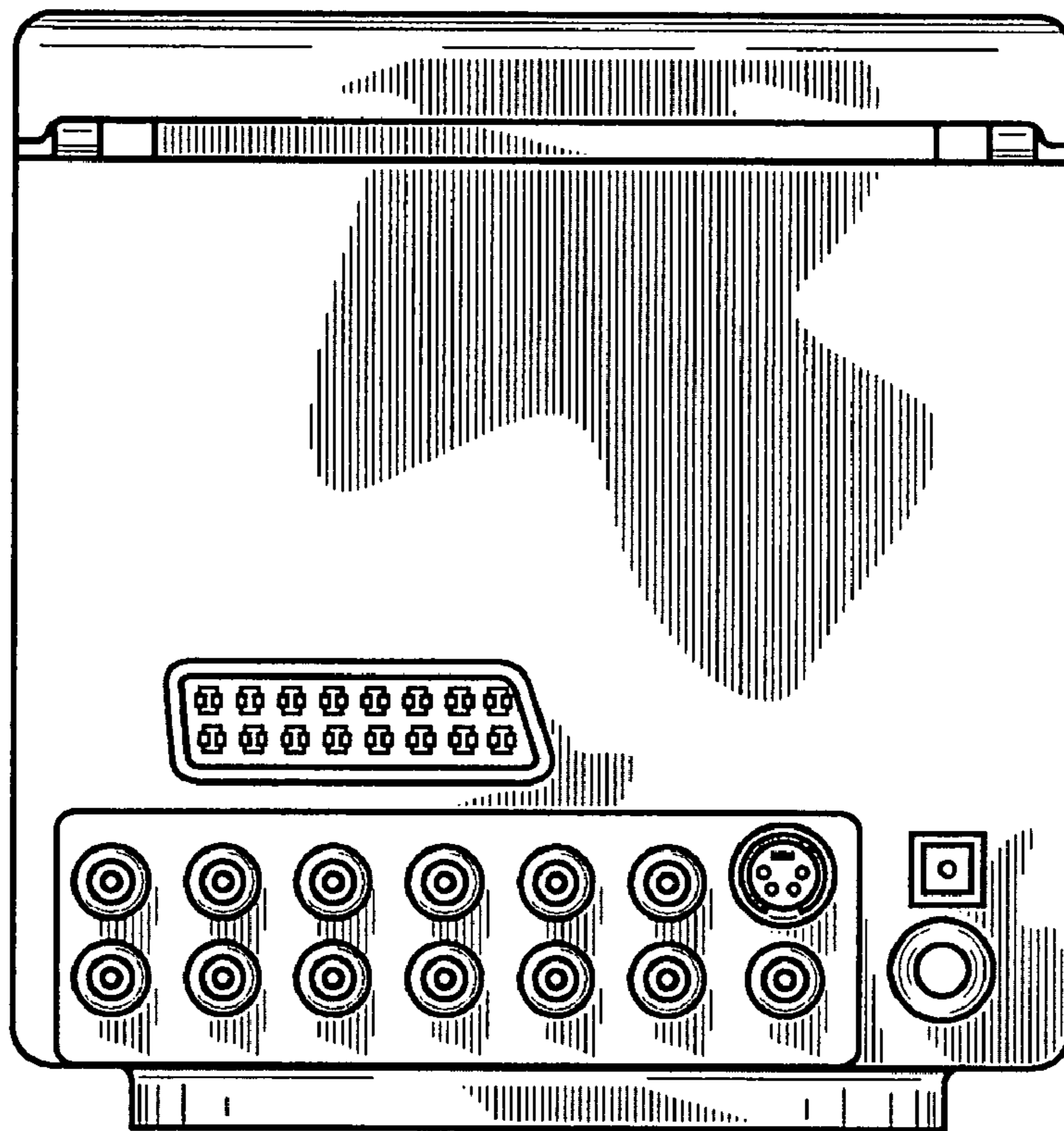

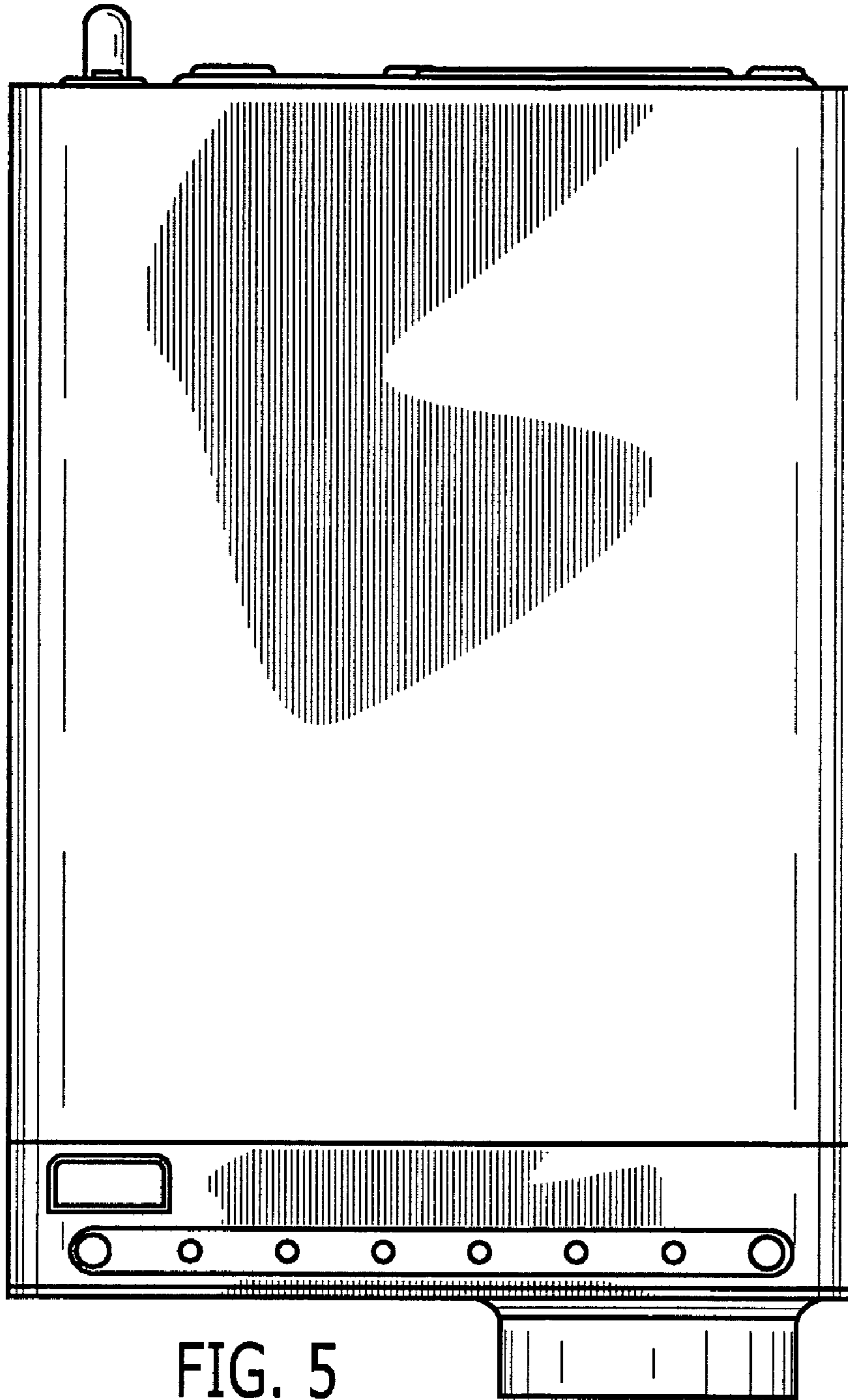

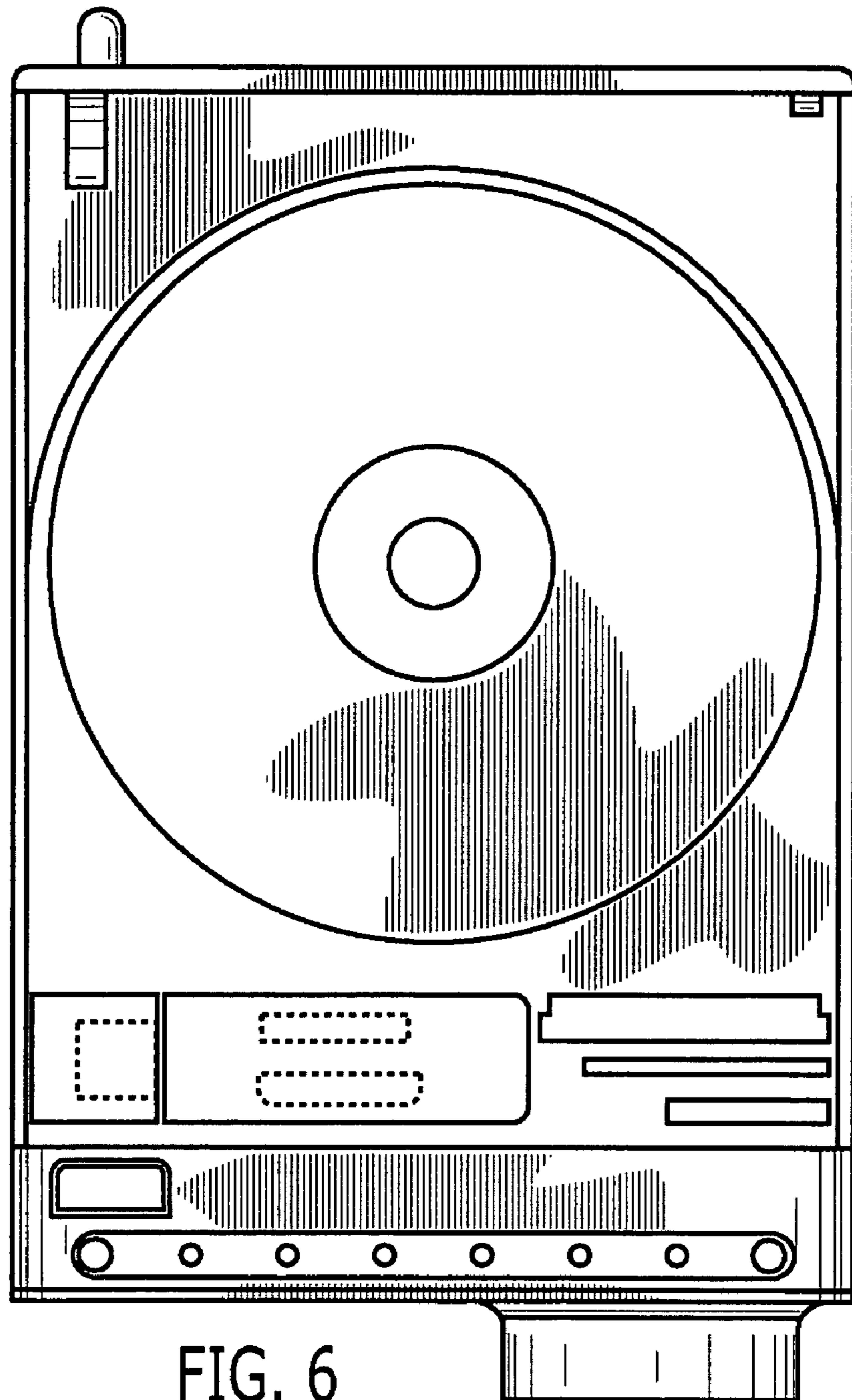

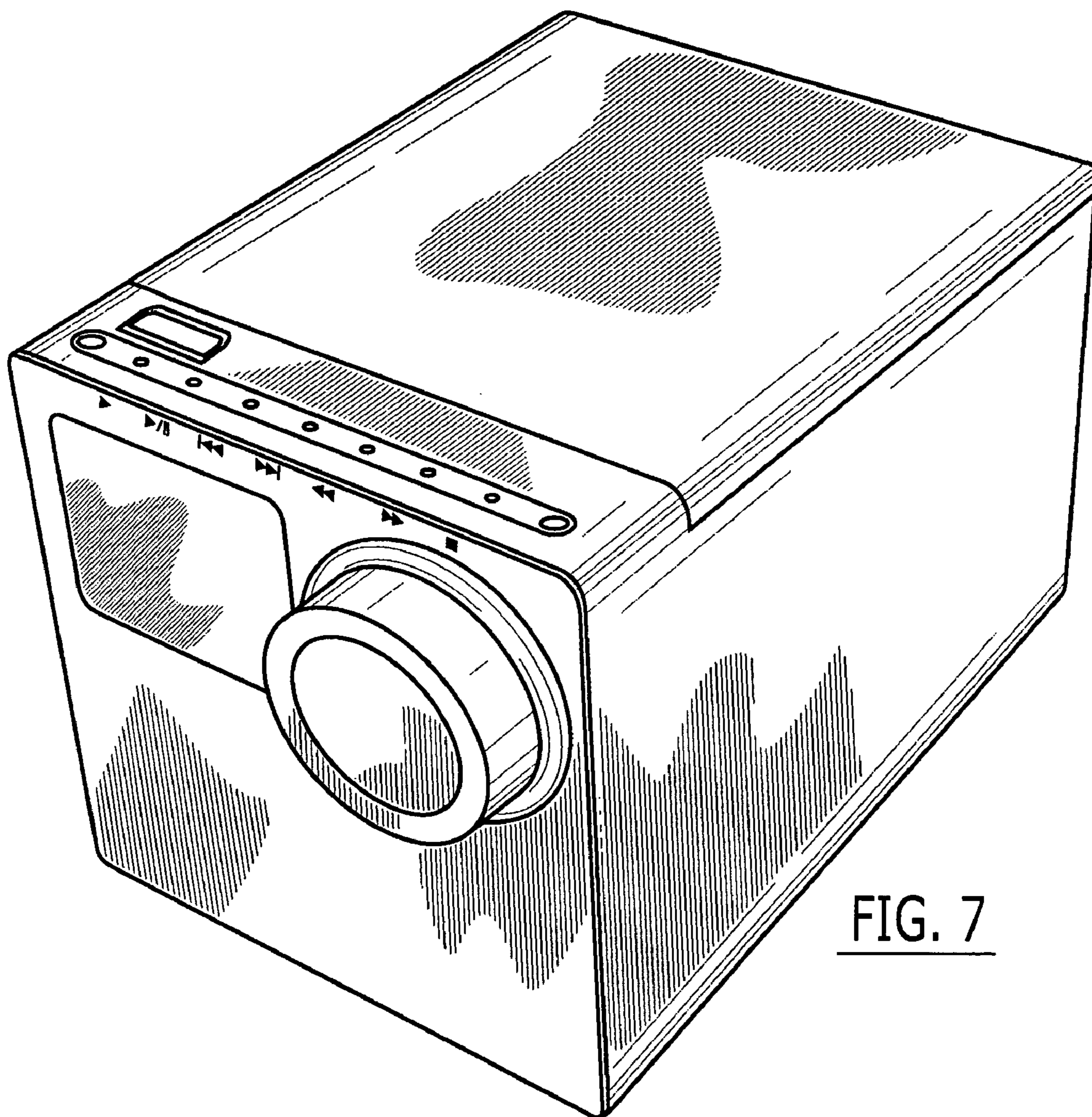

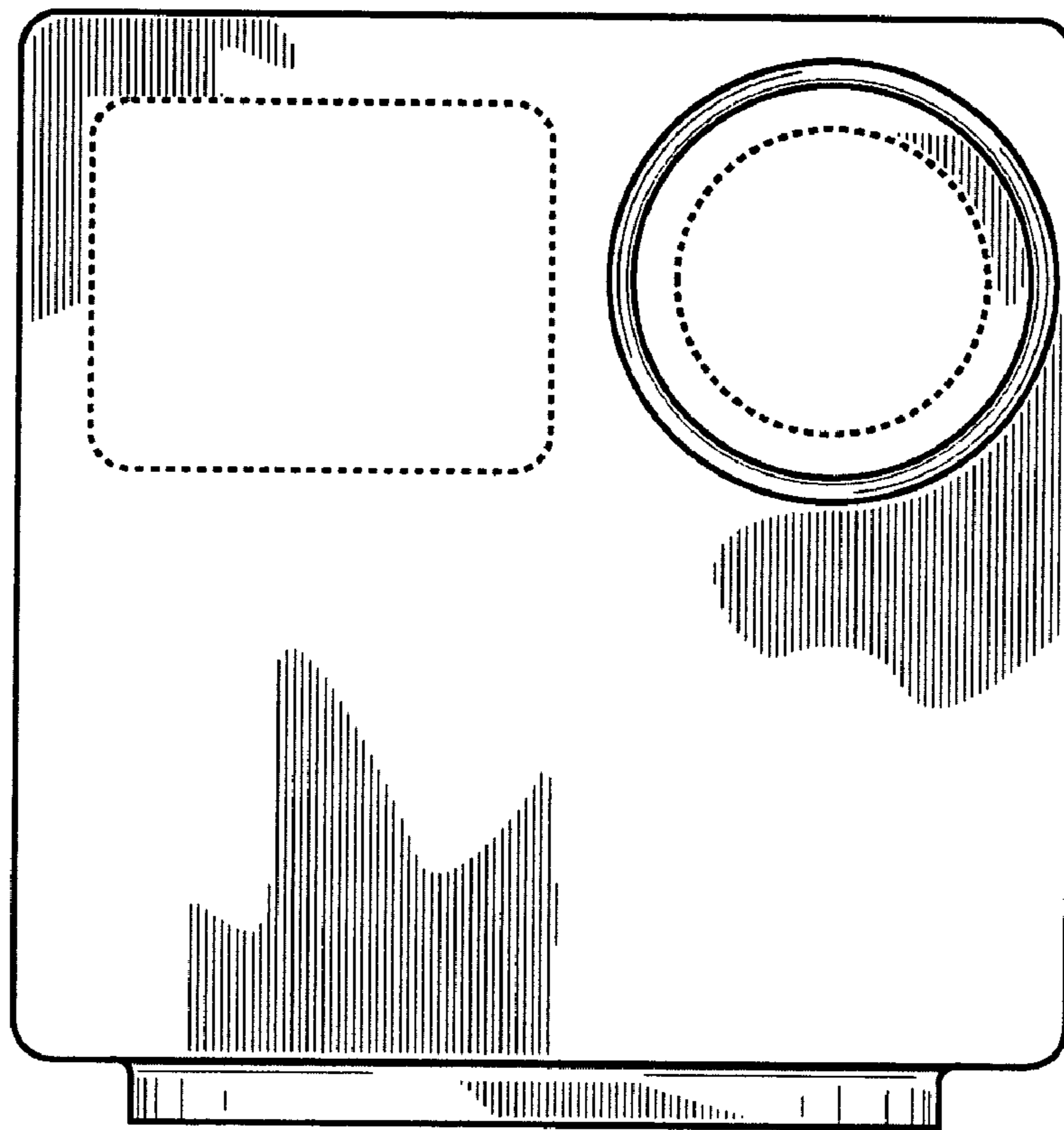

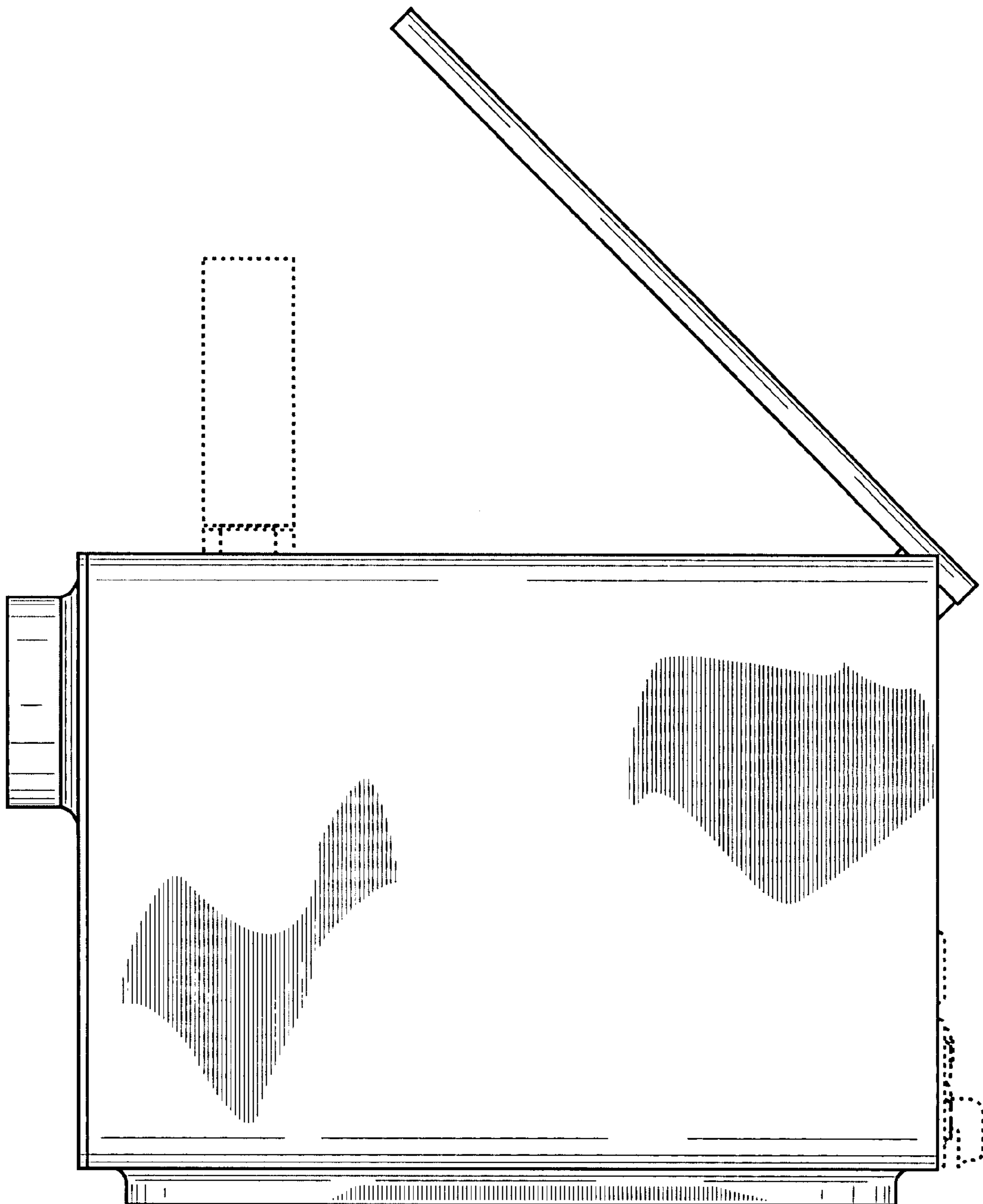

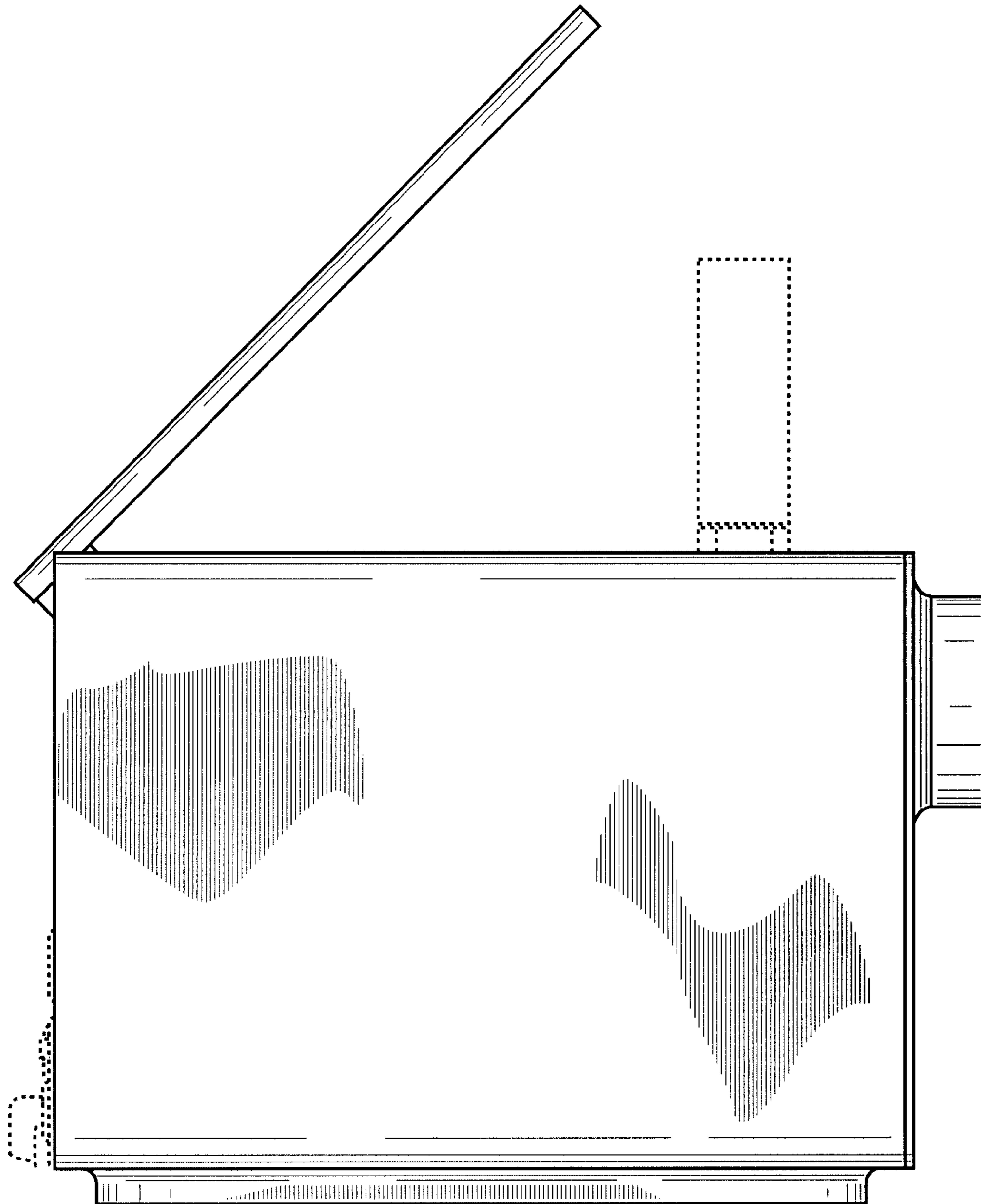

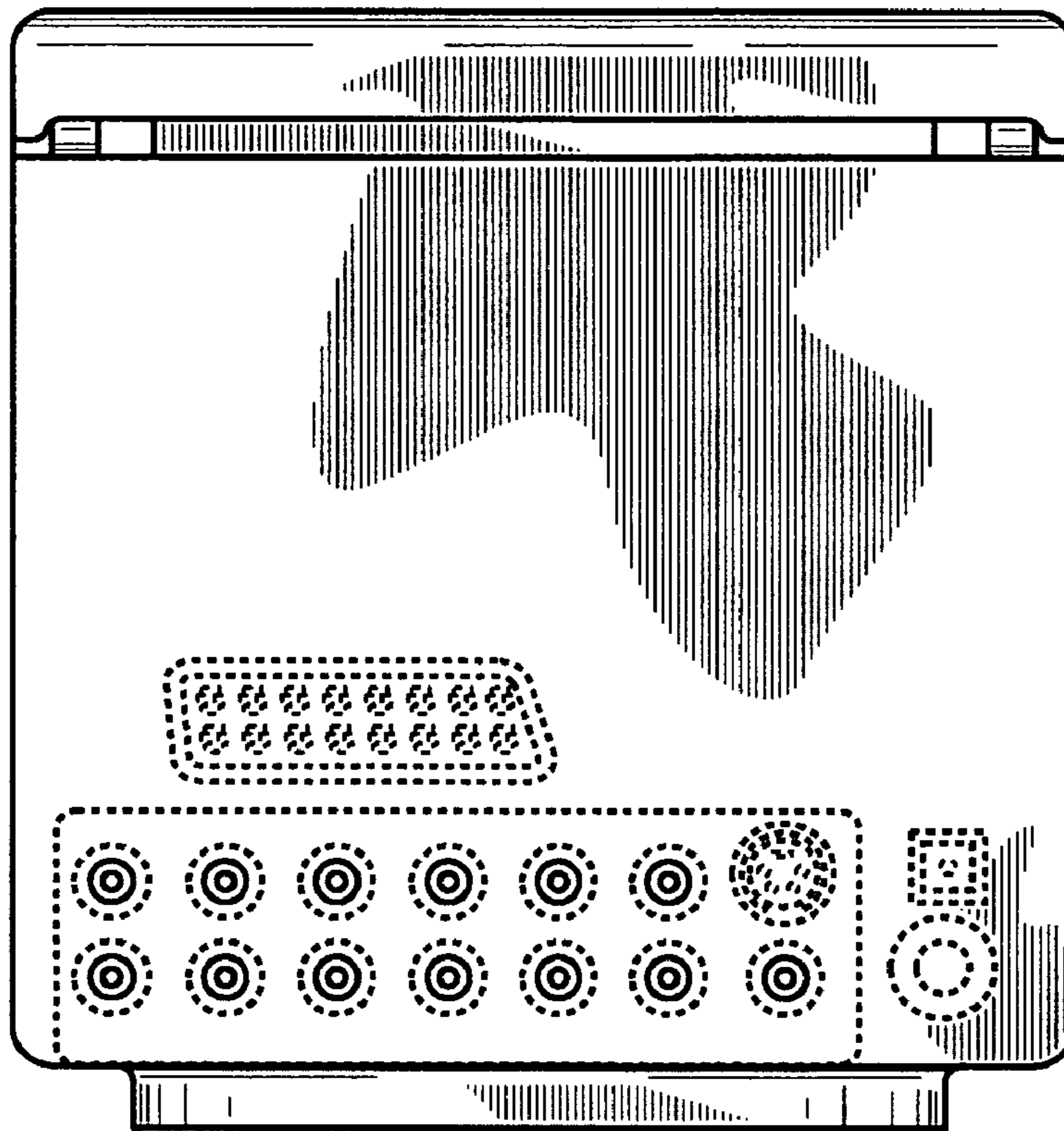

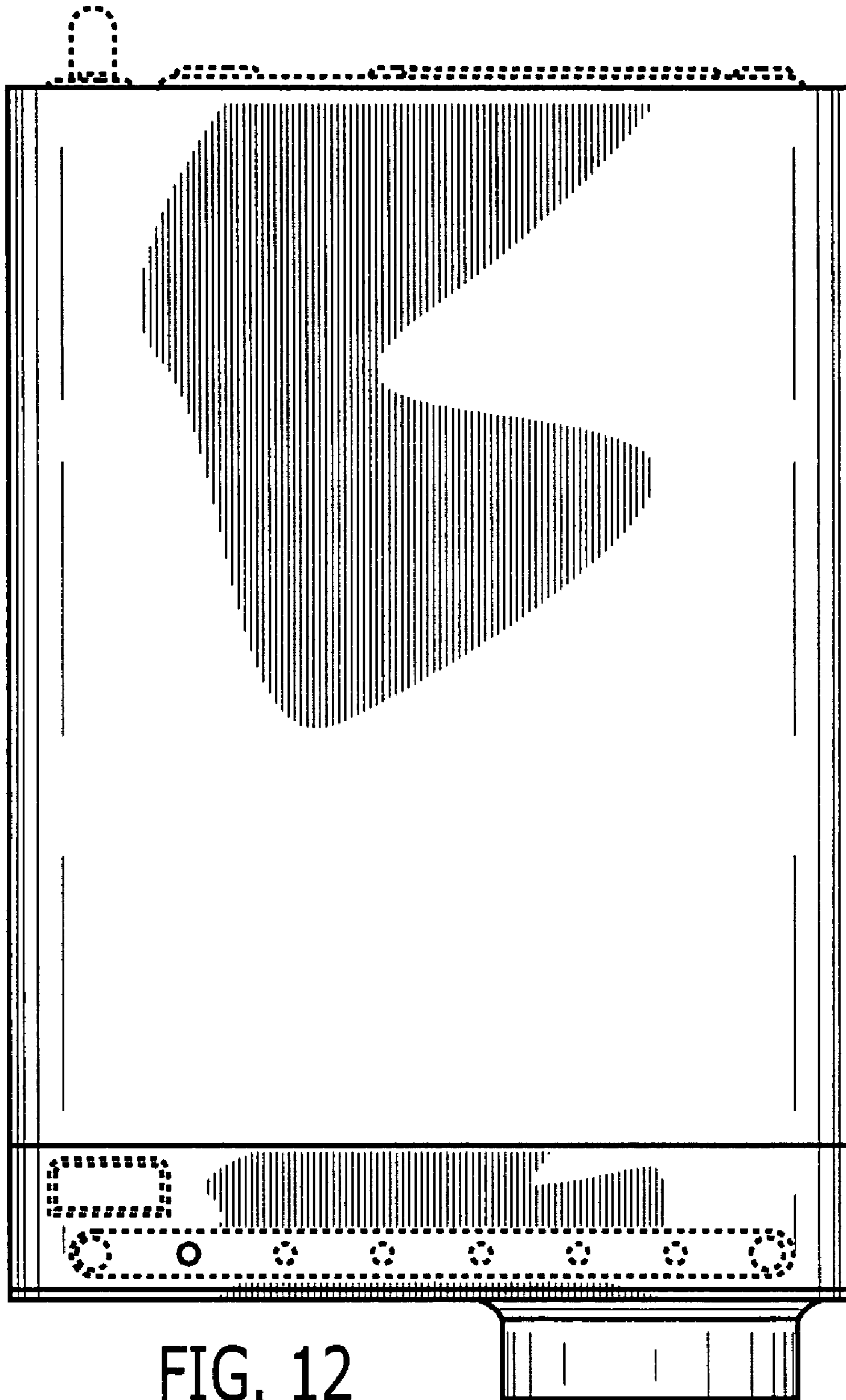

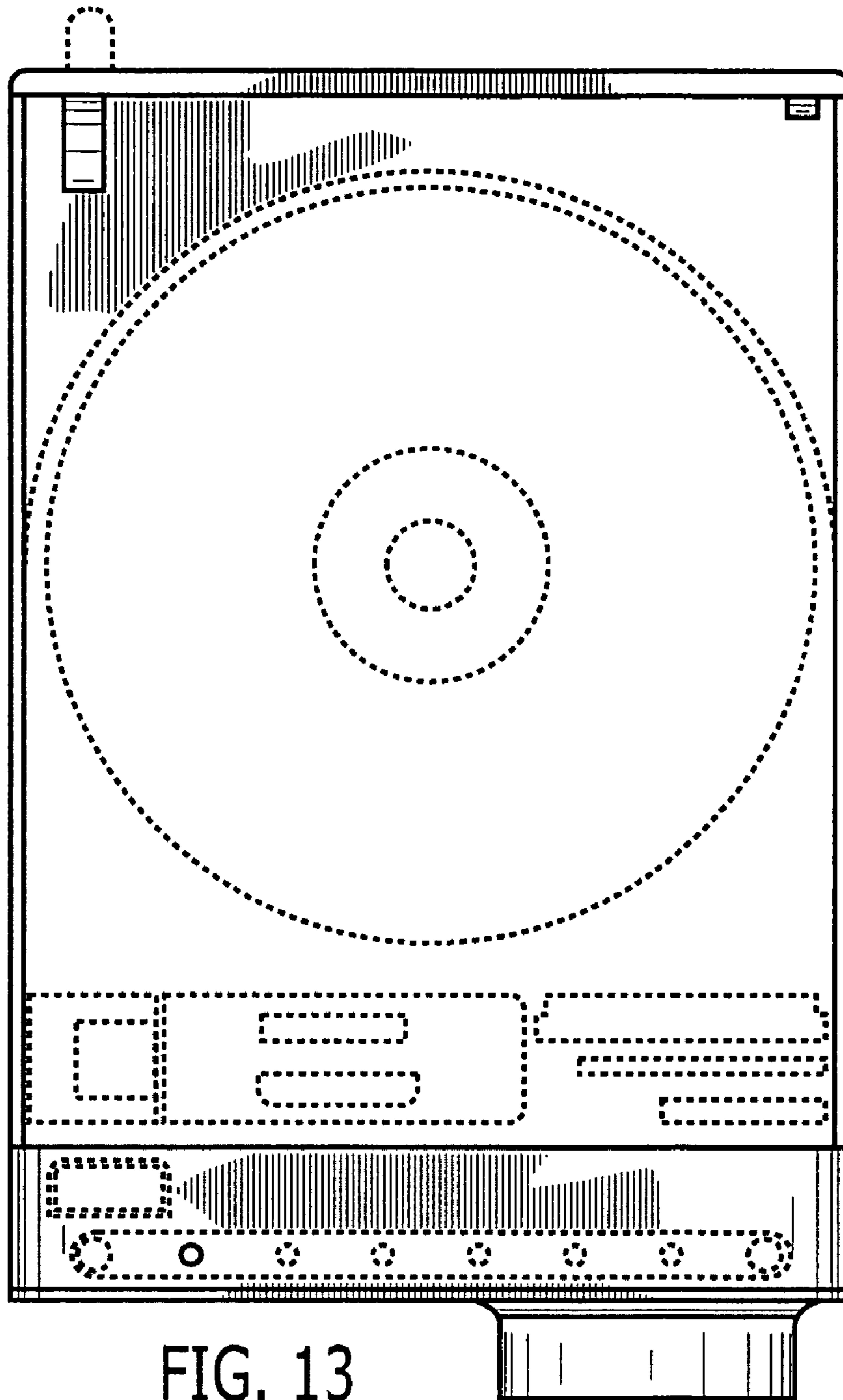

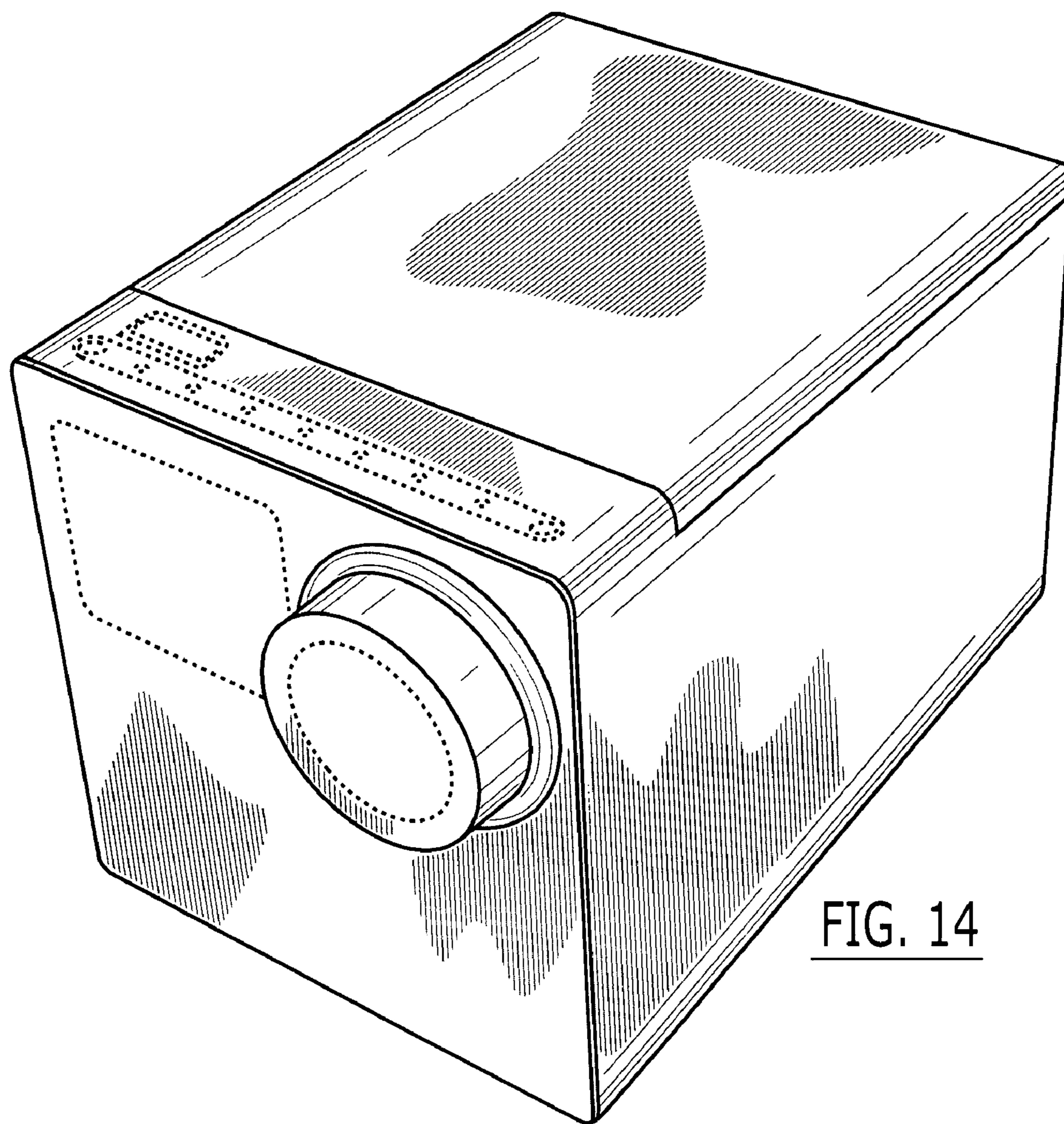
