FIG. 1 is an isometric view of the hanging file storage container of this invention;

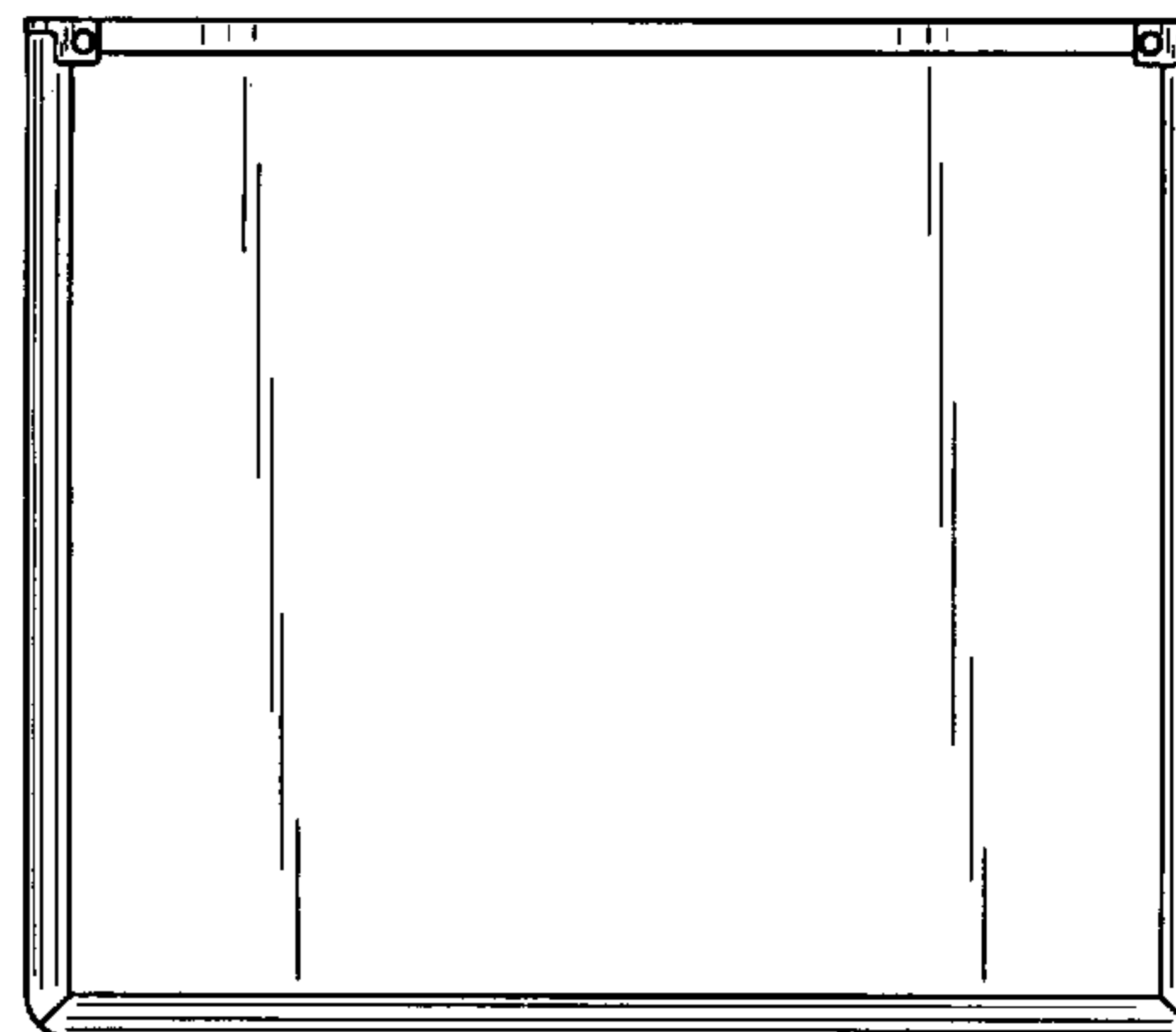
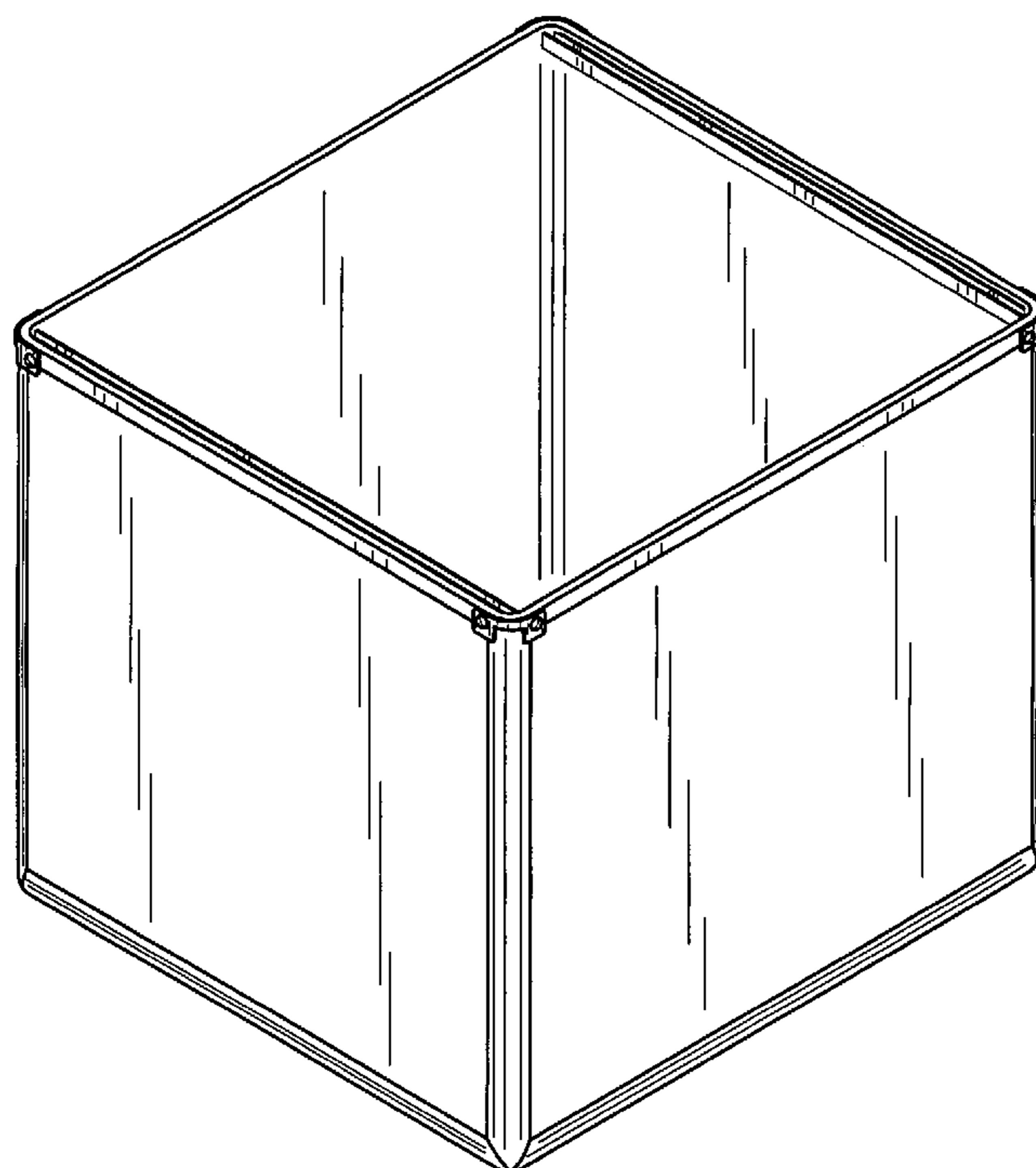
FIG. 2 is a front view, the rear view being a mirror image thereof;

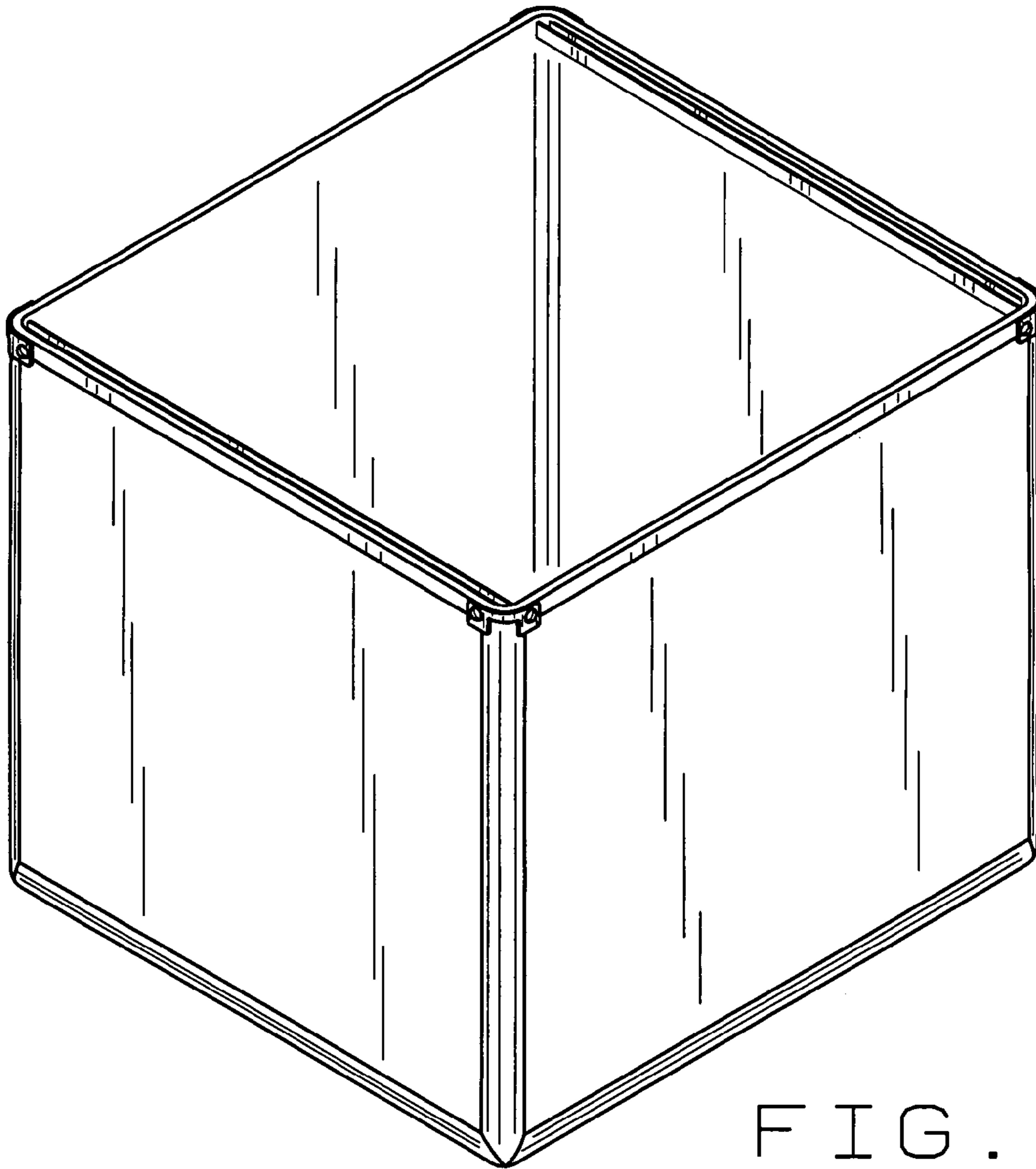

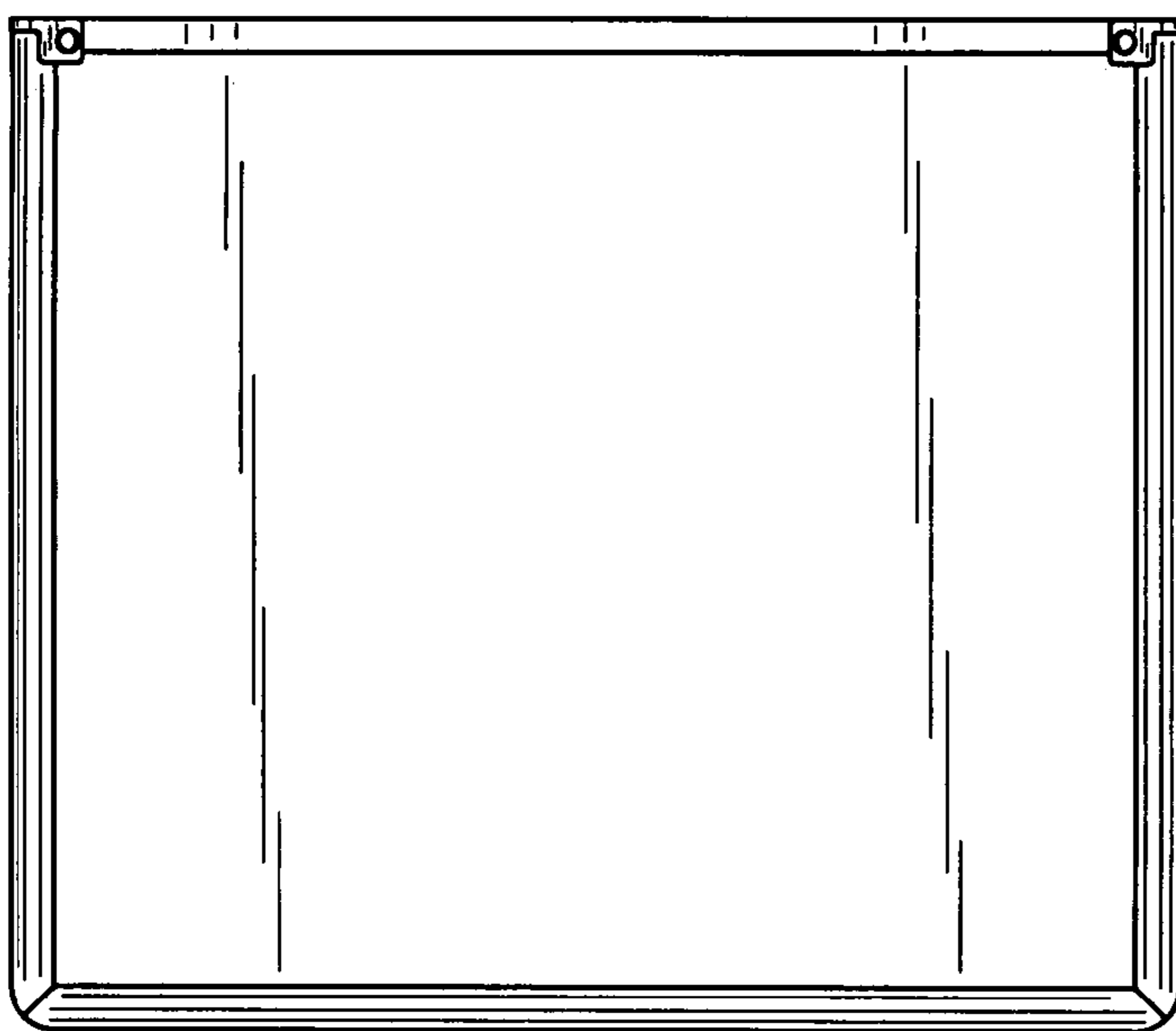

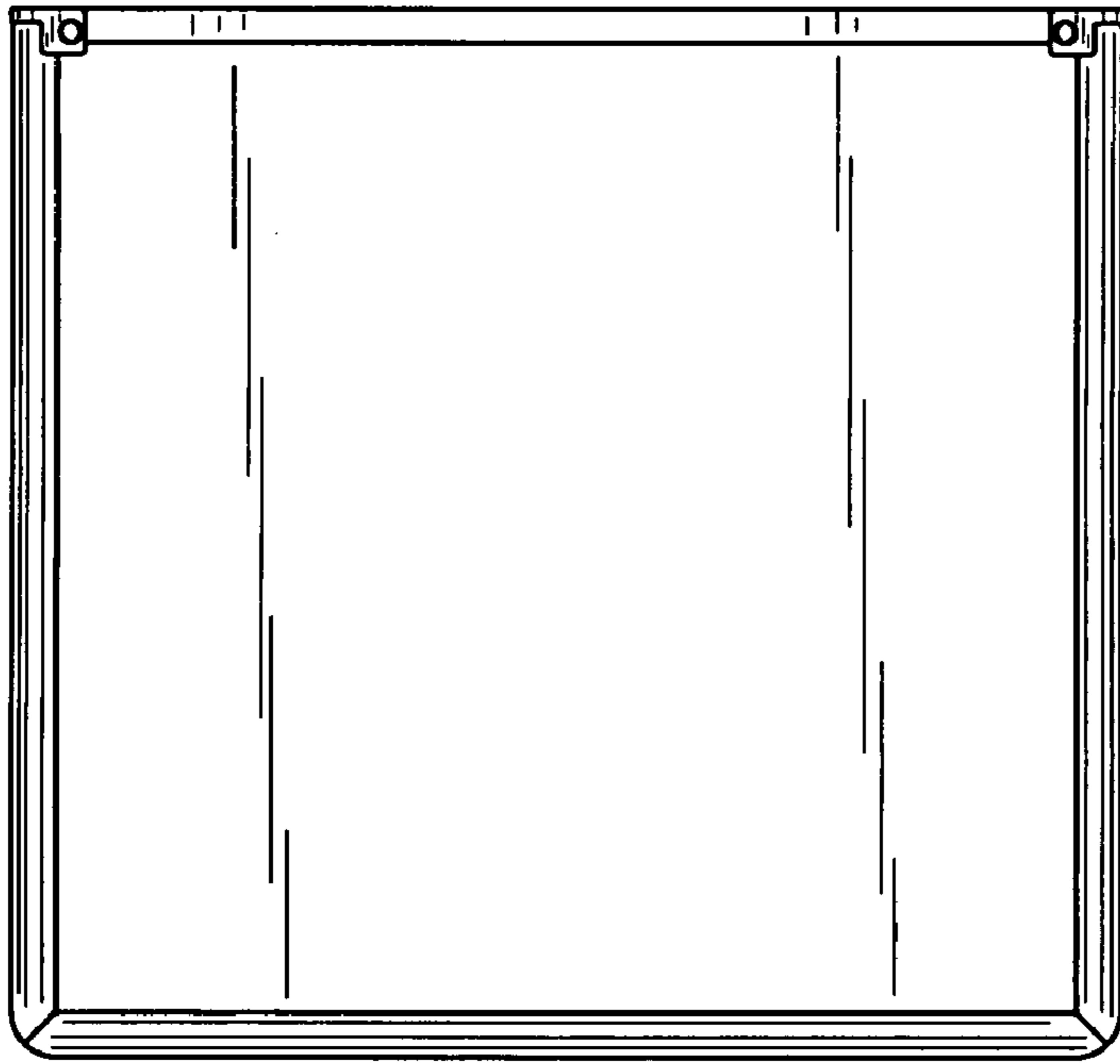

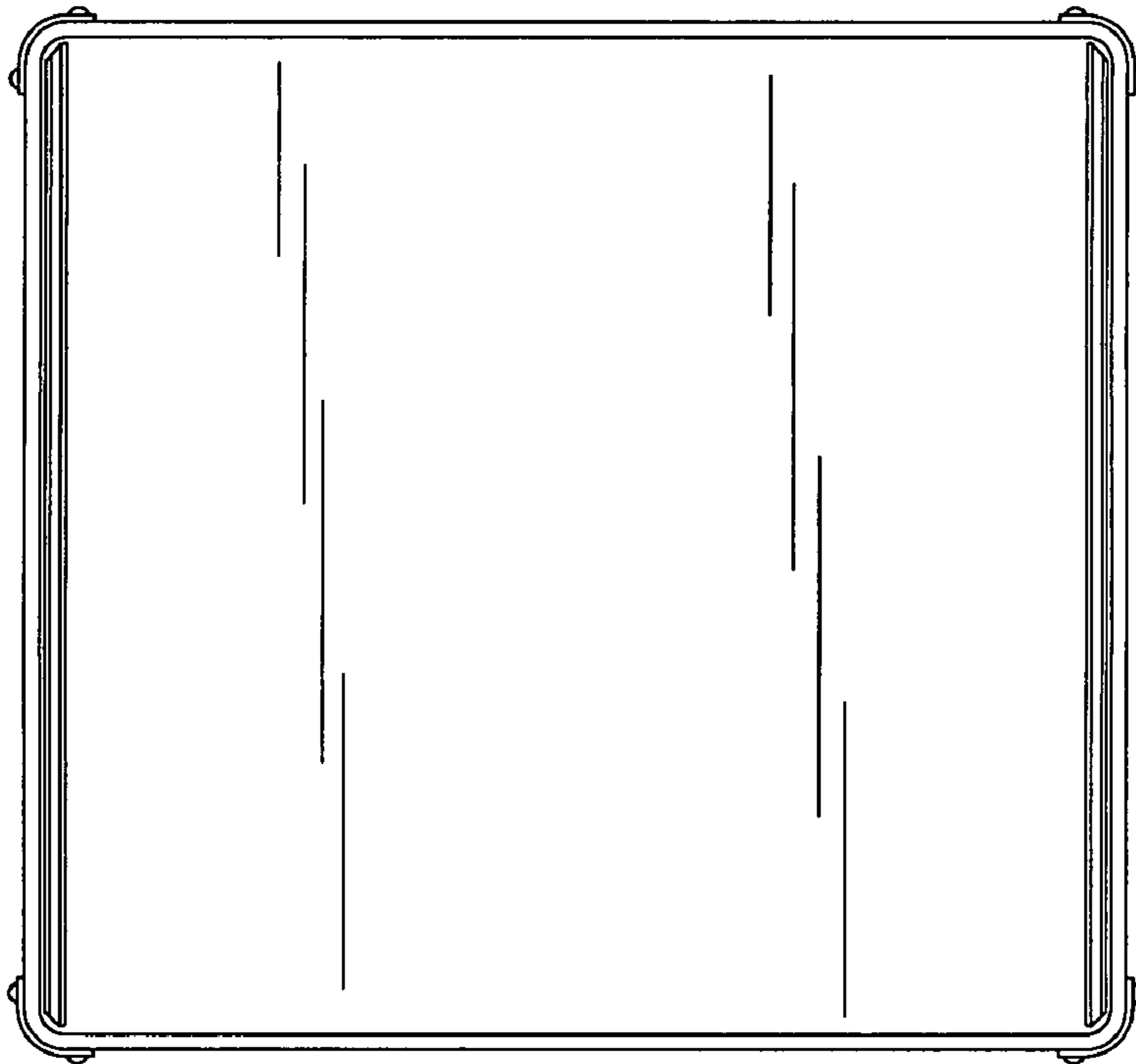

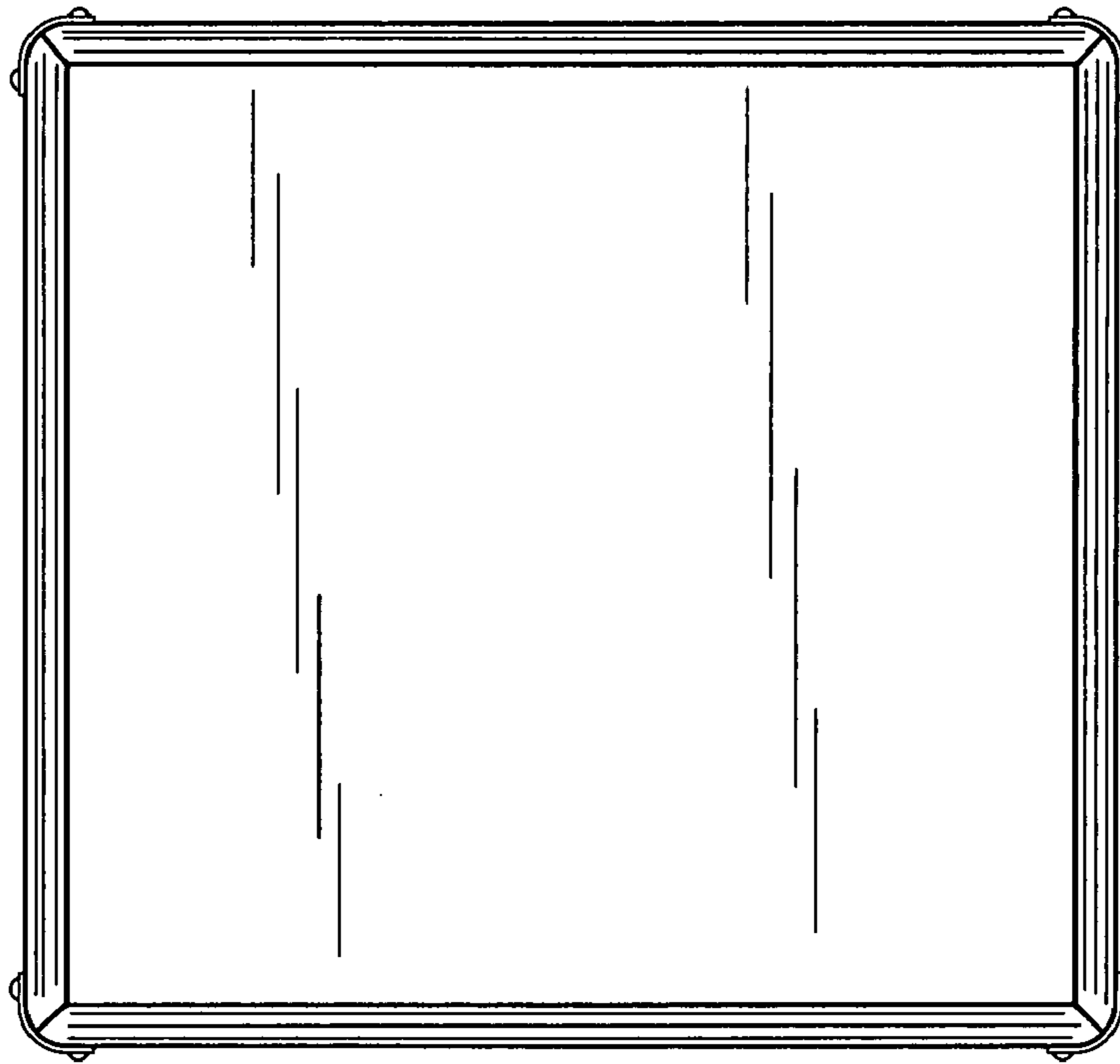
