DESCRIPTION

FIG. 1 is a perspective view of a new air purifier in accordance with the present invention;

FIG. 2 is a front elevational view of the air purifier of FIG. 1;

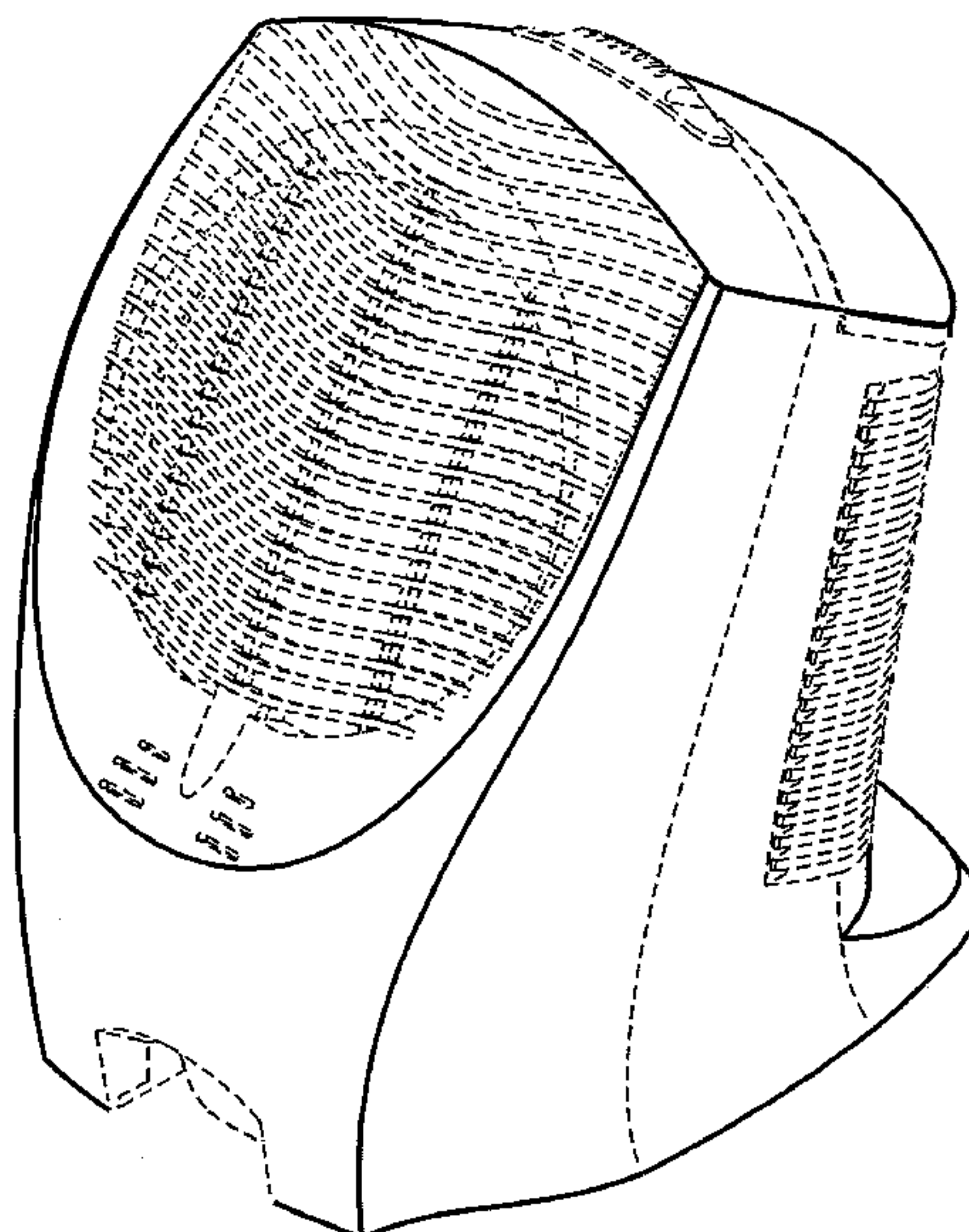
FIG. 3 is a right side elevational view of the air purifier of FIG. 1, the left side being a mirror image thereof;

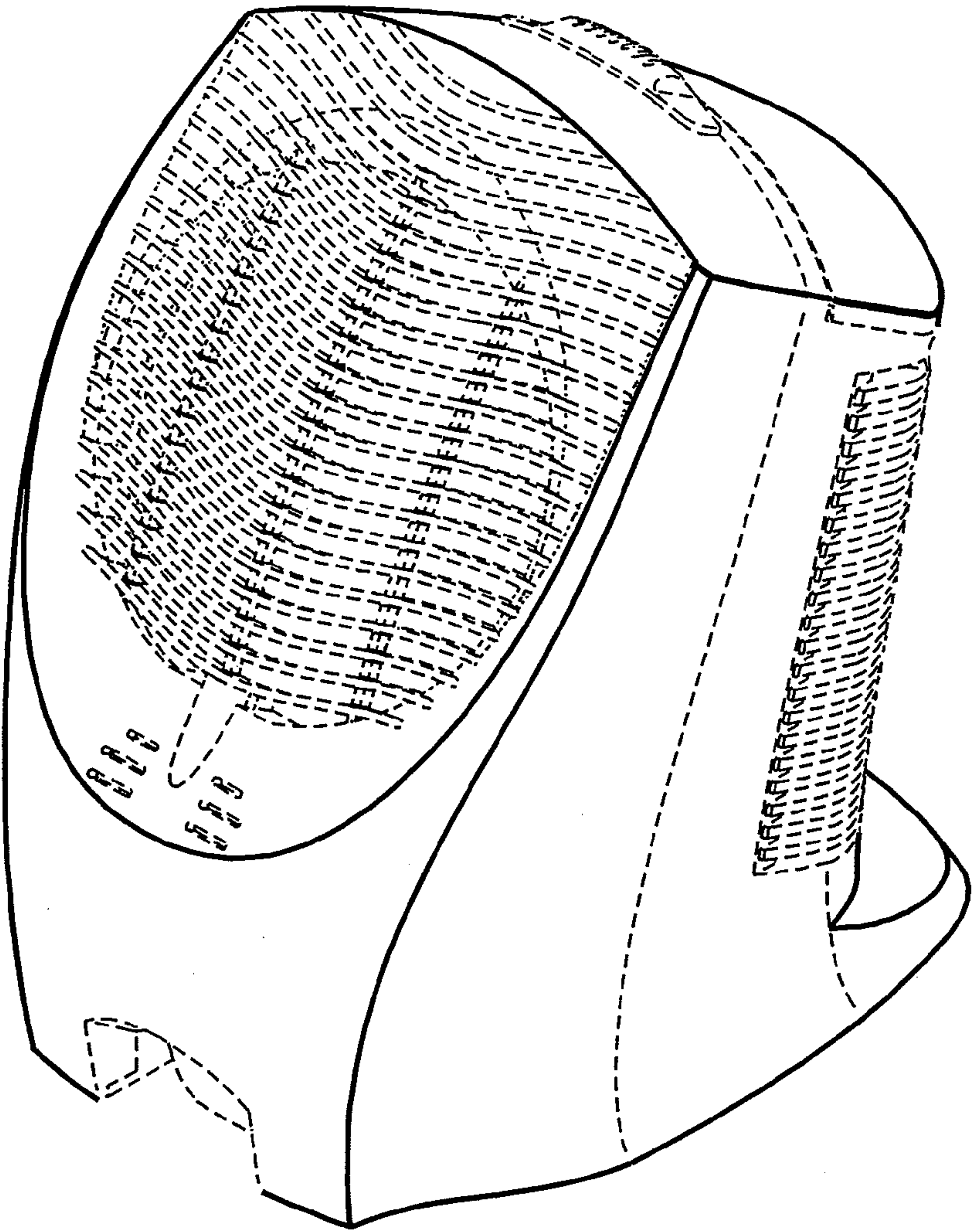

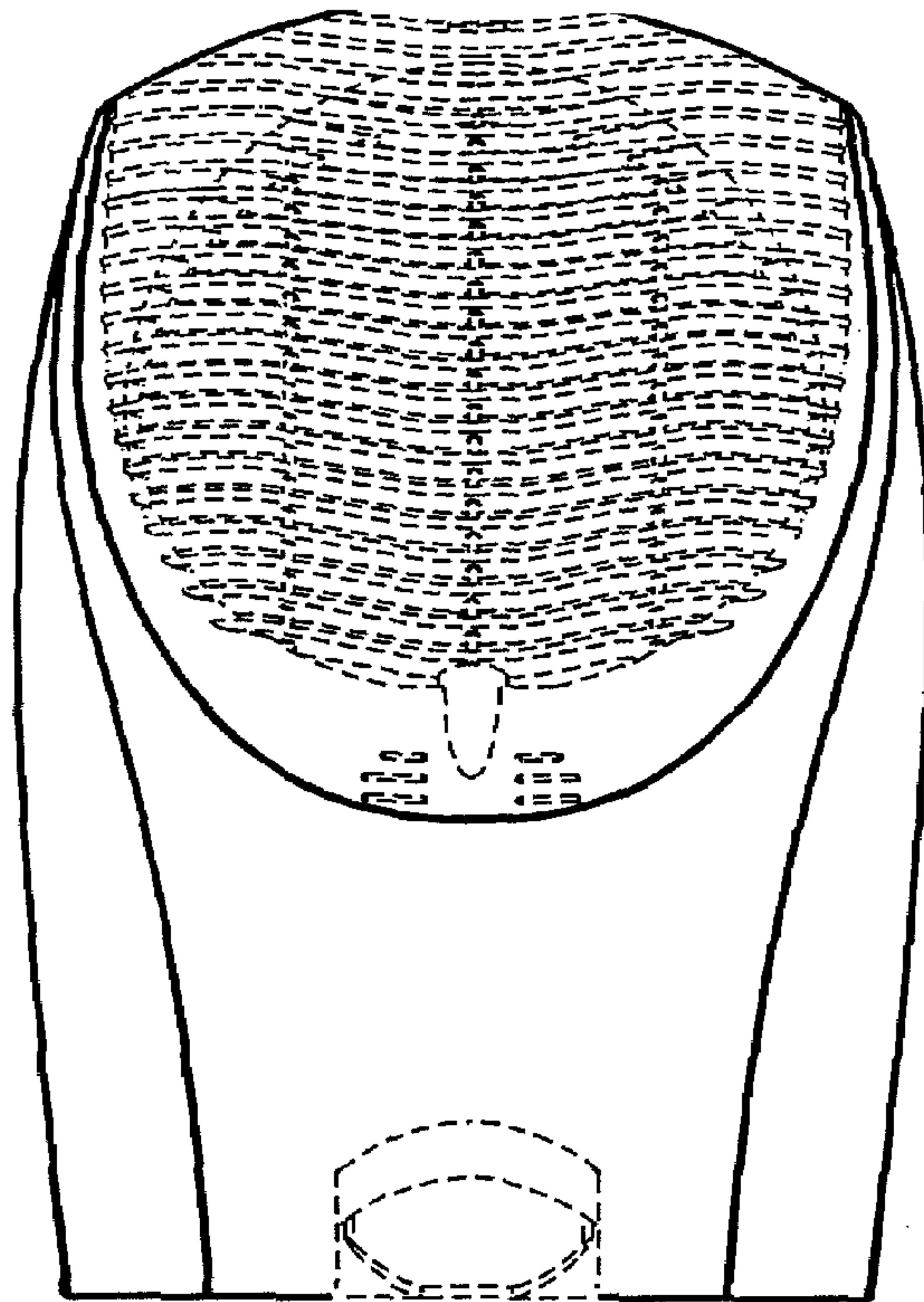
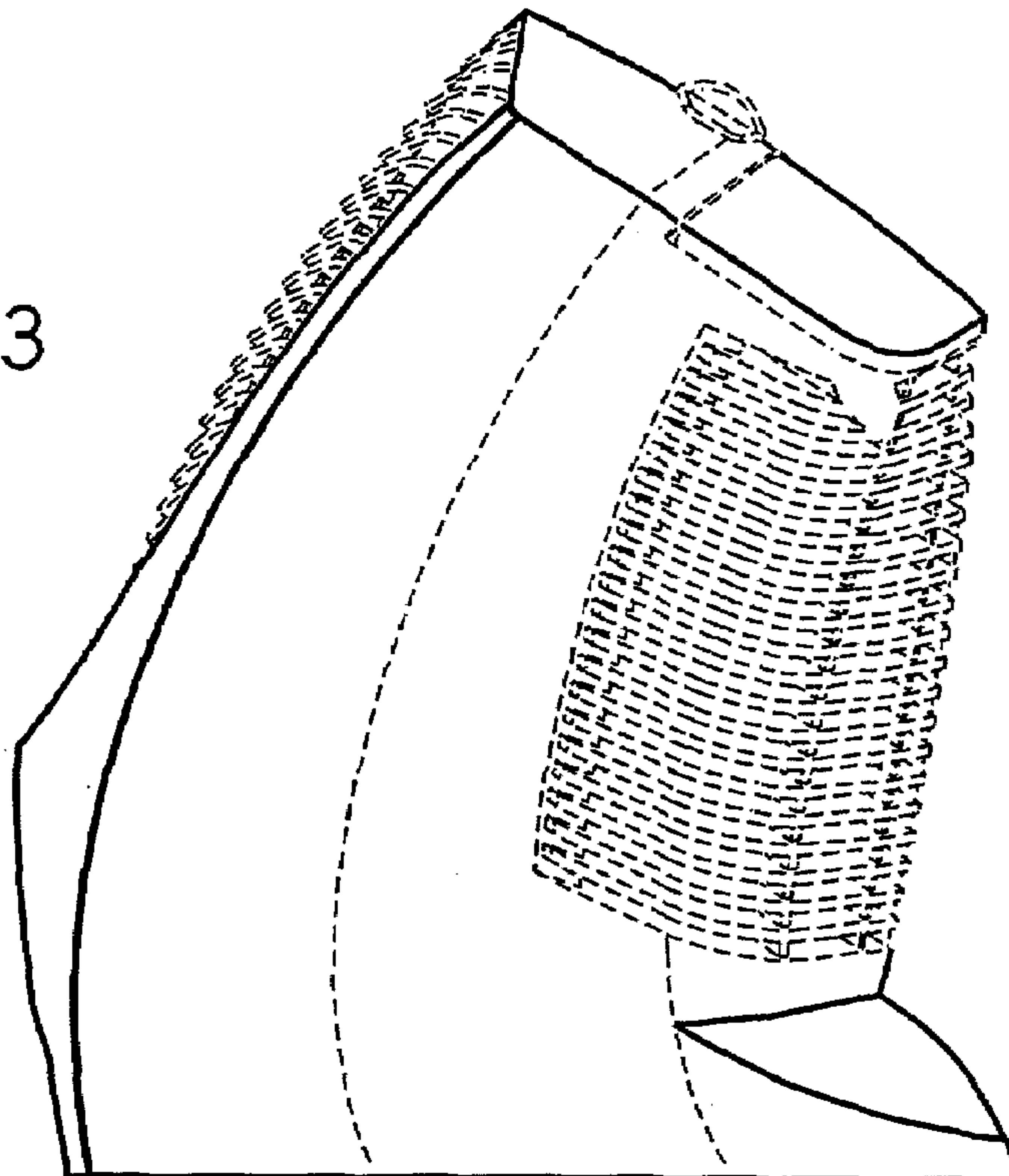

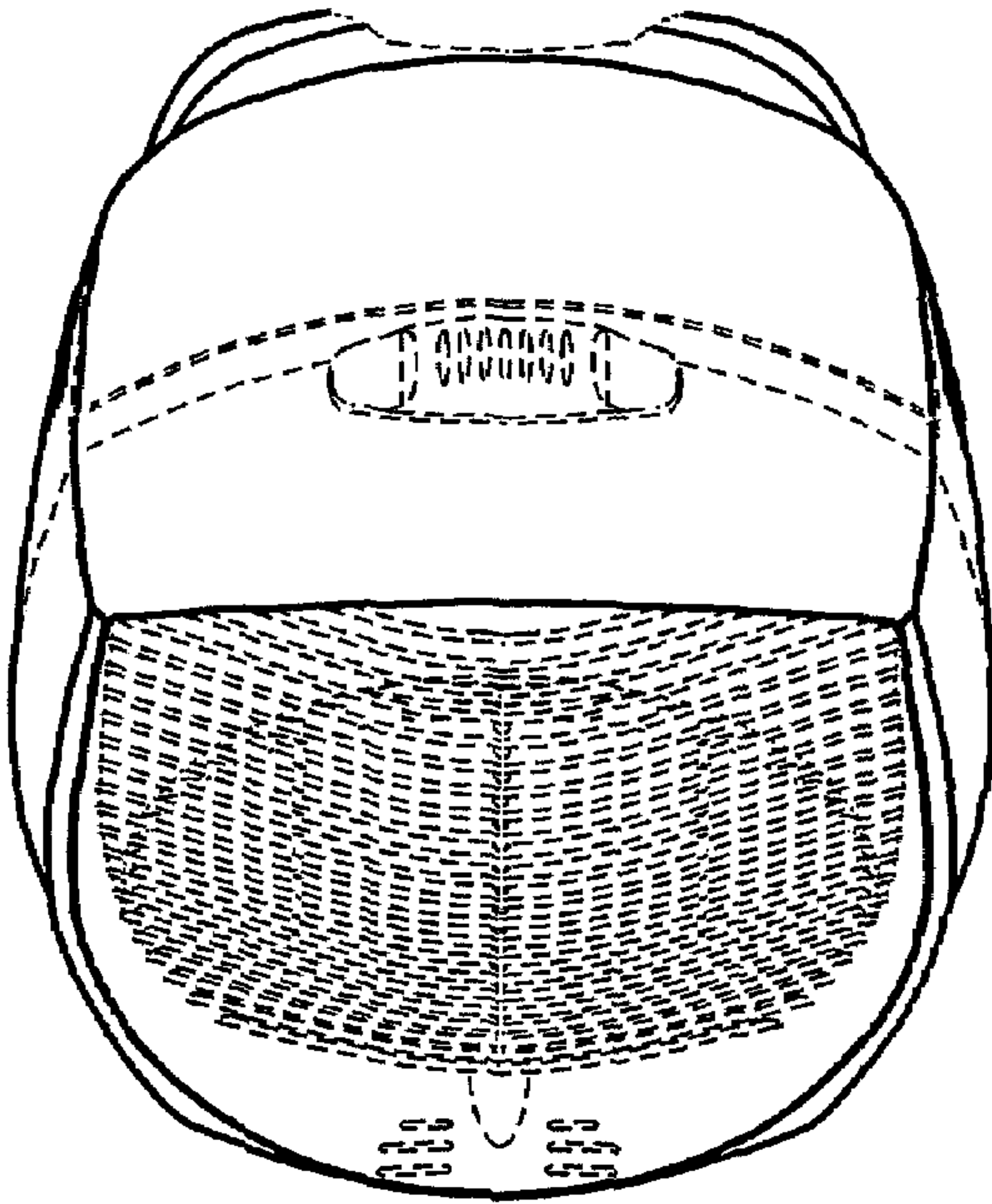
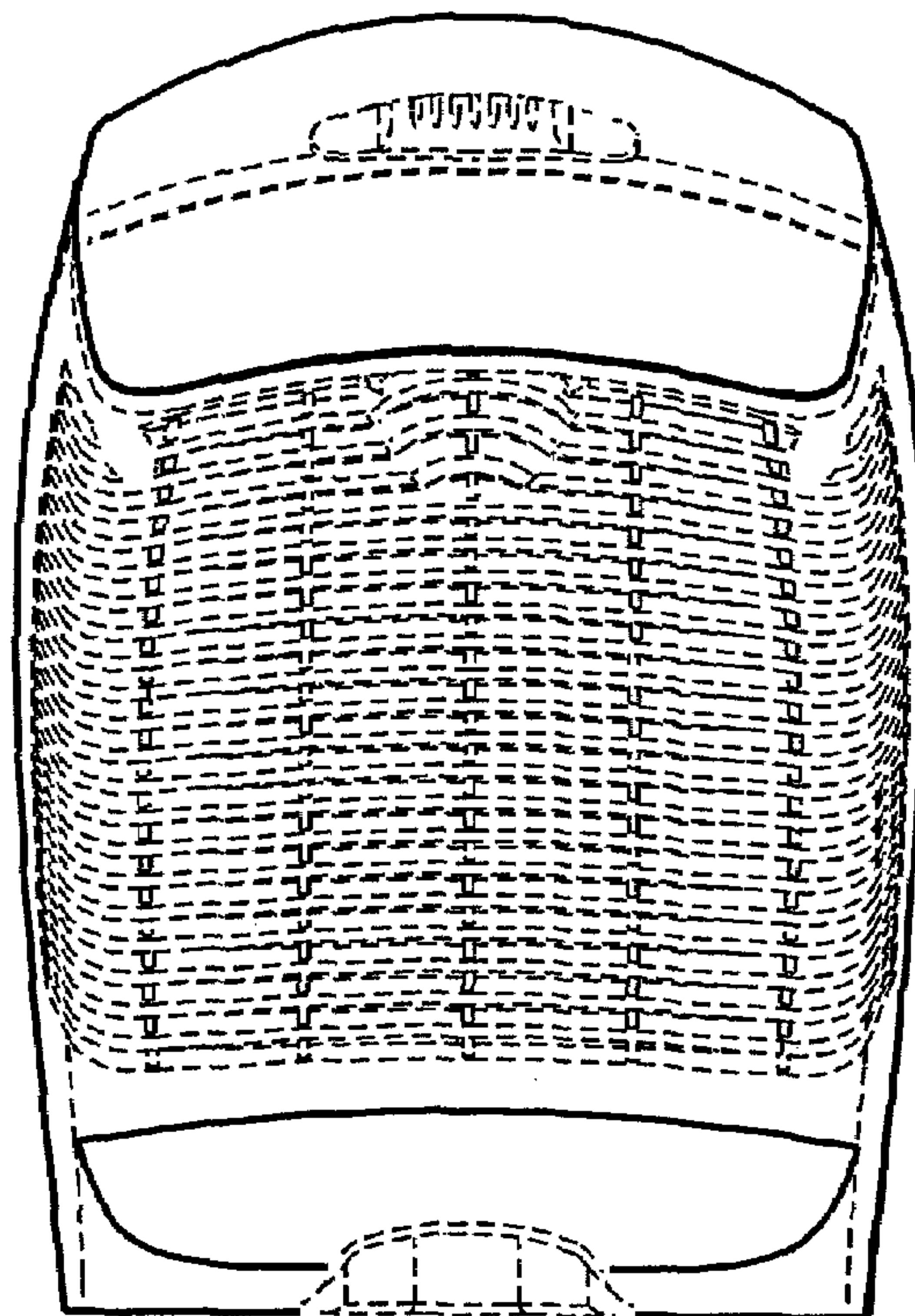

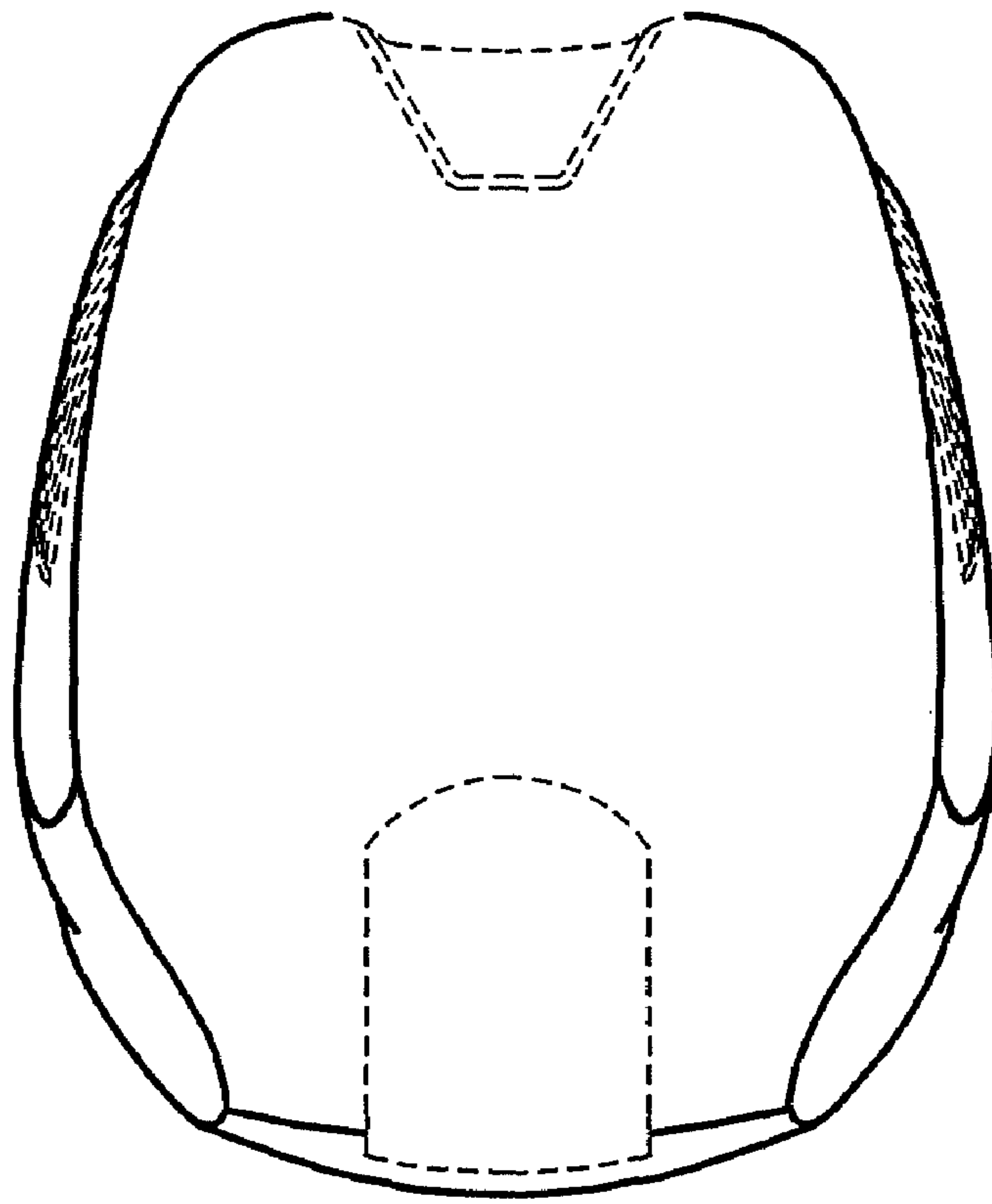
