FIG. 6 is a top view of the toothbrush sanitizer, as shown in FIG. 1;

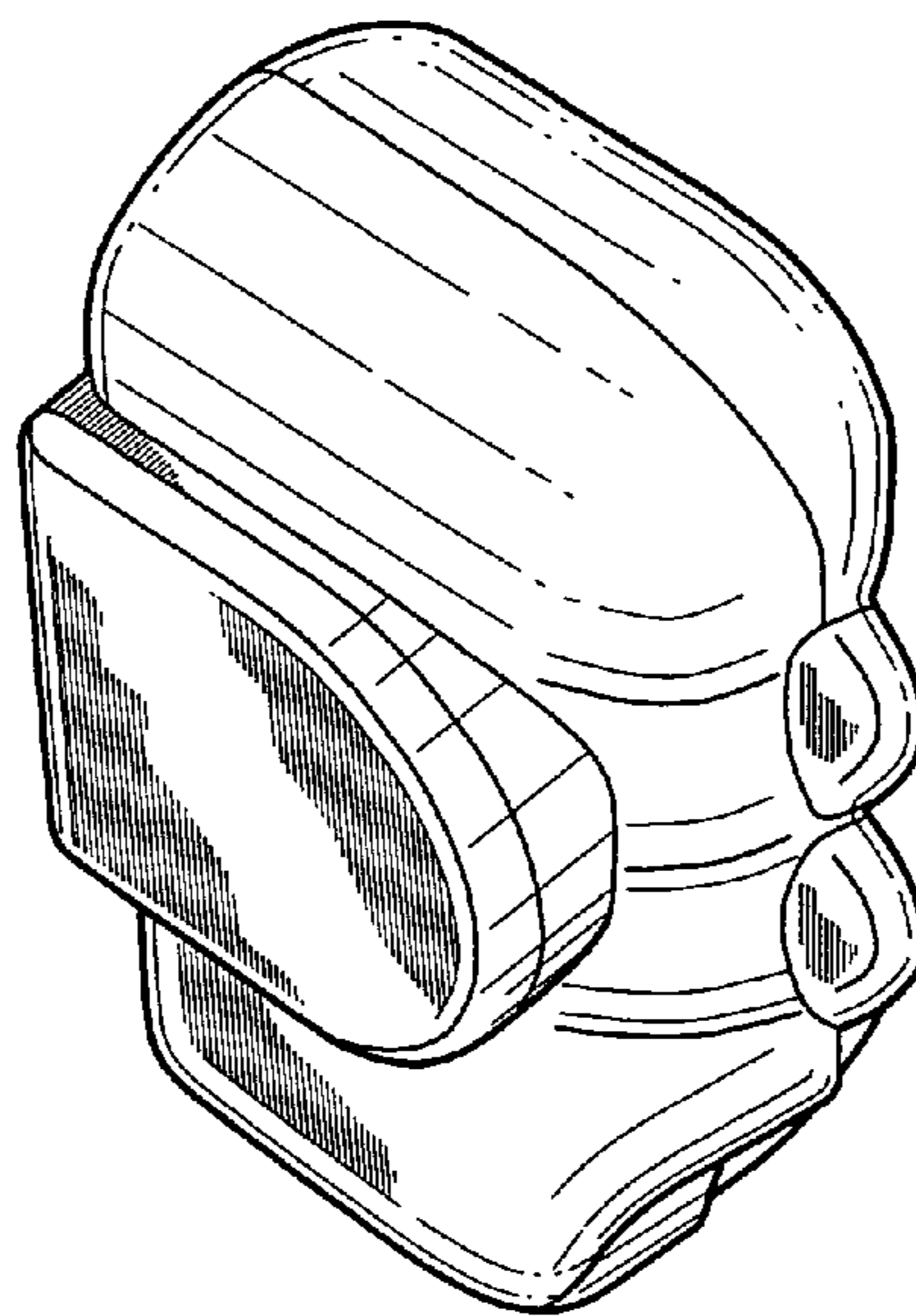
FIG. 7 is a bottom view of the toothbrush sanitizer, as shown in FIG. 1;

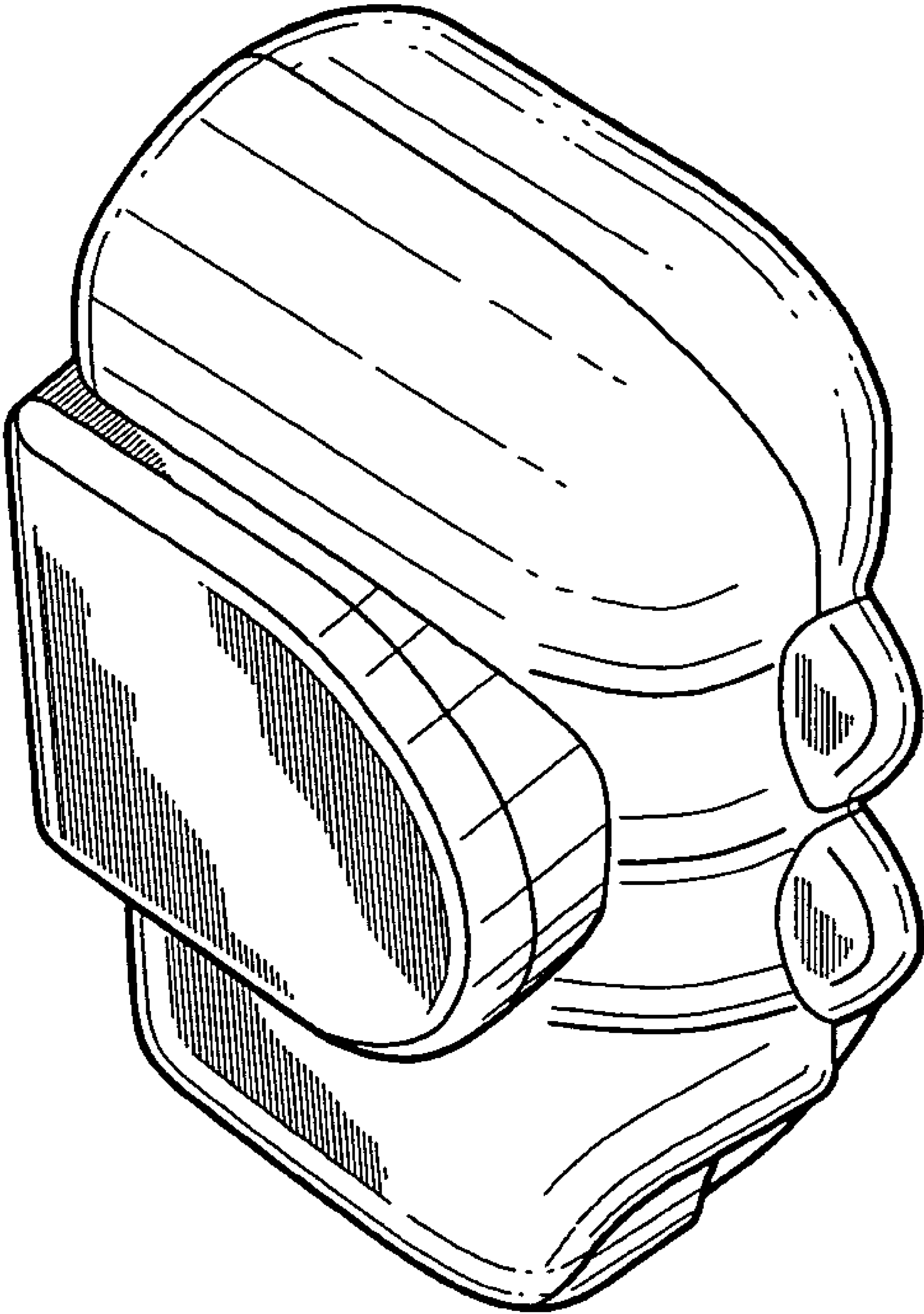

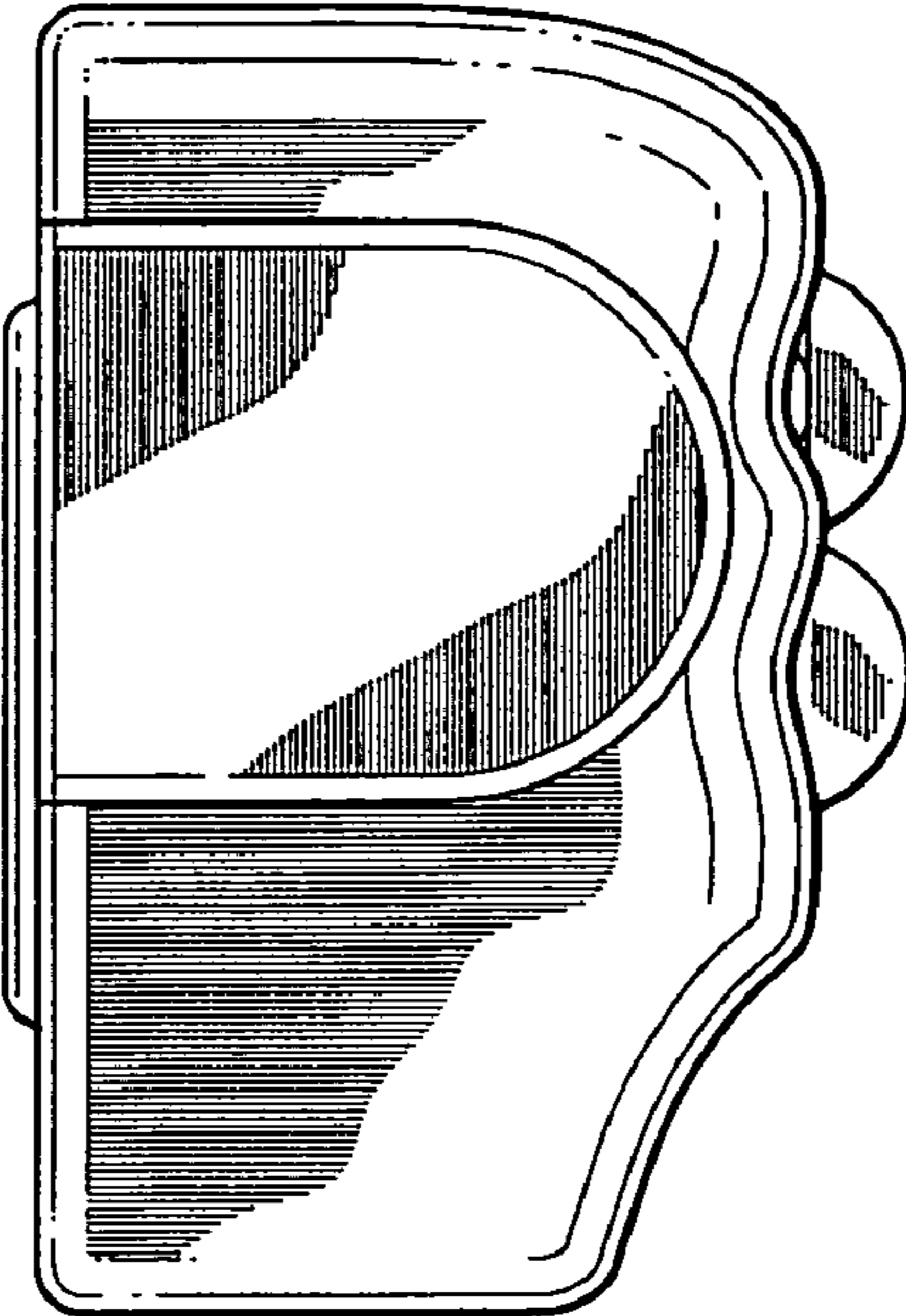

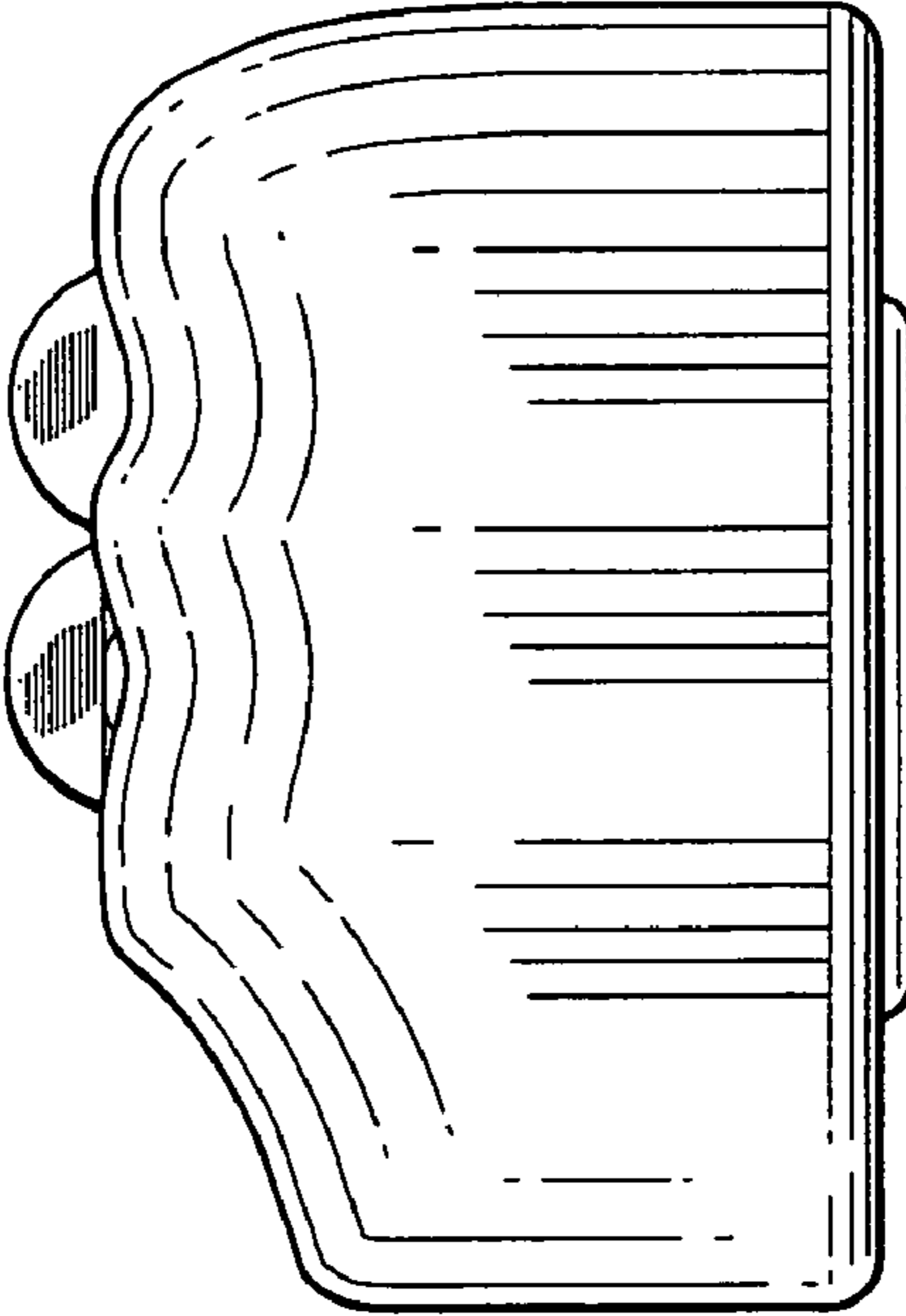

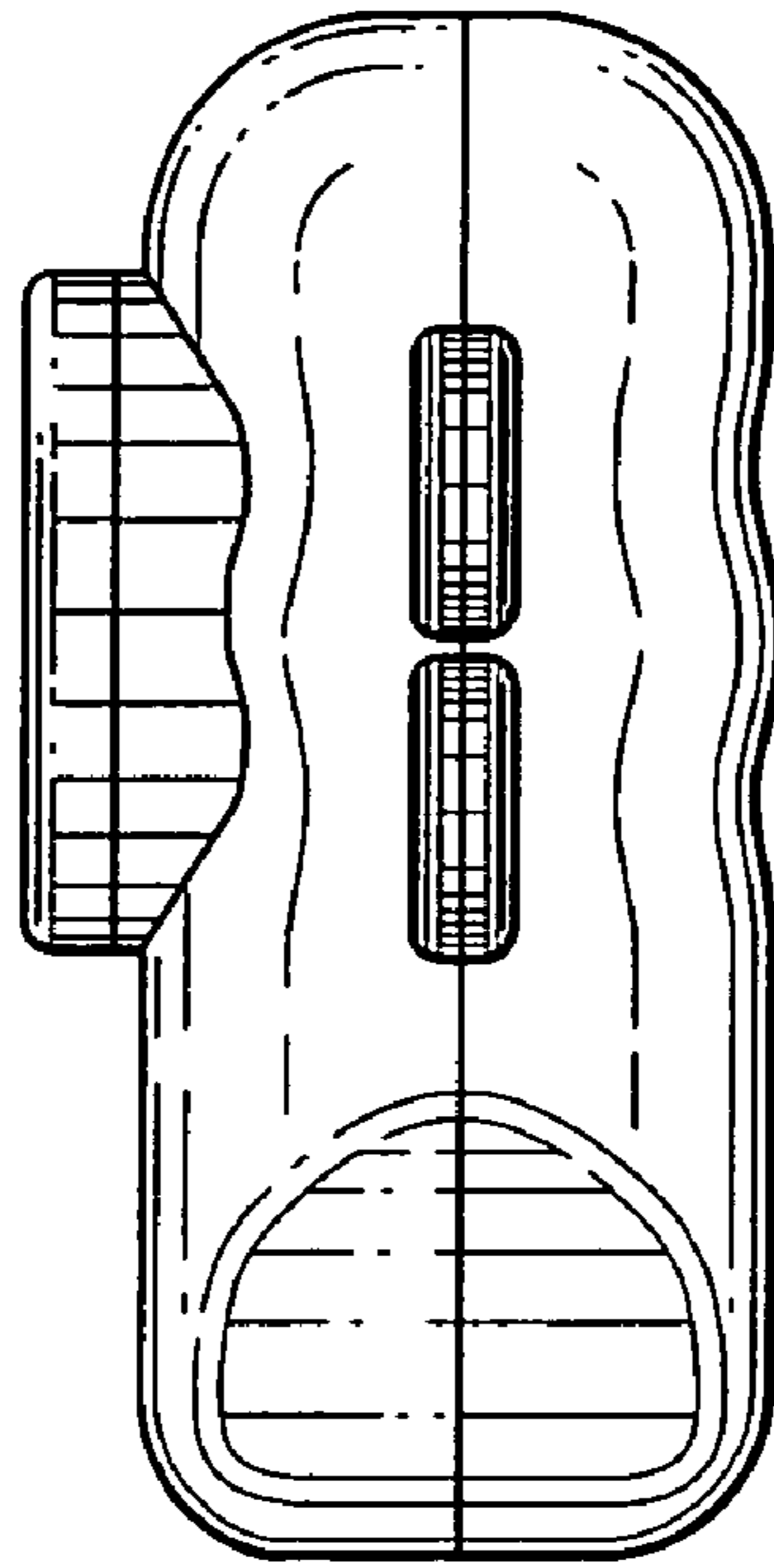

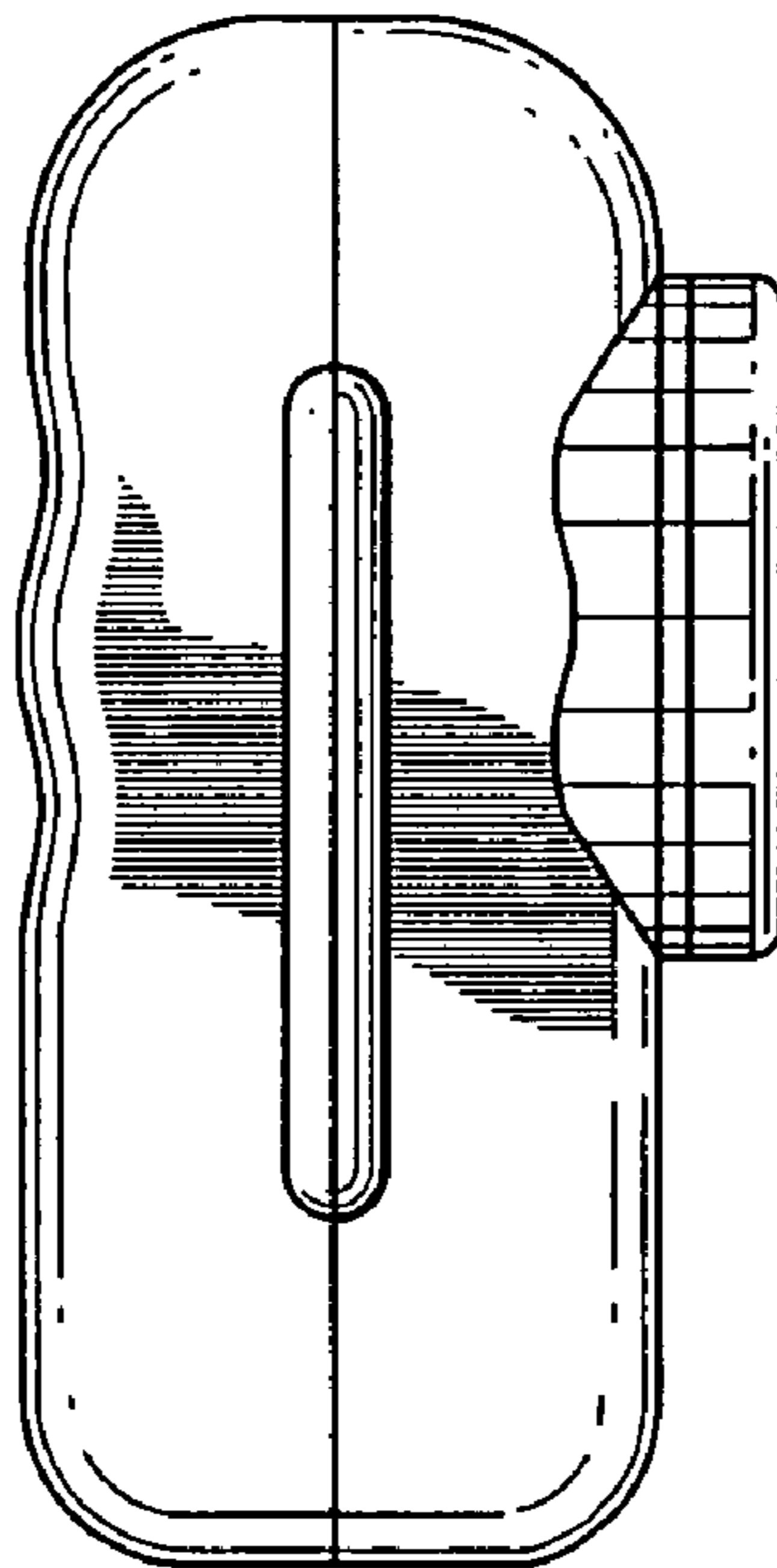

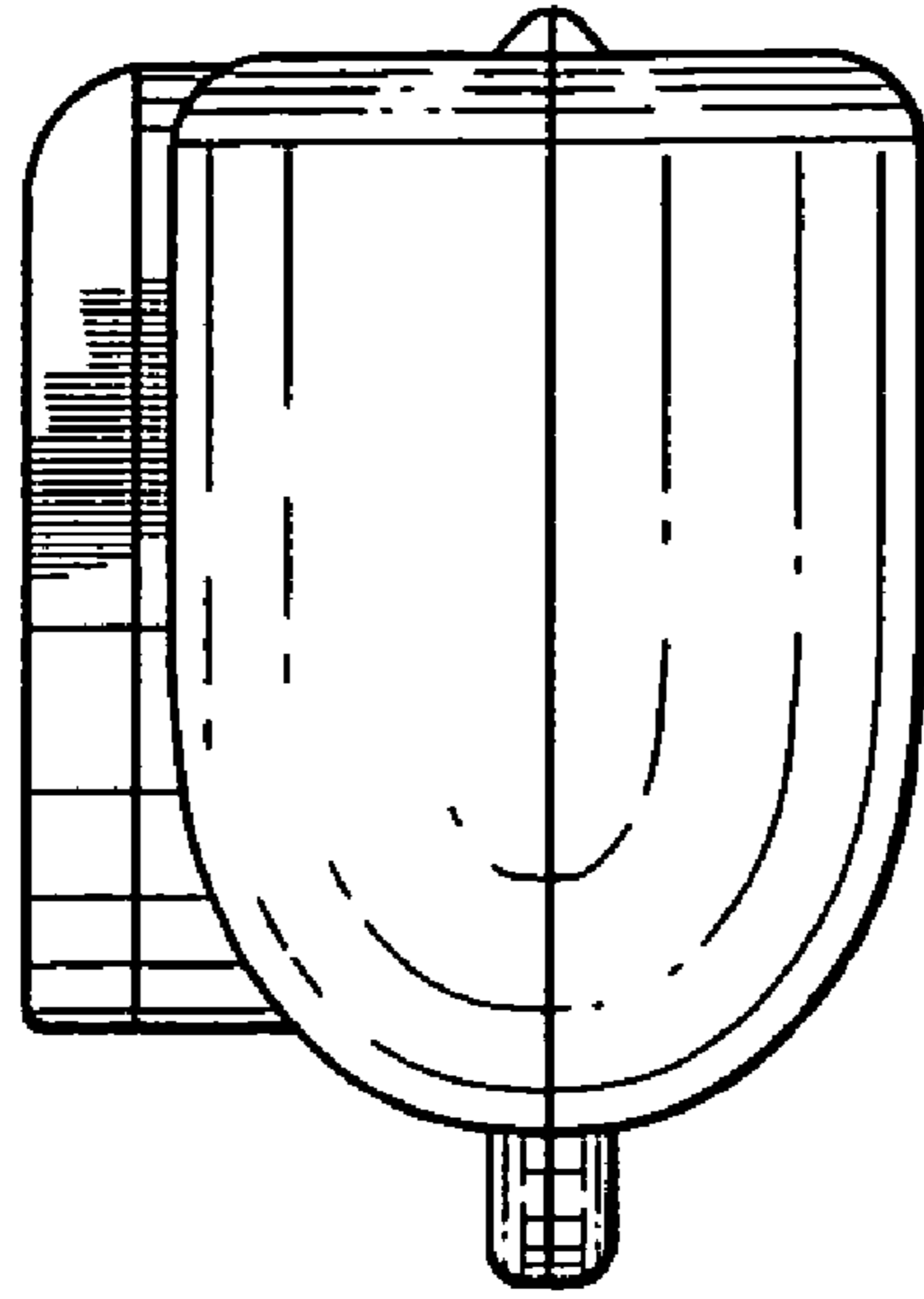

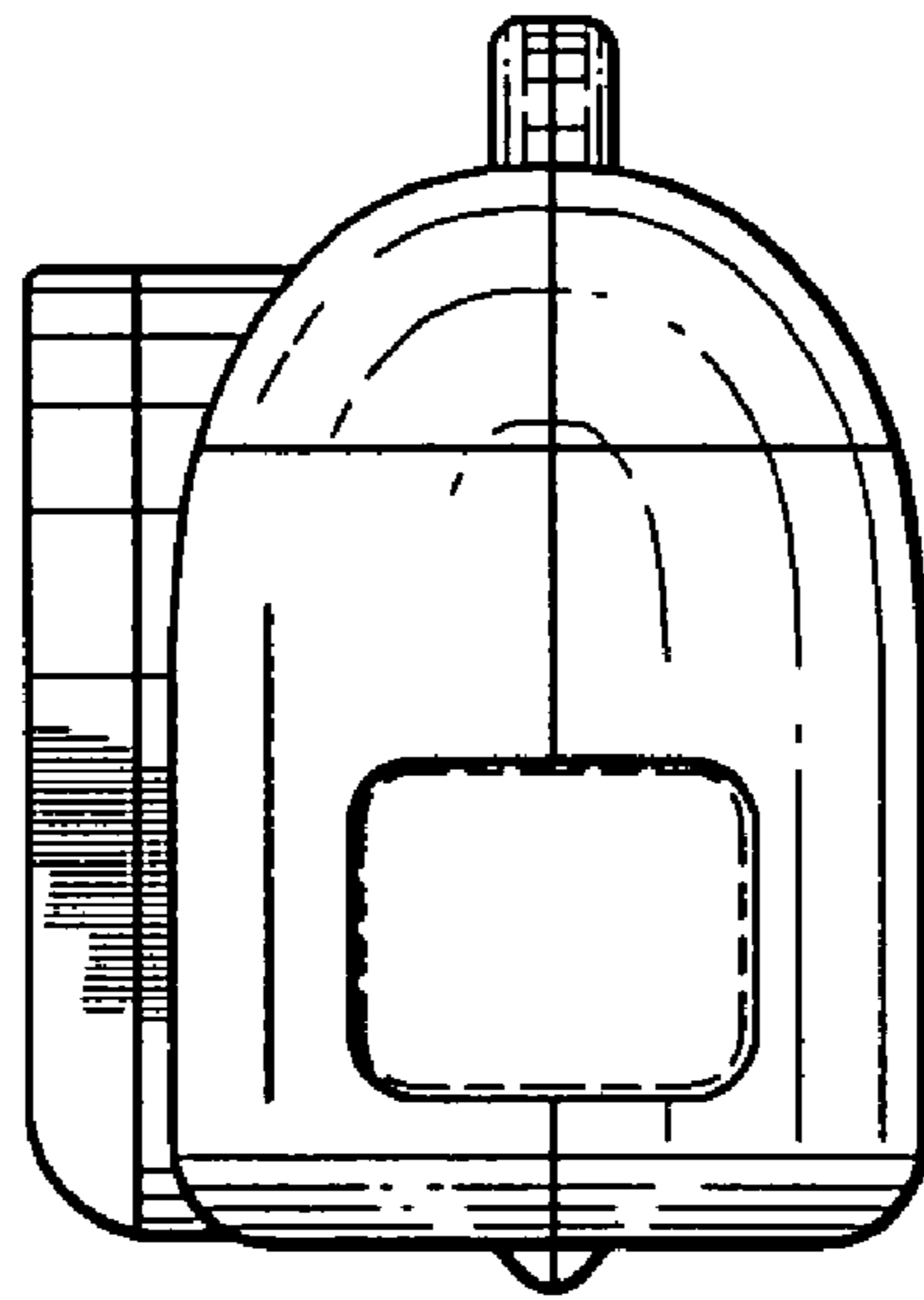

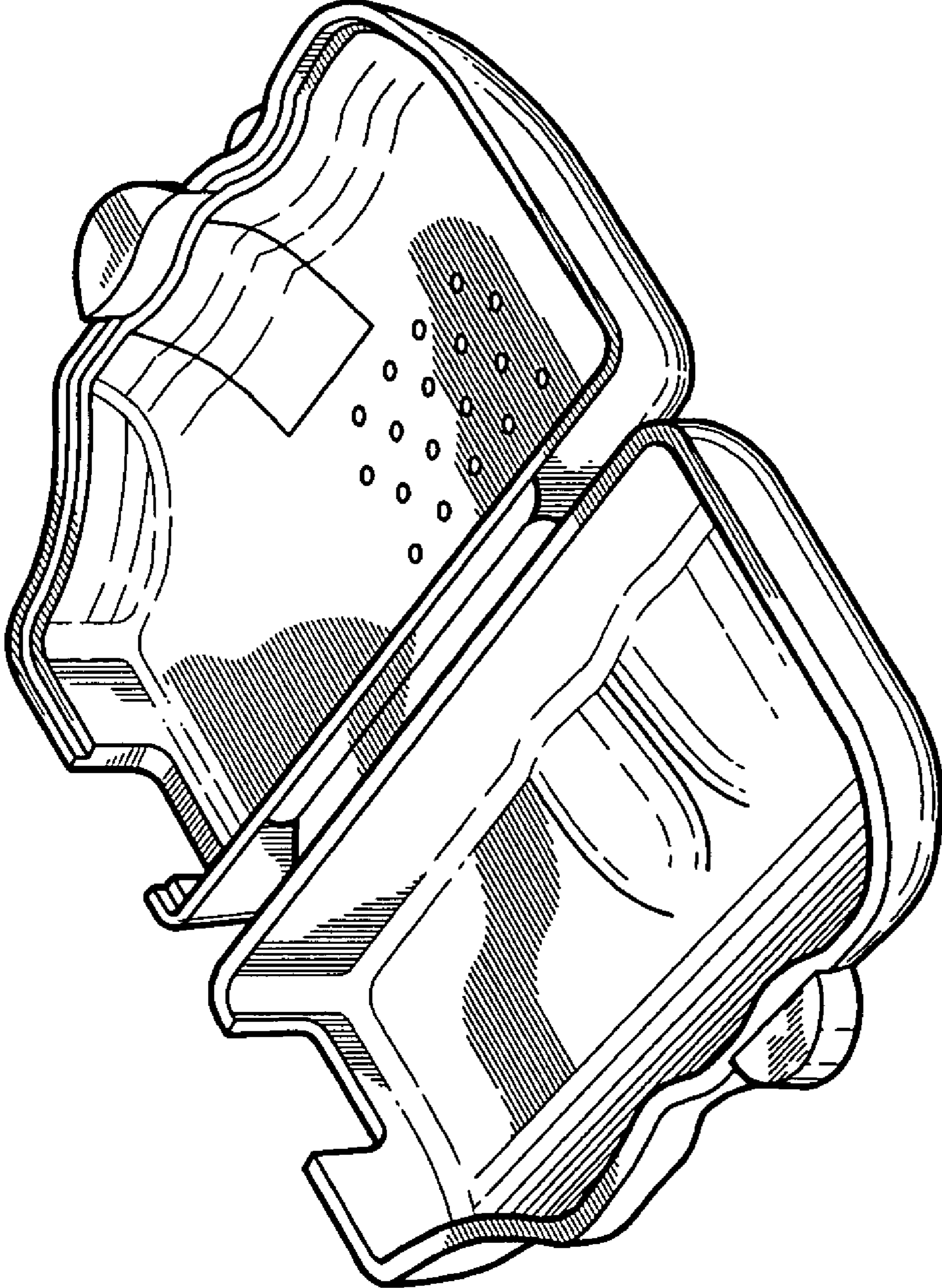

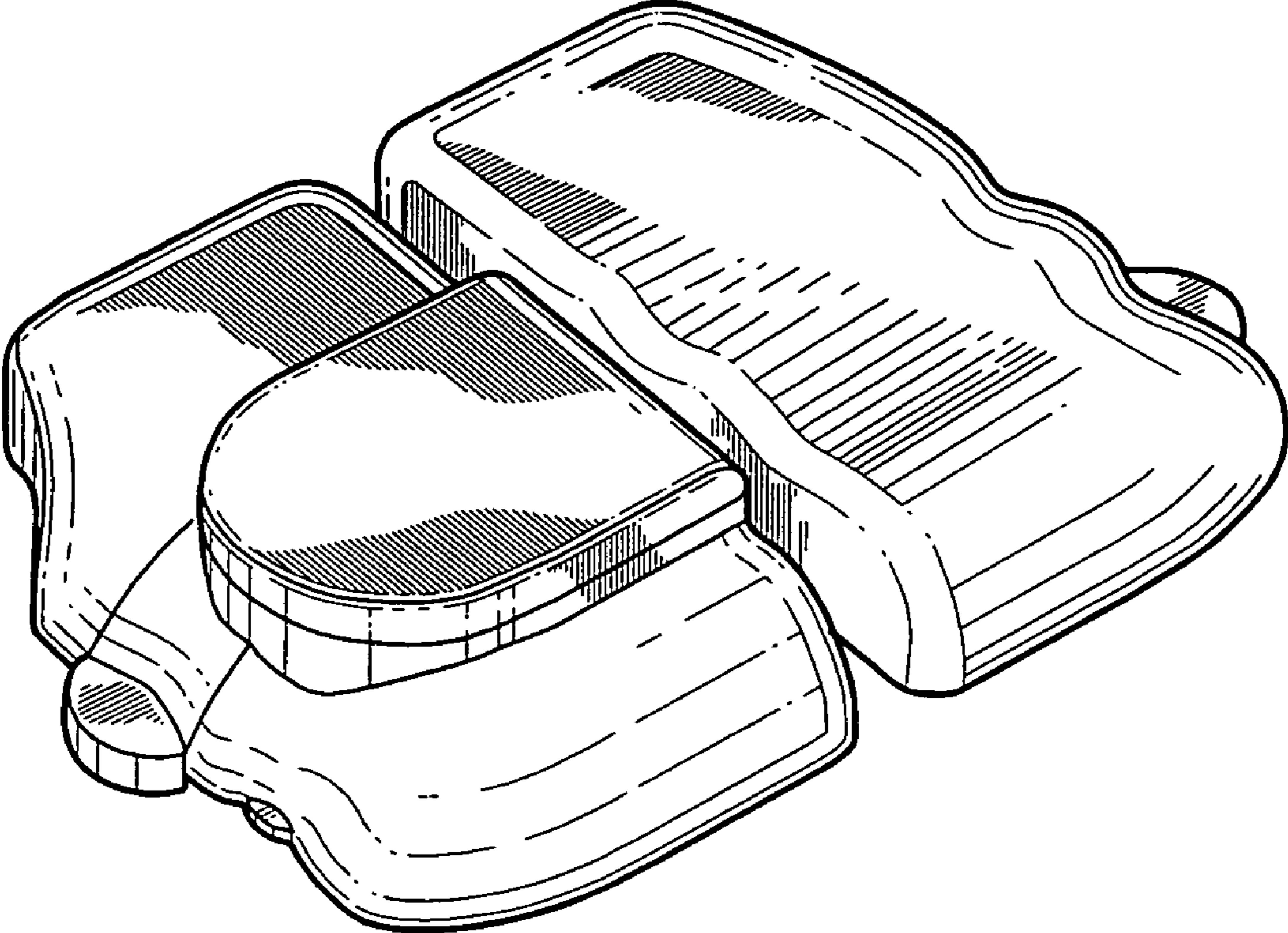
