FIG. 2 is an end view of the cattle waterer;

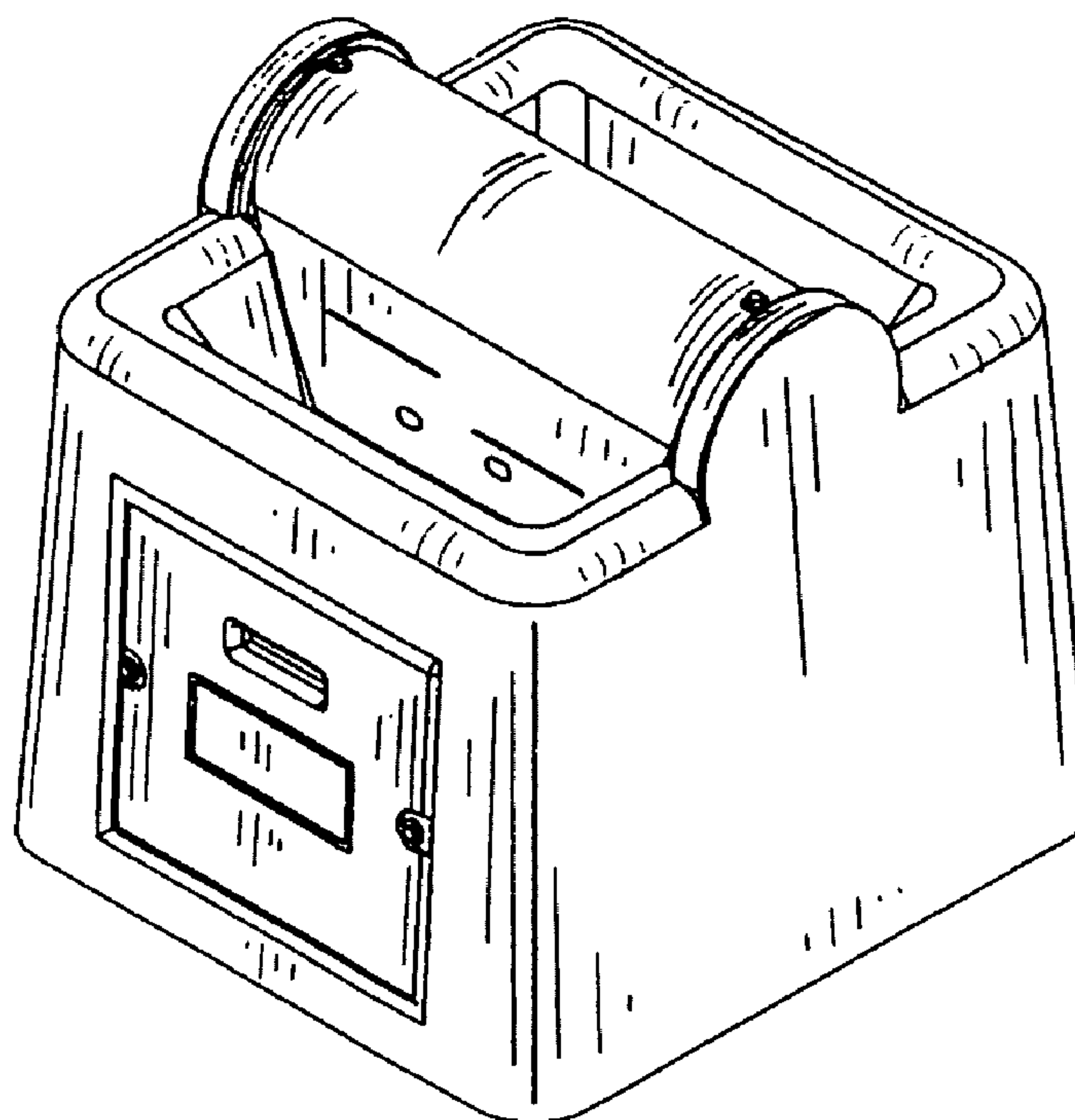
FIG. 3 is a side view of the cattle waterer;

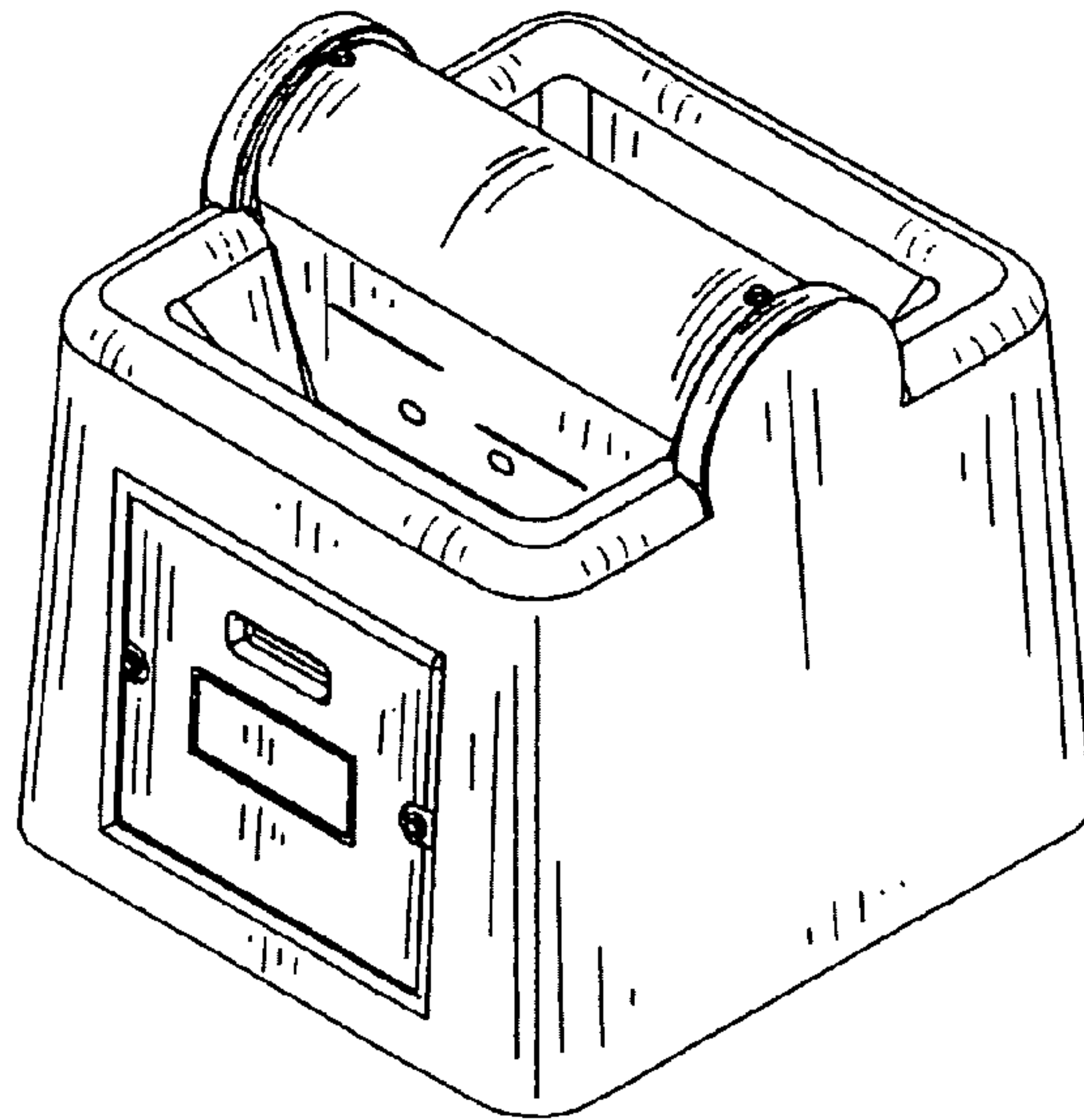

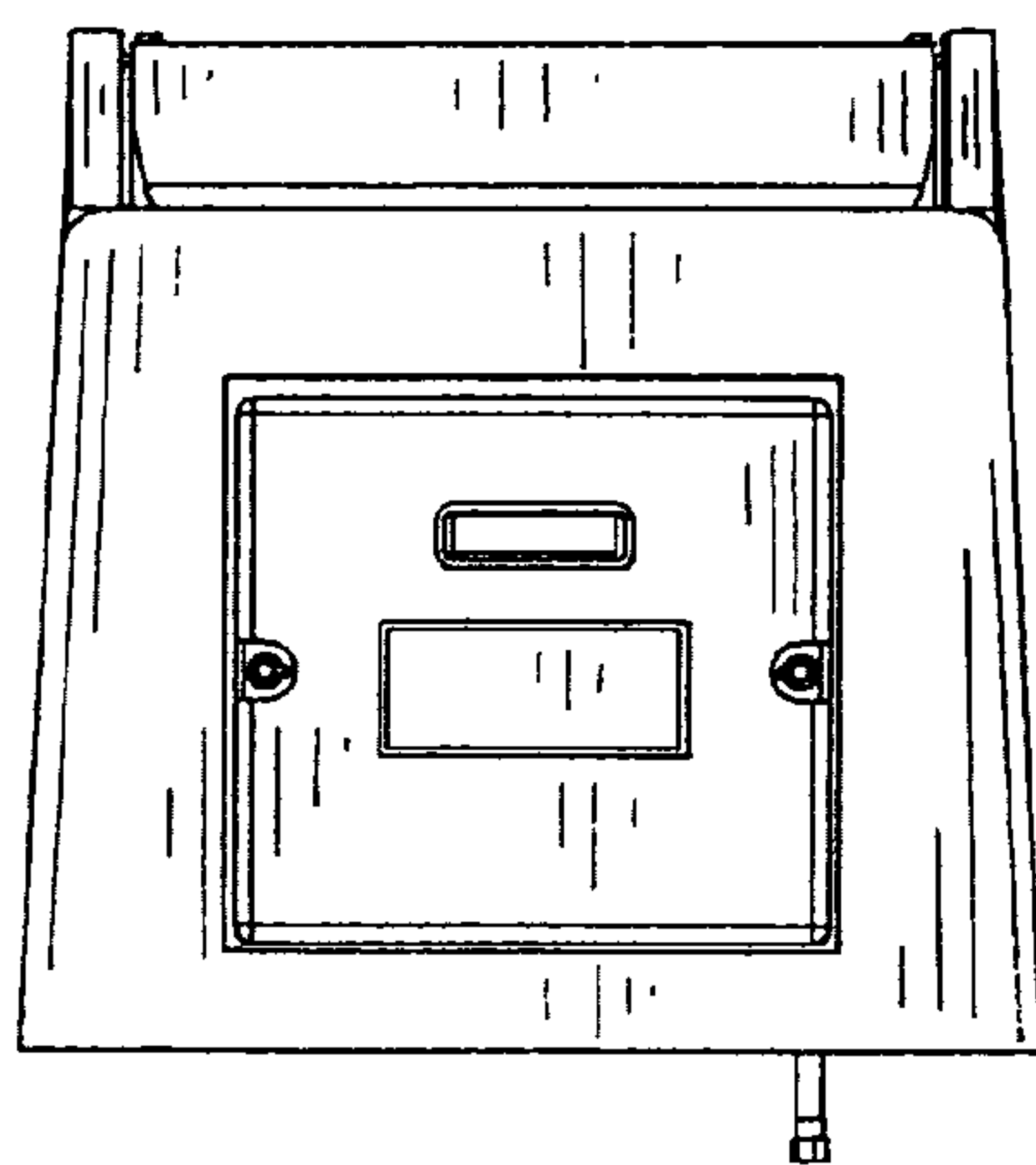

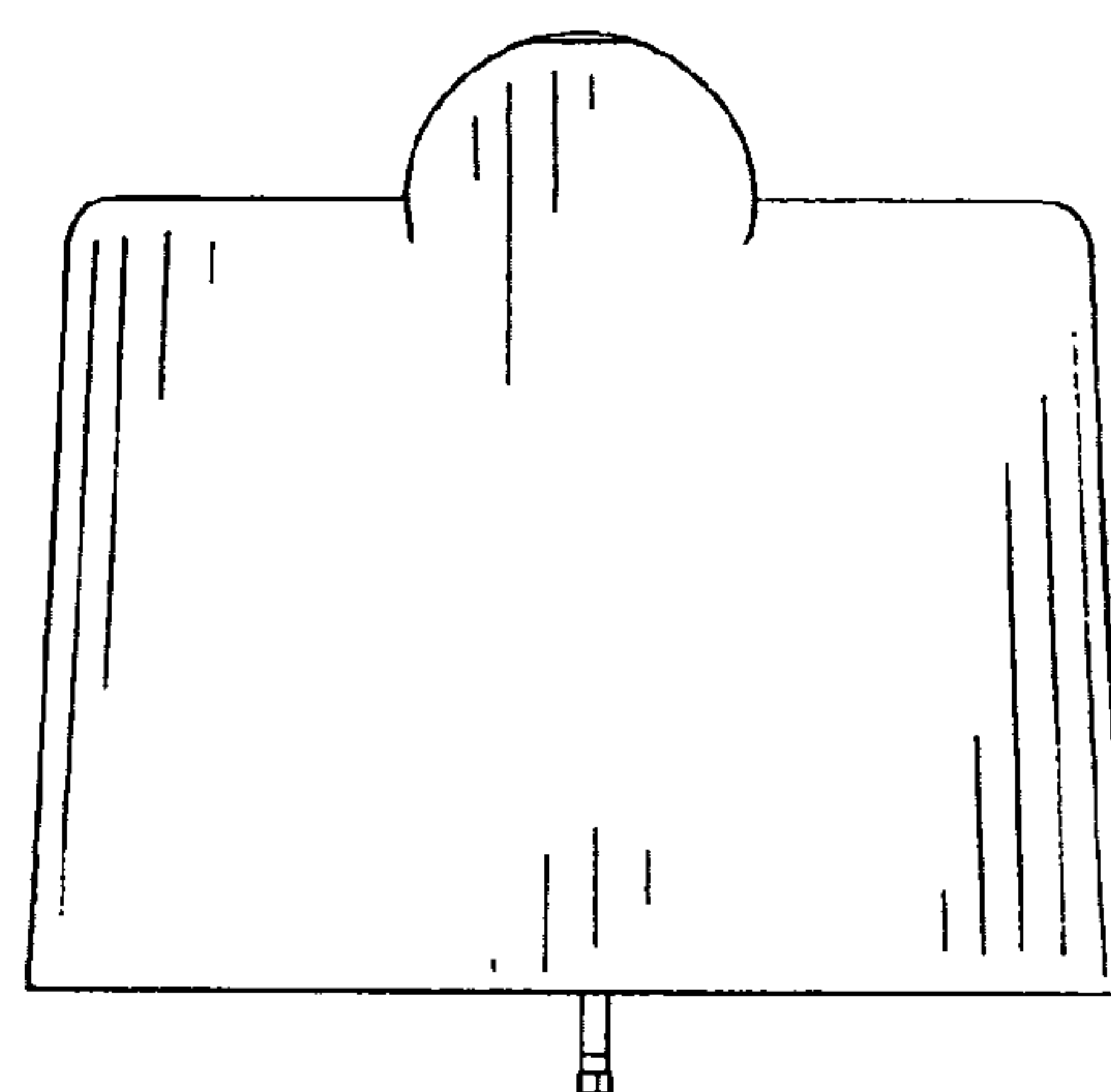

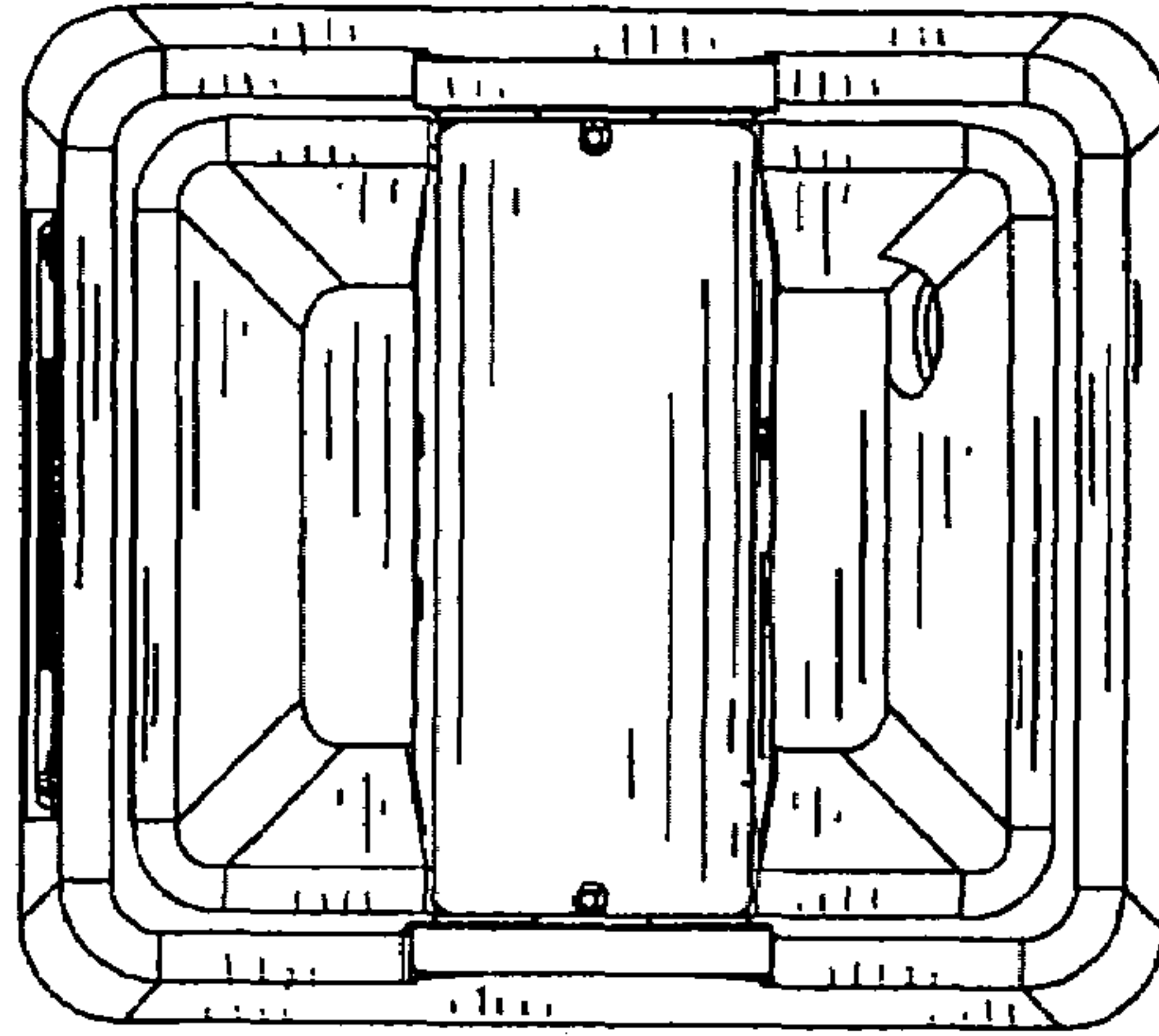

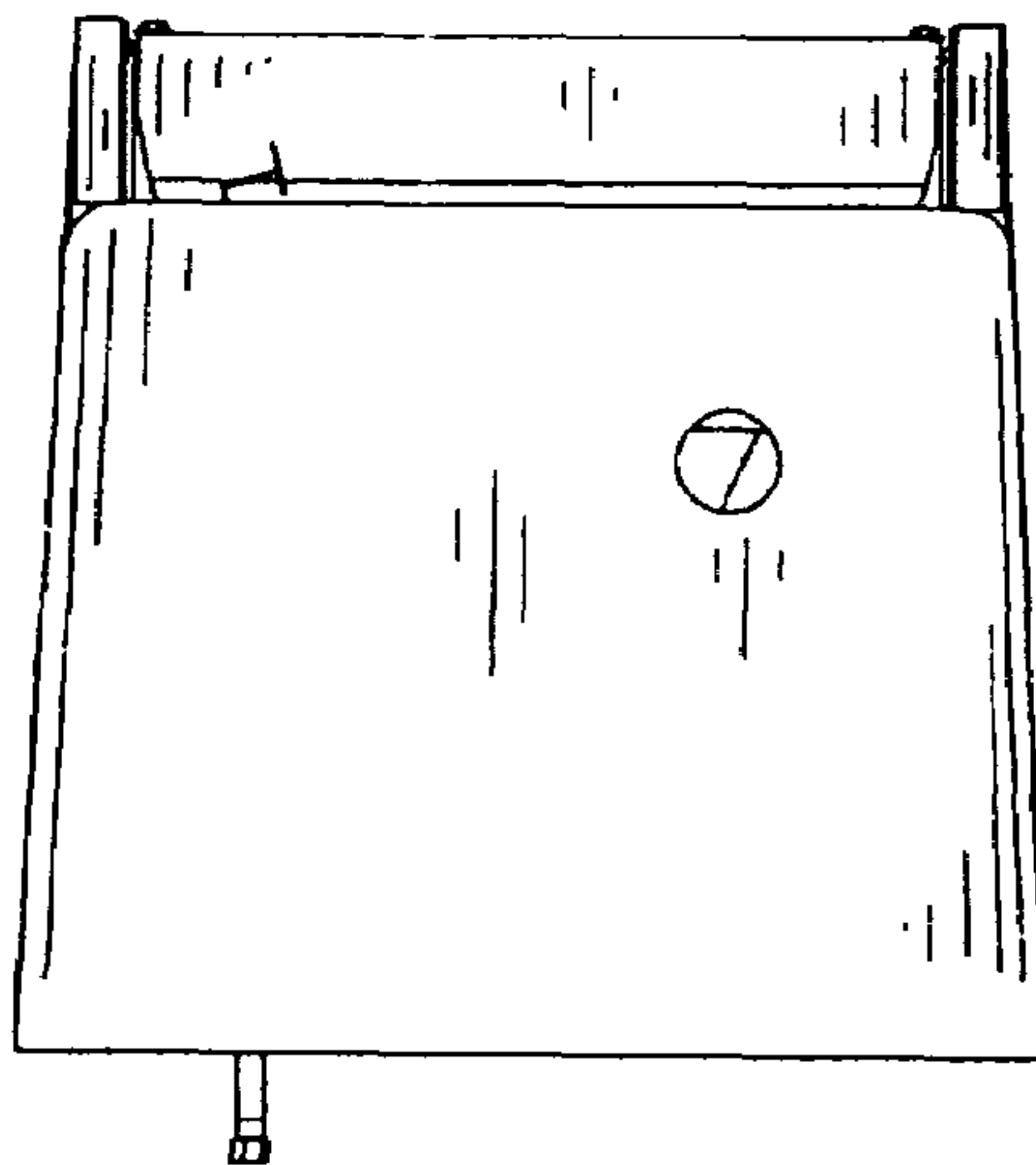

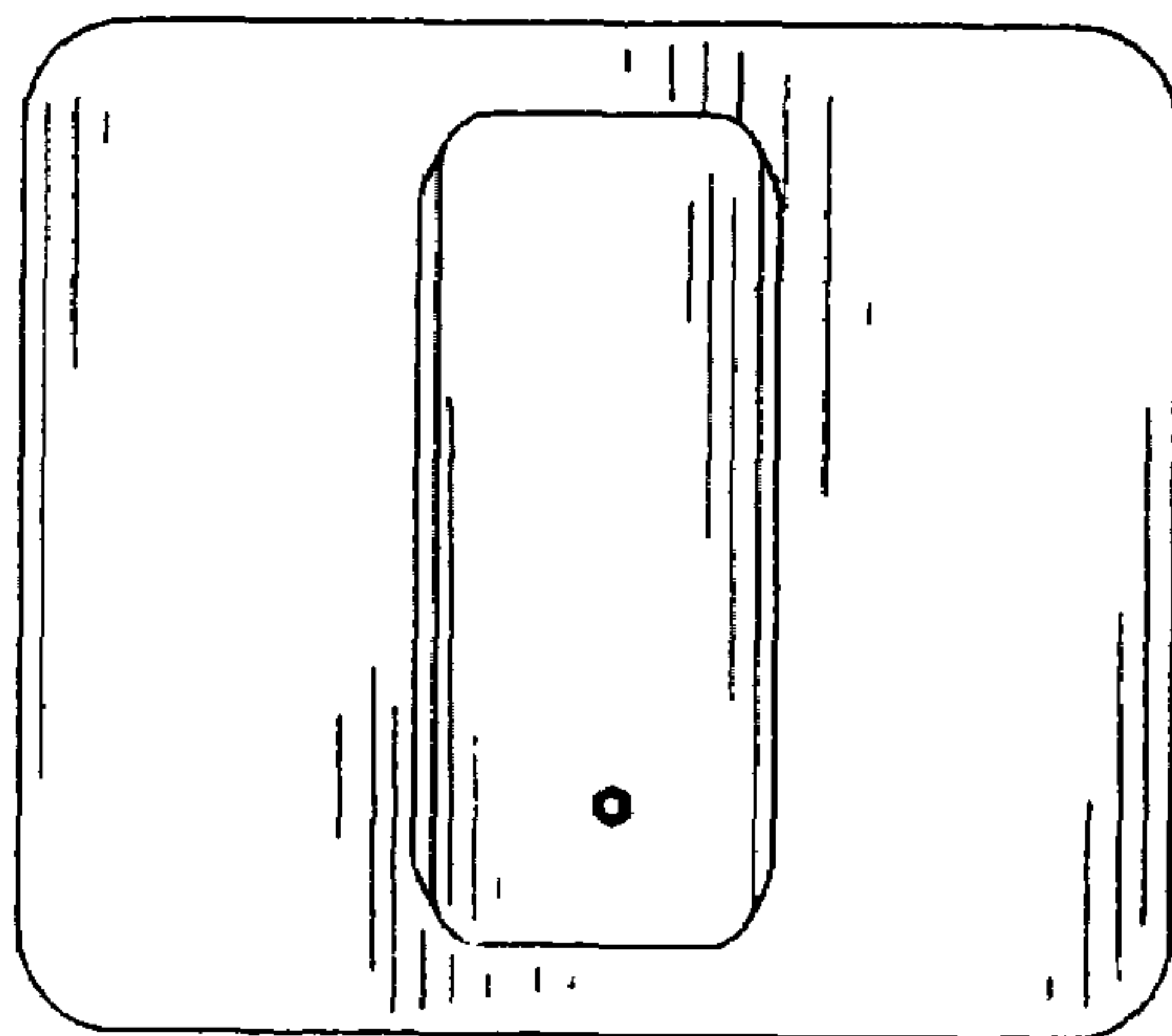
