I claim, the ornamental design for a water bucket for portable irrigator, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a water bucket for portable irrigator, showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a cross-sectional view thereof taken along line A—A in FIG. 6;

FIG. 9 is a cross-sectional view thereof taken along line B—B in FIG. 6; and,

FIG. 10 is a top rear perspective view thereof.

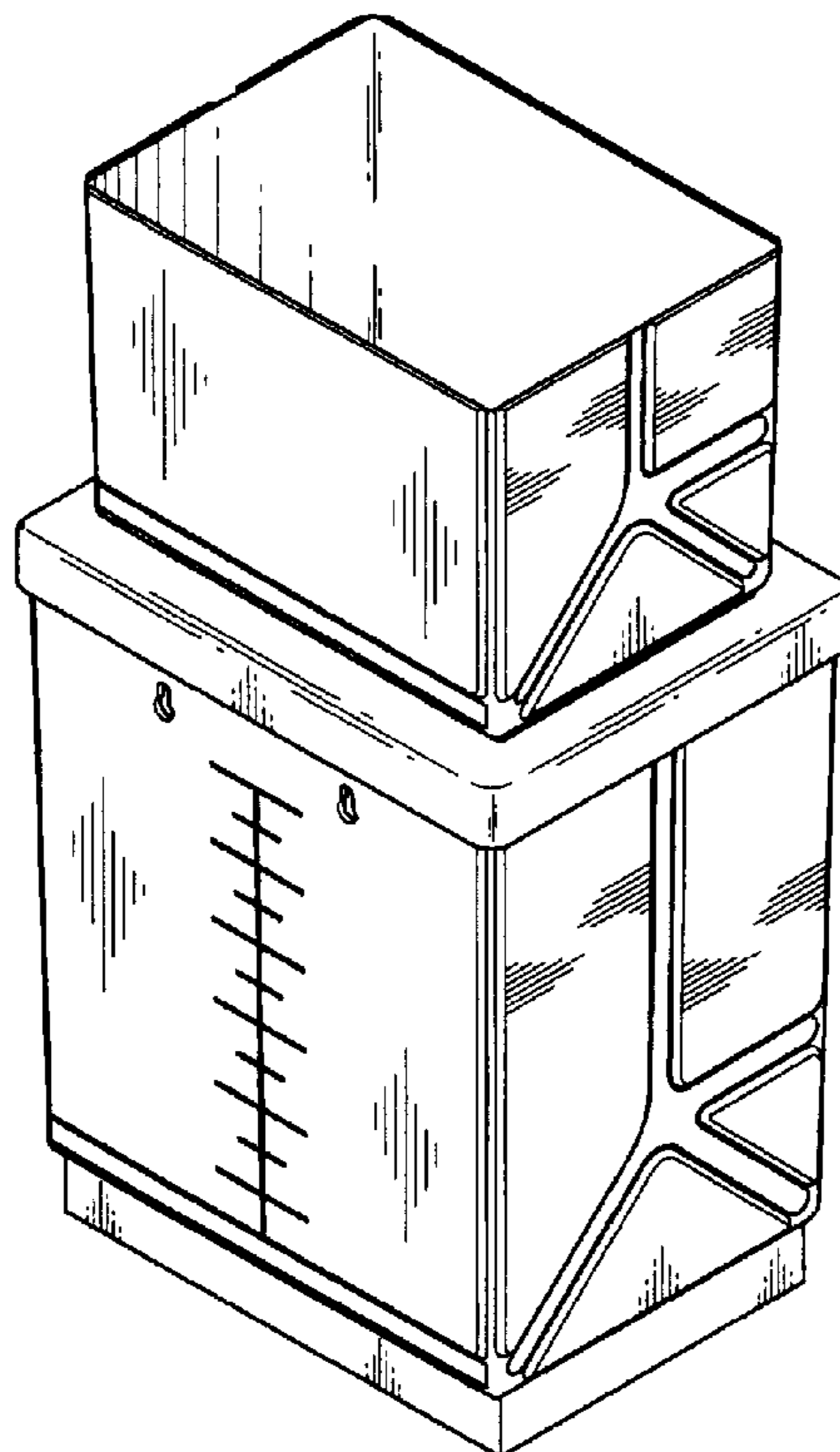

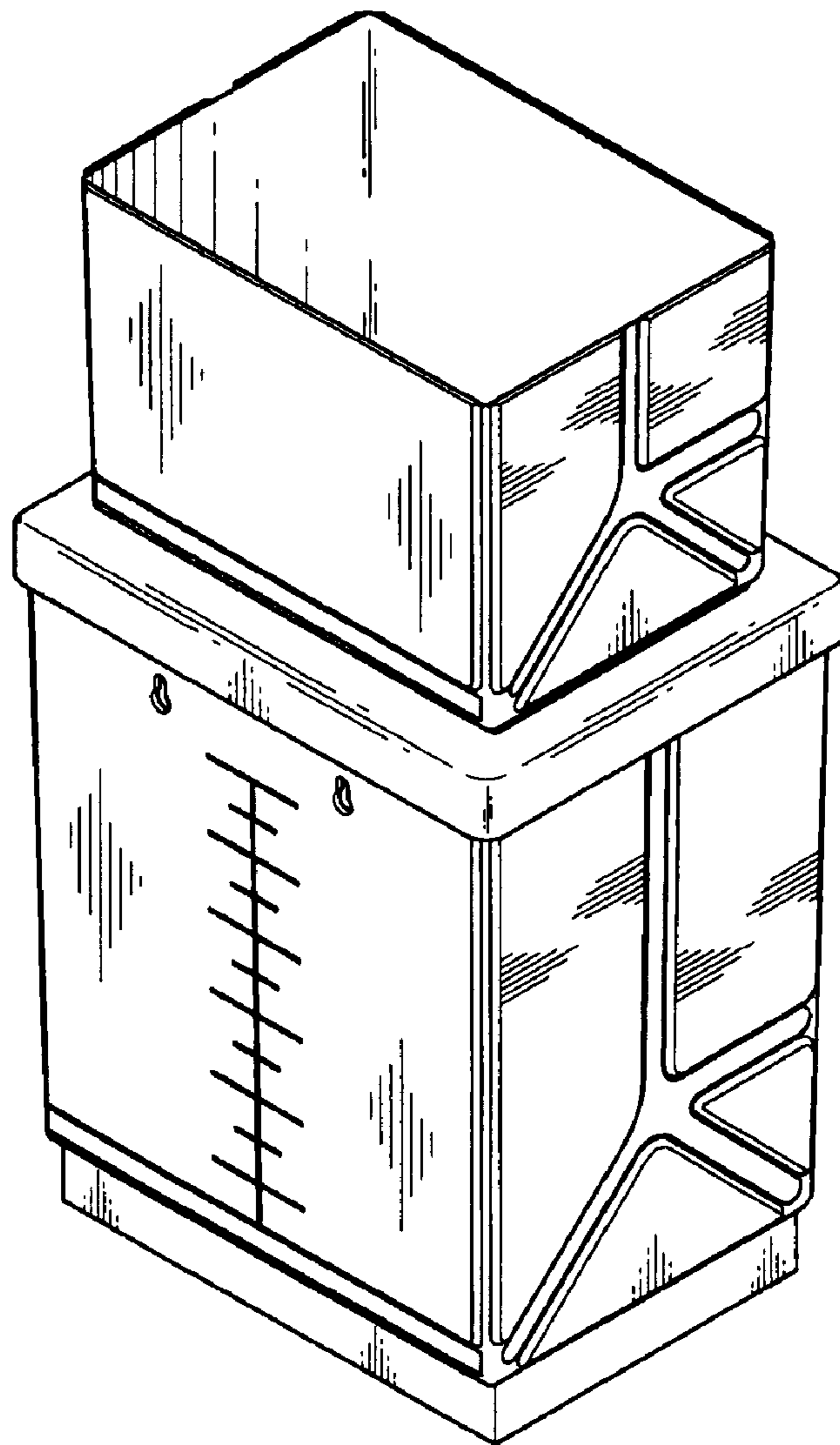

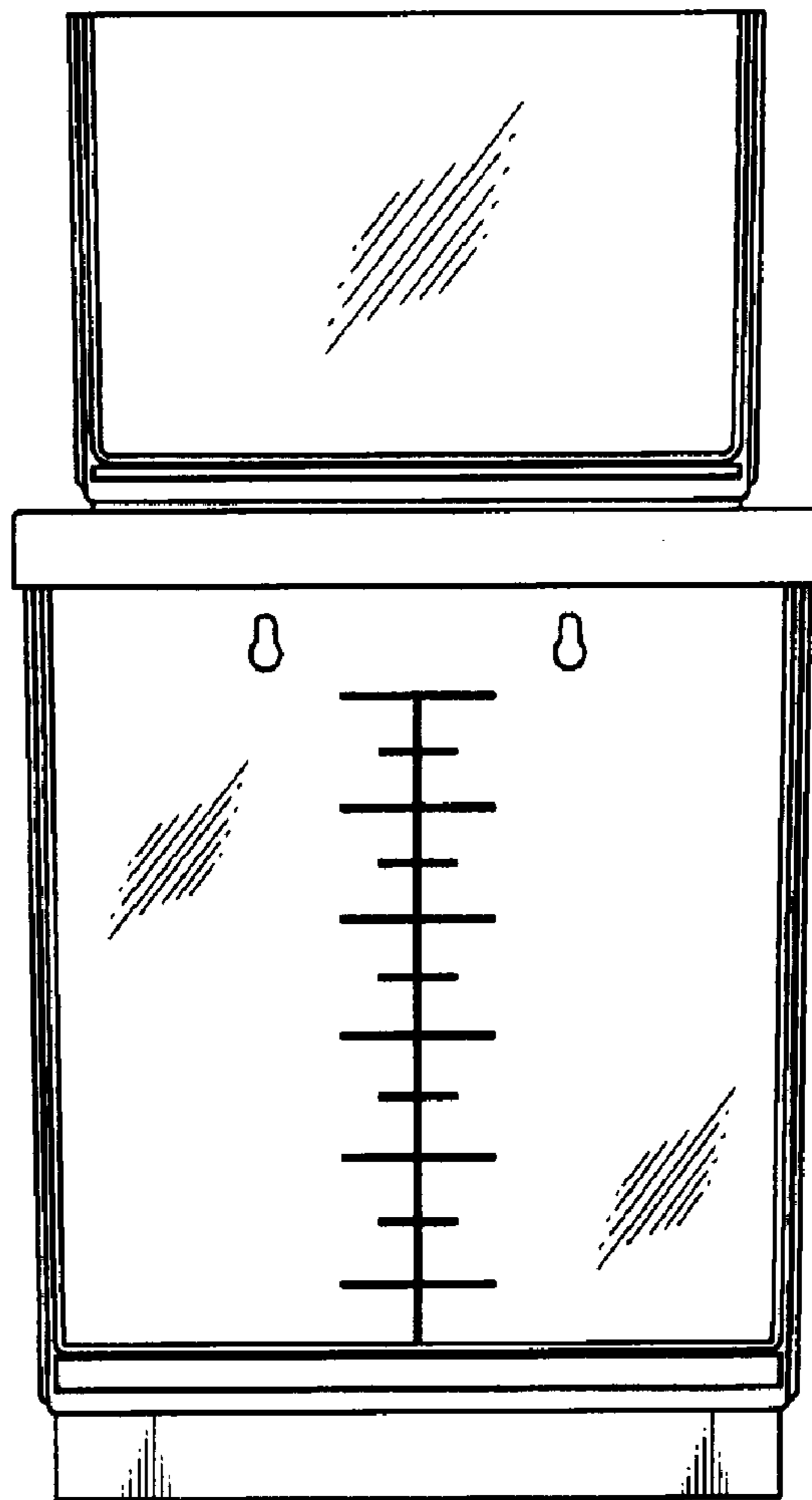

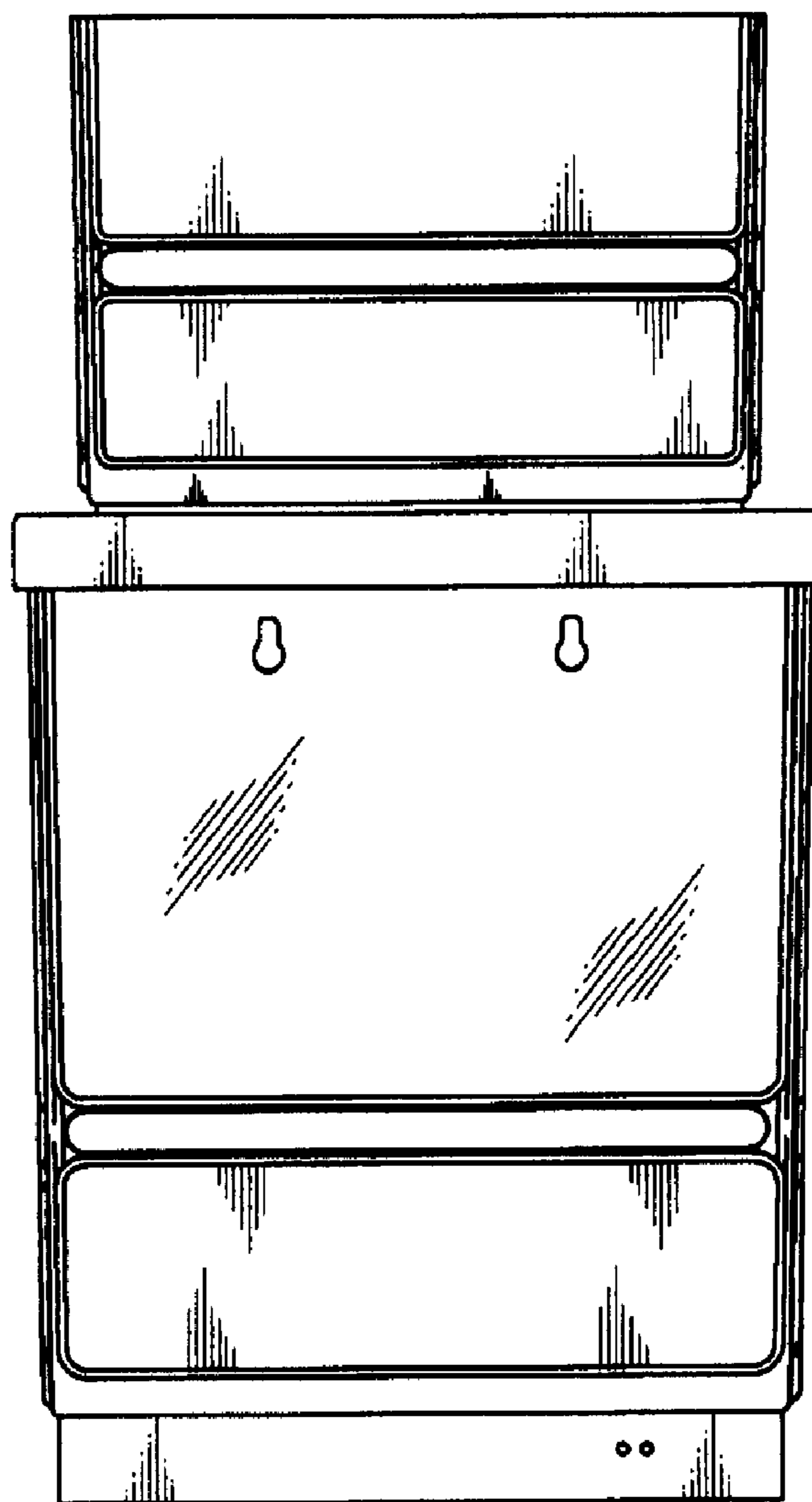

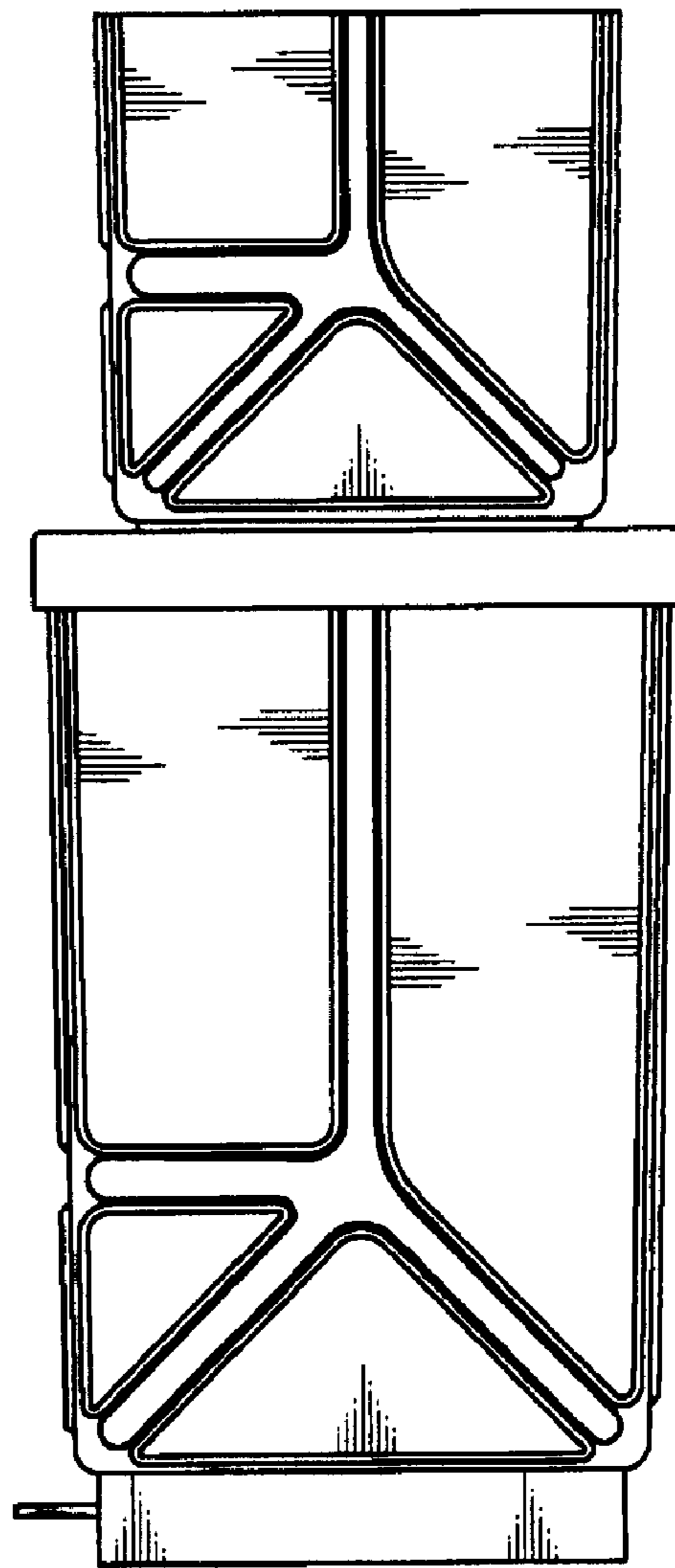

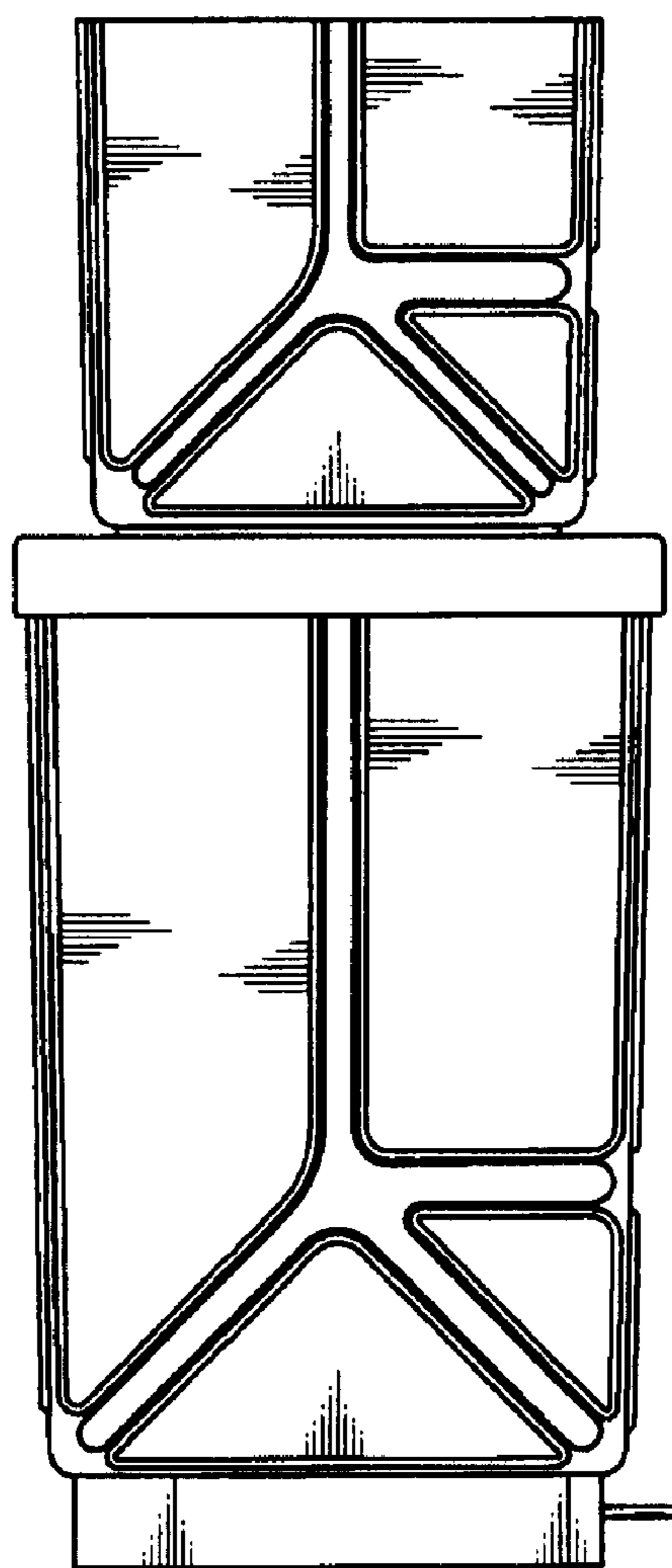

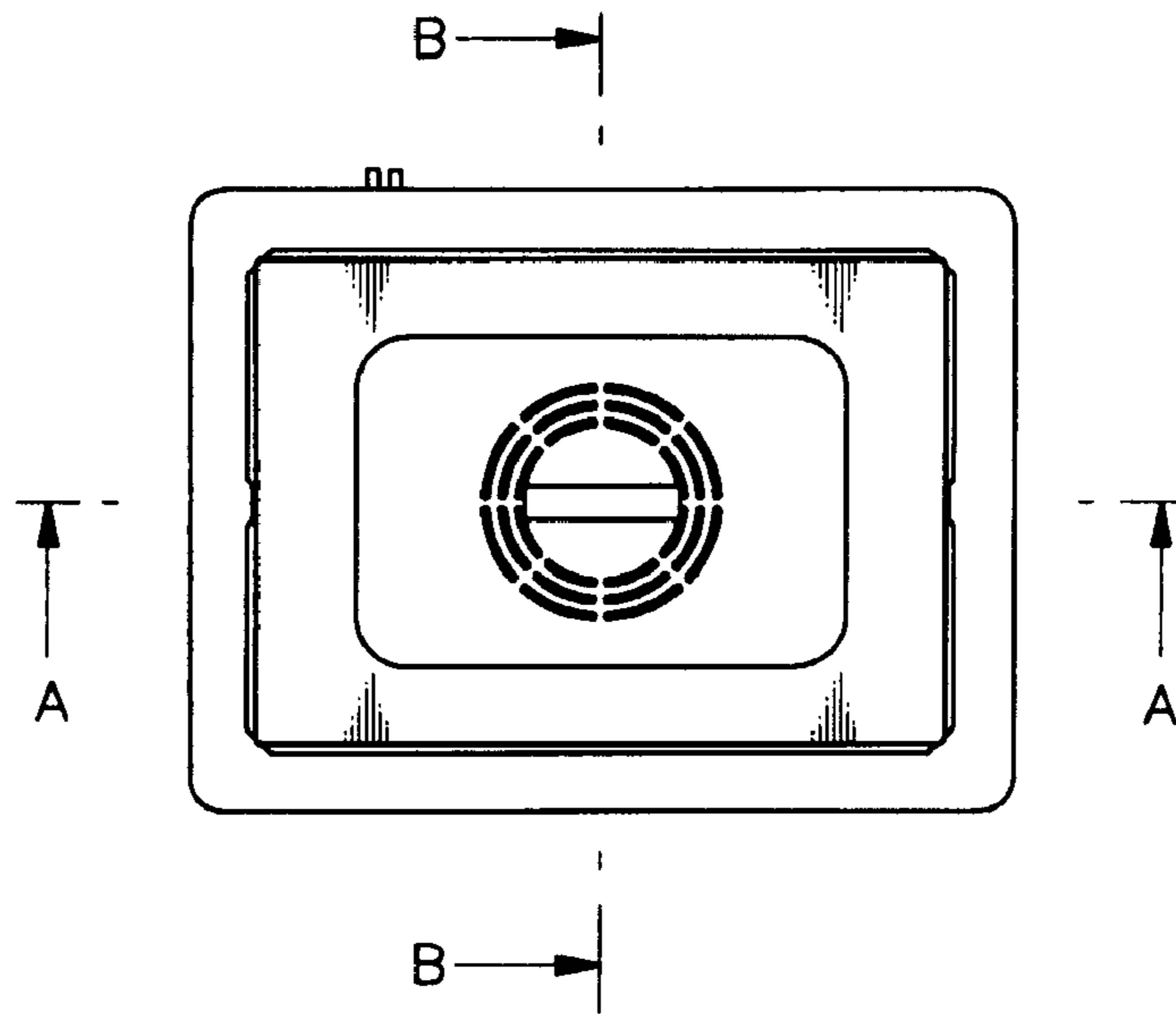

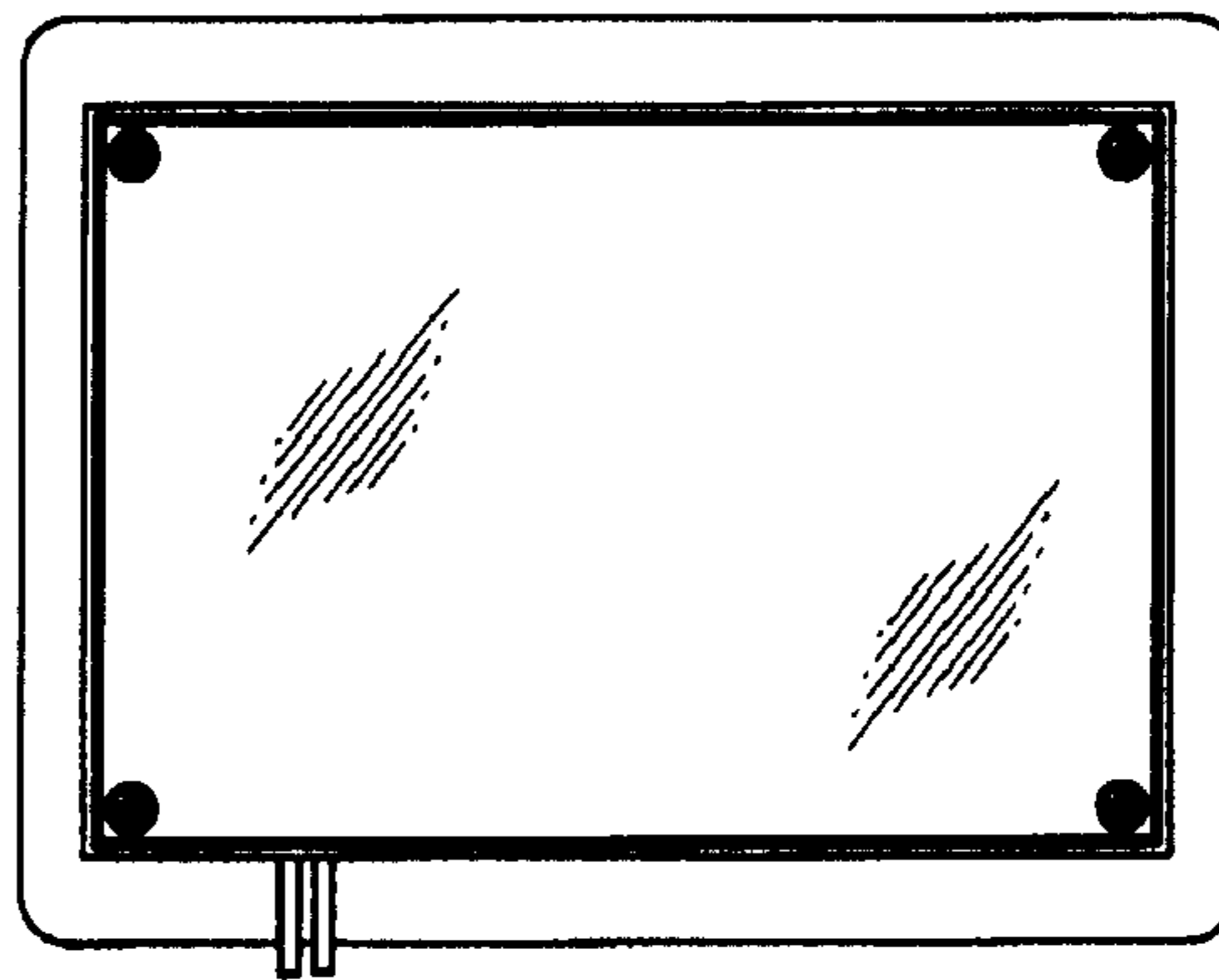

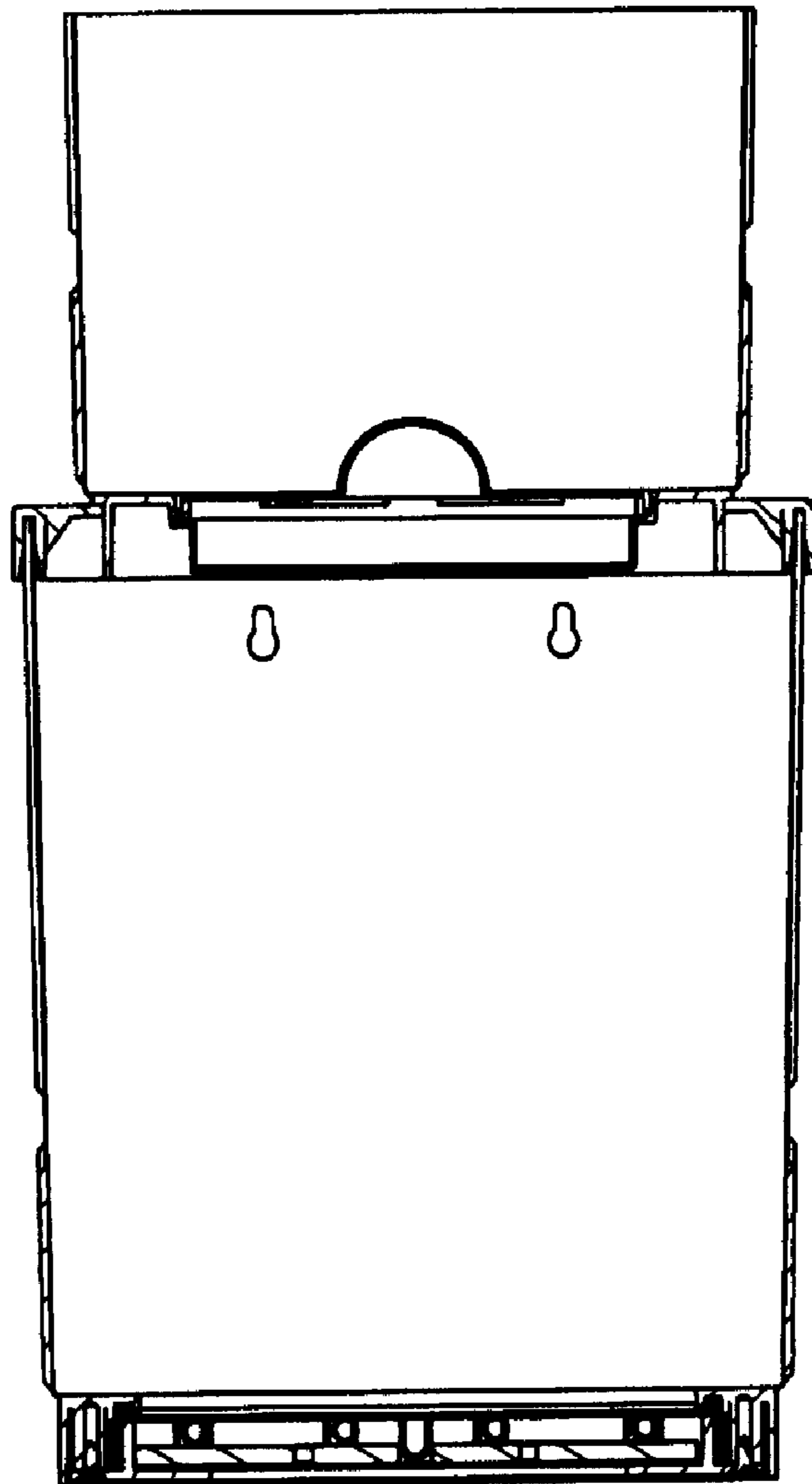

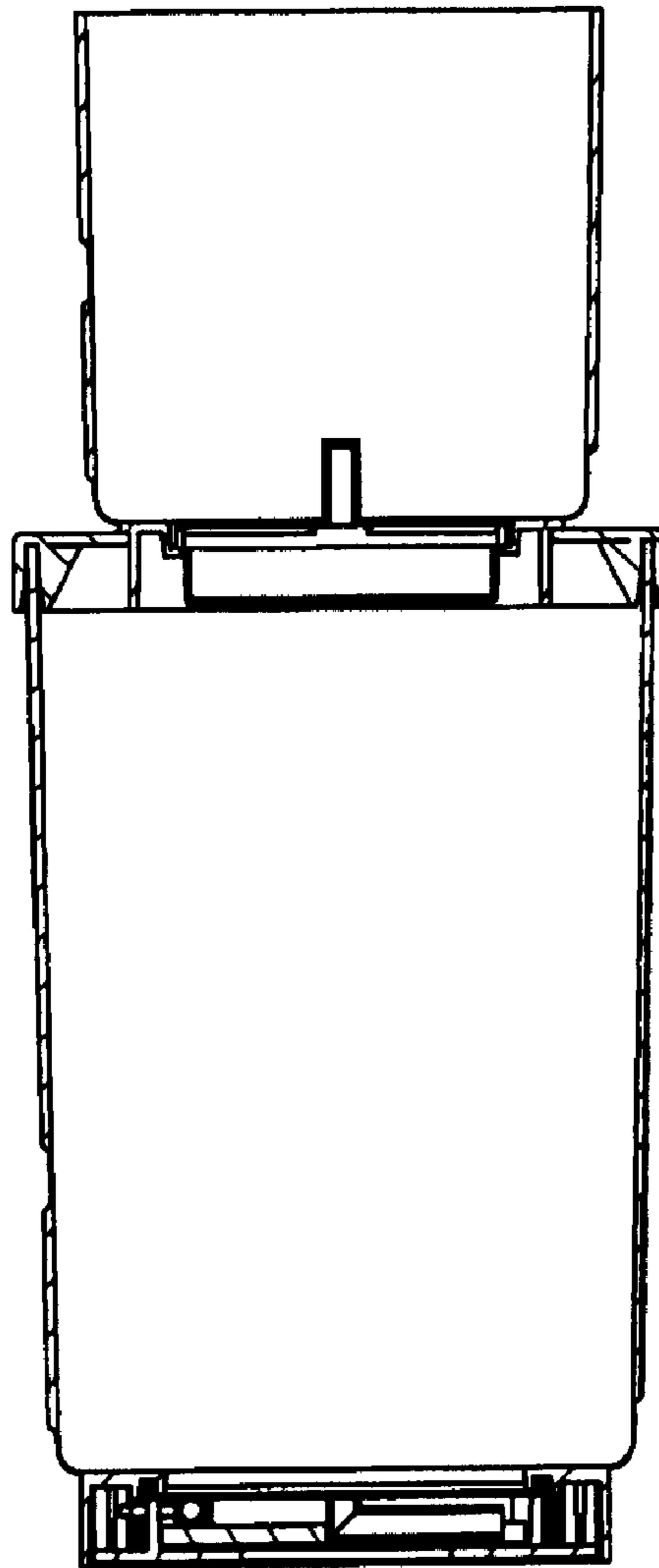
