FIG. 3 is another left side perspective view thereof;

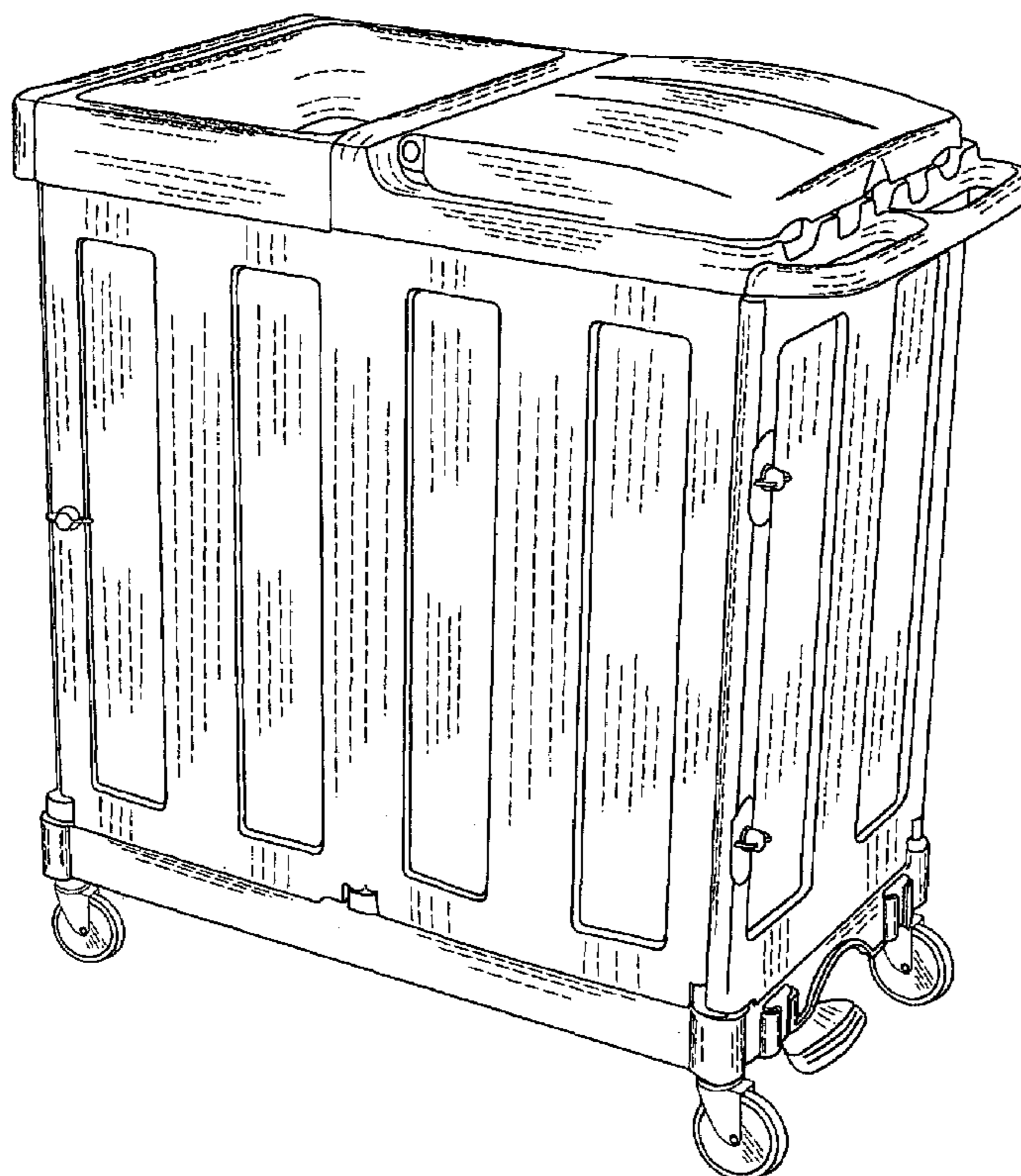
FIG. 4 is a right side elevational view thereof;

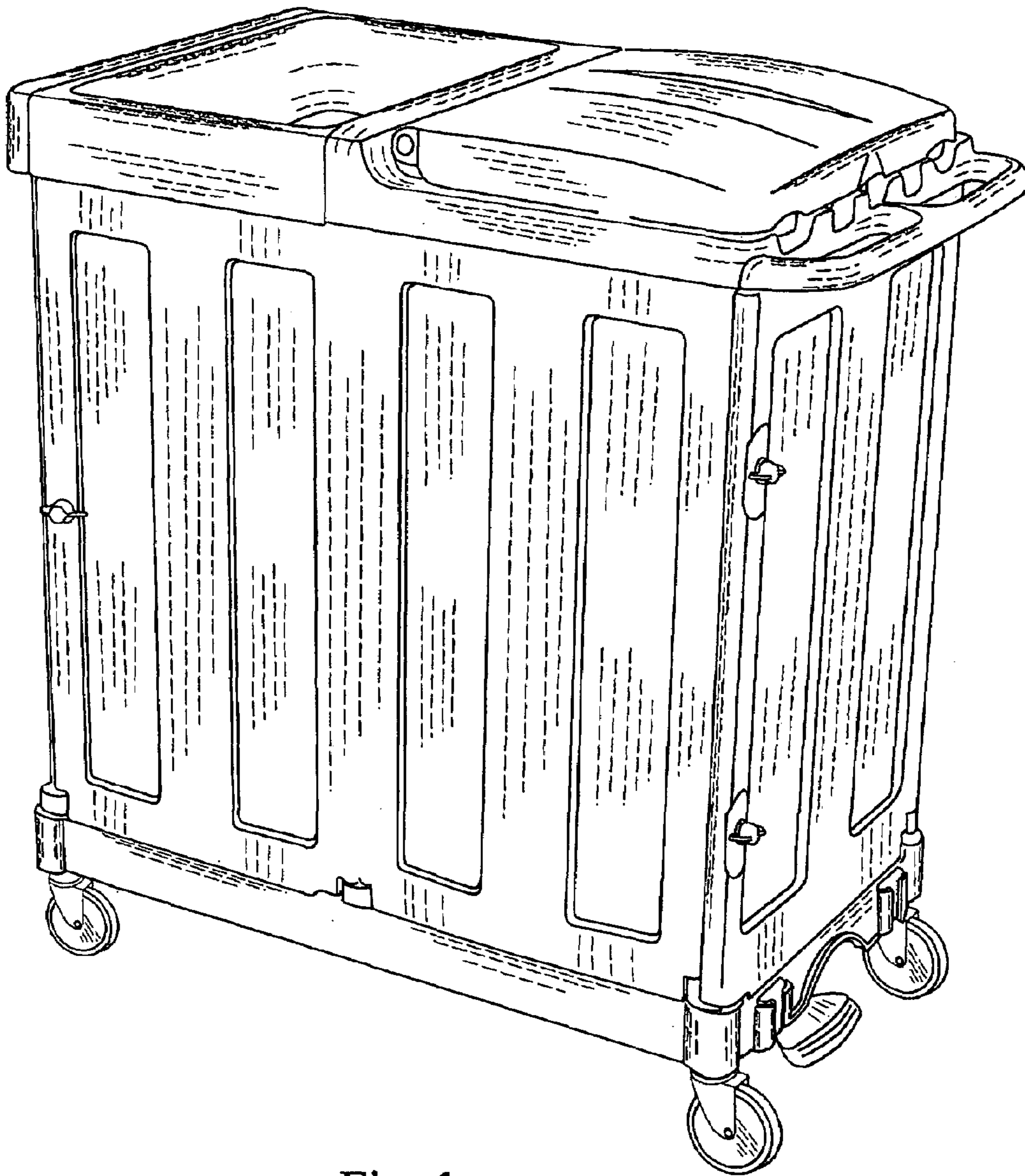

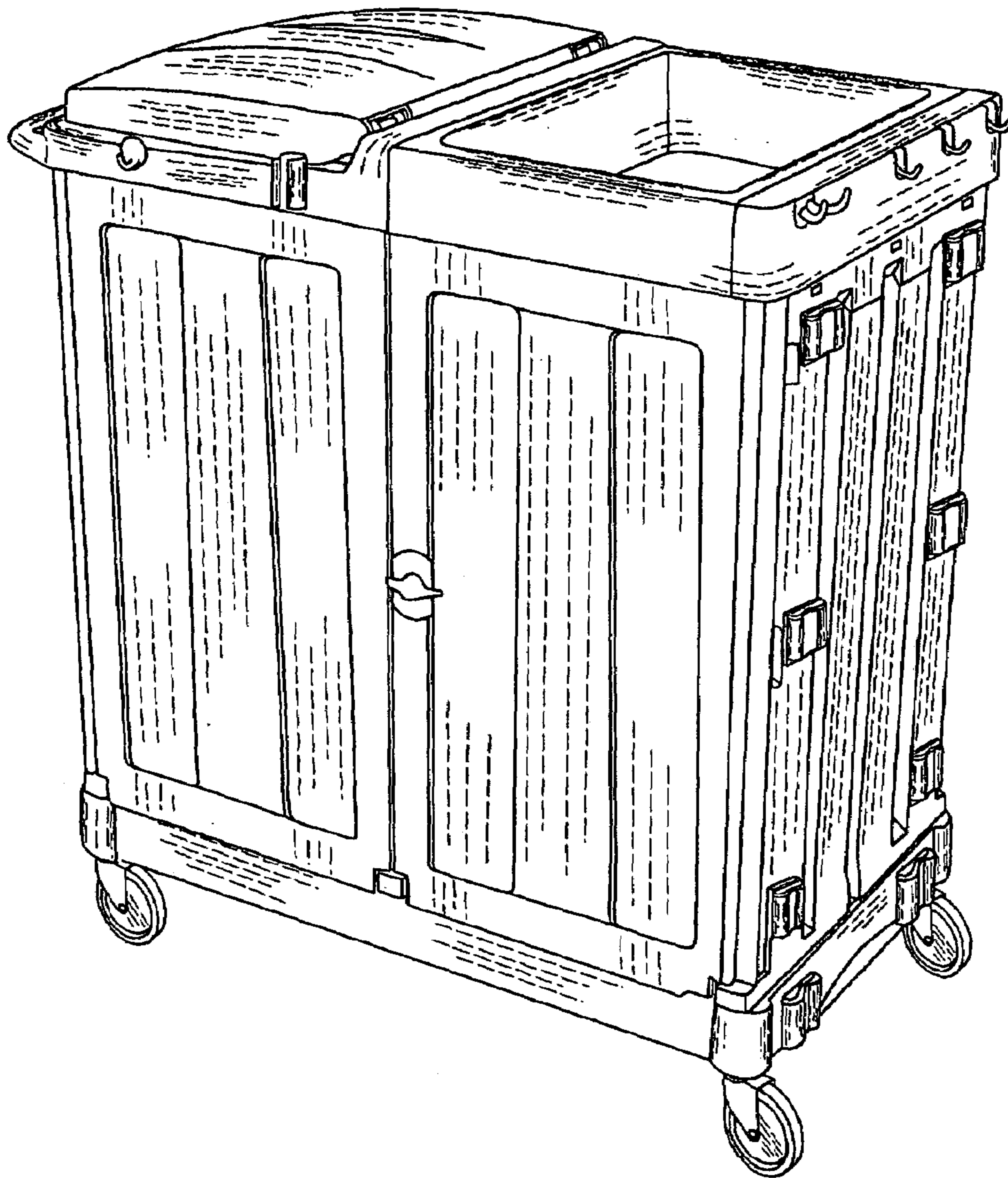

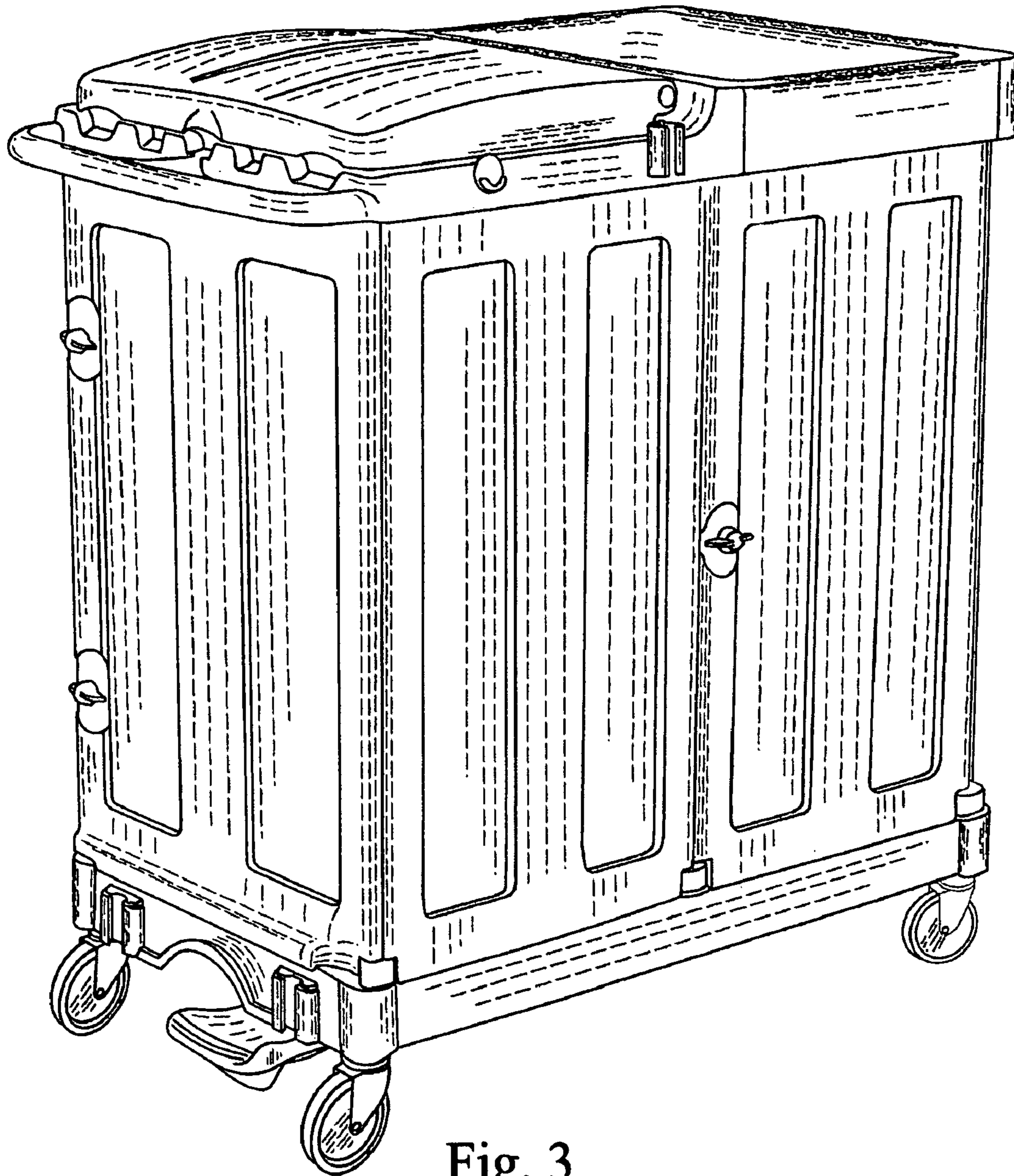

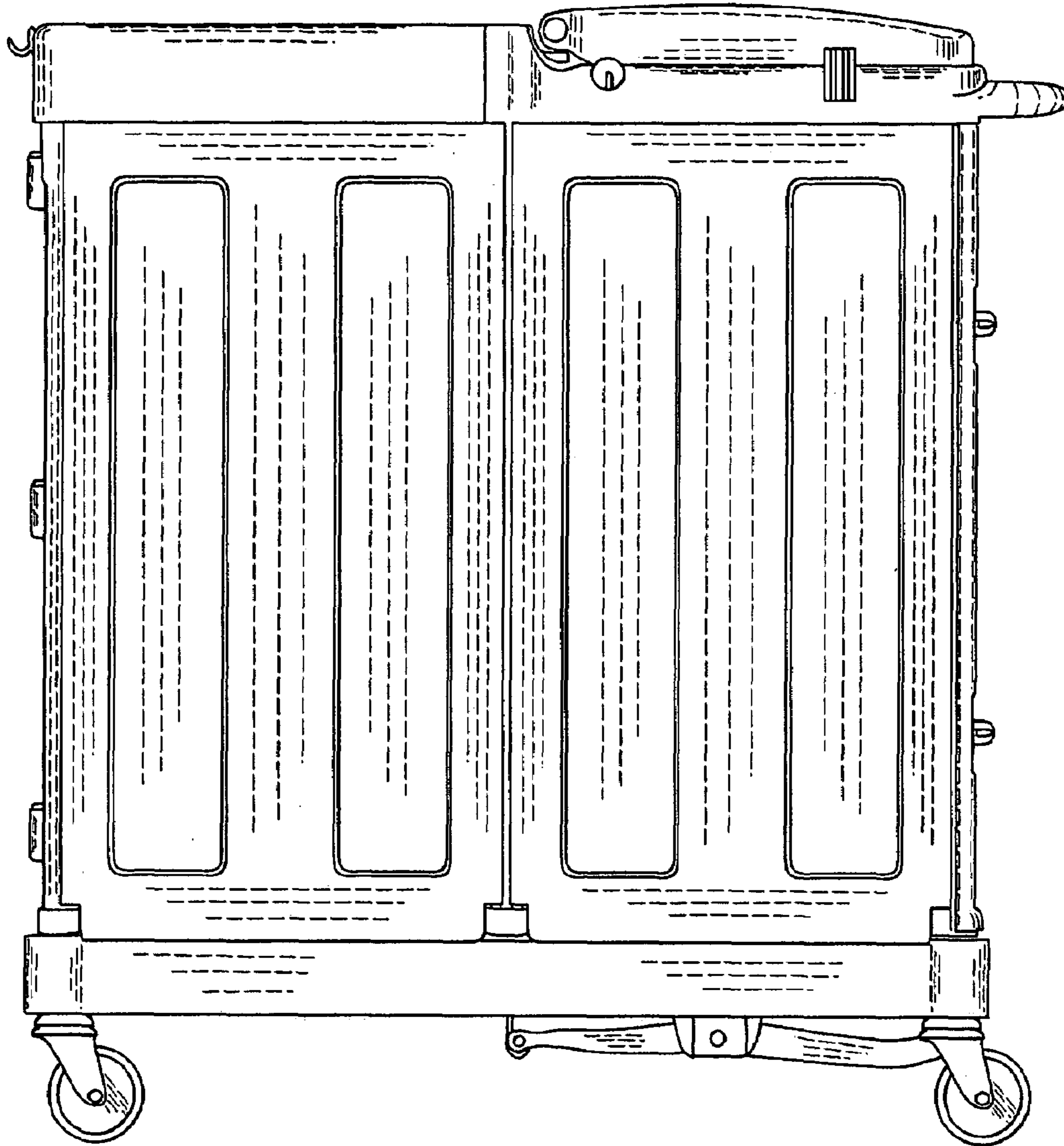

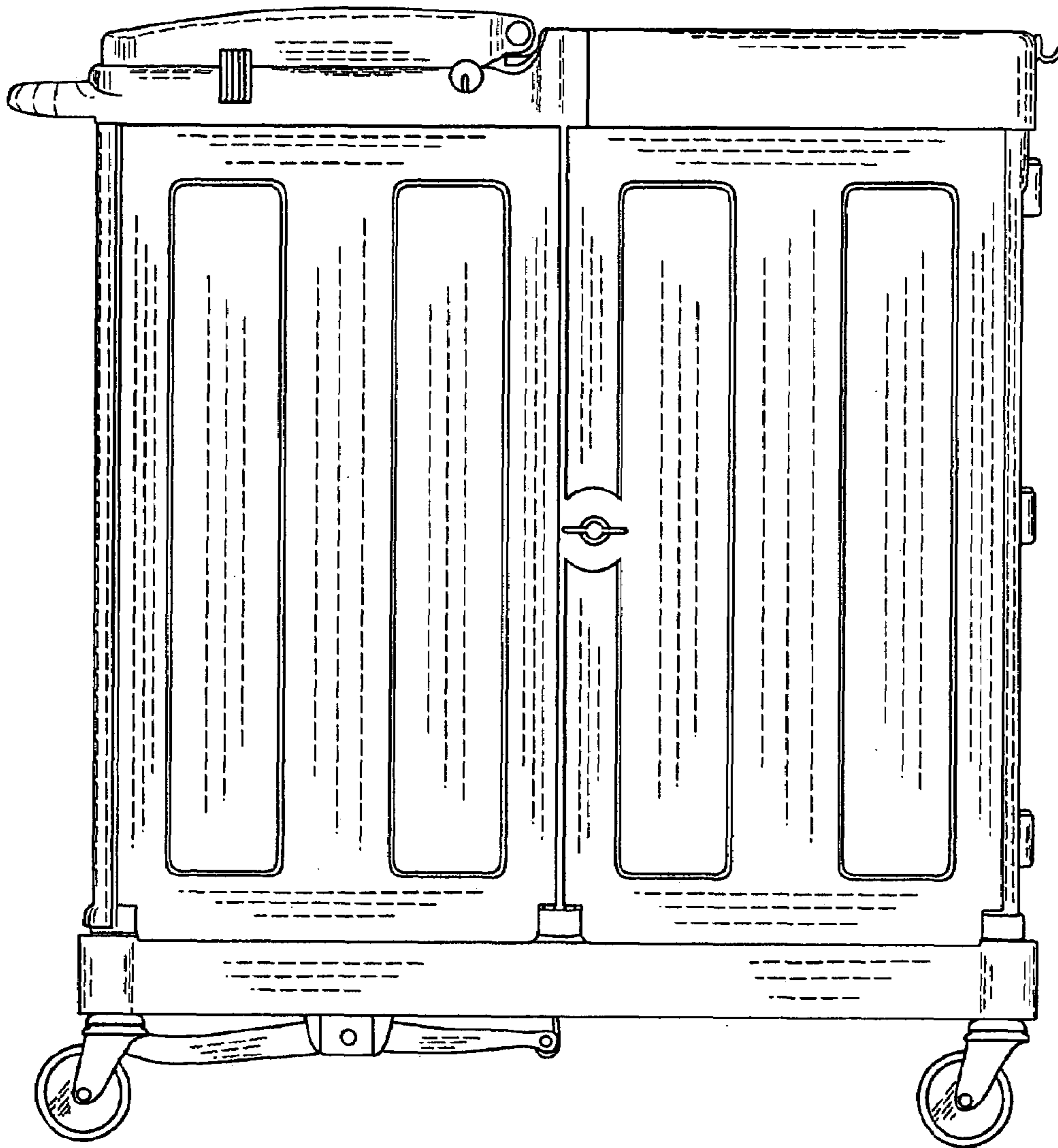

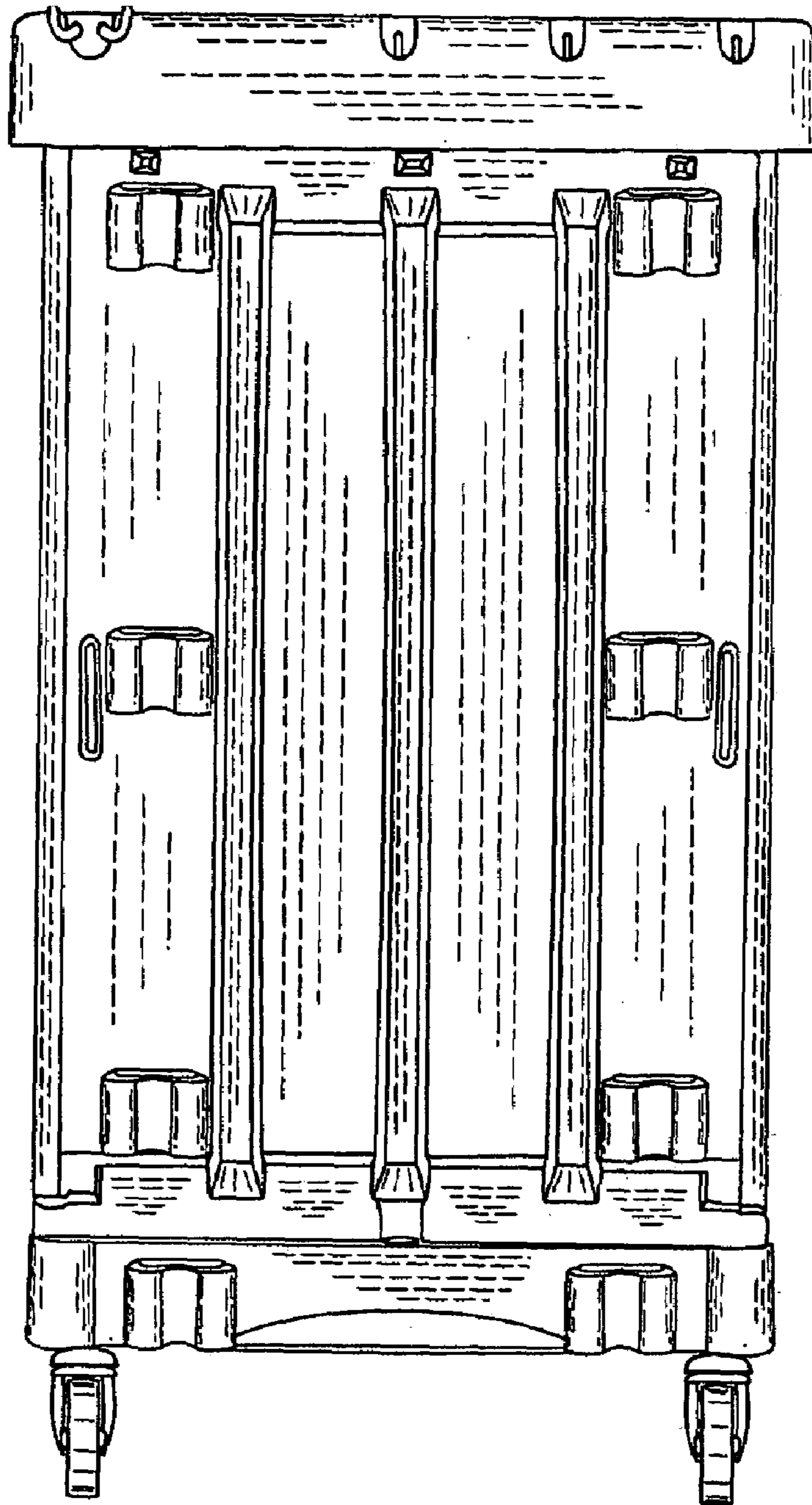

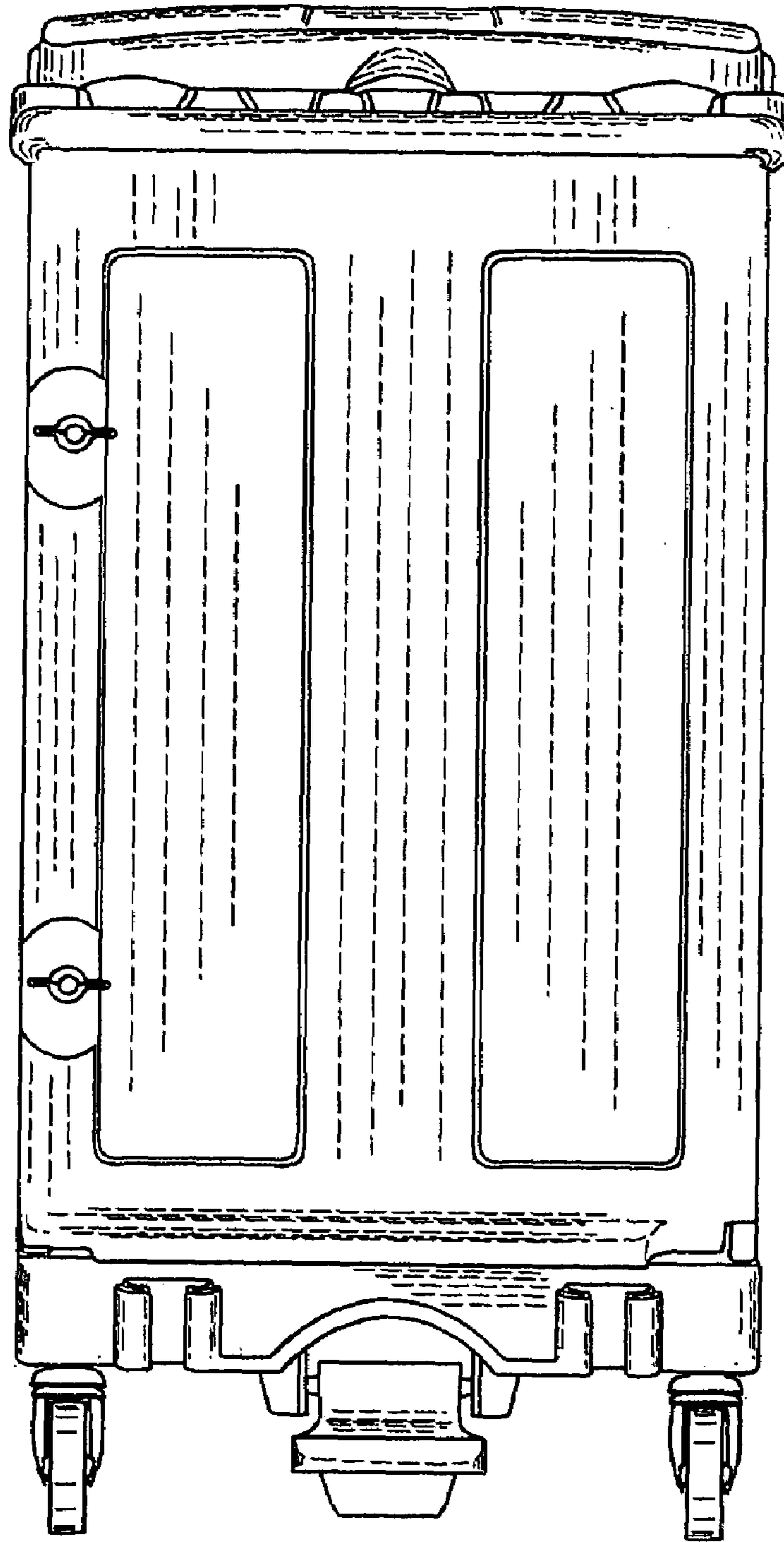
