(57) **CLAIM**

I claim the ornamental design for an equipment mounting rack, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the equipment mounting rack; FIG. 2 is a right side view of the equipment mounting rack; FIG. 3 is a front view of the equipment mounting rack; FIG. 4 is rear view of the equipment mounting rack; FIG. 5 is left side view of the equipment mounting rack; and, FIG. 6 is a bottom view of the equipment mounting rack.

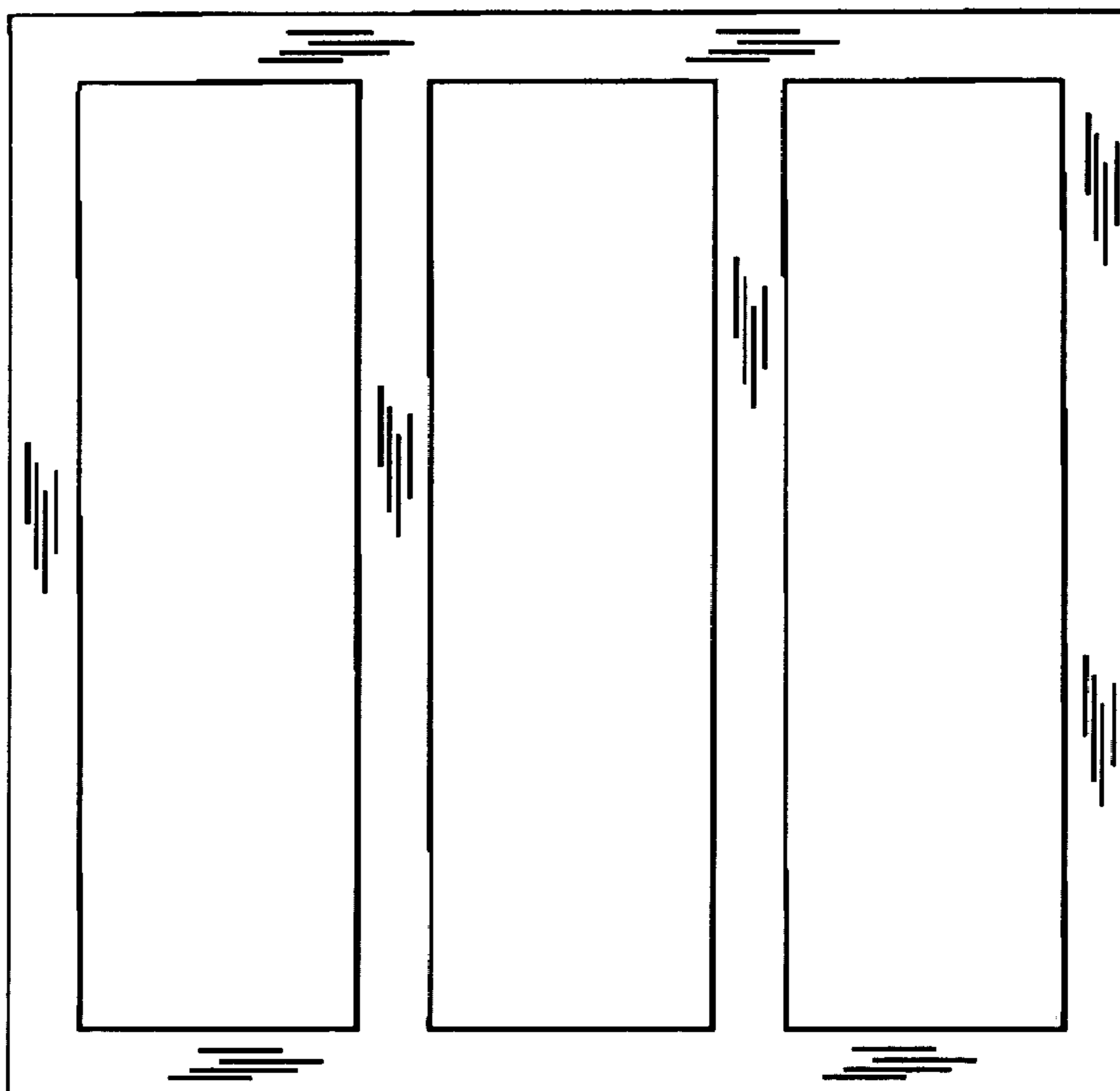

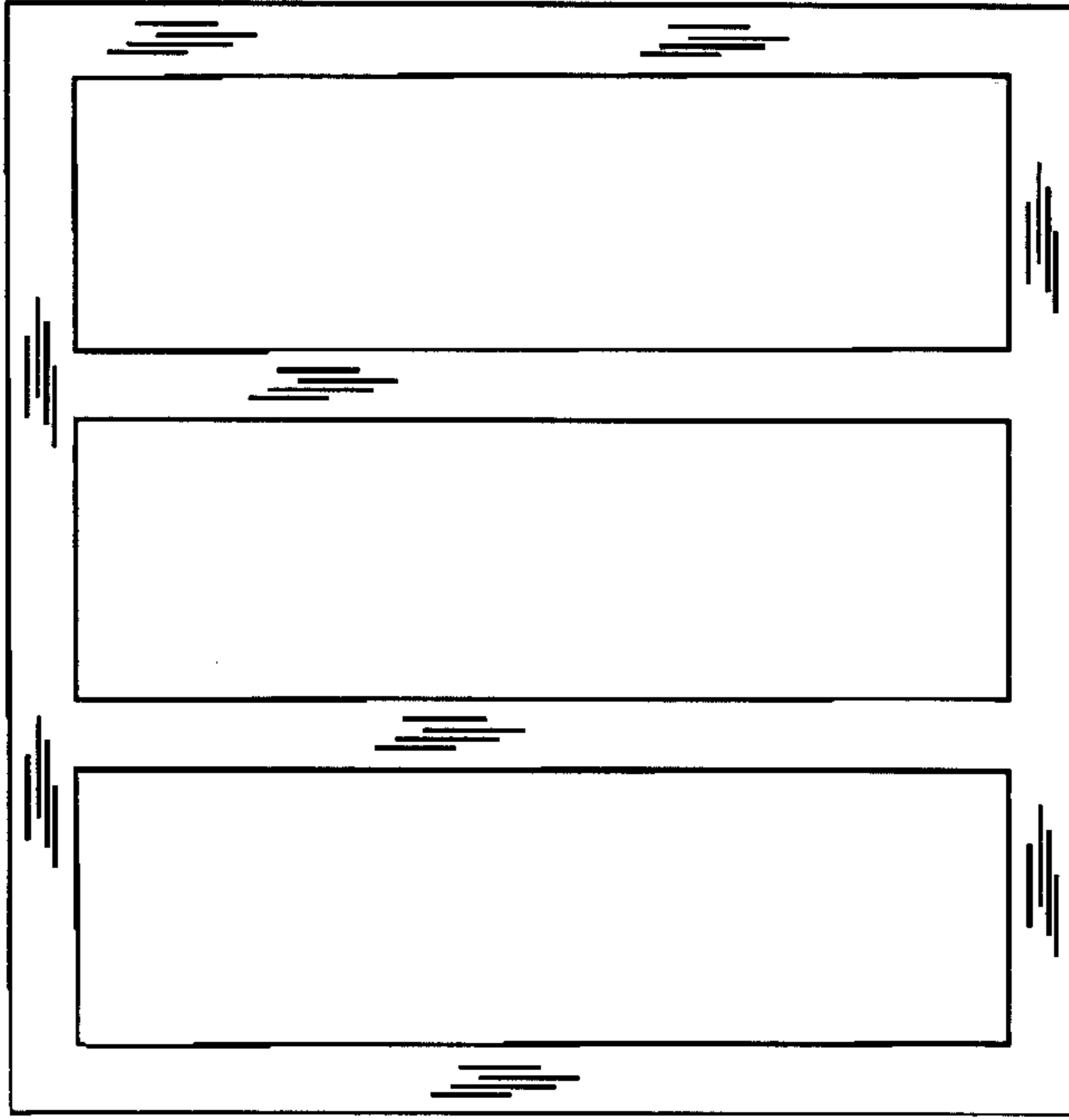

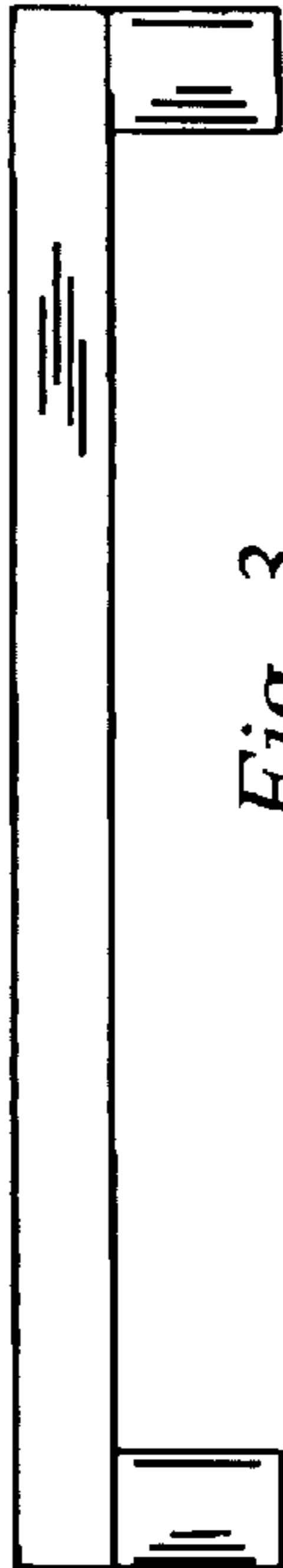

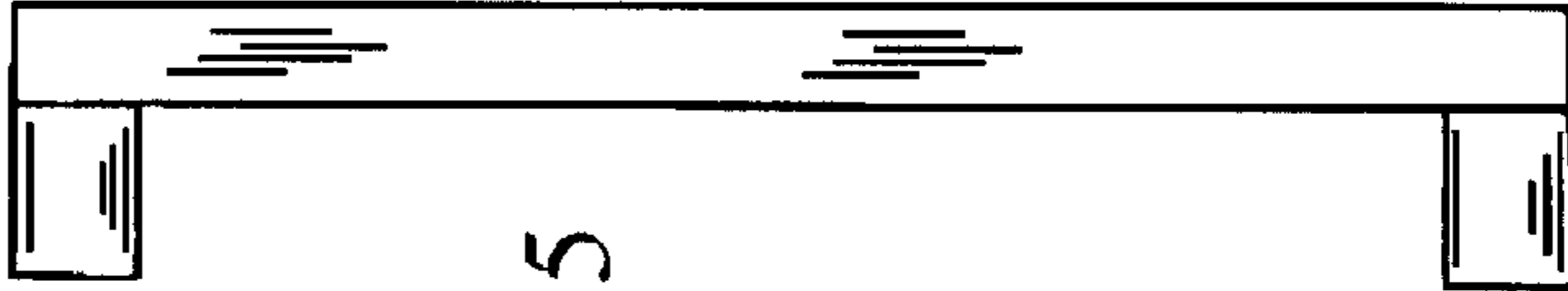

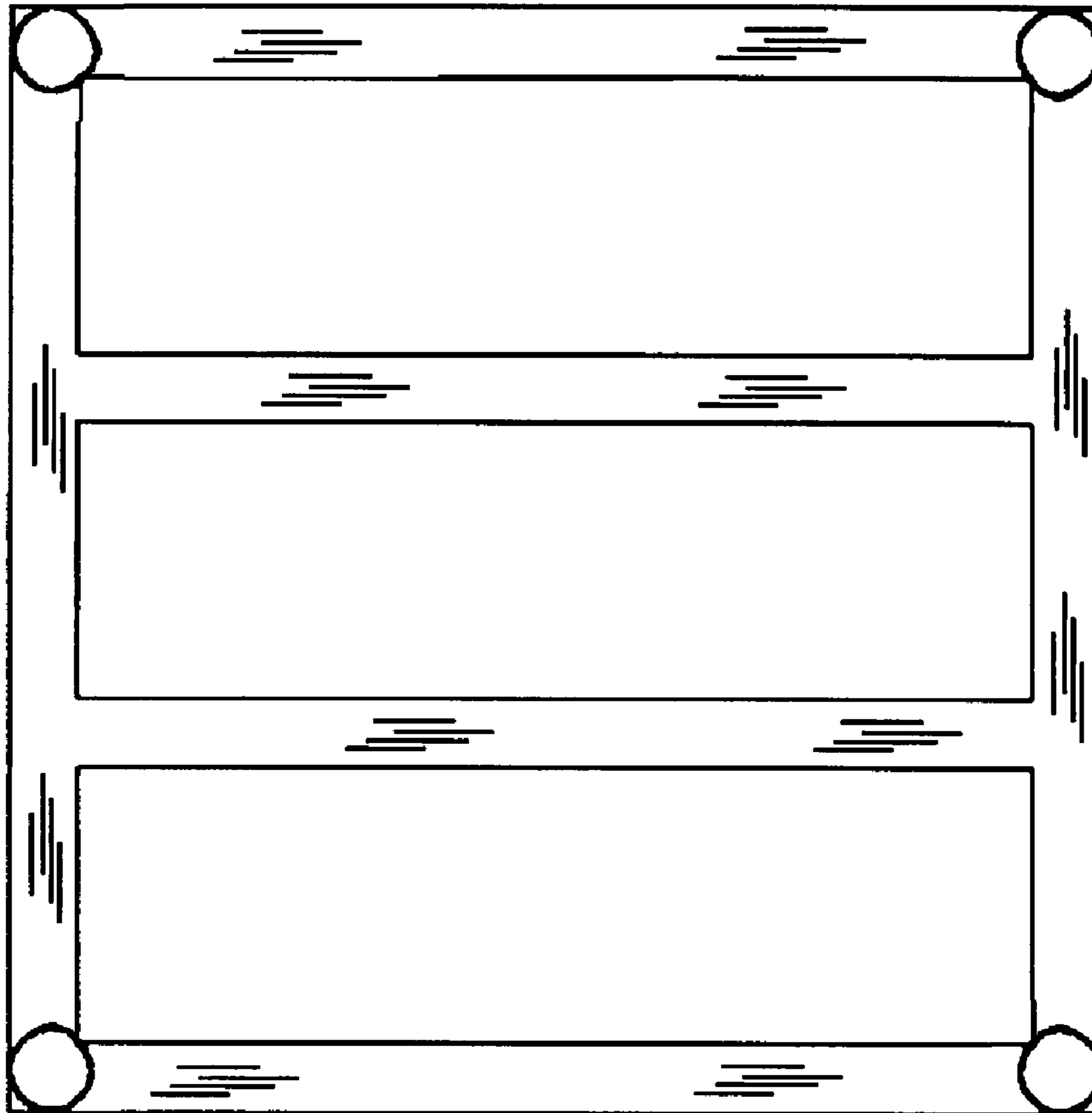
