The ornamental design for an outsole of a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an outsole of a shoe showing my new design;

FIG. 2 is a bottom view of the outsole of a shoe shown in FIG. 1;

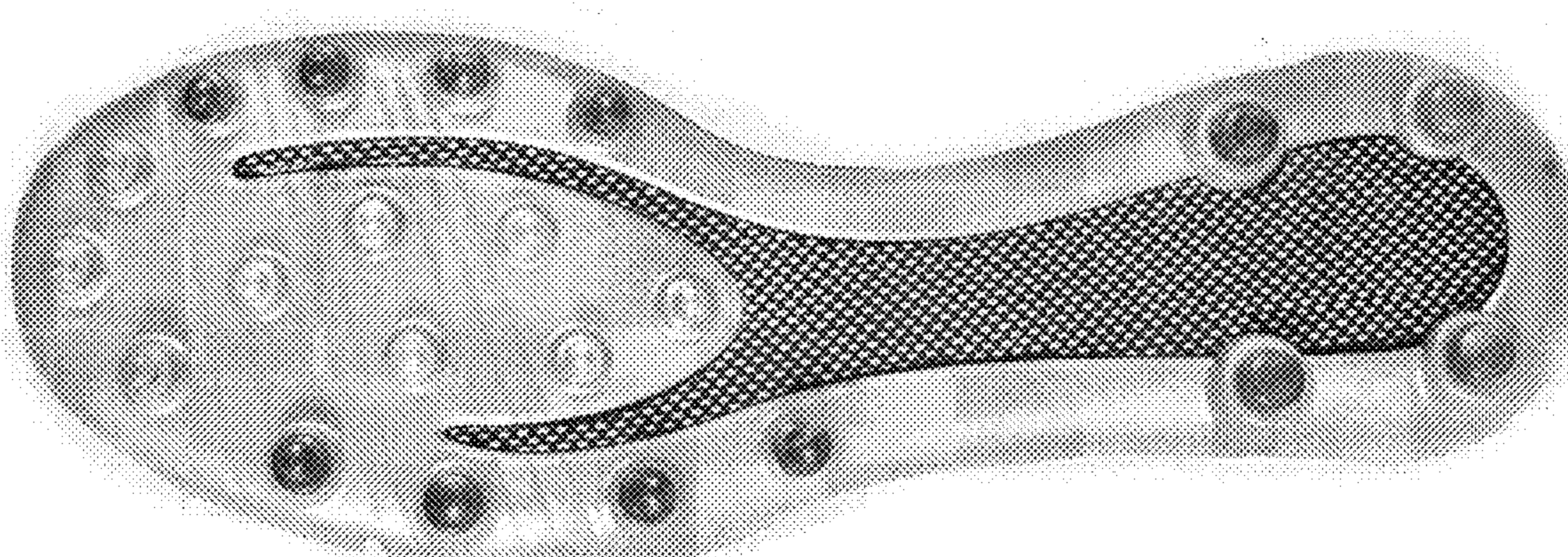
FIG. 3 is a side view of the outsole of a shoe shown in FIG. 1;

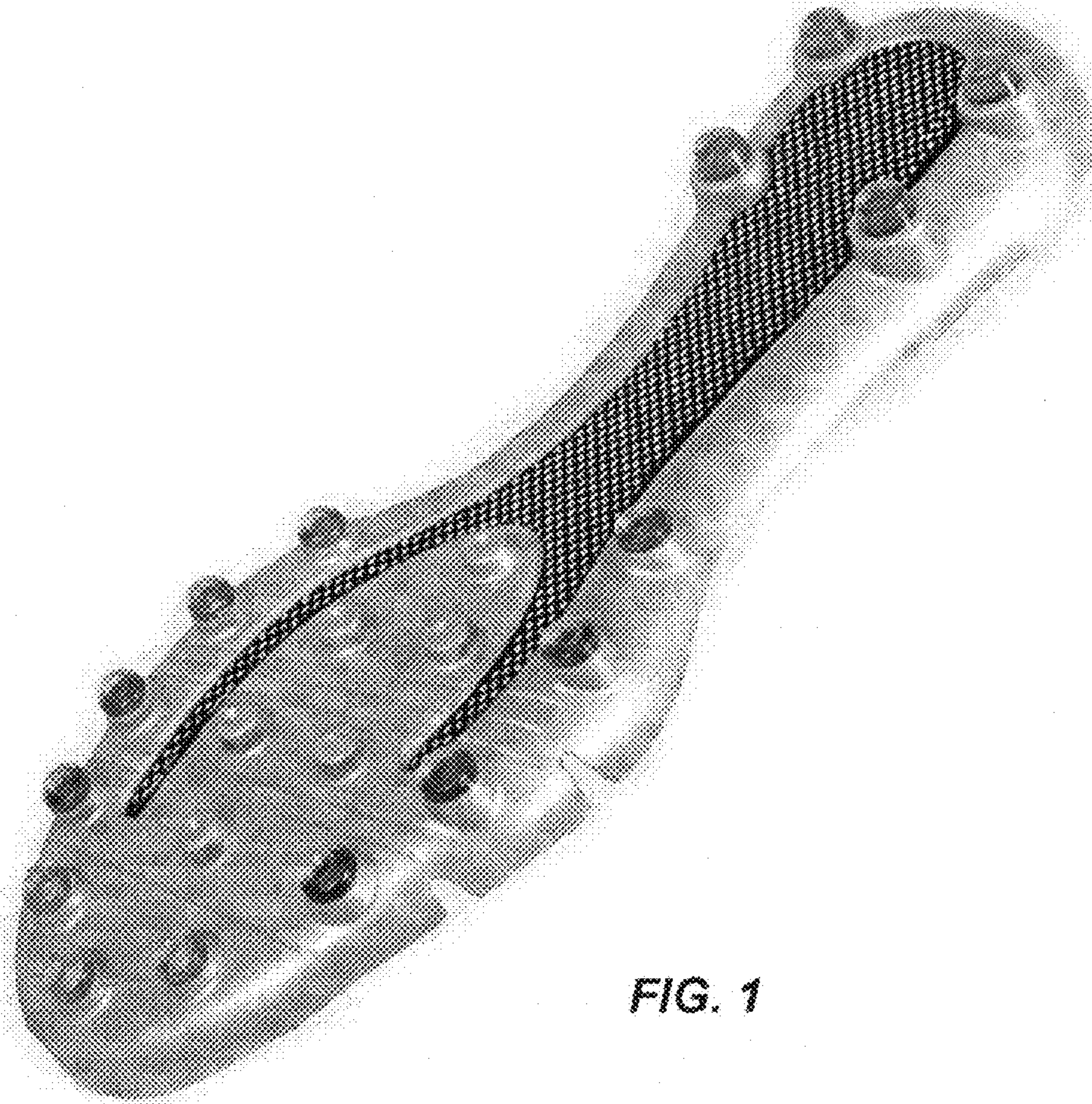

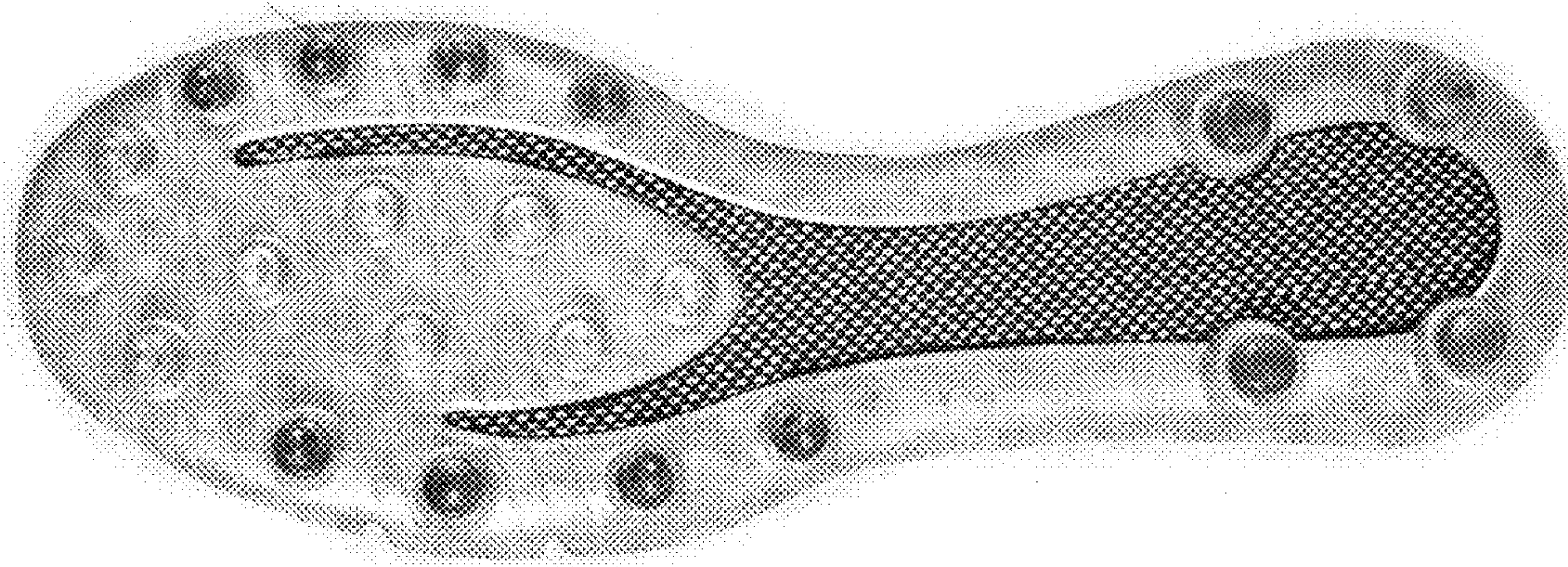

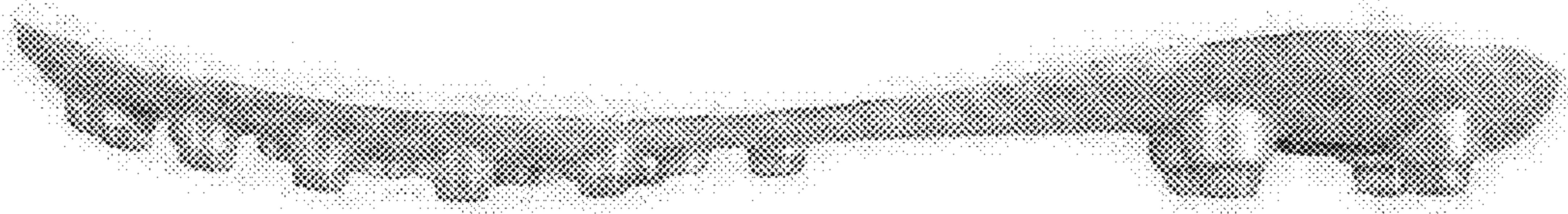

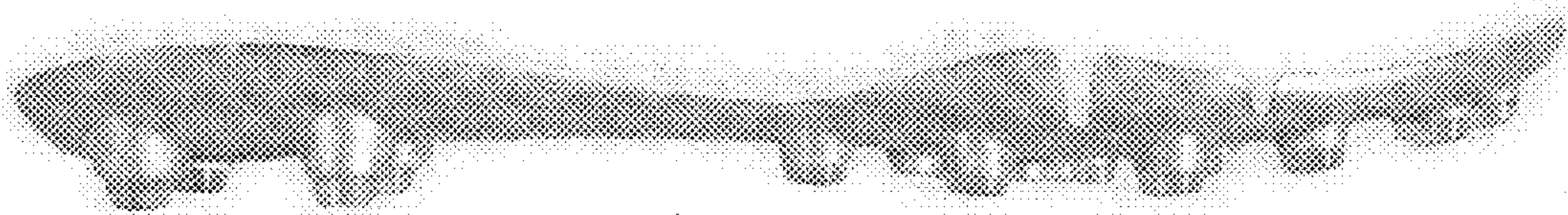

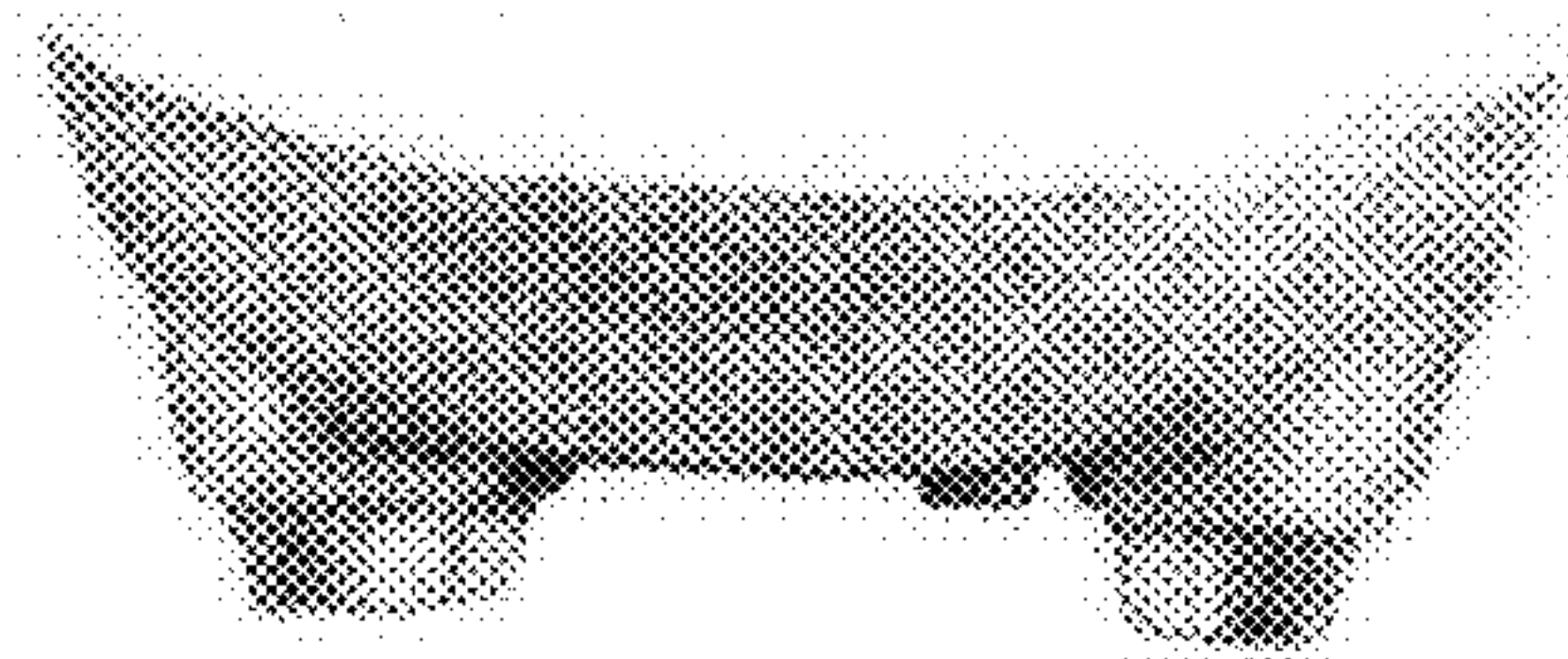
