**DESCRIPTION**

FIG. 1 is a front lateral perspective view showing the footwear;

FIG. 2 is a medial side elevation view thereof;

FIG. 3 is a lateral side elevation view thereof;

FIG. 4 is a front view thereof;

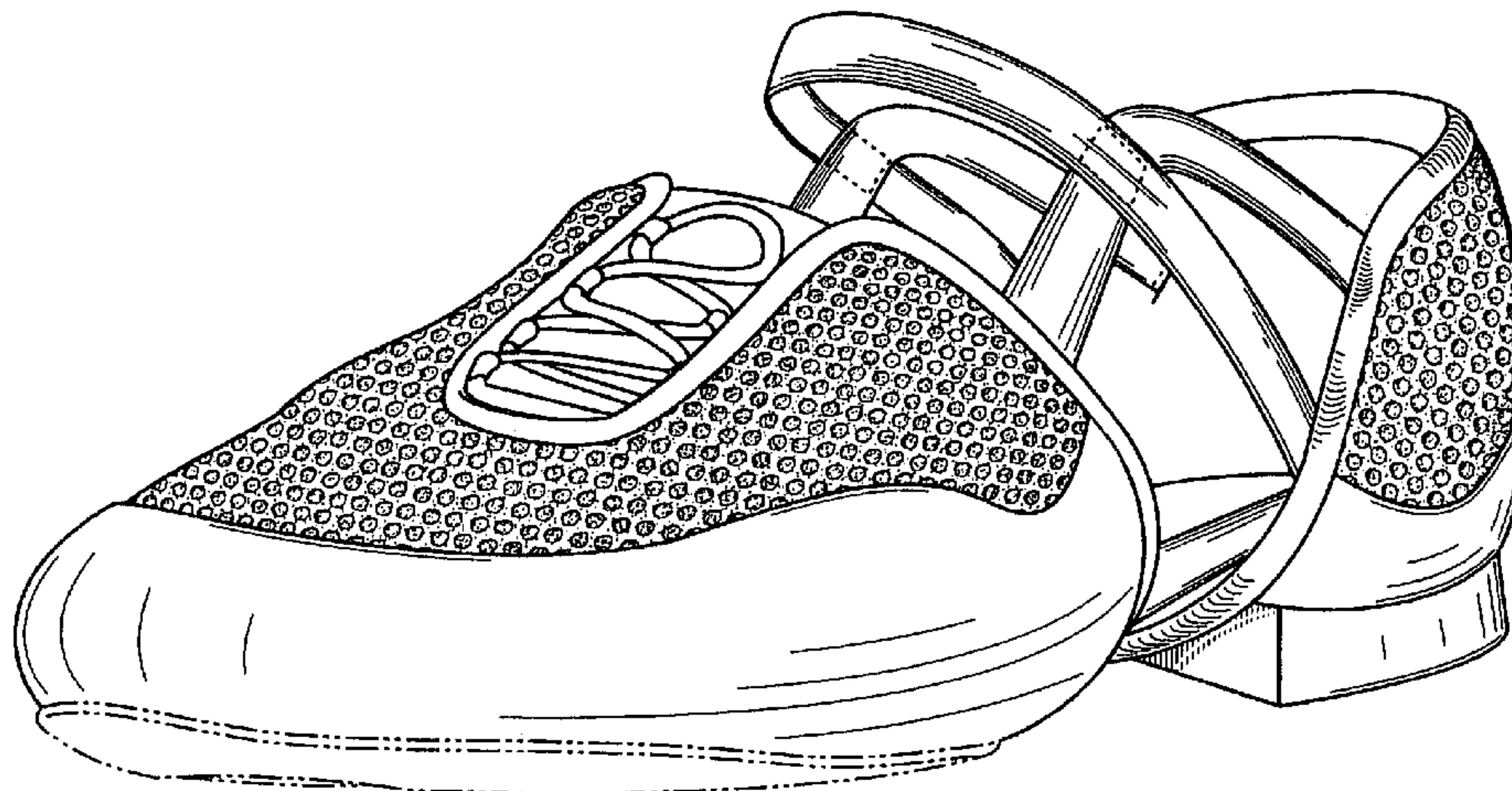
FIG. 5 is a rear view thereof;

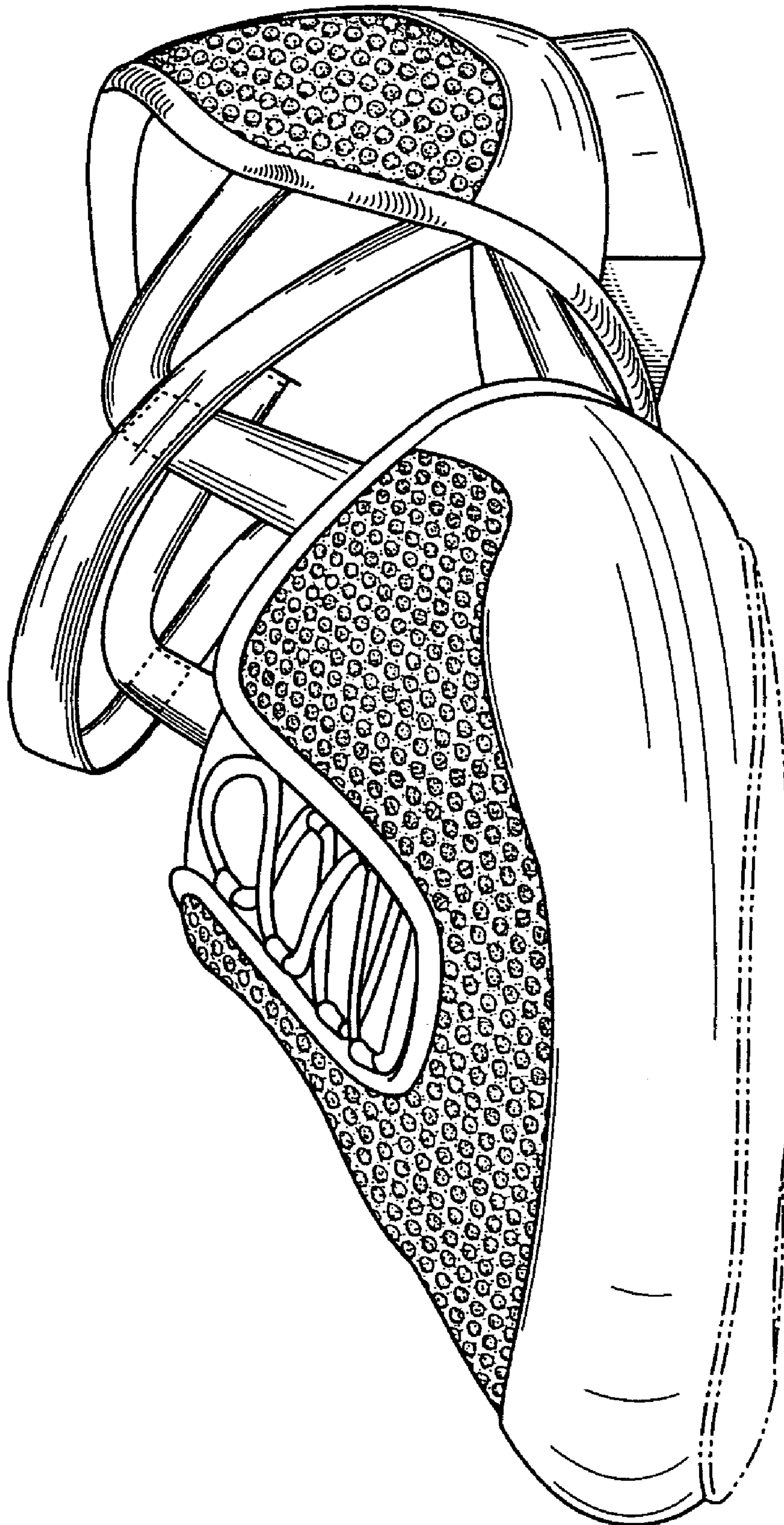
FIG. 6 is a top view thereof; and,

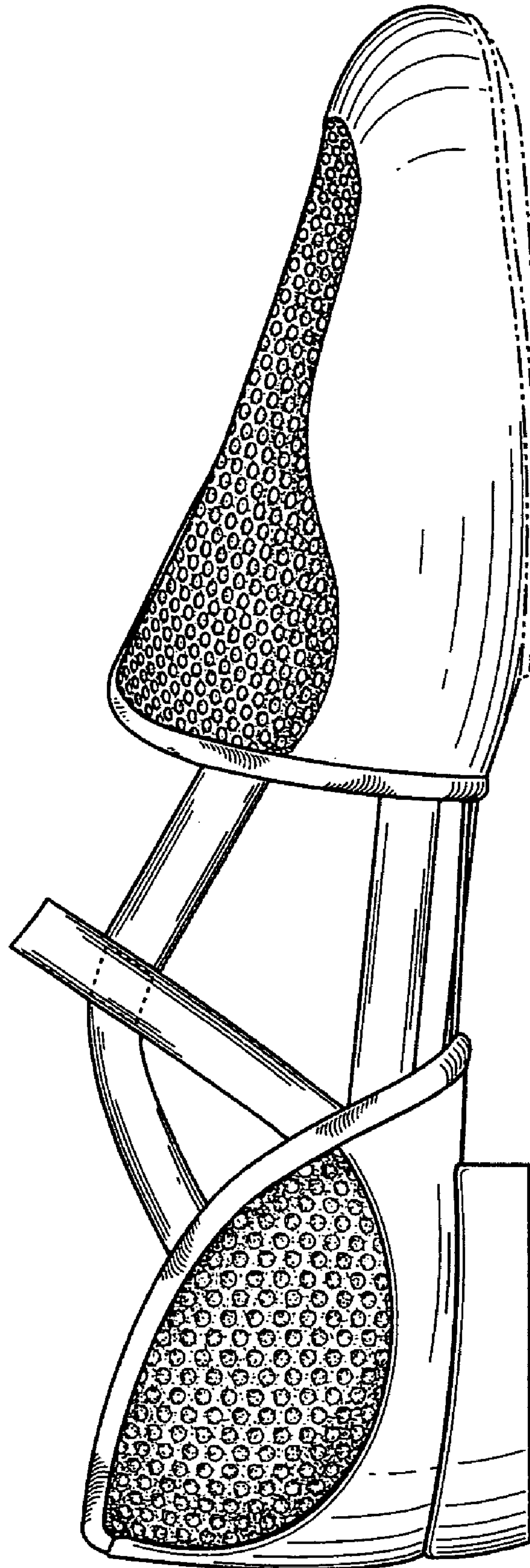

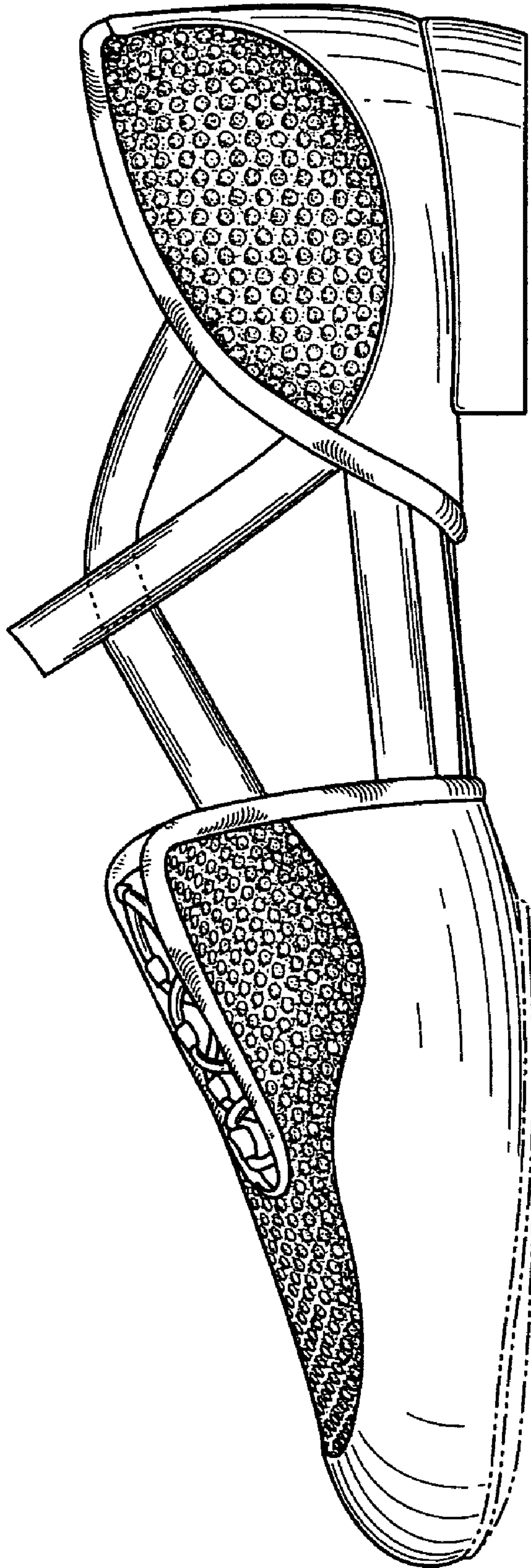

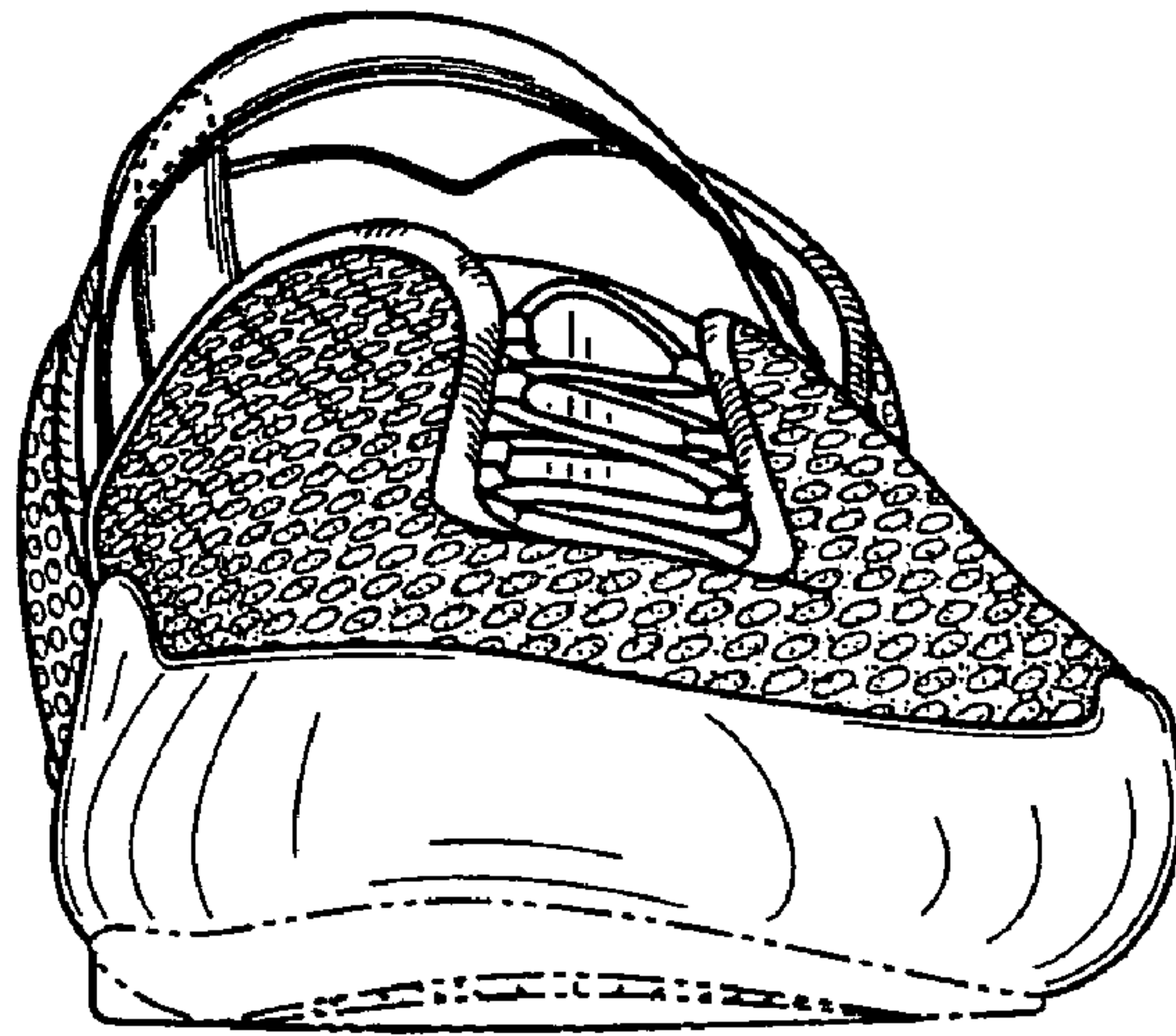

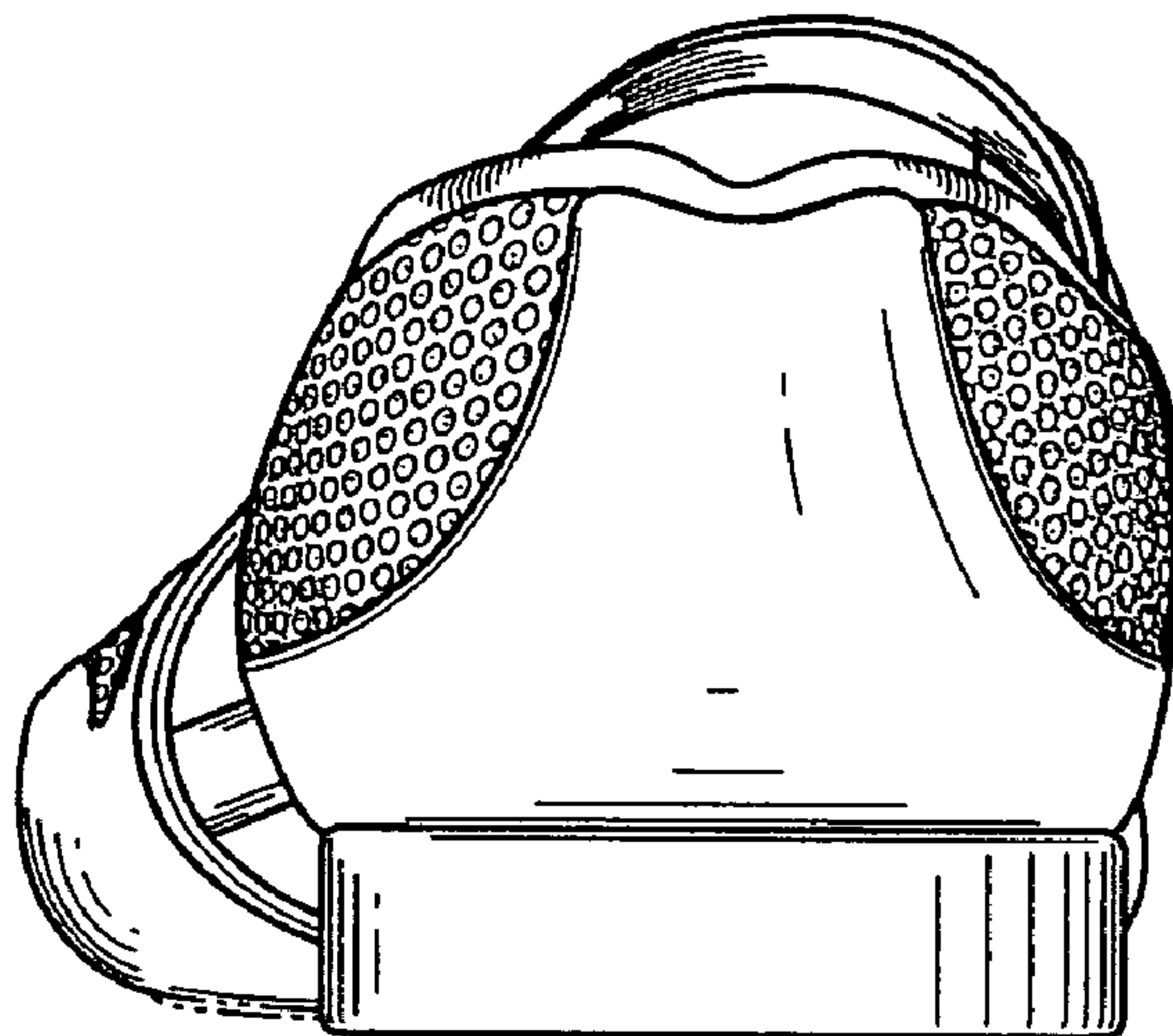

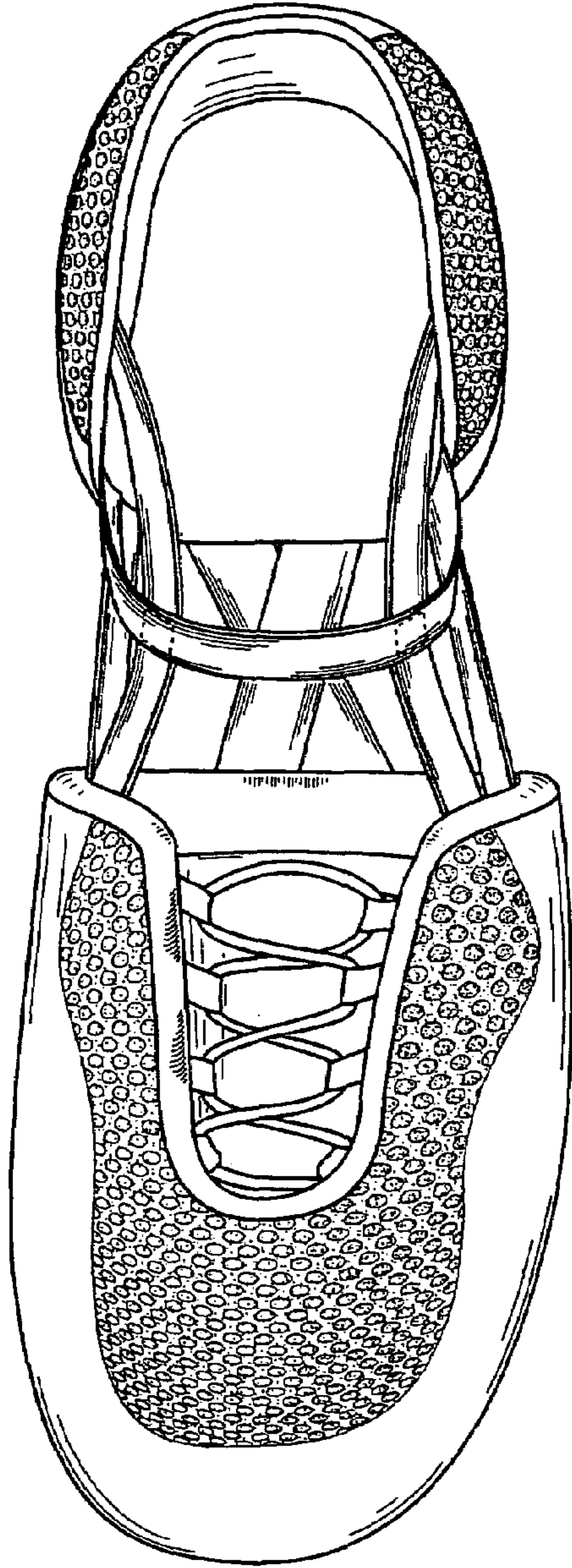

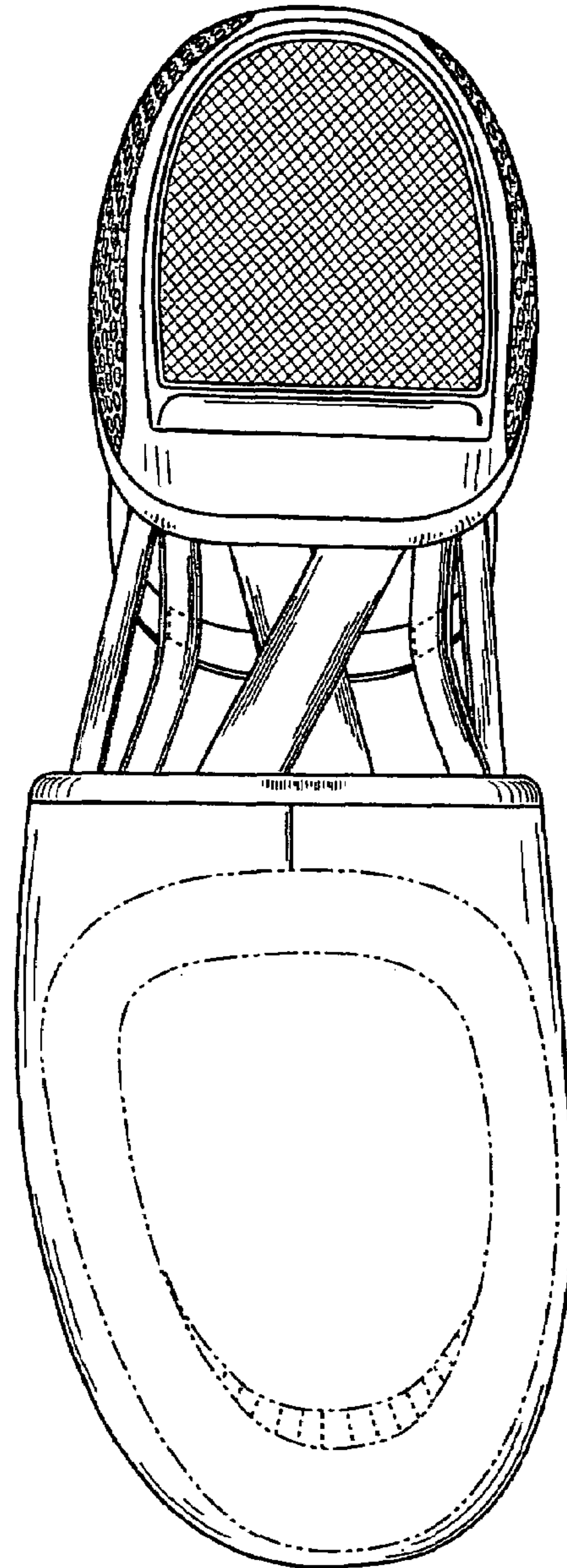
