DESCRIPTION

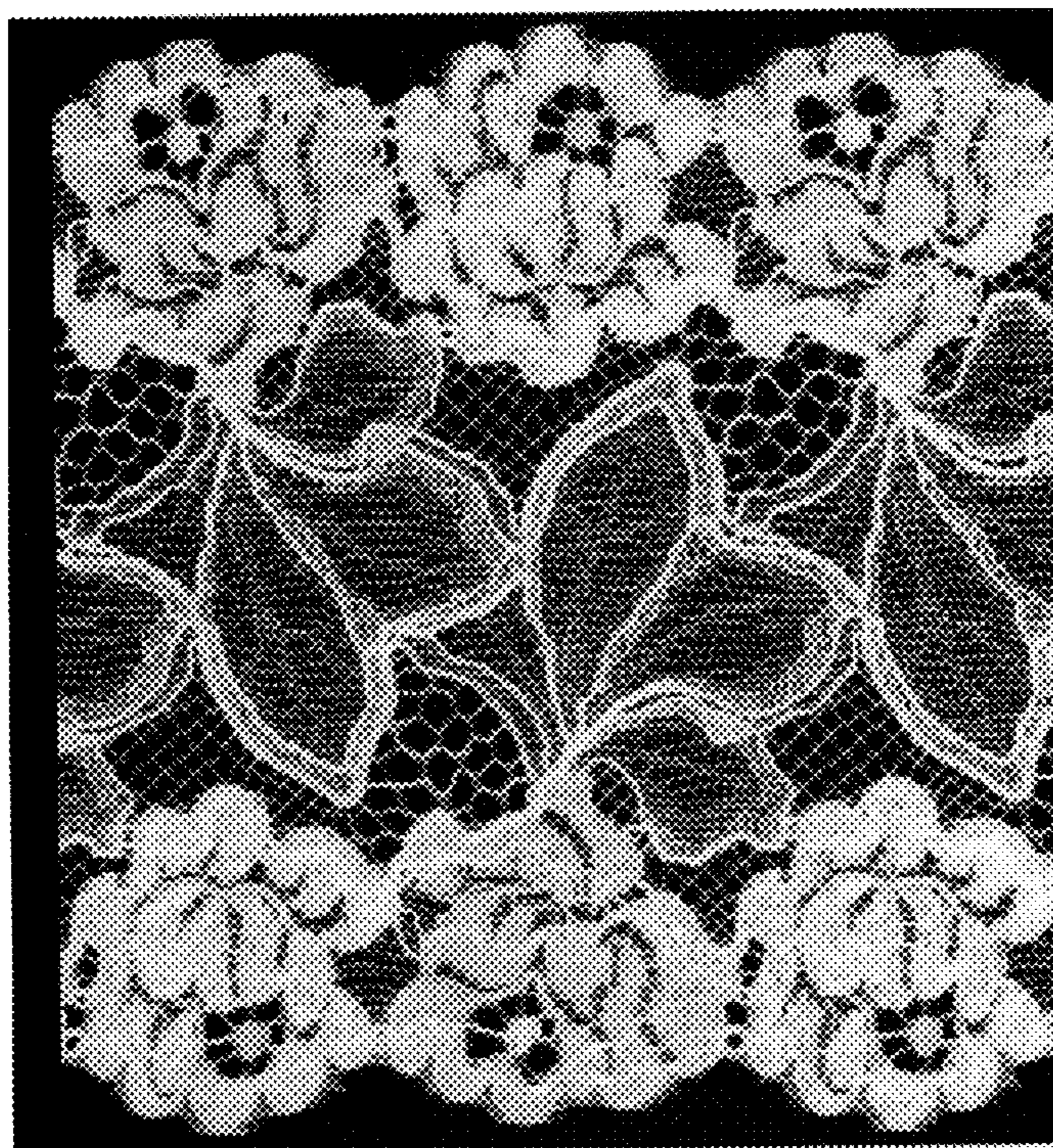
FIG. 1 is a front view of a lace fabric in accordance with the present invention;

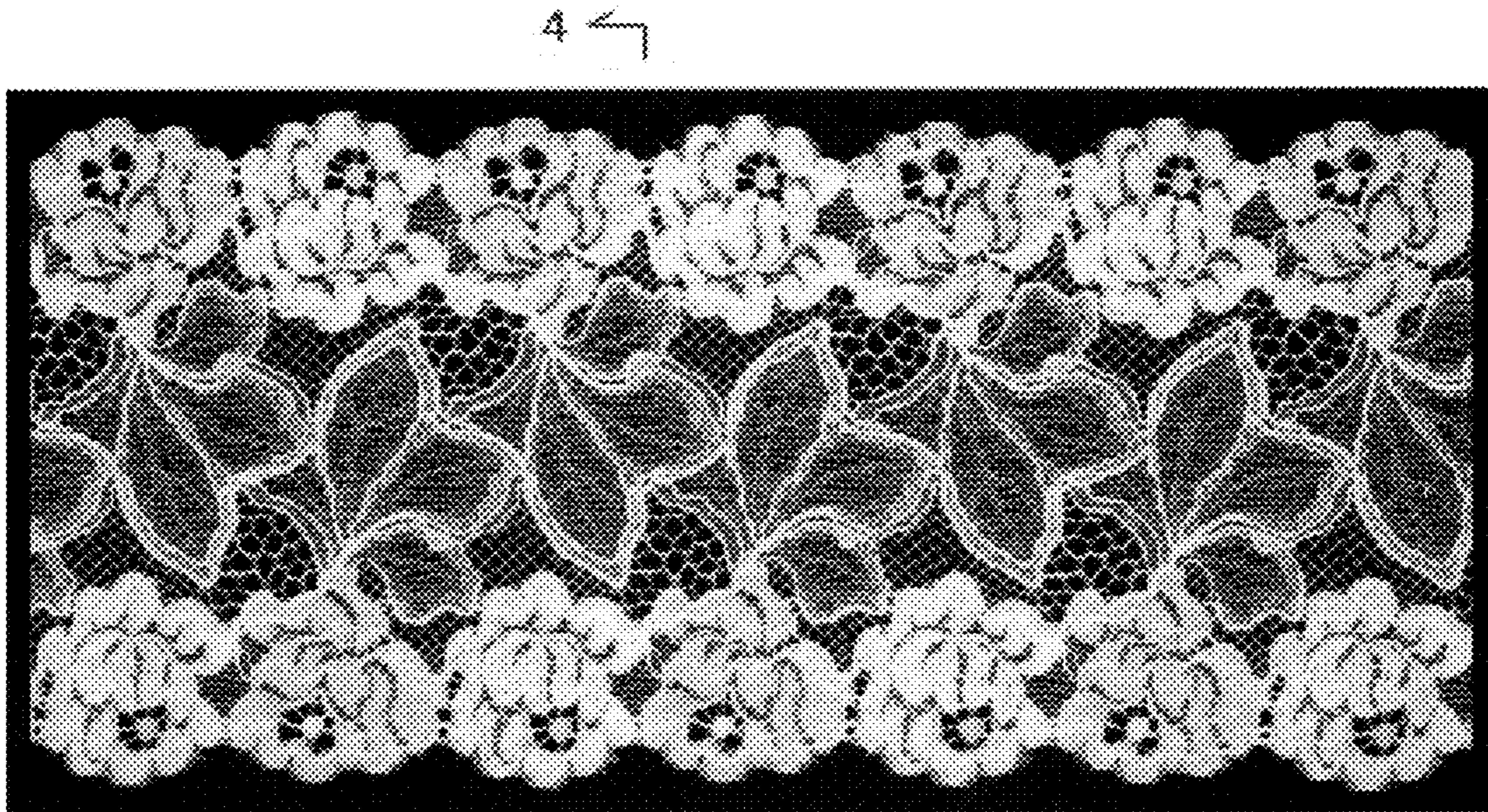
FIG. 2 is a back side view thereof;

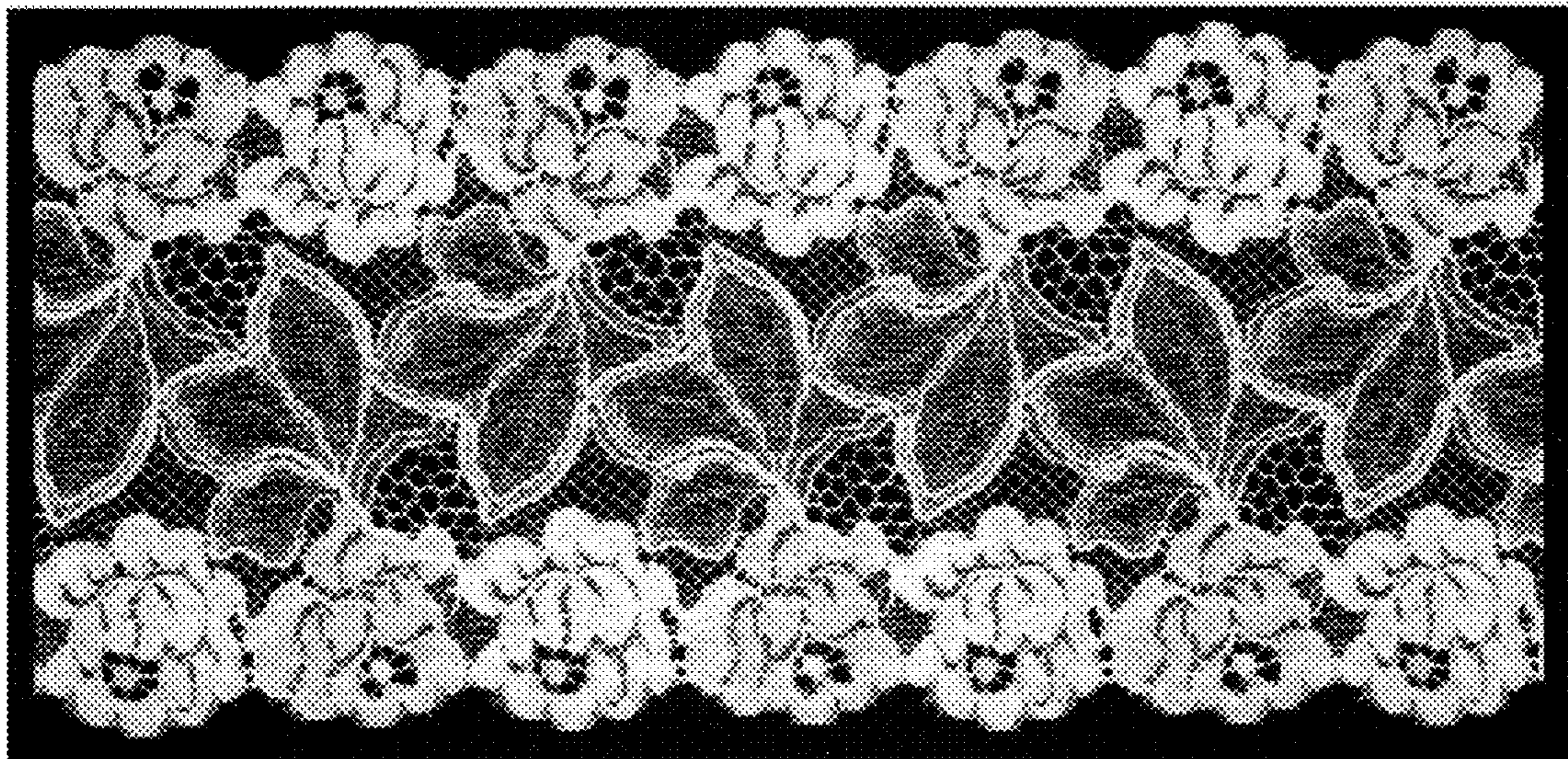

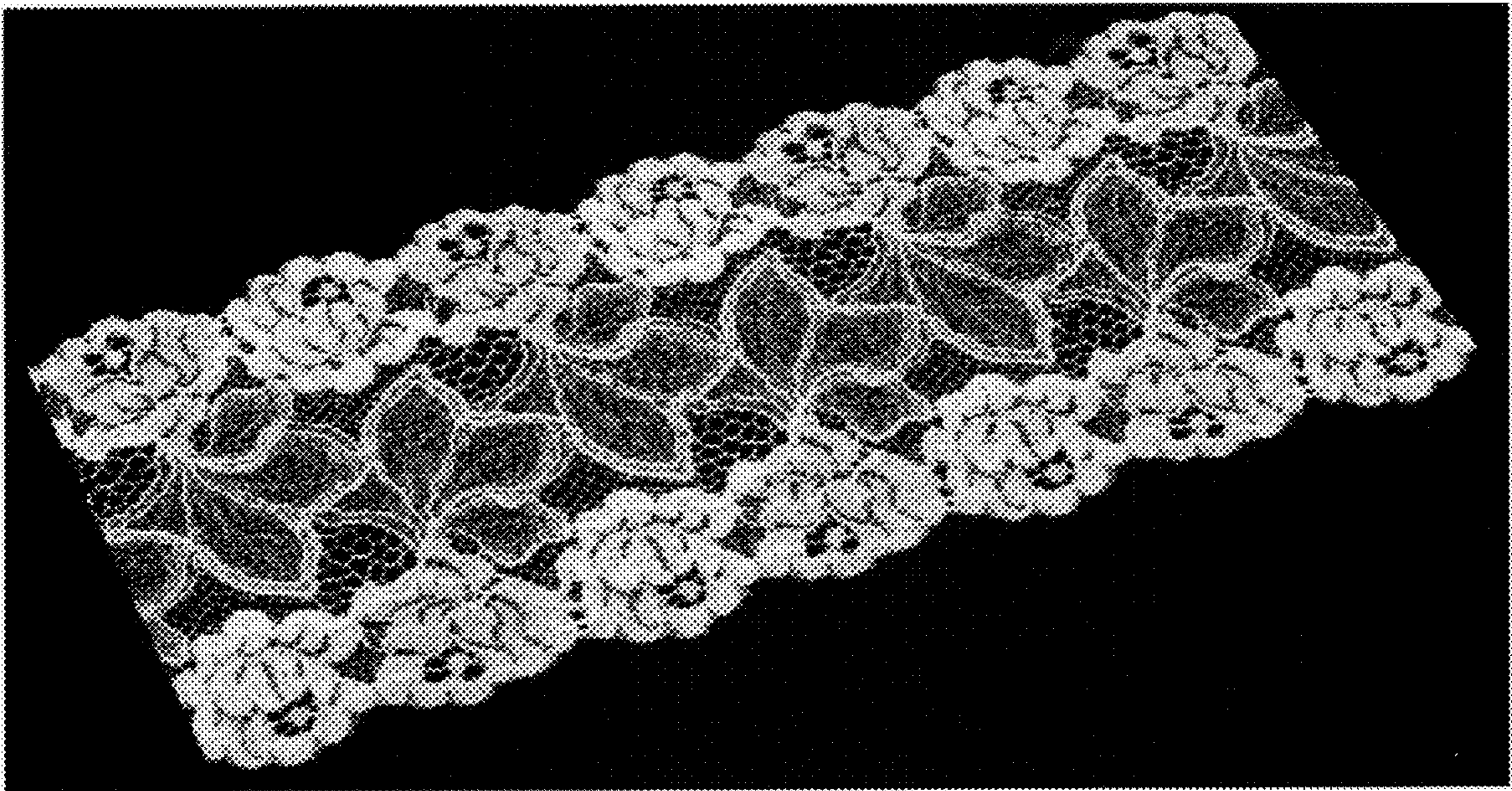

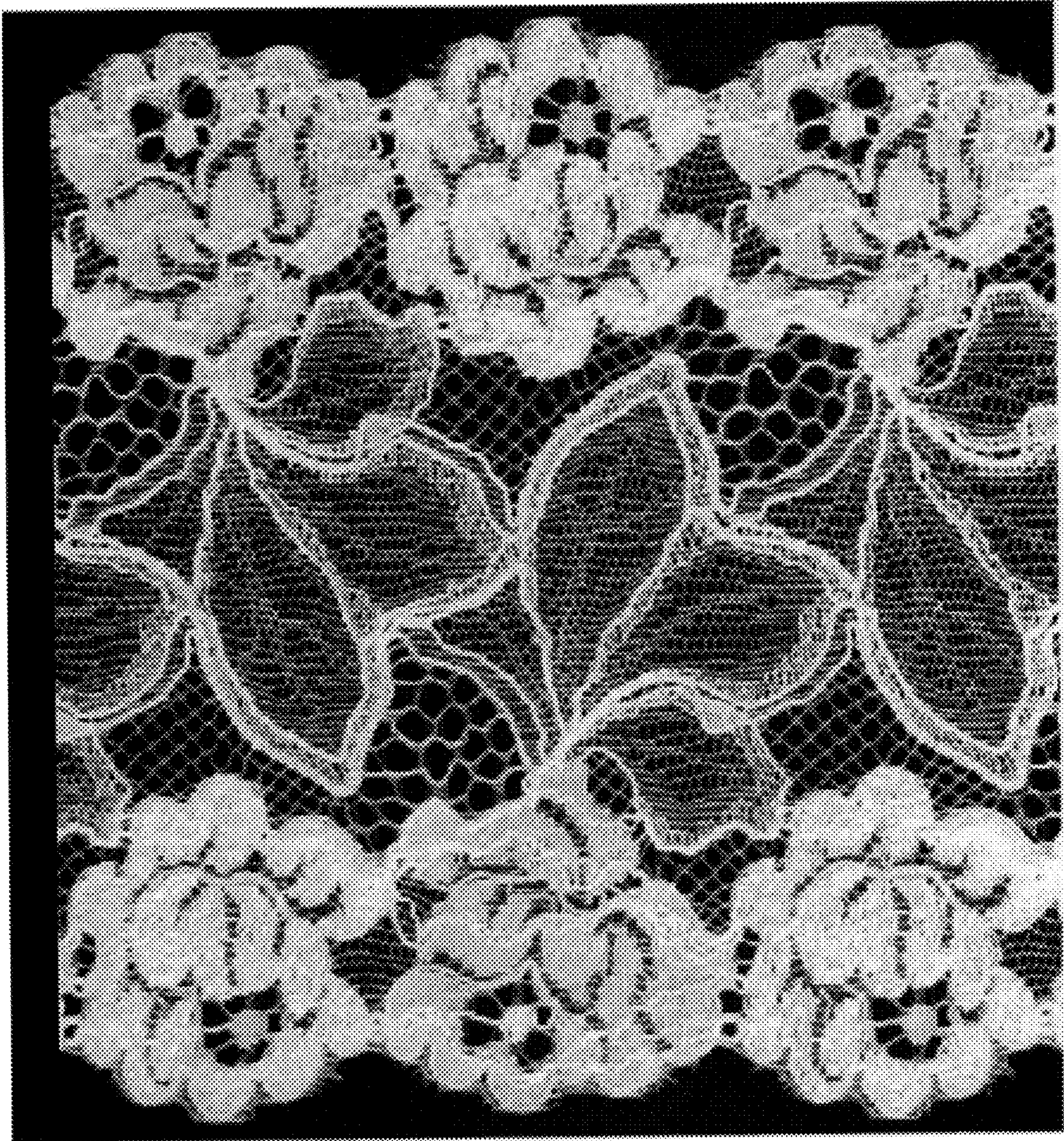
