DESCRIPTION

FIG. 1 is a front elevational view of the toddler hooded
stroller bag showing our novel design in use by a toddler;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view of the toddler hooded stroller
bag of the present invention.

The broken line showing of a partial human face in FIG. 1
is for illustrative only and forms no part of the claimed
design. Other broken lines shown on the claimed design
represent conventional stitching or surface treatment resem-
bling stitching.

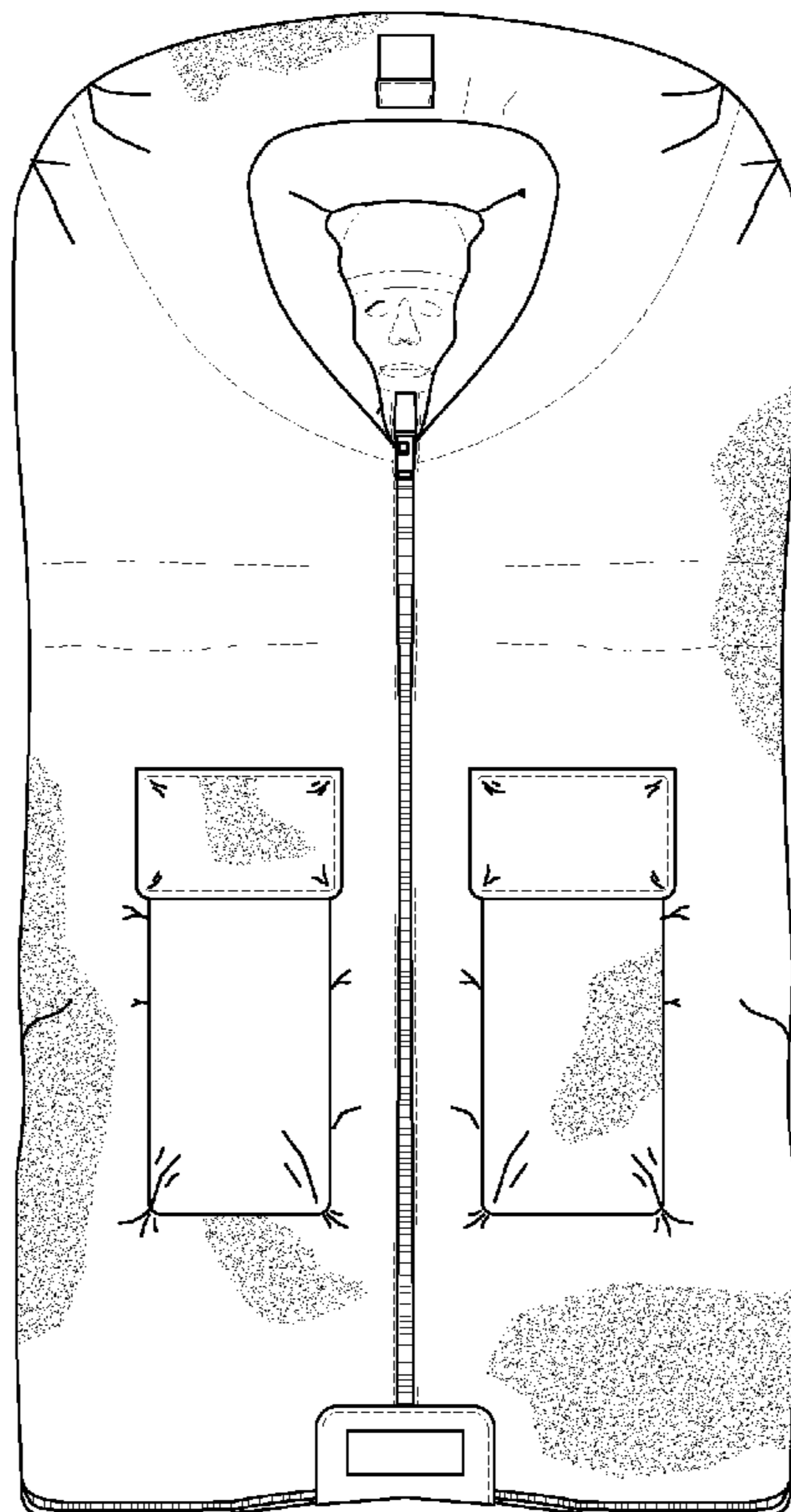

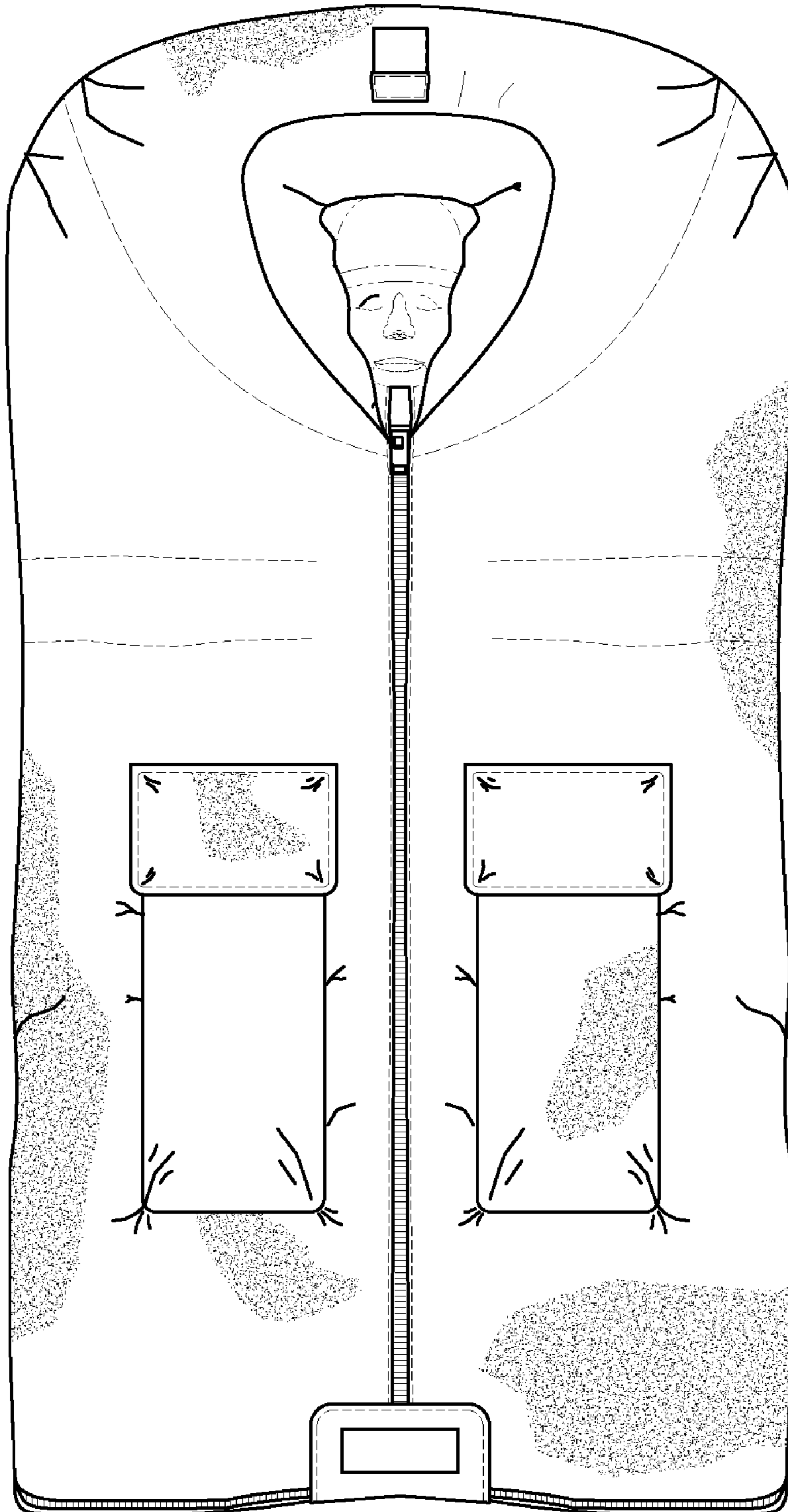

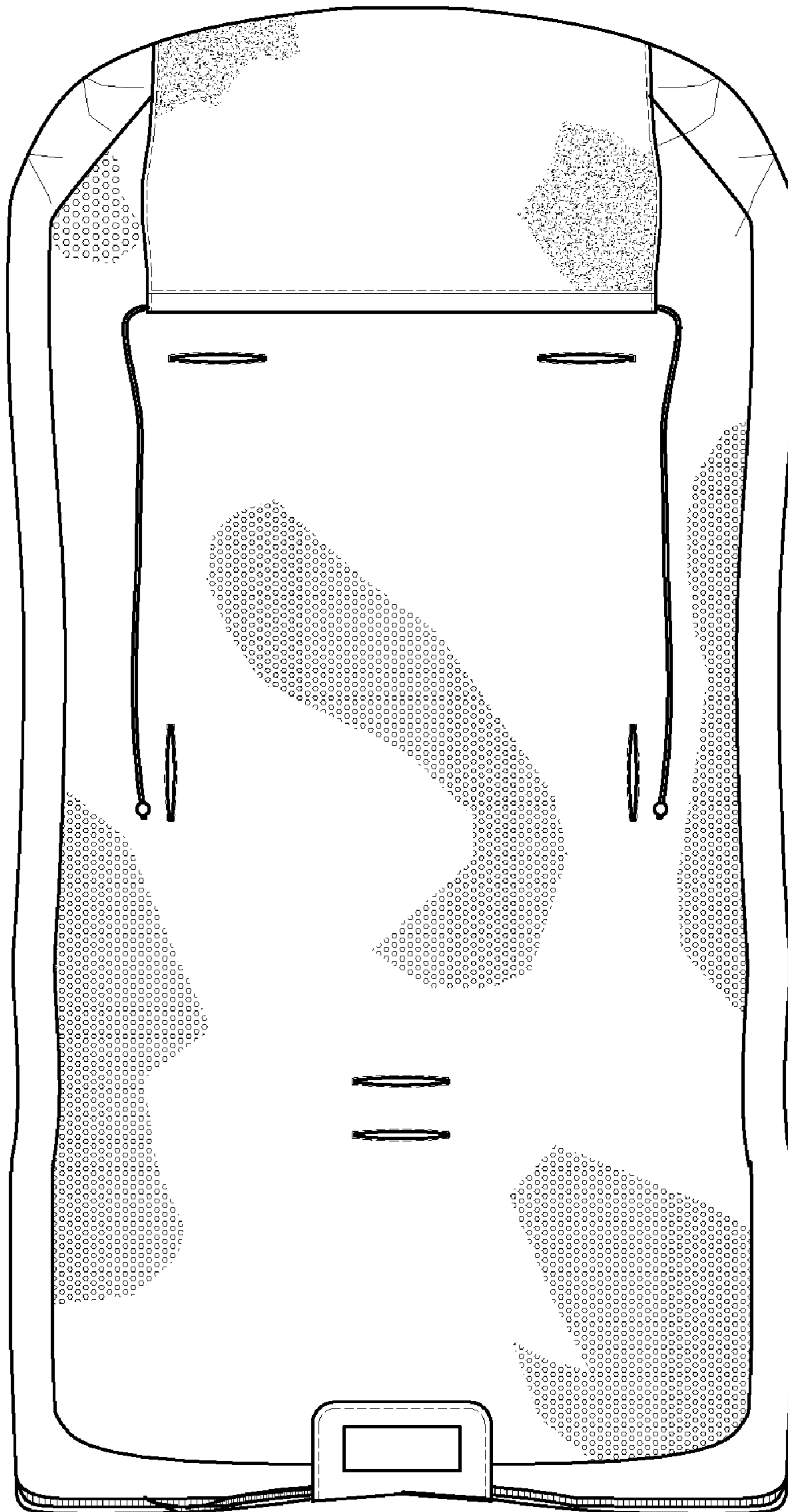

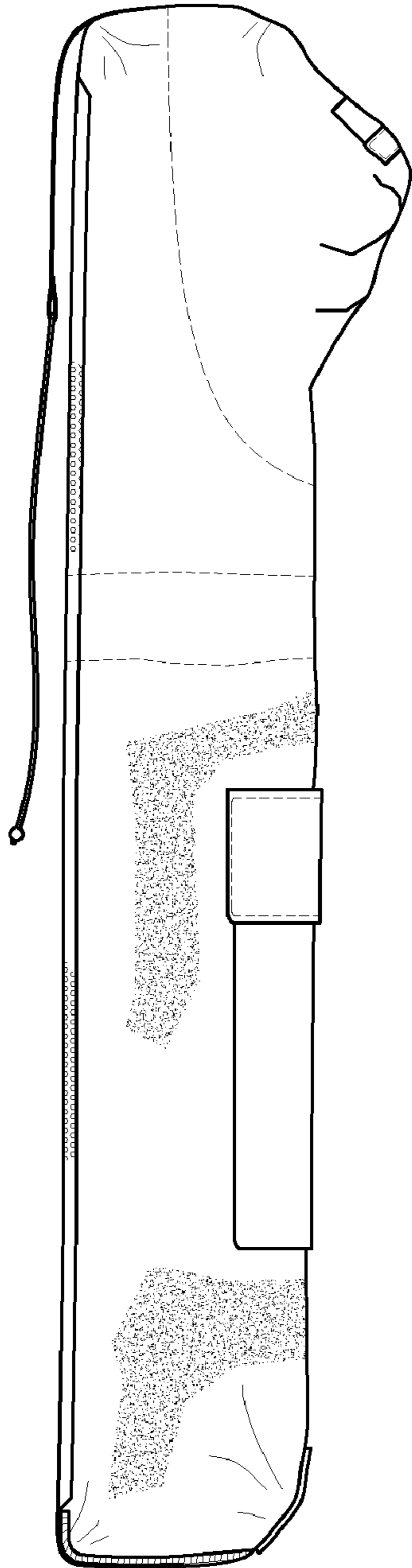

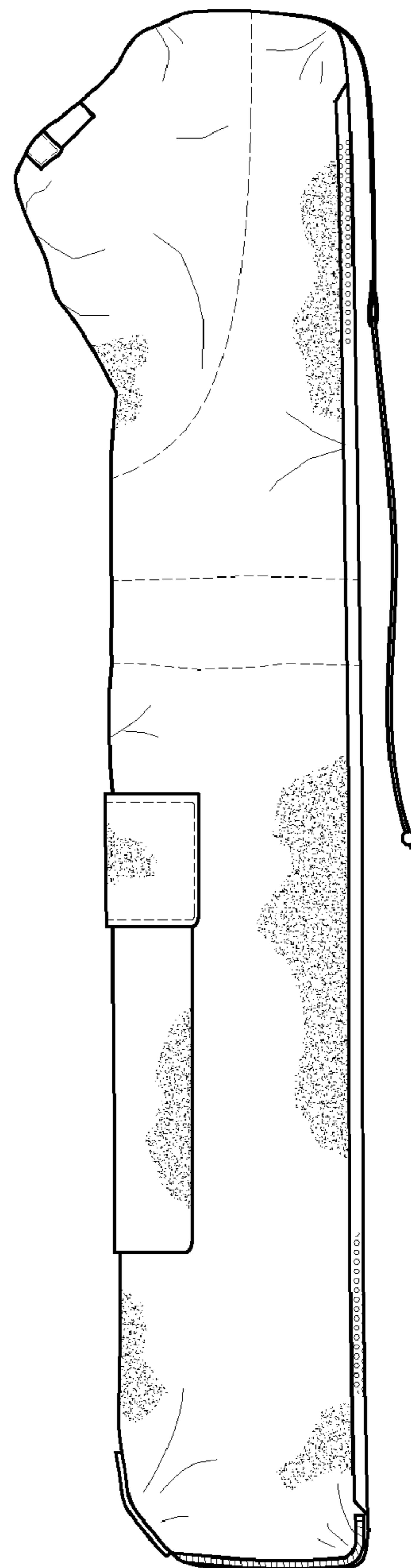

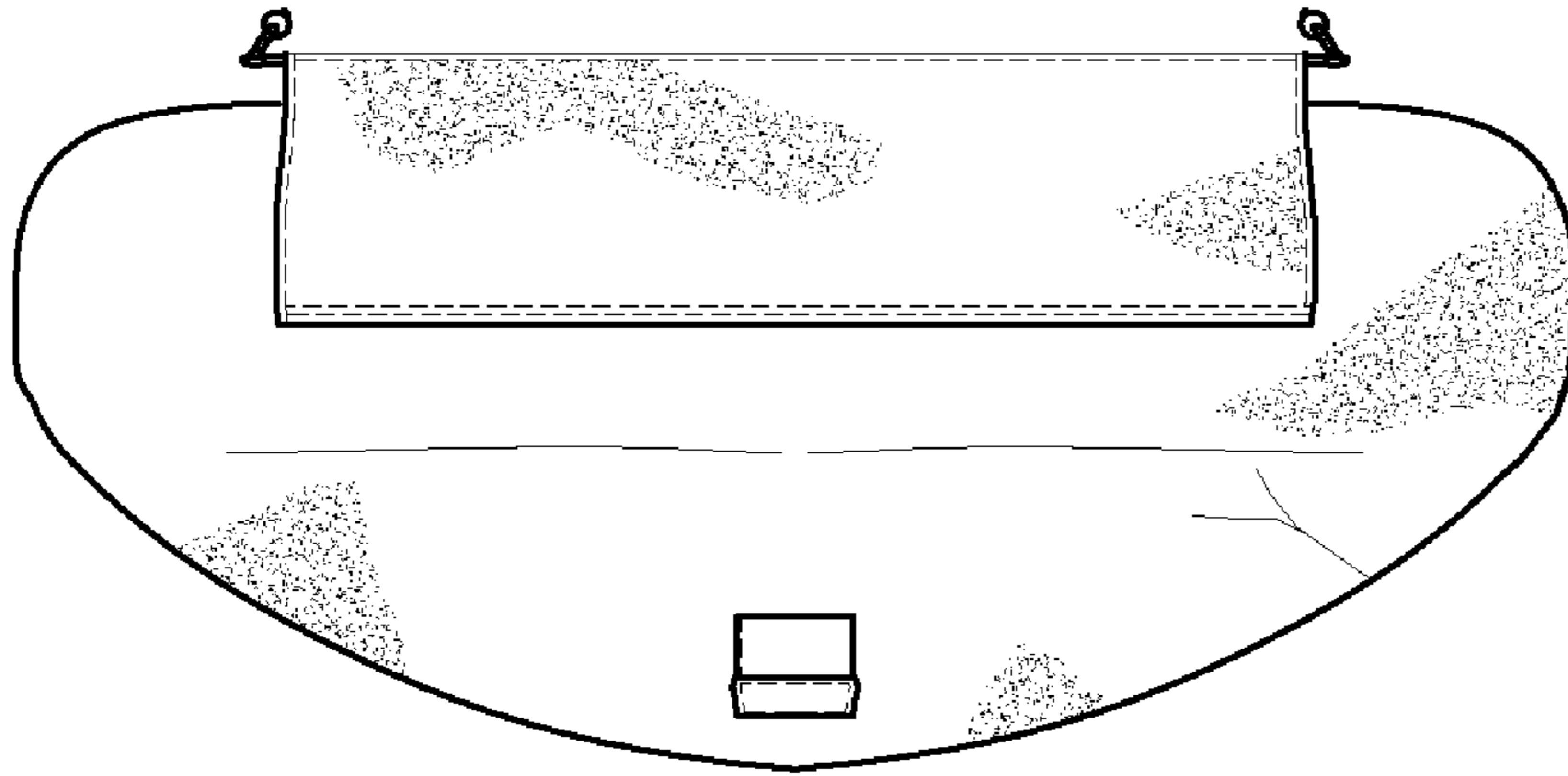
