DESCRIPTION

FIG. 1 is a front perspective view of a blender showing my new design;

FIG. 2 is a front perspective view thereof, shown with the cover removed for completeness of illustration;

FIG. 3 is a front perspective view thereof, shown with the cover removed and the control panel fully retracted for completeness of illustration;

FIG. 4 is a front view thereof with the control panel partially retracted;

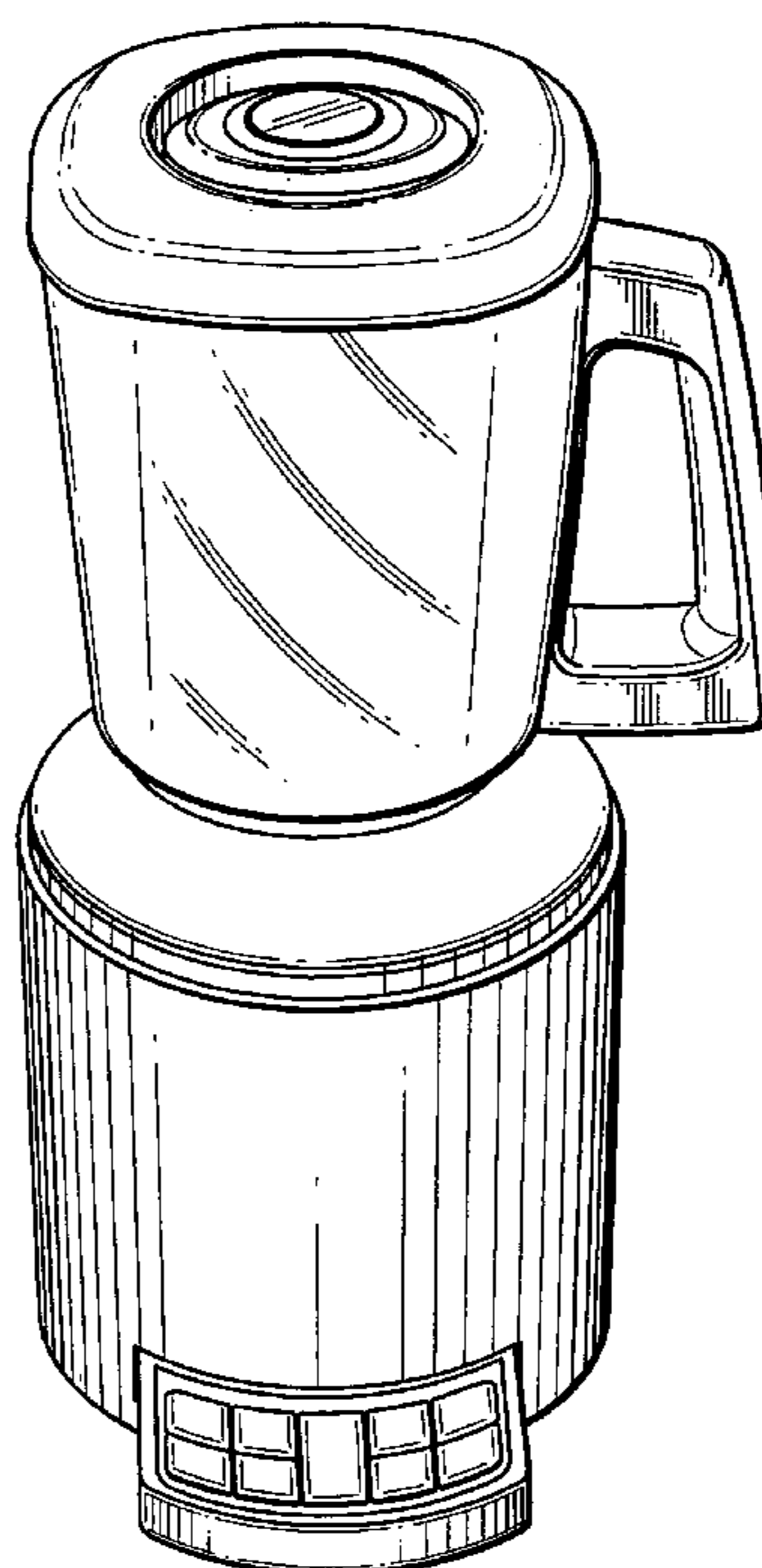
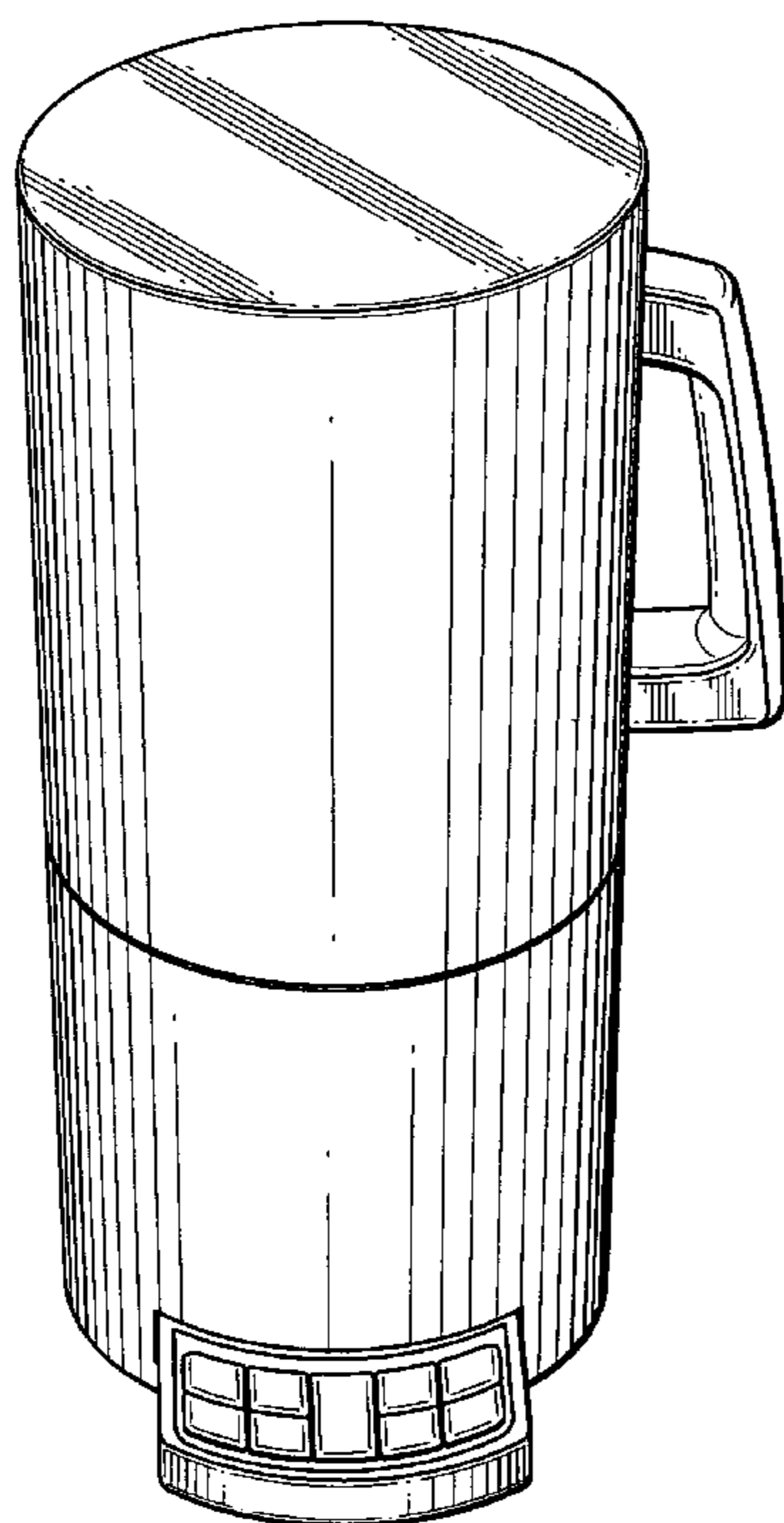
FIG. 5 is a front view thereof with the control panel fully retracted;

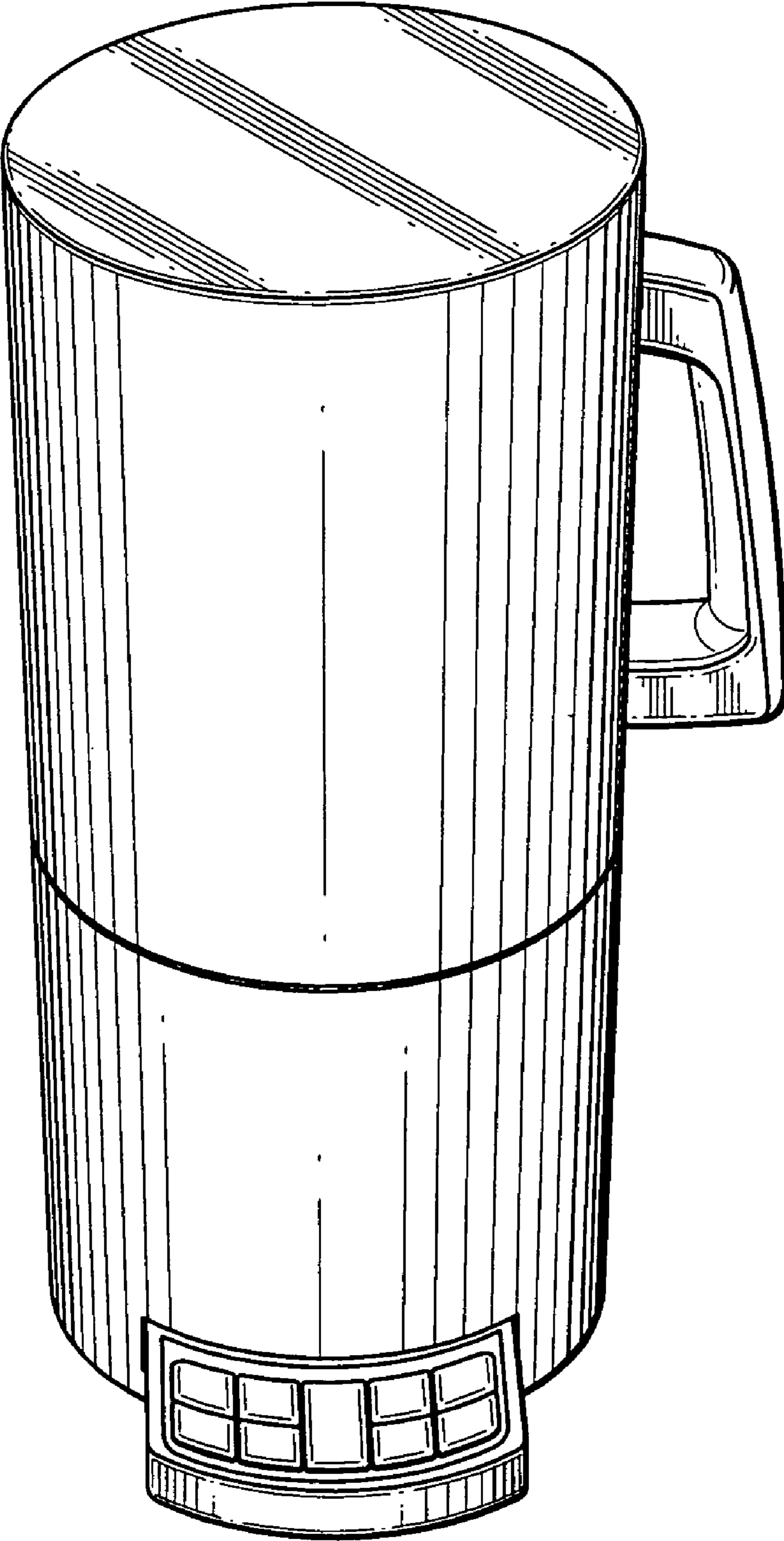

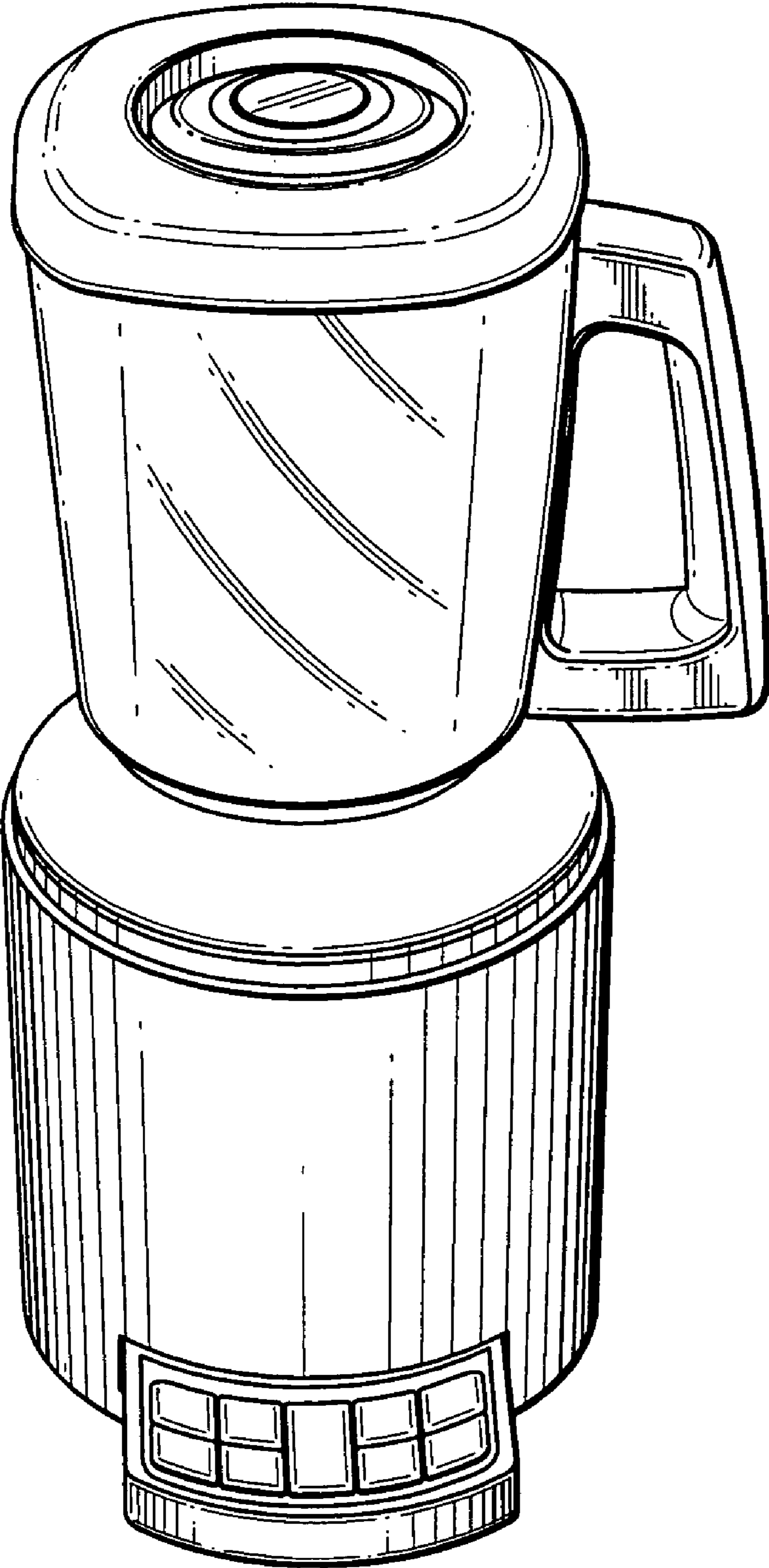

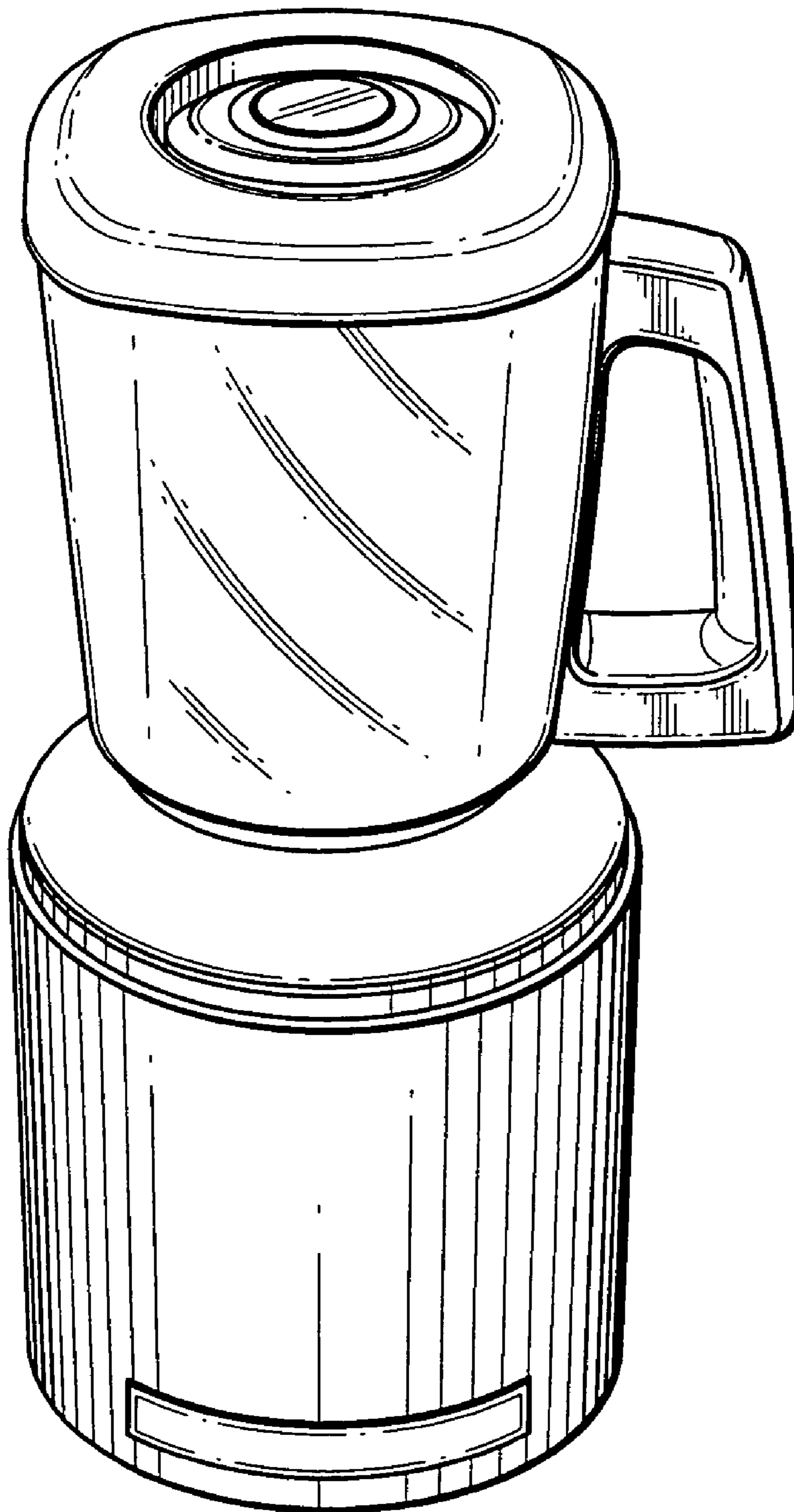

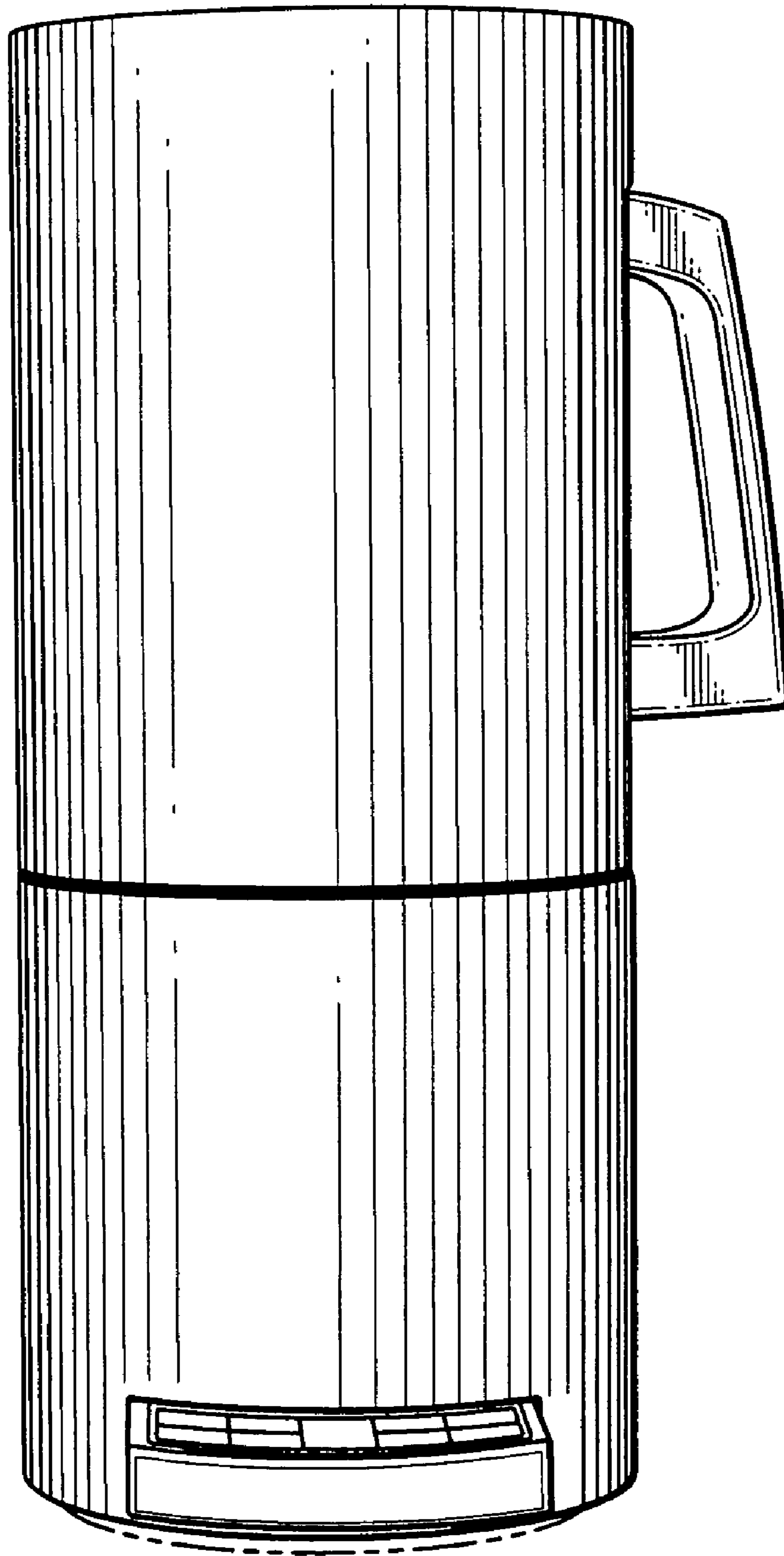

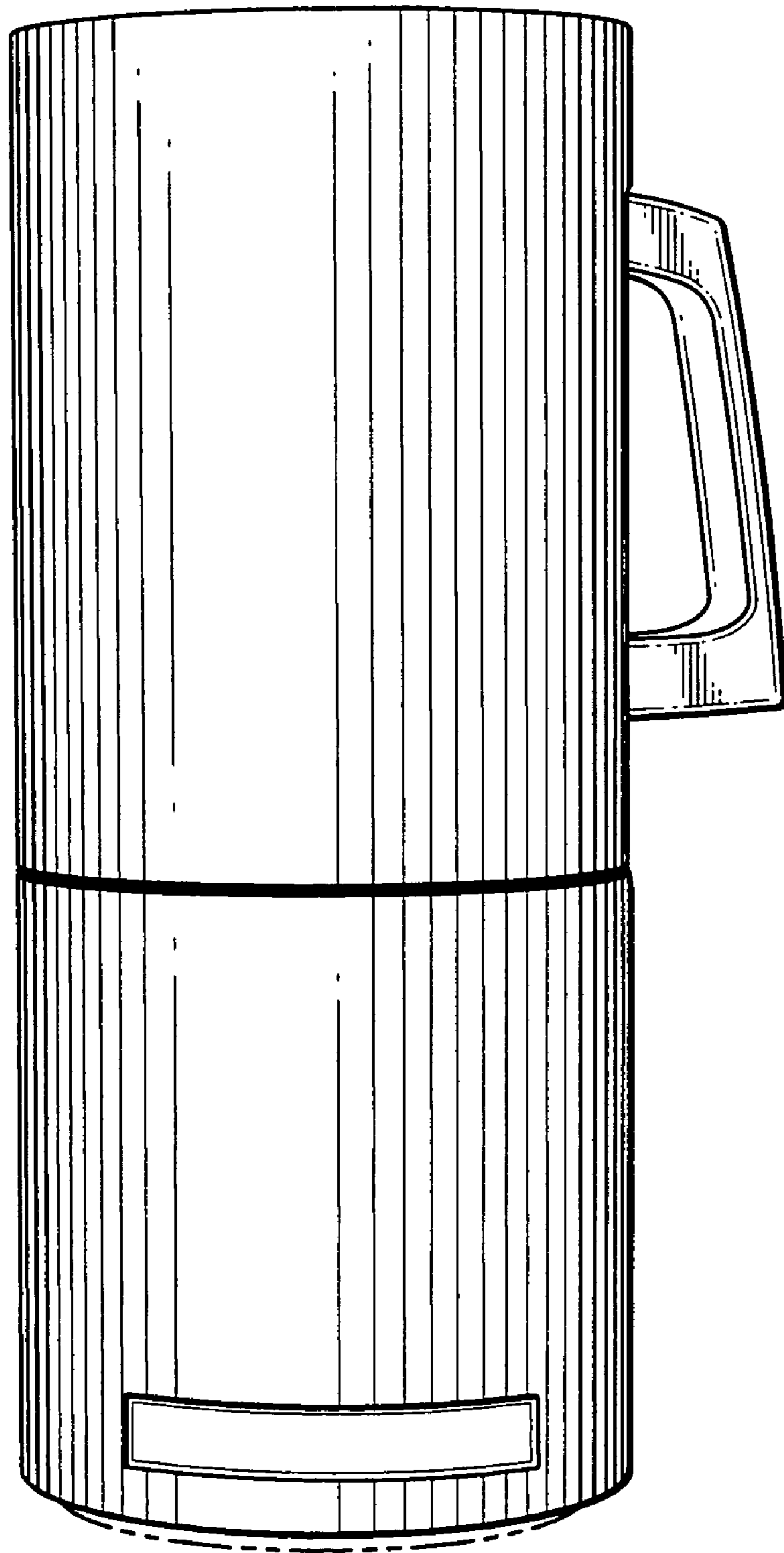

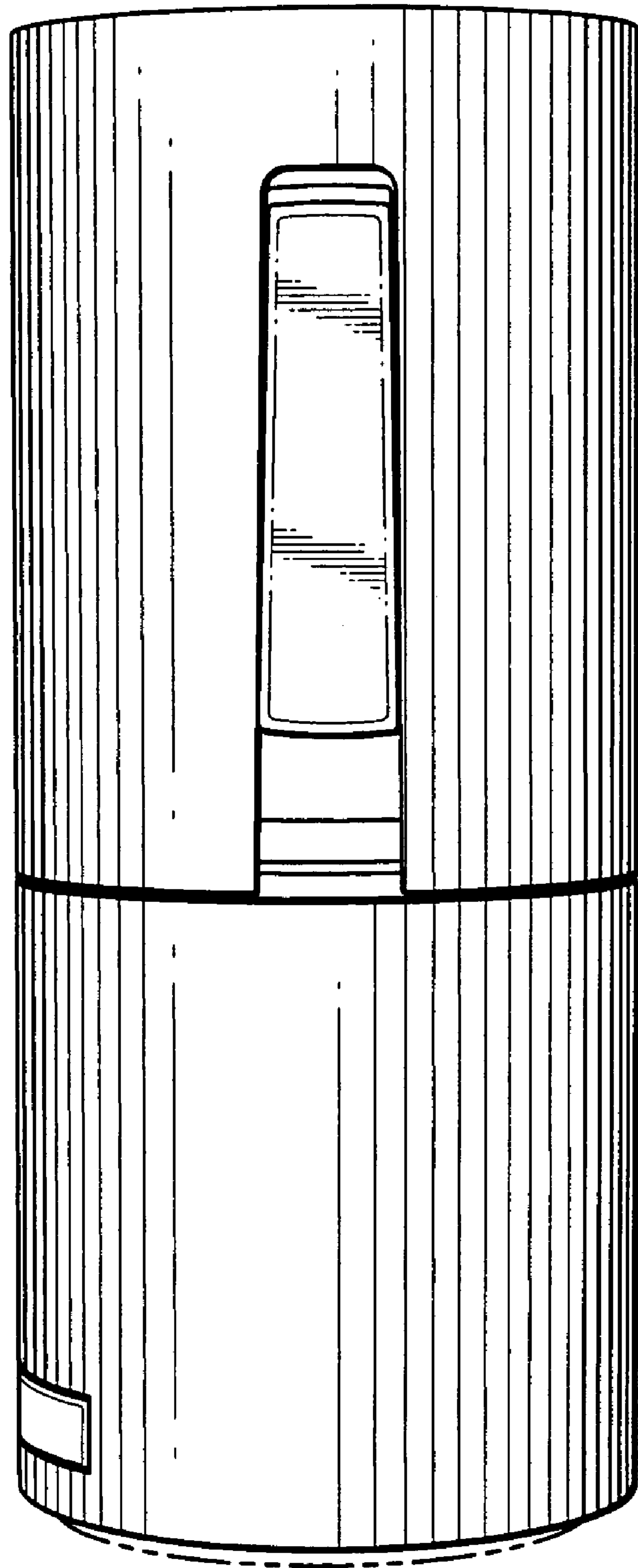

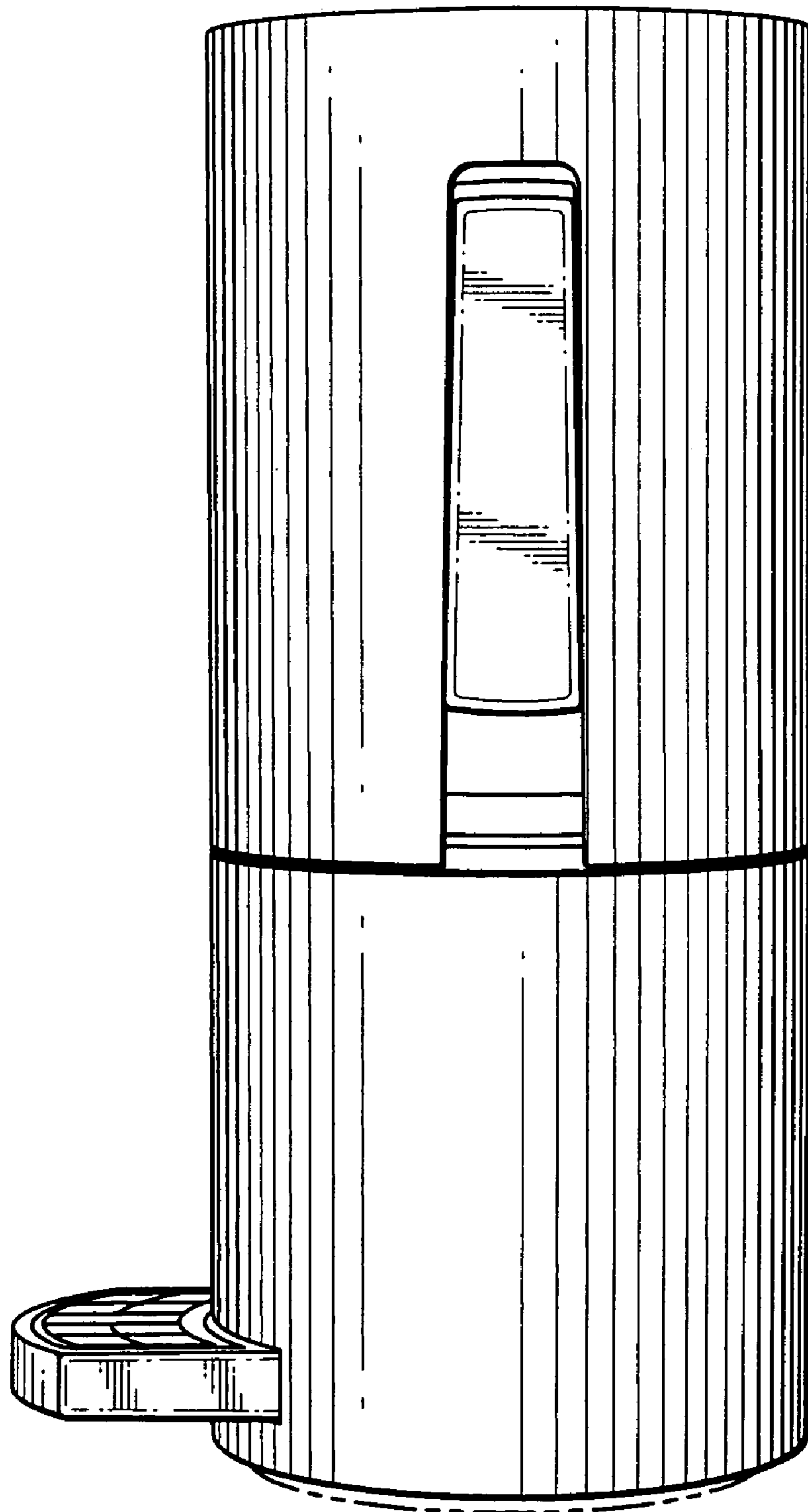
