DESCRIPTION

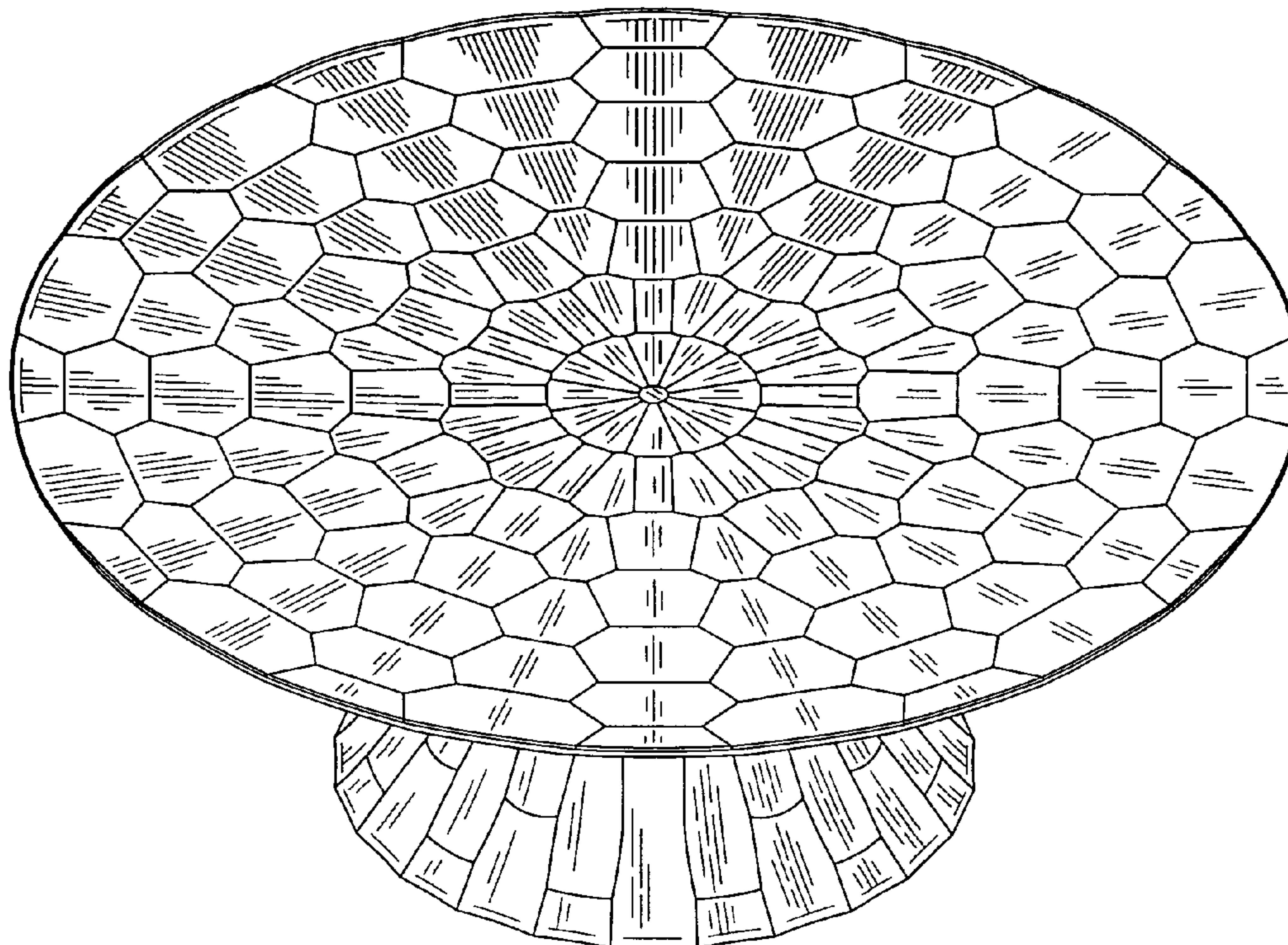
FIG. 1 is a top, front perspective view showing the new design;

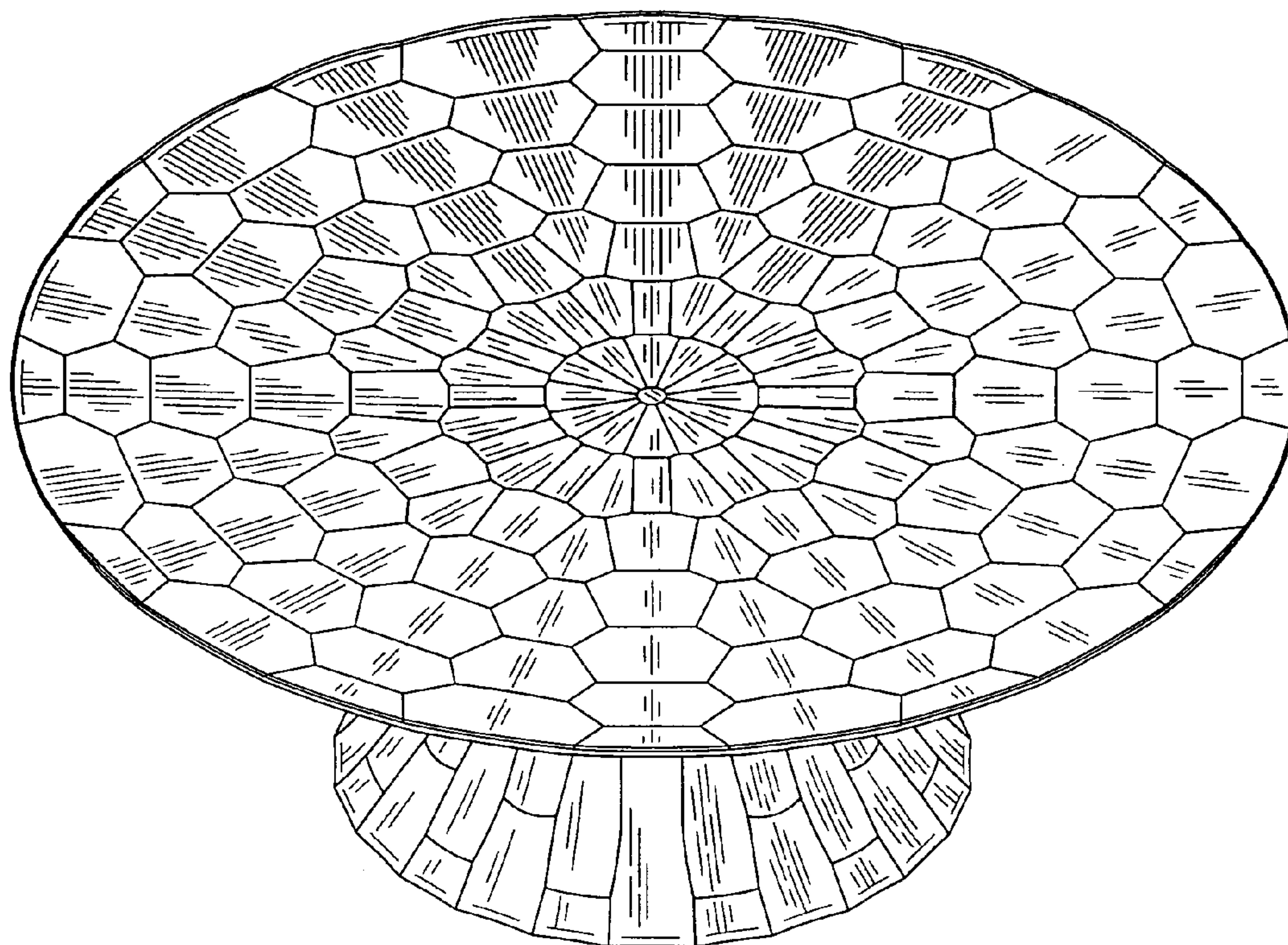

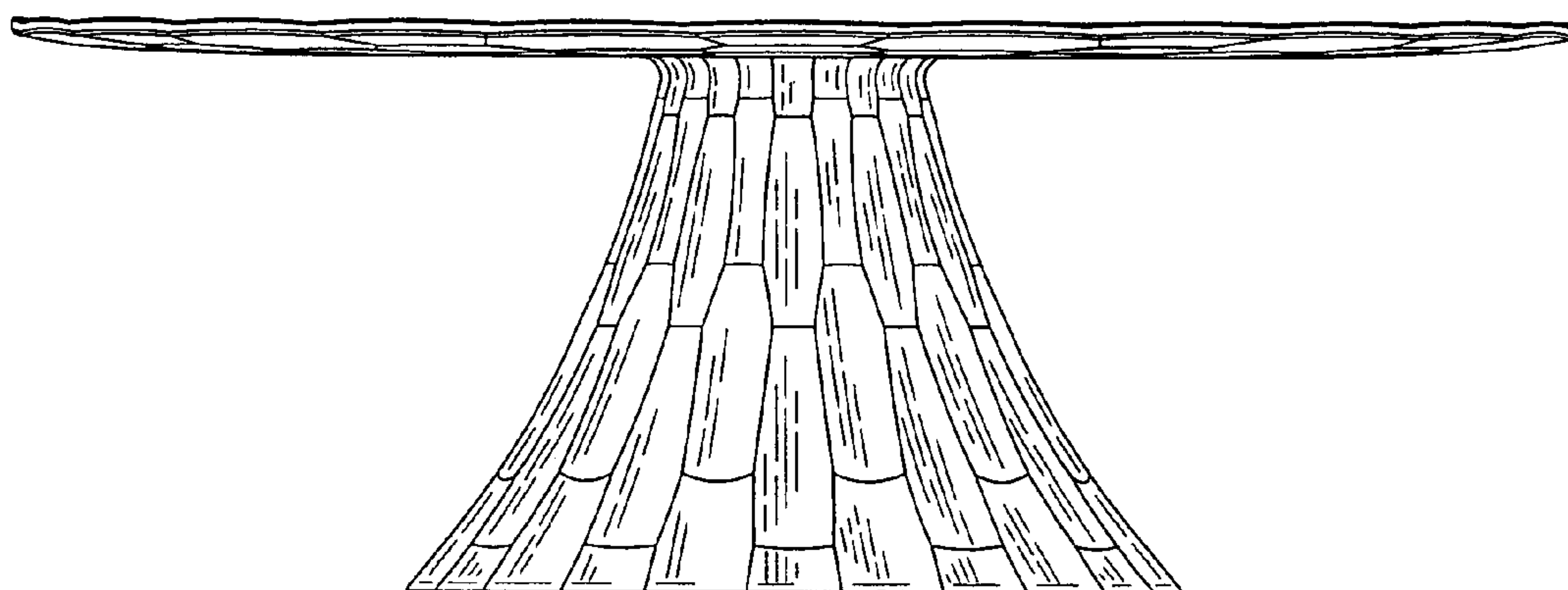

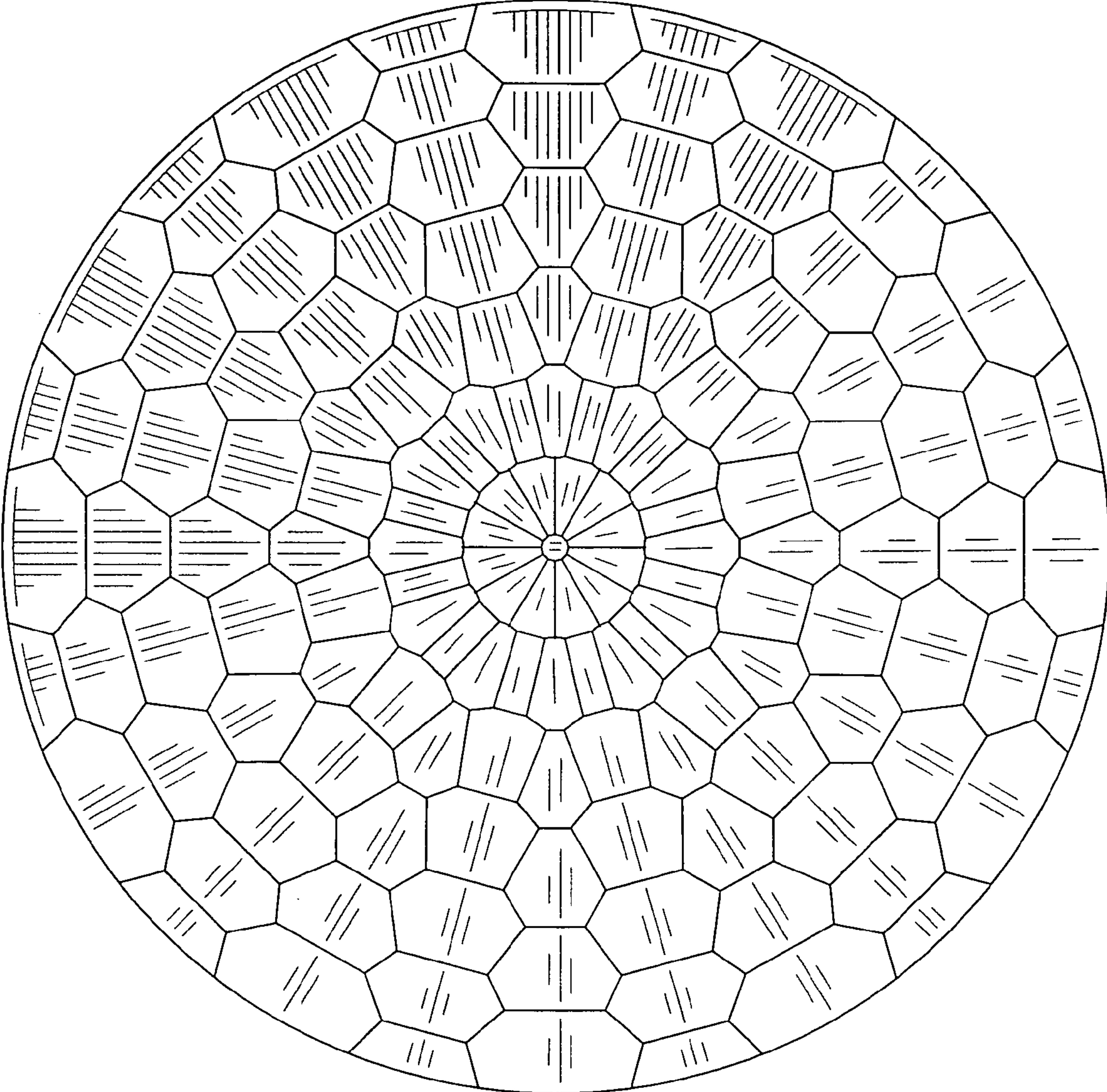

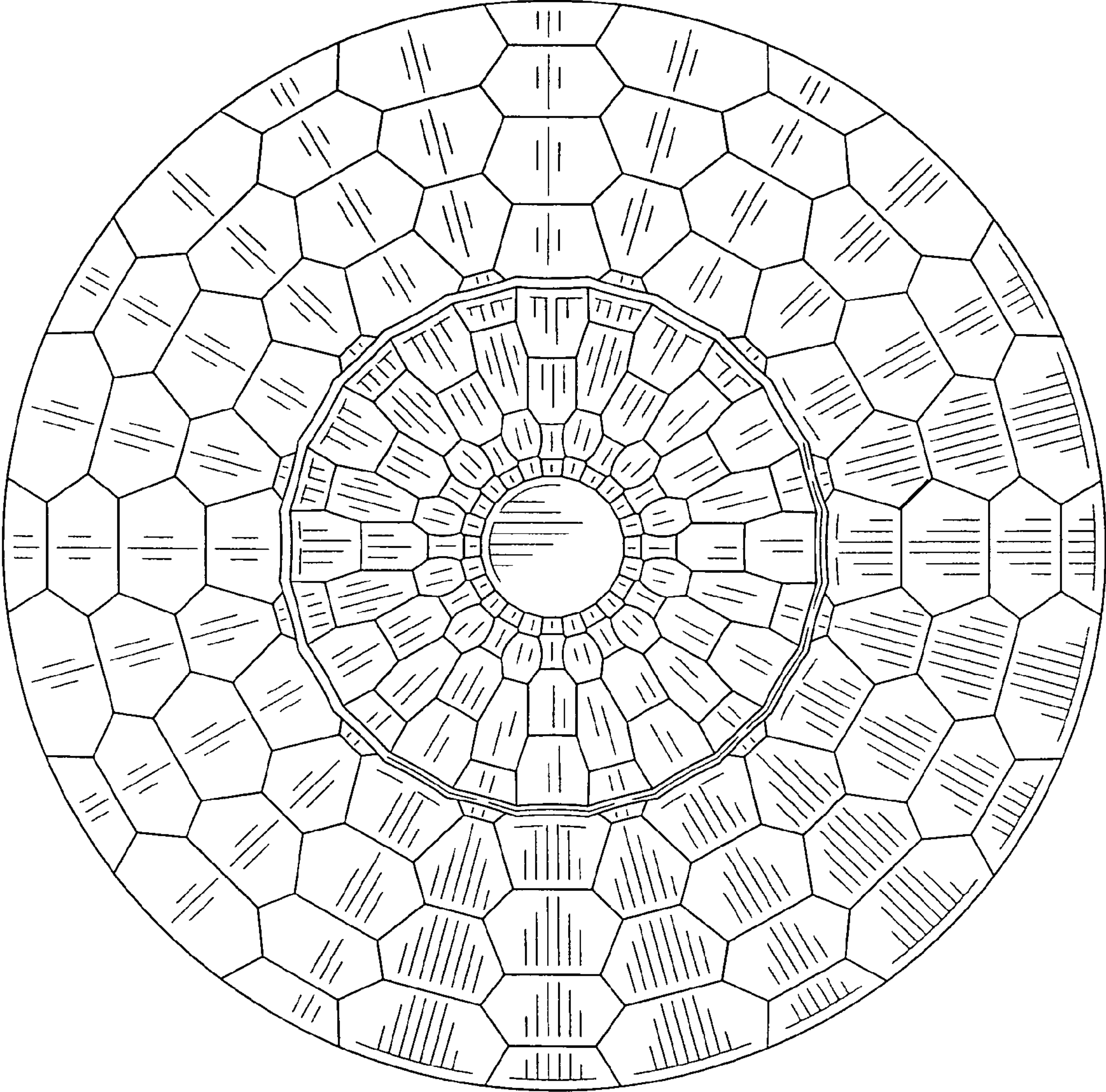
