DESCRIPTION

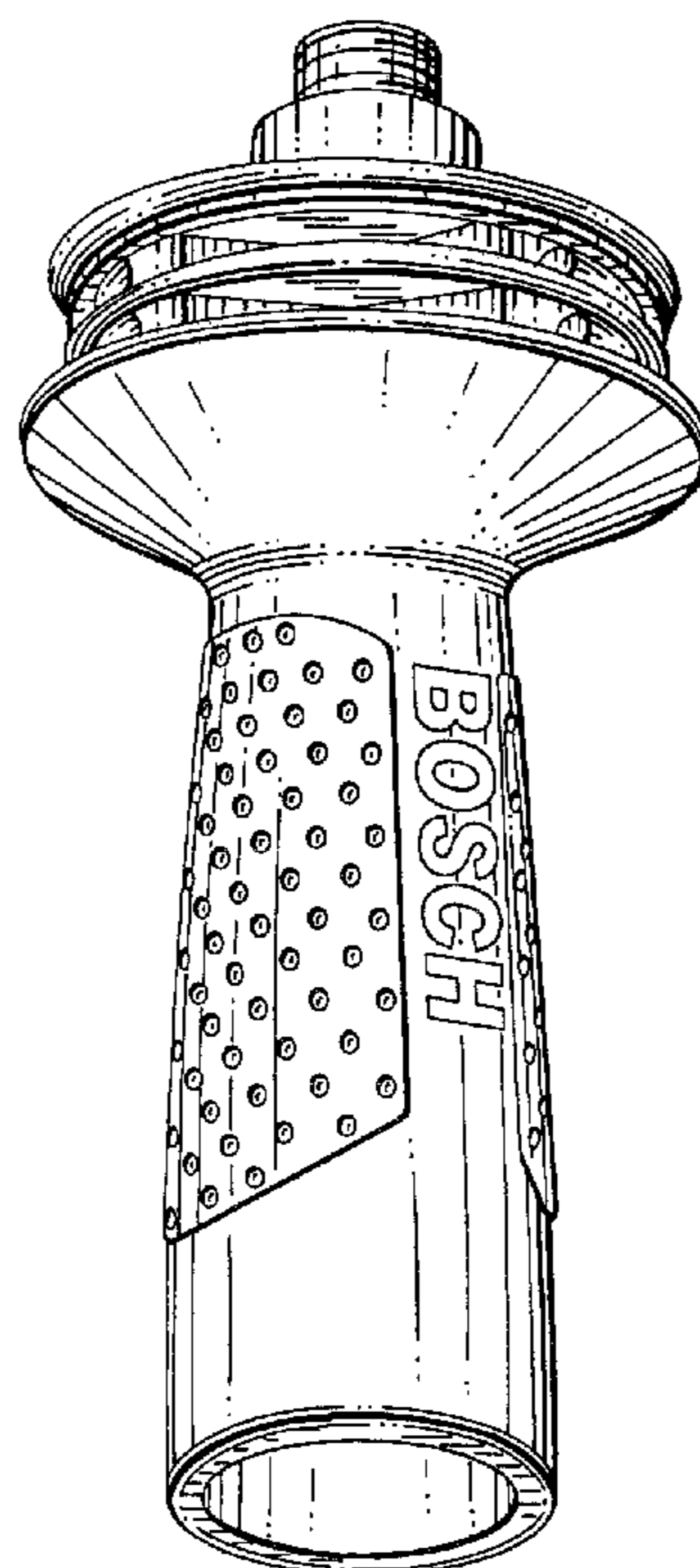

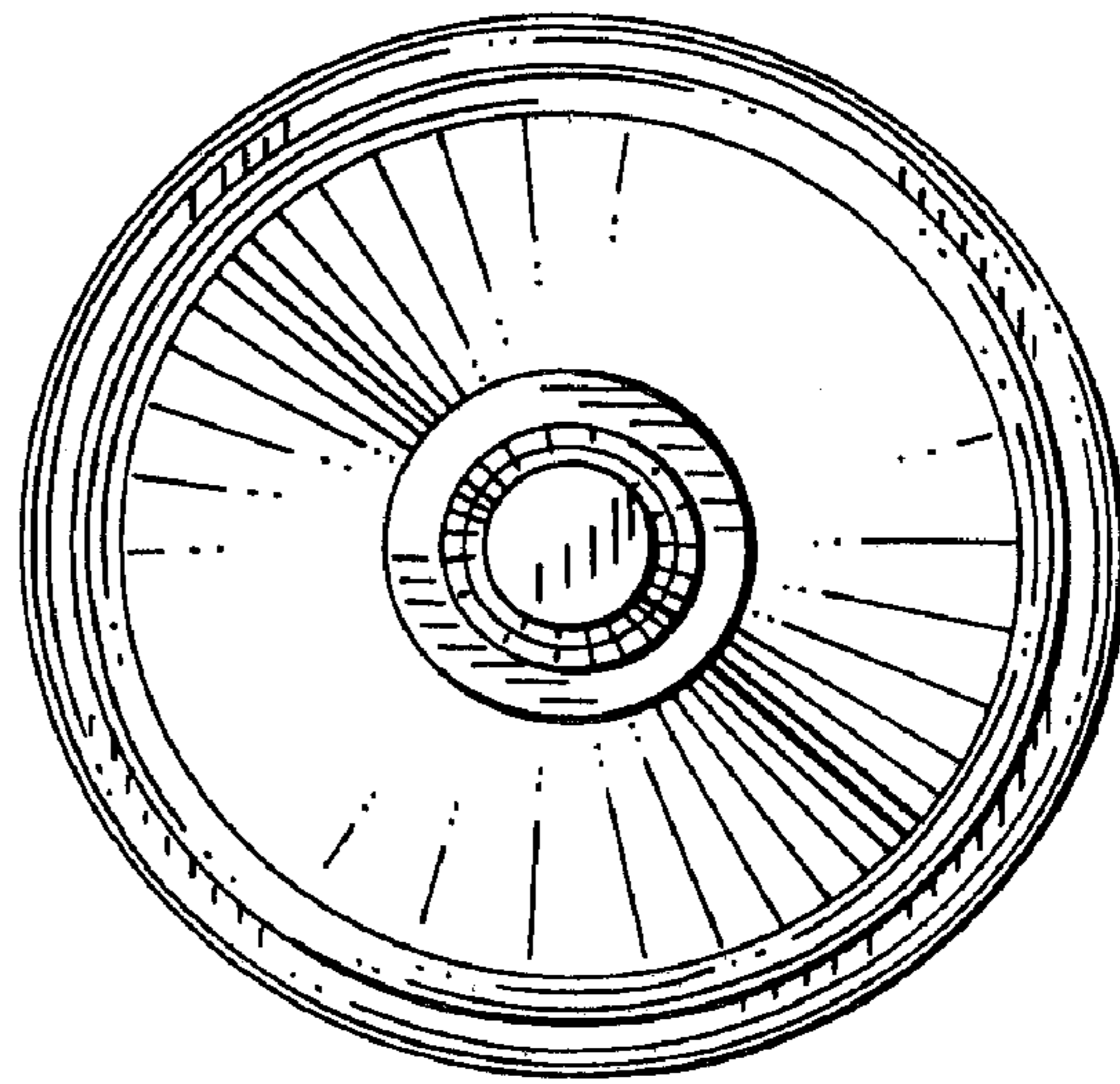
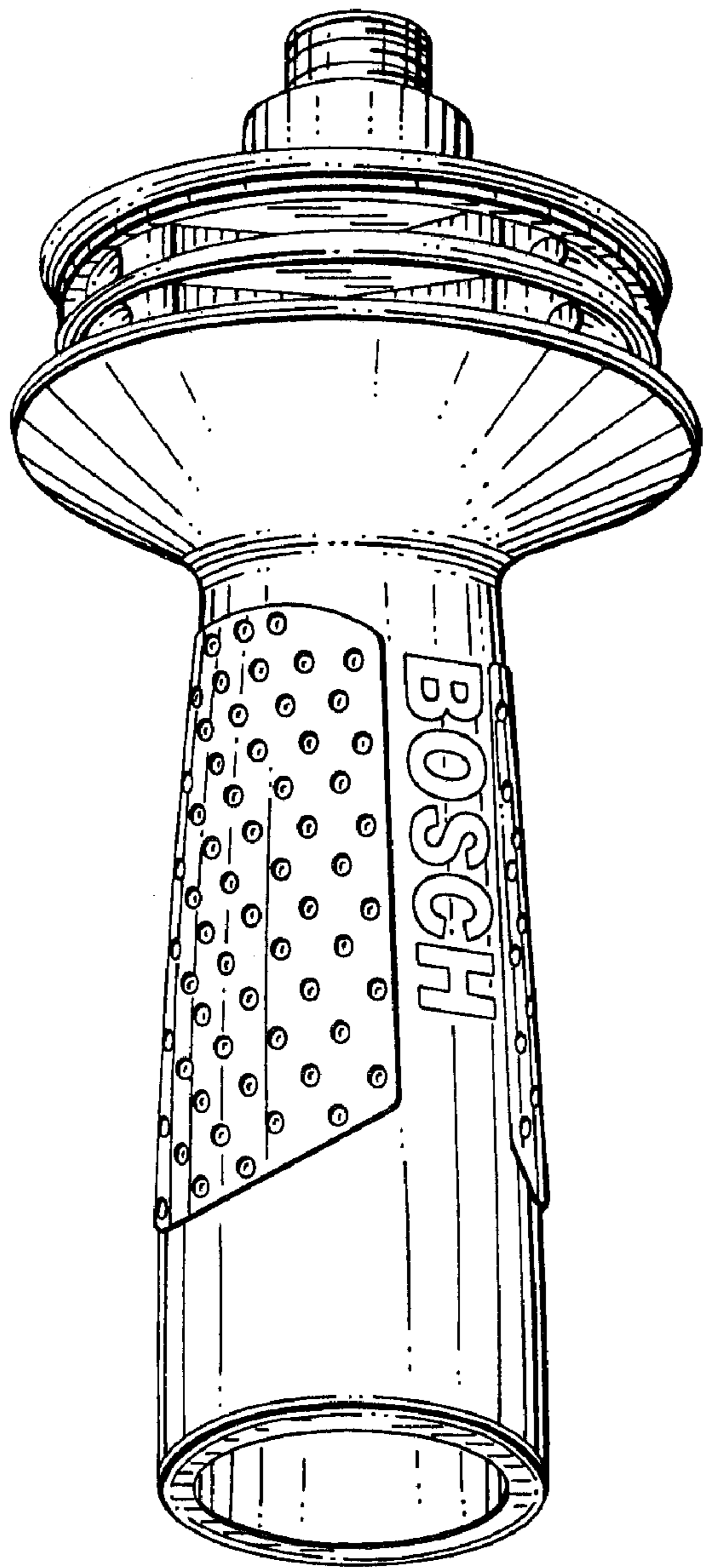

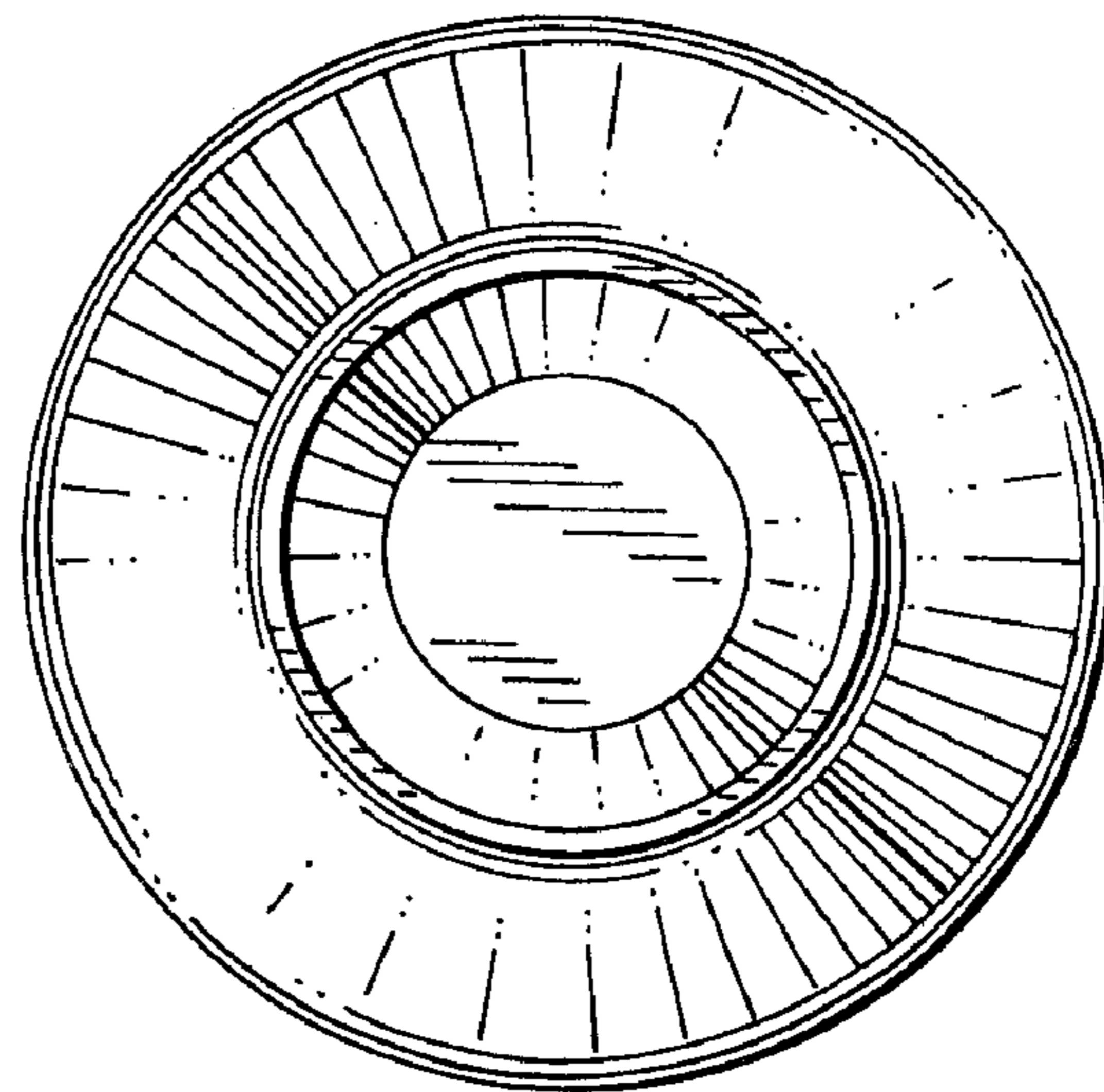

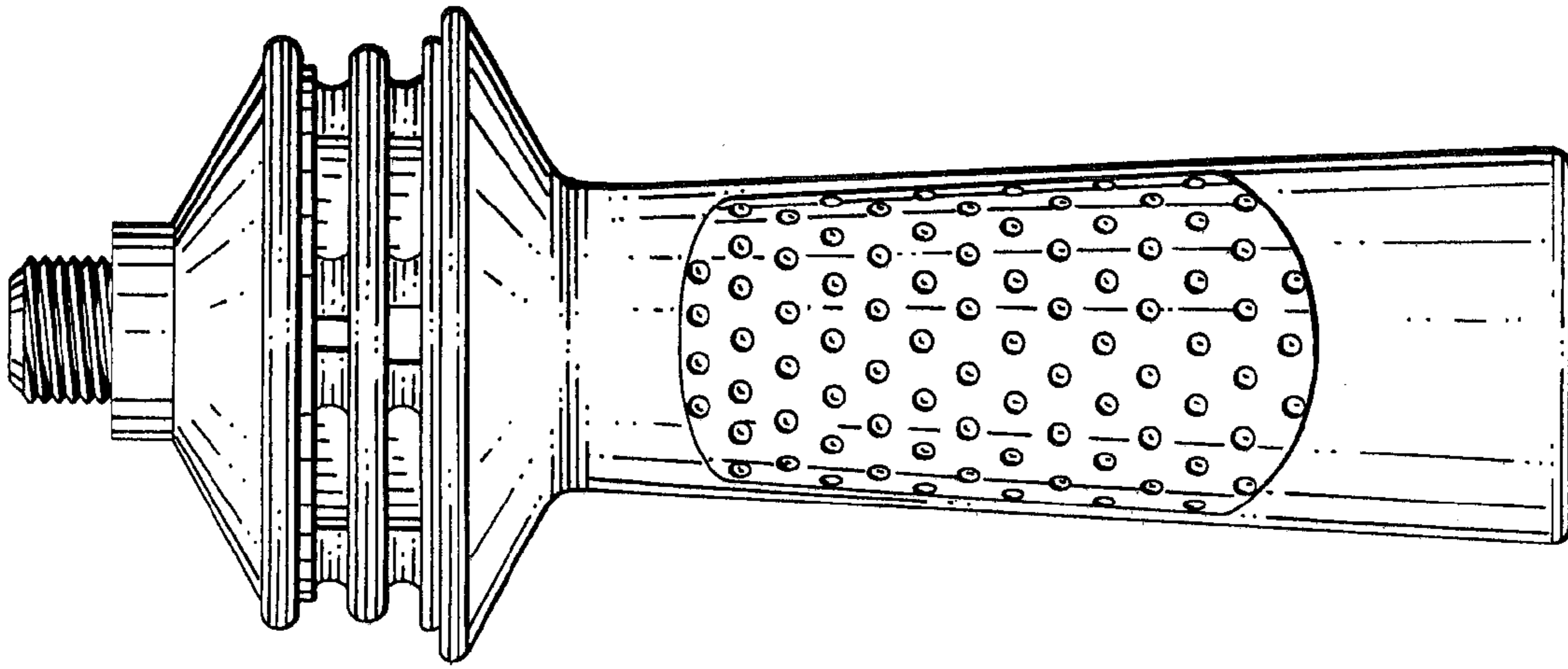

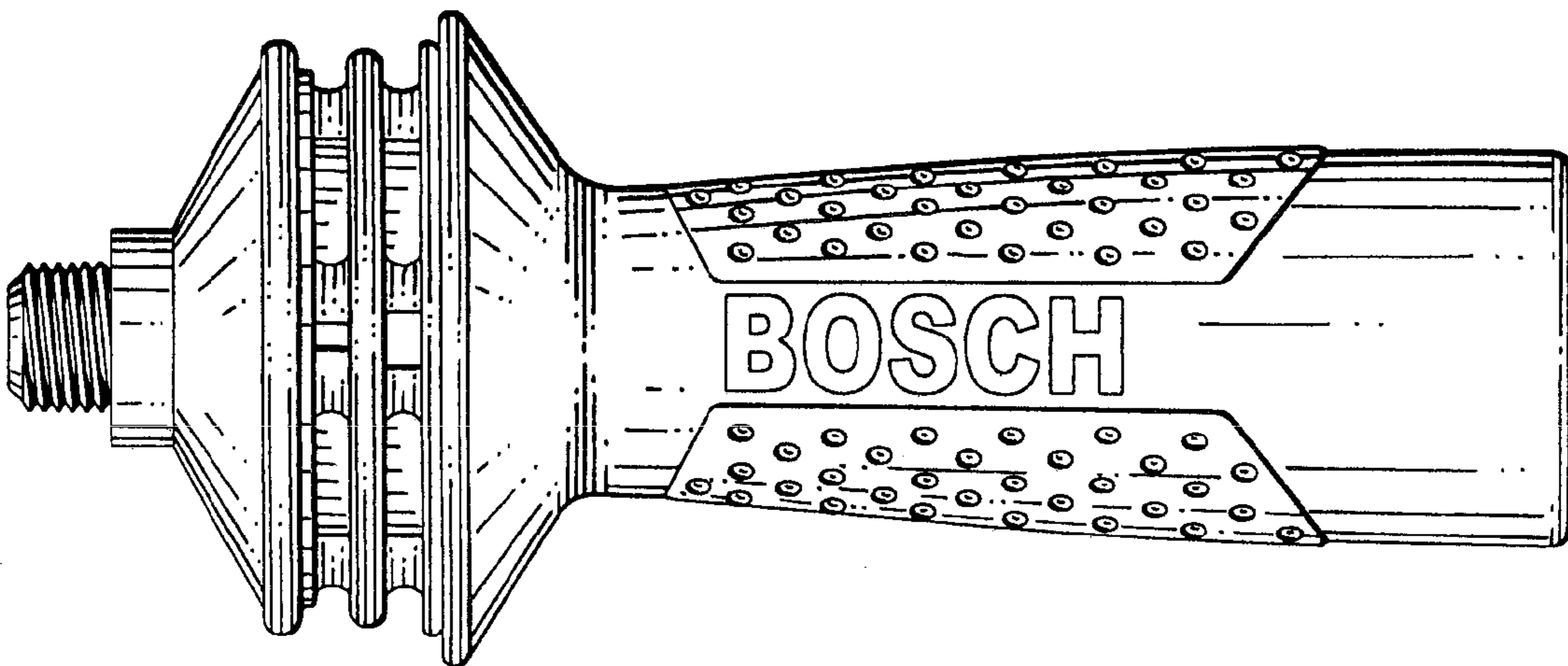

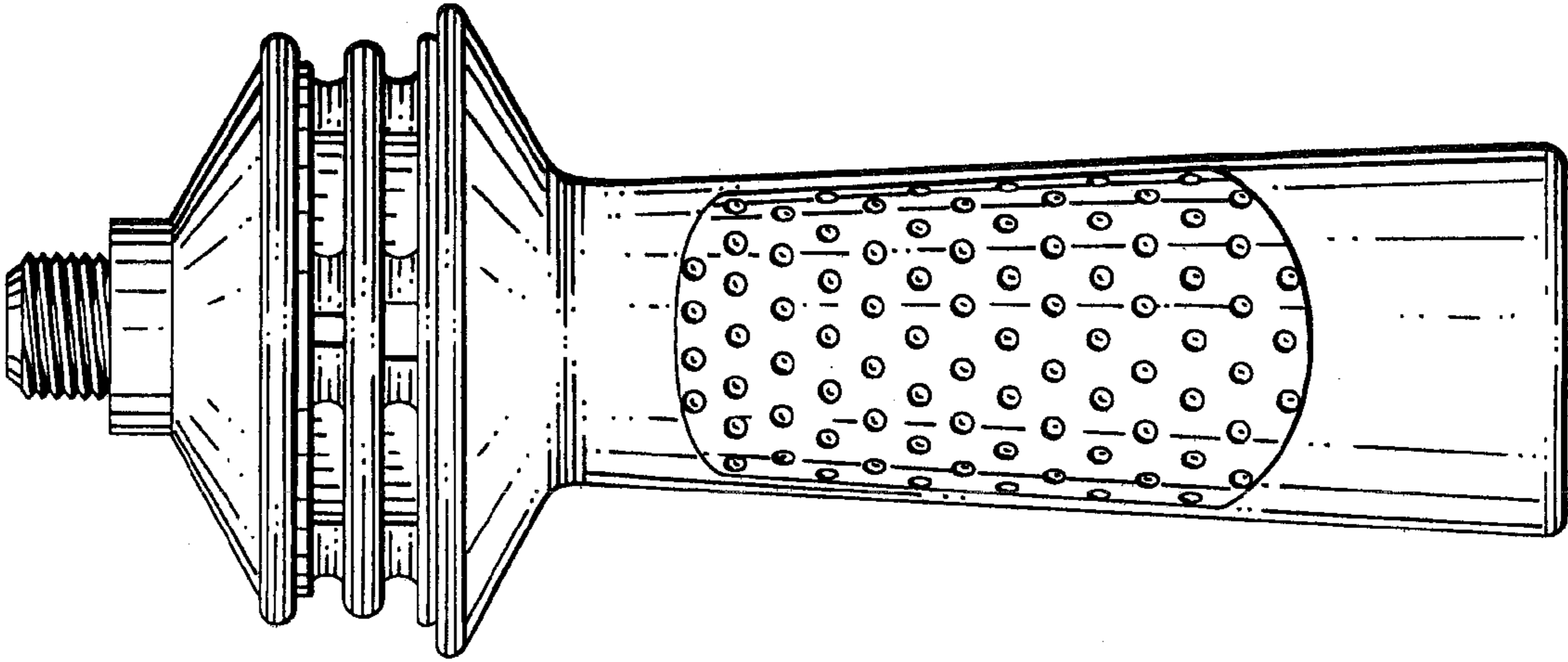

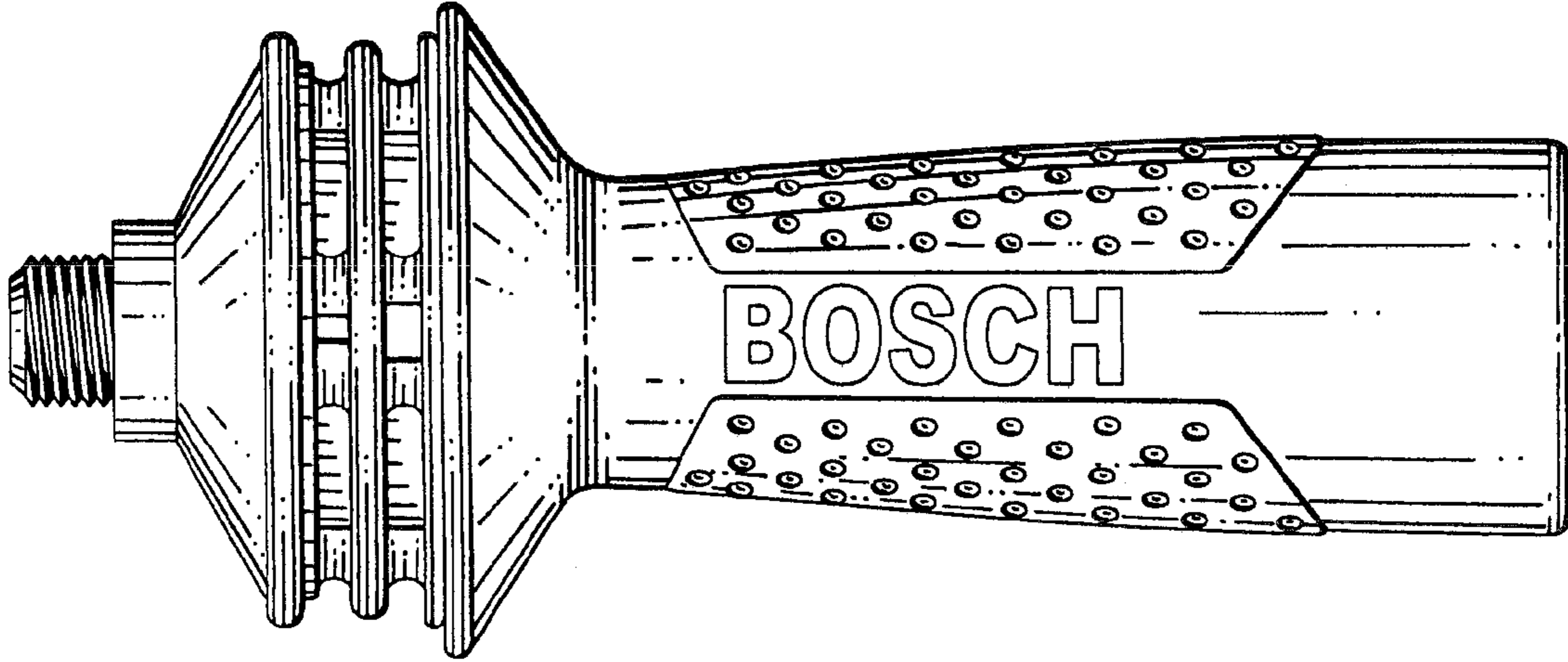
