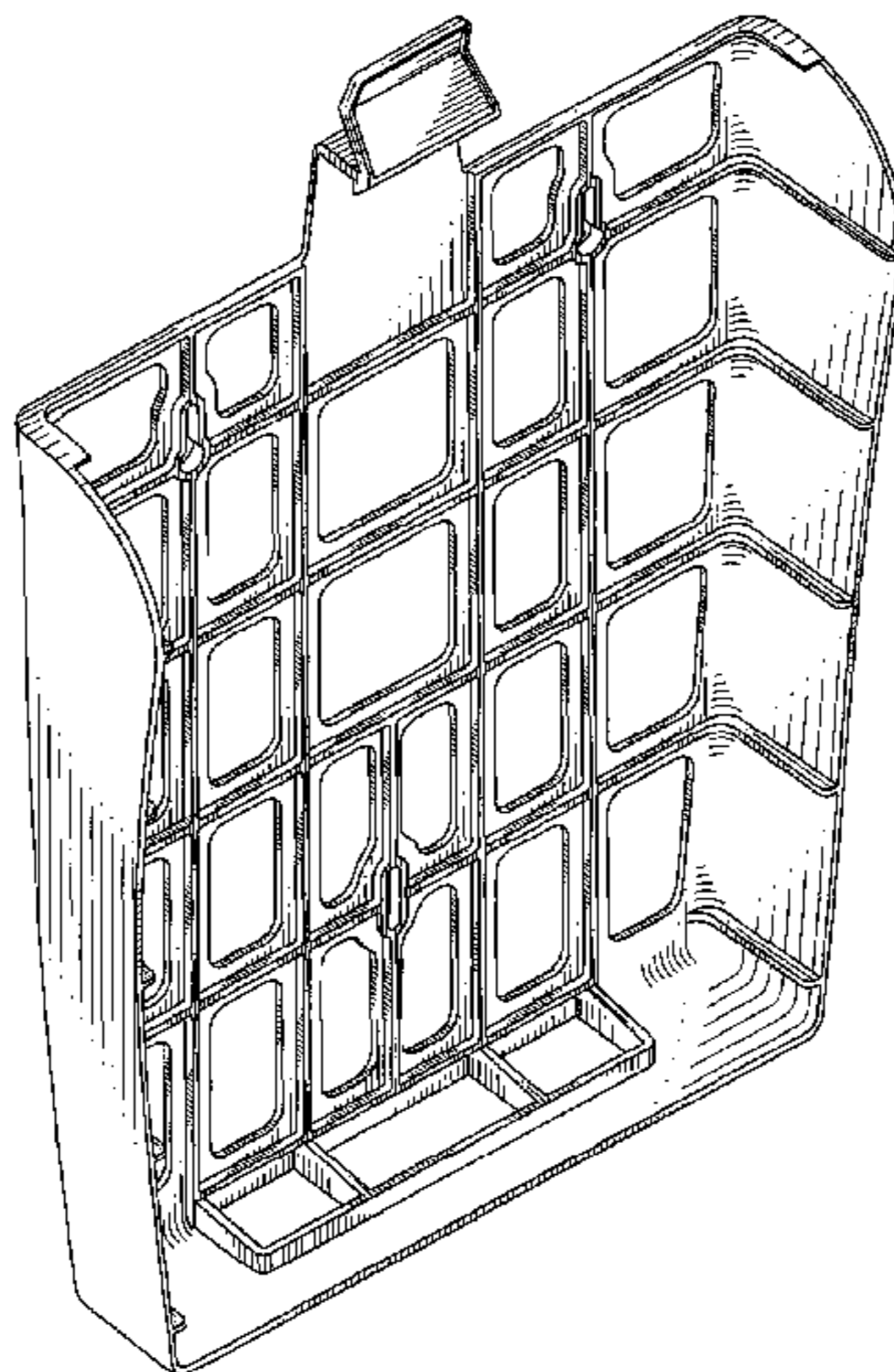

FIG. 4 is a right side elevation view of the mounting bracket, the left side view being a mirror image thereof.
FIG. 5 is a top plan view of the mounting bracket; and,
FIG. 6 is a bottom plan view of the mounting bracket.

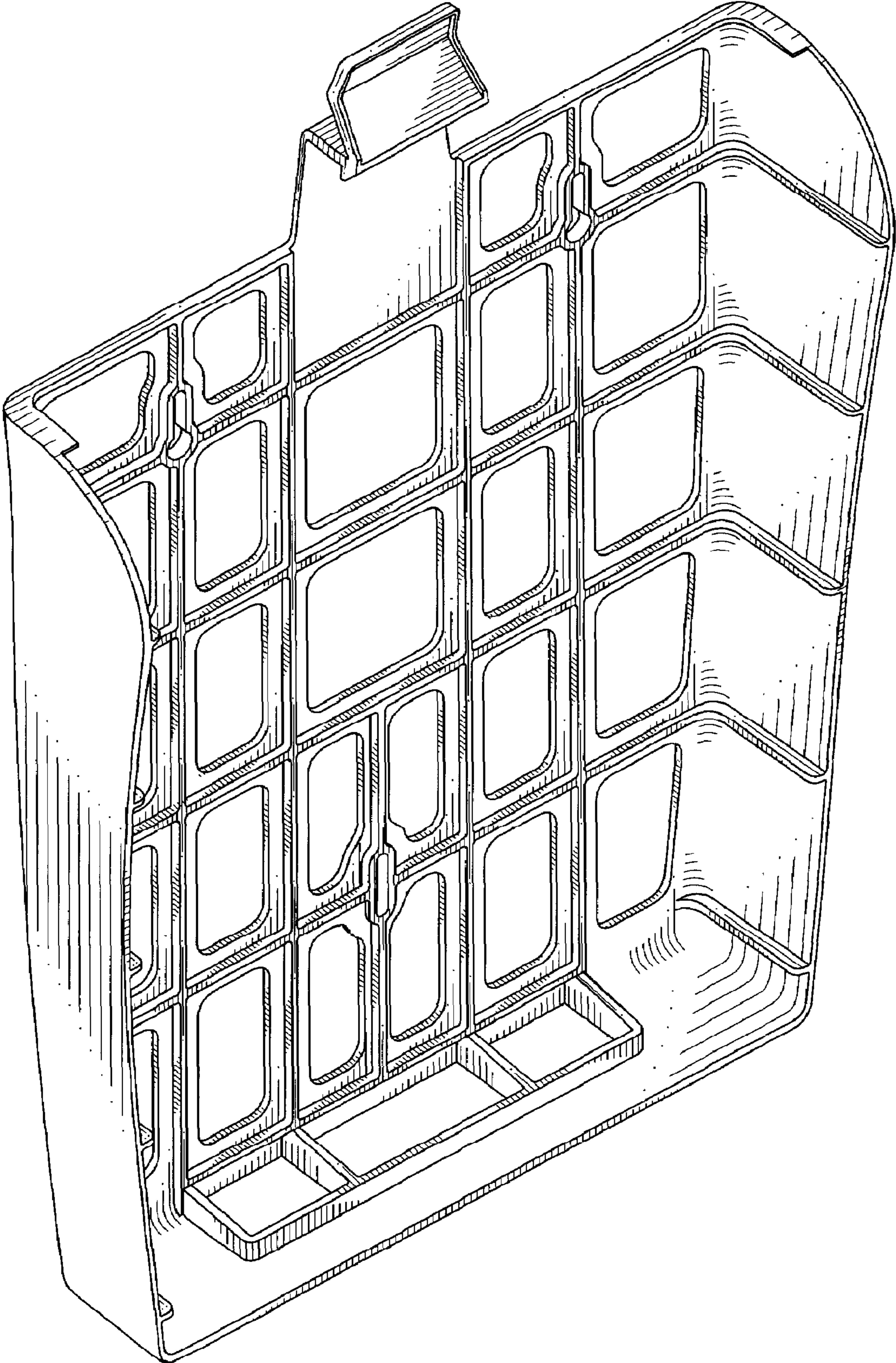

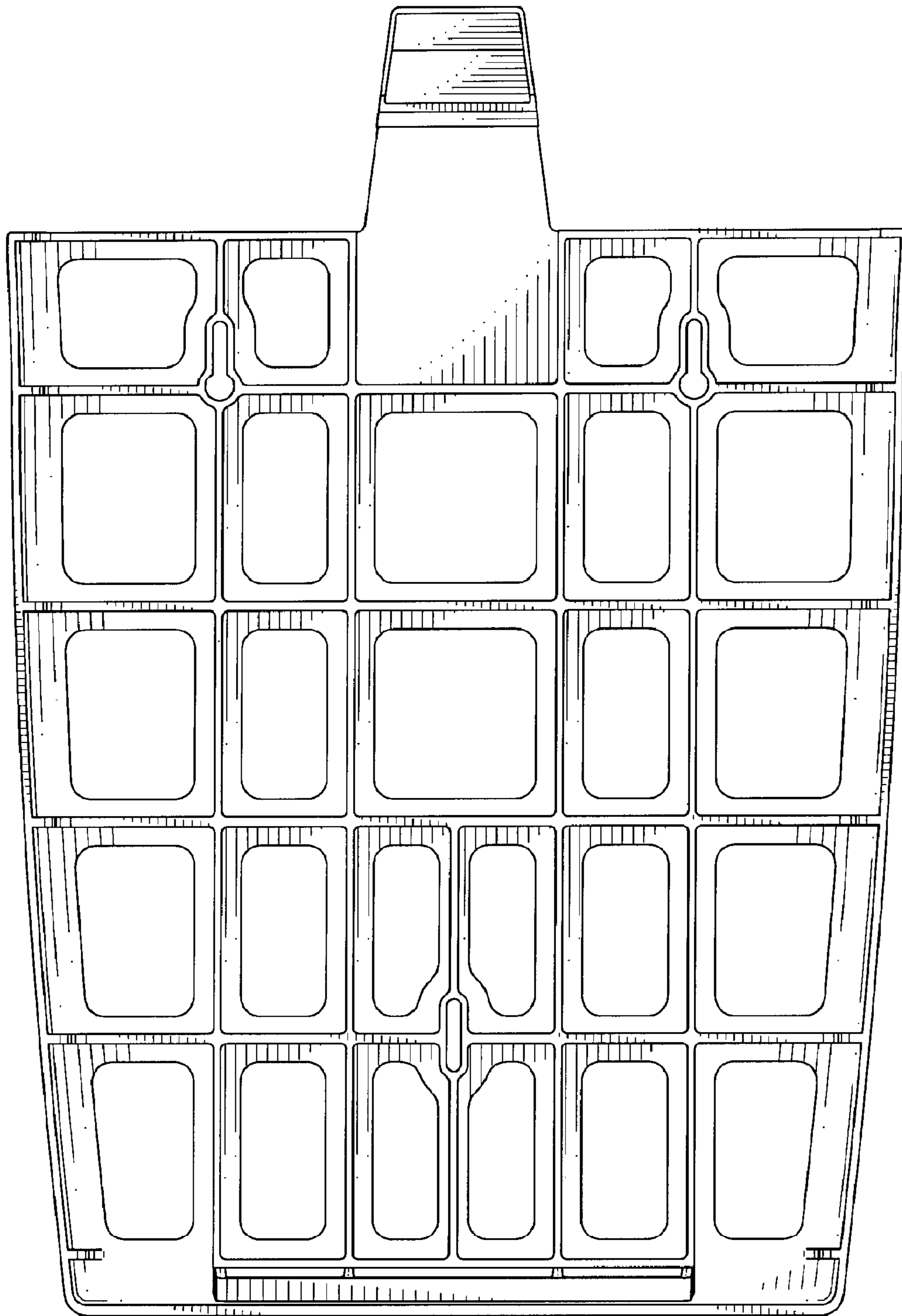

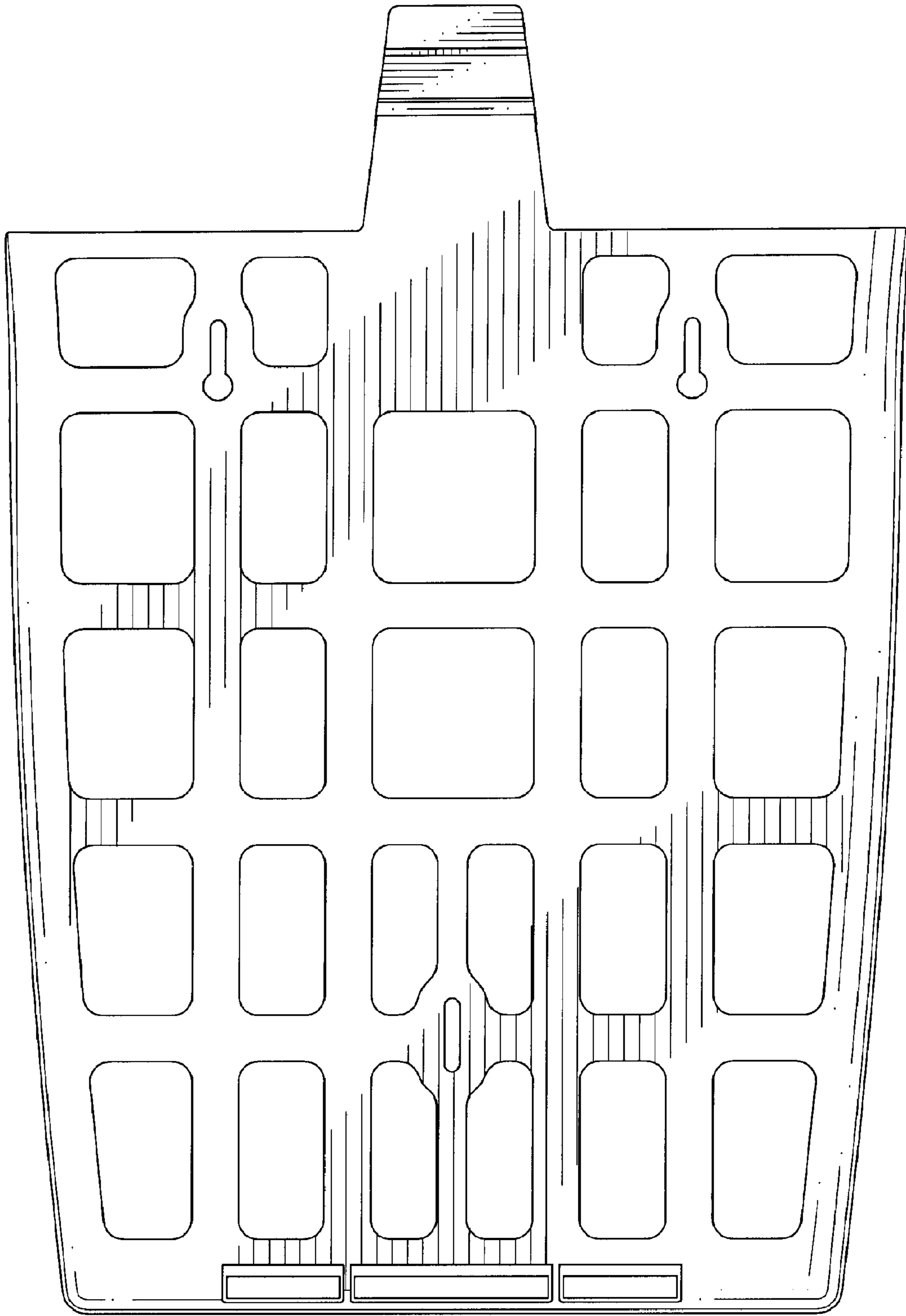

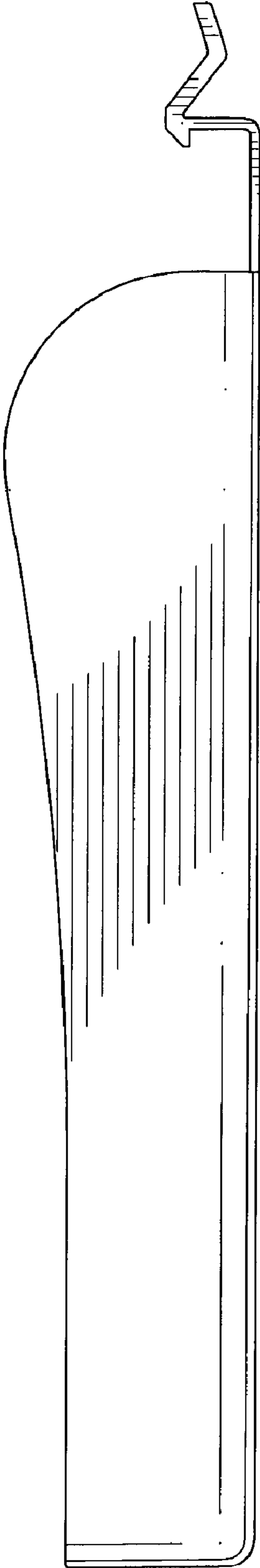

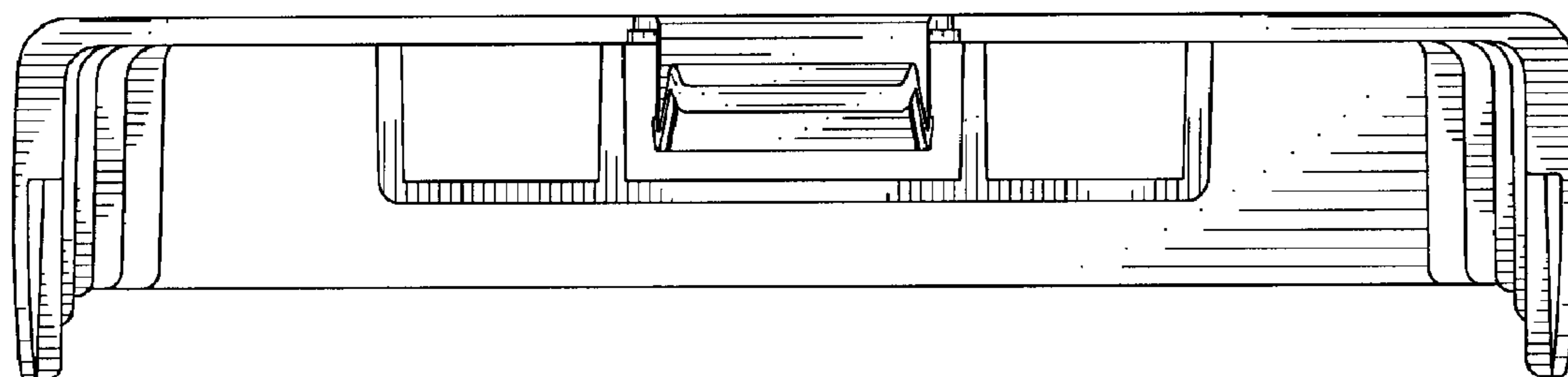

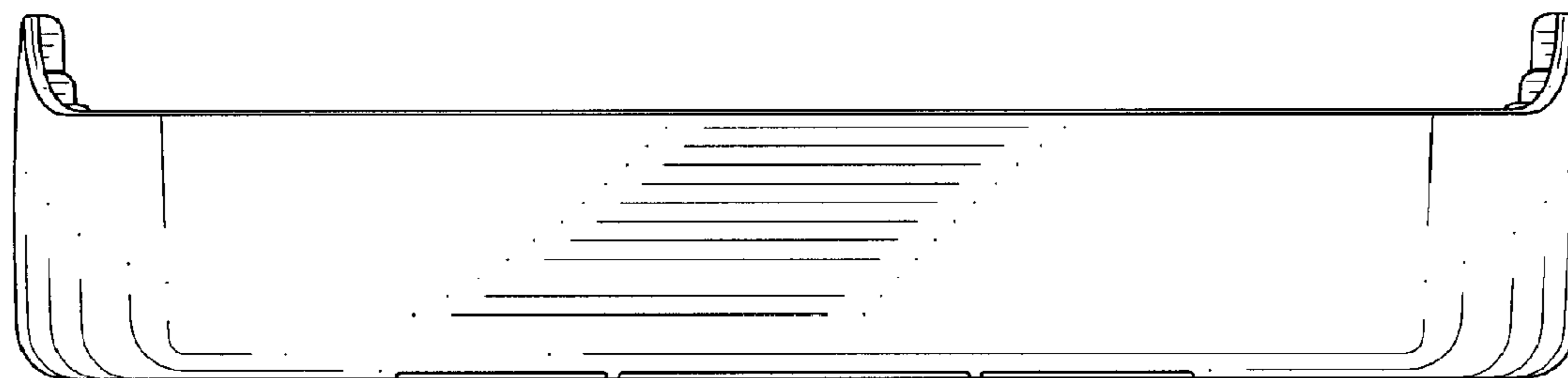
