FIG. 1 is the top perspective view of a gemstone with 88 inclined facets, showing my new design;

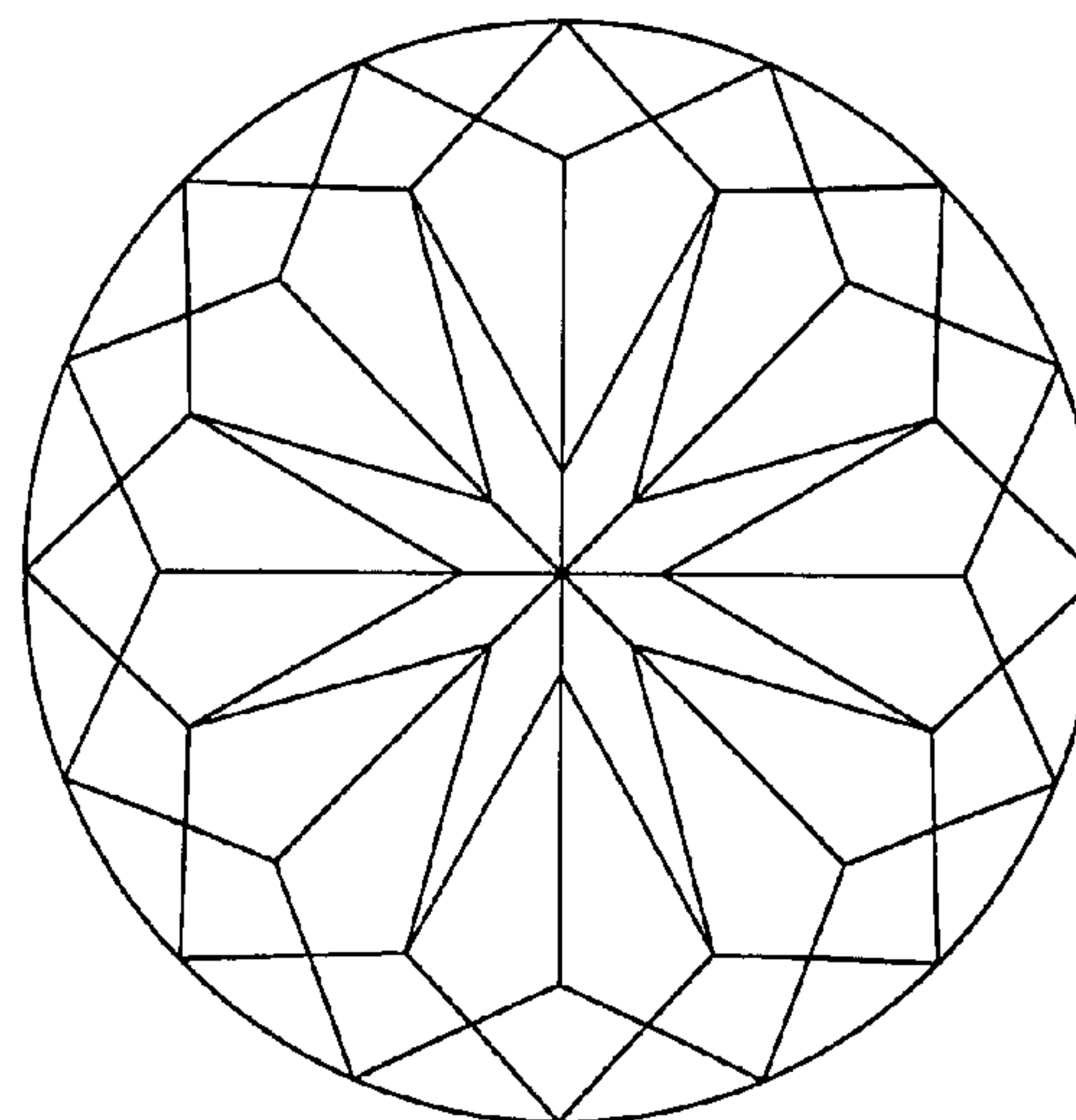
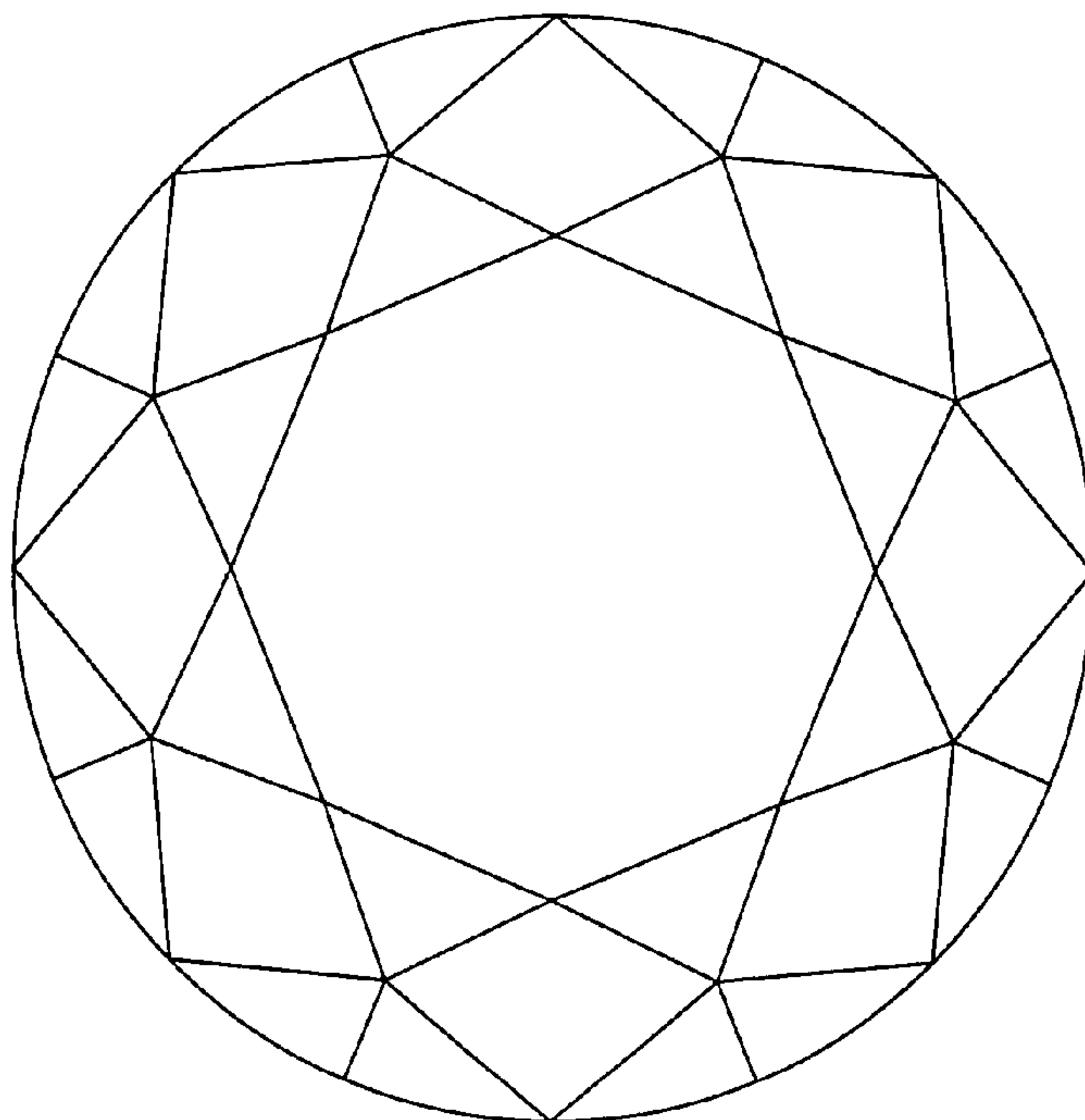
FIG. 2 is the bottom perspective view thereof;

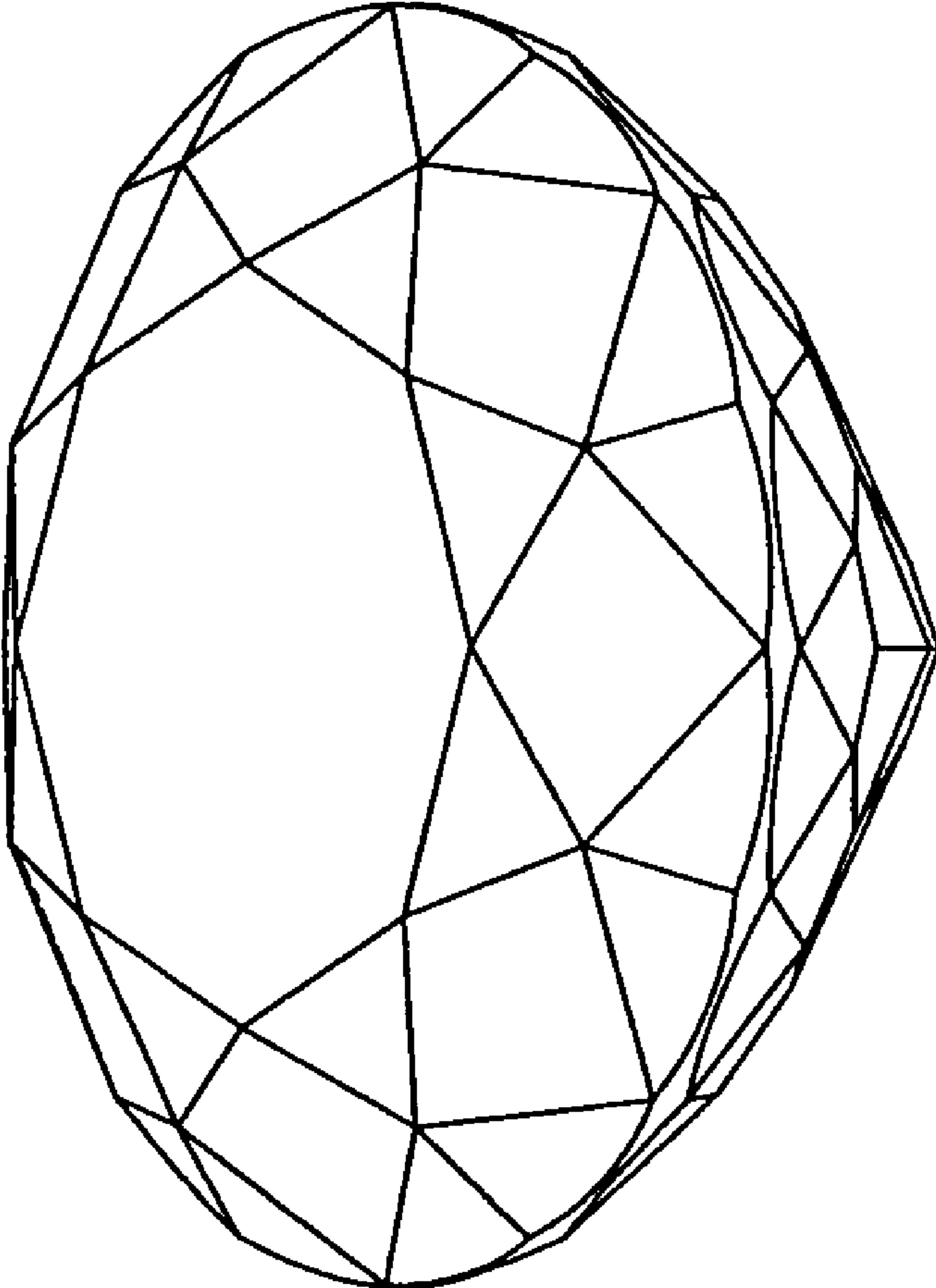

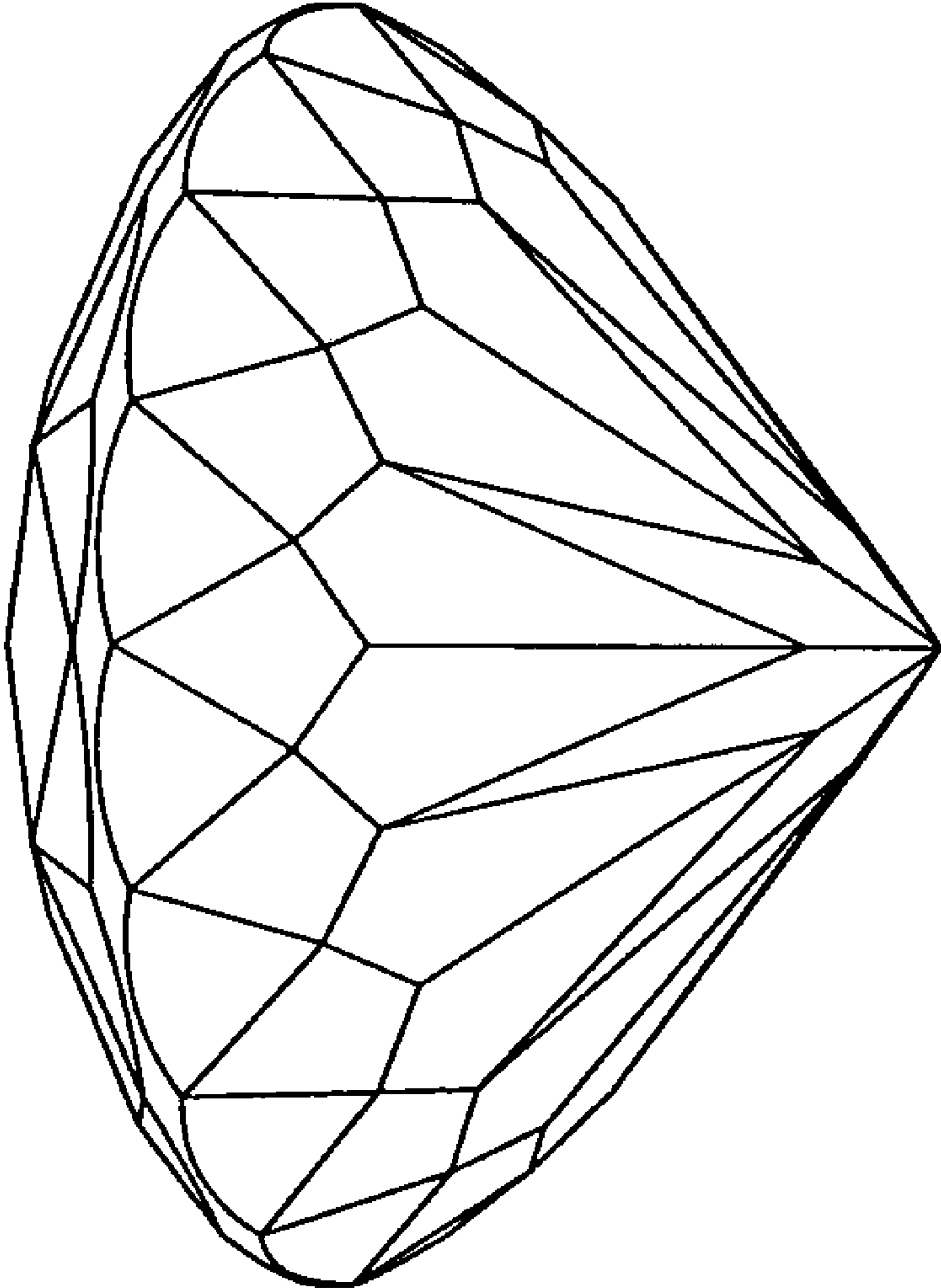

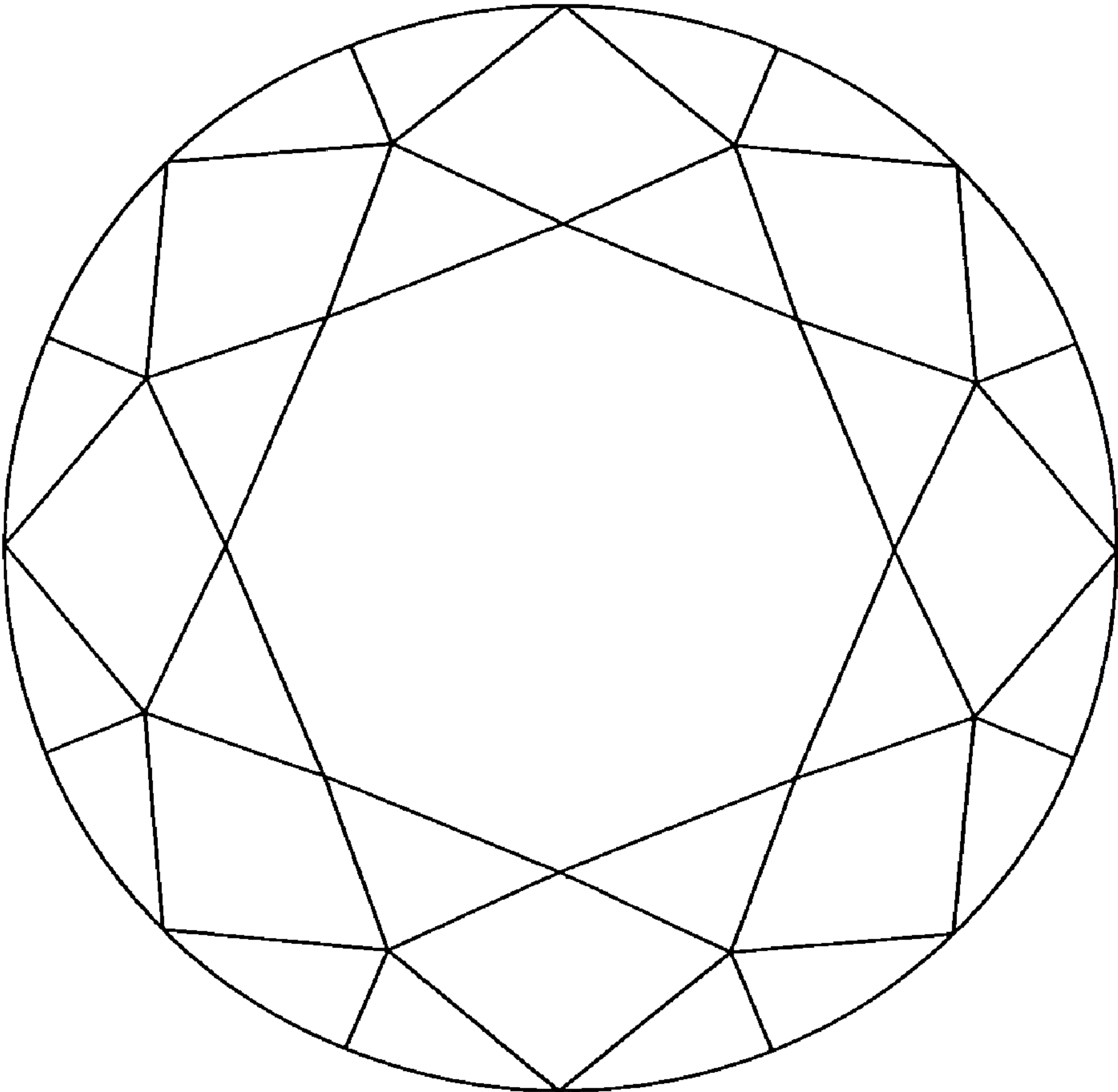

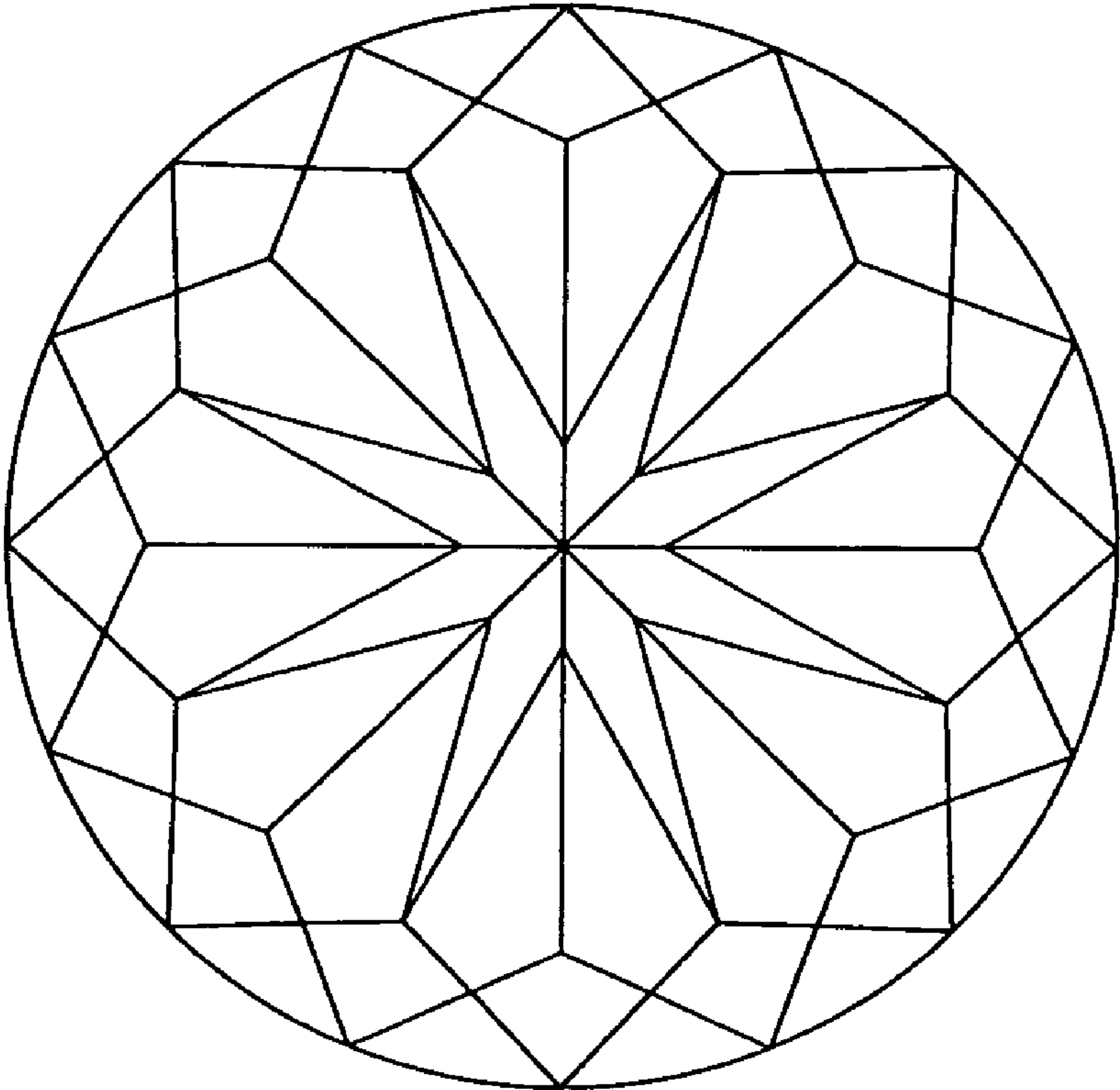

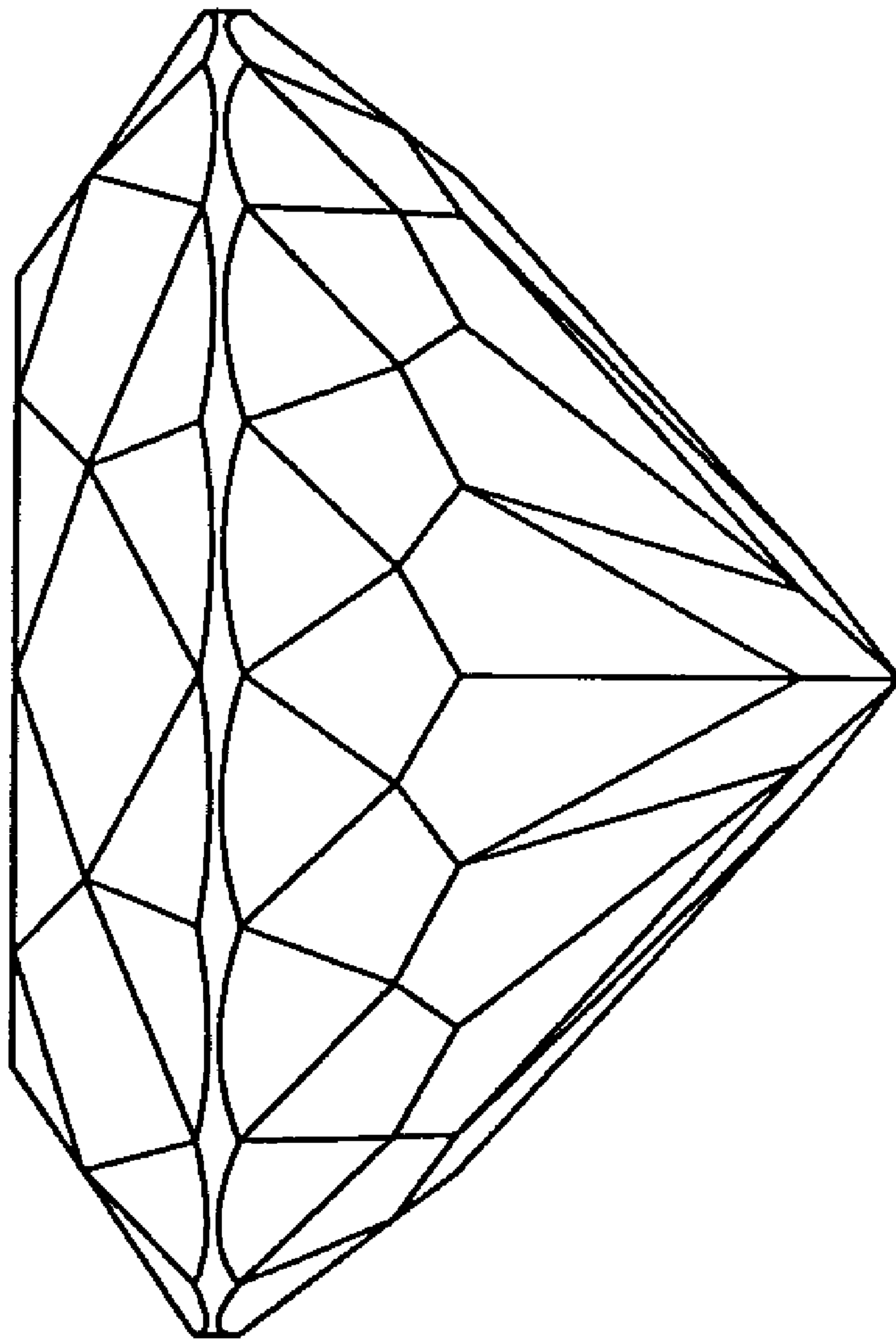
