(57) **CLAIM**

The ornamental design for a door figurine, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a door figurine in accordance with the invention;

FIG. 2 is a front elevation view of the door figurine shown in FIG. 1;

FIG. 3 is a rear elevation view of the door figurine shown in FIG. 1;

FIG. 4 is a left side elevation view of the door figurine shown in FIG. 1;

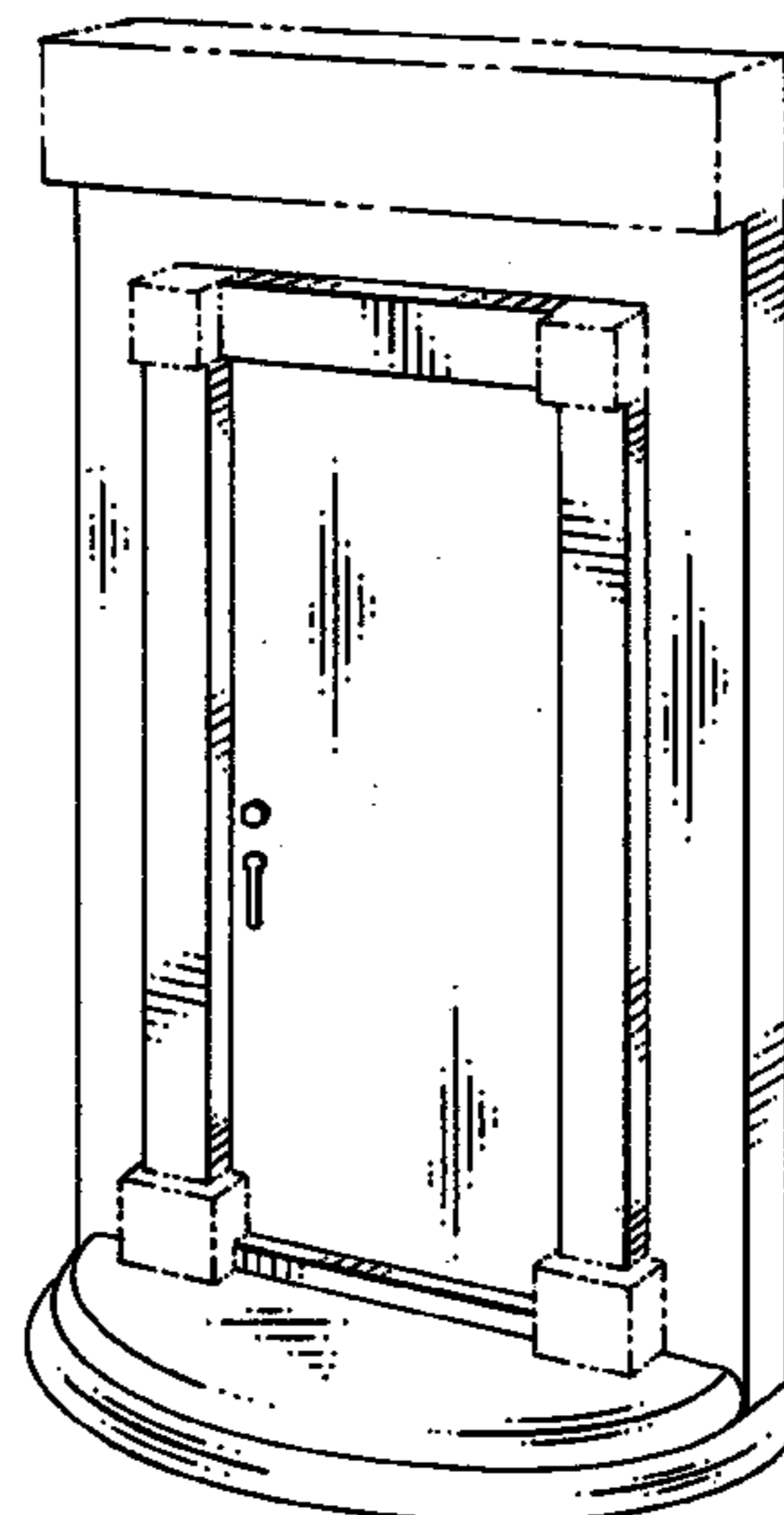
FIG. 5 is a right side elevation view of the door figurine shown in FIG. 1;

FIG. 6 is a top plan view of the door figurine shown in FIG. 1; and,

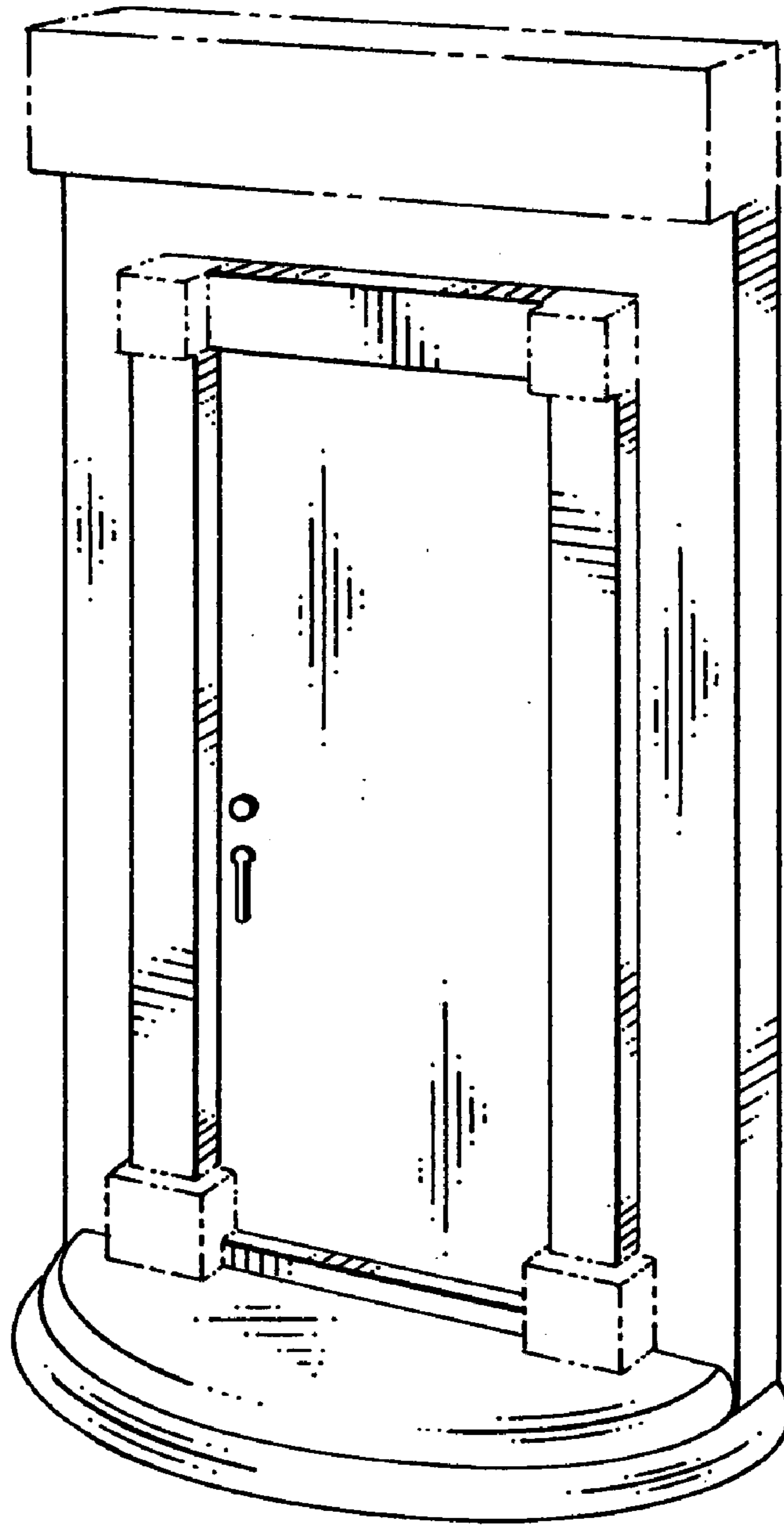

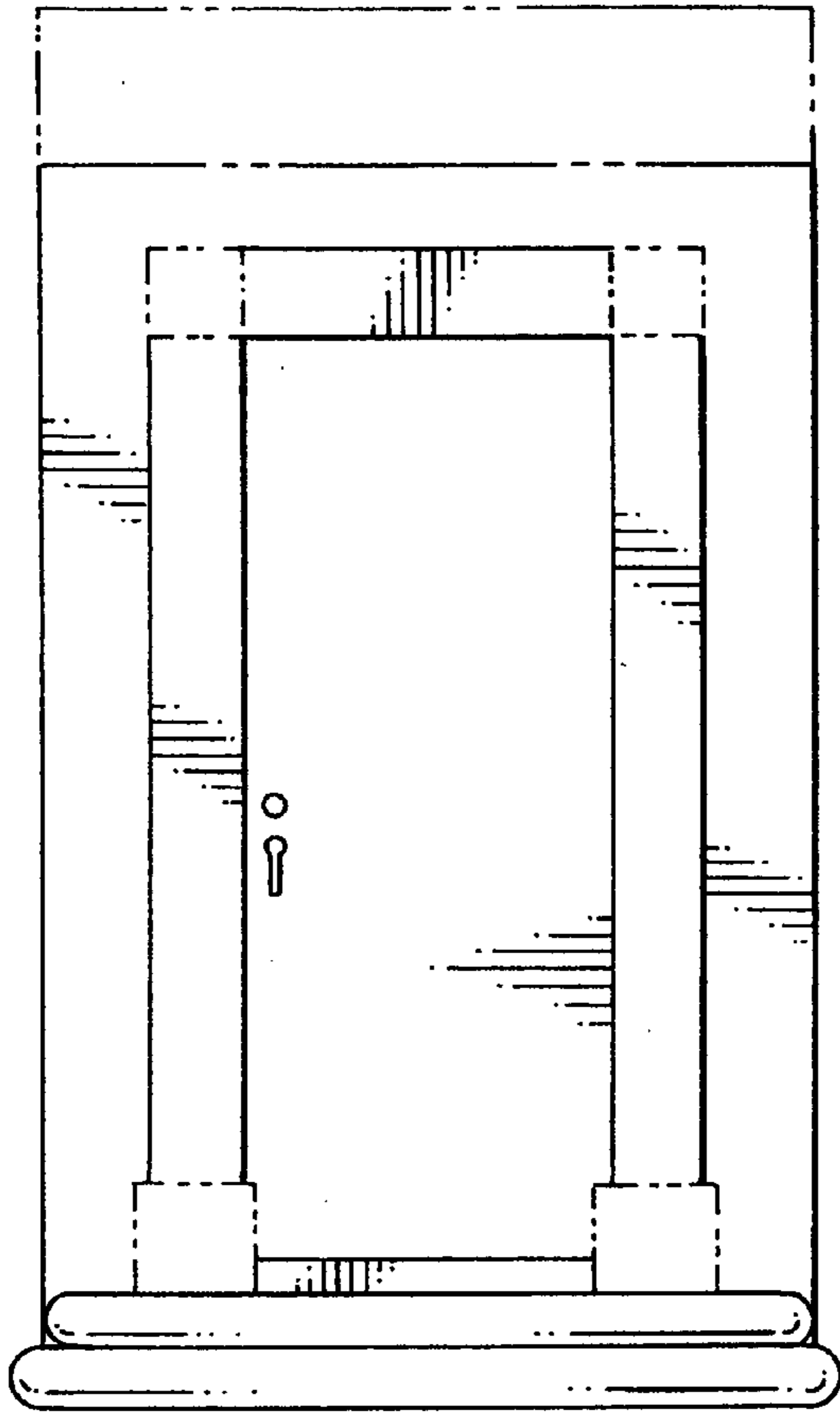

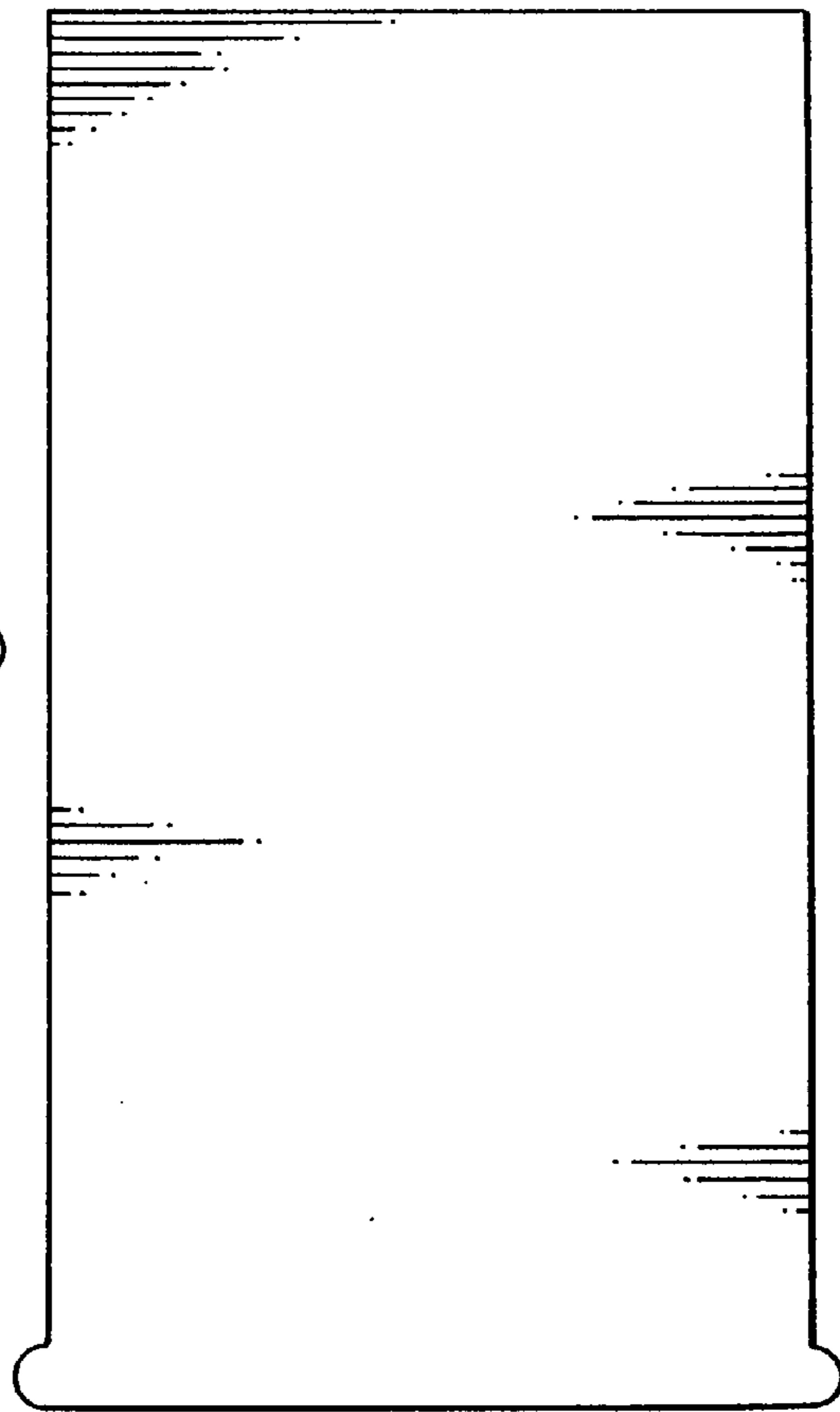

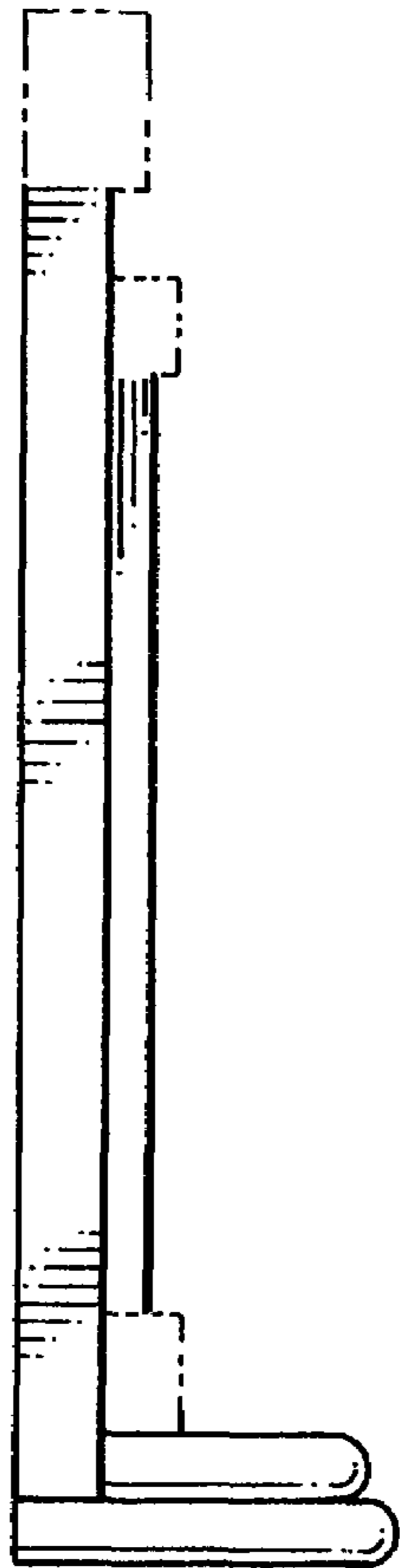

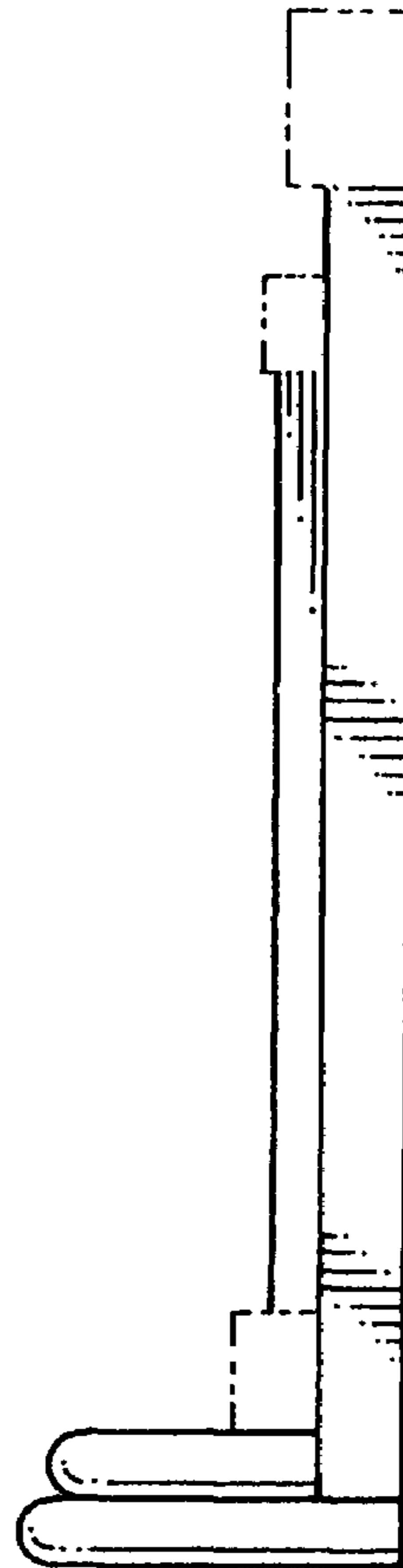

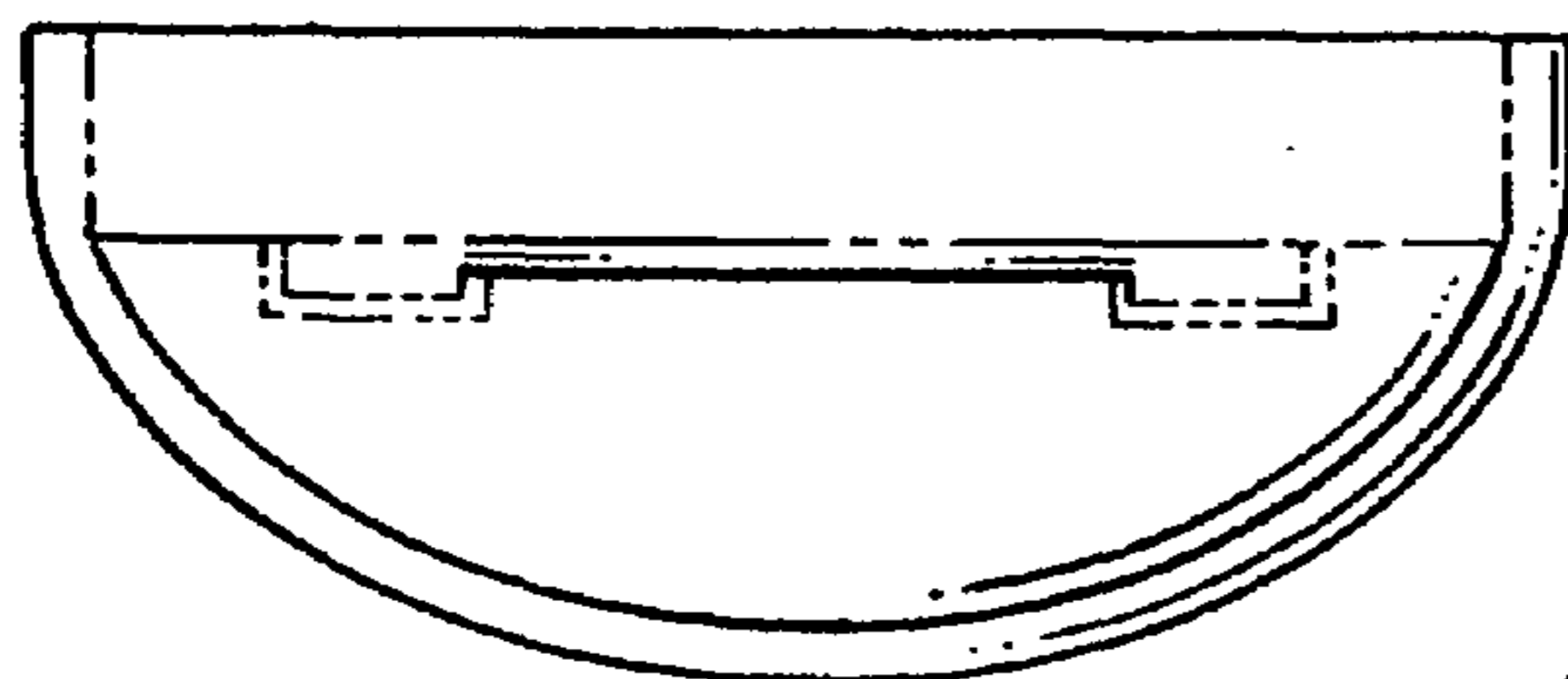

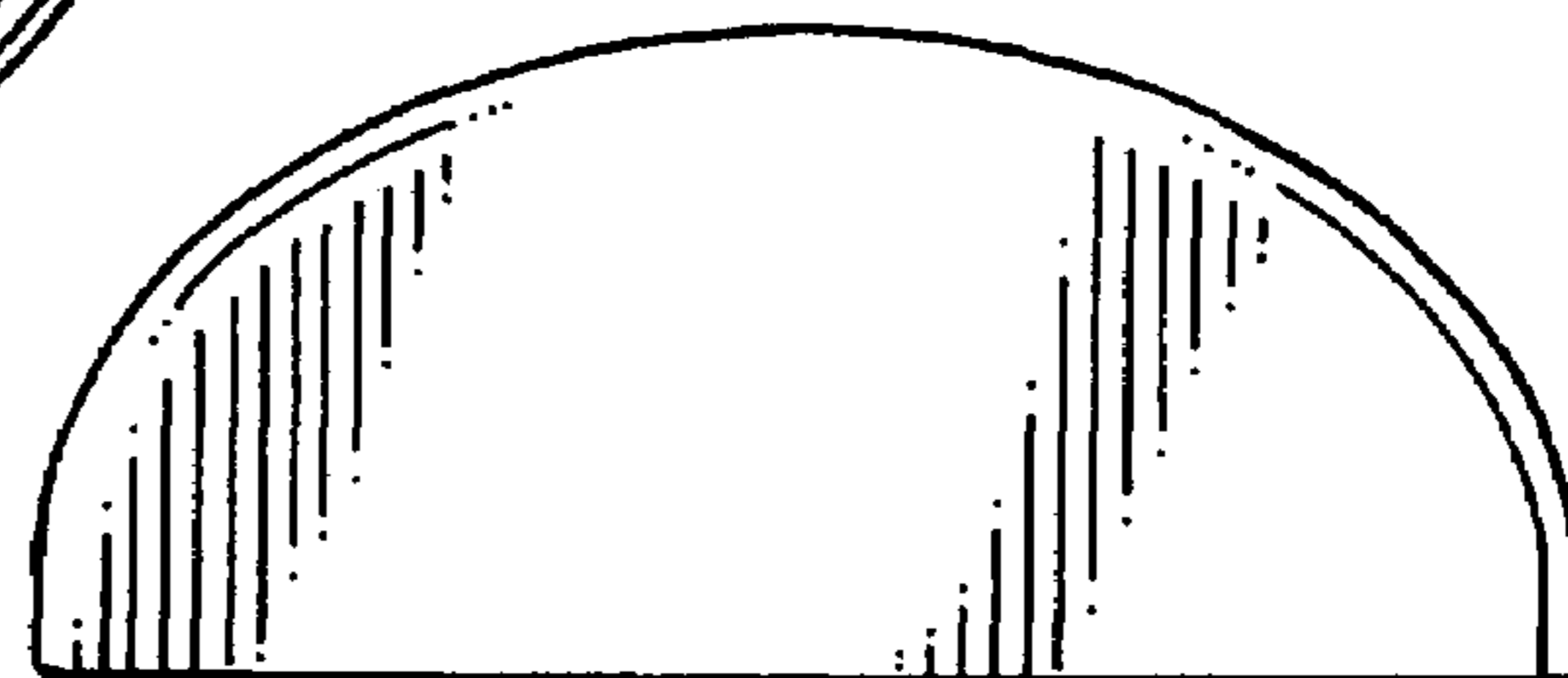
