FIG. 1 is a perspective view of the greeting card showing my new design.

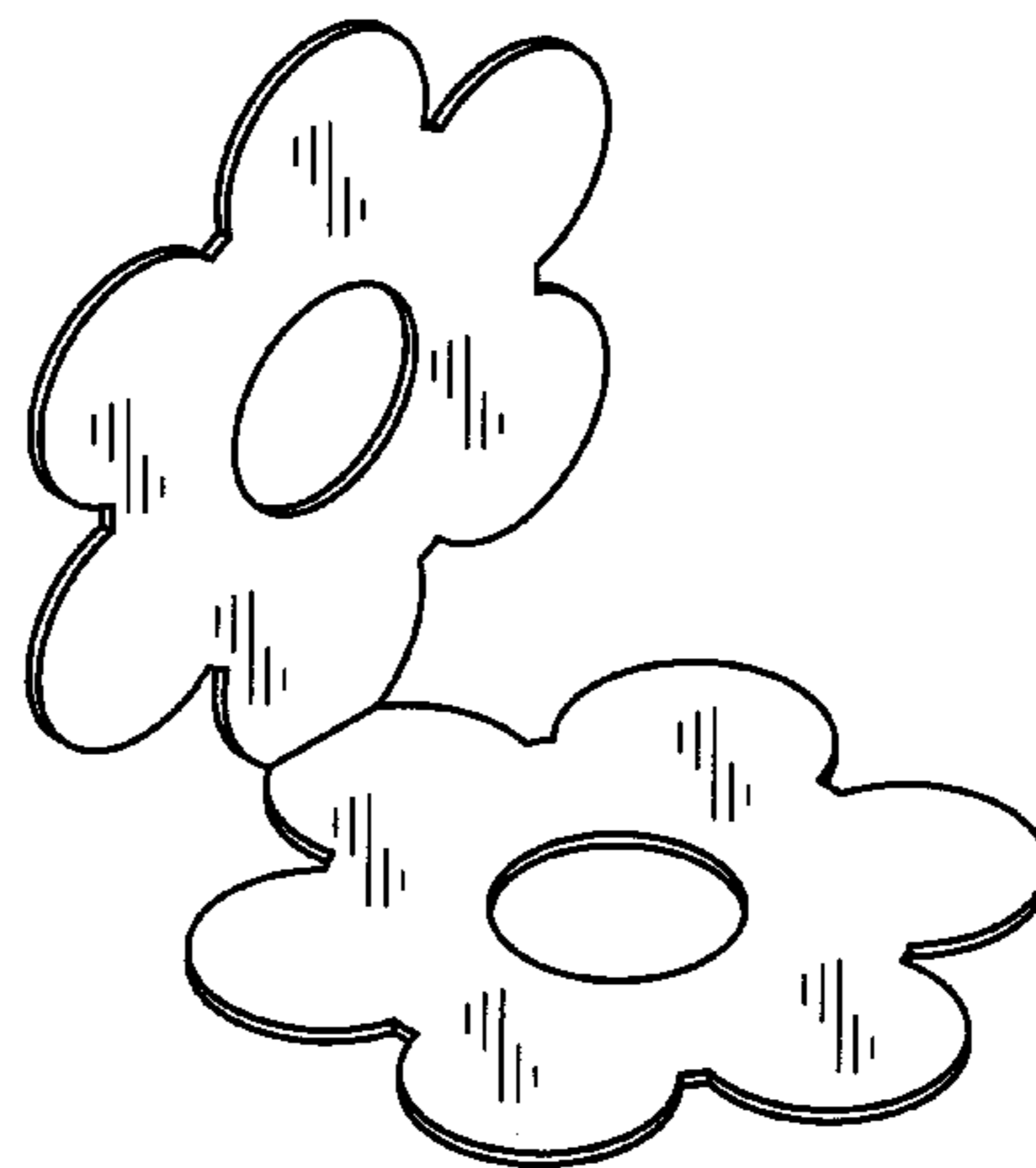
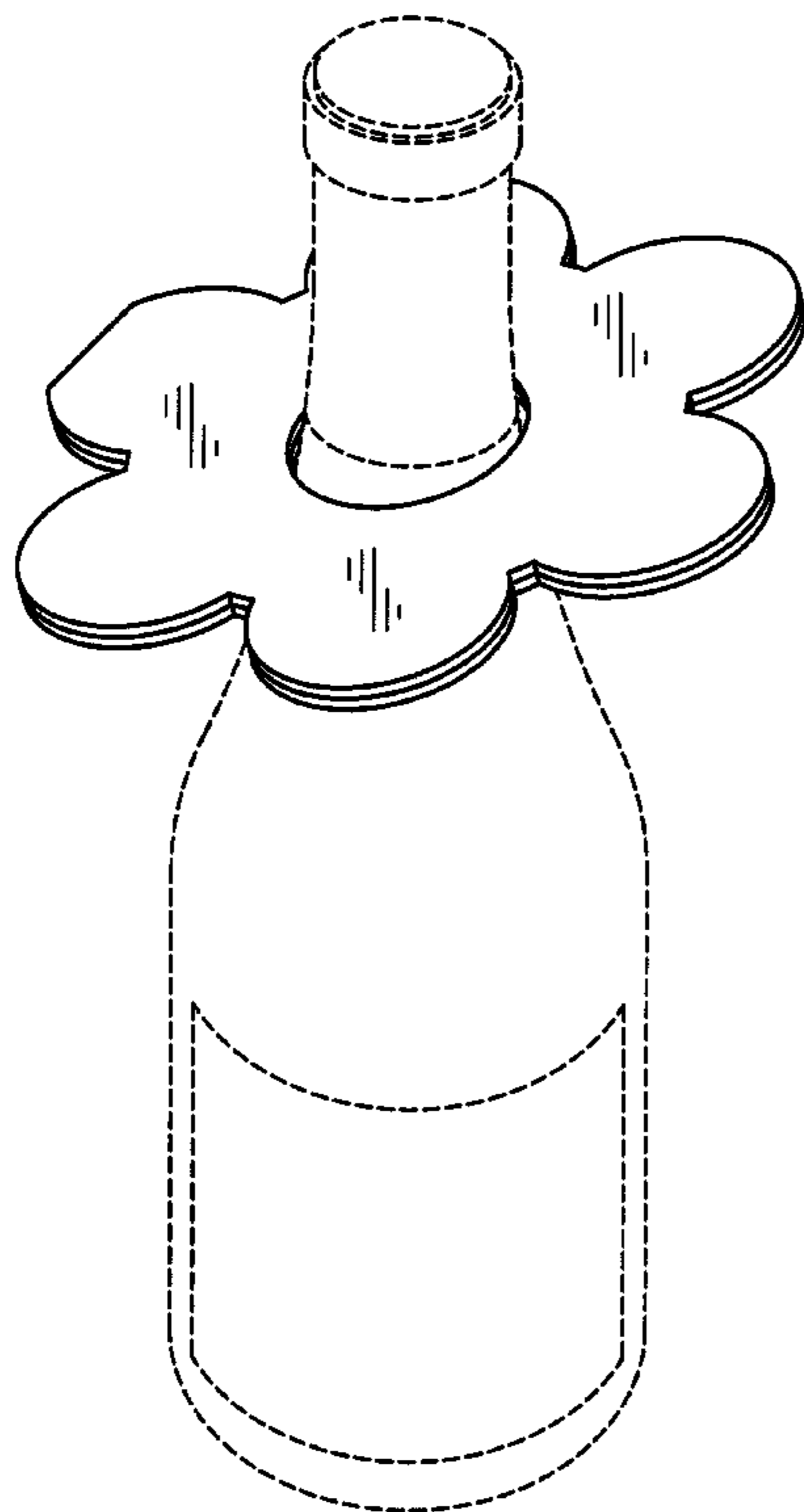
FIG. 2 is a front perspective view thereof; and,

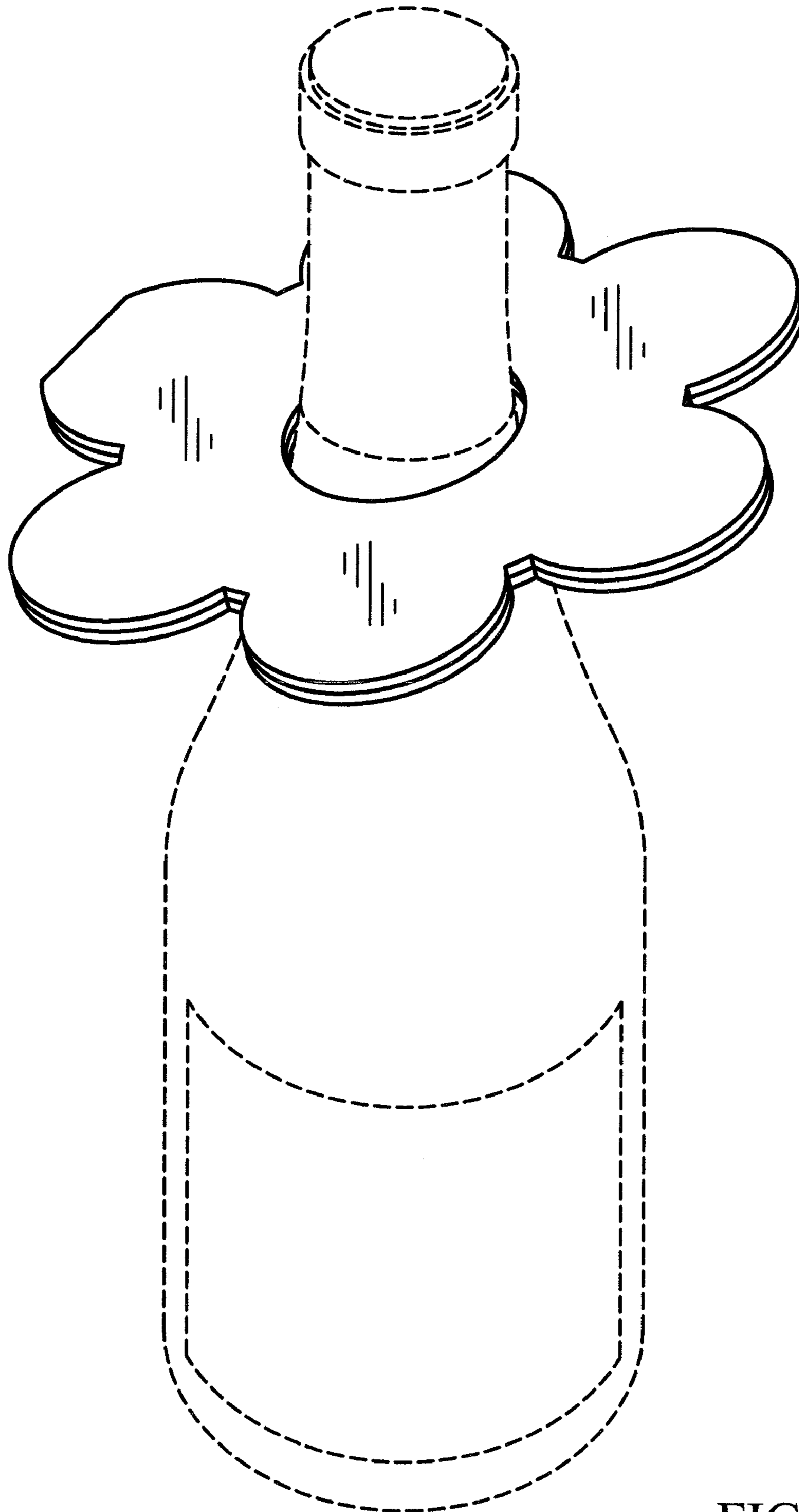

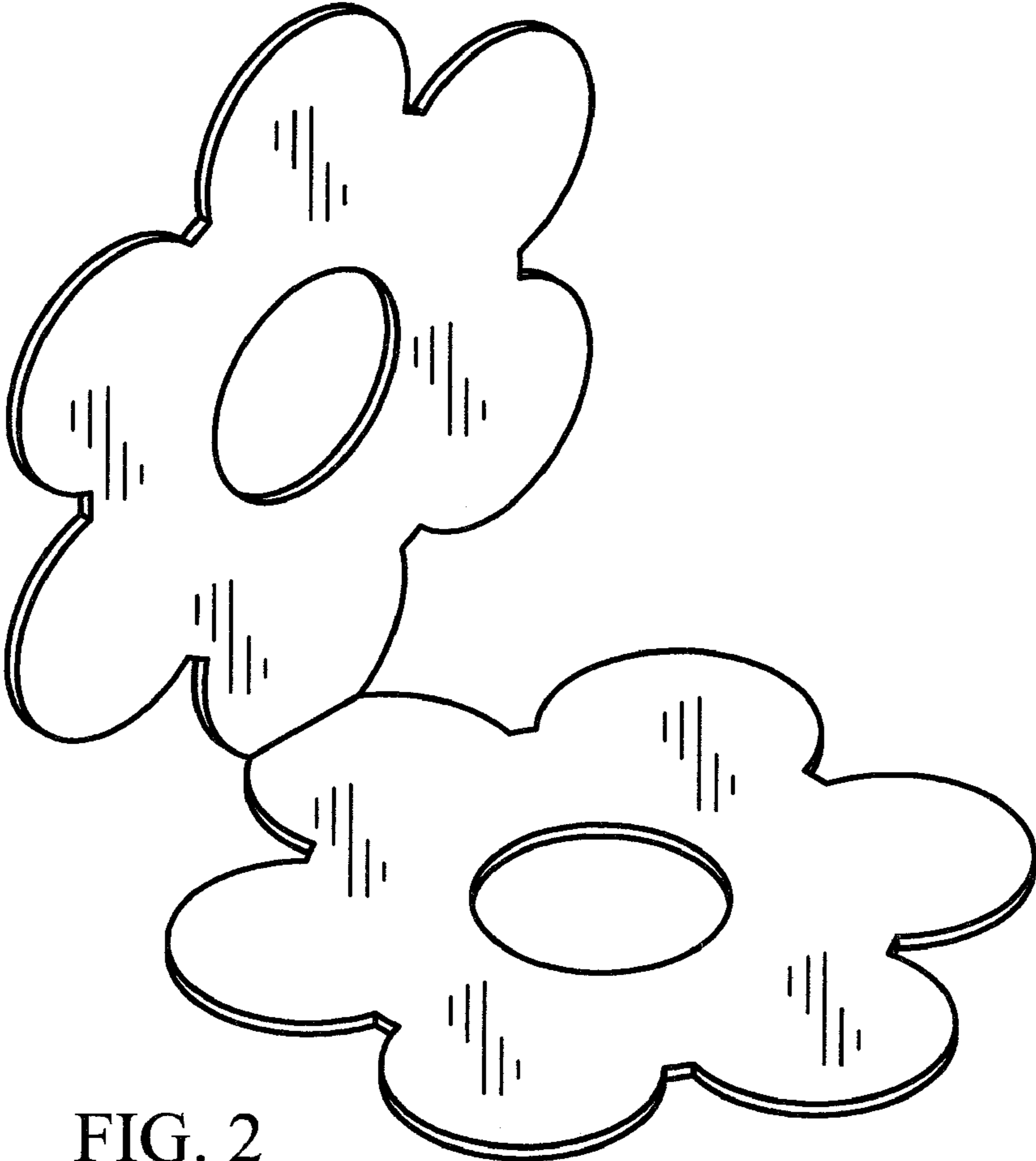

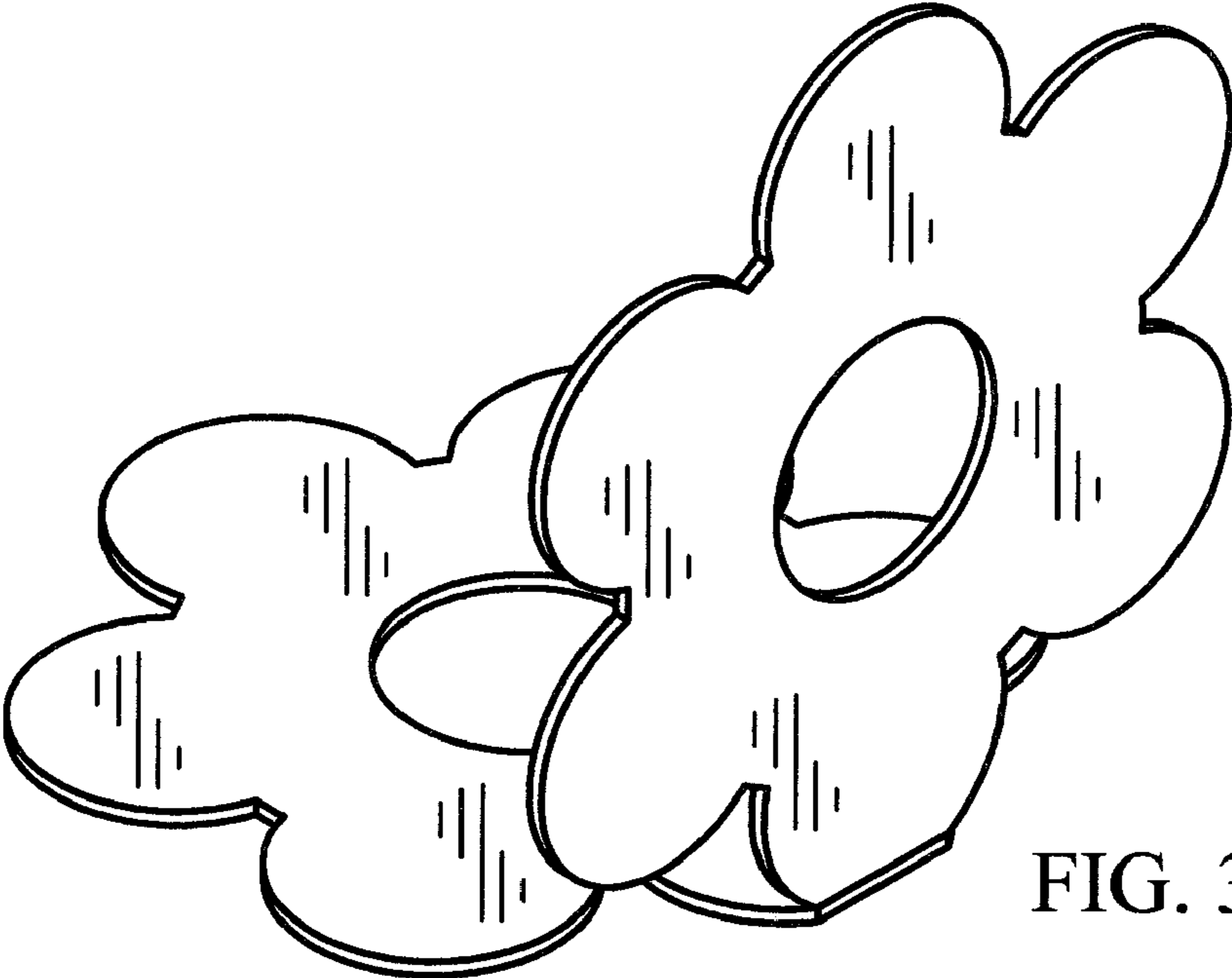
