(57) **CLAIM**

The ornamental design for the toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first component of the toy showing our new design, the strap end being partially broken away in FIGS. 1-3 for ease of illustration;

FIG. 2 is an inverted top view of FIG. 1;

FIG. 3 is a bottom view thereof;

FIG. 4 is a front view showing the full length of the strap end in an alternate position relative to FIGS. 1-3;

FIG. 5 is a back view thereof;

FIG. 6 is a left side view showing the strap end in another alternate position;

FIG. 7 is a right side view thereof;

FIG. 8 is a perspective view of the remote control component of the design;

FIG. 9 is a top view showing the remote control component with its tethered elements in an alternate position;

FIG. 10 is a bottom view thereof;

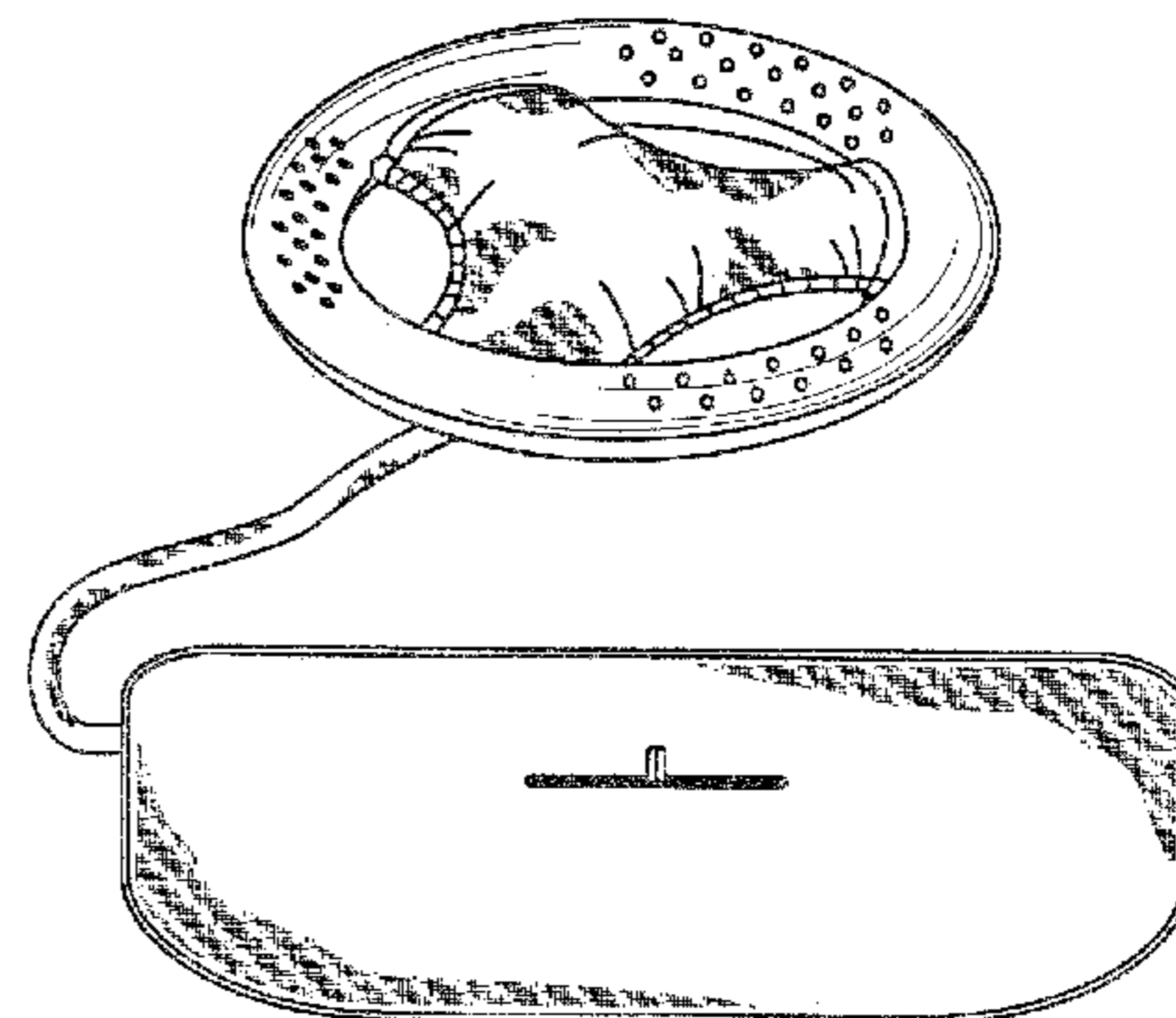
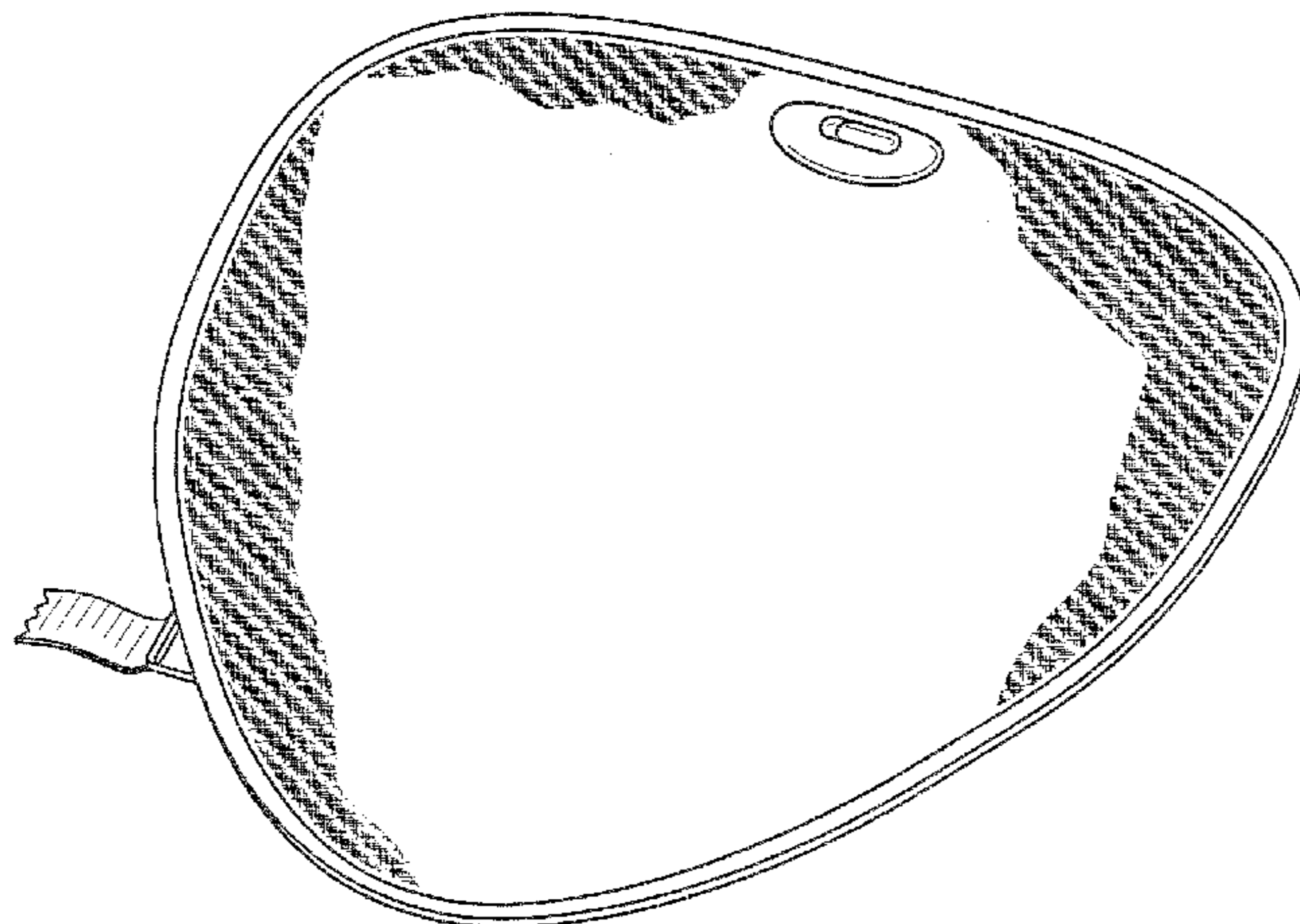
FIG. 11 is a left side view showing the remote control component with its tethered elements in another alternative position;

FIG. 12 is a right side view thereof;

FIG. 13 is a fragmentary front view of FIGS. 11 and 12; and,

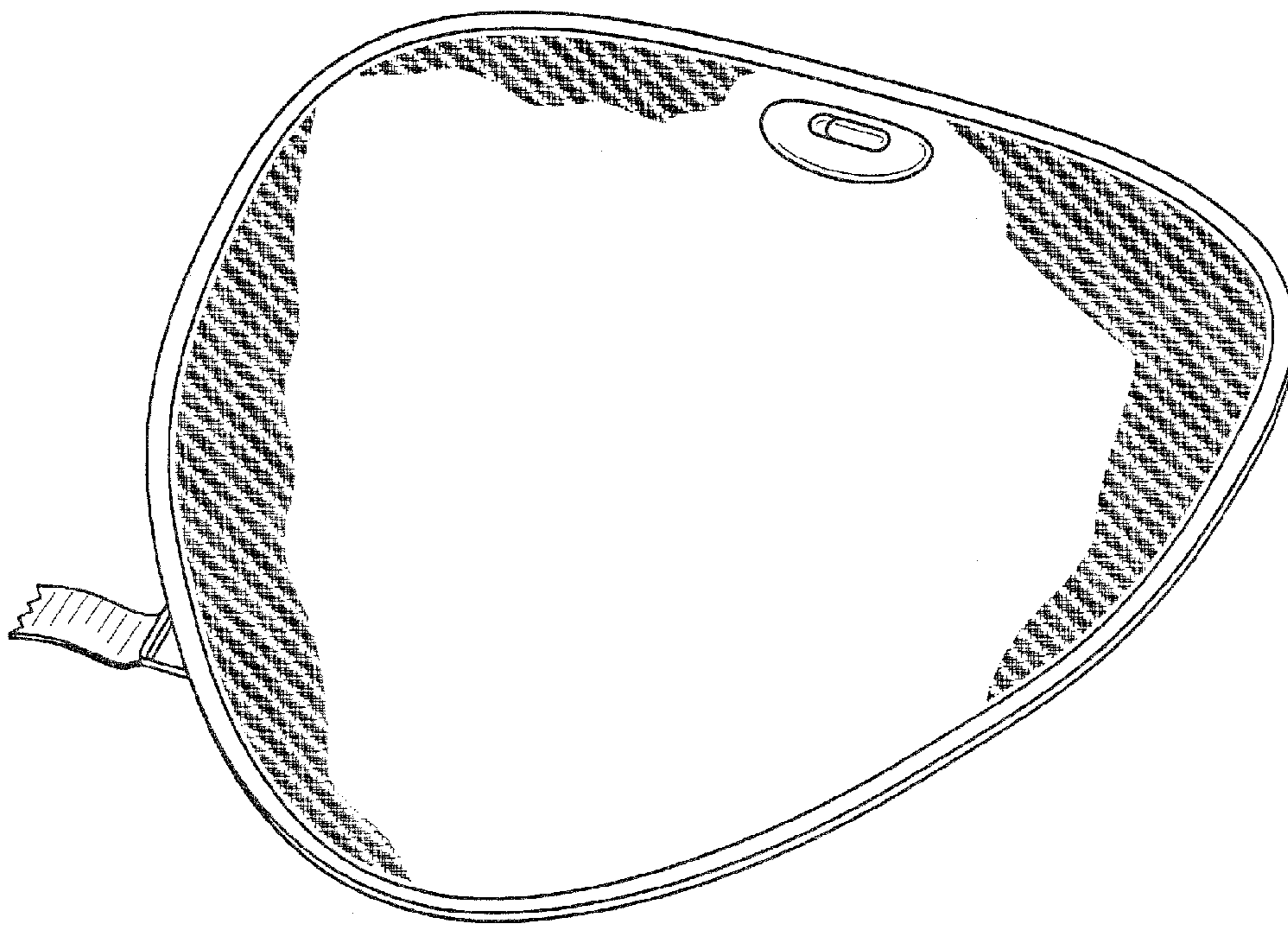

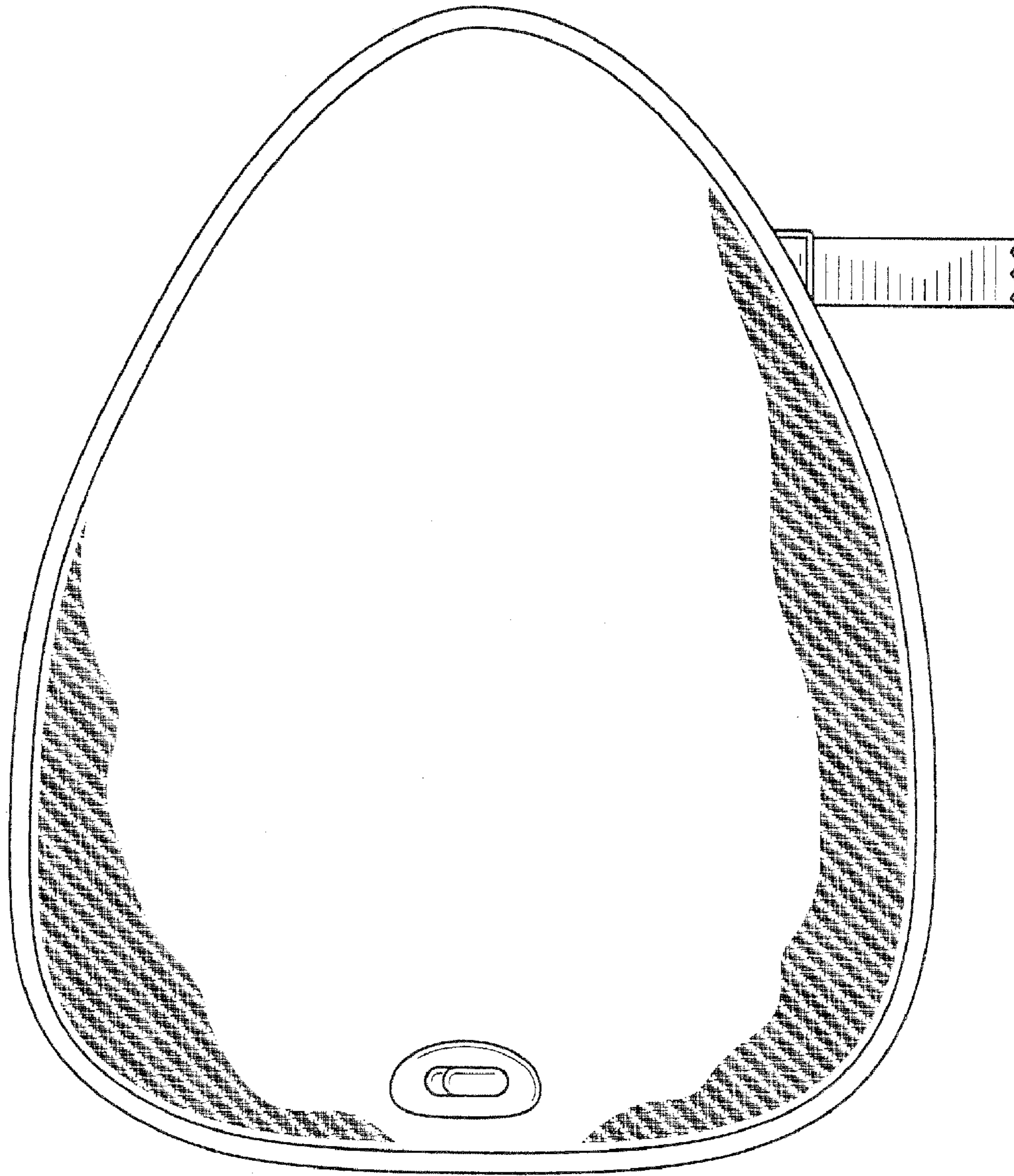

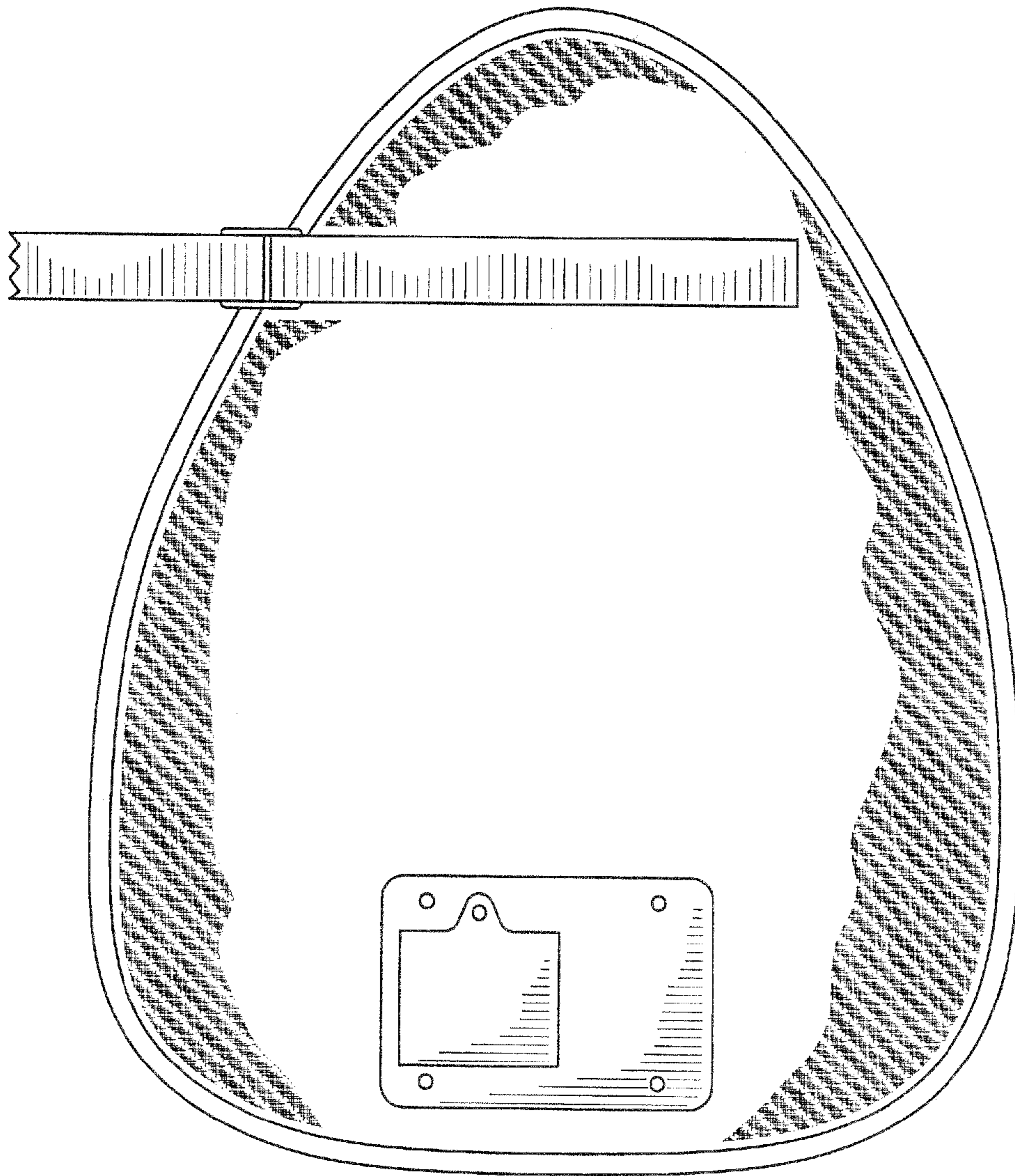

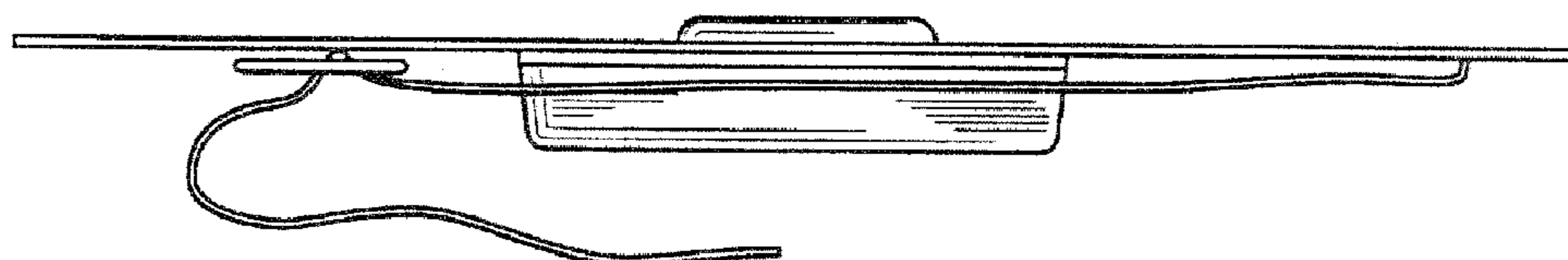

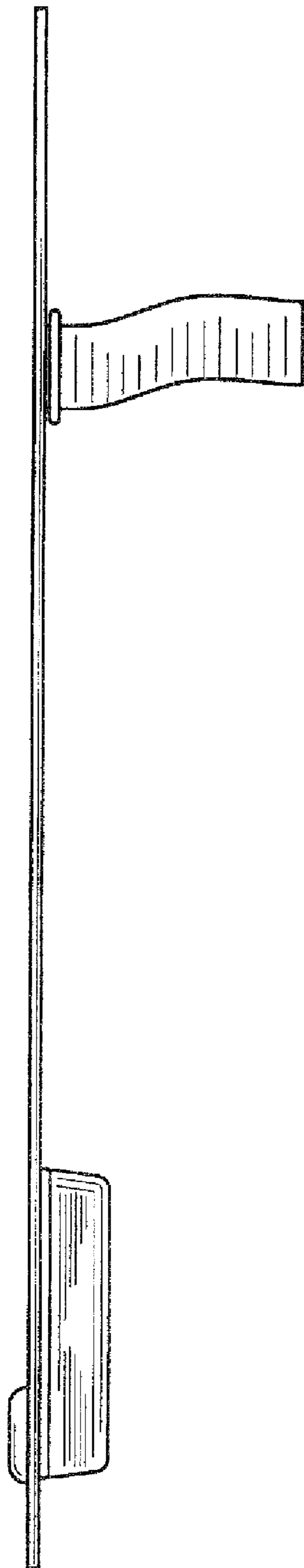

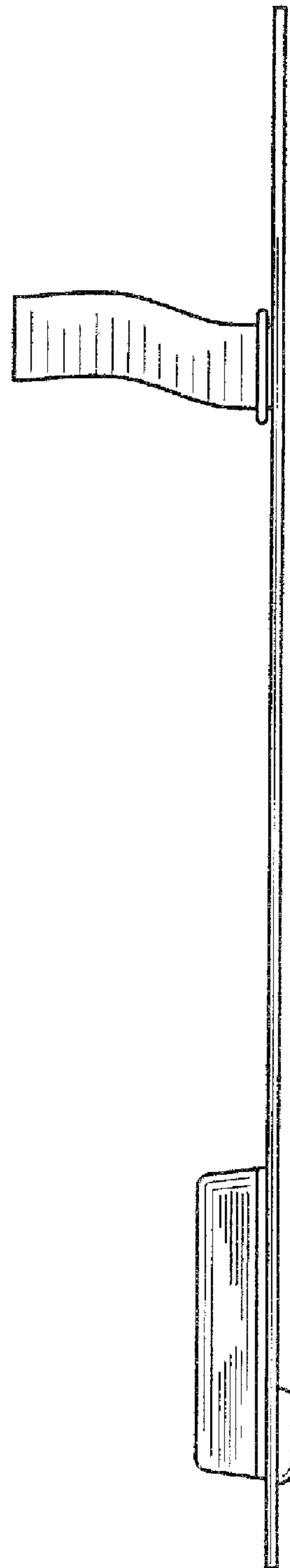

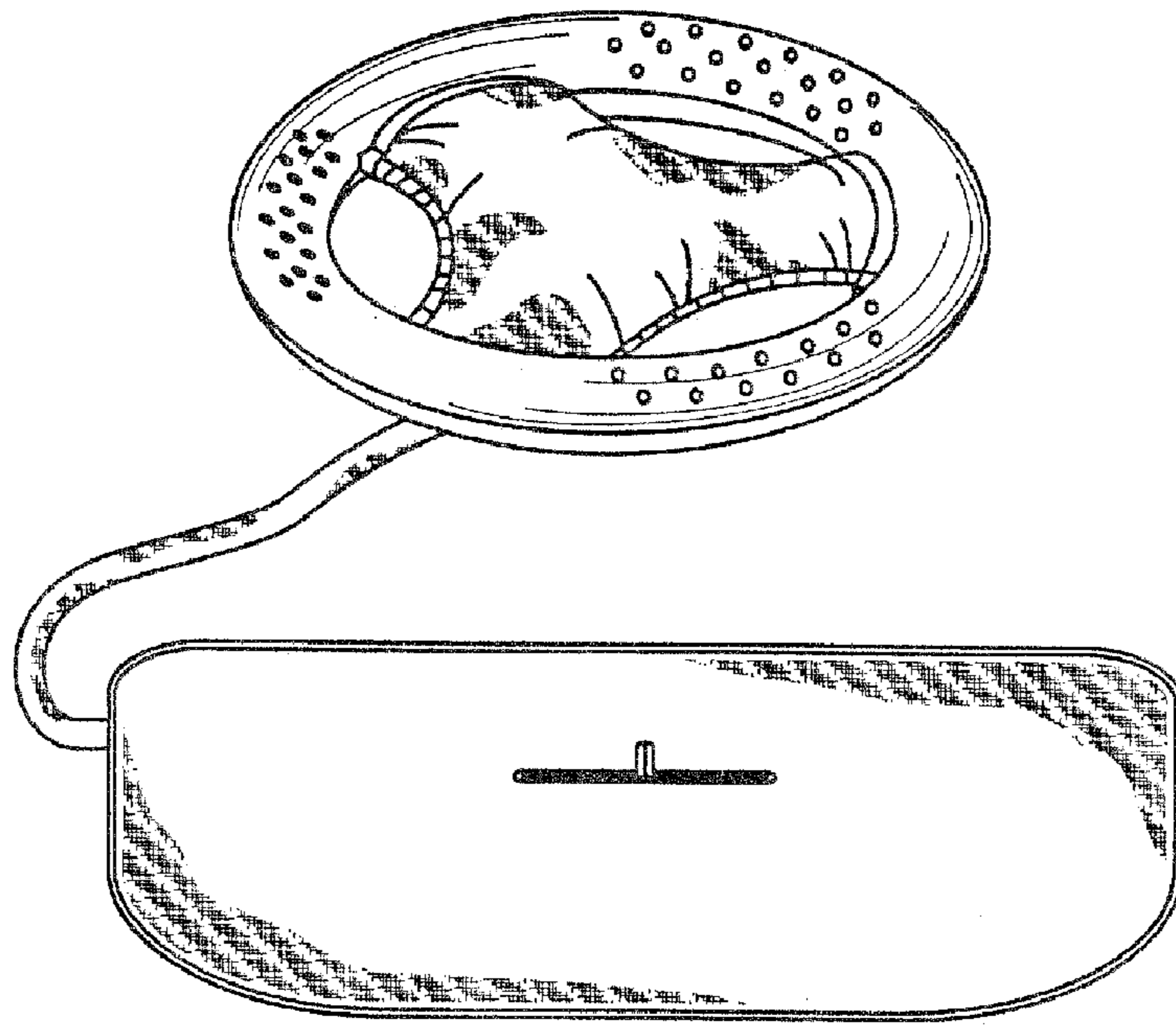

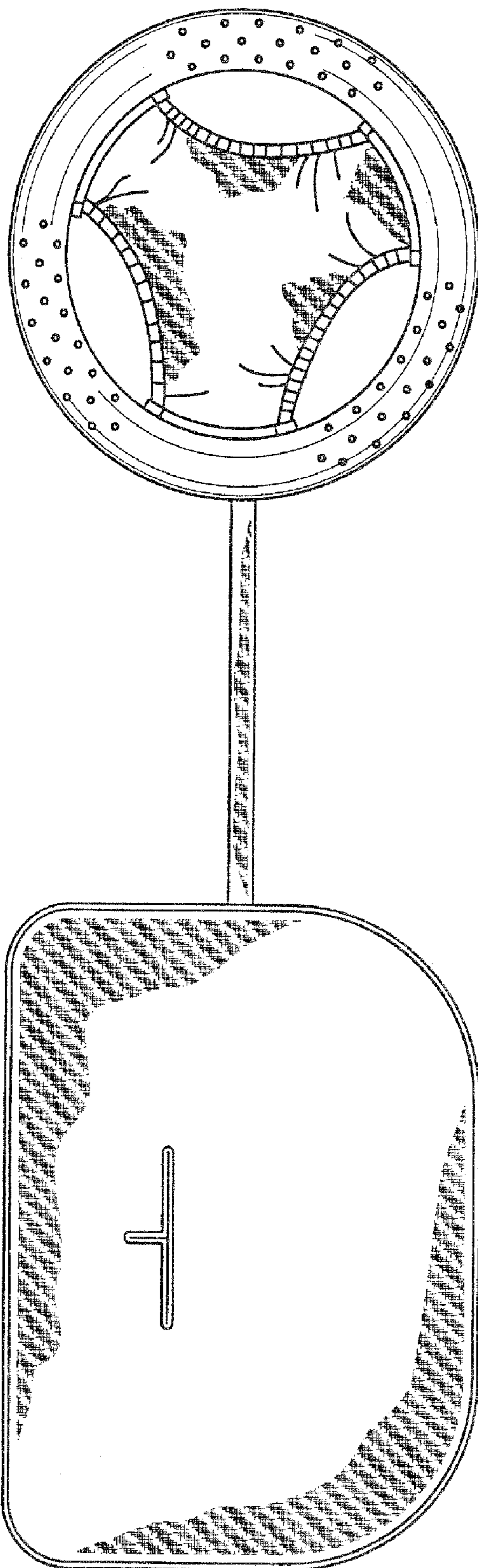

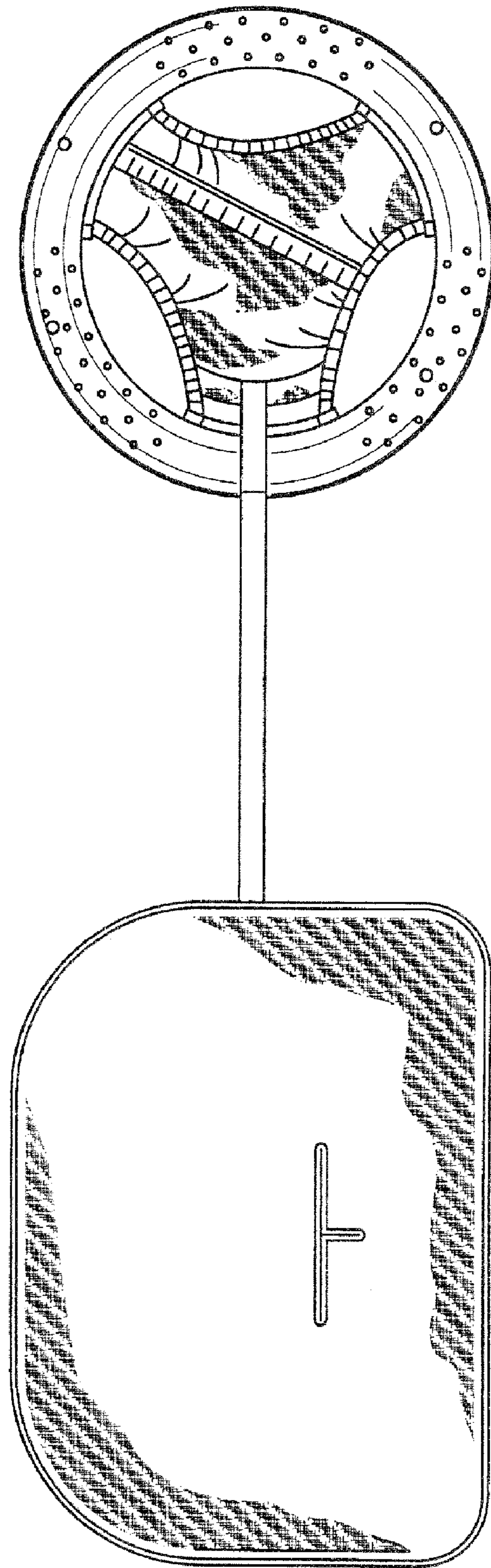

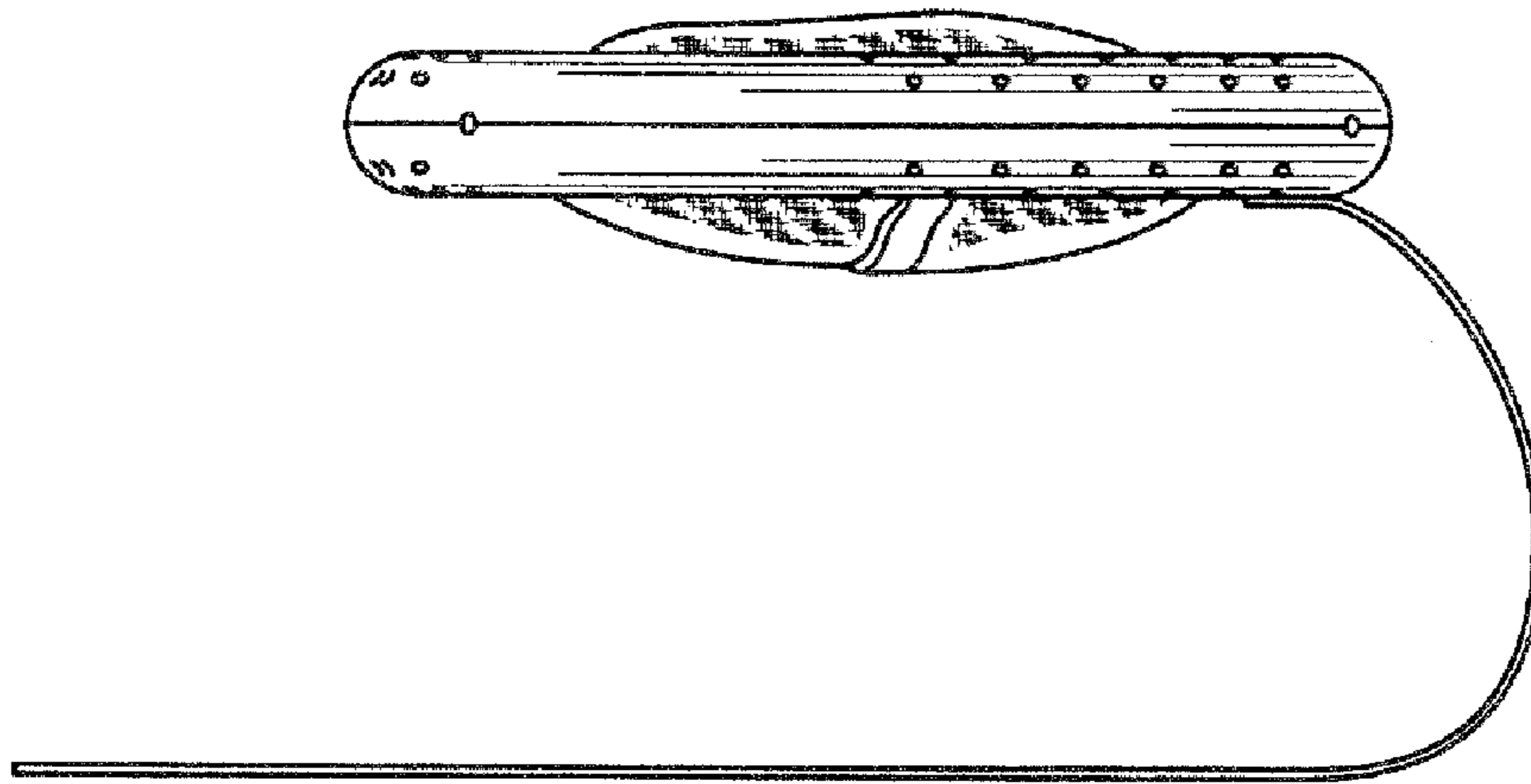

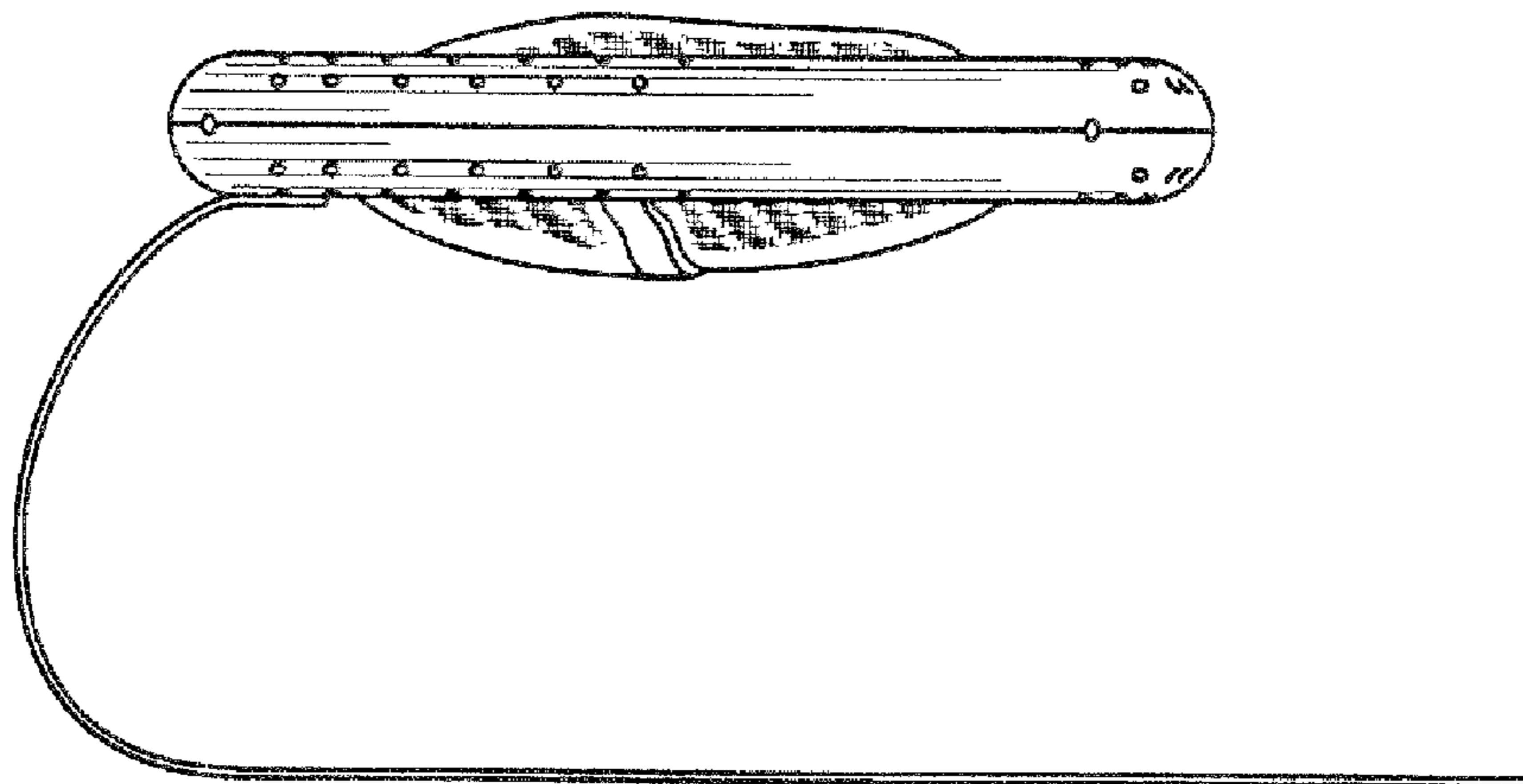

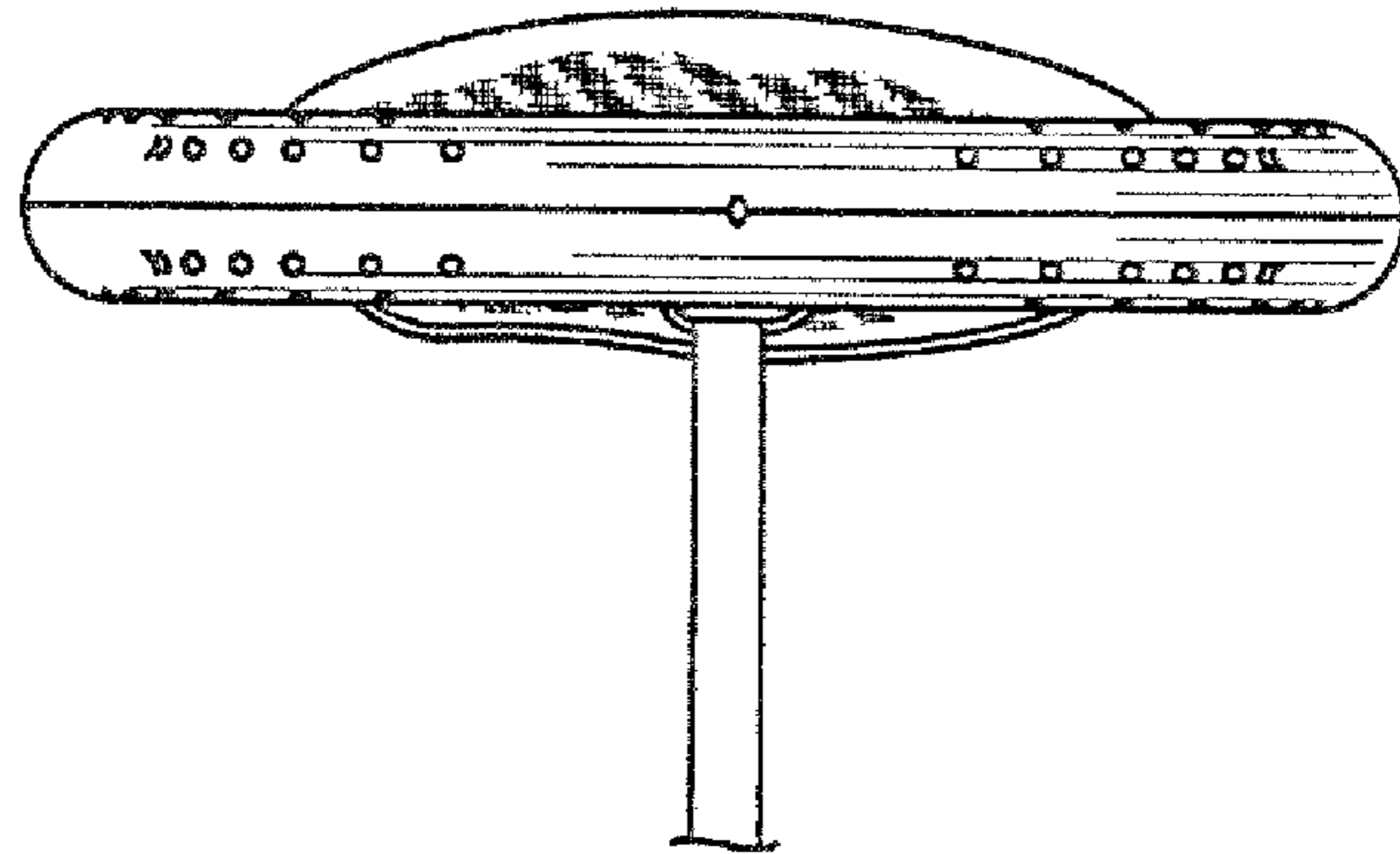

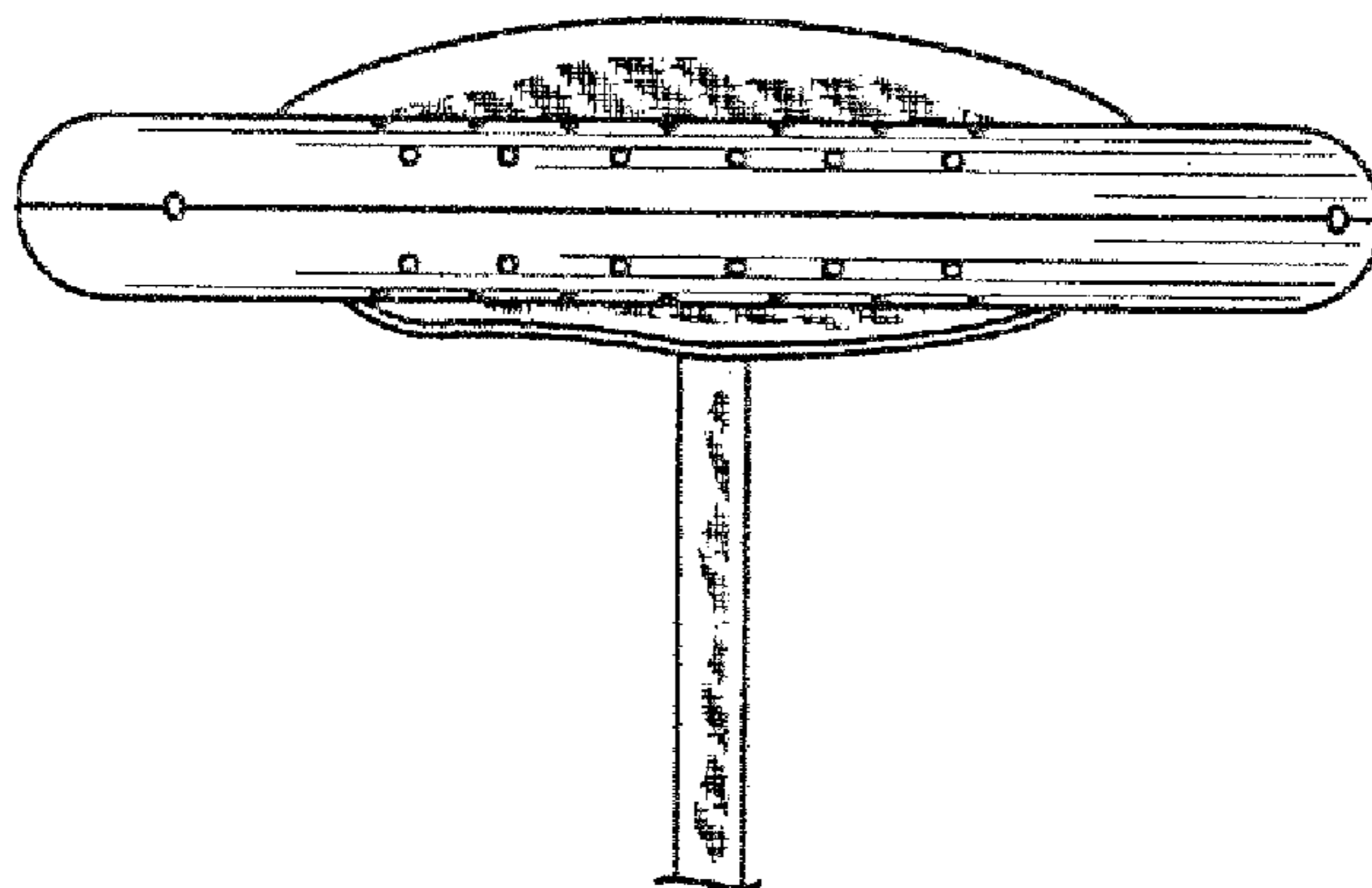
