**DESCRIPTION**

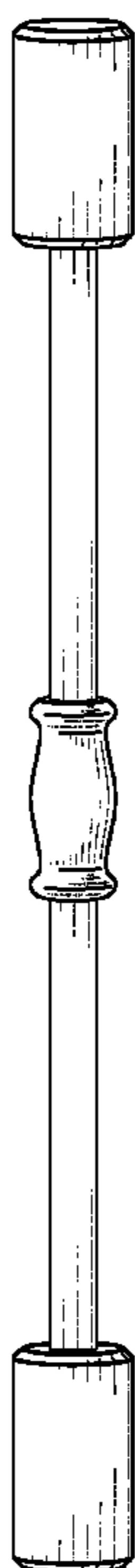
FIG. 1 is a perspective view of the plyometric exercise apparatus;

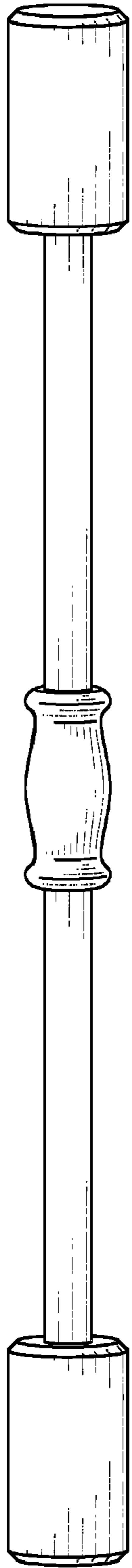
FIG. 2 is a front elevational view;

FIG. 3 is a top plan view of the plyometric exercise apparatus, the bottom view being a mirror image thereof; and,

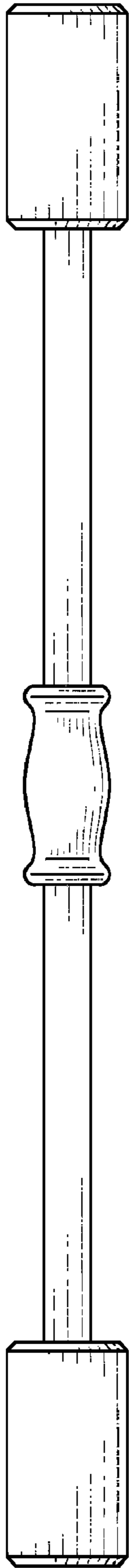
FIG. 4 is a fragmentary front elevation view, drawn to an enlarged scale showing an end portion thereof.

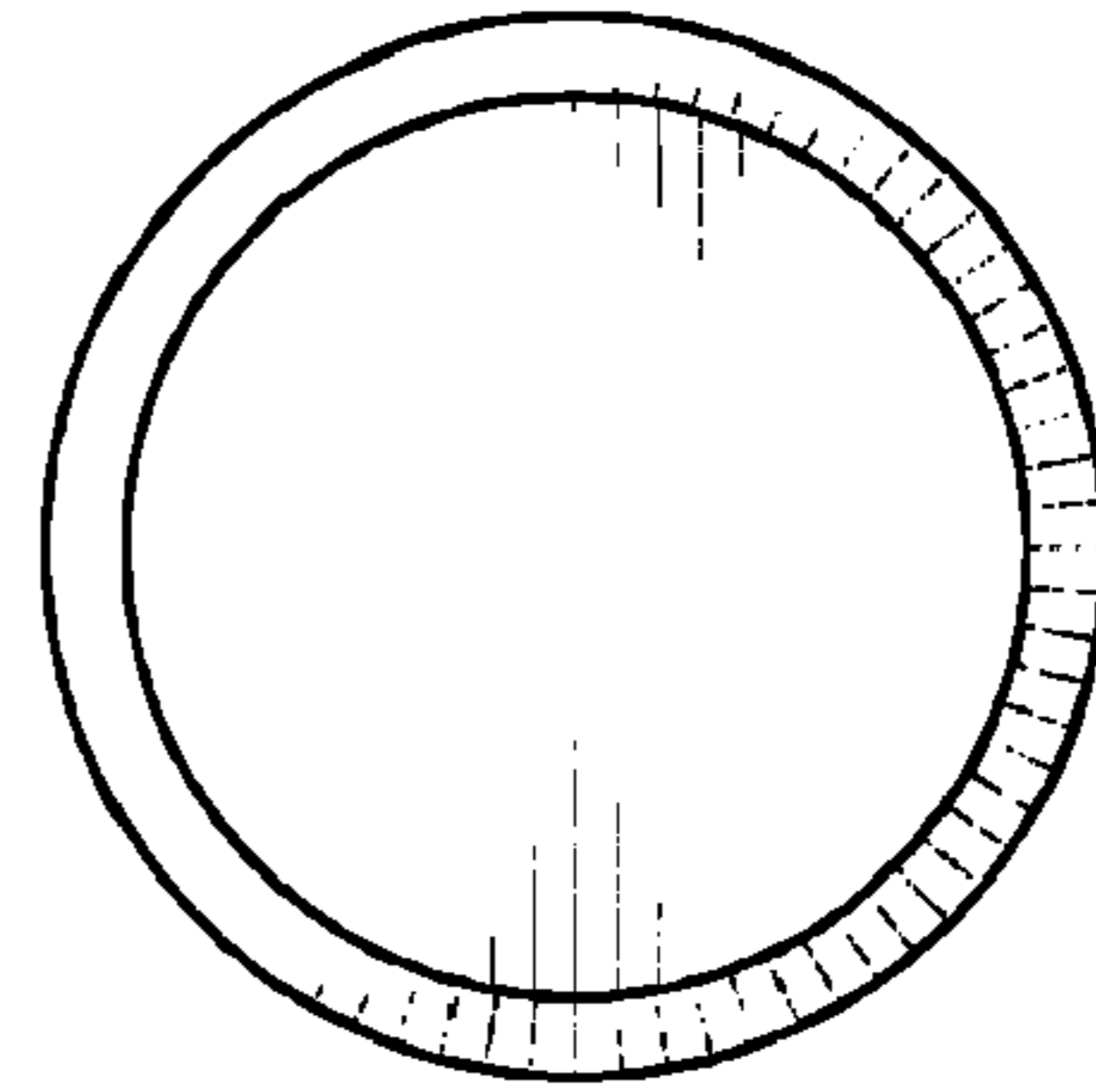




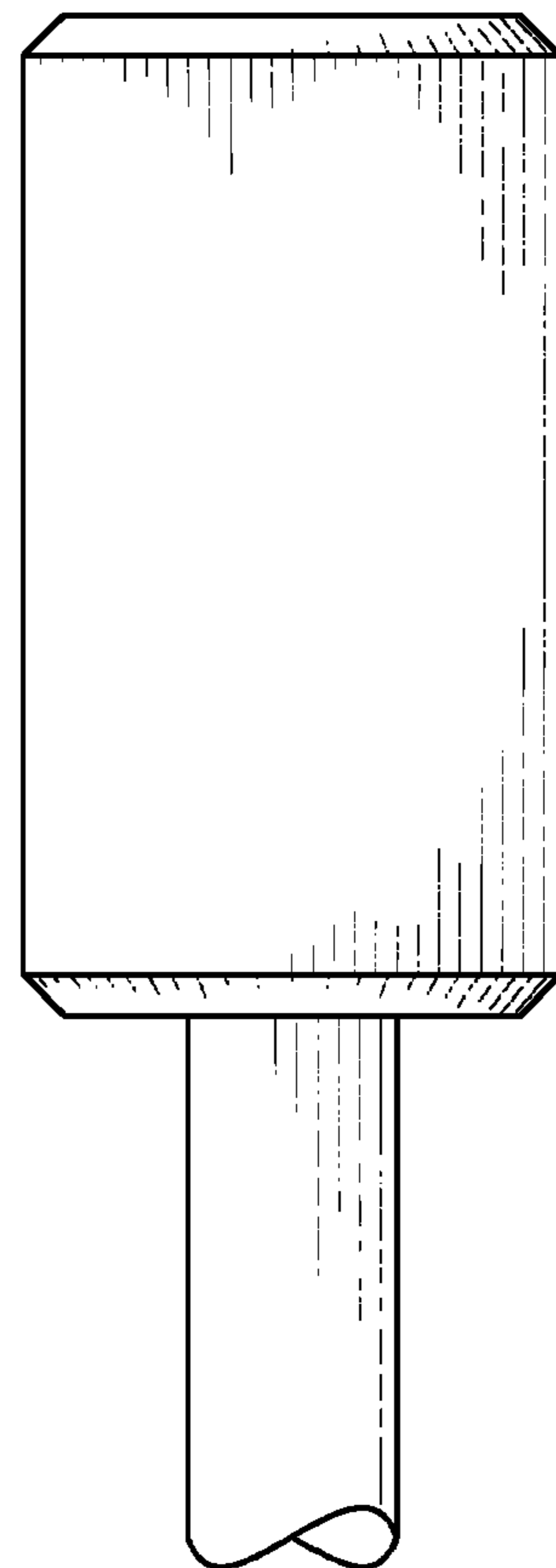
