FIG. 8 is a rear perspective view thereof.

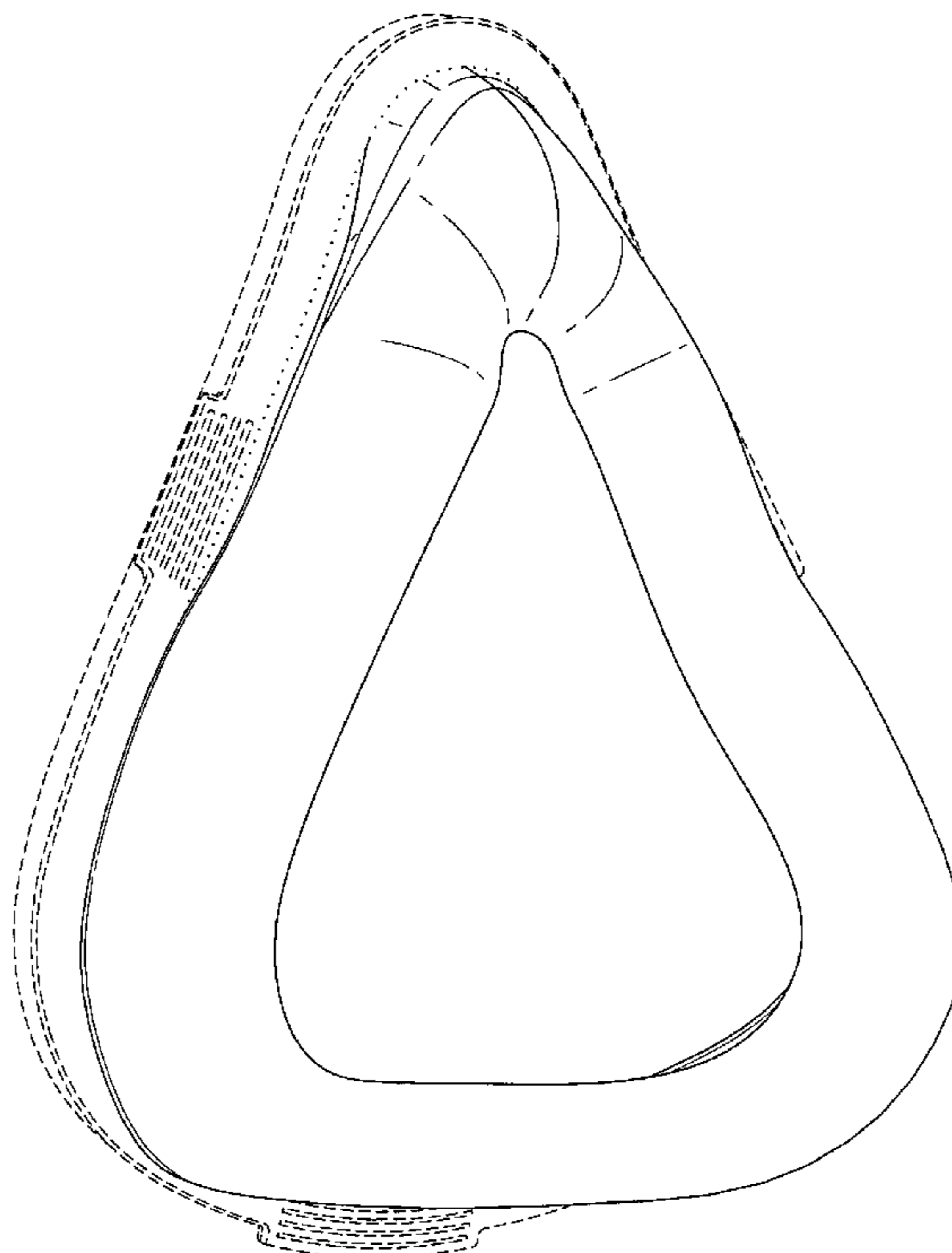

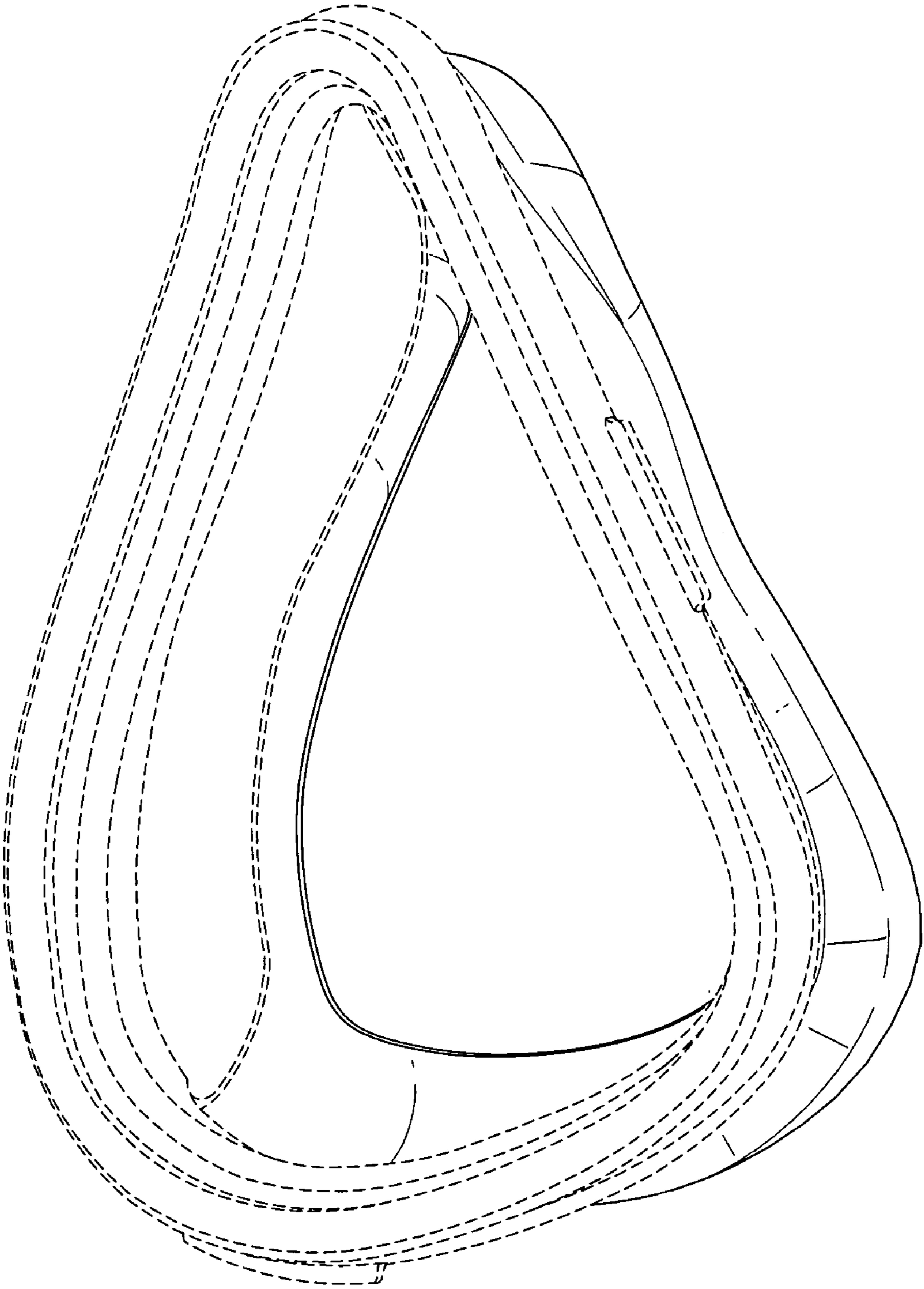

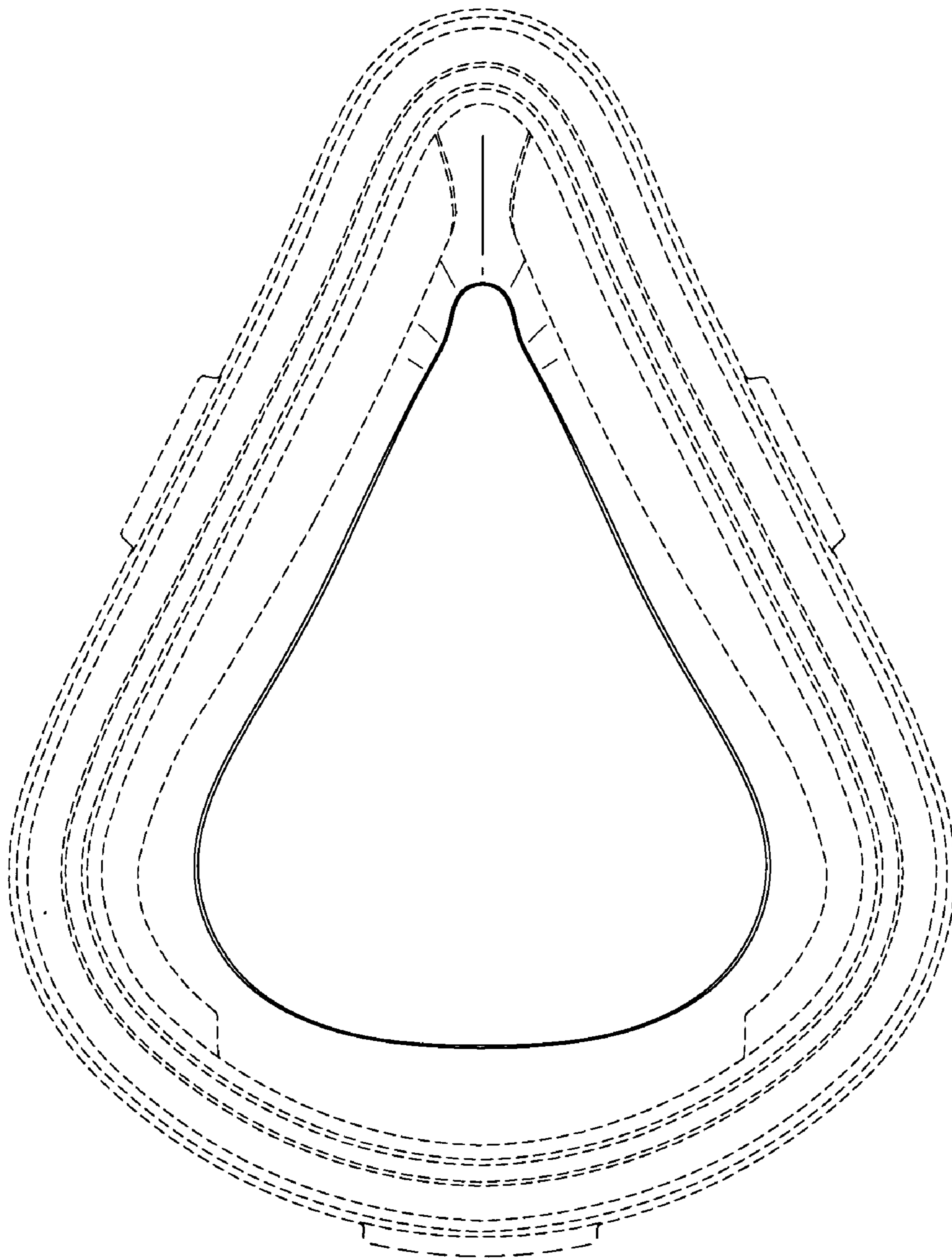

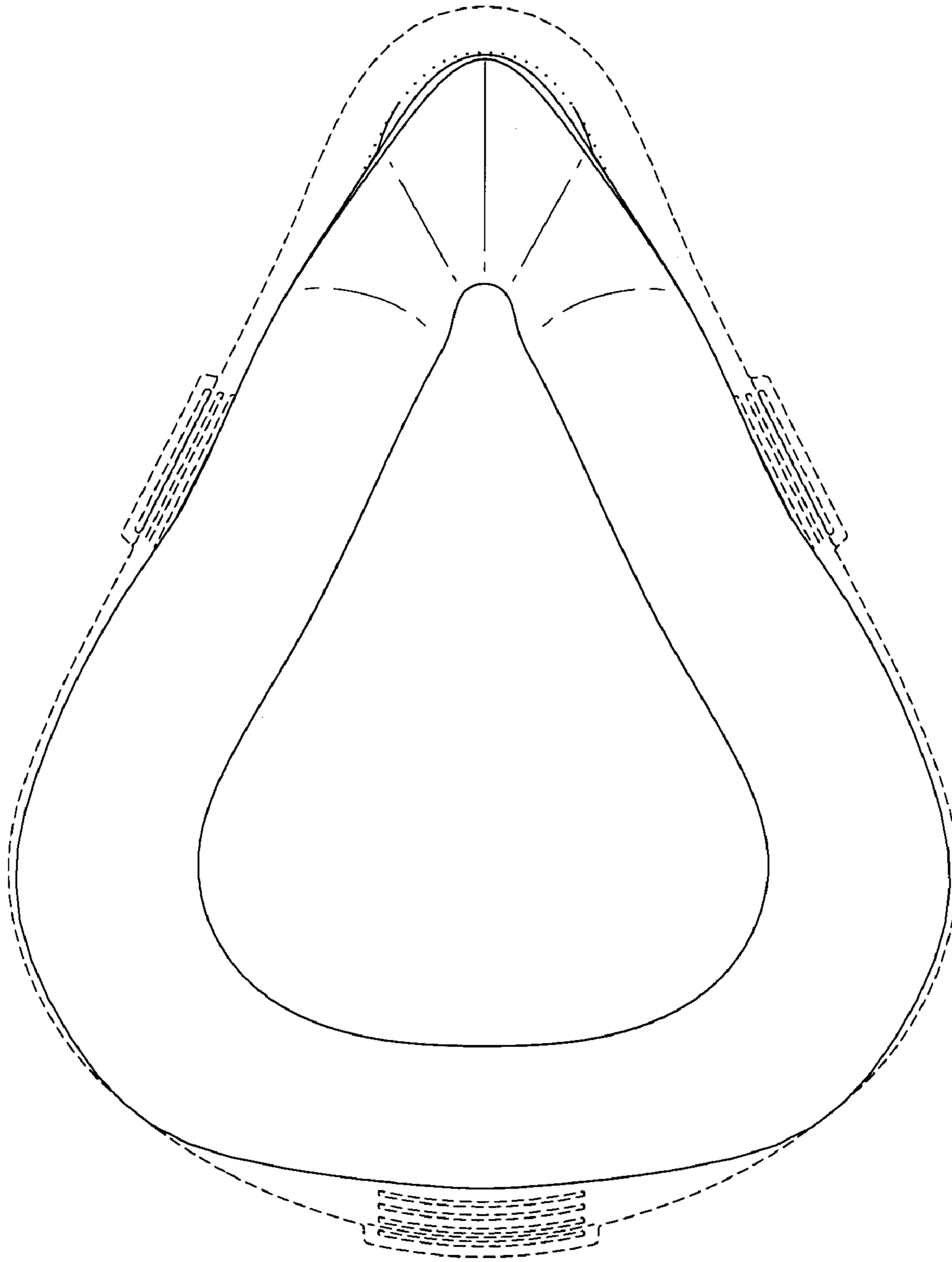

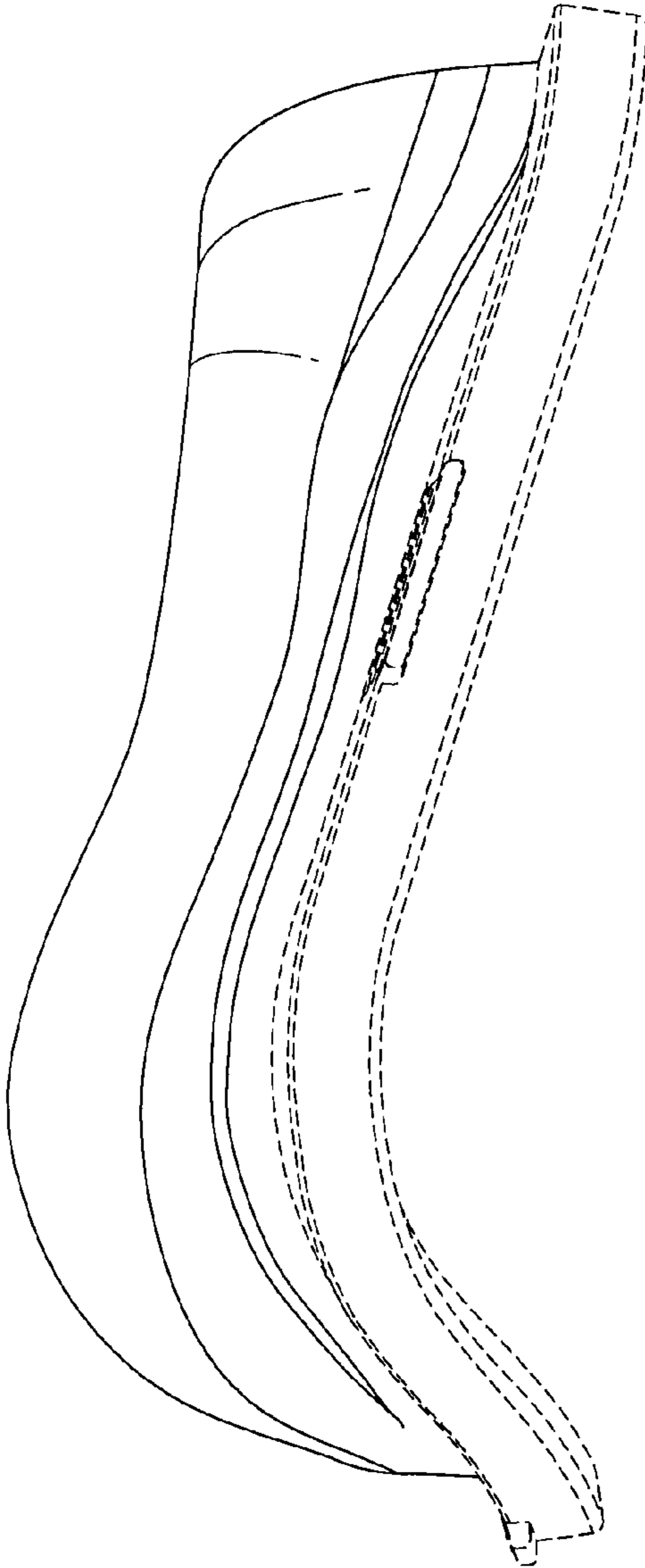

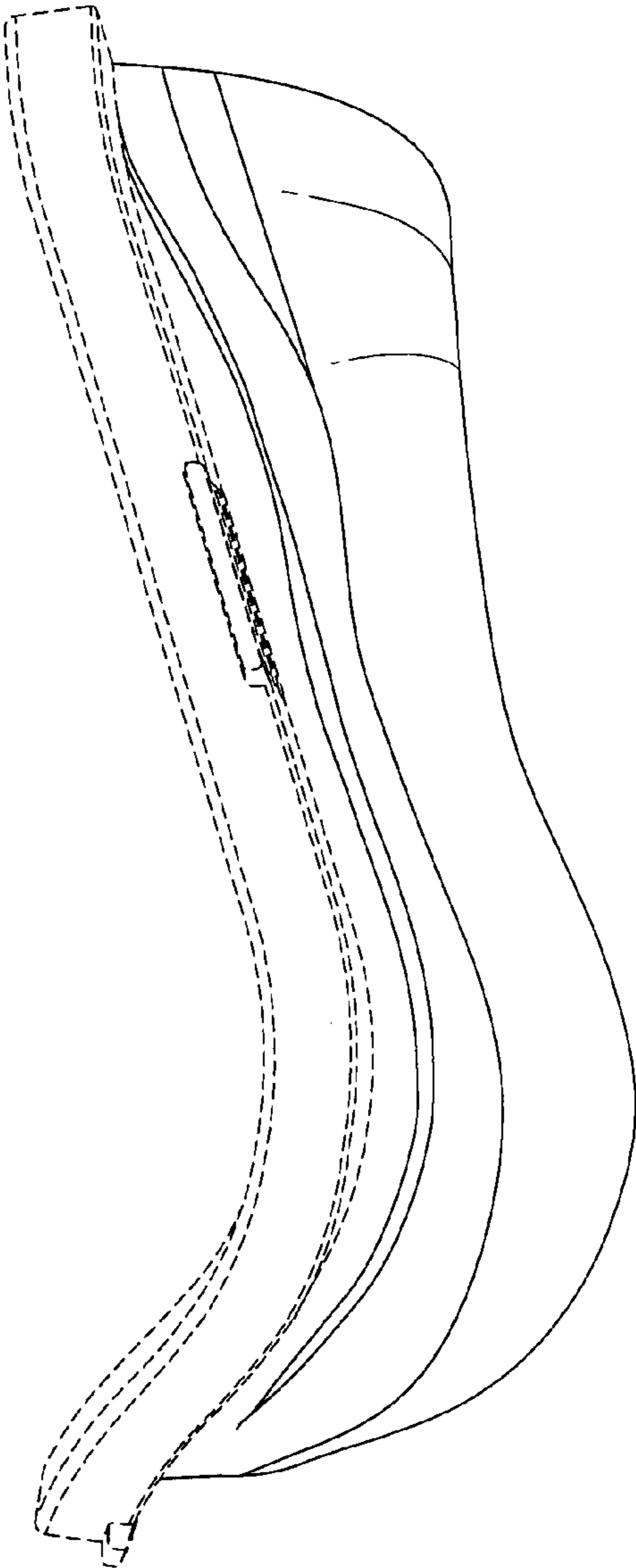

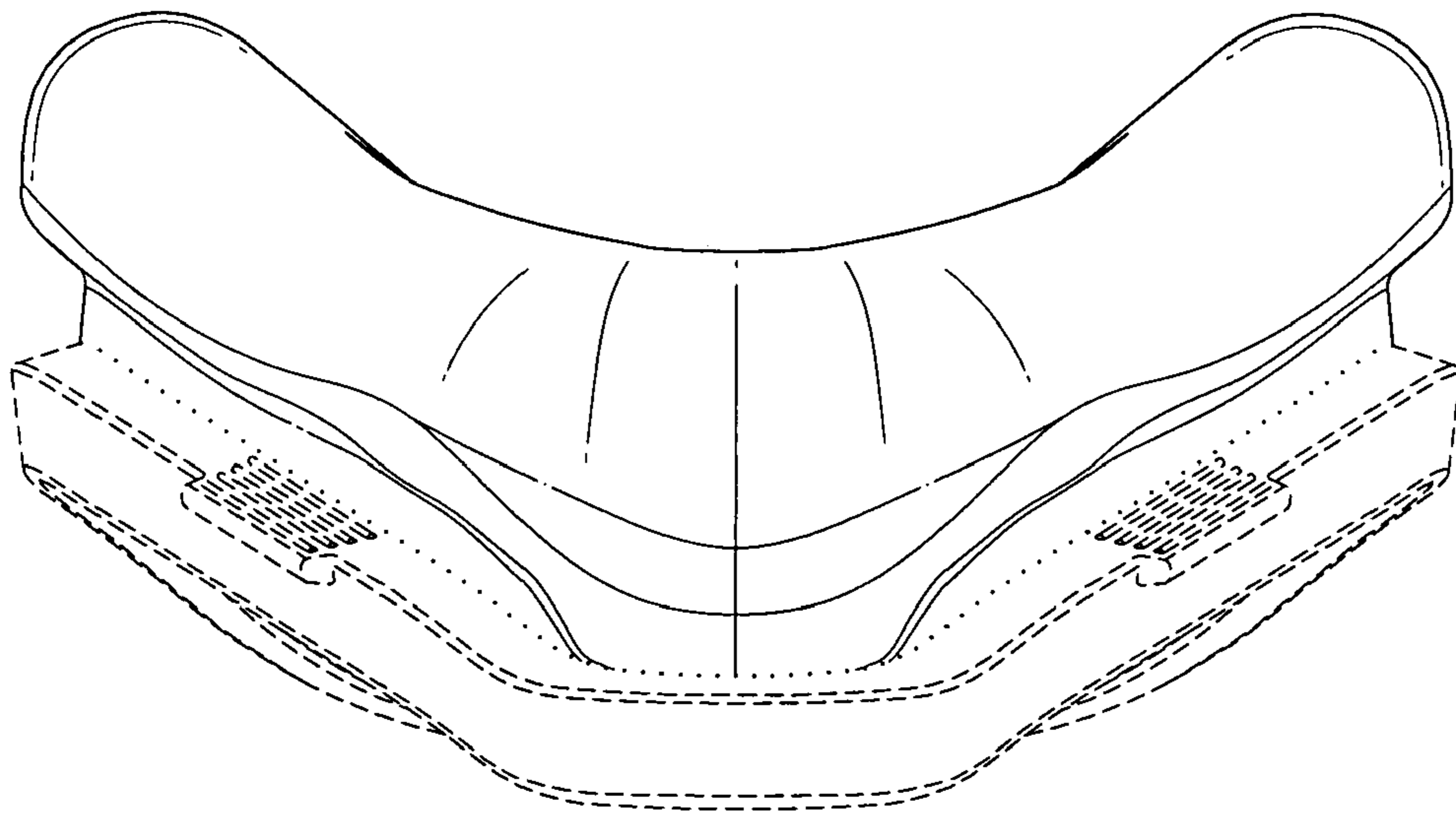

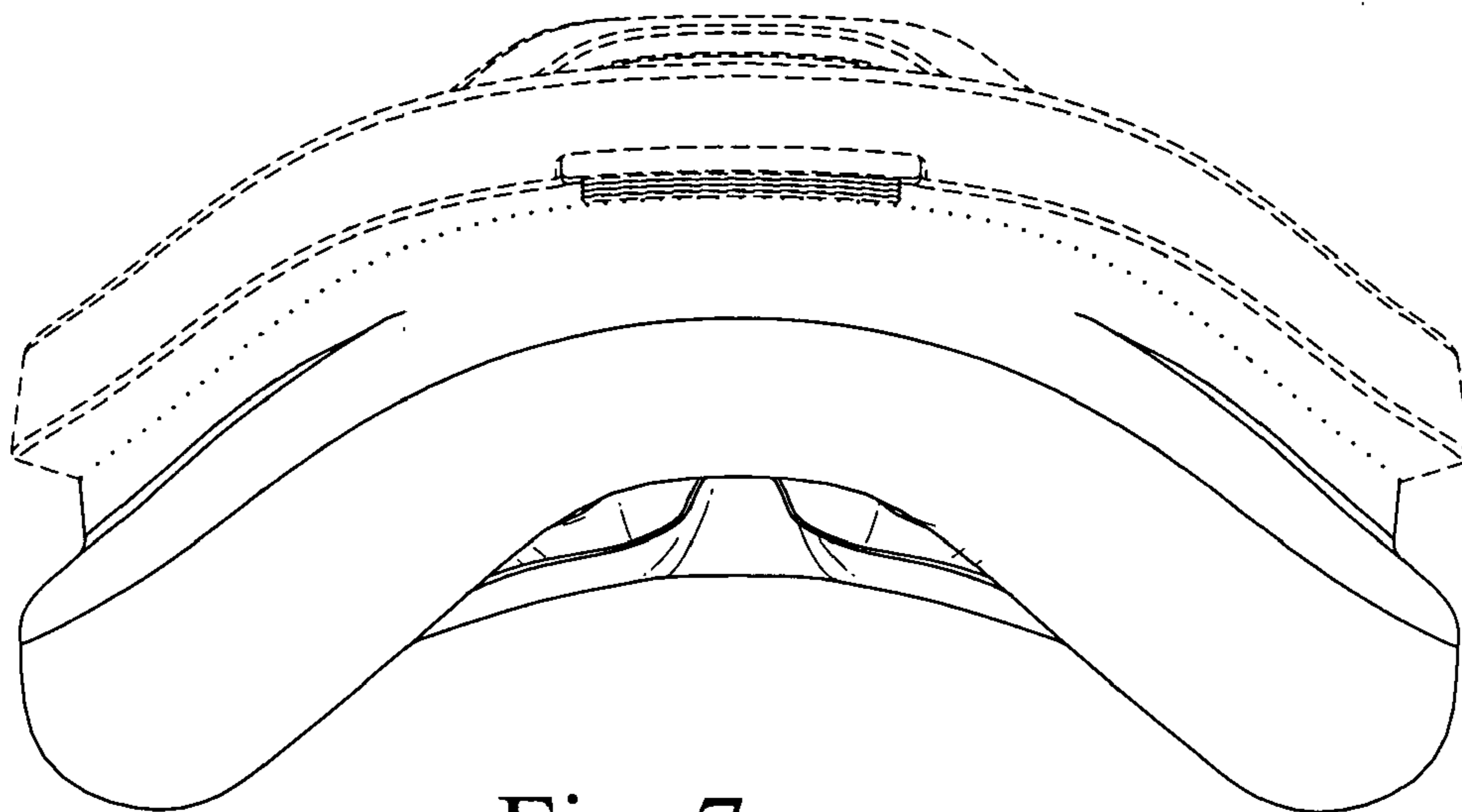

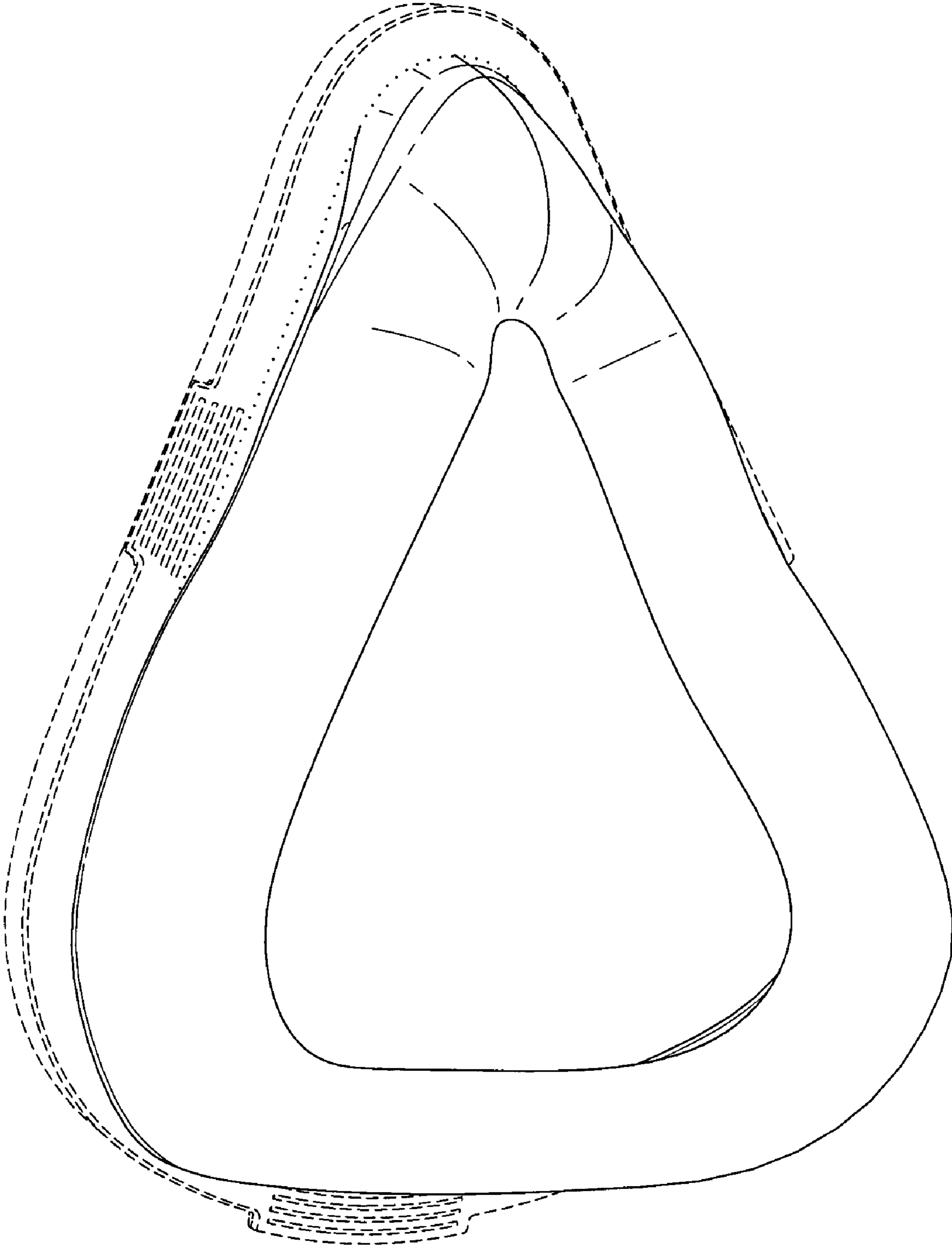
