The ornamental design for a cassette for peritoneal dialysis cyclor, as shown and described.

**DESCRIPTION**

FIG. 3 is a rear elevation view of the cassette of FIG. 1;

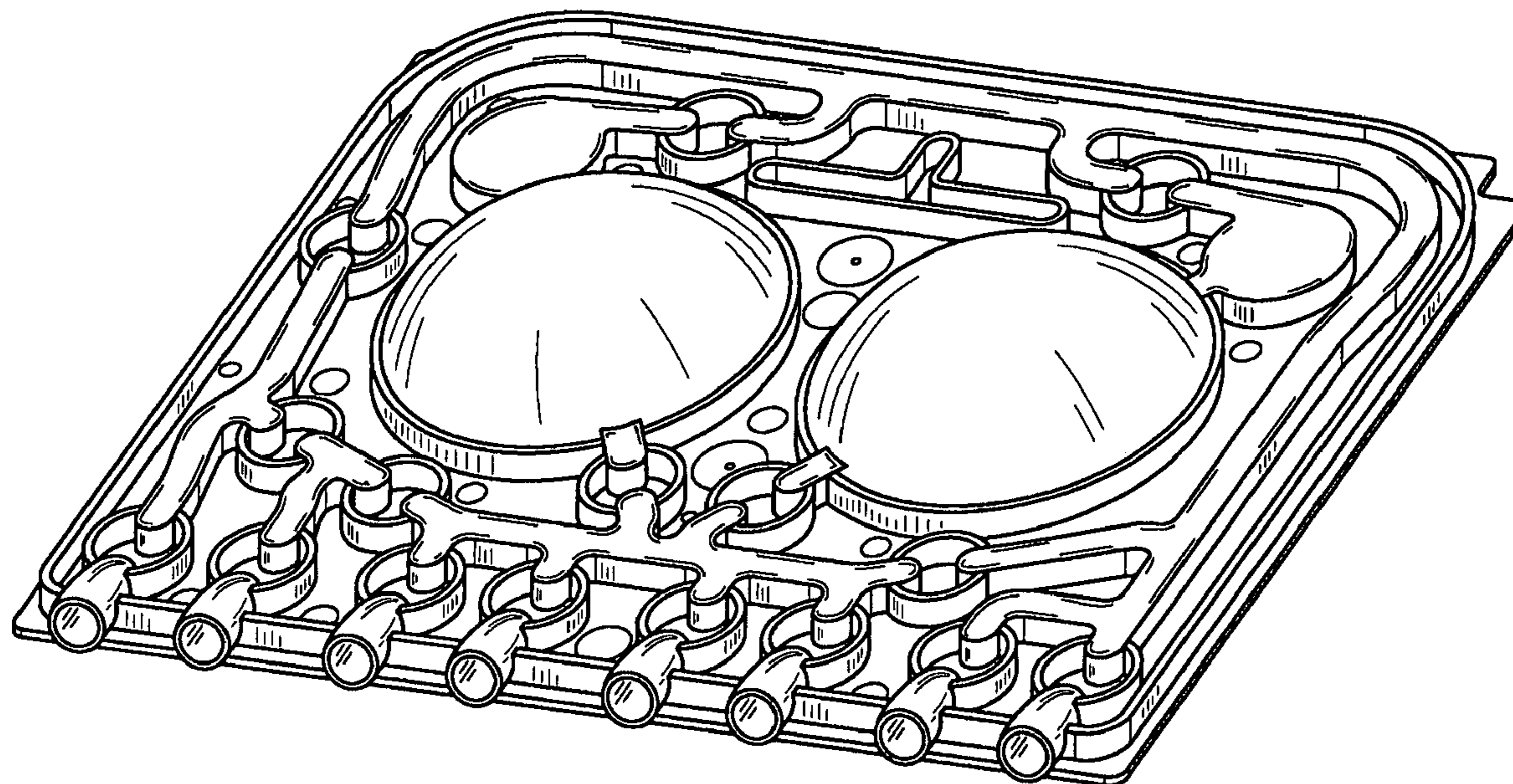
FIG. 4 is a right side view of the cassette of FIG. 1;

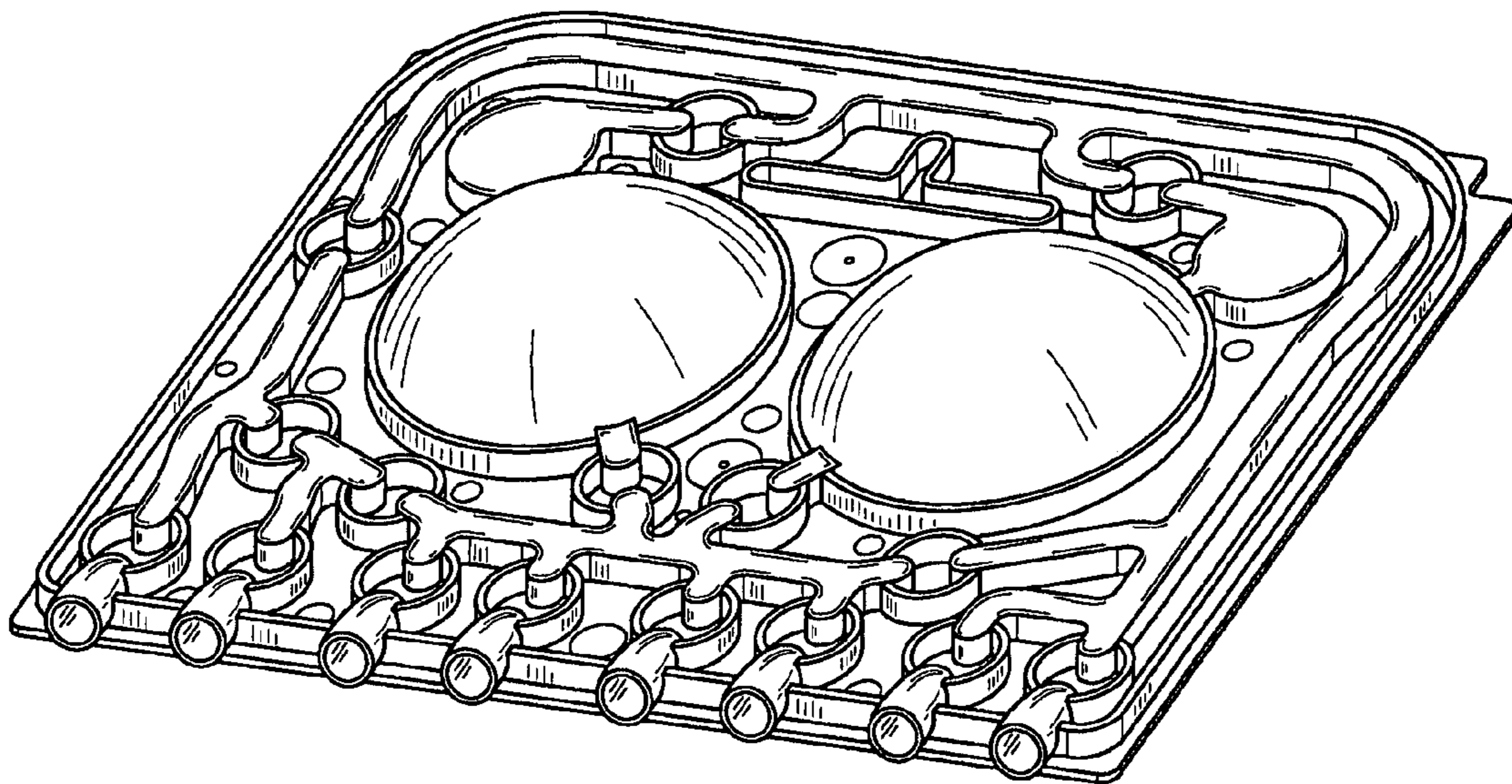

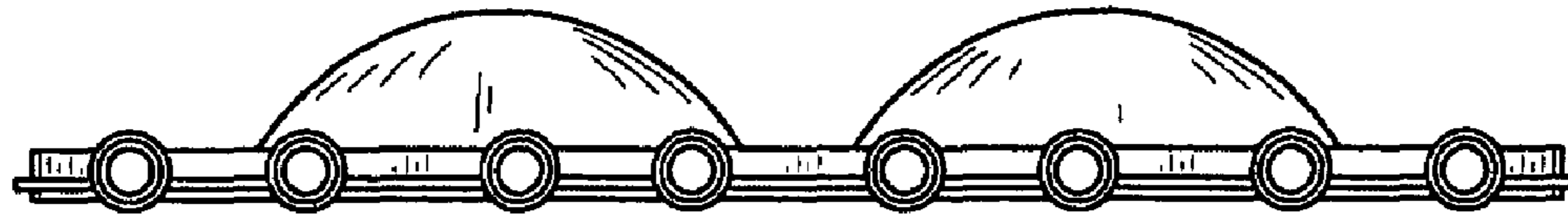

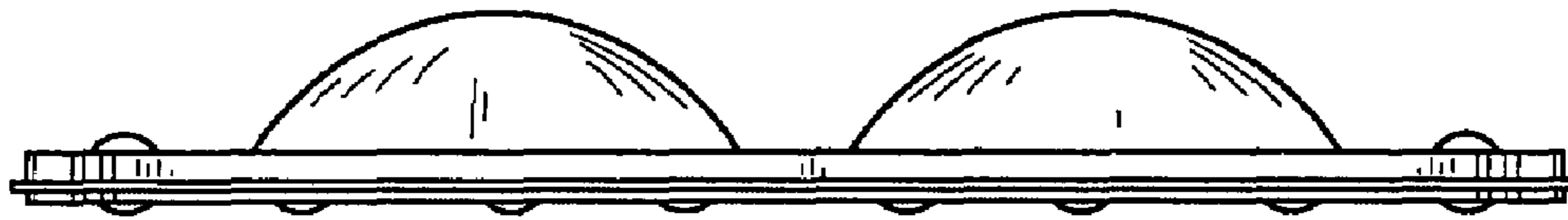

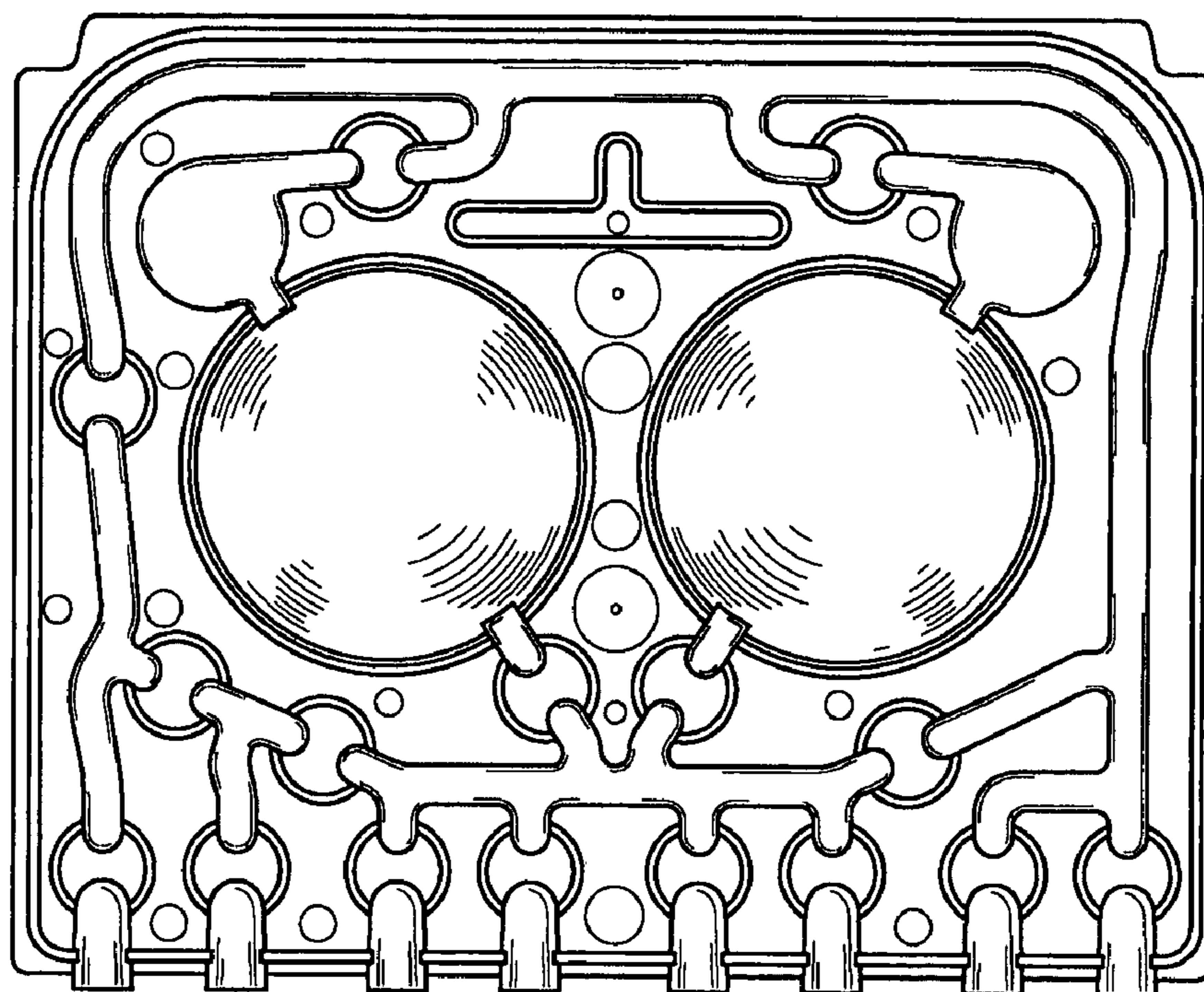

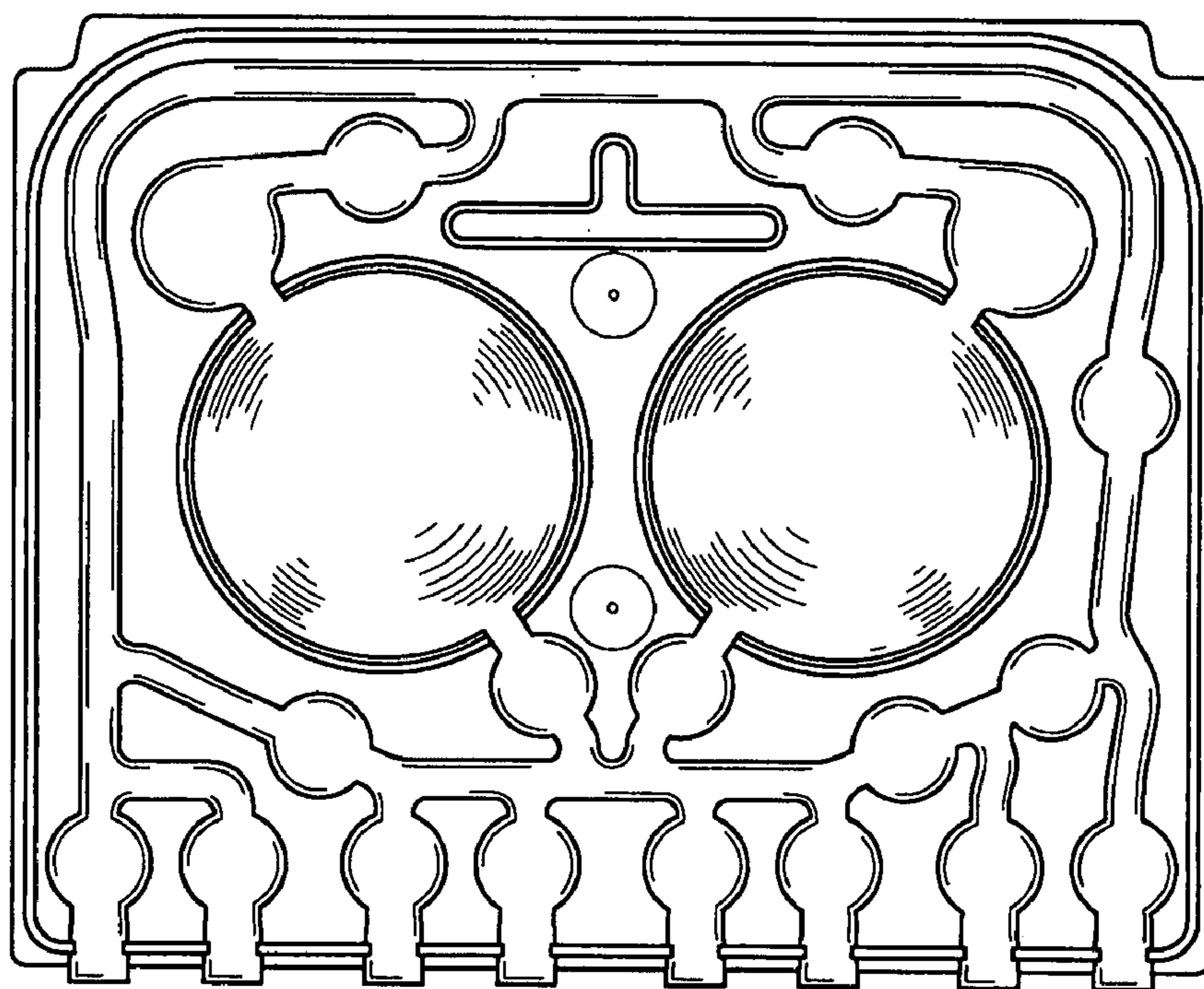
