DESCRIPTION

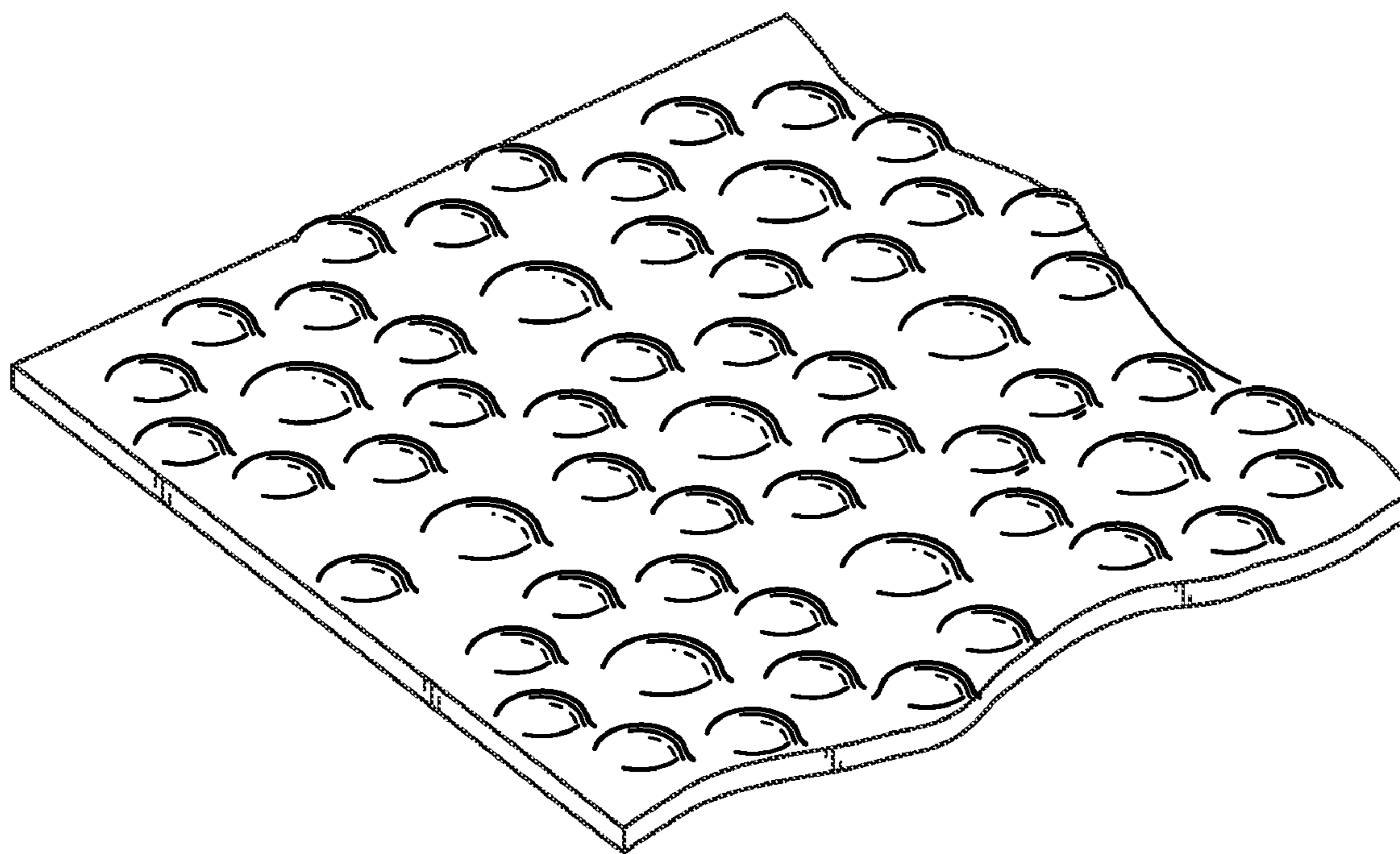
FIG. 1 is a perspective view of a cleaning cloth showing the new design;

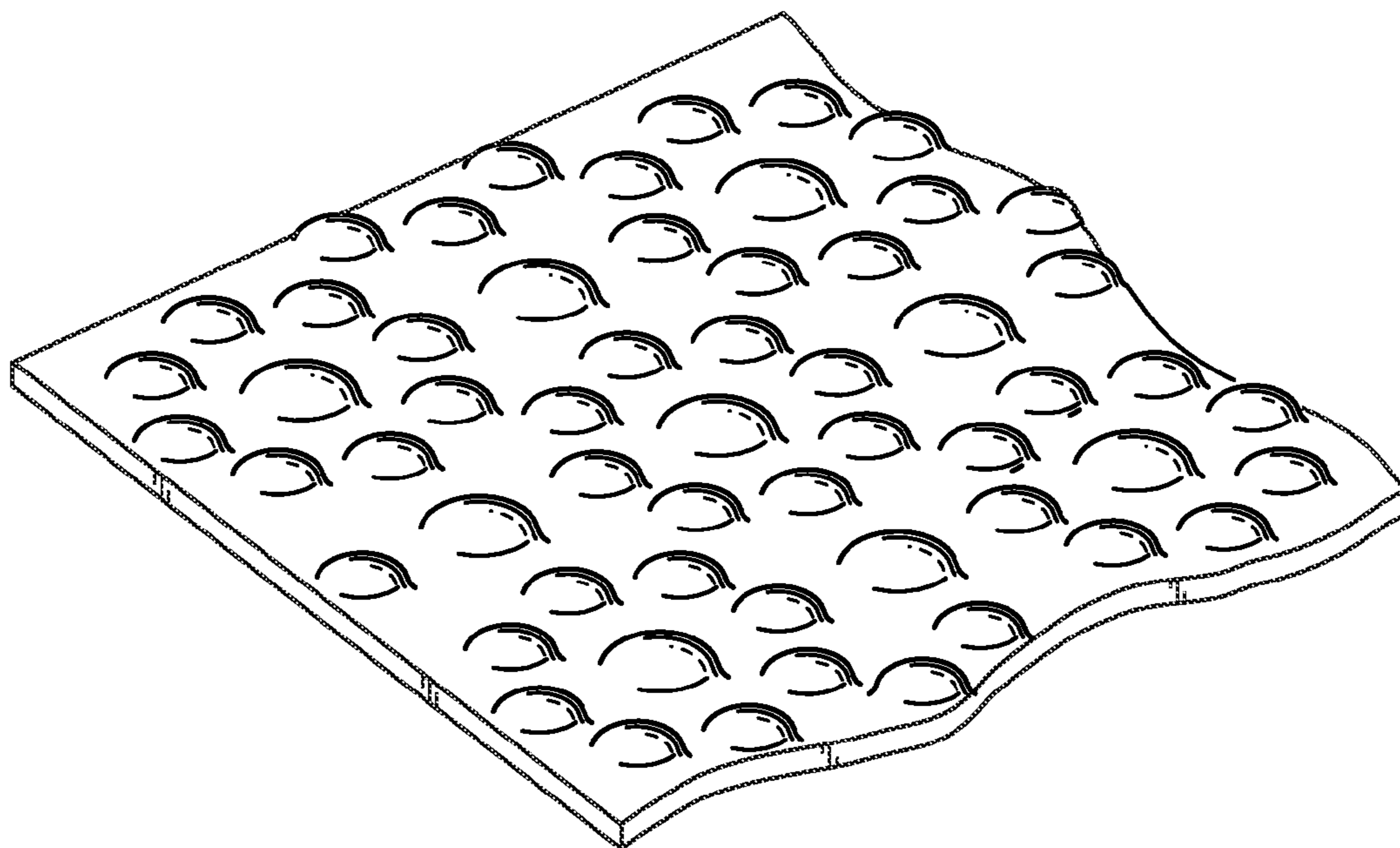

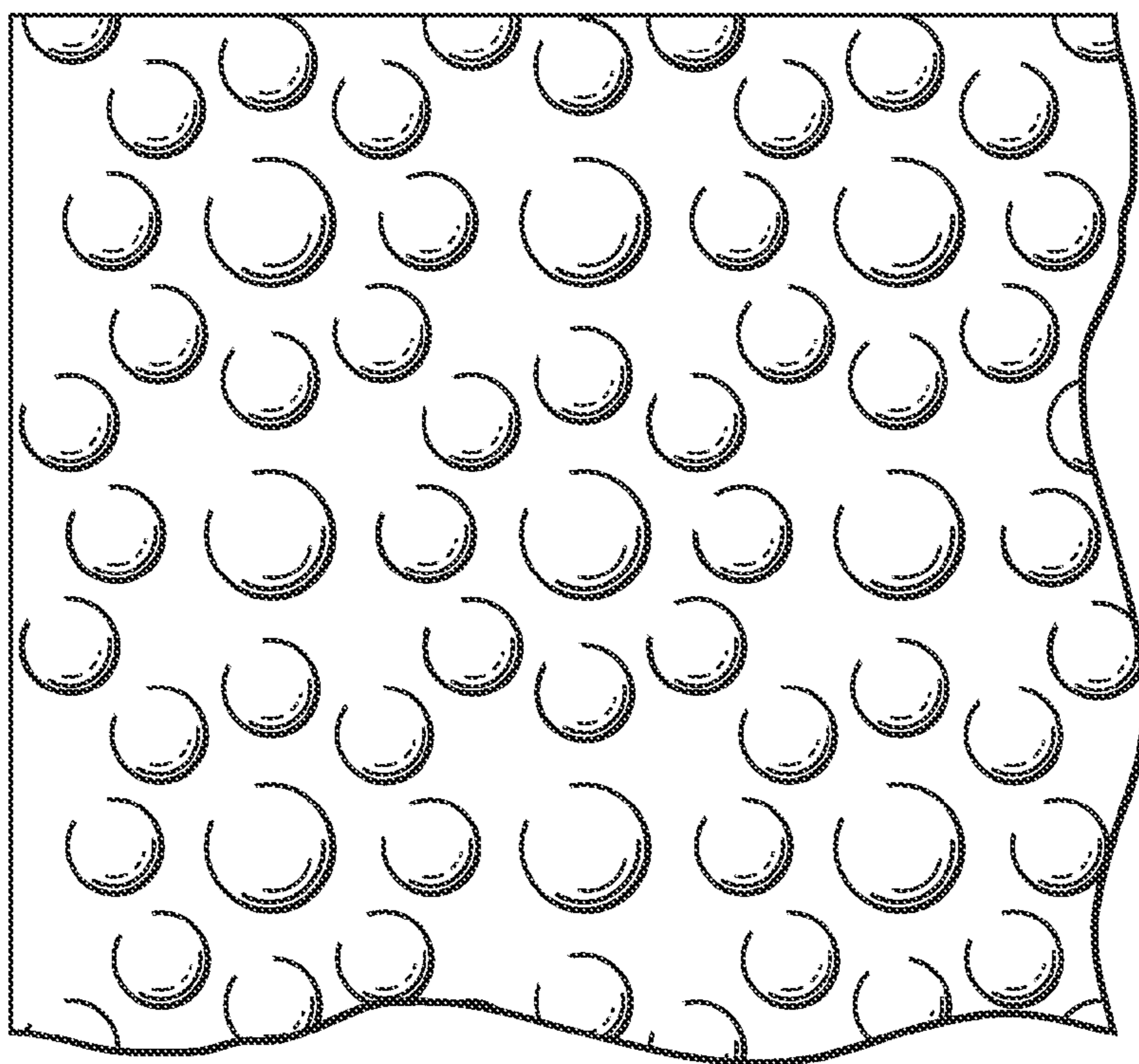

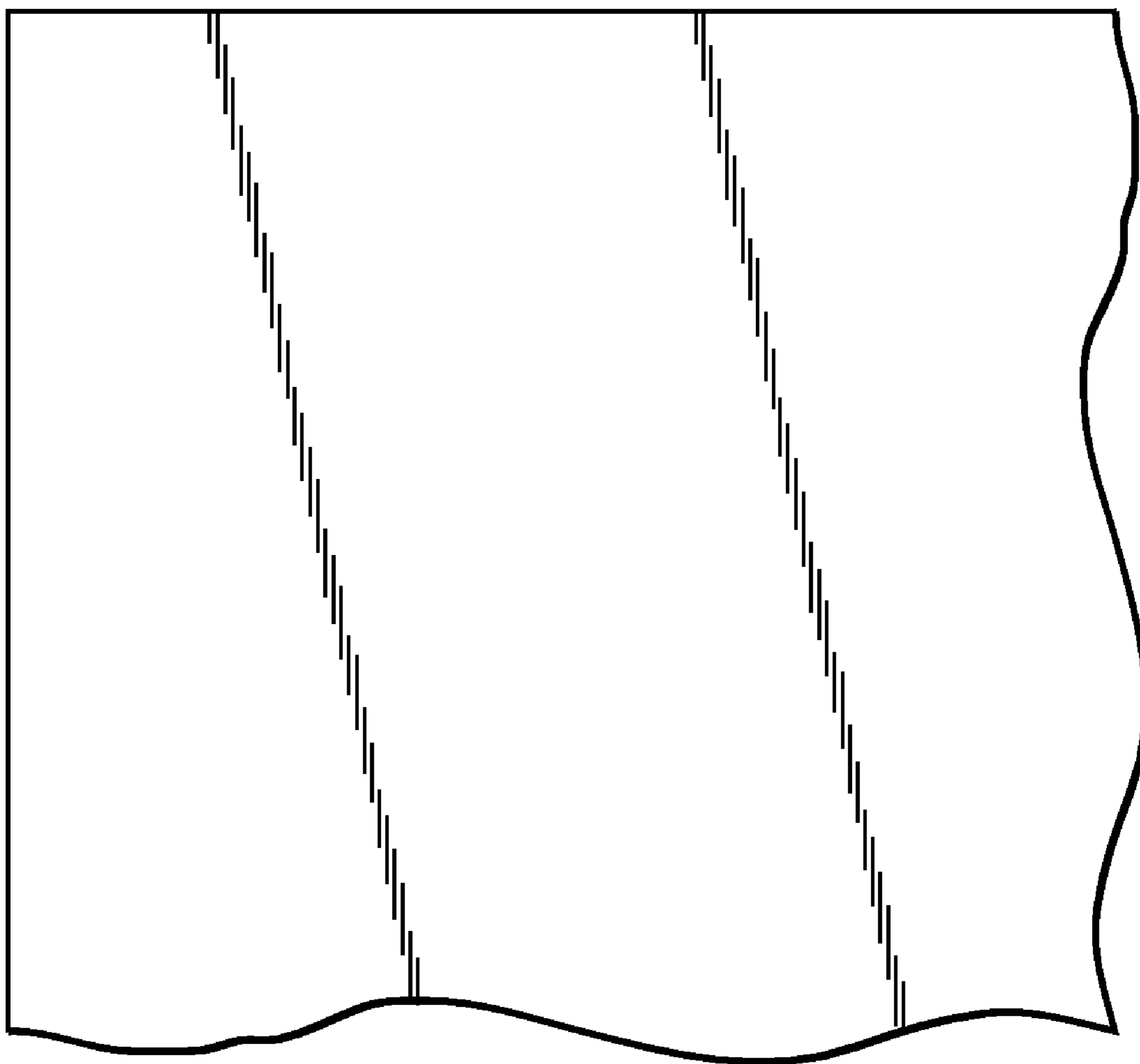
