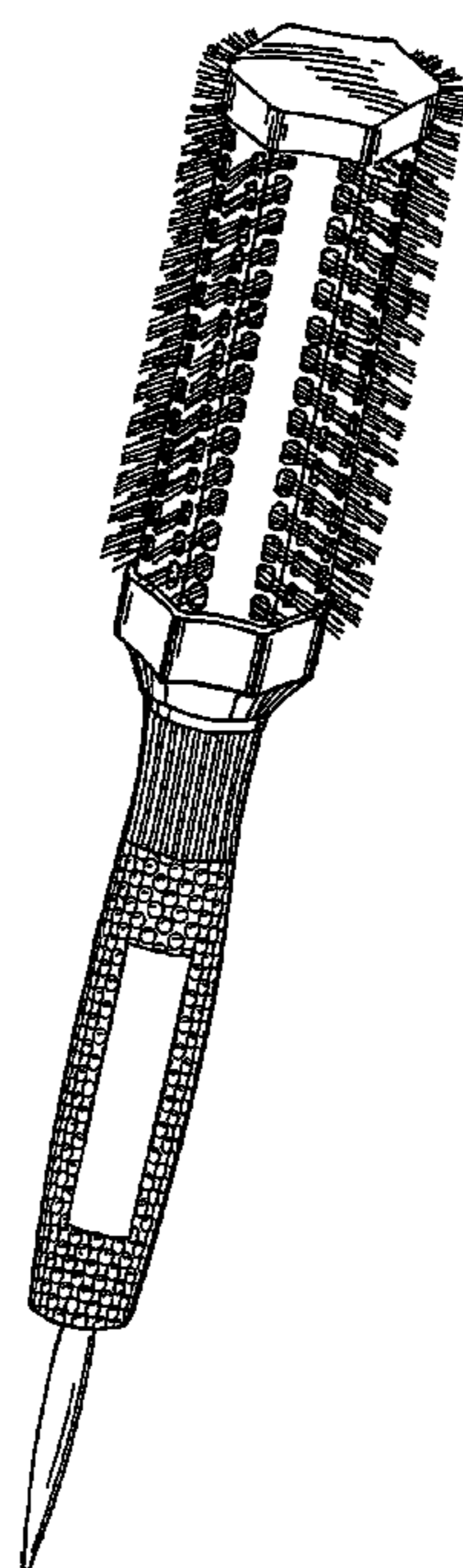
(57) **CLAIM**

The ornamental design for a hair brush, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a hair brush showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view, the right side being symmetrical thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

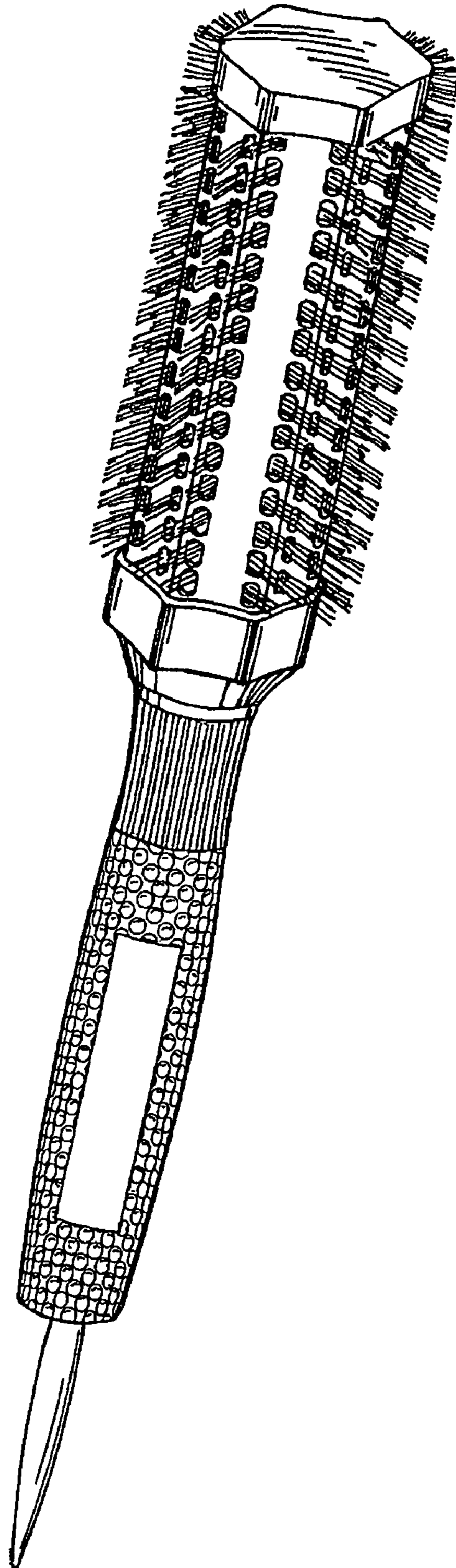

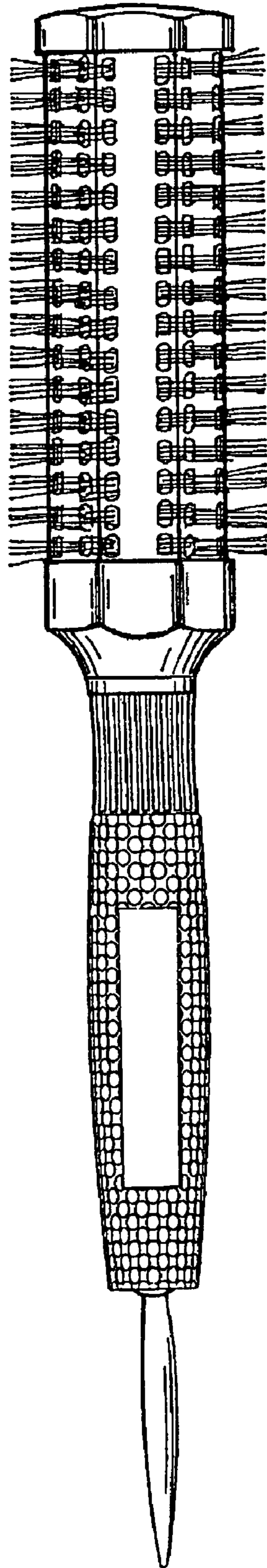

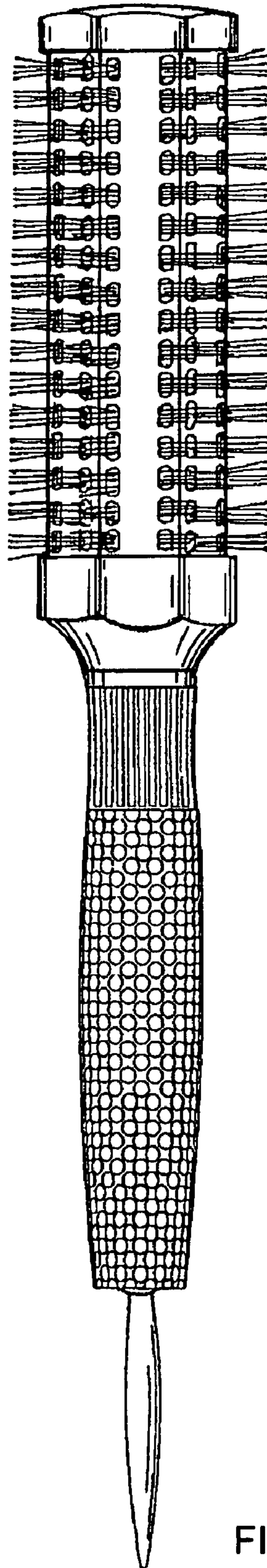

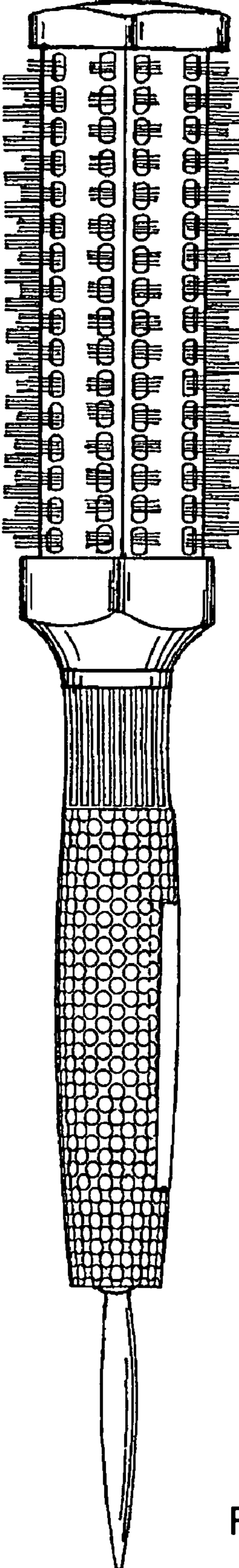

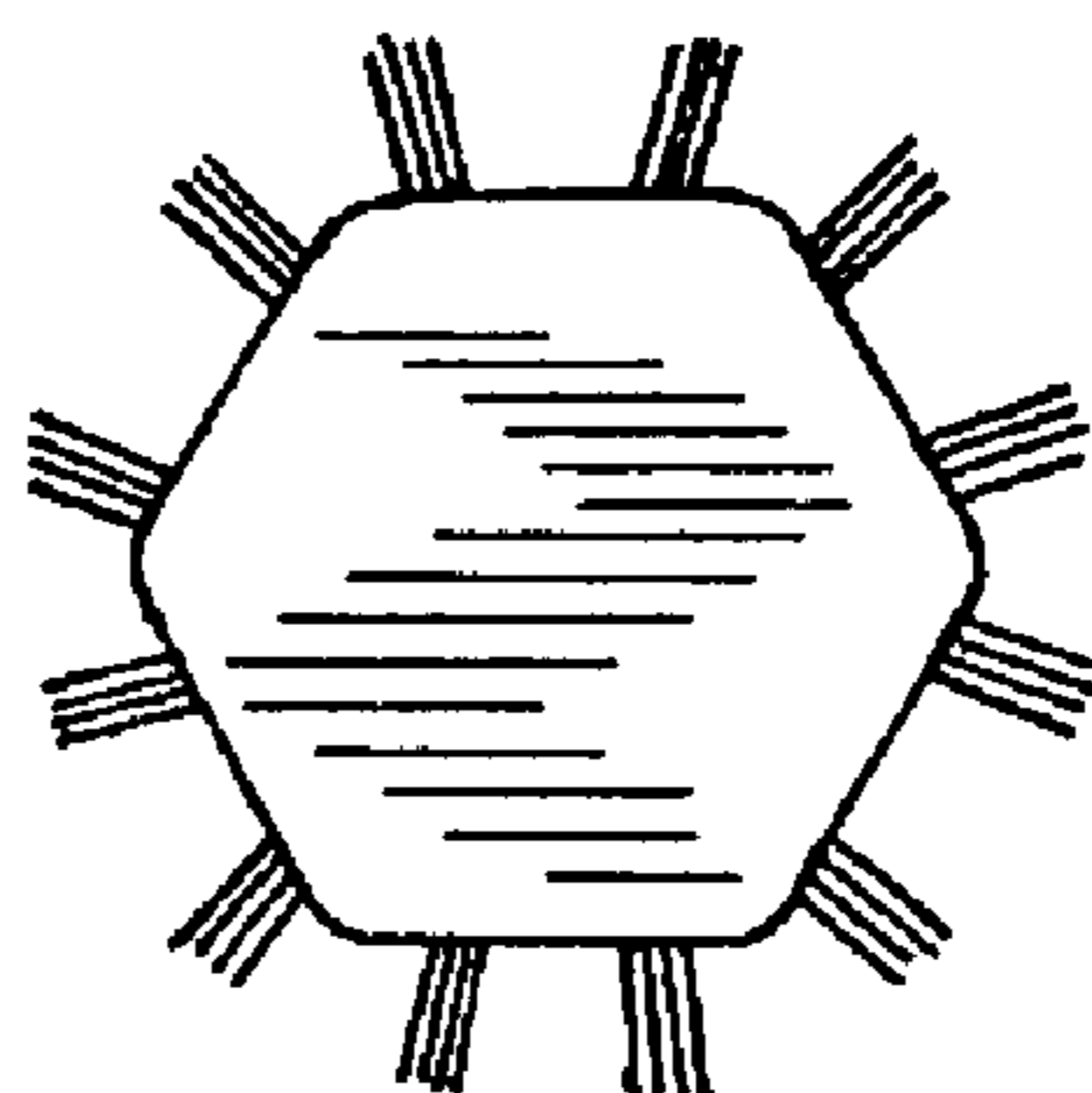

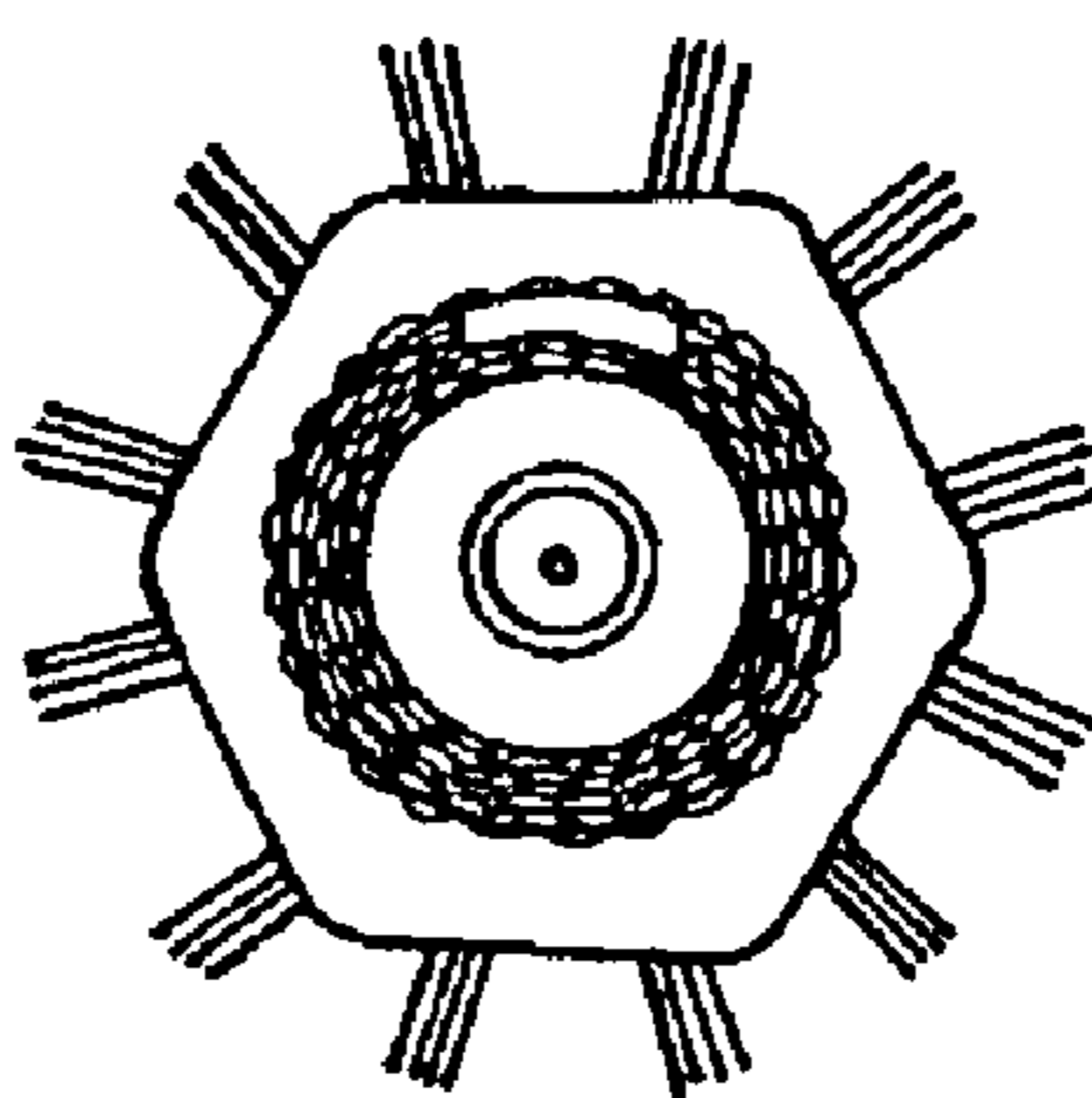
