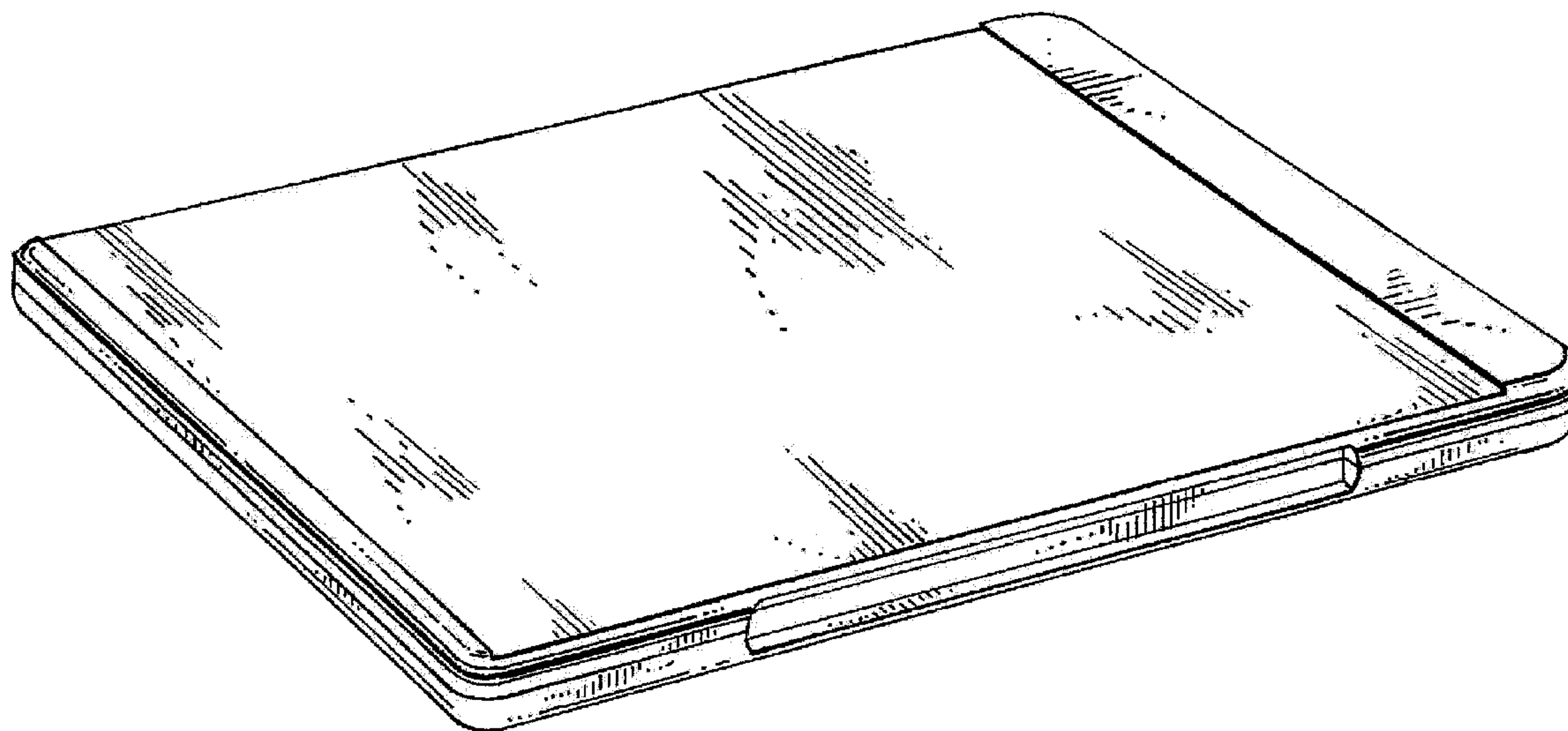
FIG. 6 is an interior perspective view of the disc package of FIG. 5.

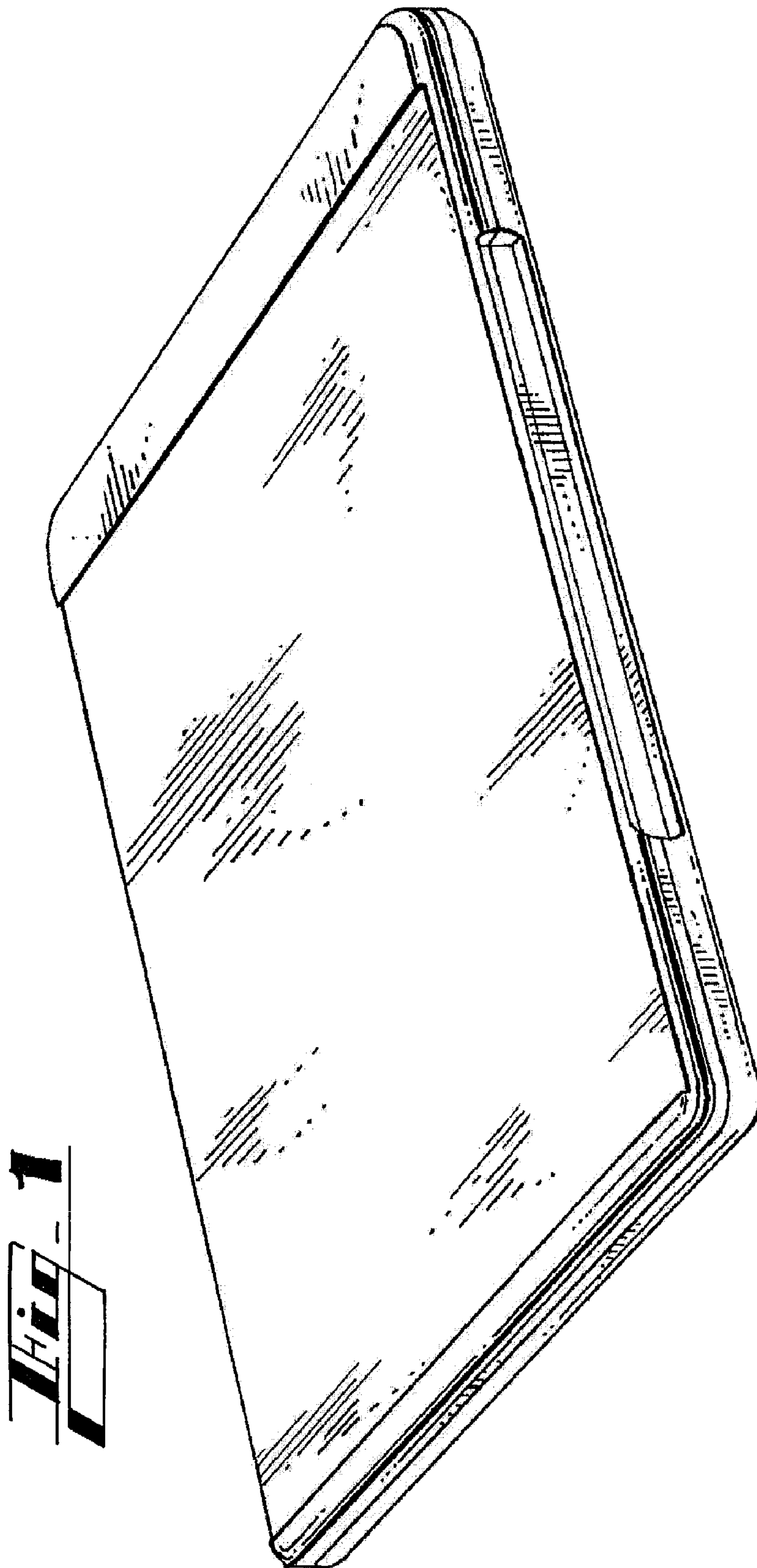
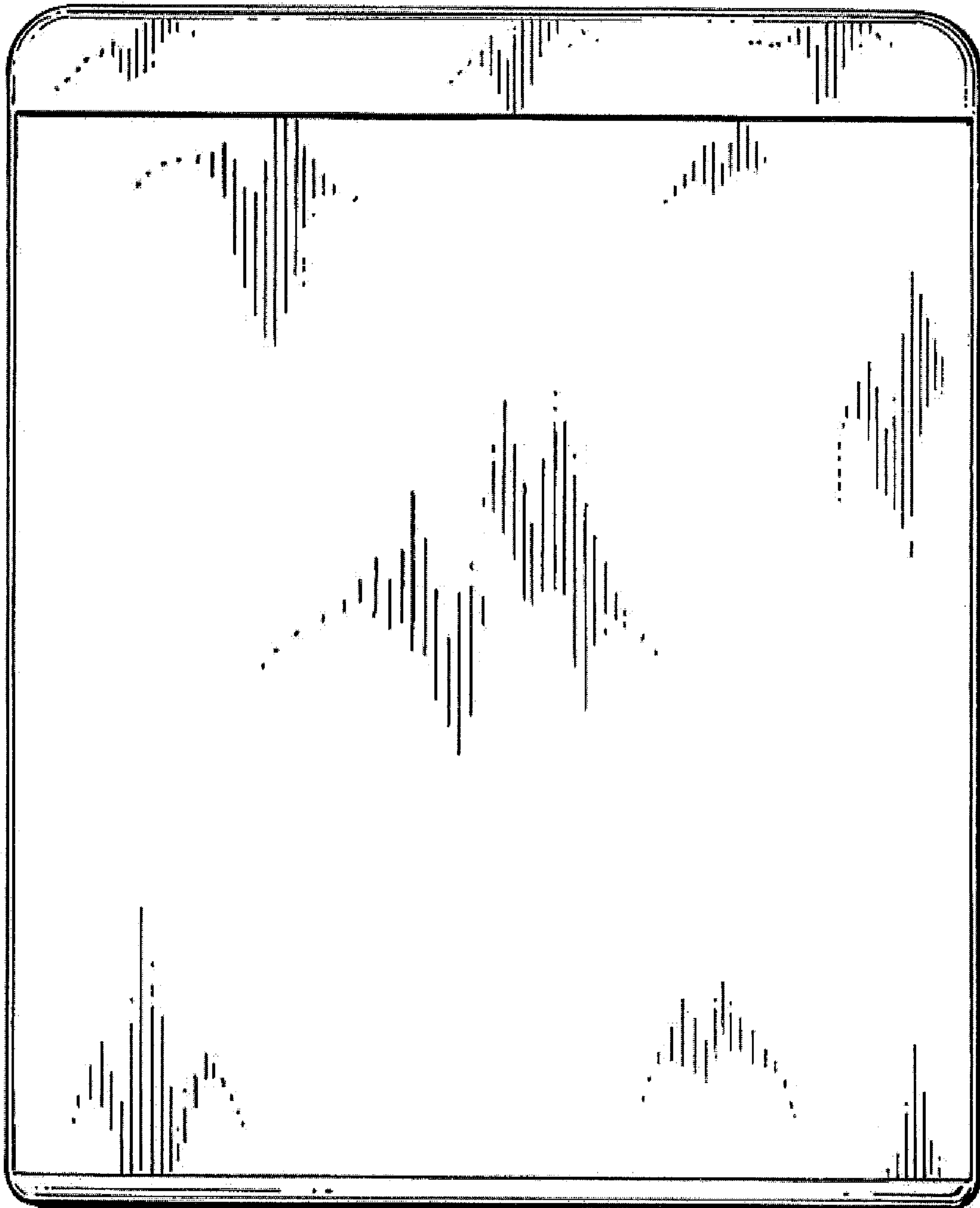

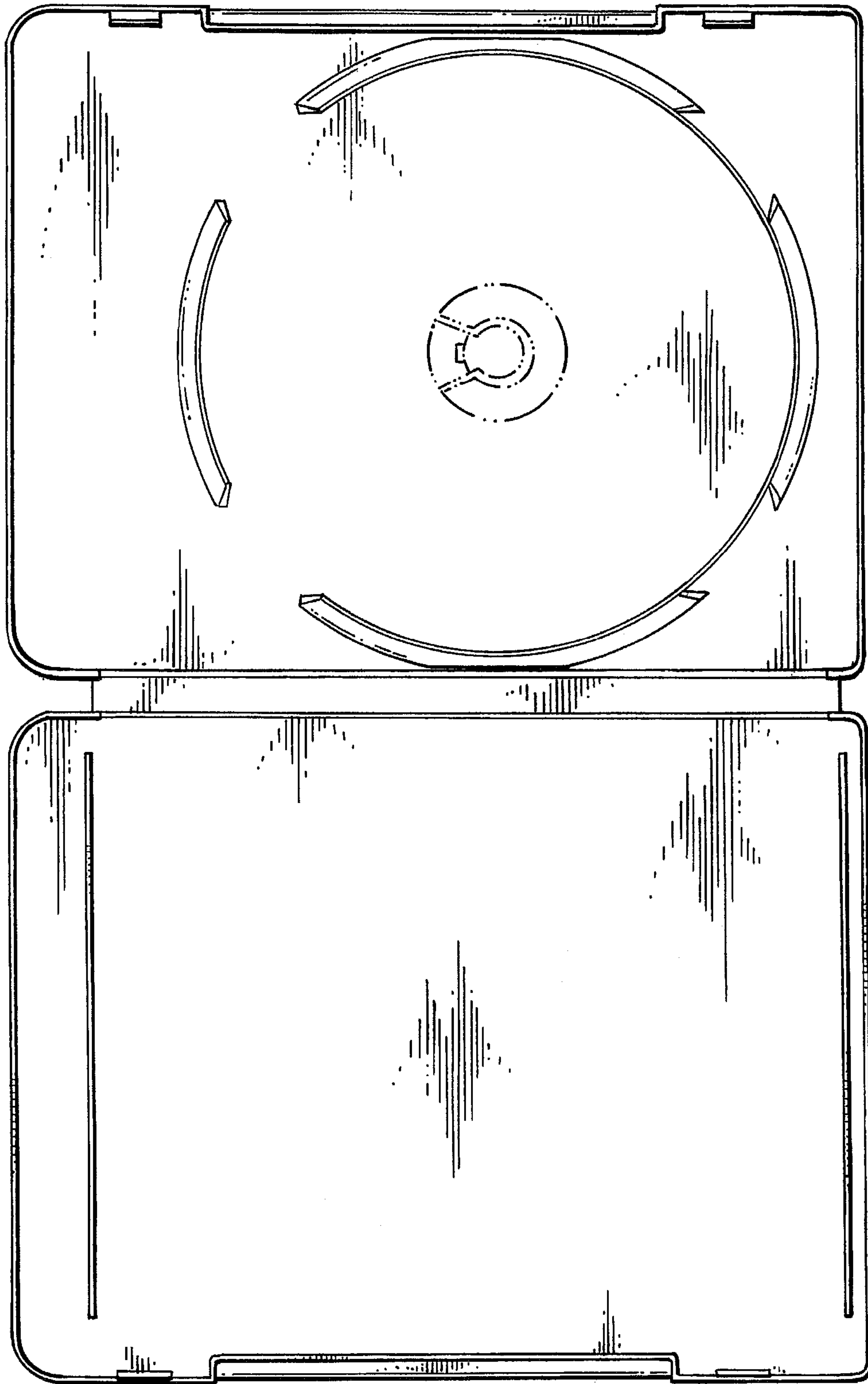

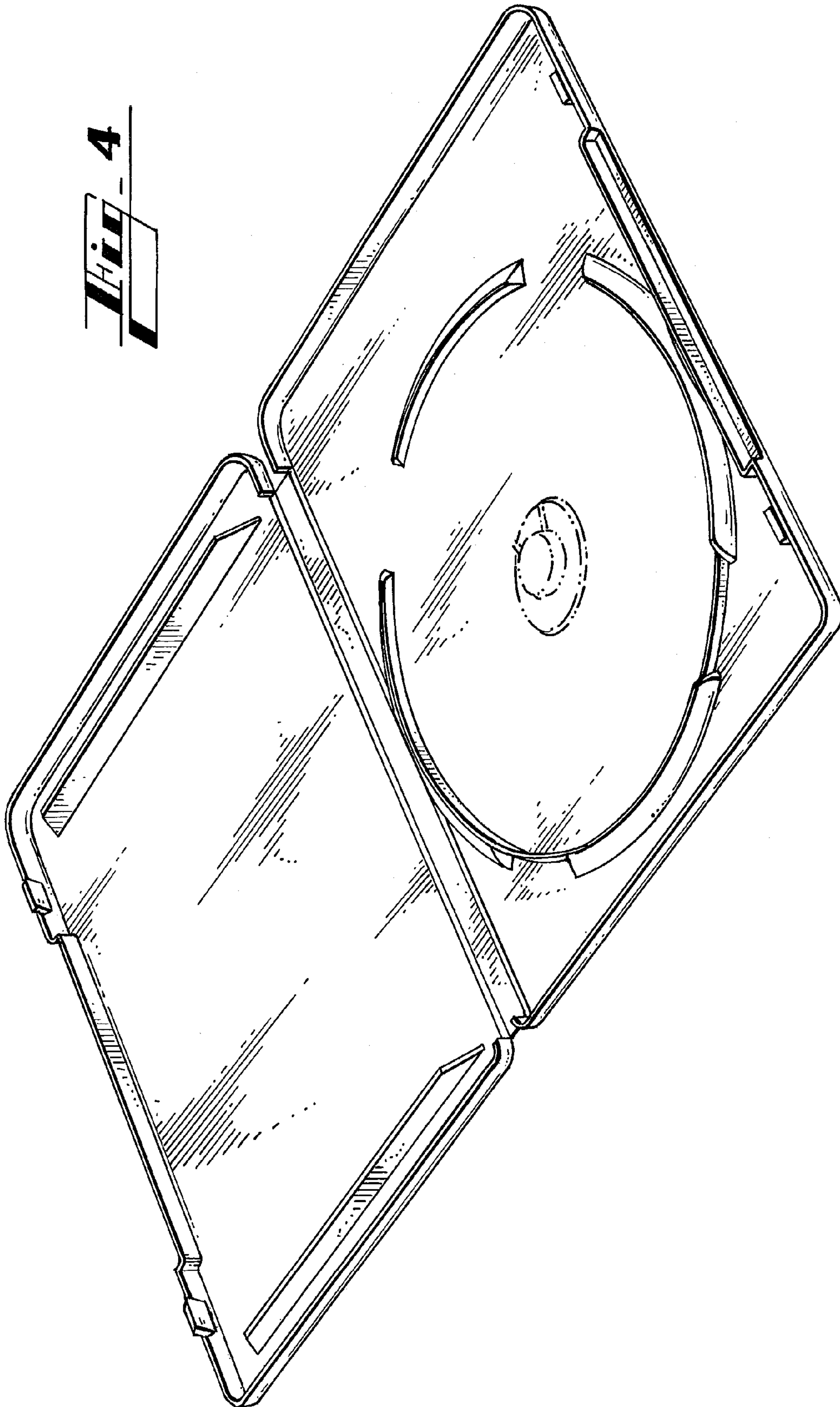

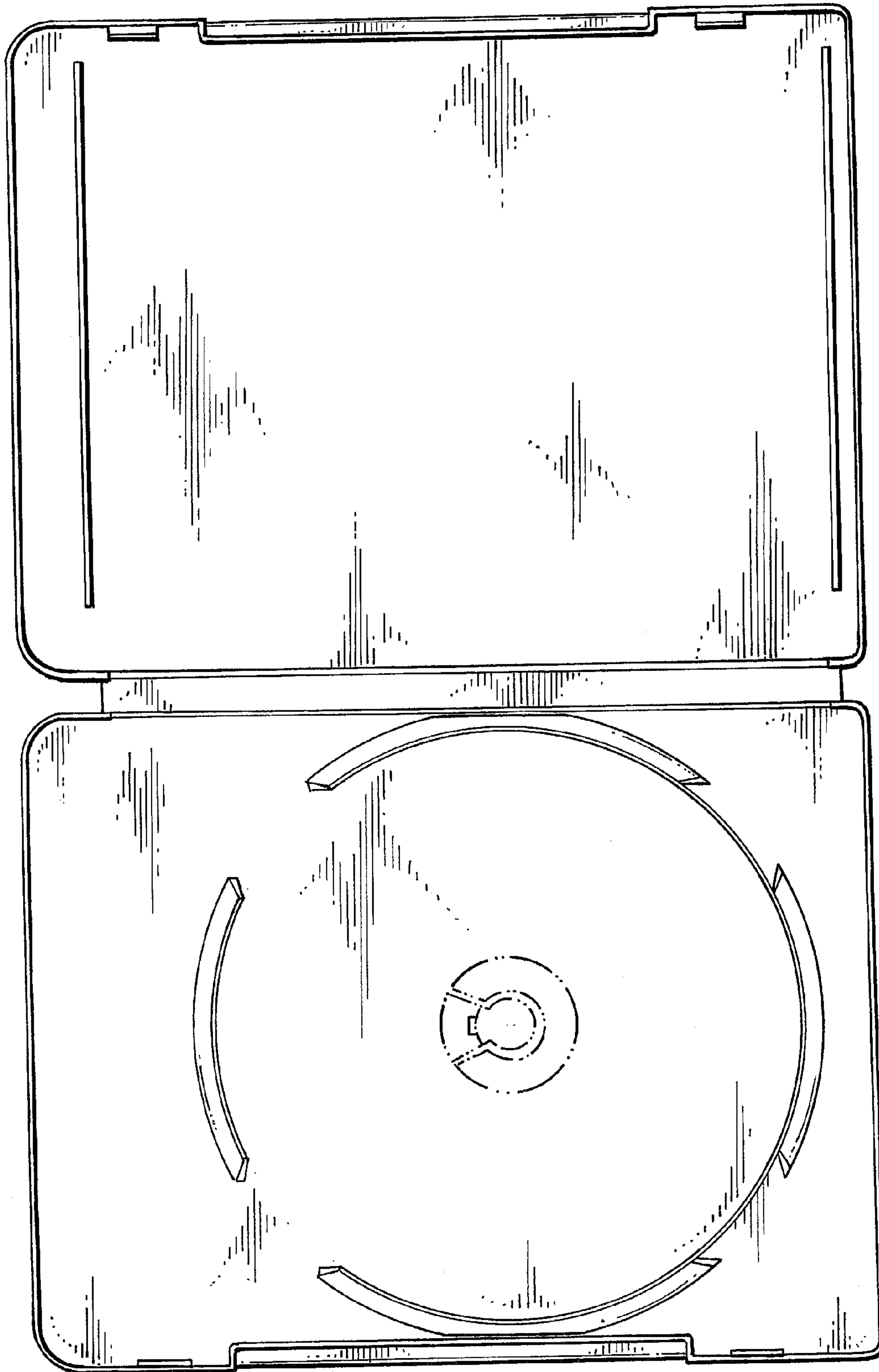
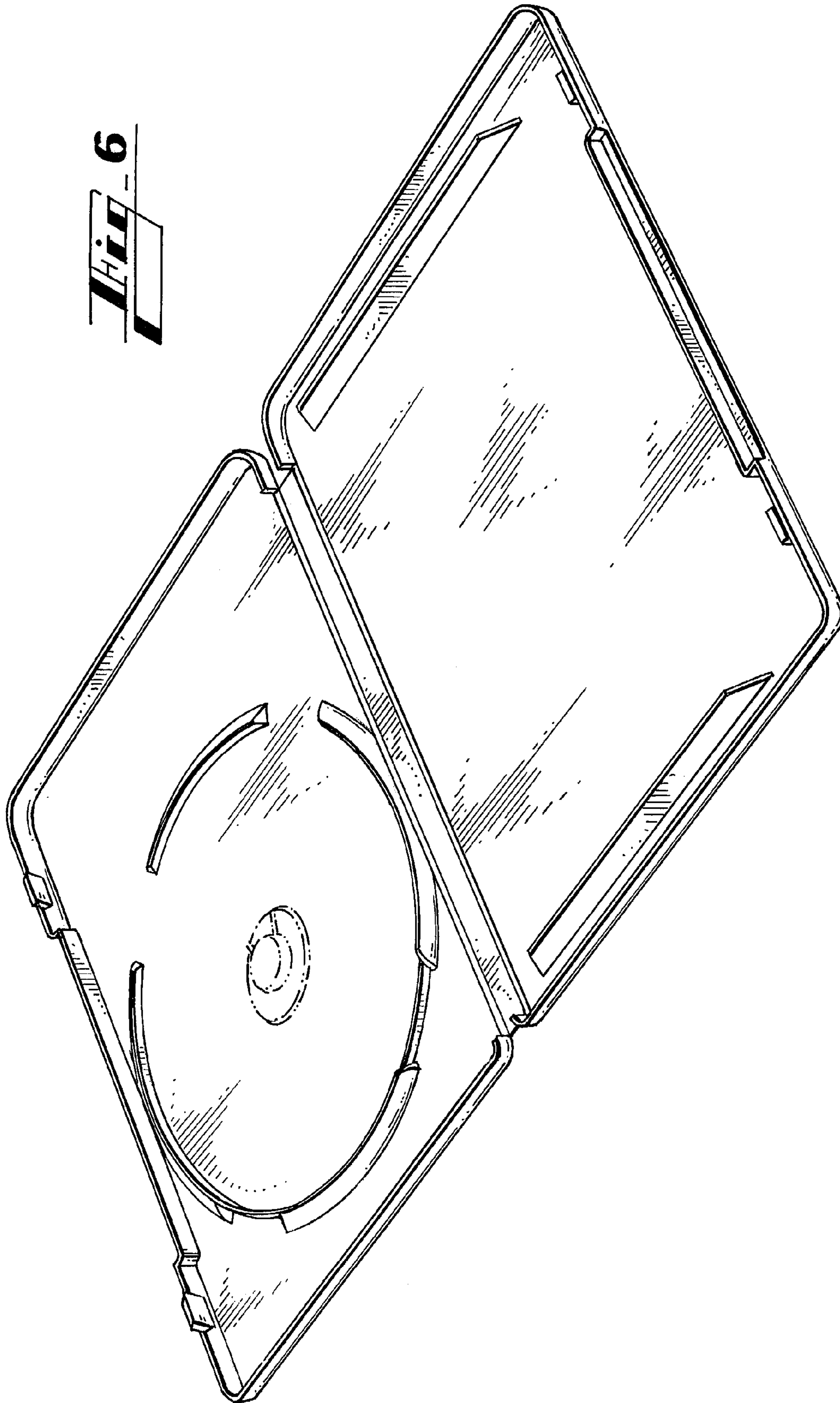

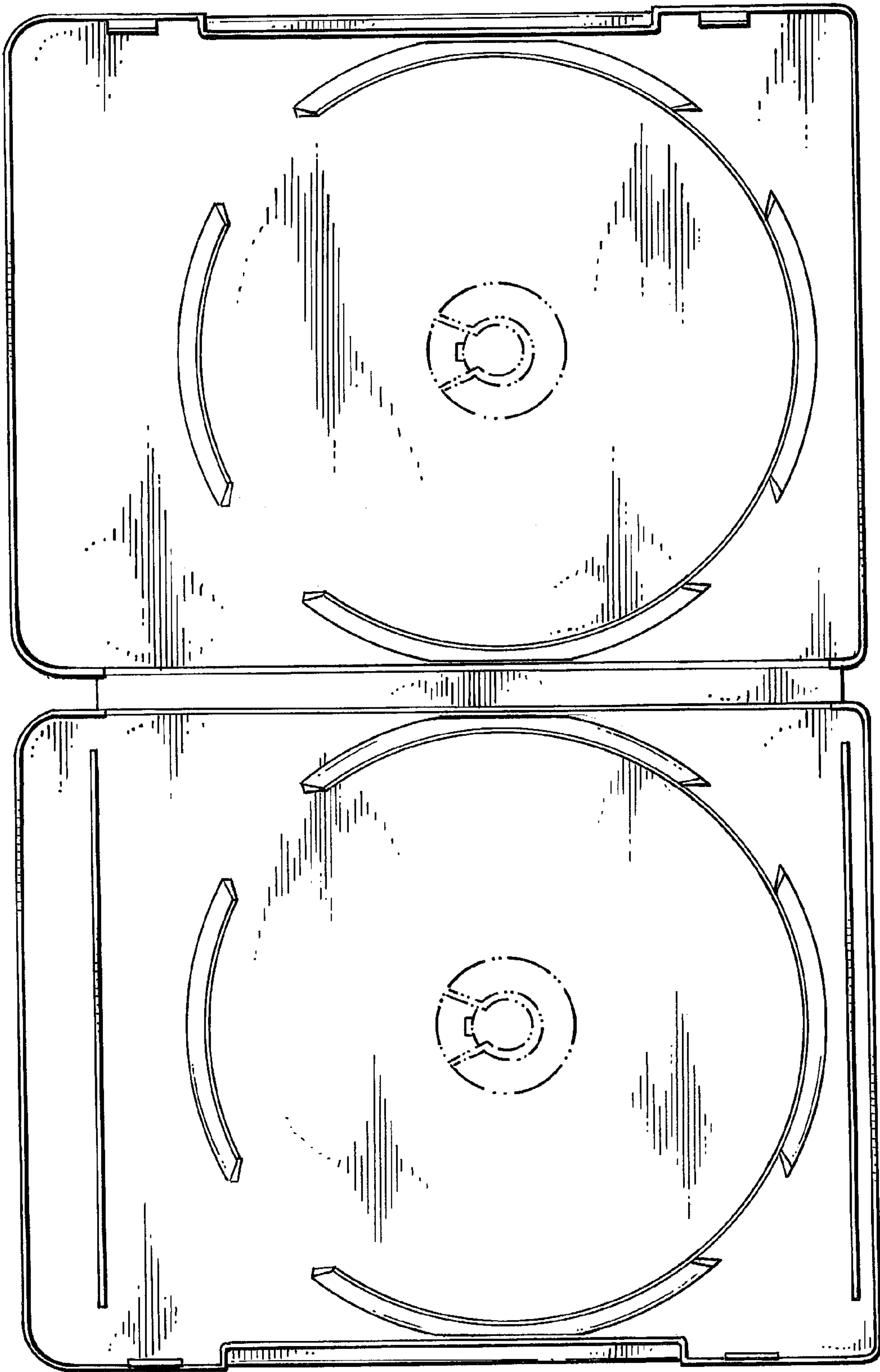

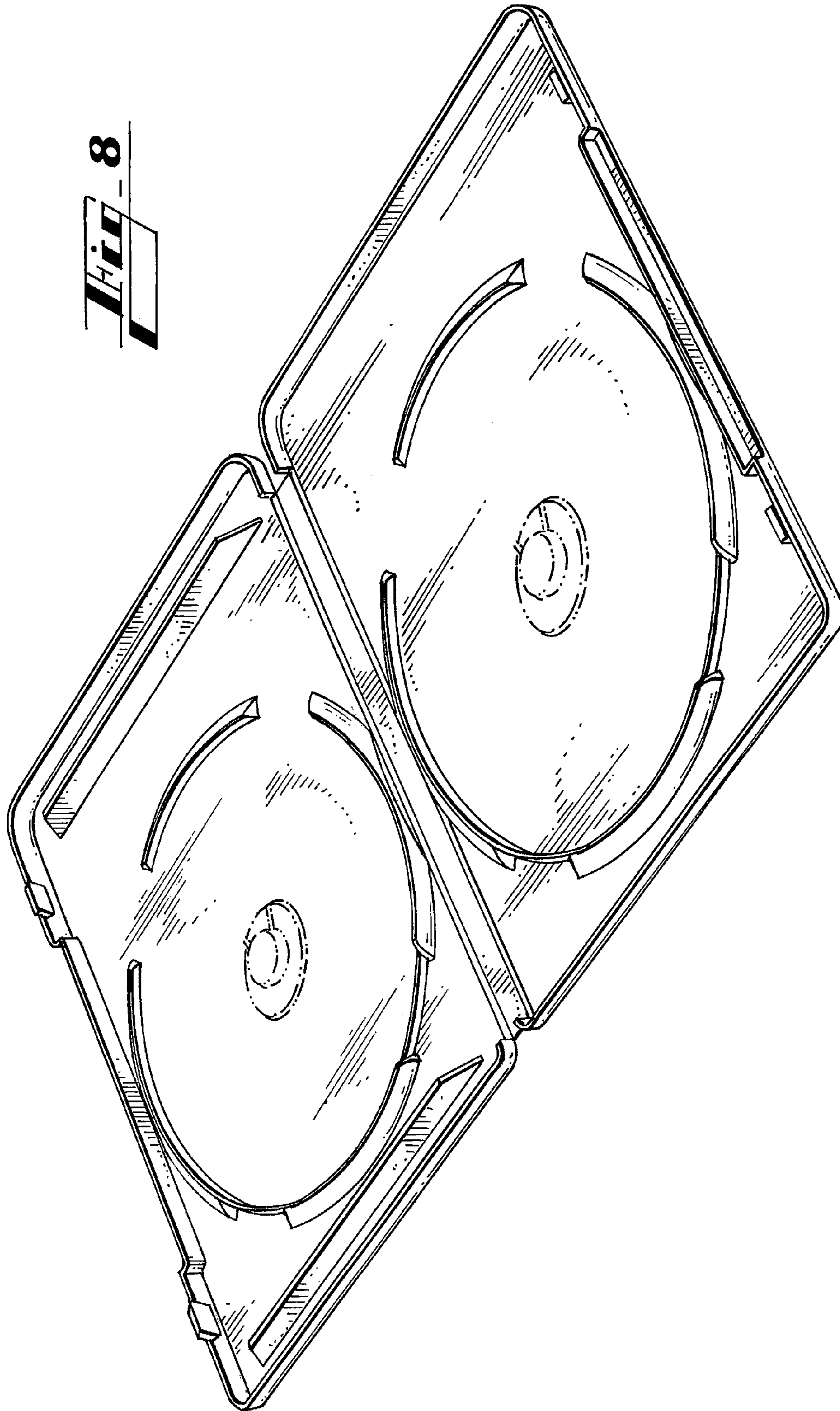
