(57) **CLAIM**

We claim the ornamental design for the knife, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a knife showing the present design;

FIG. 2 is a right elevational view of the knife of FIG. 1, wherein the left side elevational view is a mirror image thereof;

FIG. 3 is a top plan view of the knife of FIG. 1;

FIG. 4 is a bottom plan view of the knife of FIG. 1;

FIG. 5 is an enlarged front elevational view of the knife of FIG. 1; and,

FIG. 6 is an enlarged rear elevational view of the knife of FIG. 1.

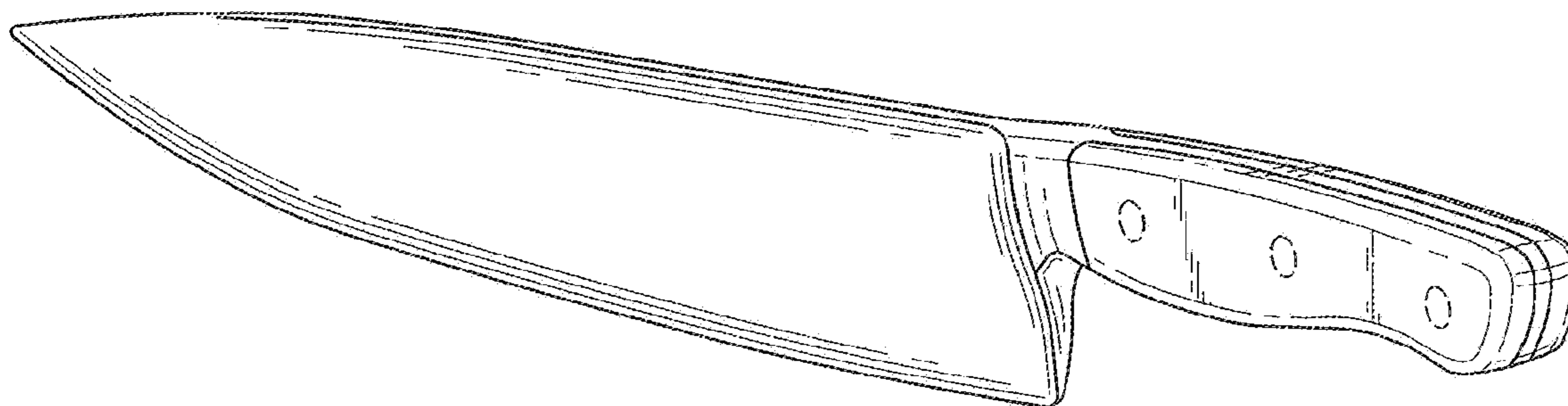

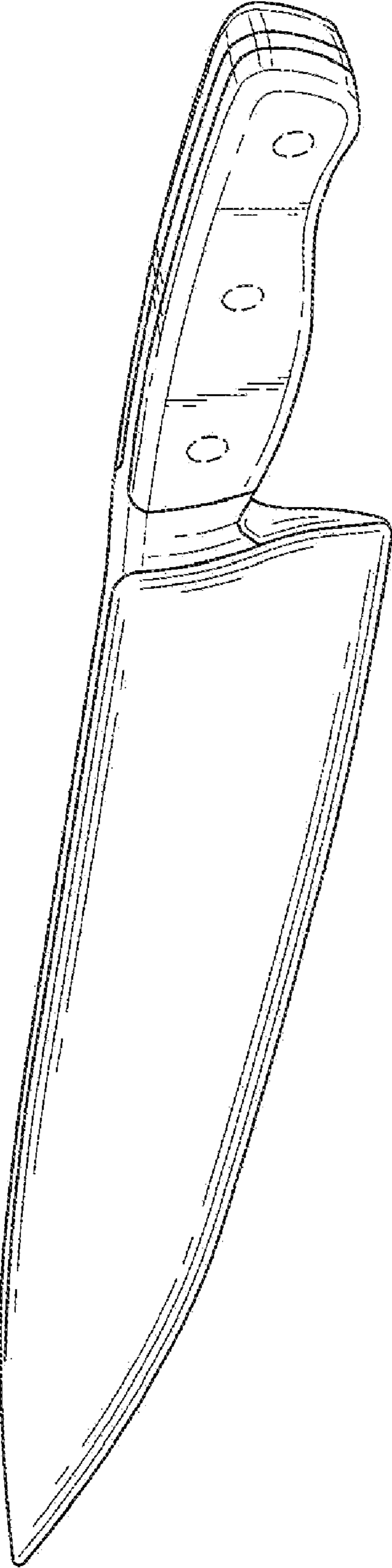

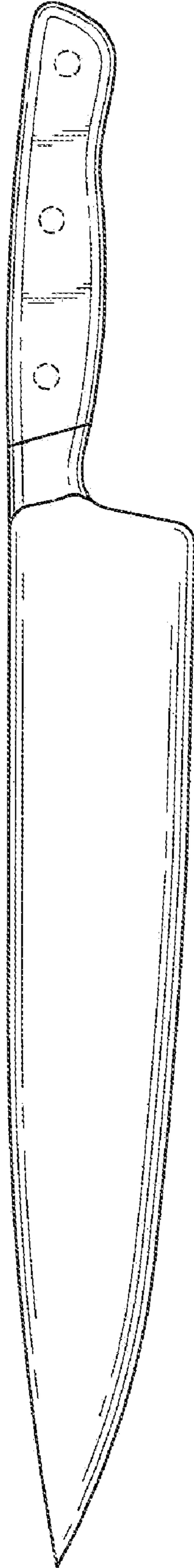

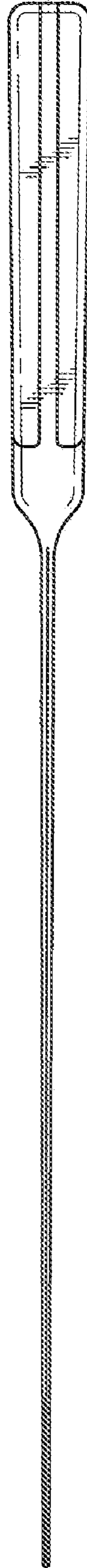
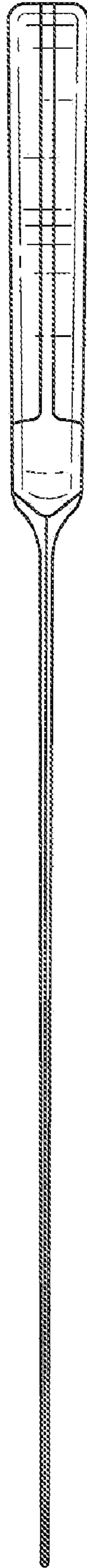

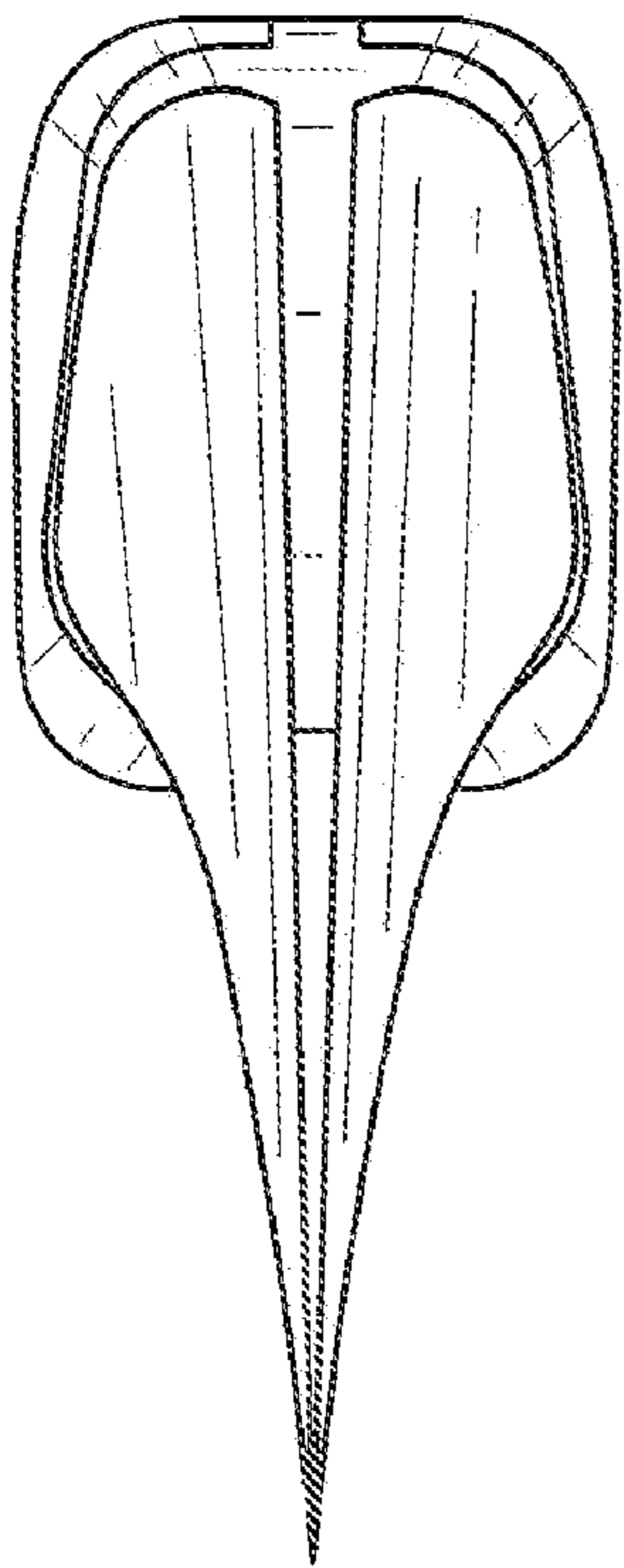

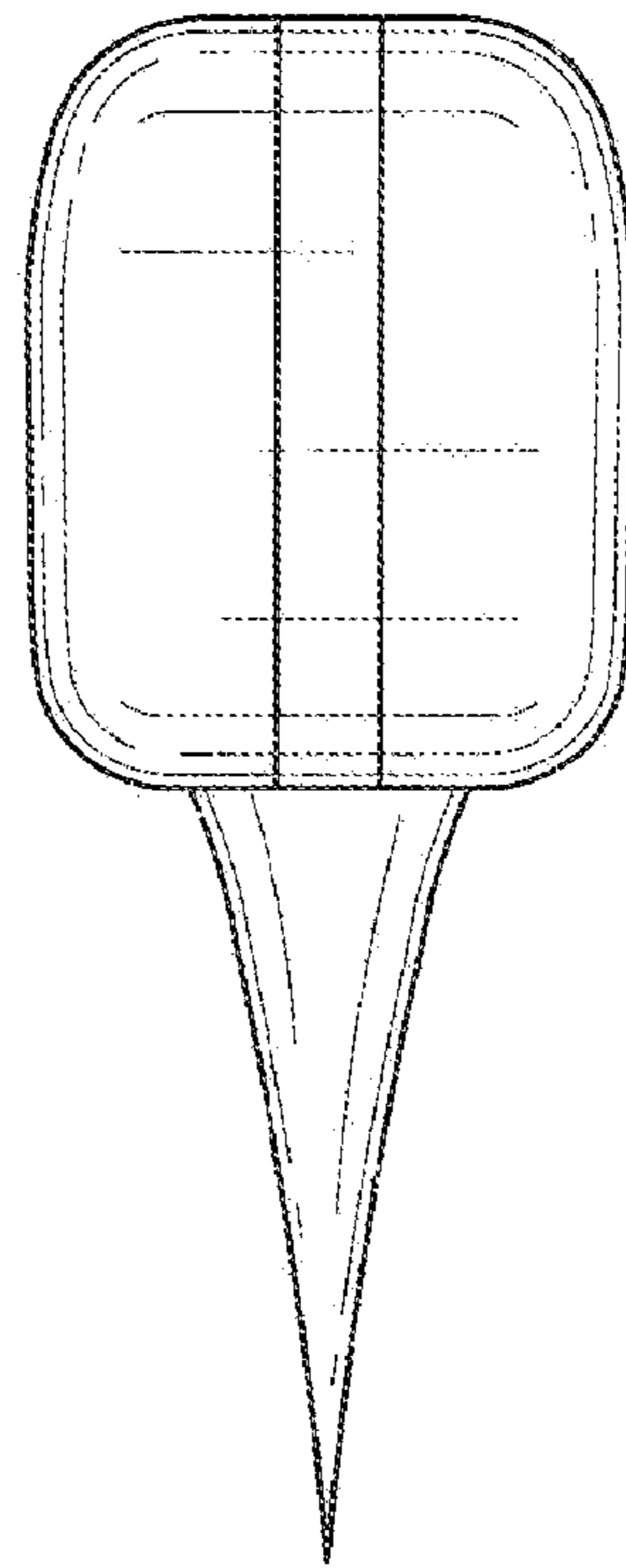
