FIG. 10 is a bottom plan view of the embodiment shown in FIG. 7; and,

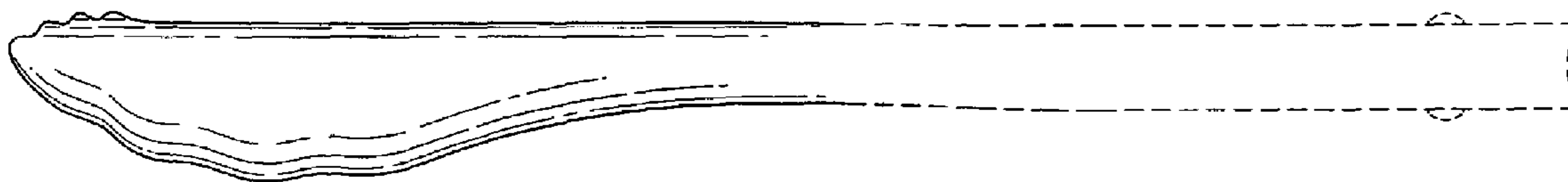
FIG. 11 is a perspective view of the embodiment shown in FIG. 7.

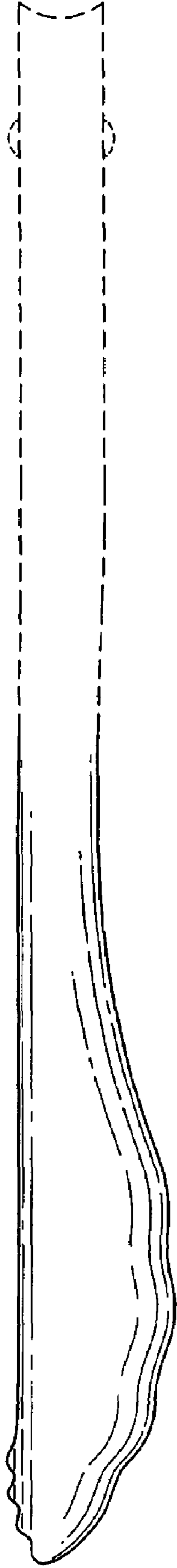

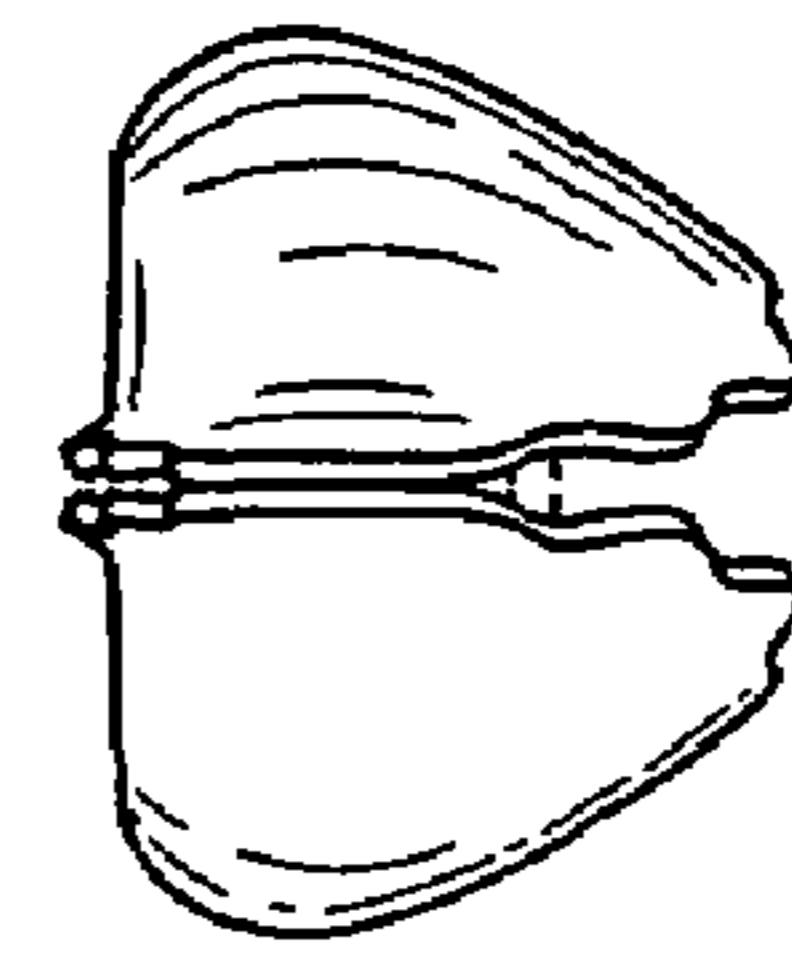

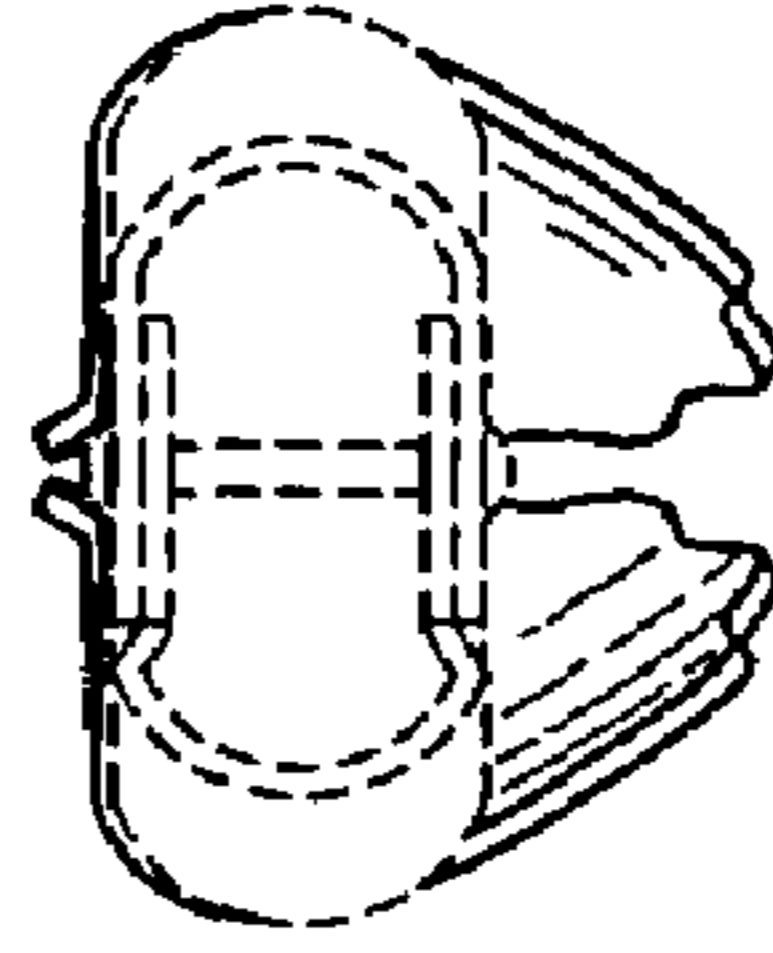

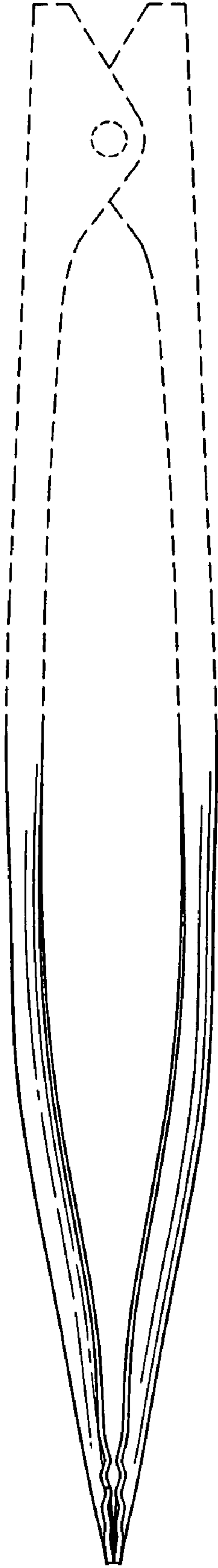

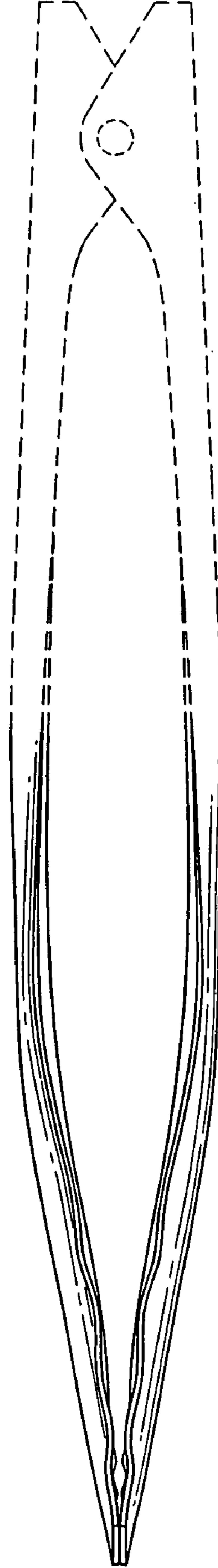

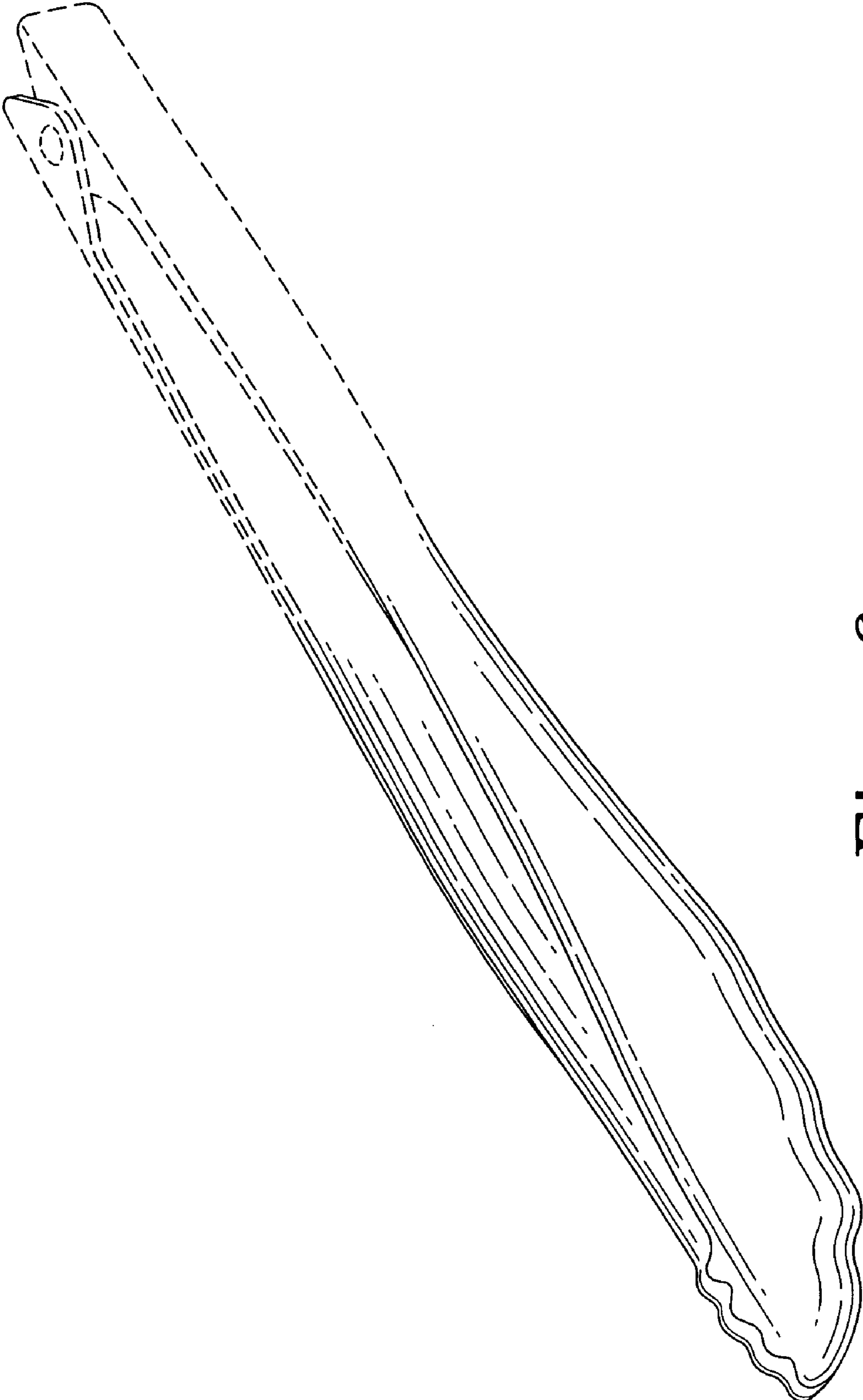

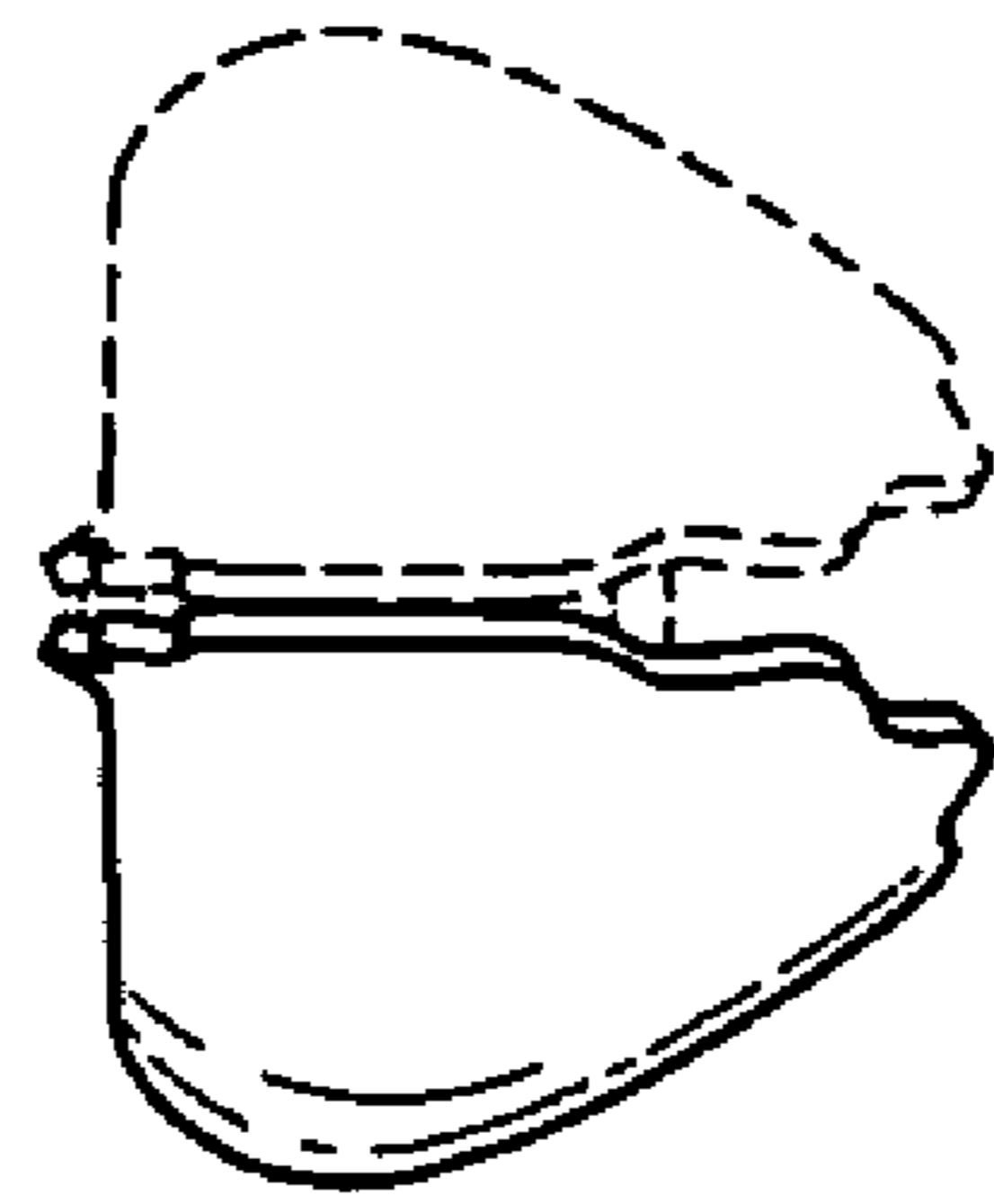

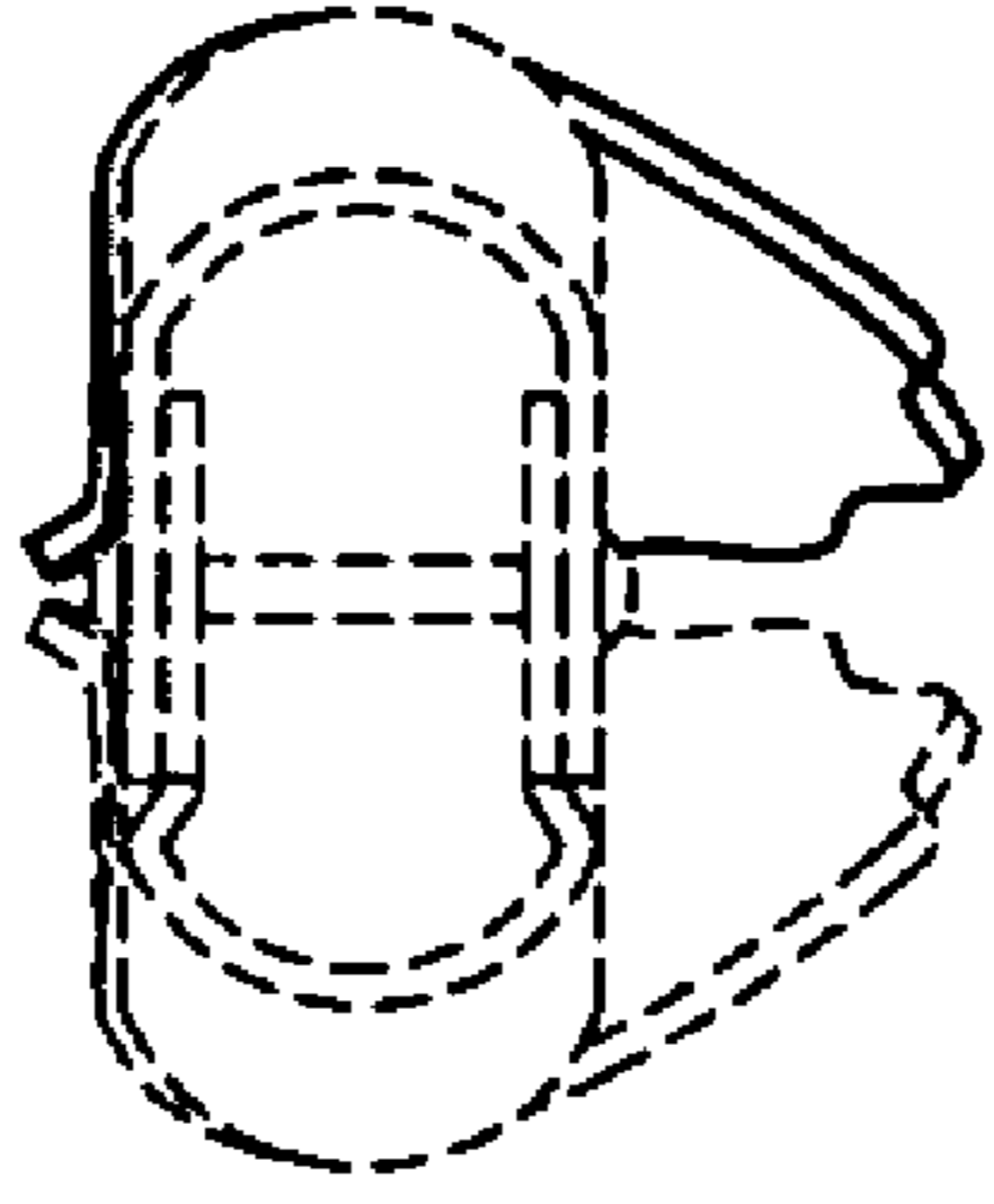

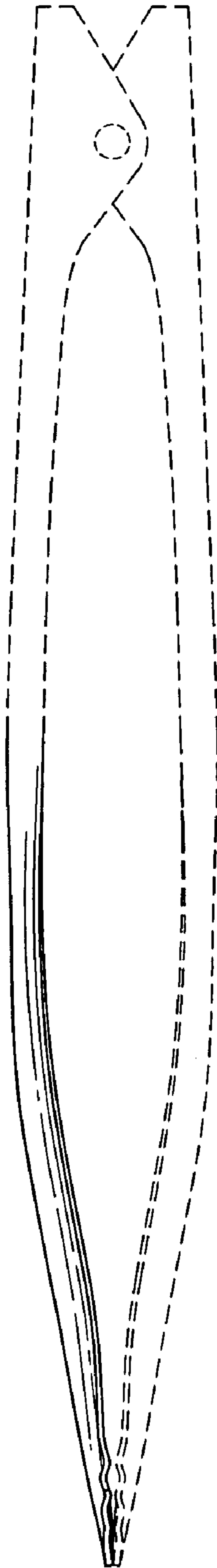

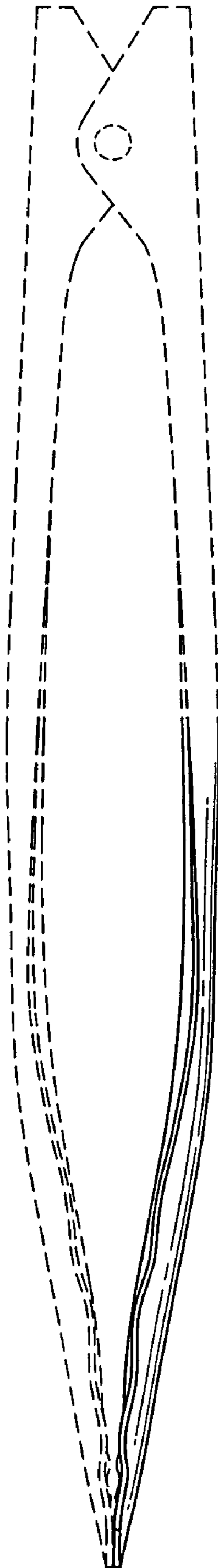

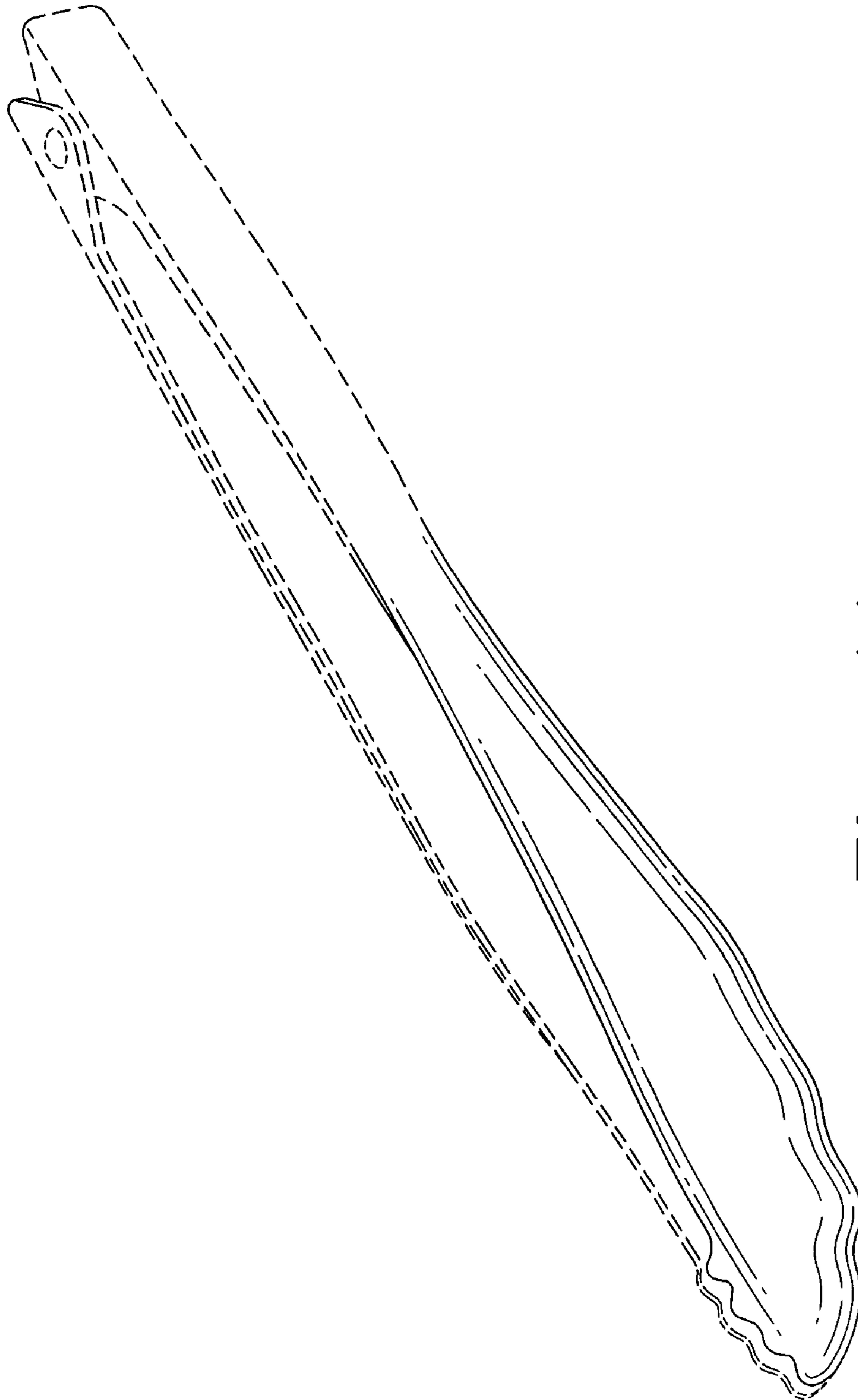
