**DESCRIPTION**

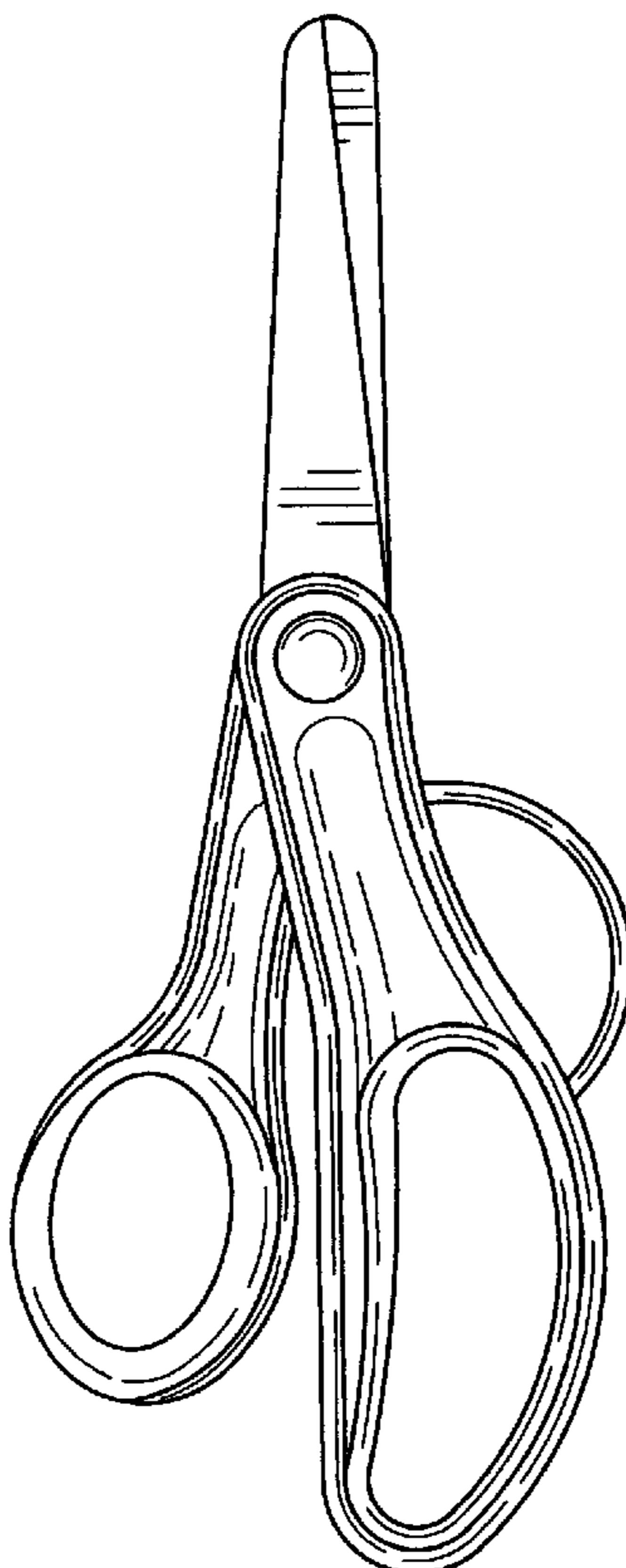
FIG. 1 is a frontal view of a scissors incorporating the features of the invention;

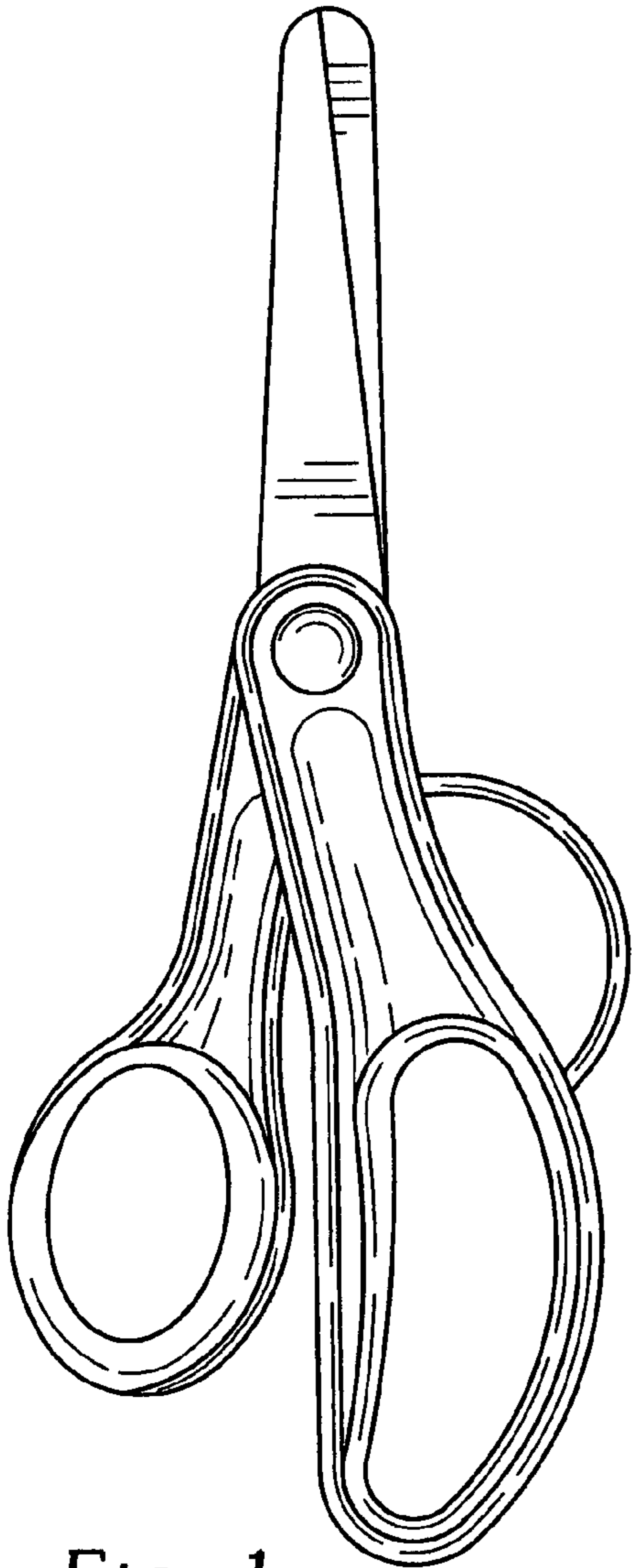
FIG. 2 is a rear or back view of the scissors shown in FIG. 1;

FIG. 3 is an edge view of the scissors shown in FIG. 1, as seen from the edge of the upper portion of the handle; and,

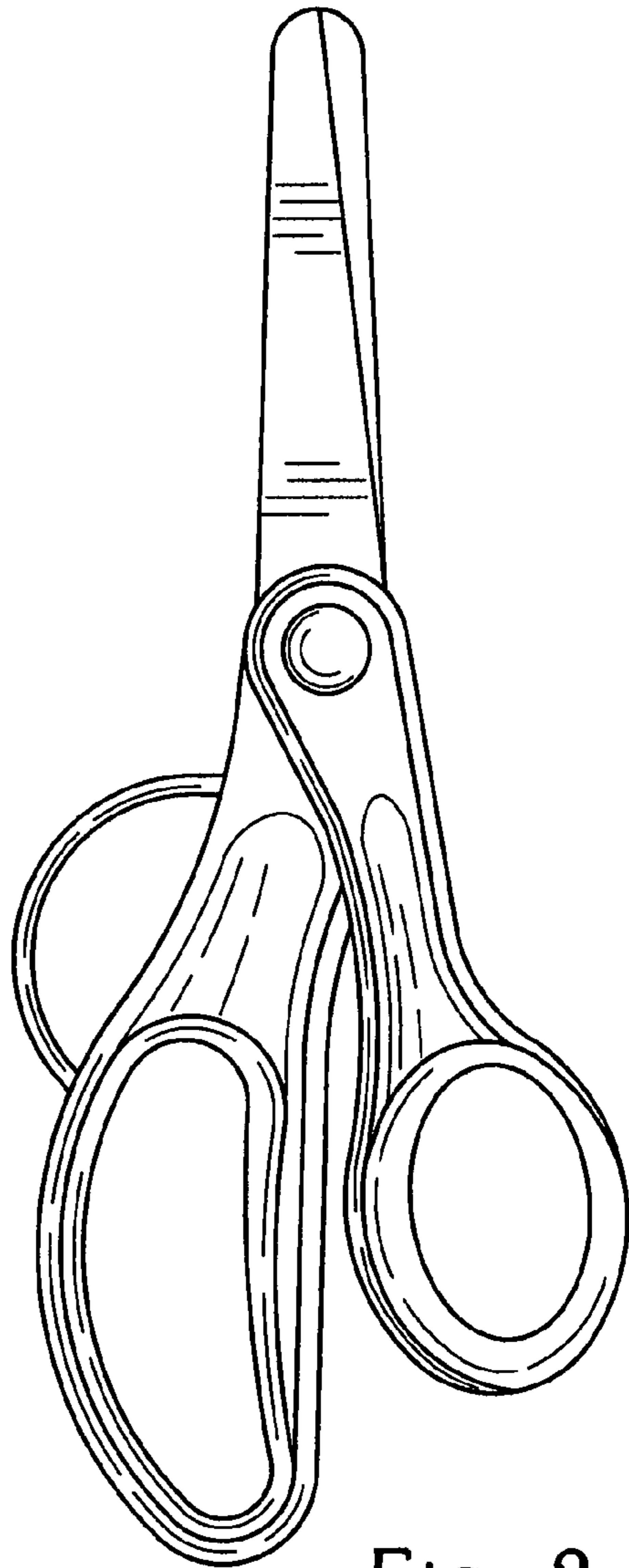
FIG. 4 is an opposite edge view of the scissors shown in FIG. 1, as seen from the edge of the elongated lower portion of the handle.

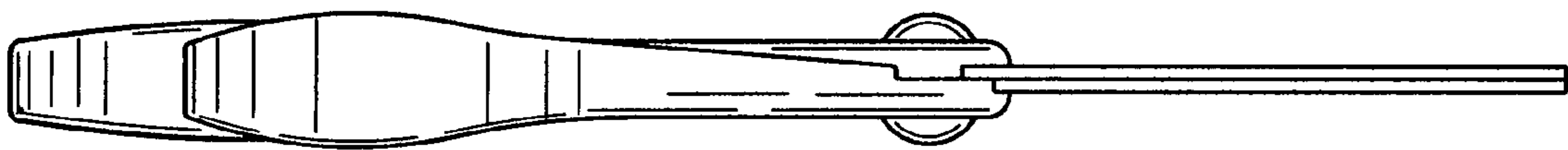




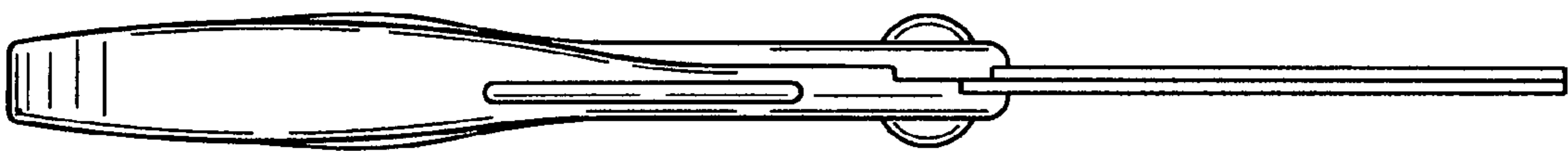
