(57) **CLAIM**

The ornamental design for a butterfly impact wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a butterfly impact wrench incorporating my design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a top plan view thereof;

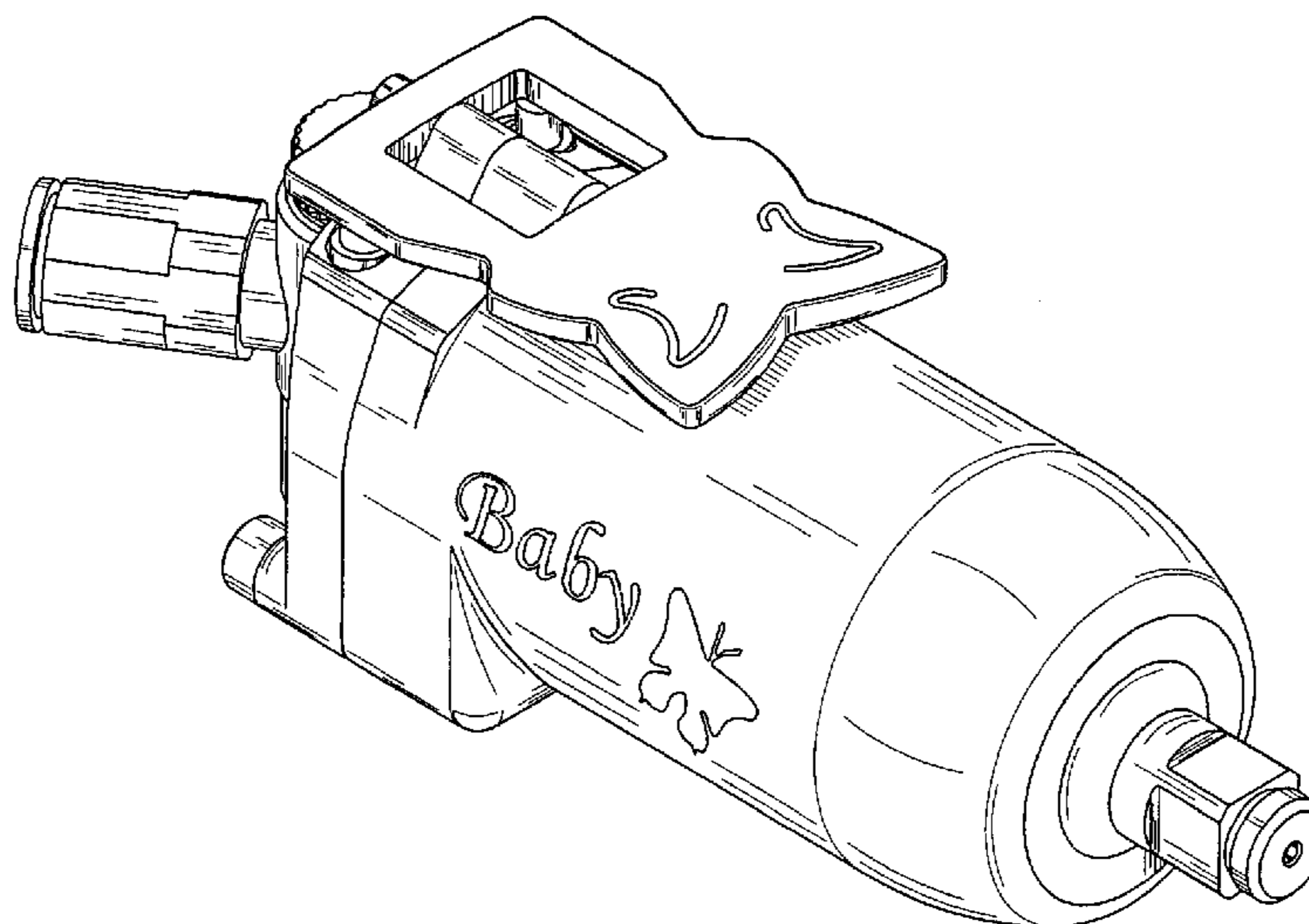
FIG. 5 is a bottom plan view thereof;

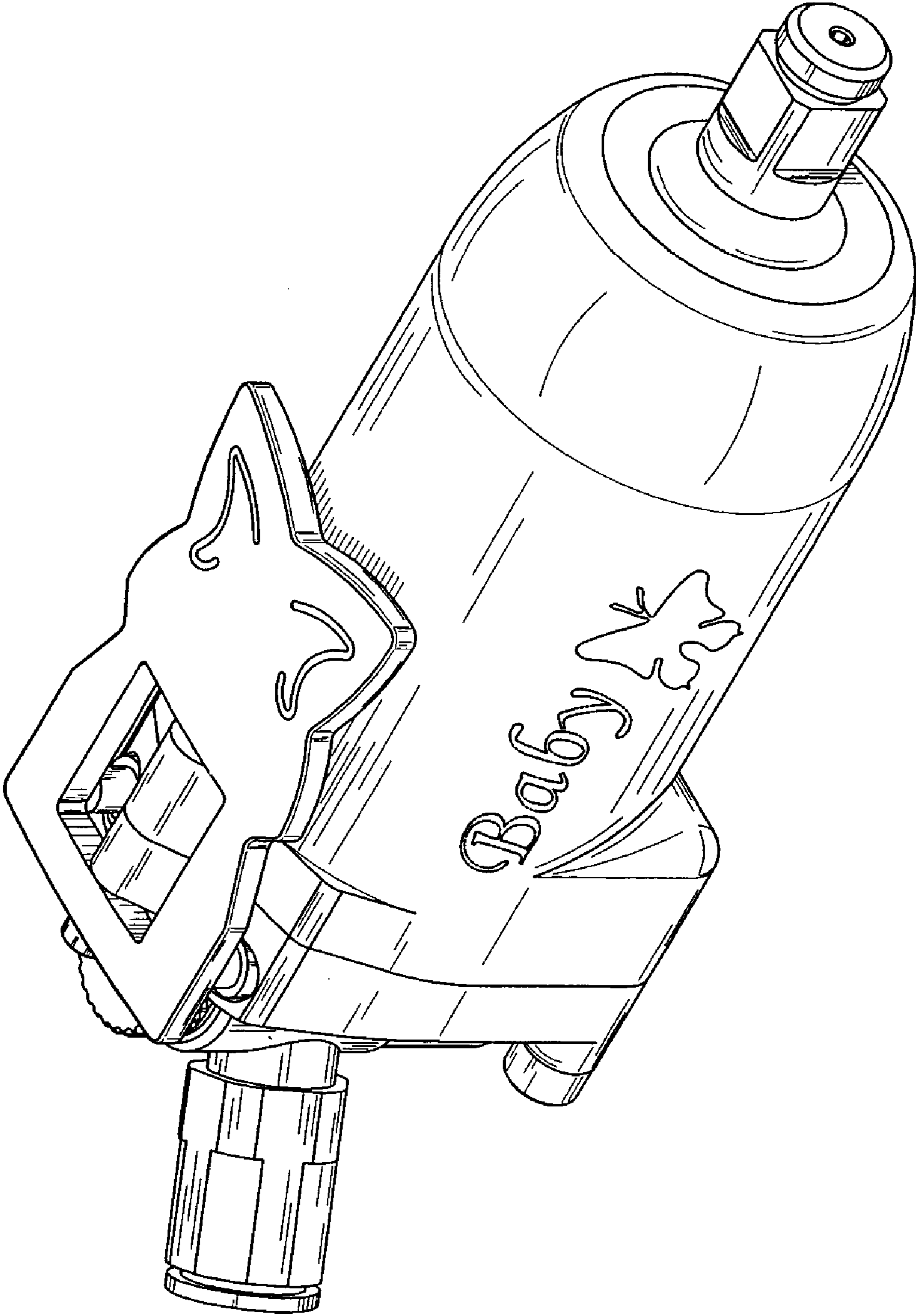

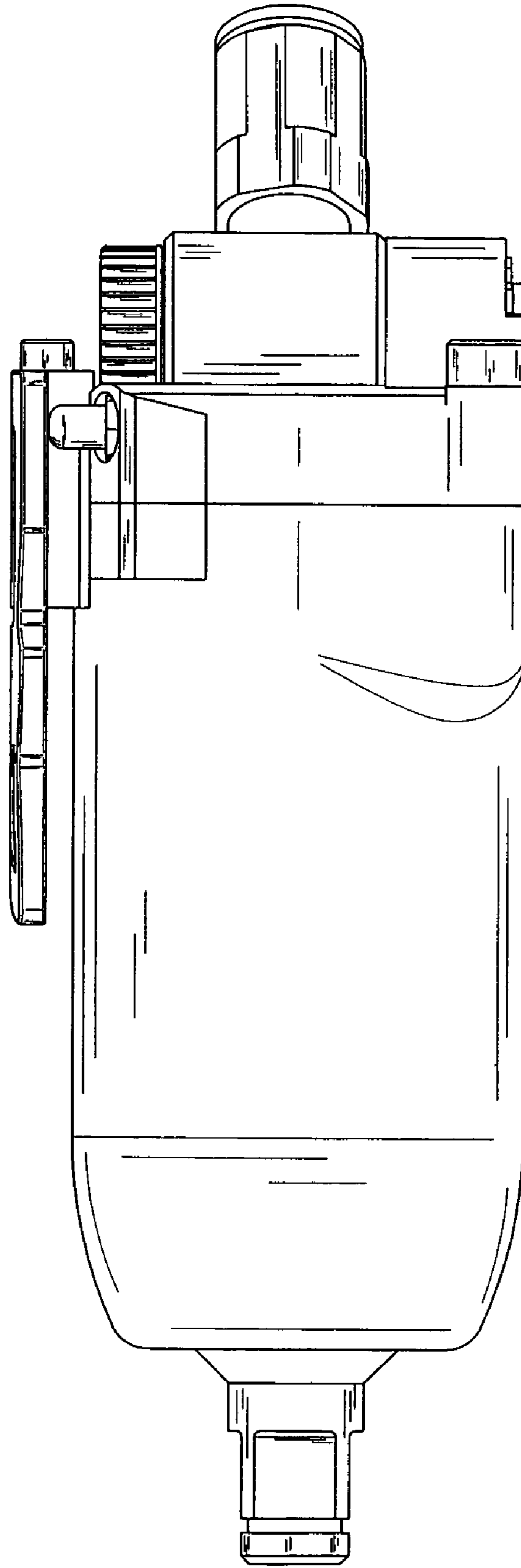

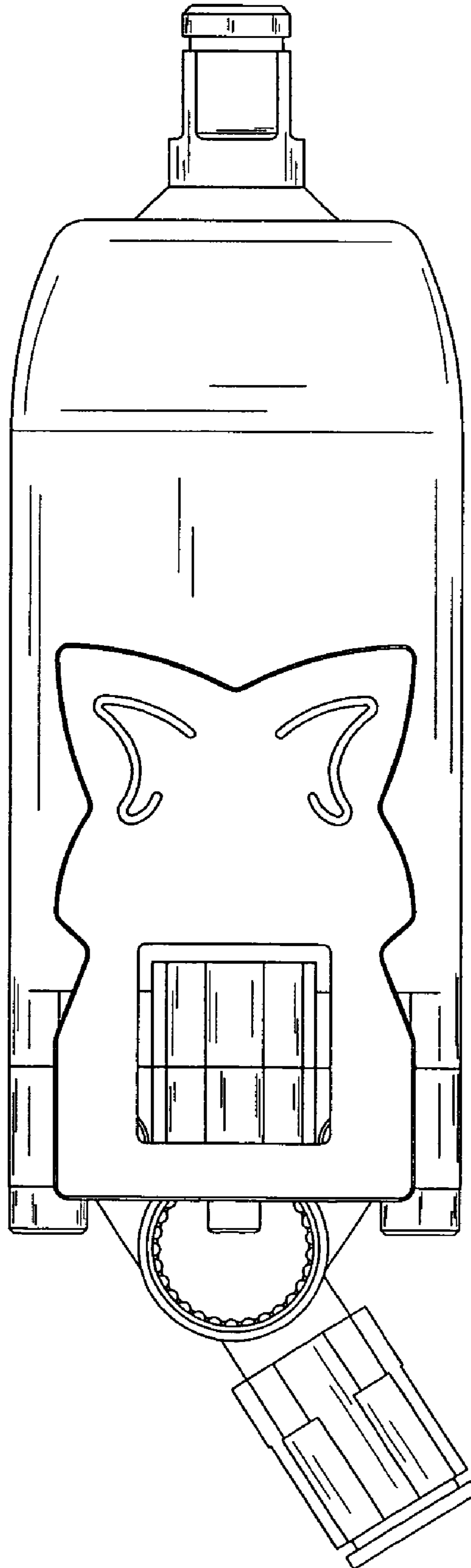

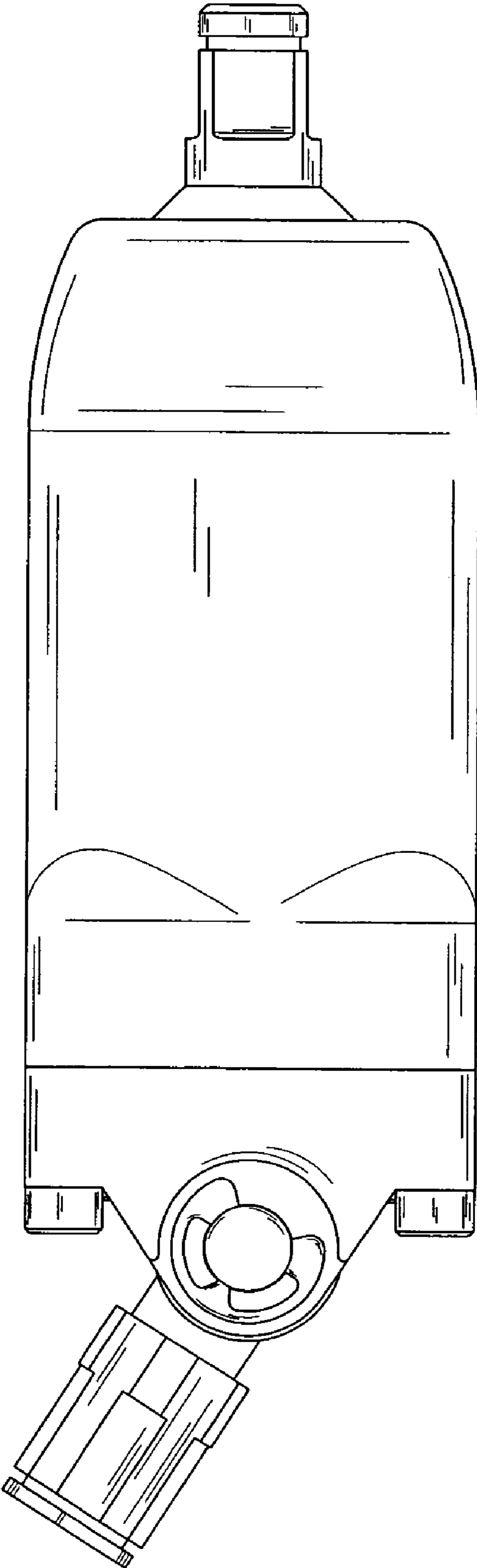

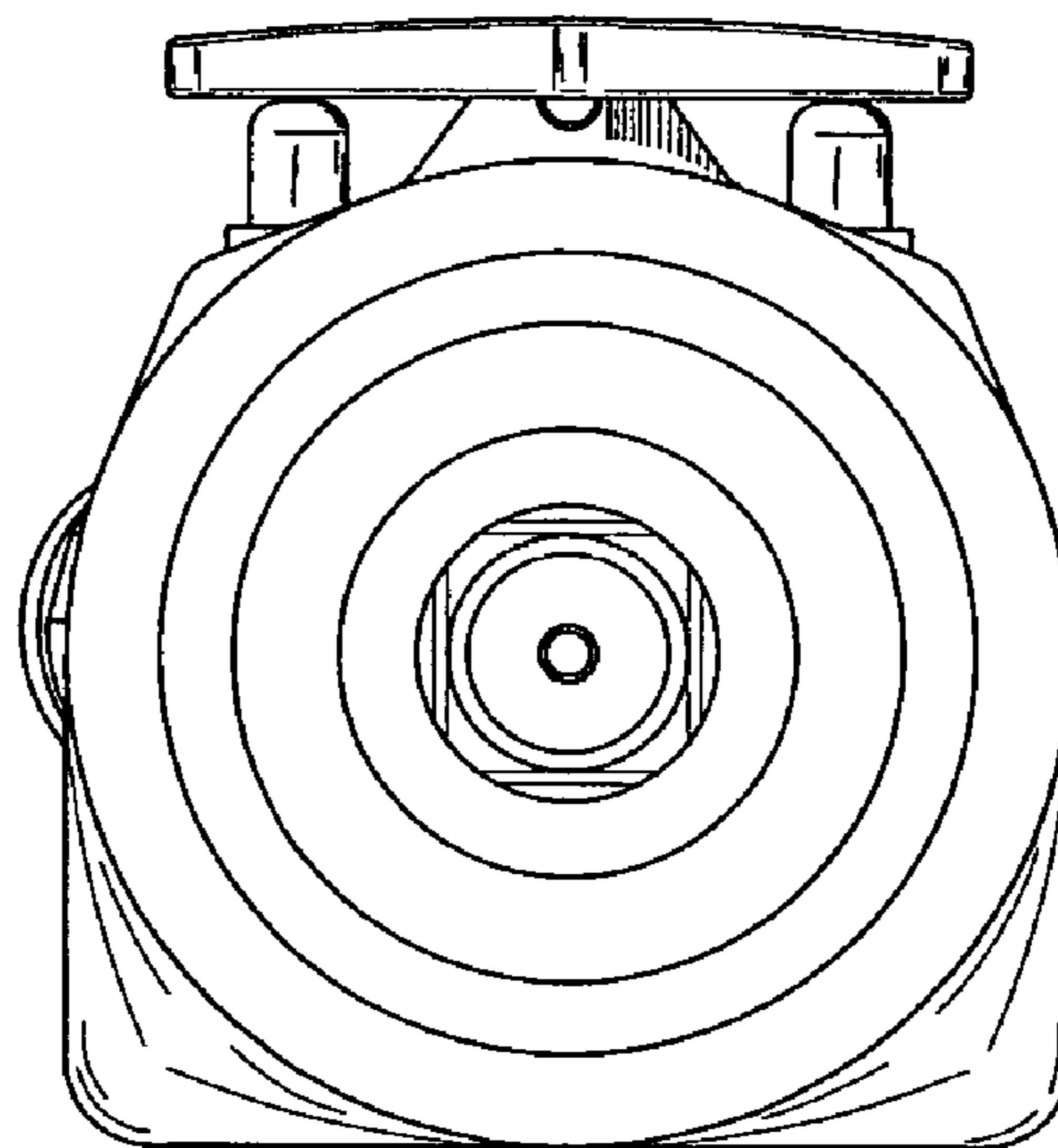
