DESCRIPTION

FIG. 1 is a left side elevation view of a bottle in accordance with our design;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is top plan view thereof;

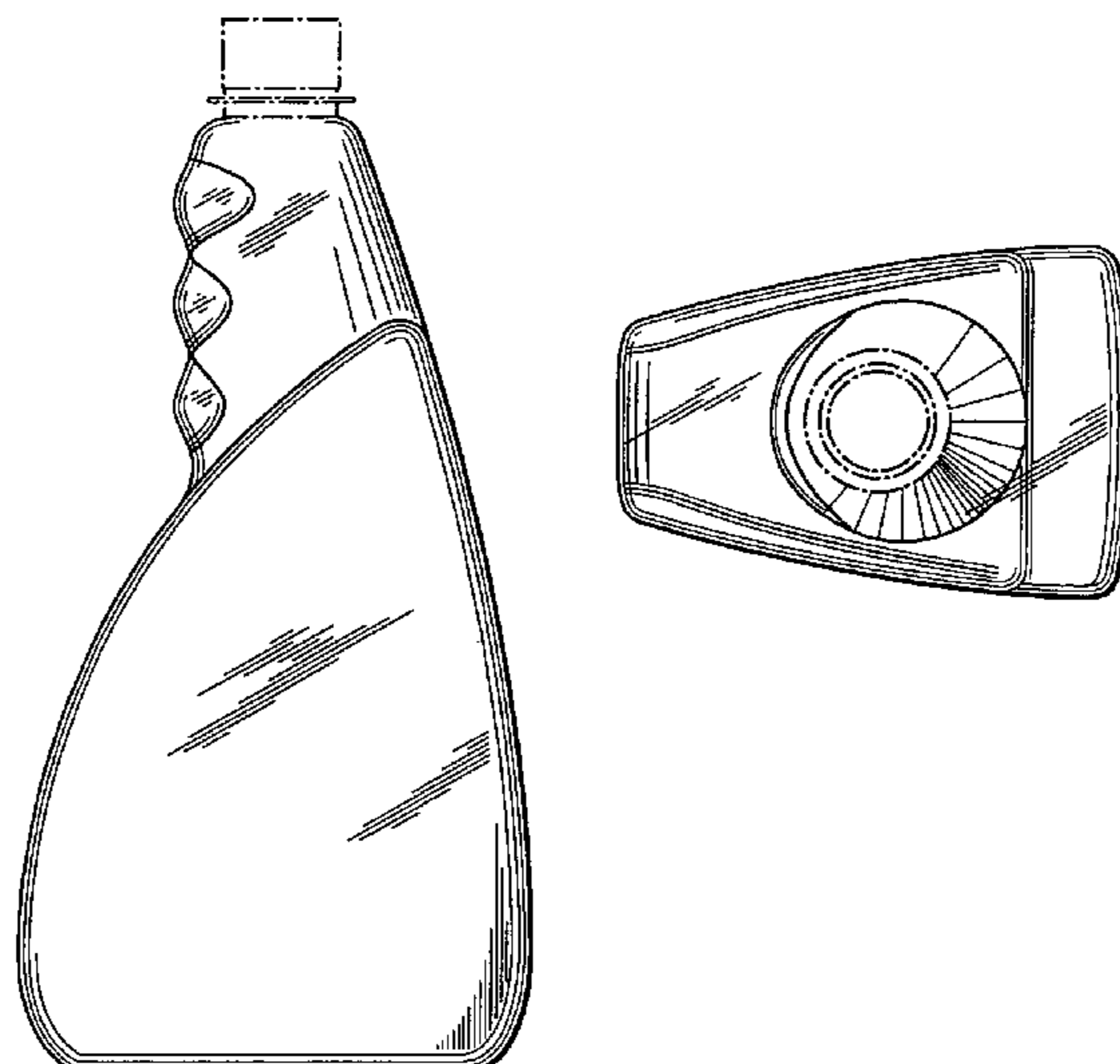
FIG. 4 is a bottom plan view thereof.

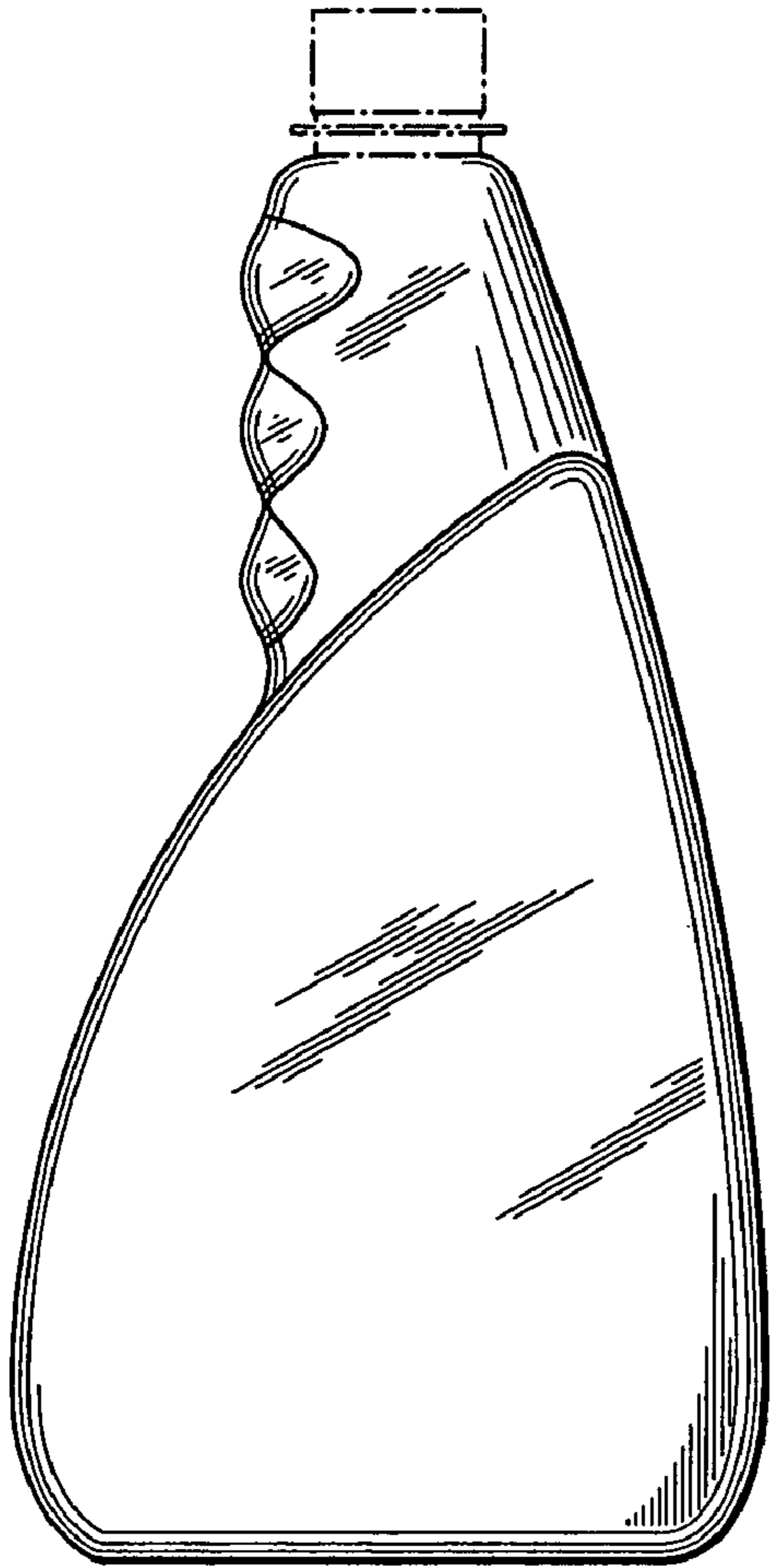

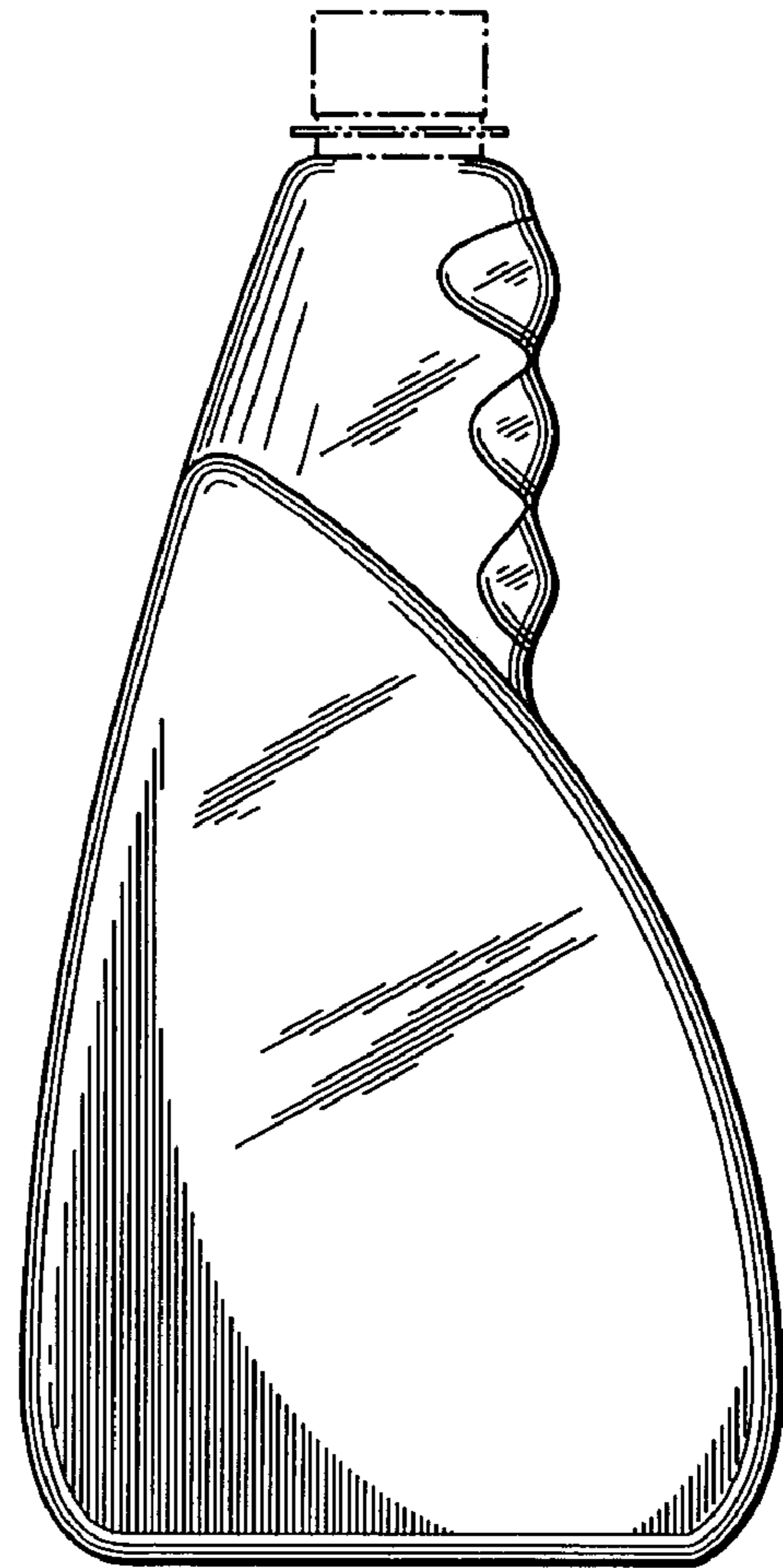

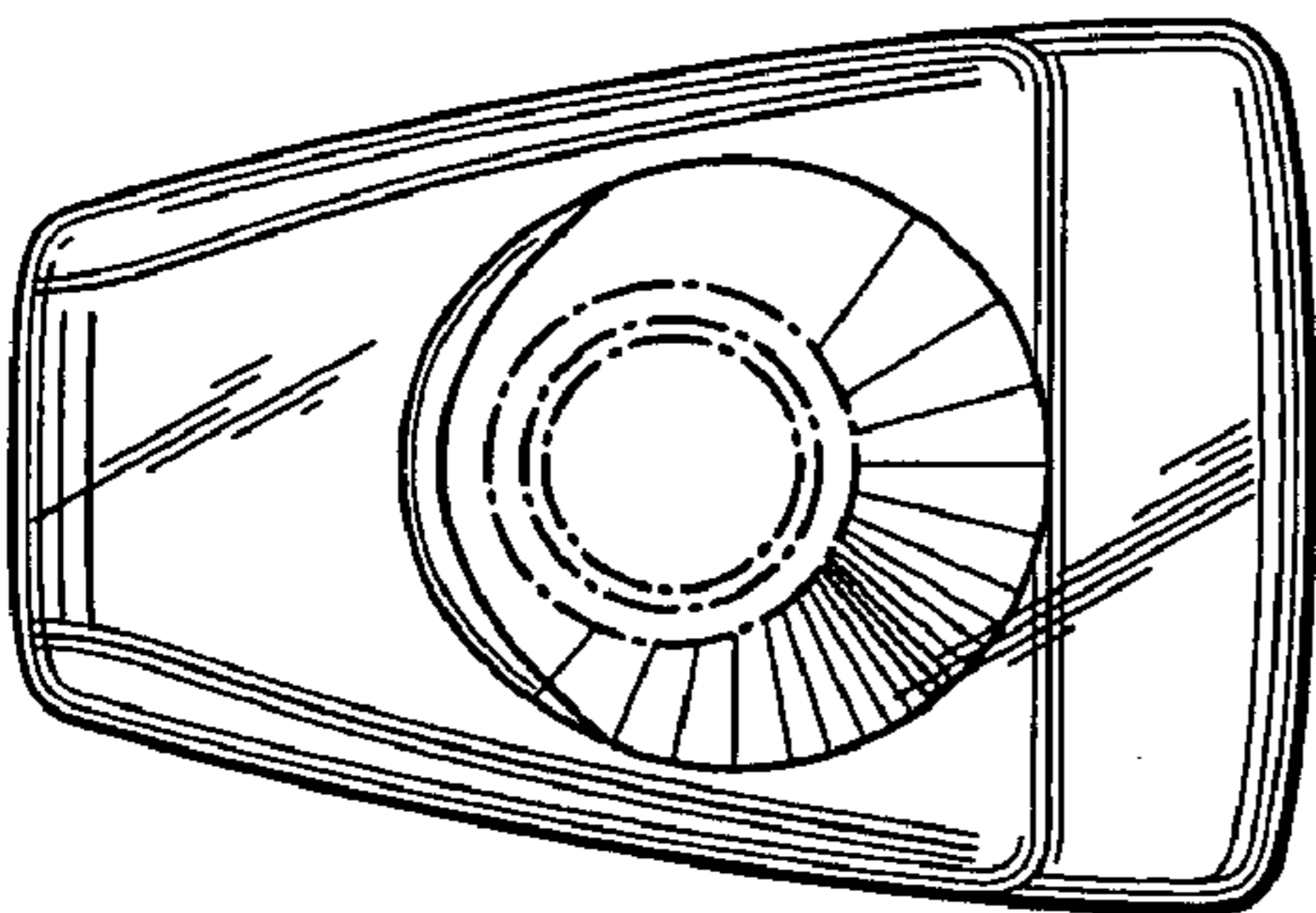

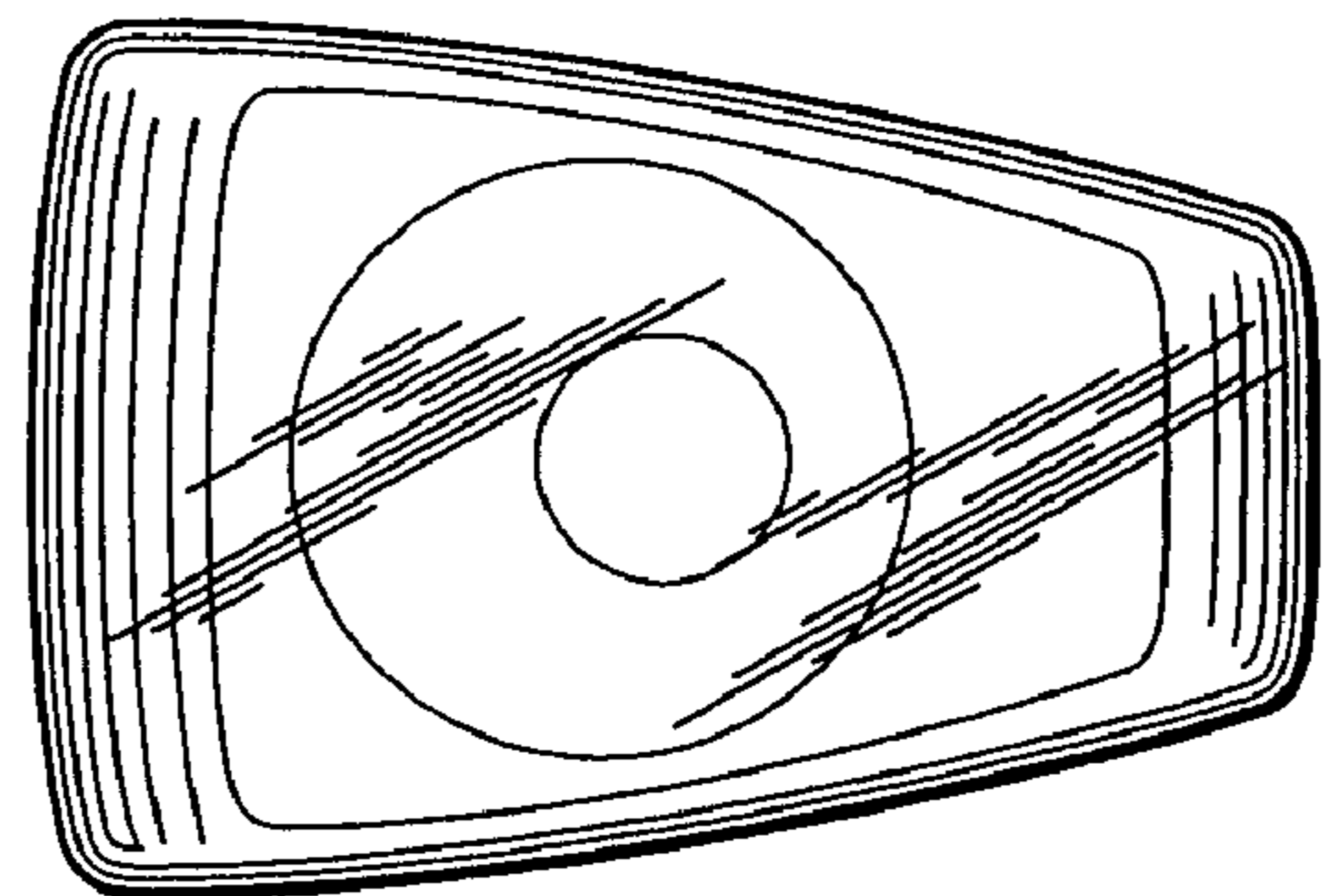

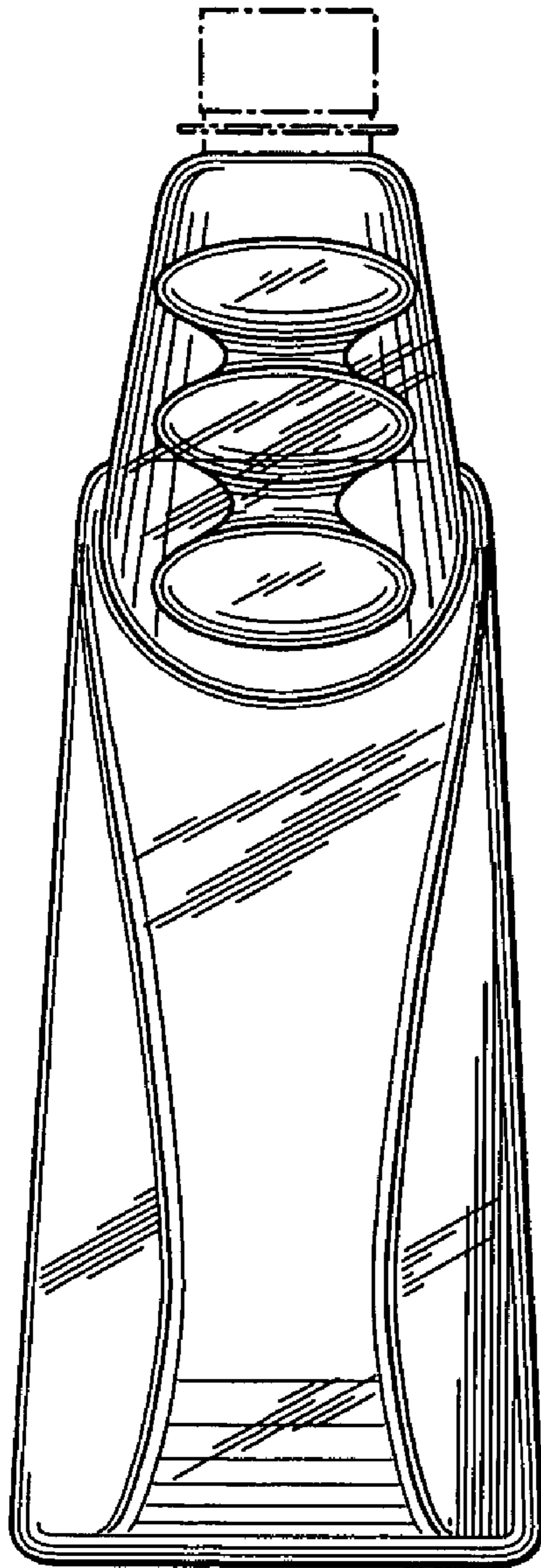

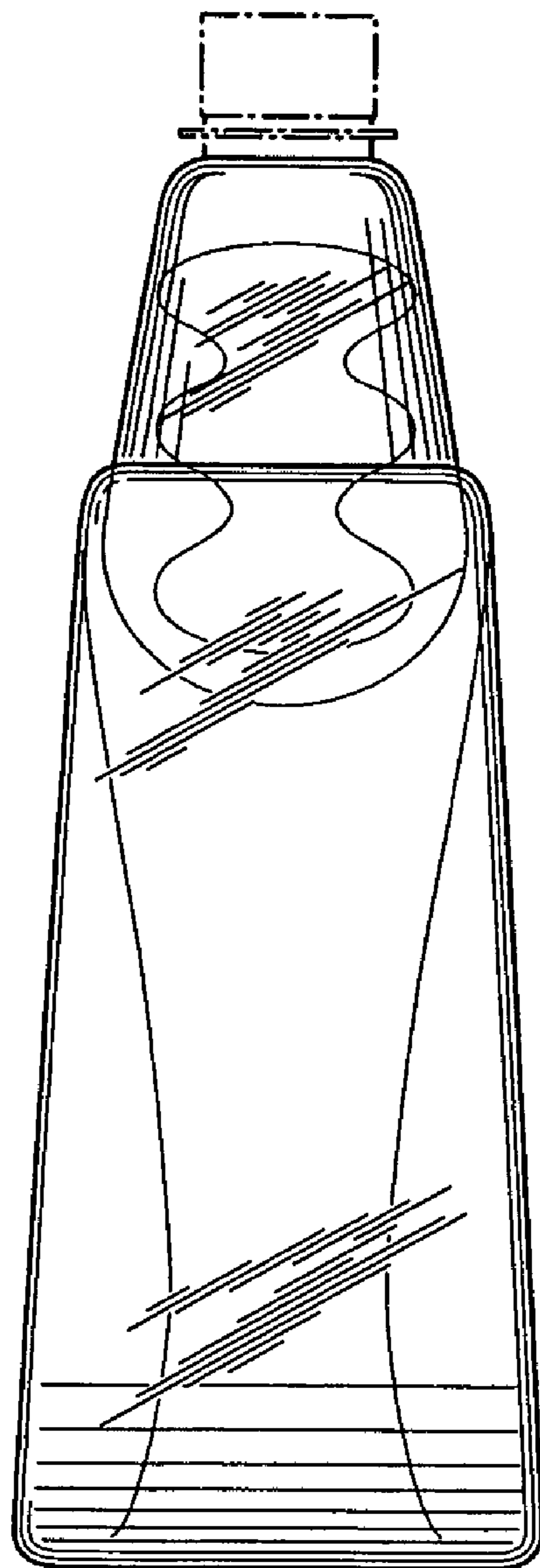
